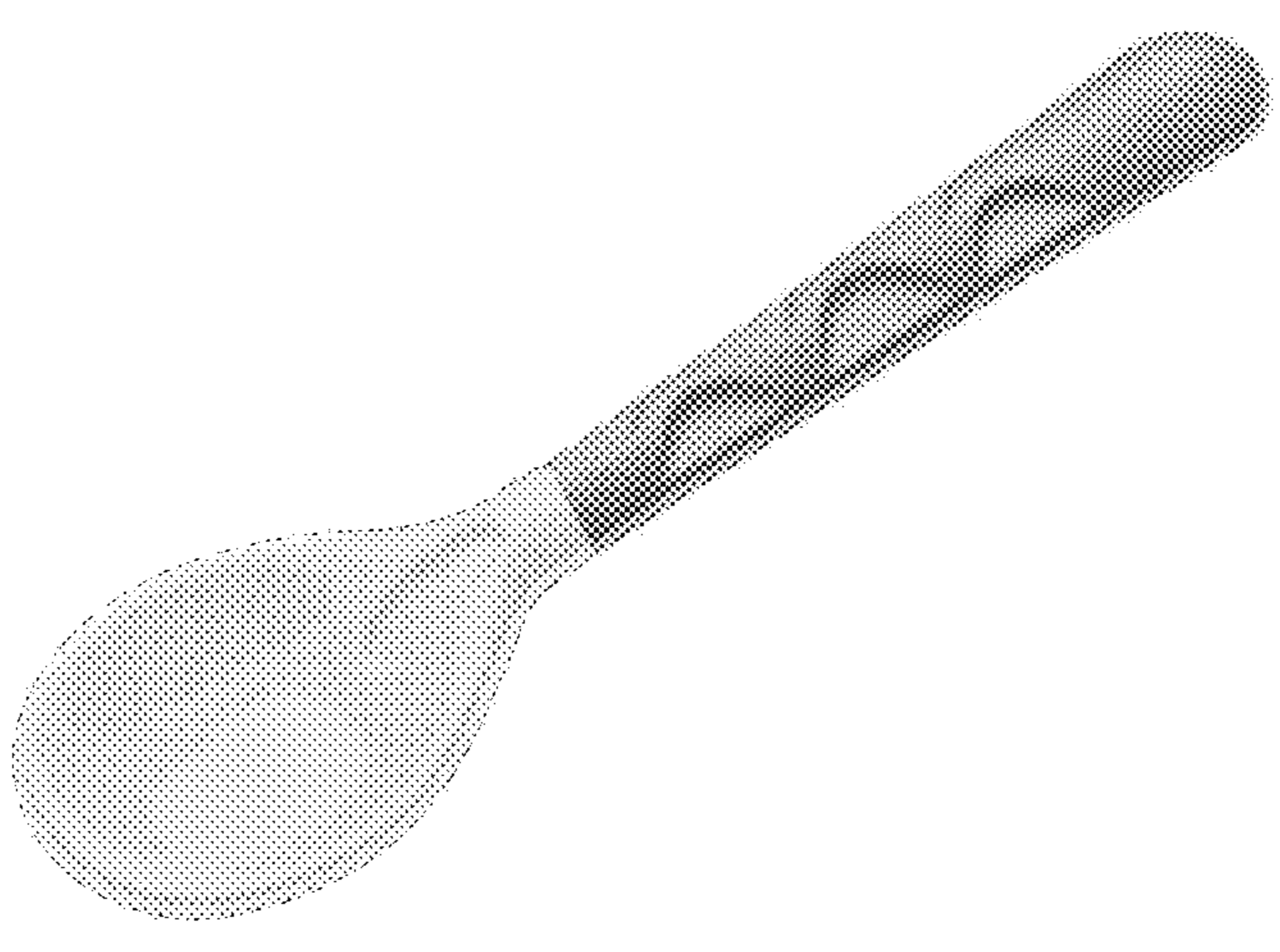
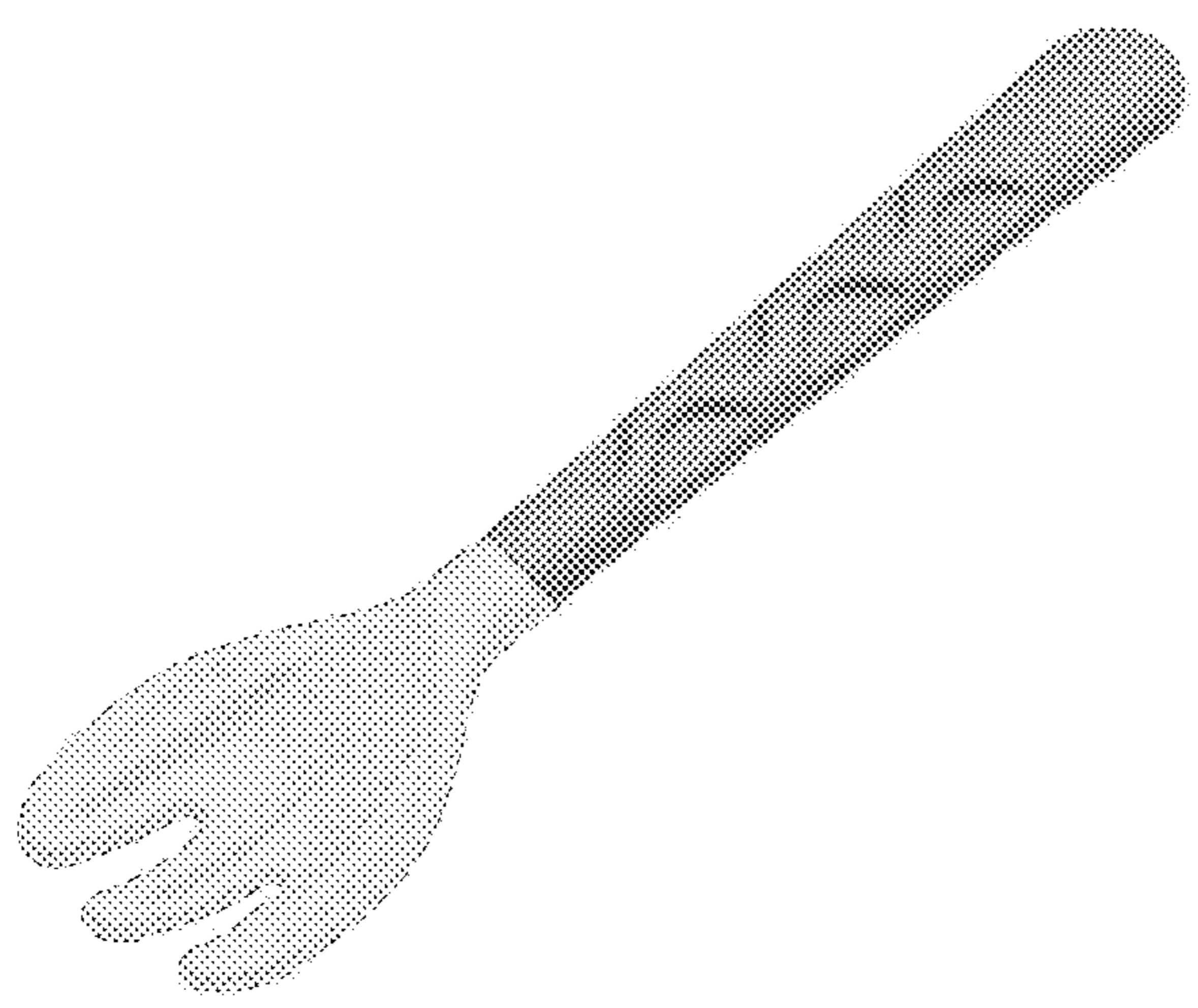

**DESCRIPTION**

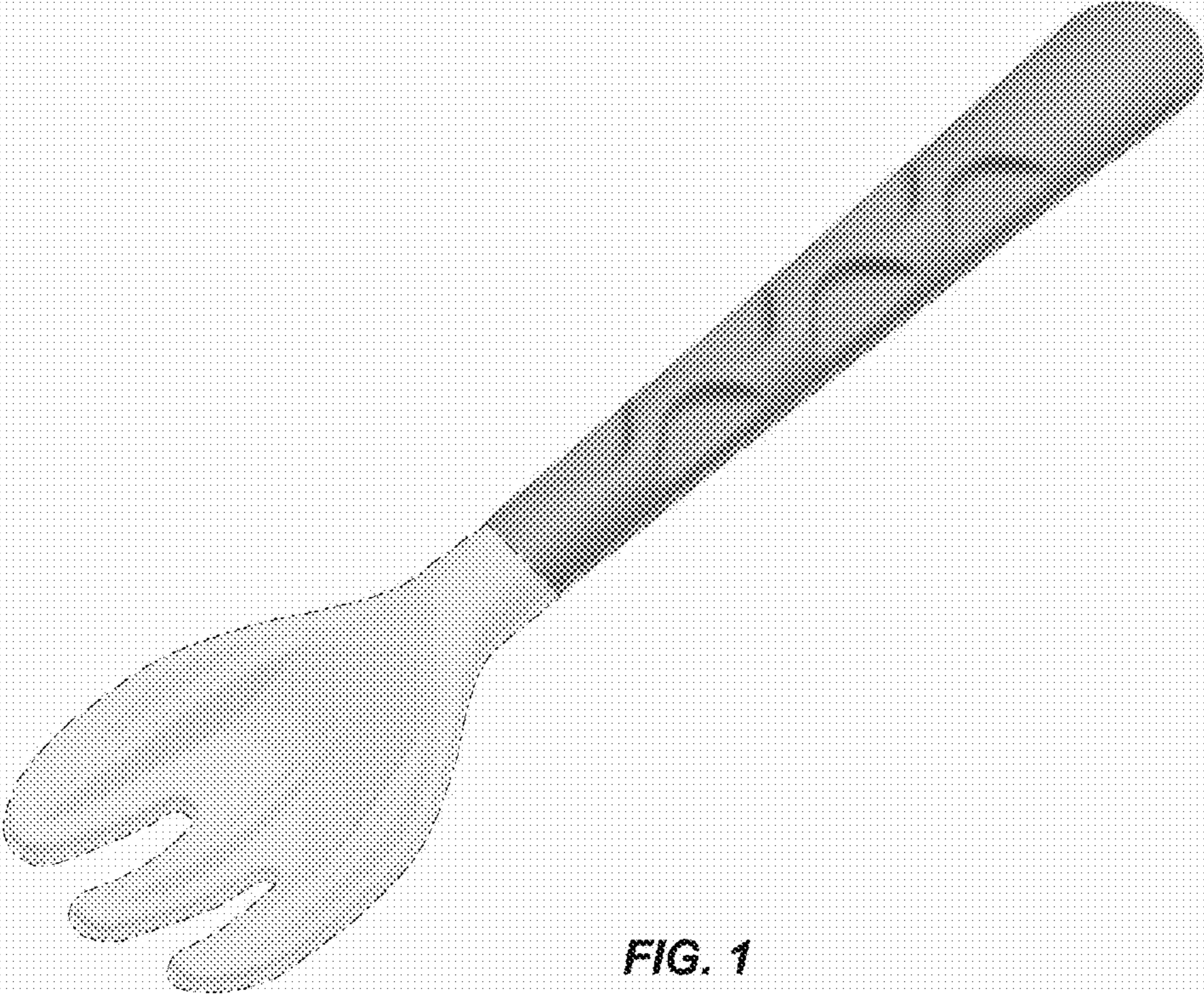

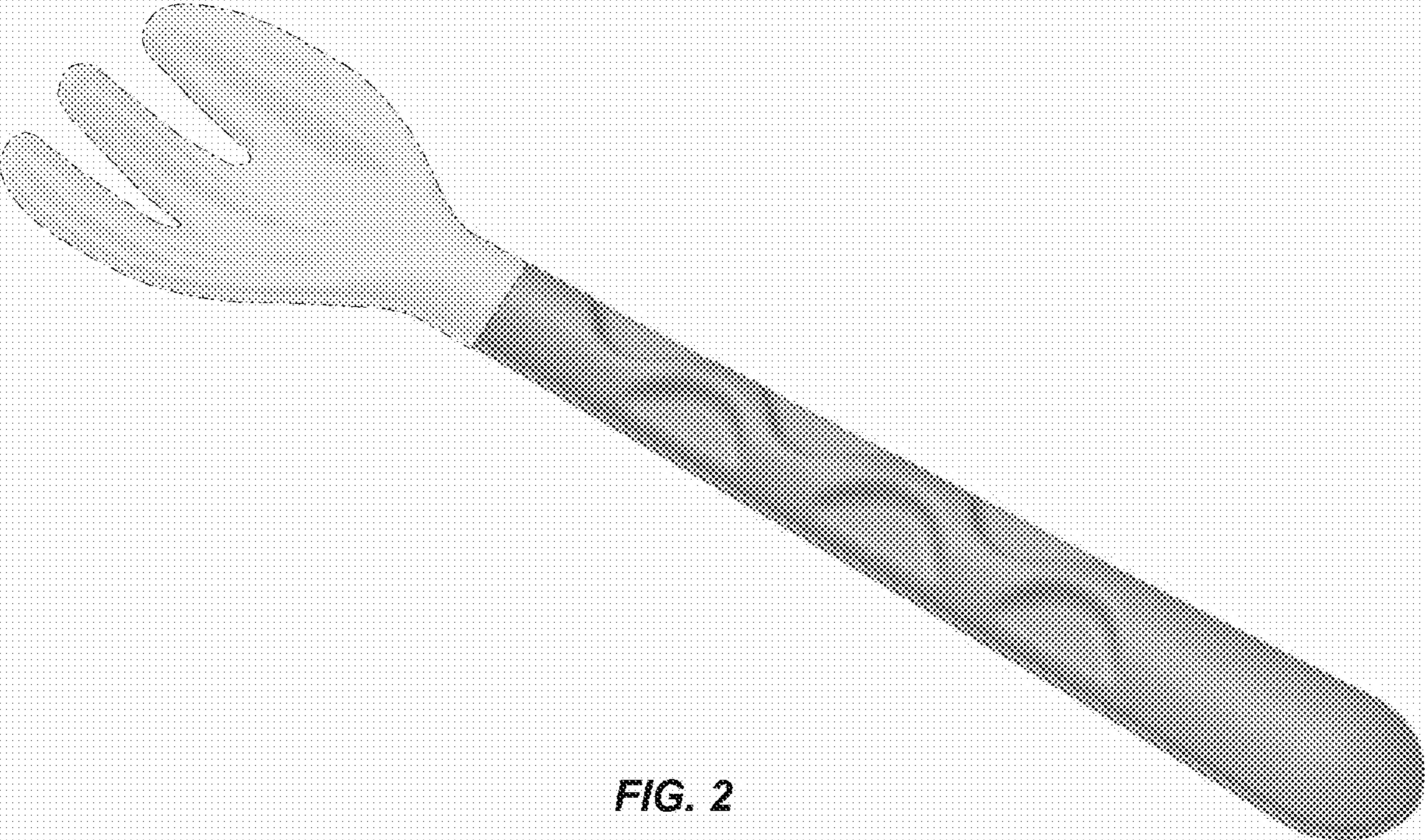

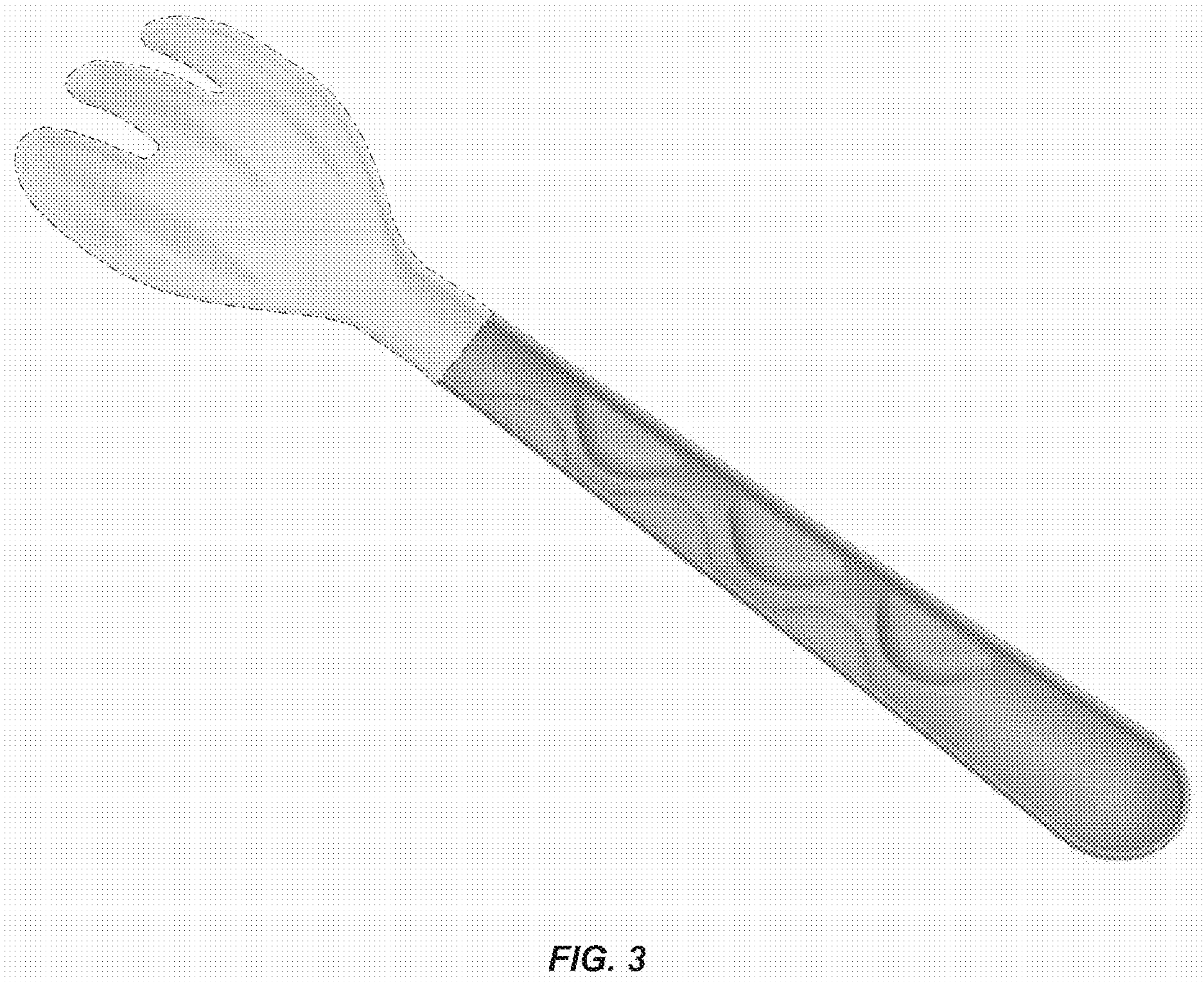
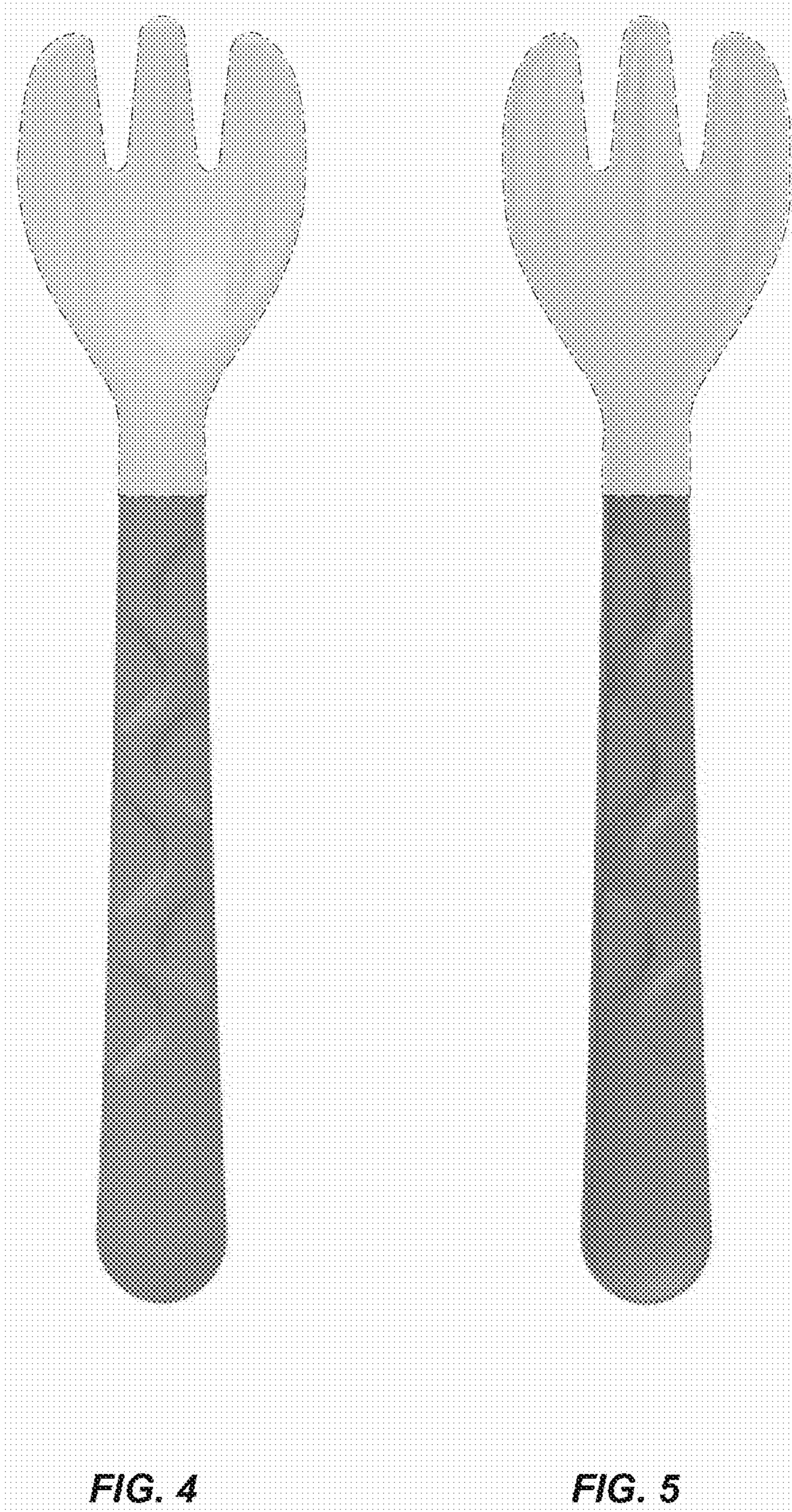
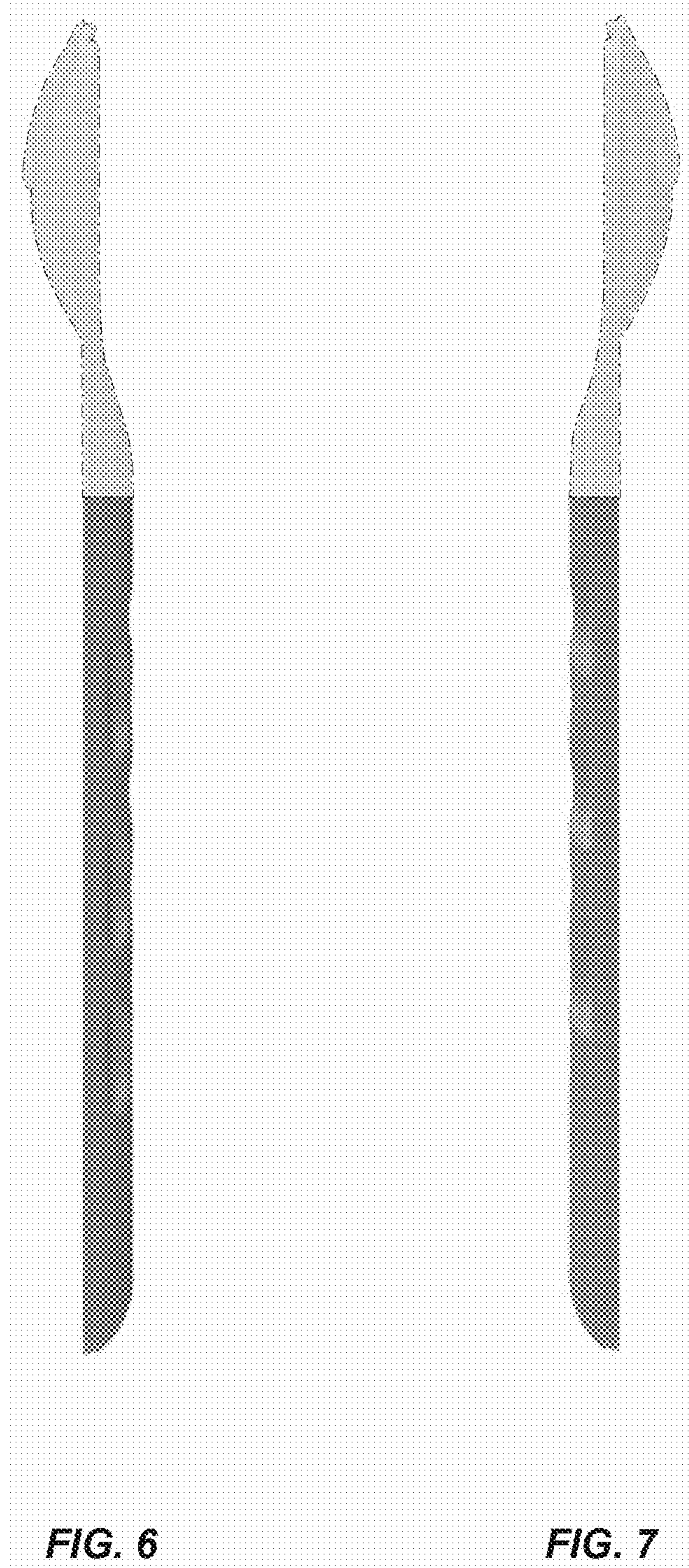
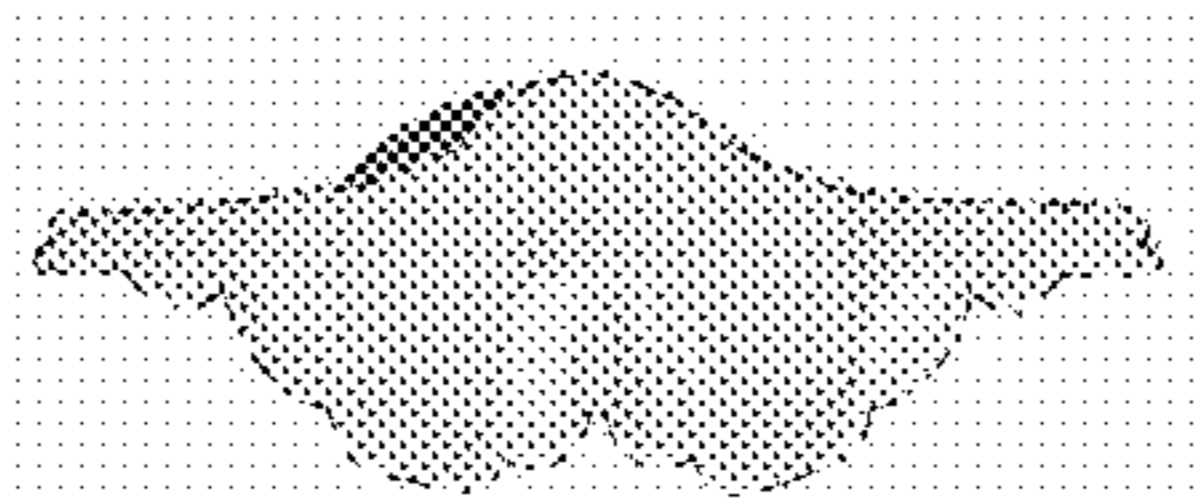

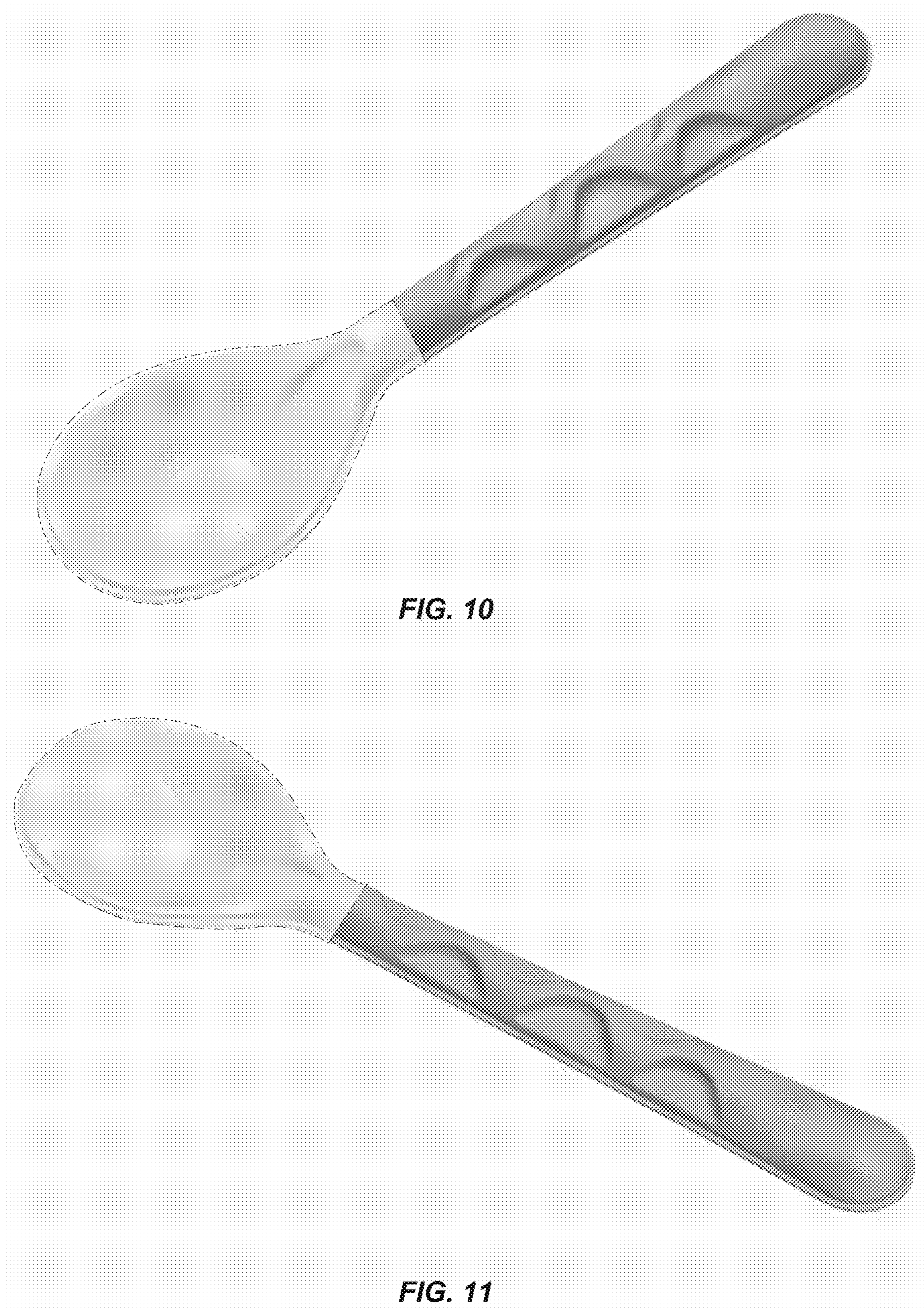
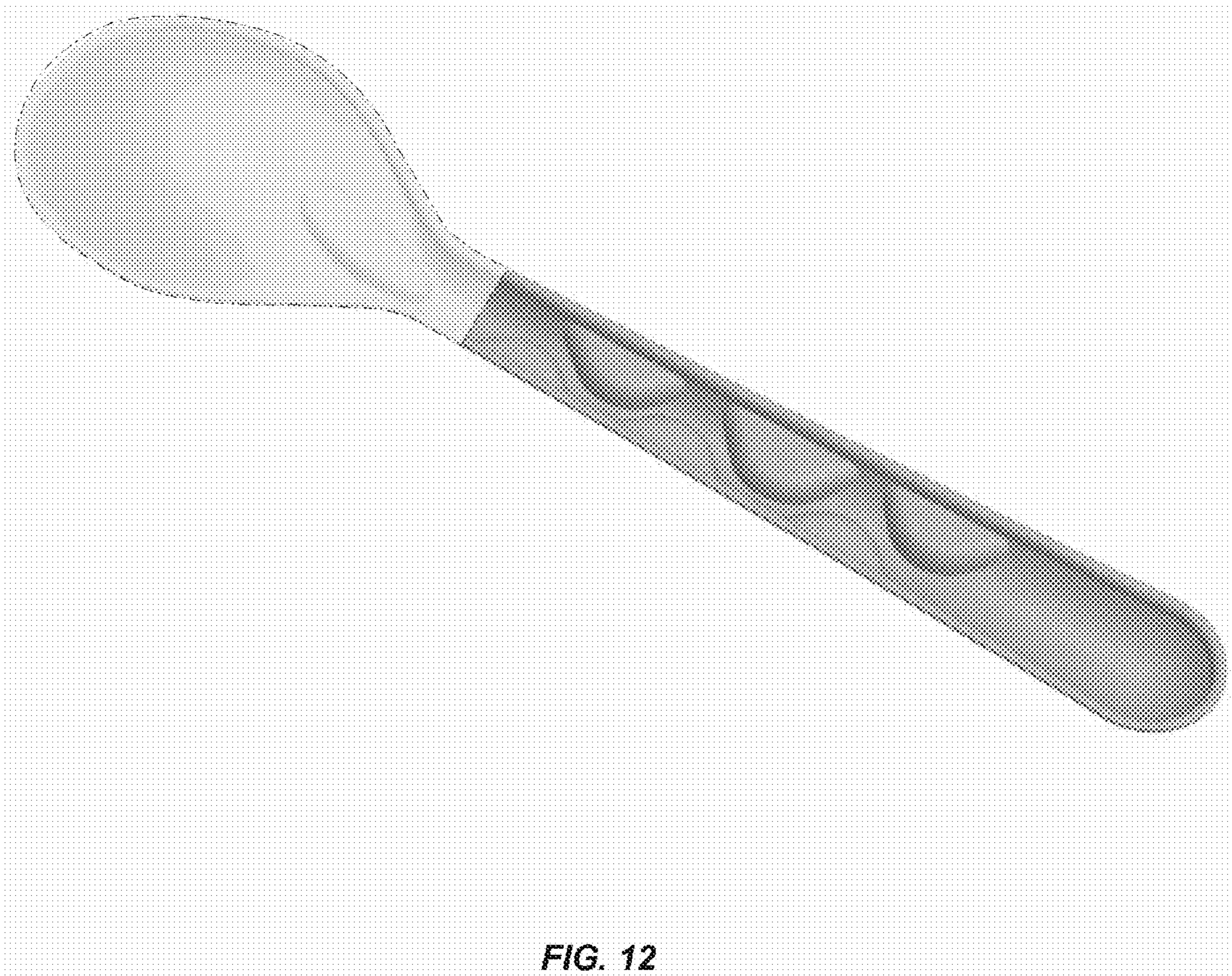
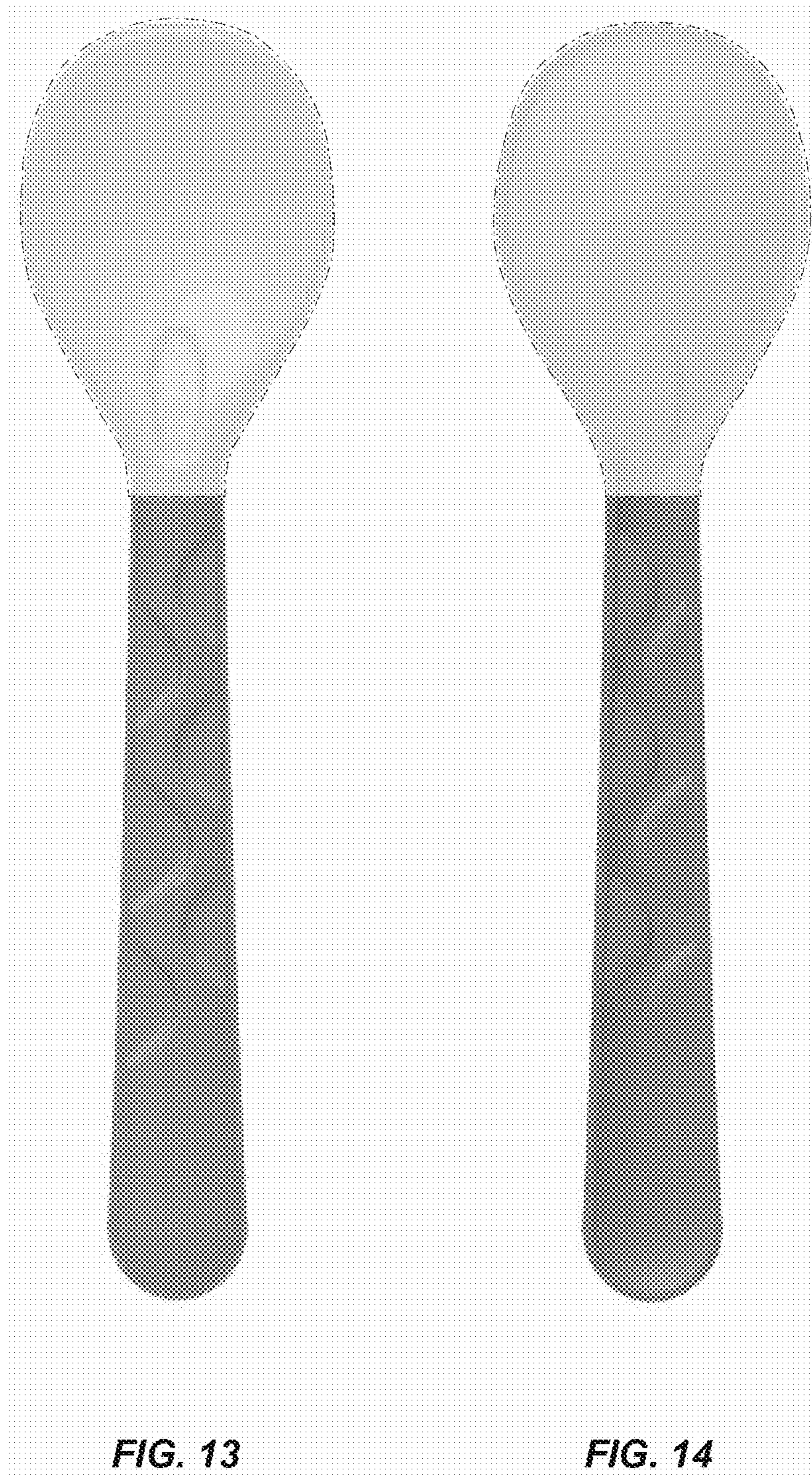

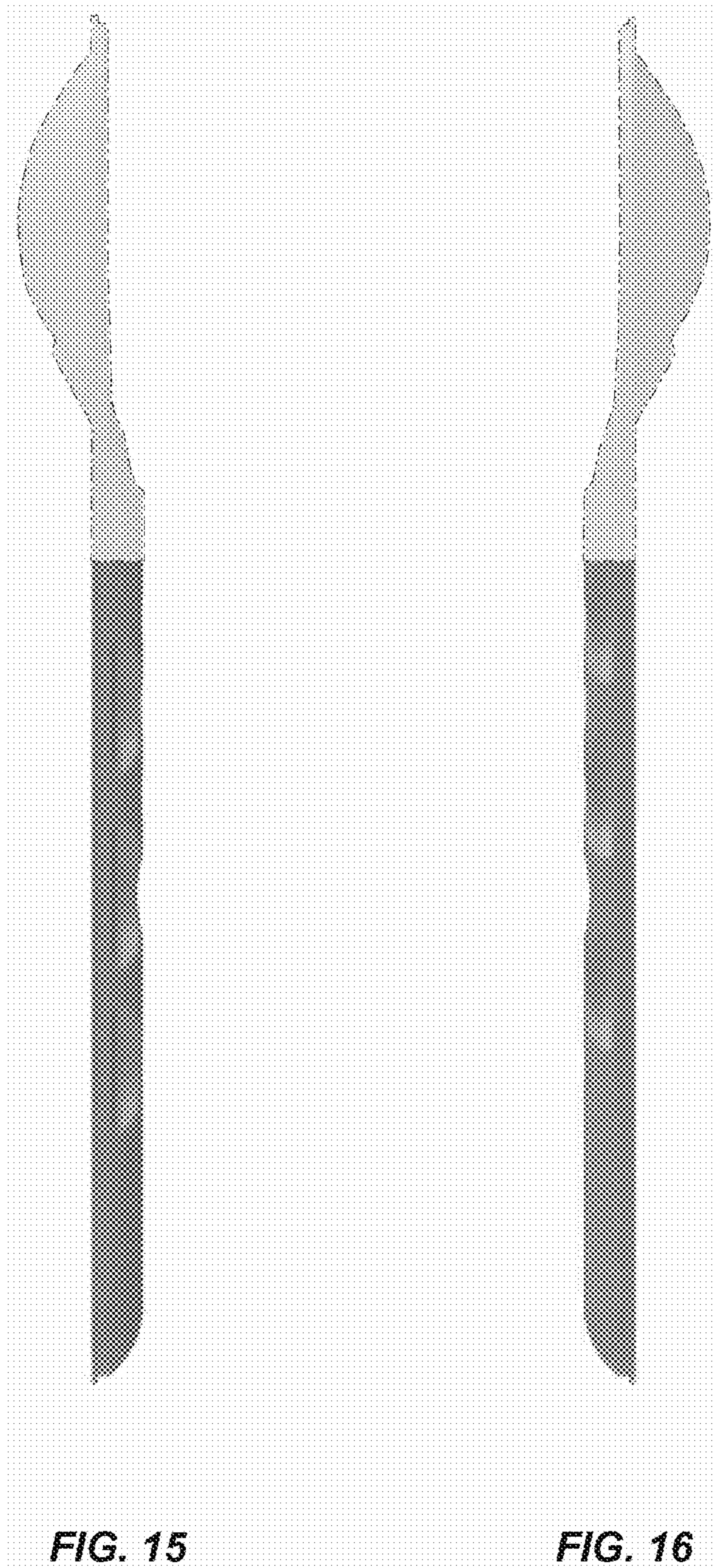


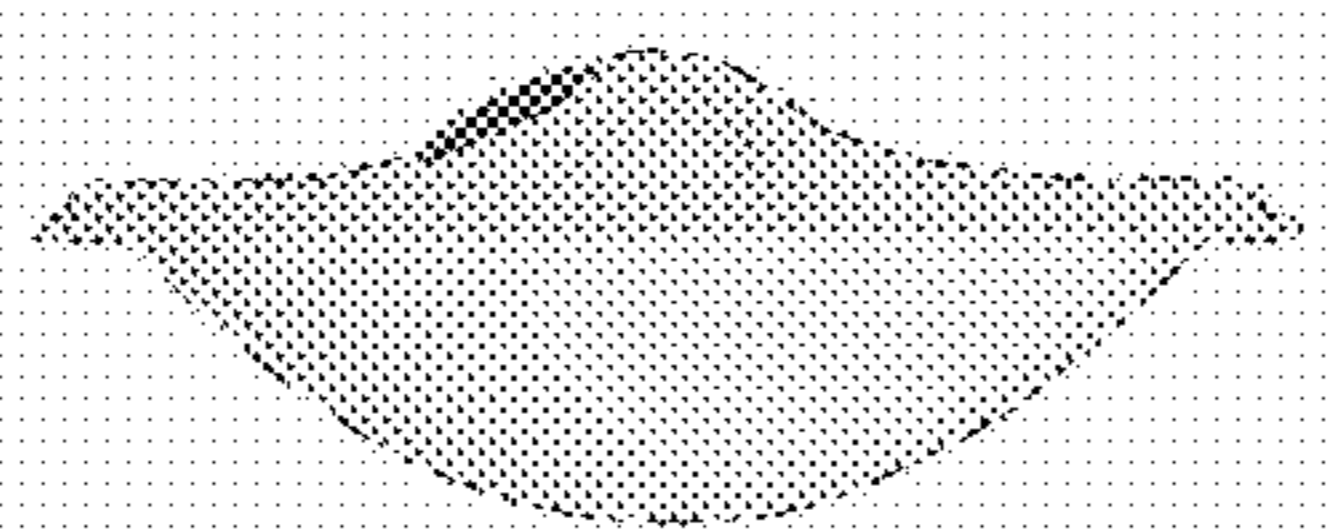




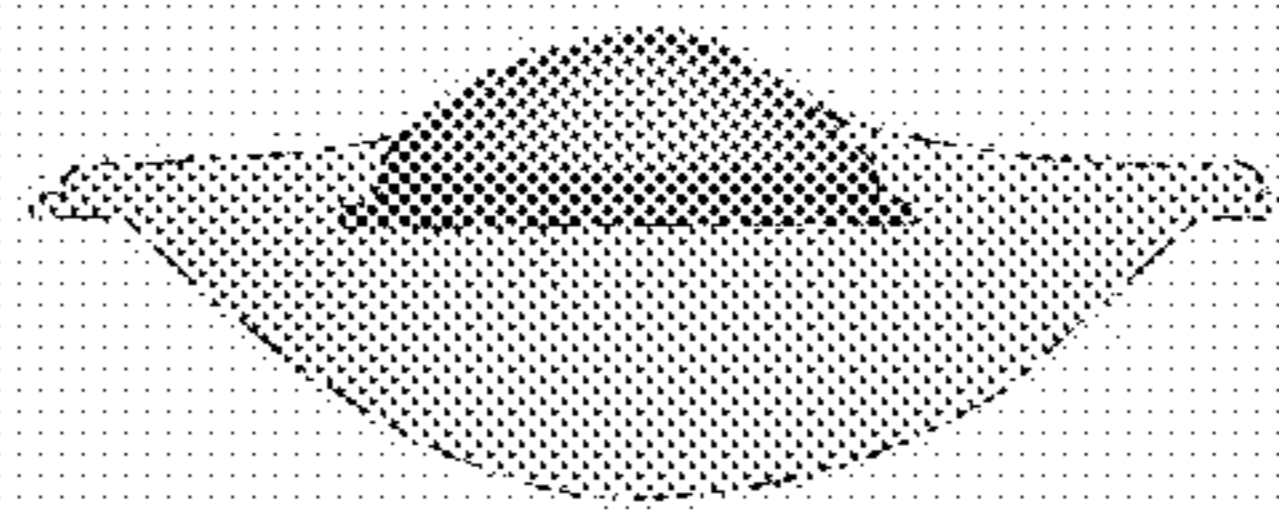

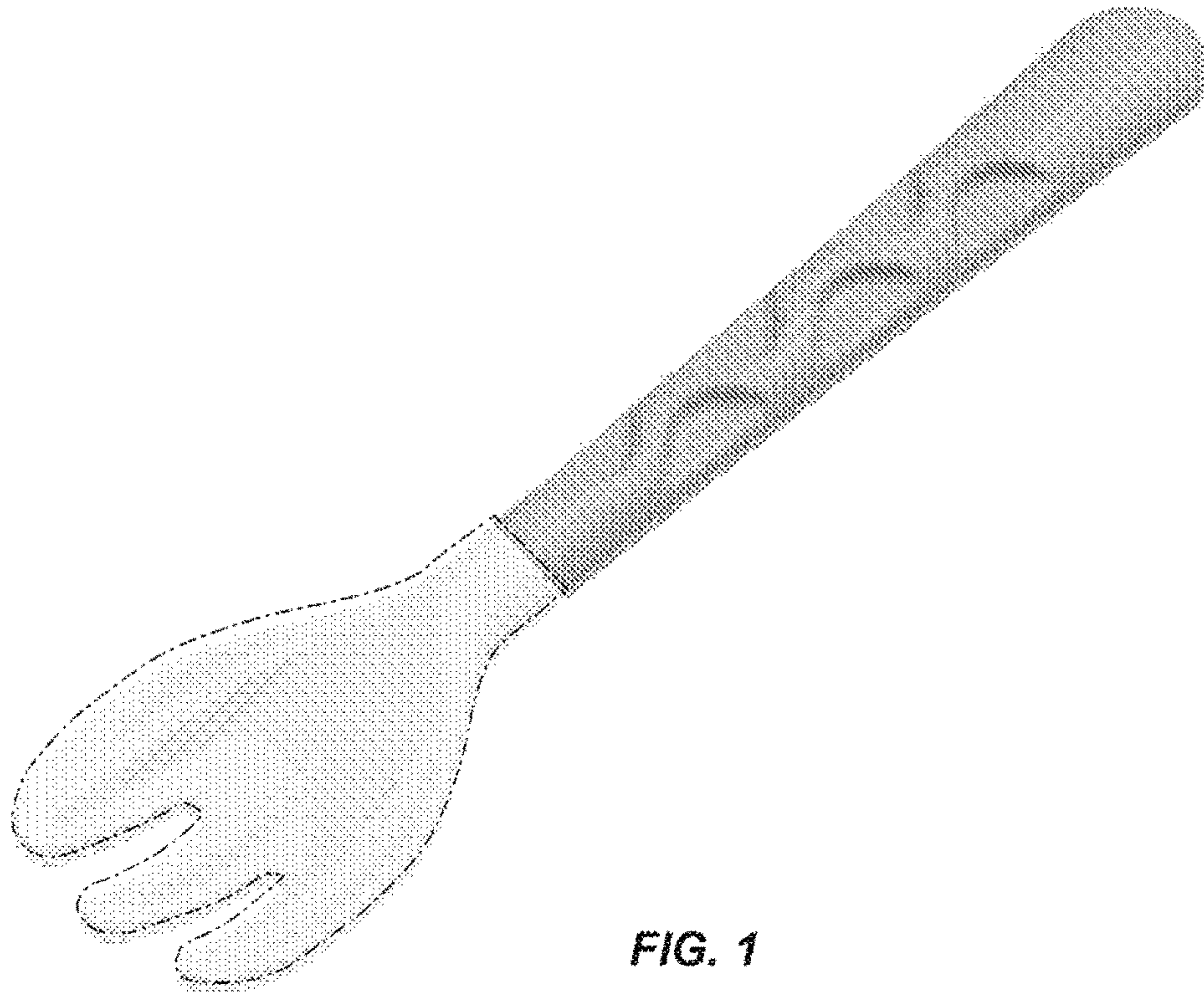

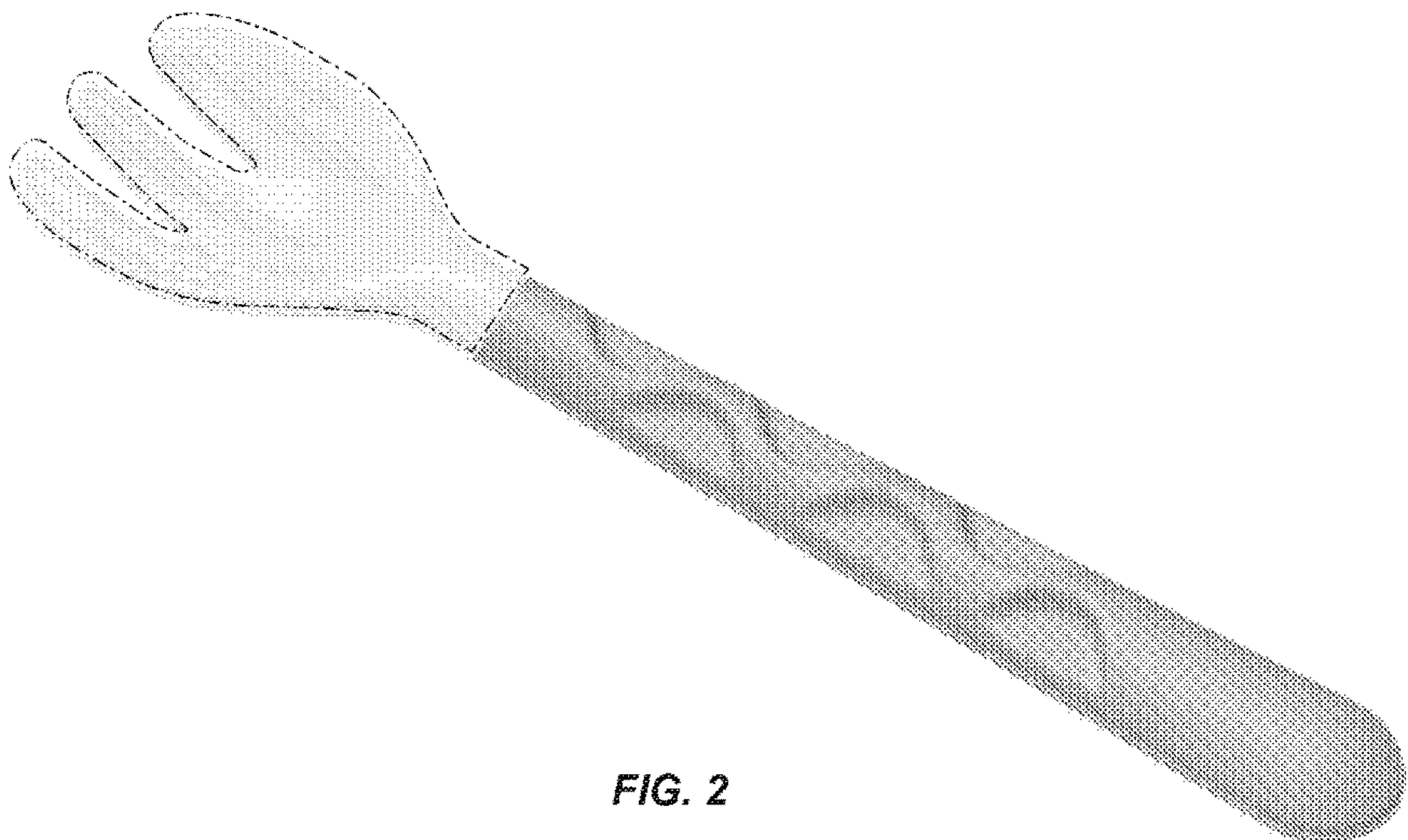

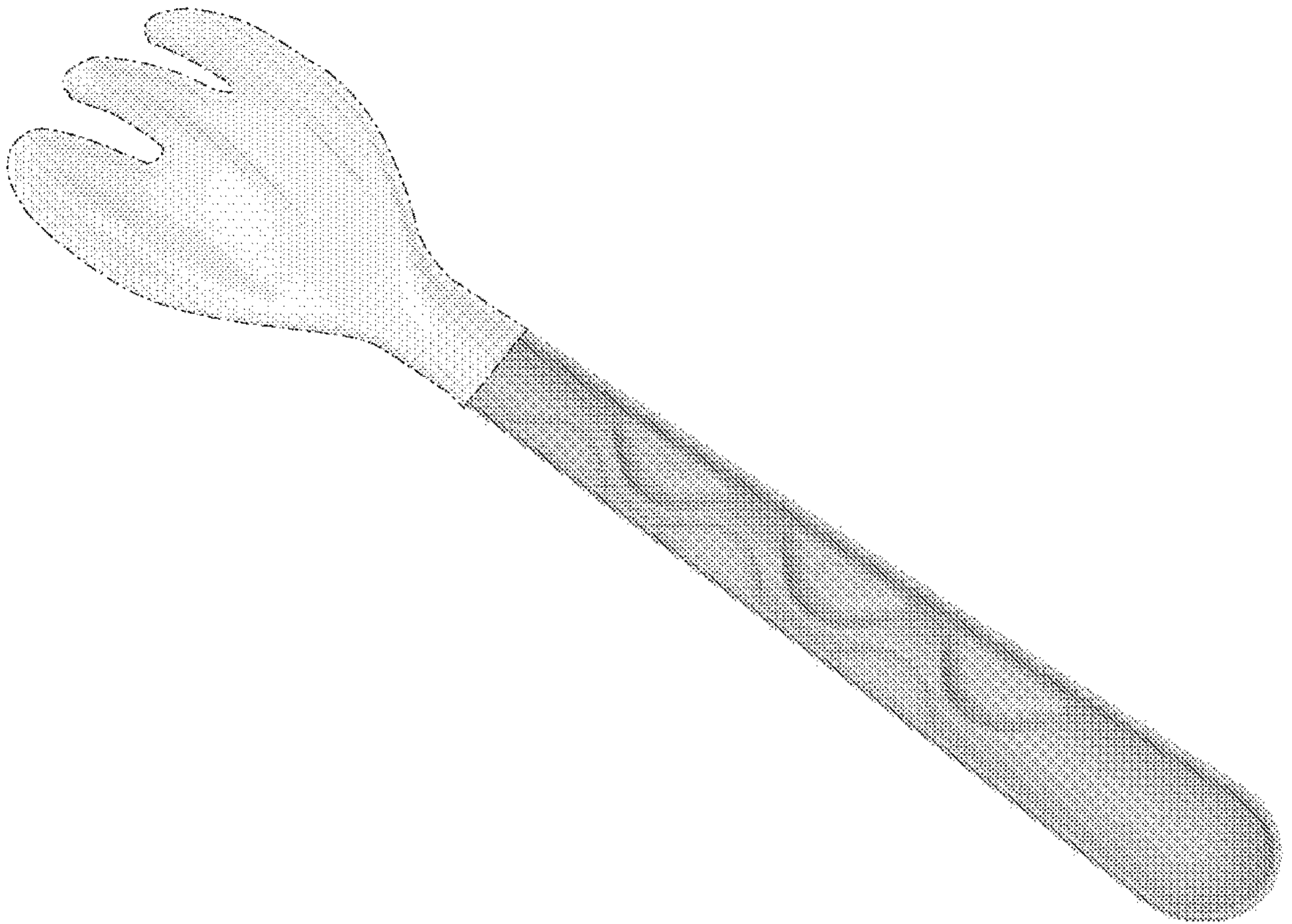

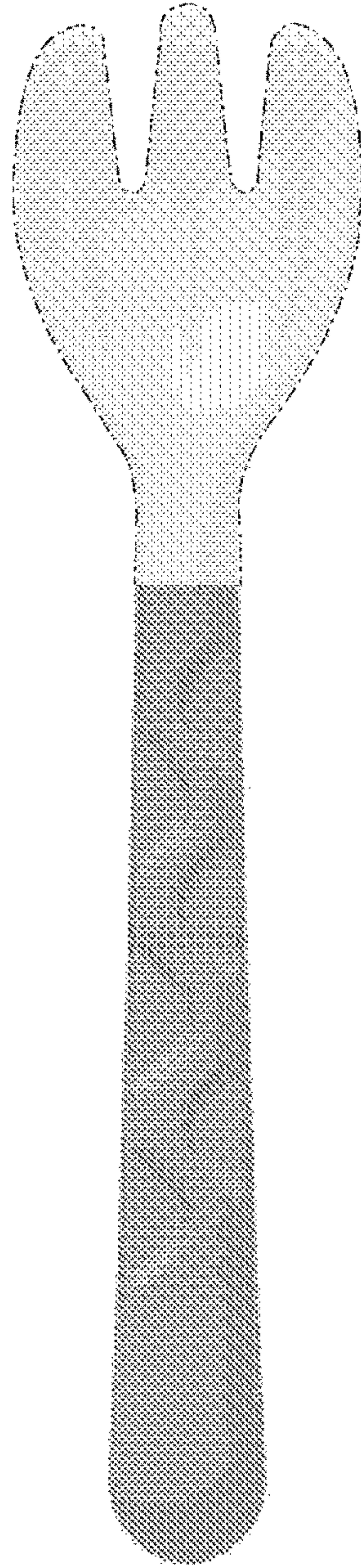

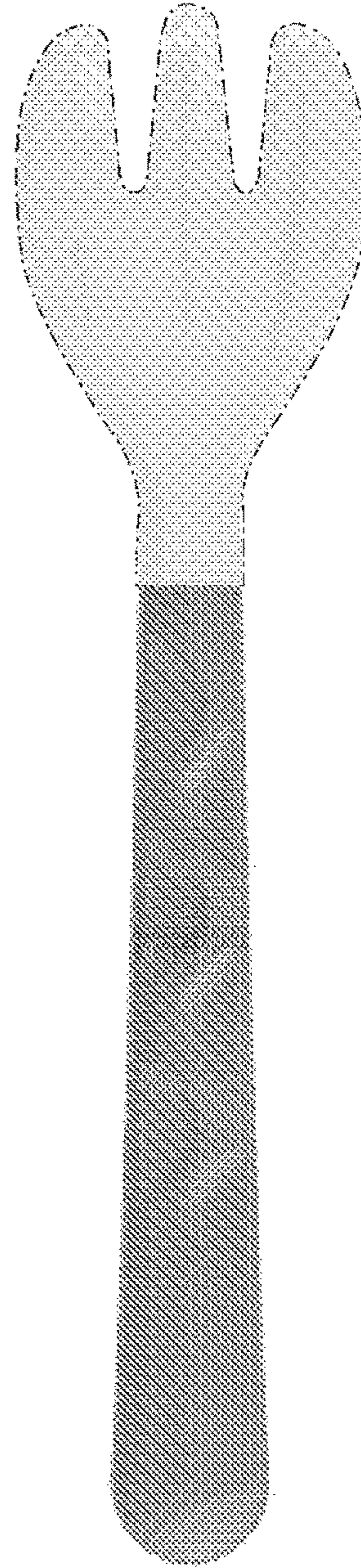

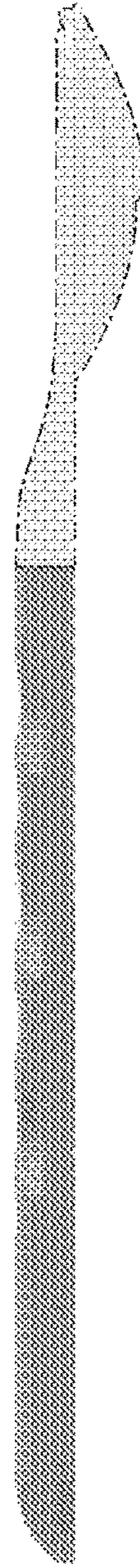

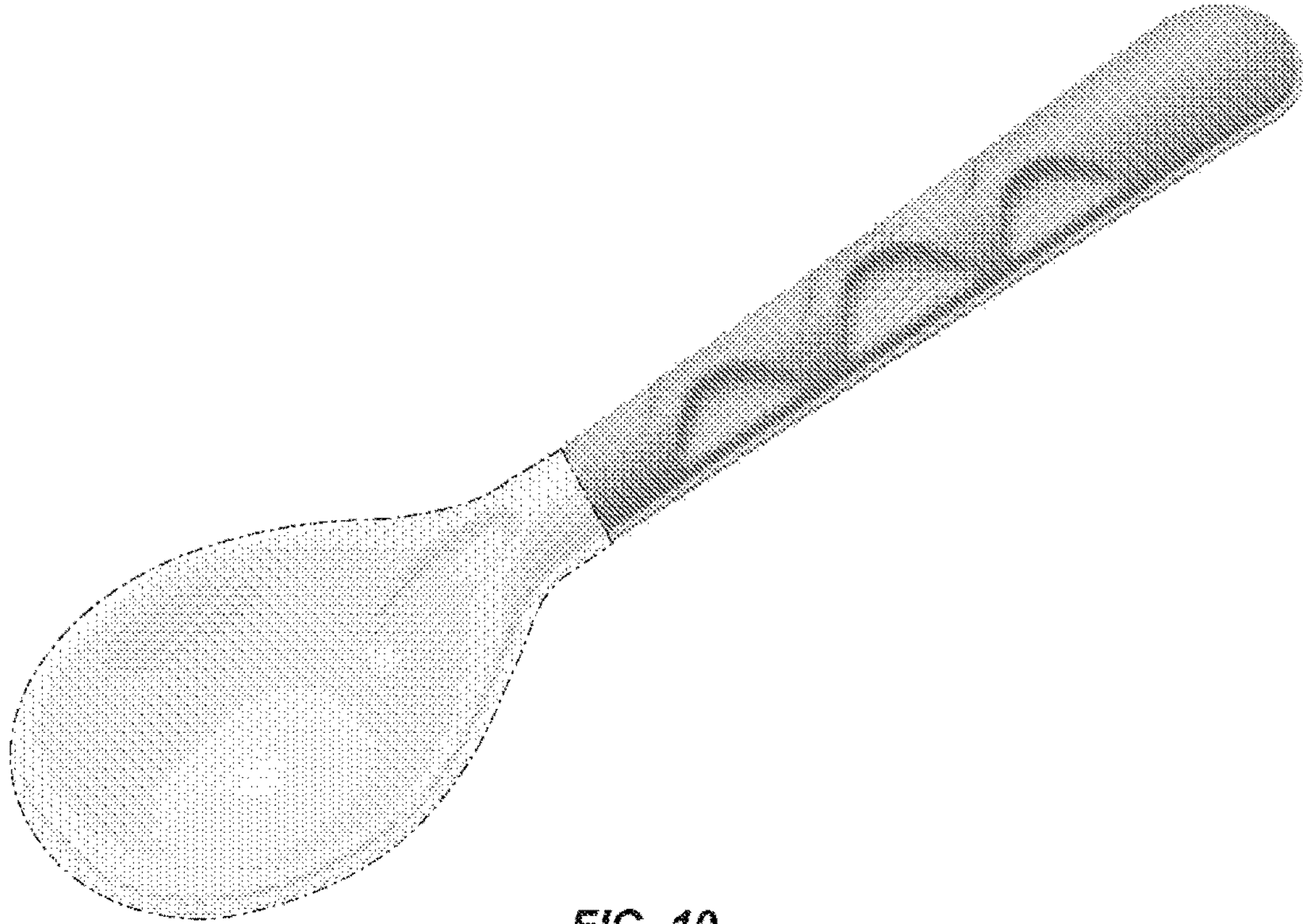

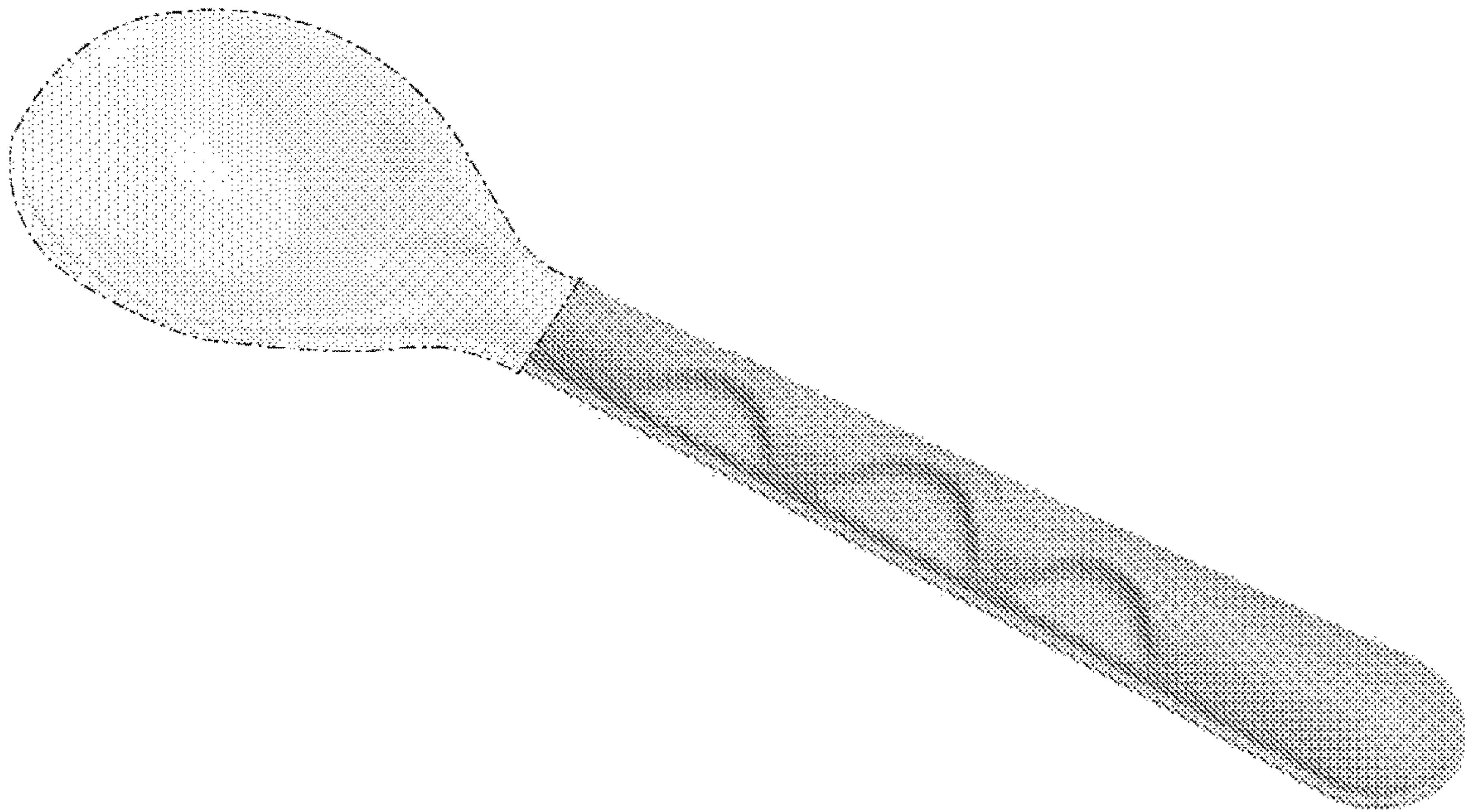

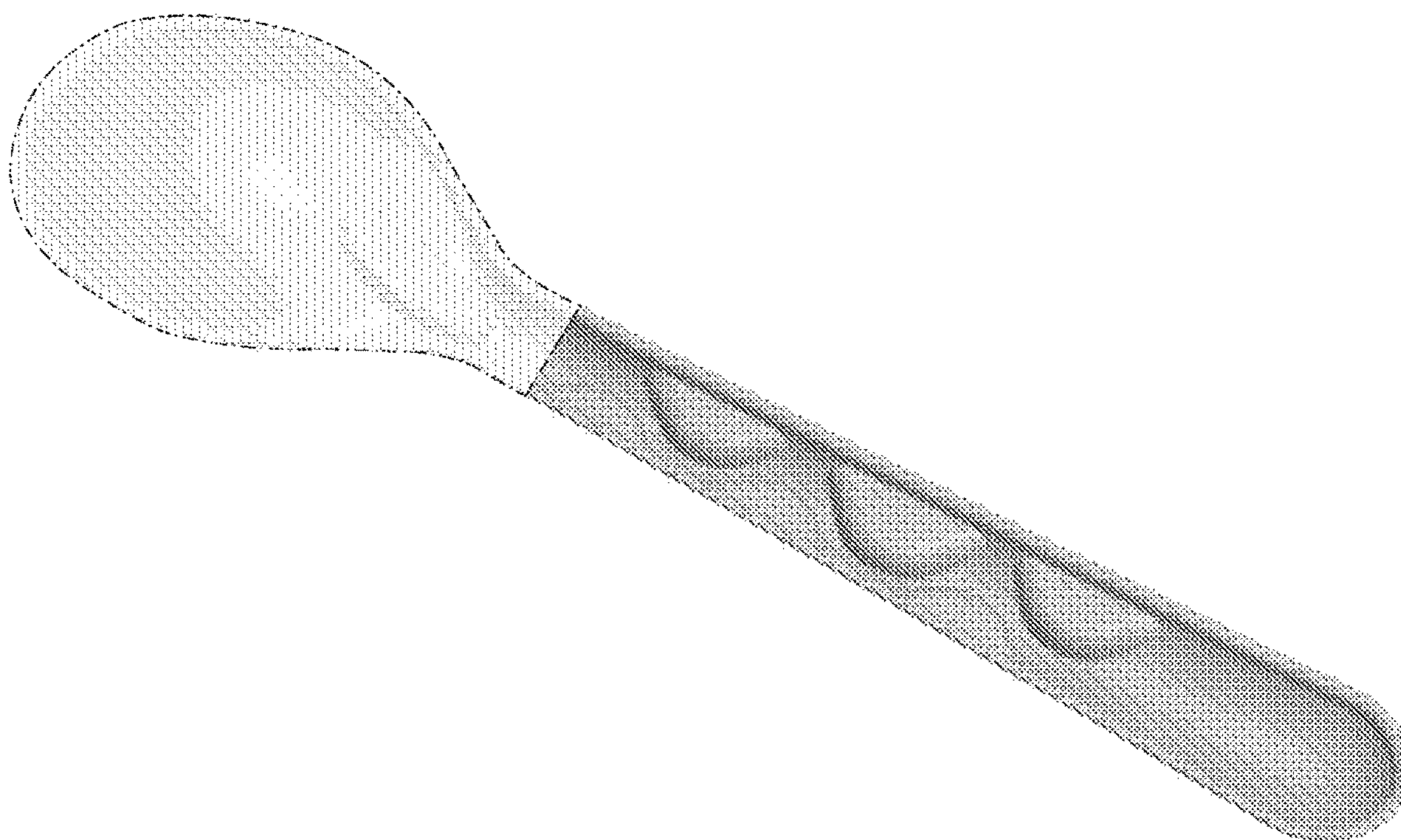

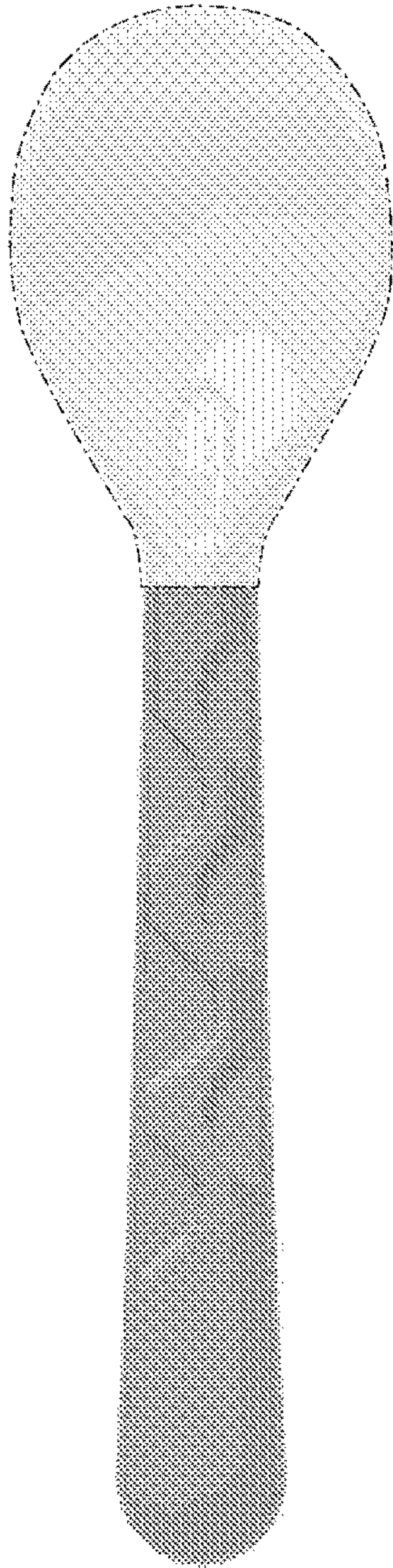

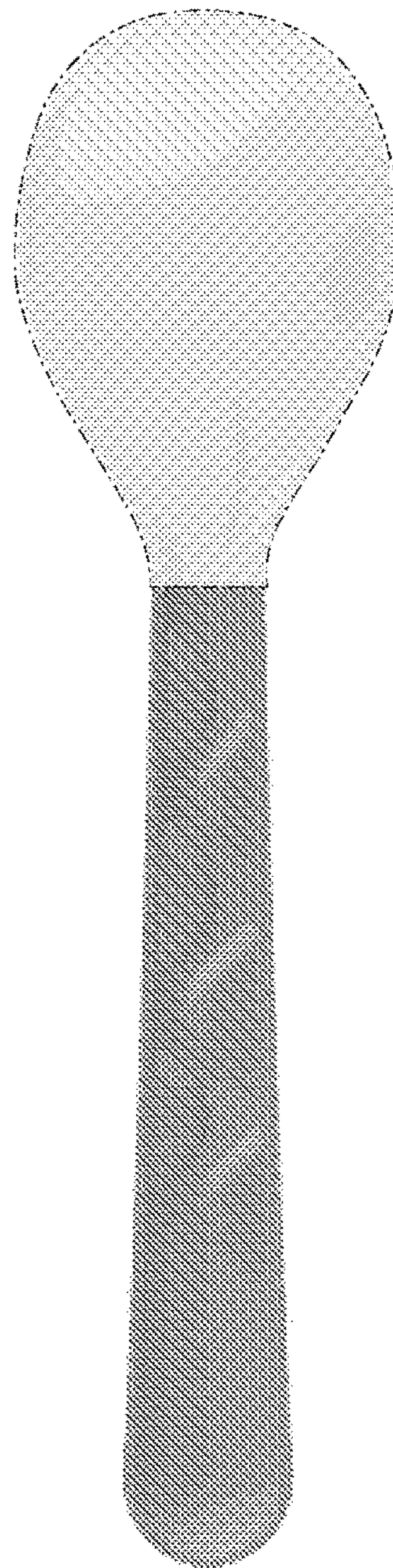

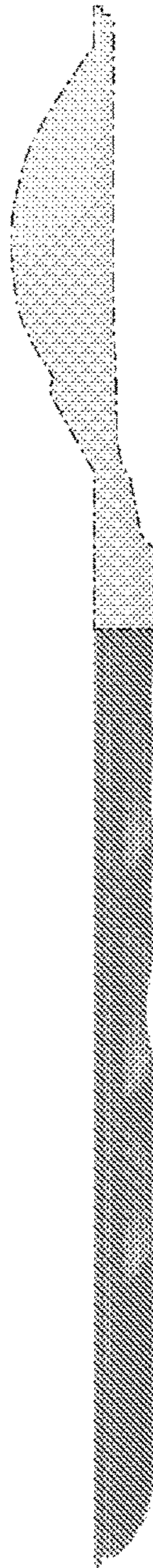

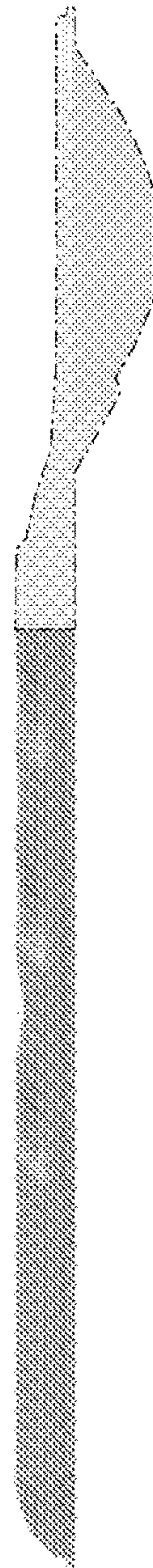

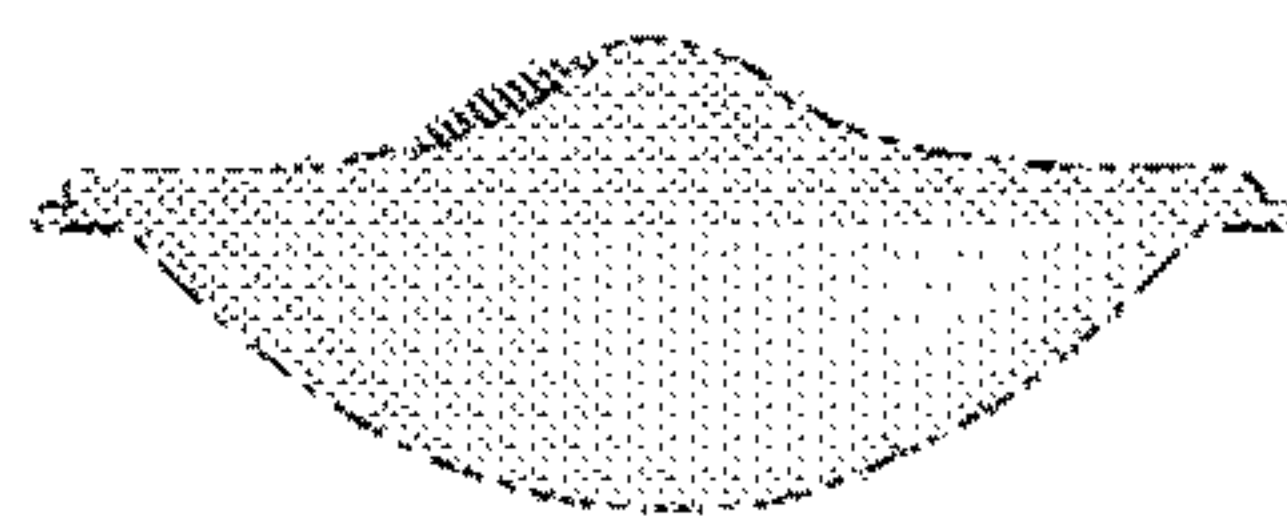

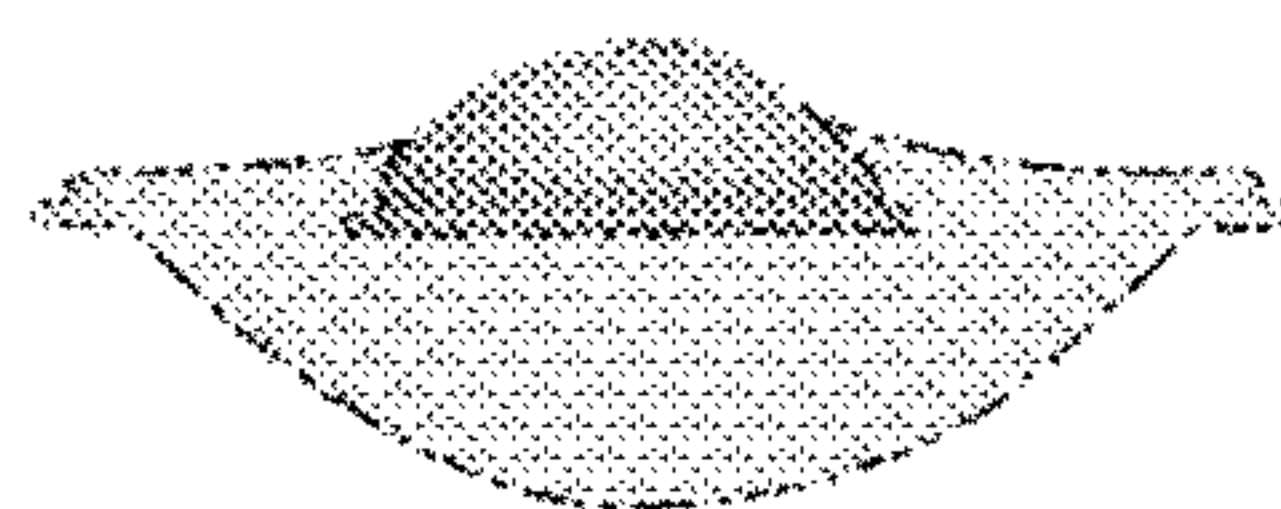
