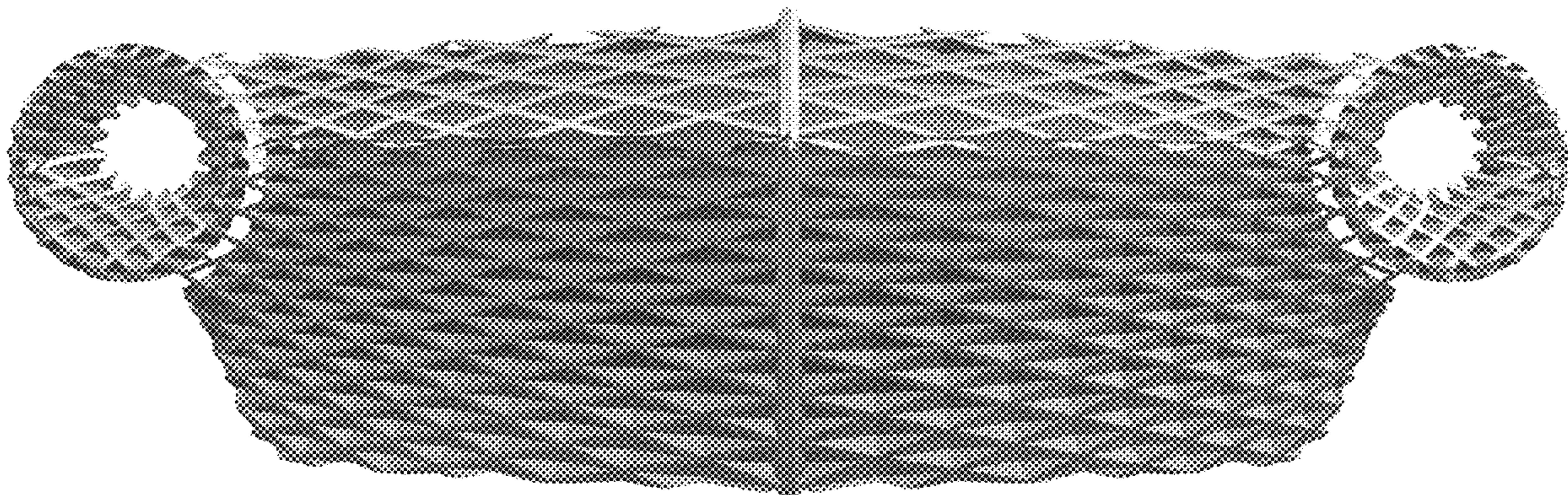
(57) **CLAIM**

The ornamental design for a radiator grille, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a radiator grille illustrating my ornamental design;
FIG. 2 is a right side elevation view thereof, the left side view being a mirror image; and,
FIG. 3 is a top plan view thereof.
The de-emphasized portions of the radiator grille are for the purpose of illustrating environmental structure that forms no part of the claimed design.

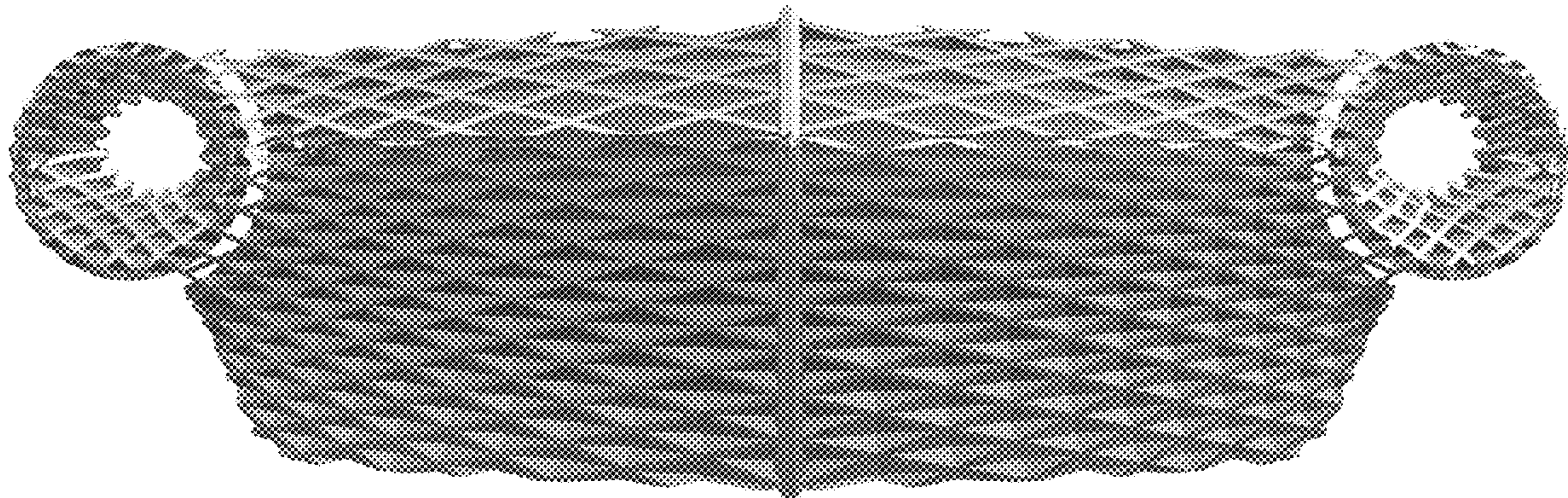

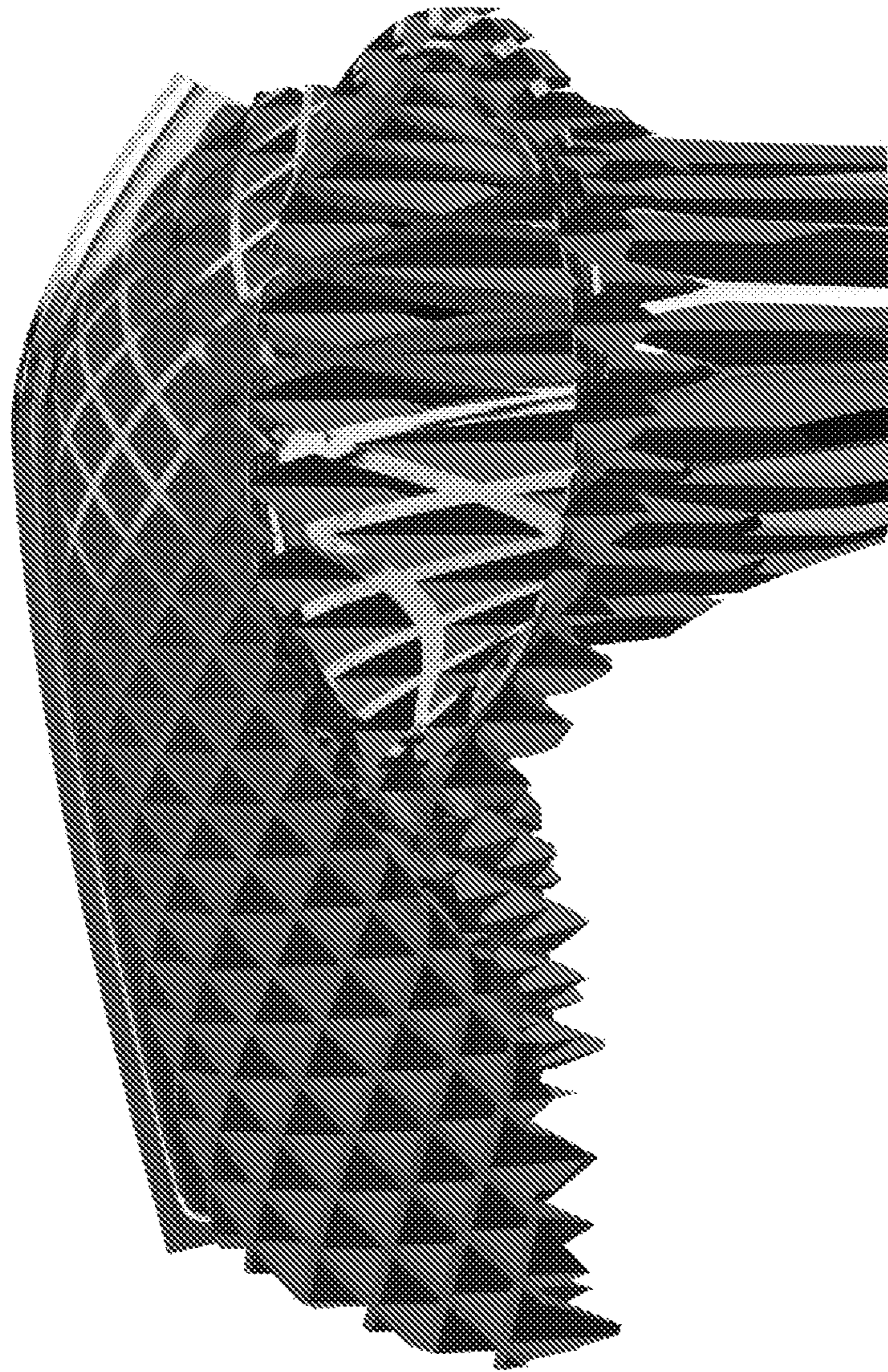
