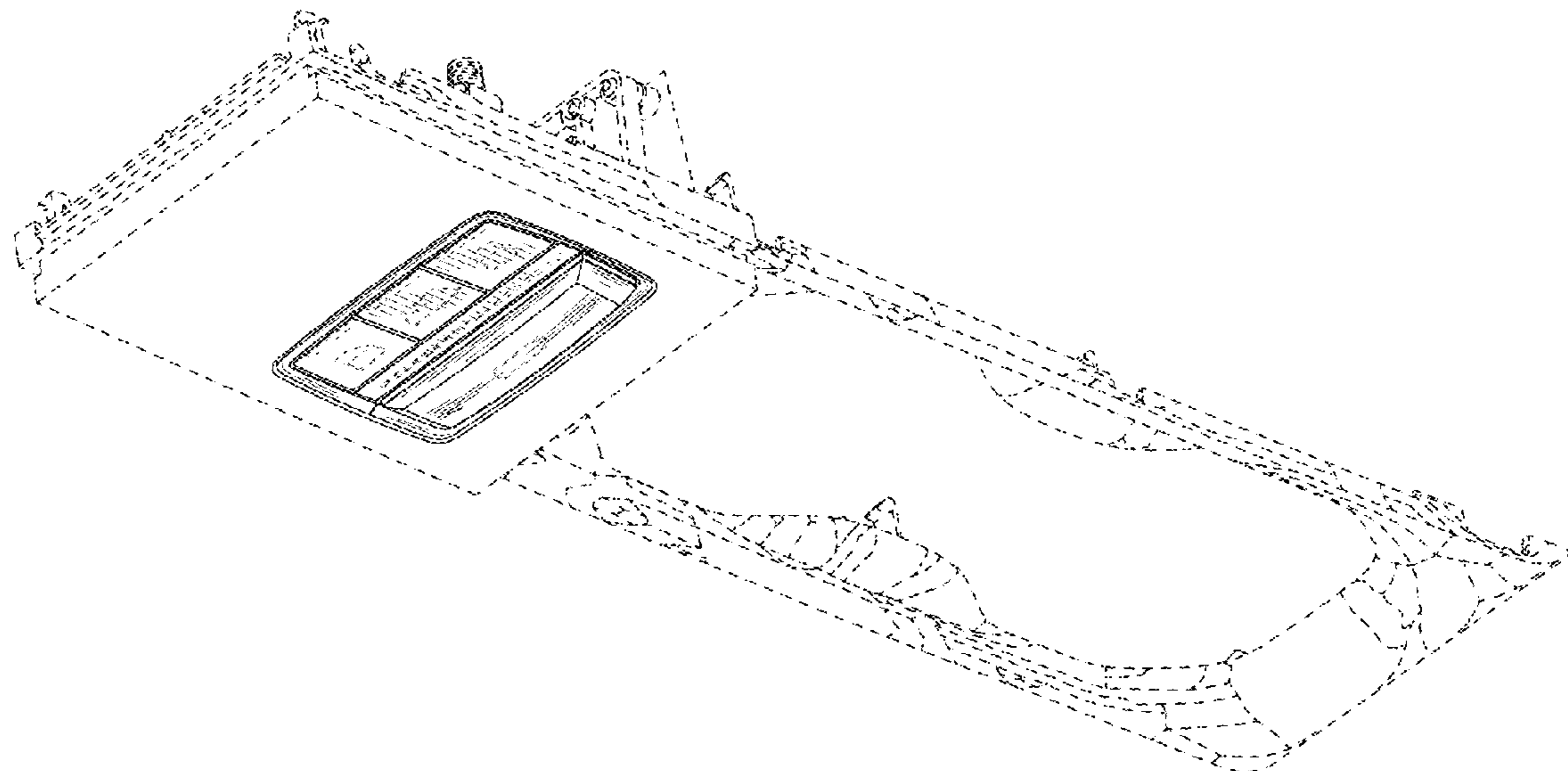
(57) **CLAIM**

We claim the ornamental design for a control switch, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a bottom first side perspective view of a control switch of the present disclosure;

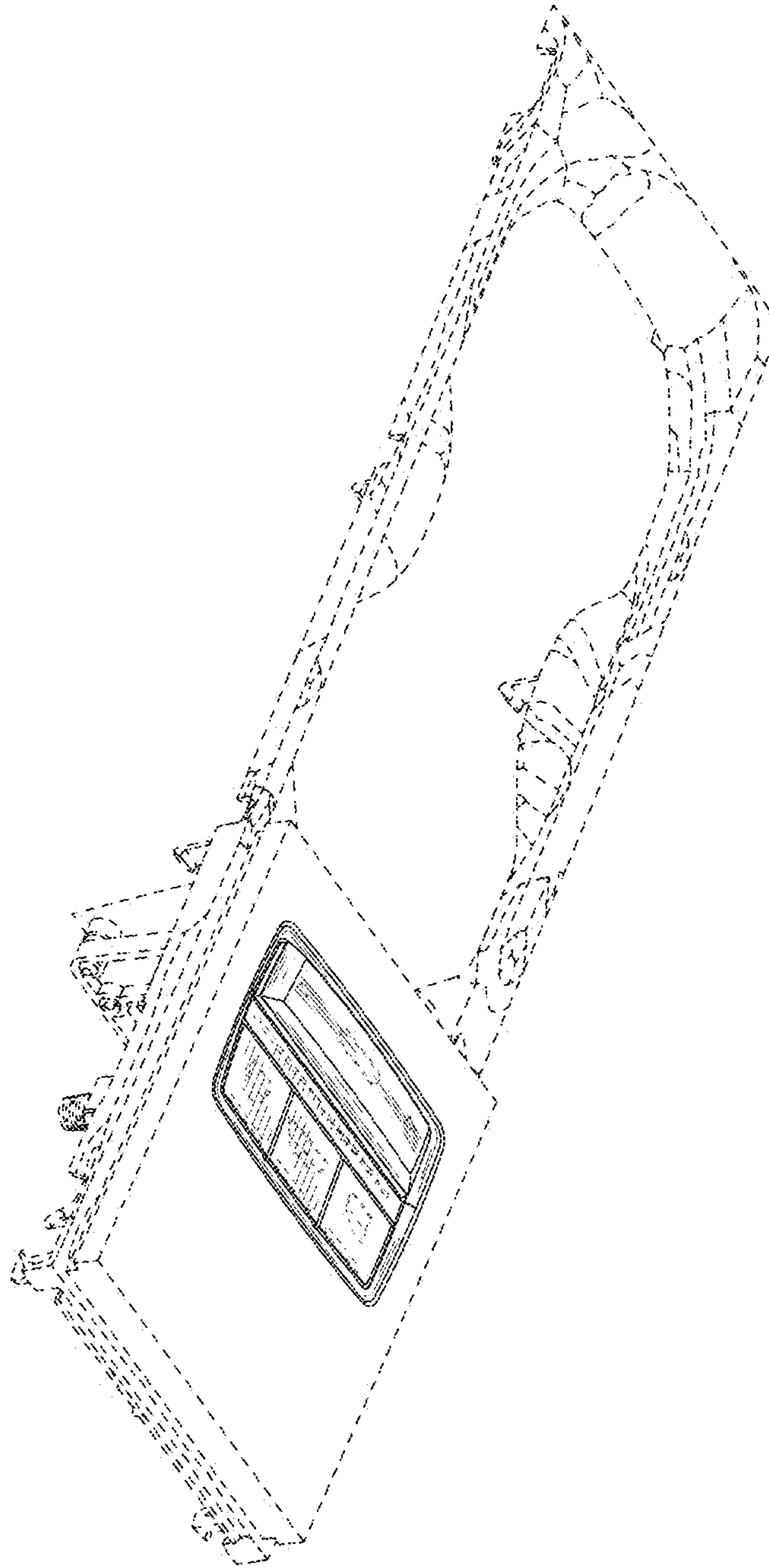

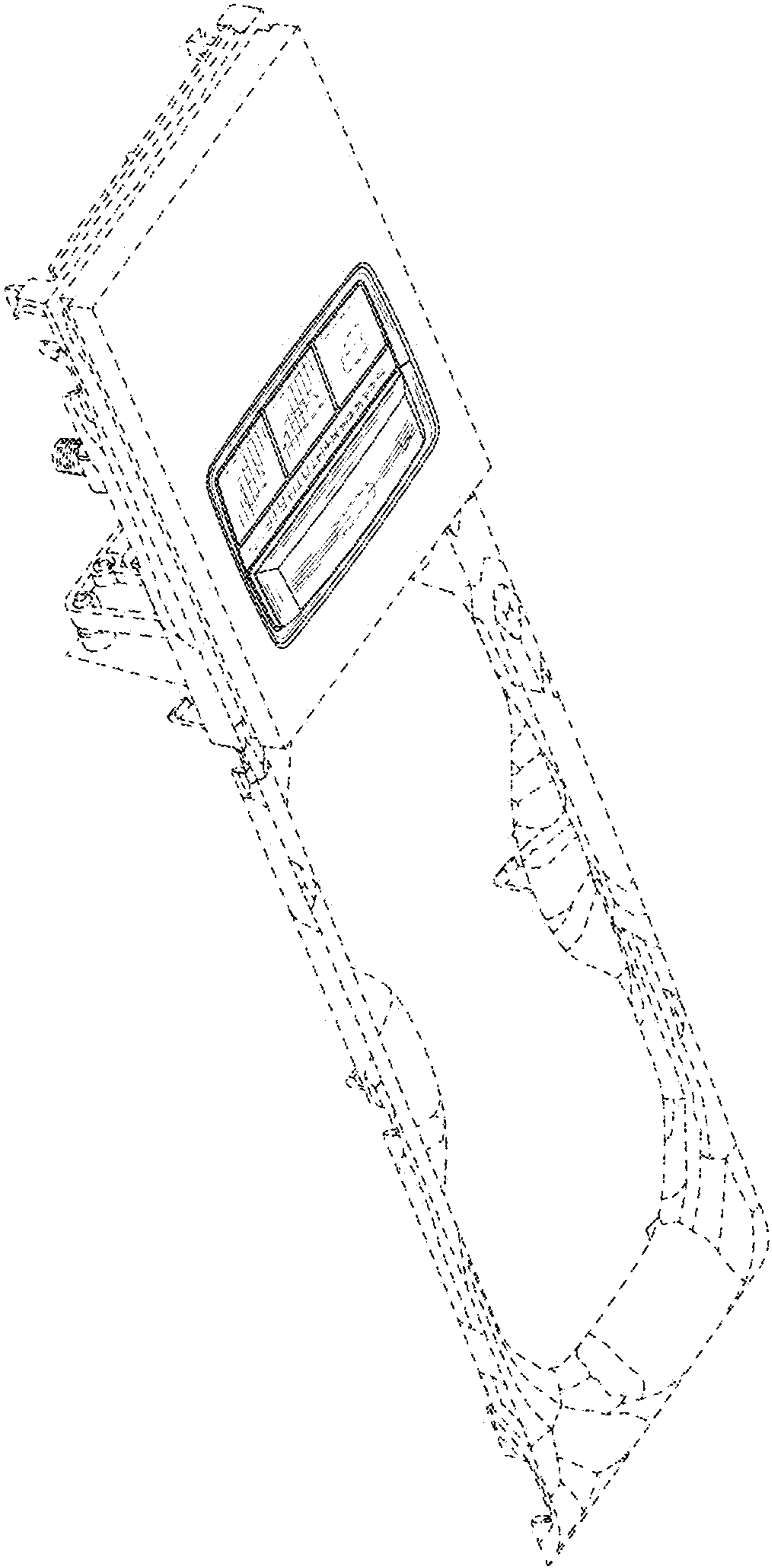
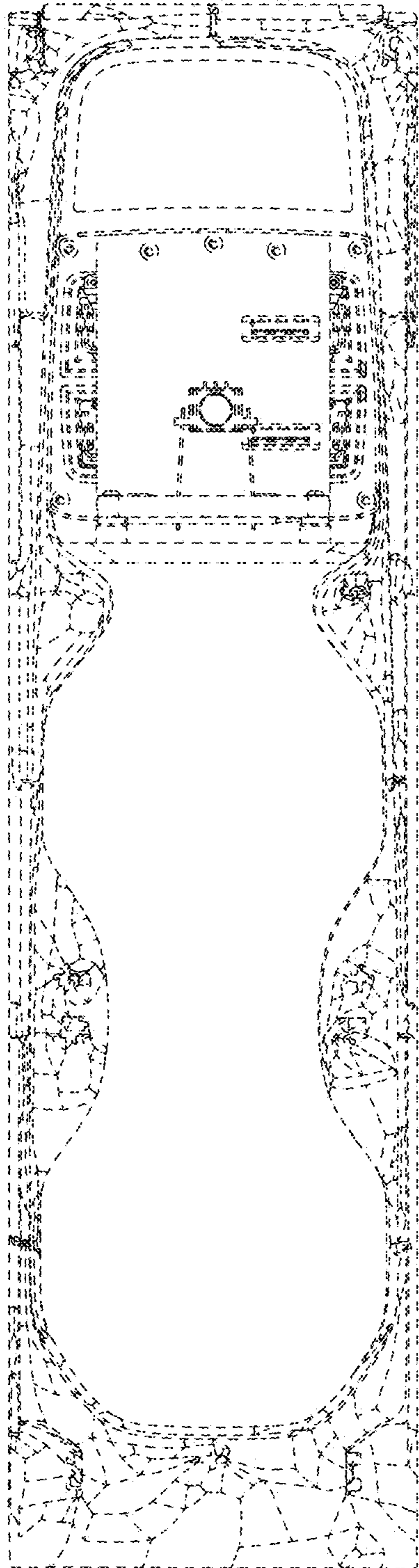
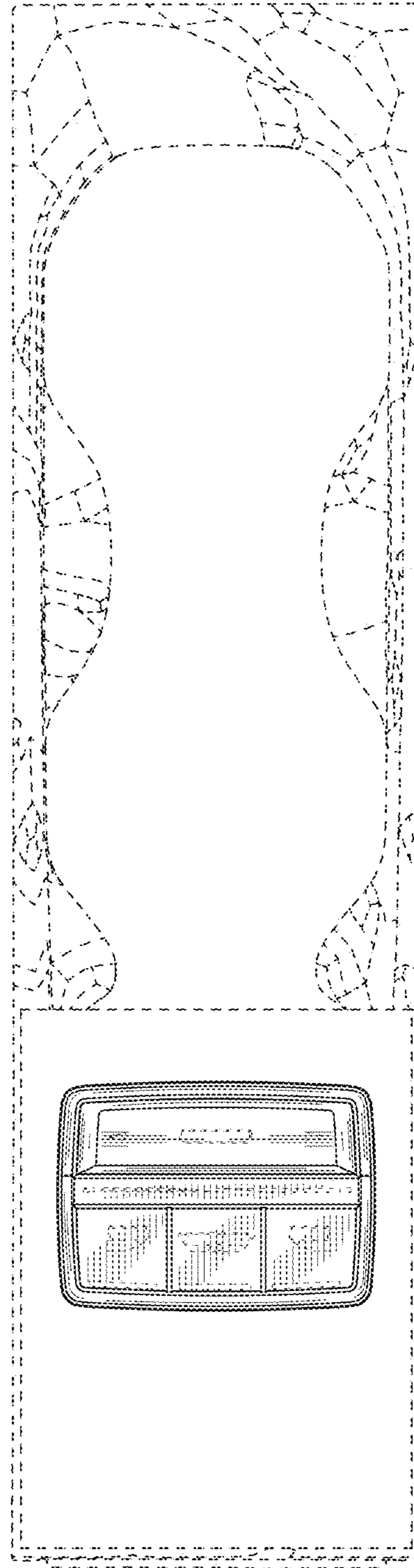

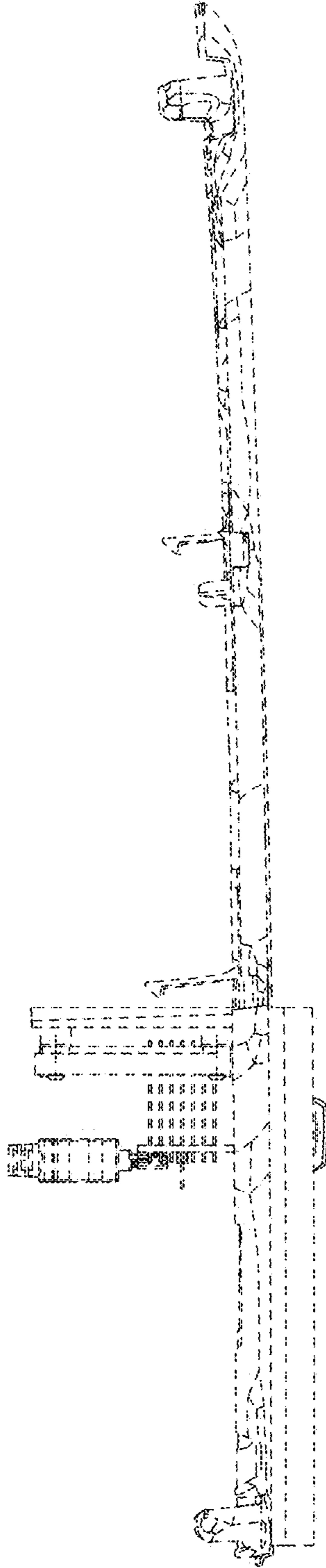




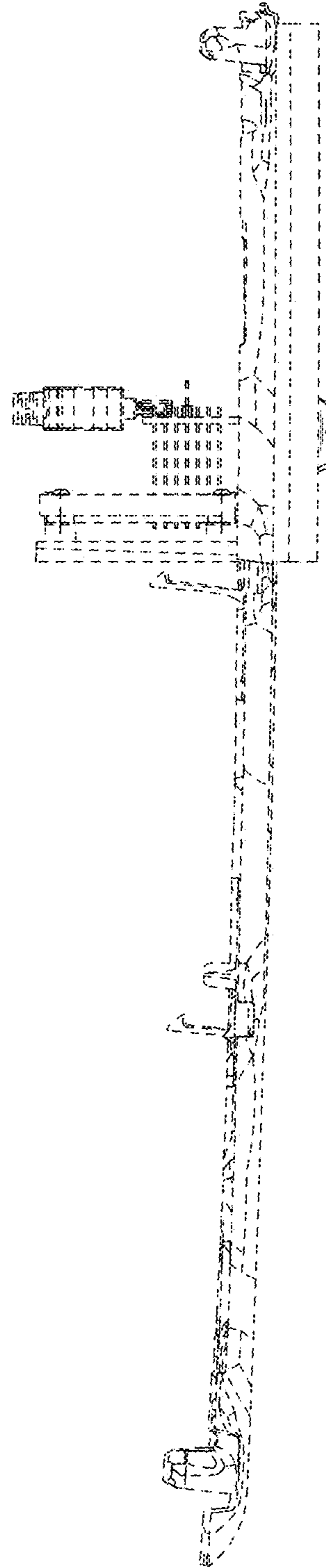

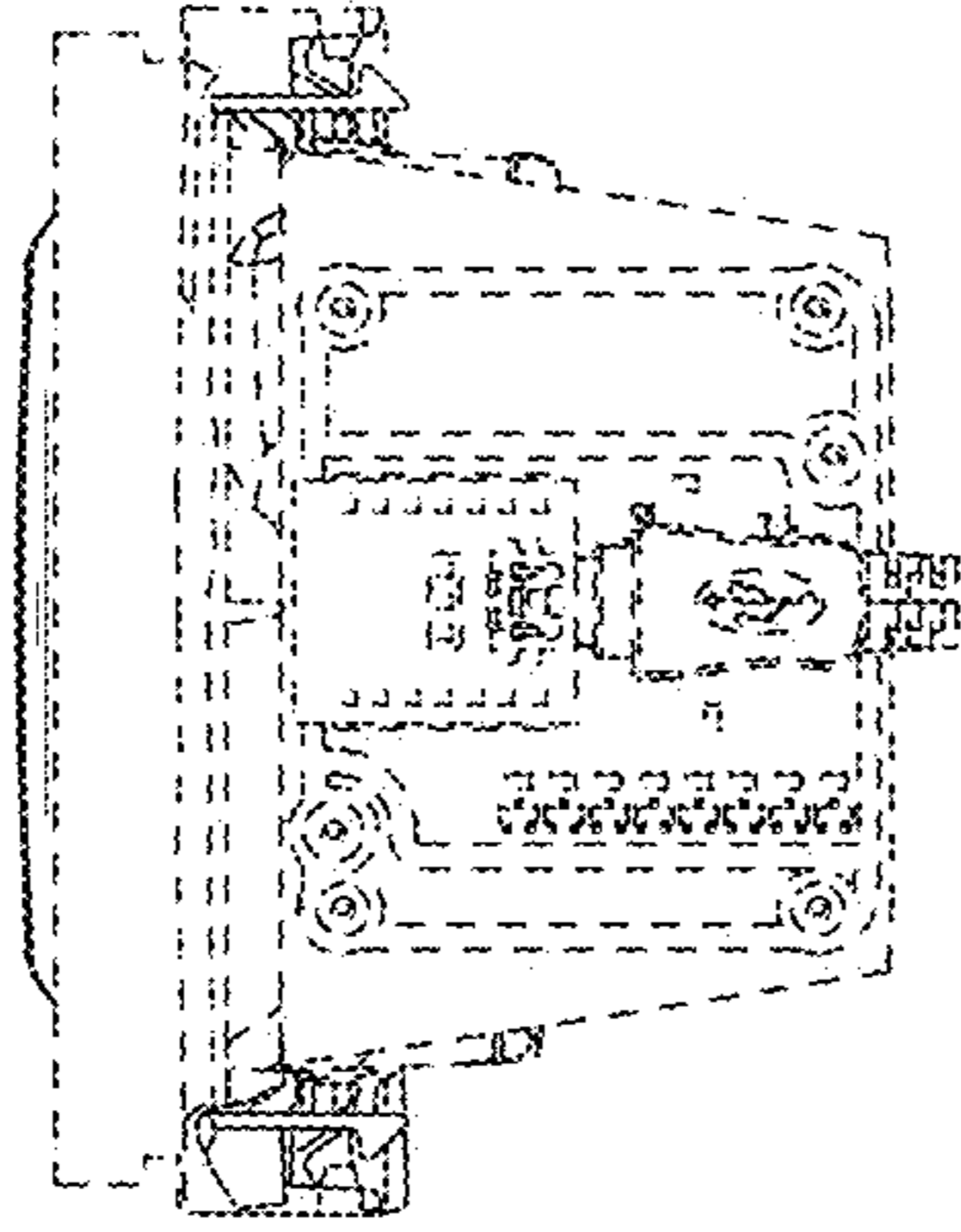

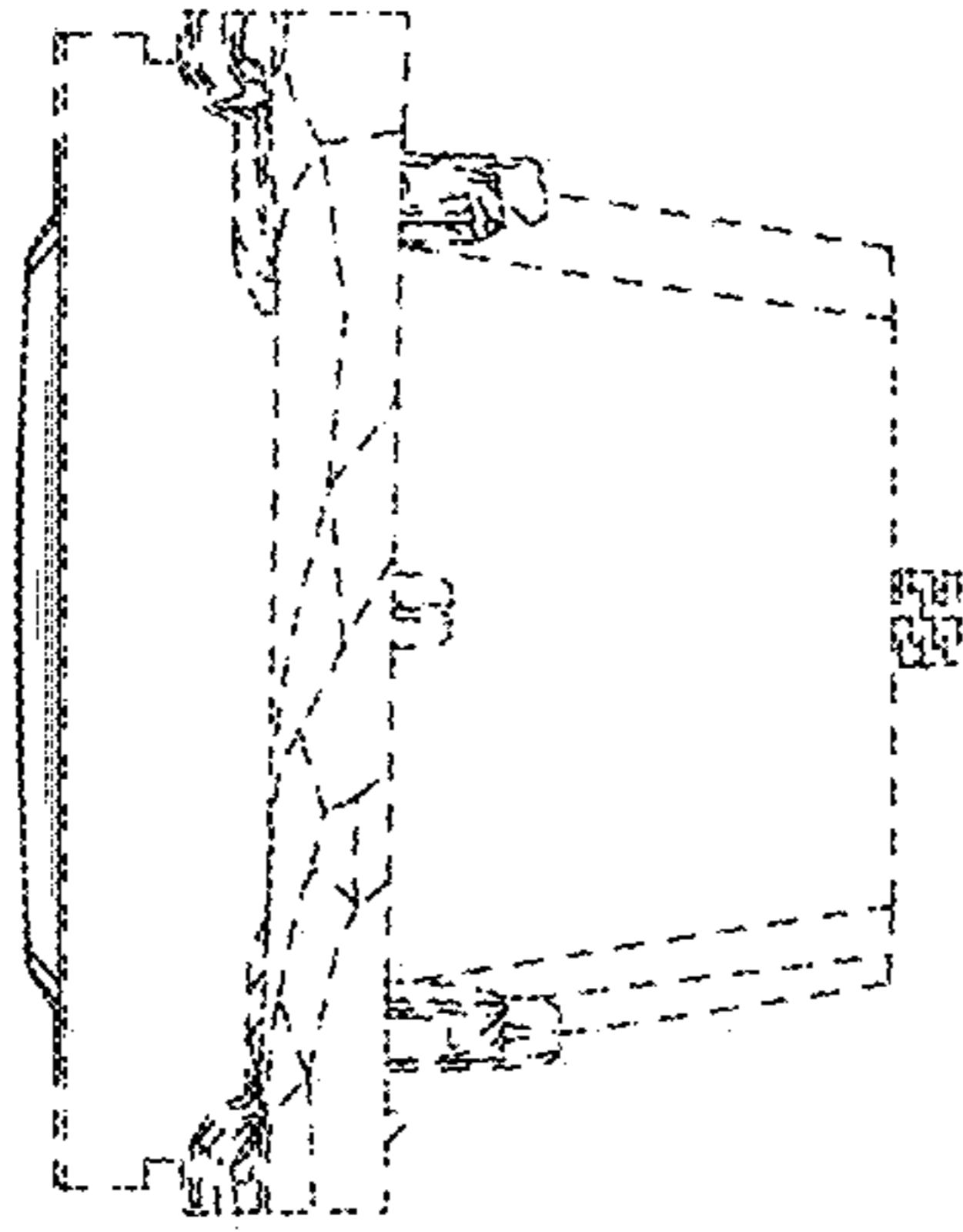
