The ornamental design for an automotive wheel, as shown and described.

DESCRIPTION
FIG. 1 is a front, top, right perspective view of a first embodiment of an automotive wheel showing our new design;
FIG. 2 is a front, top perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof.
FIG. 8 is a front, top, right perspective view of a second embodiment of an automotive wheel showing our new design;
FIG. 9 is a front, top perspective view of FIG. 8;
FIG. 10 is a front elevational view of FIG. 8;
FIG. 11 is a left side elevational view of FIG. 8;
FIG. 12 is a right side elevational view of FIG. 8;
FIG. 13 is a top plan view of FIG. 8; and,
FIG. 14 is a bottom plan view of FIG. 8.

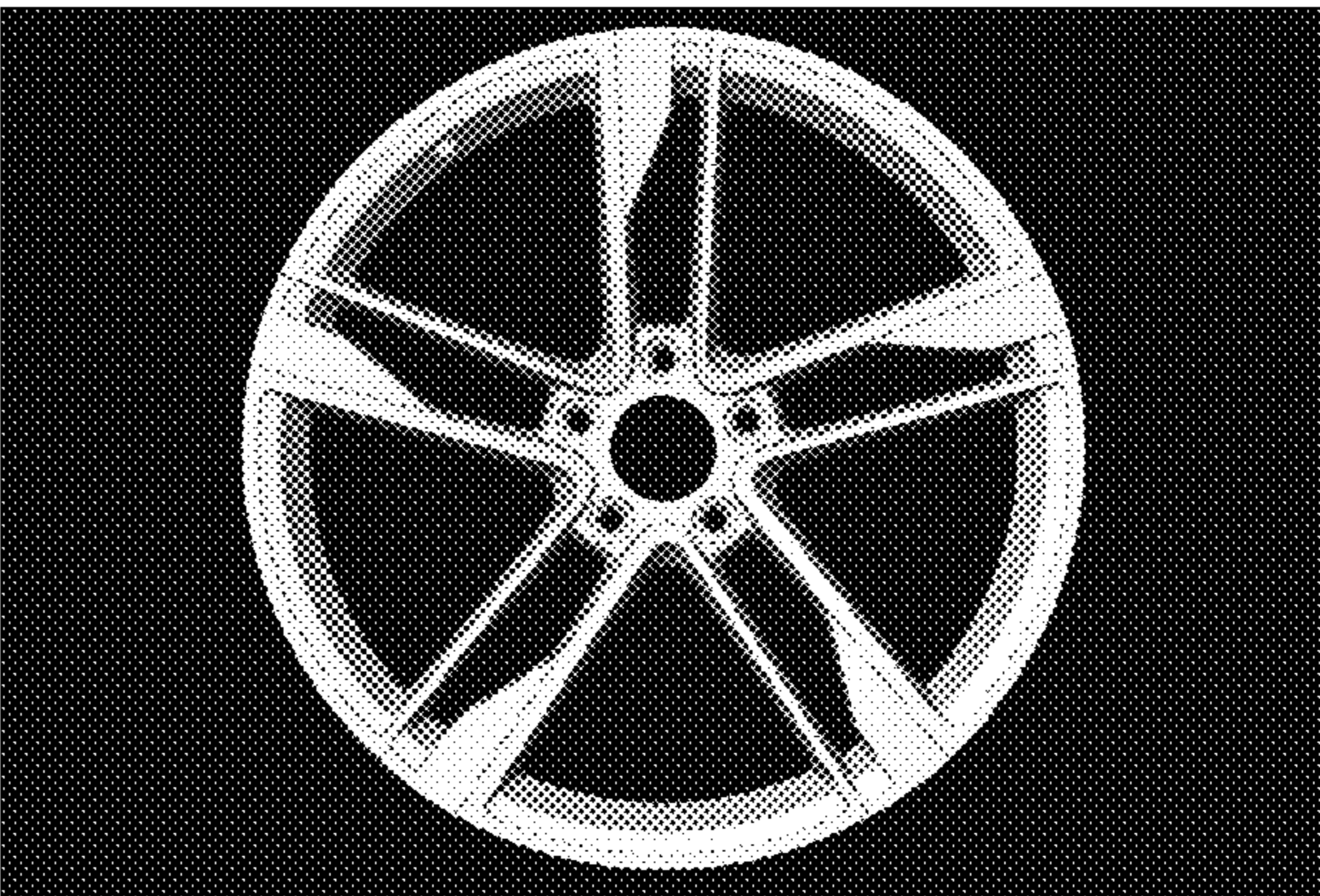
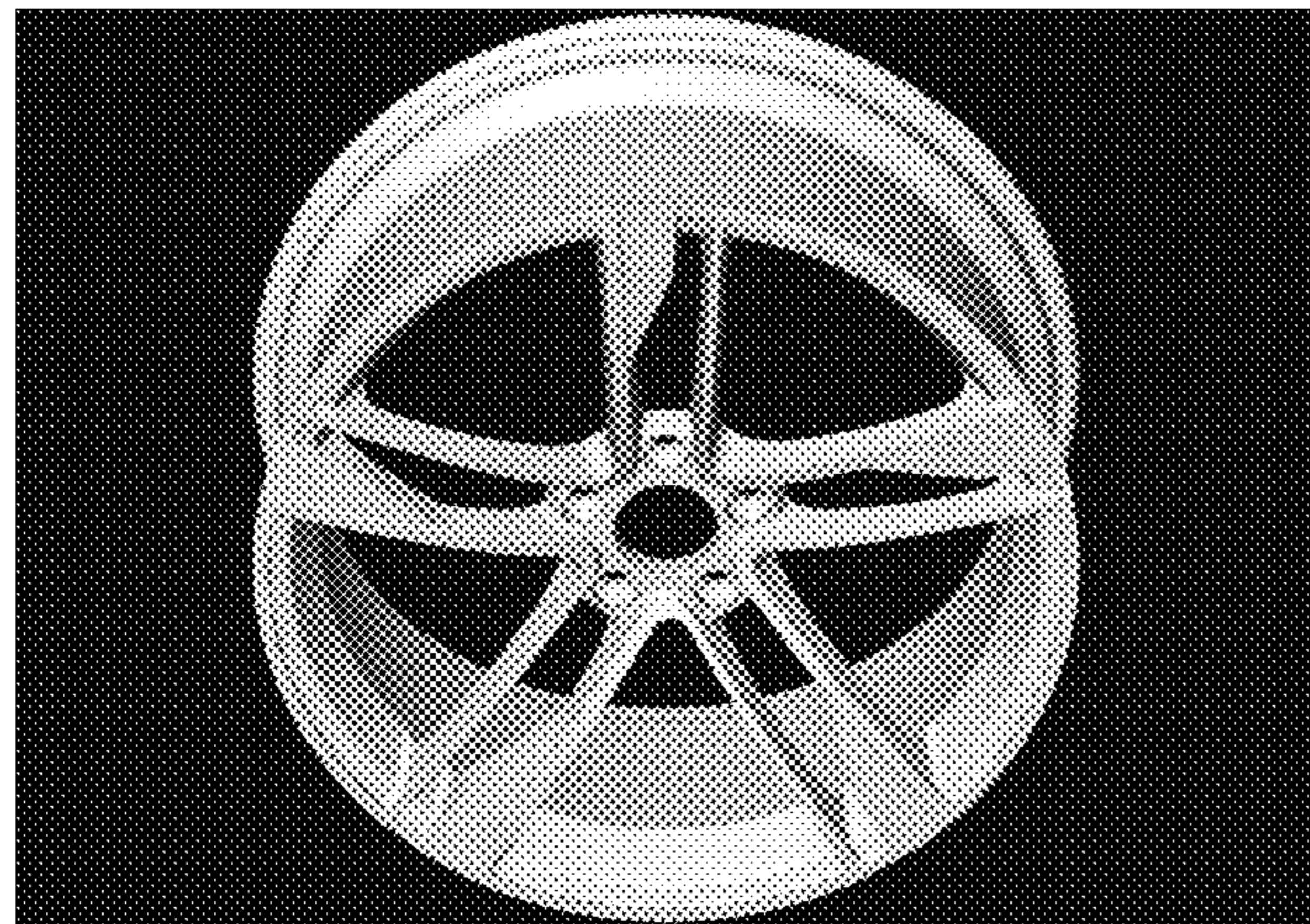

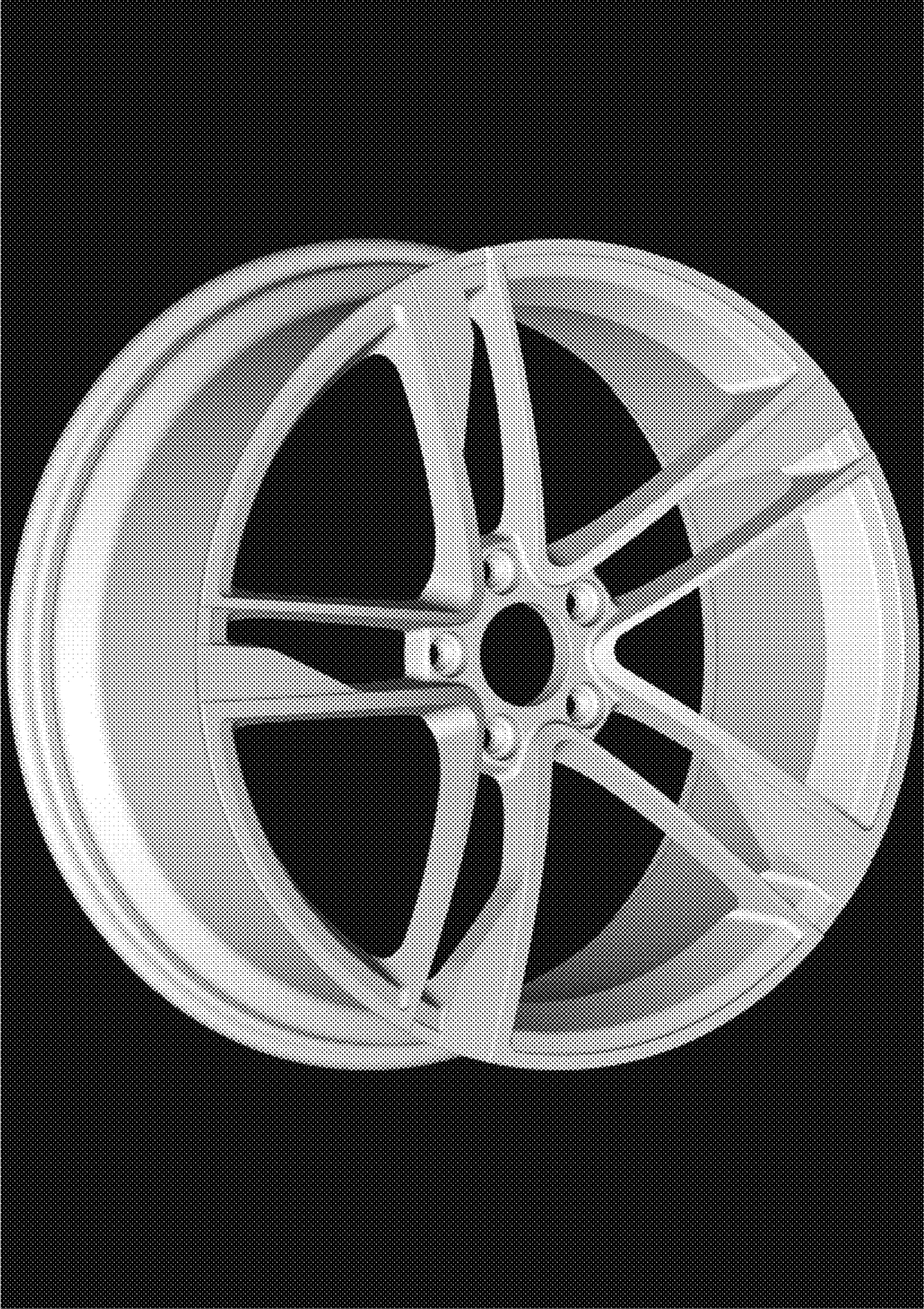

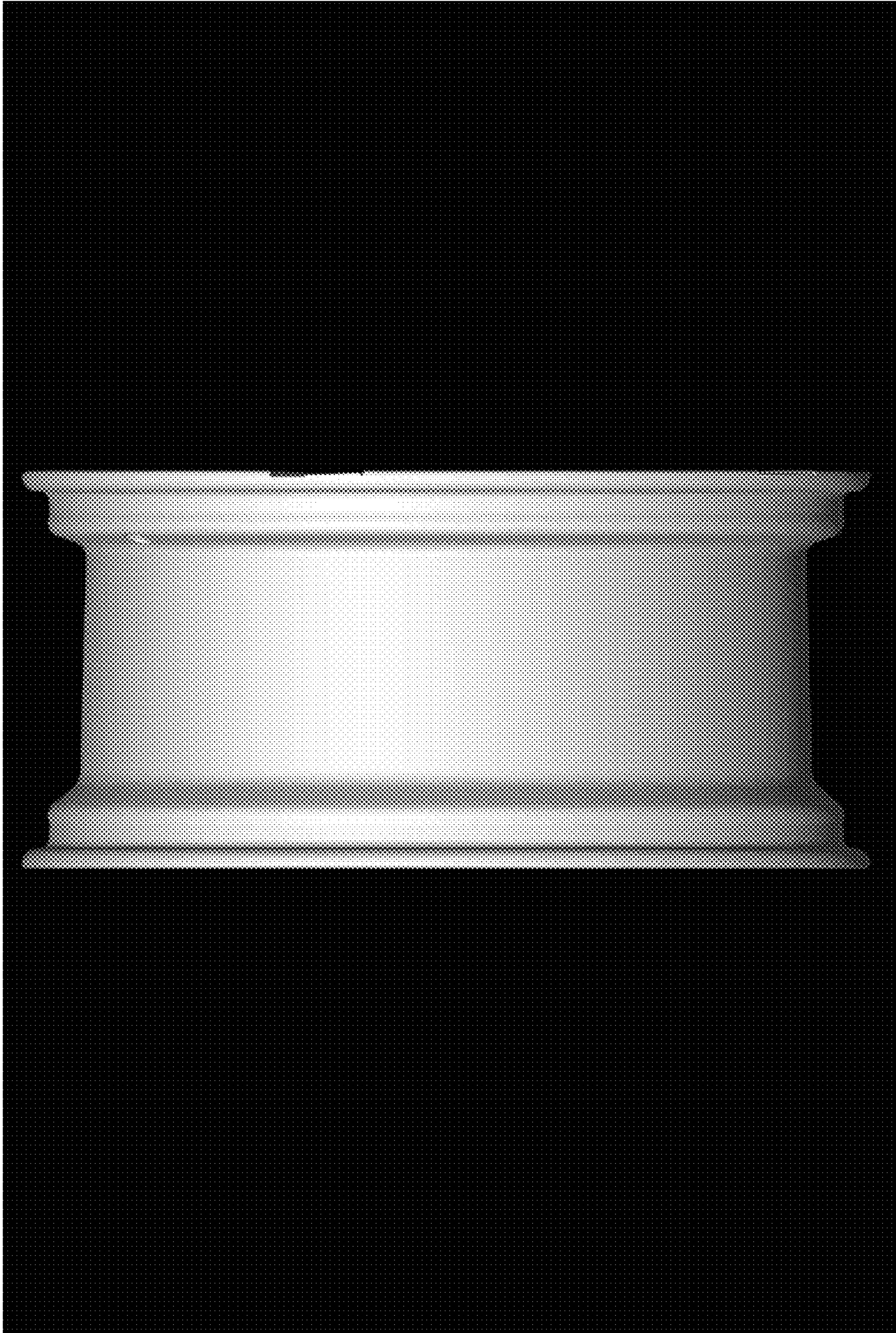

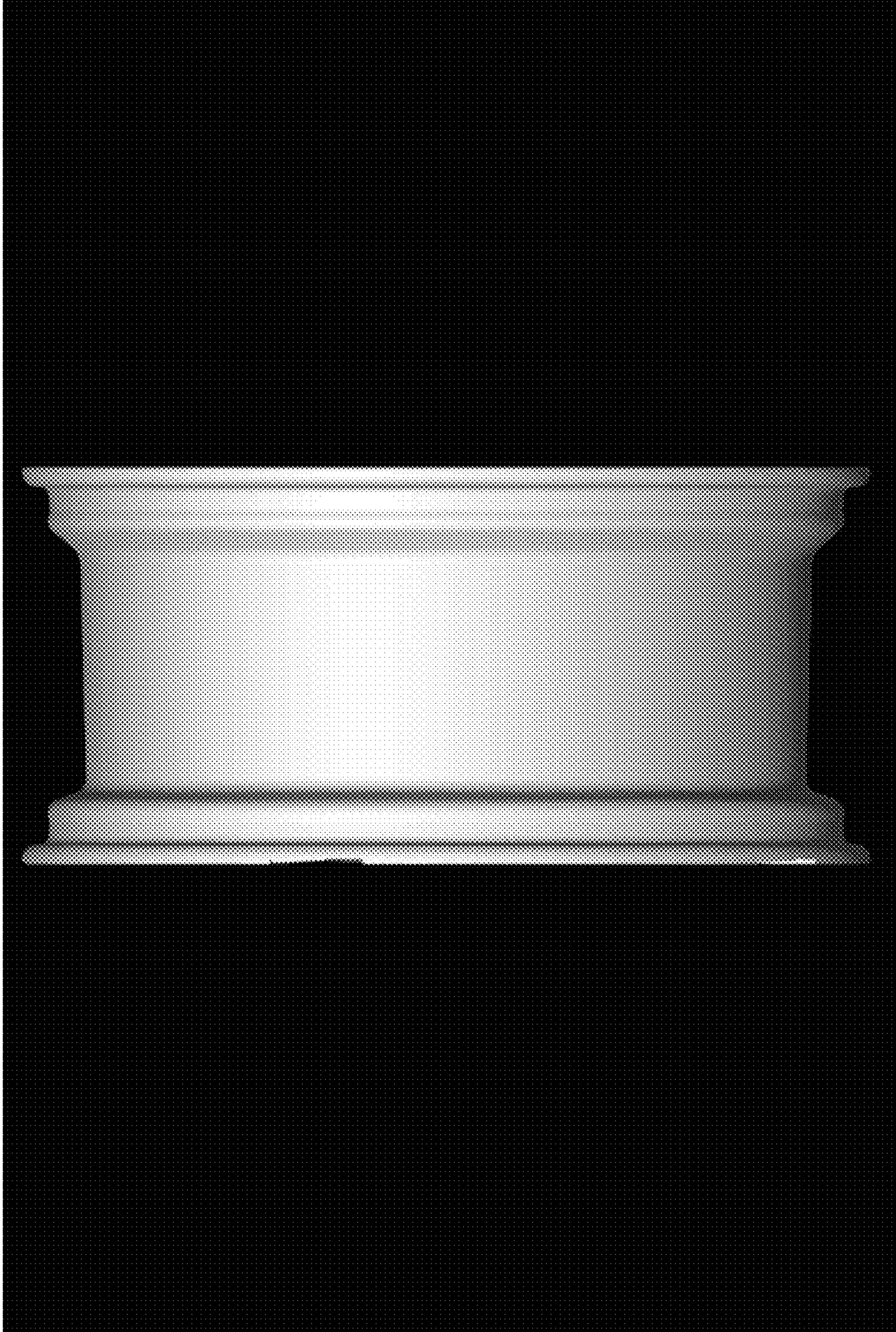

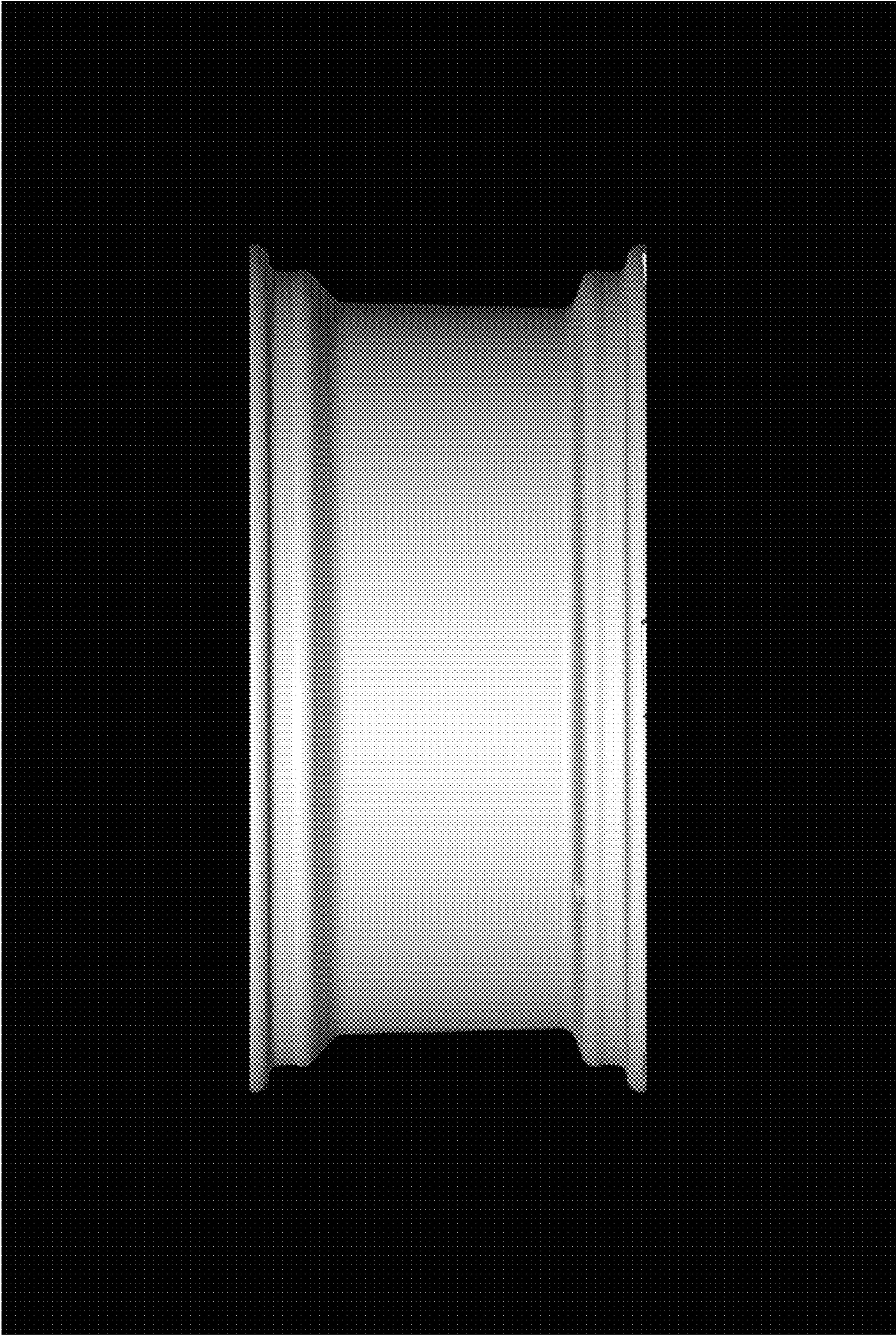

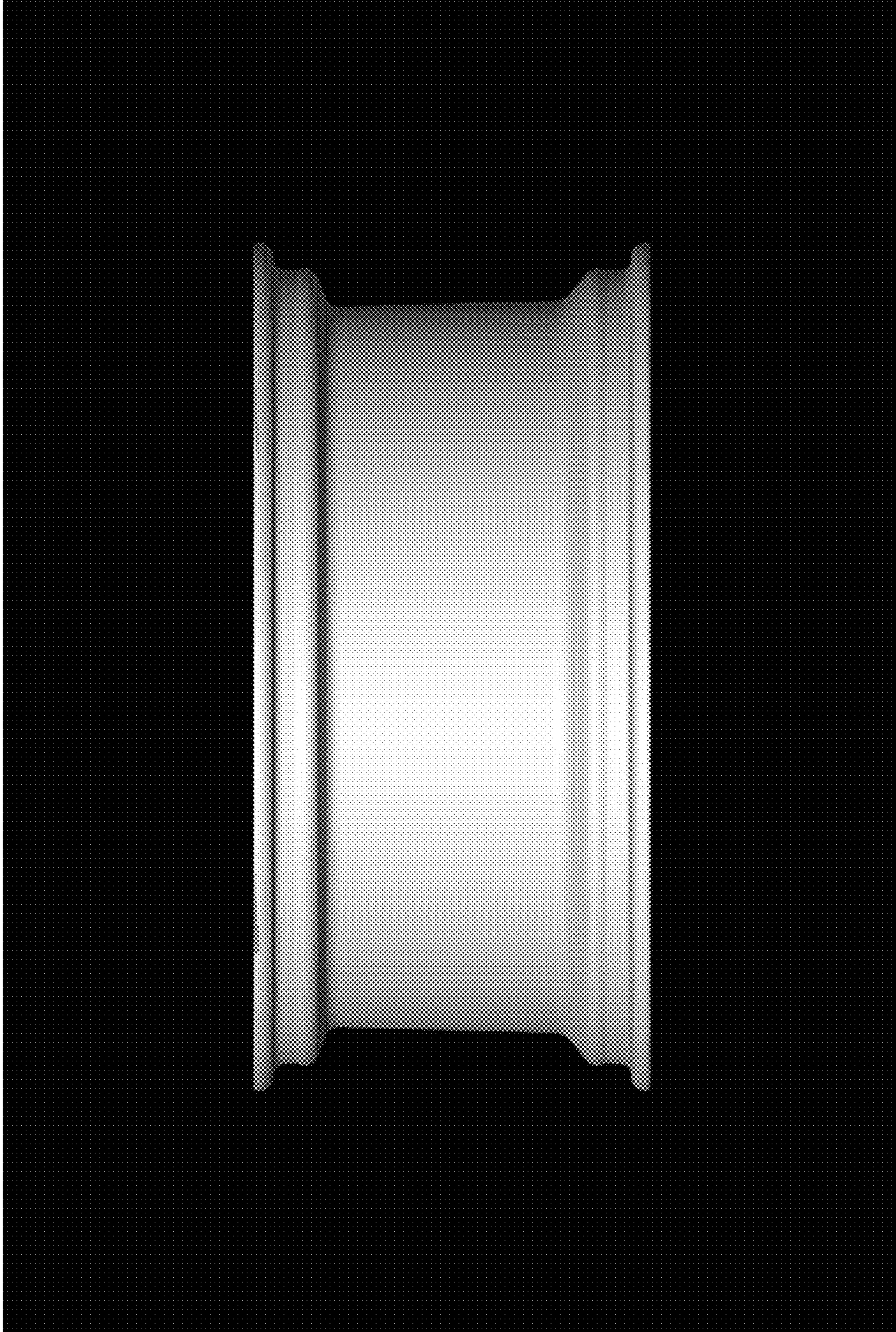

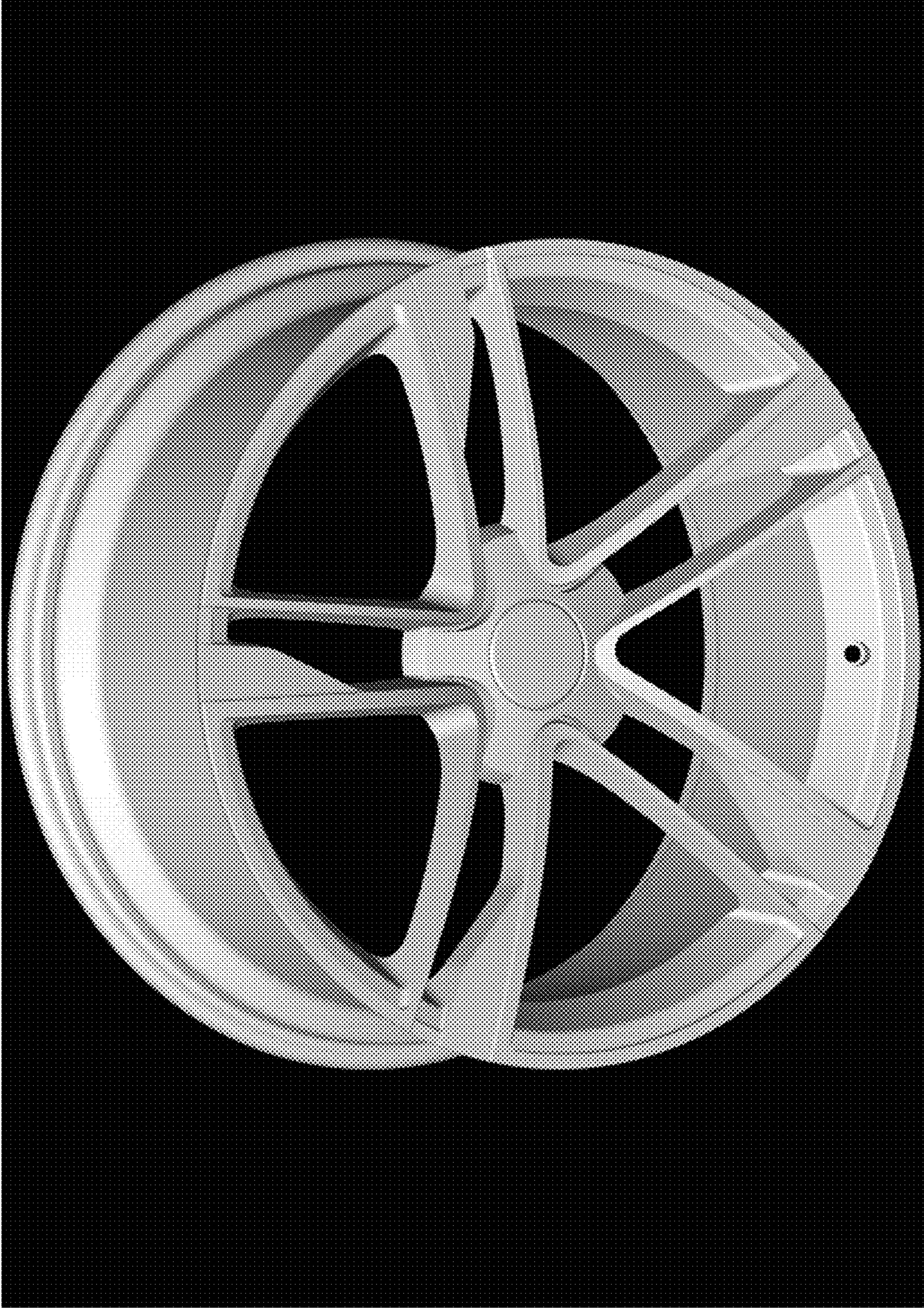

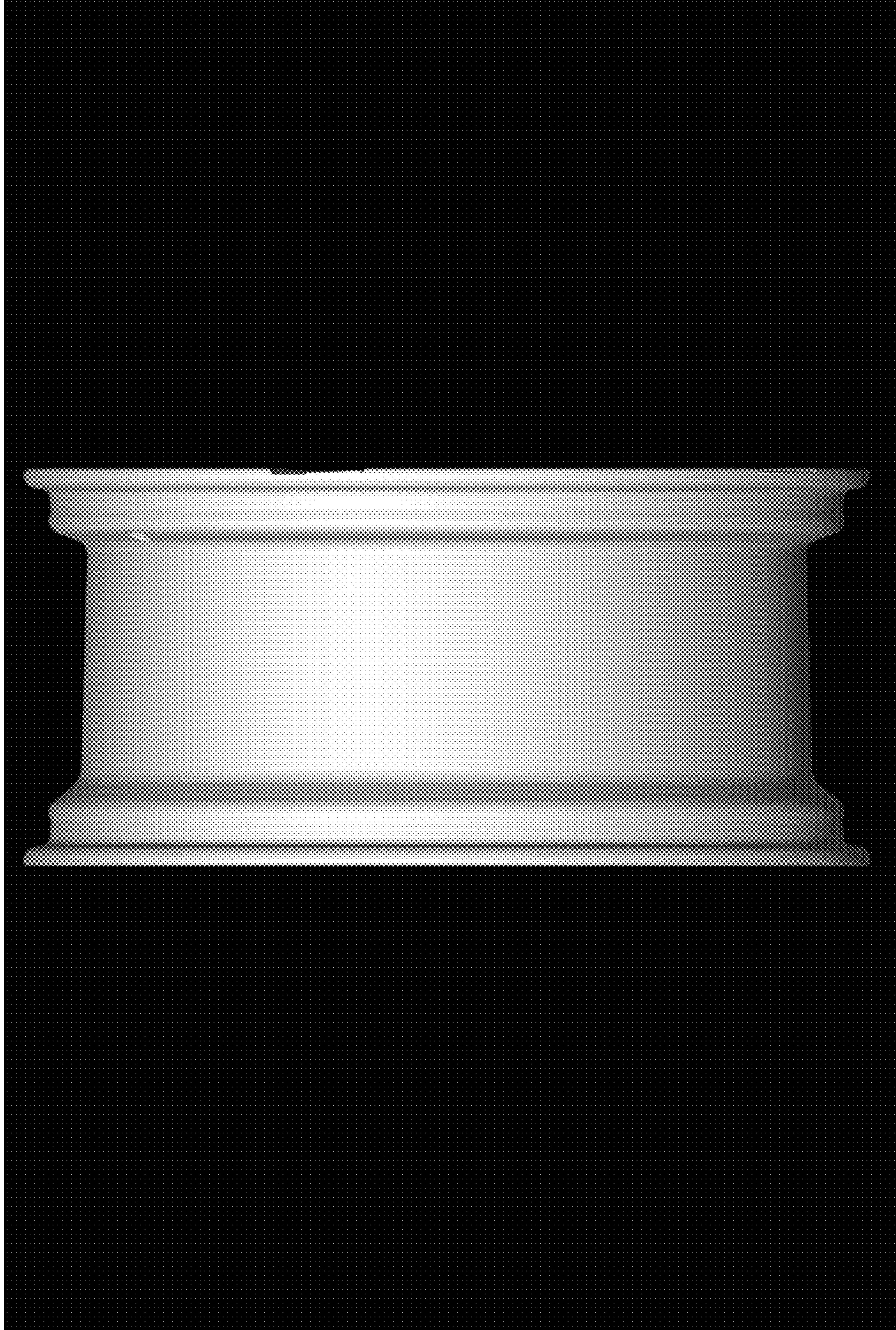

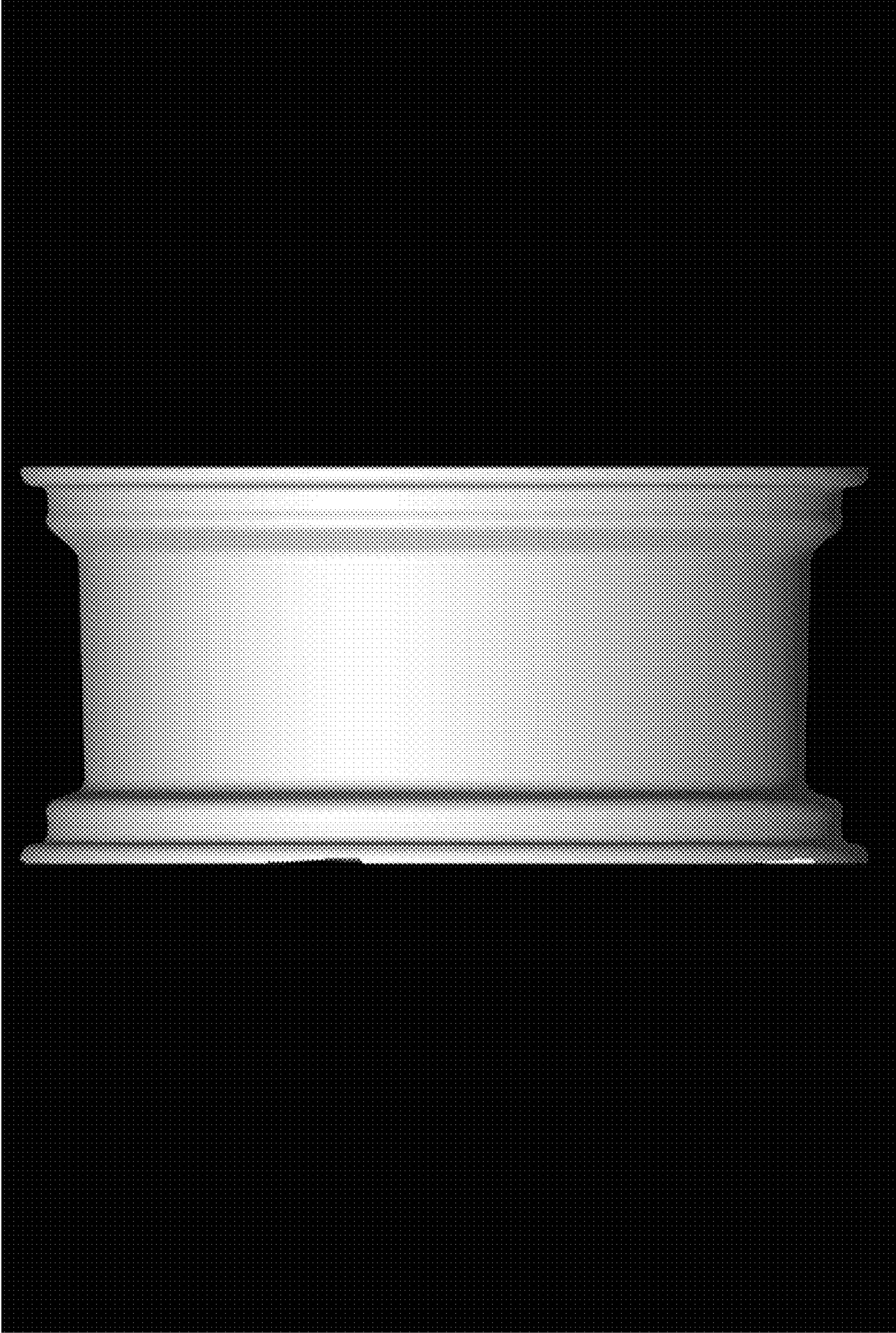

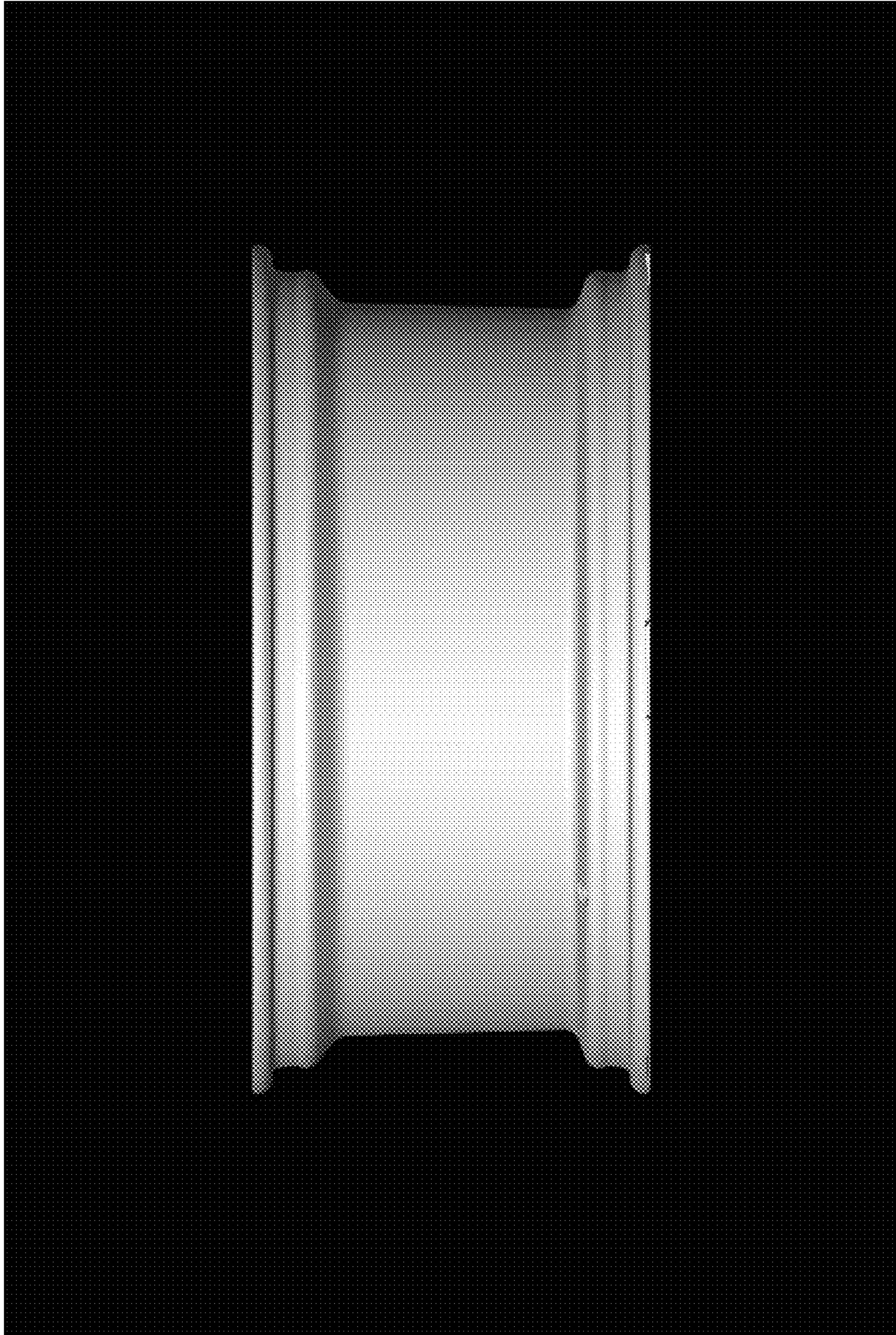
