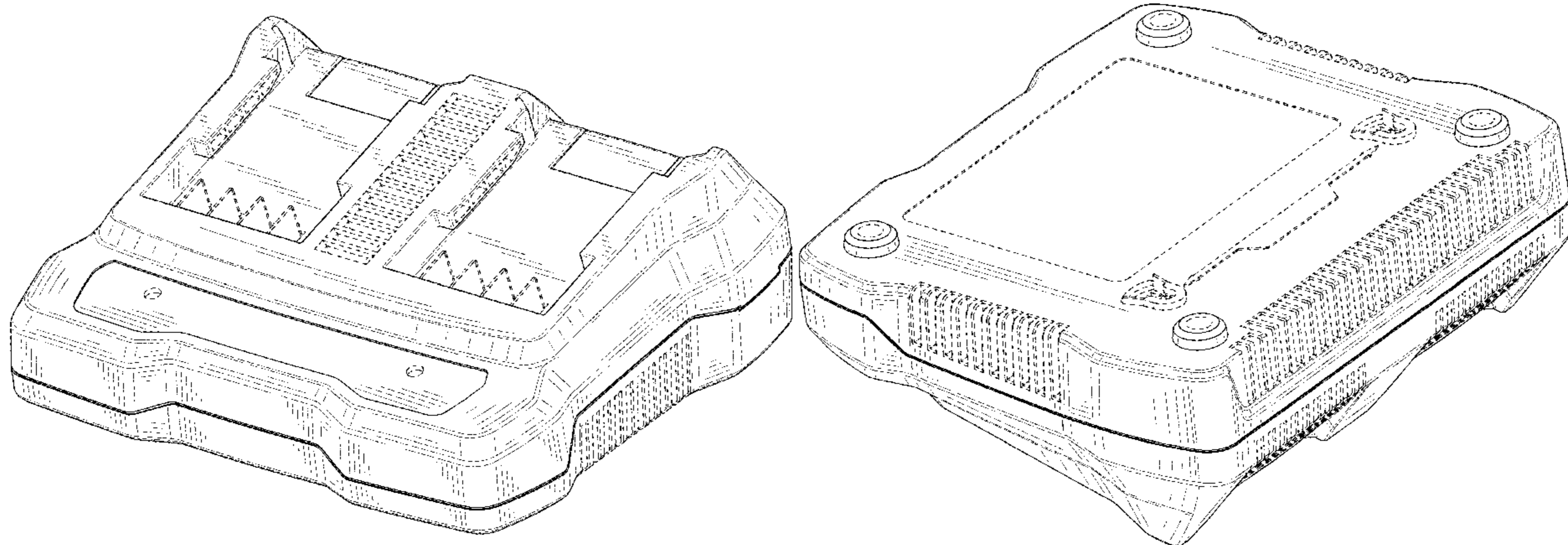
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a charger showing our new design;
FIG. 2 is a bottom, rear and left side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;

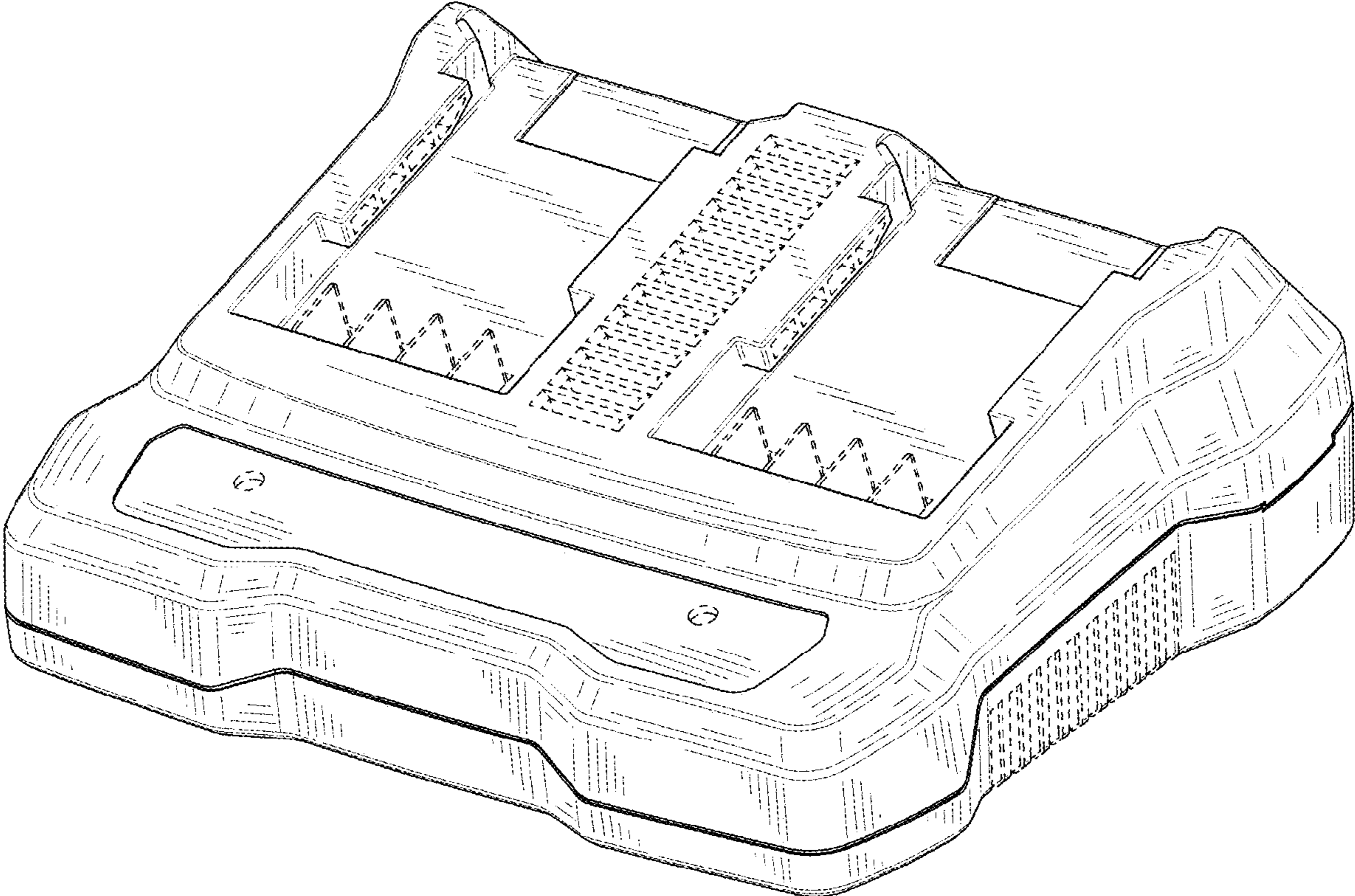

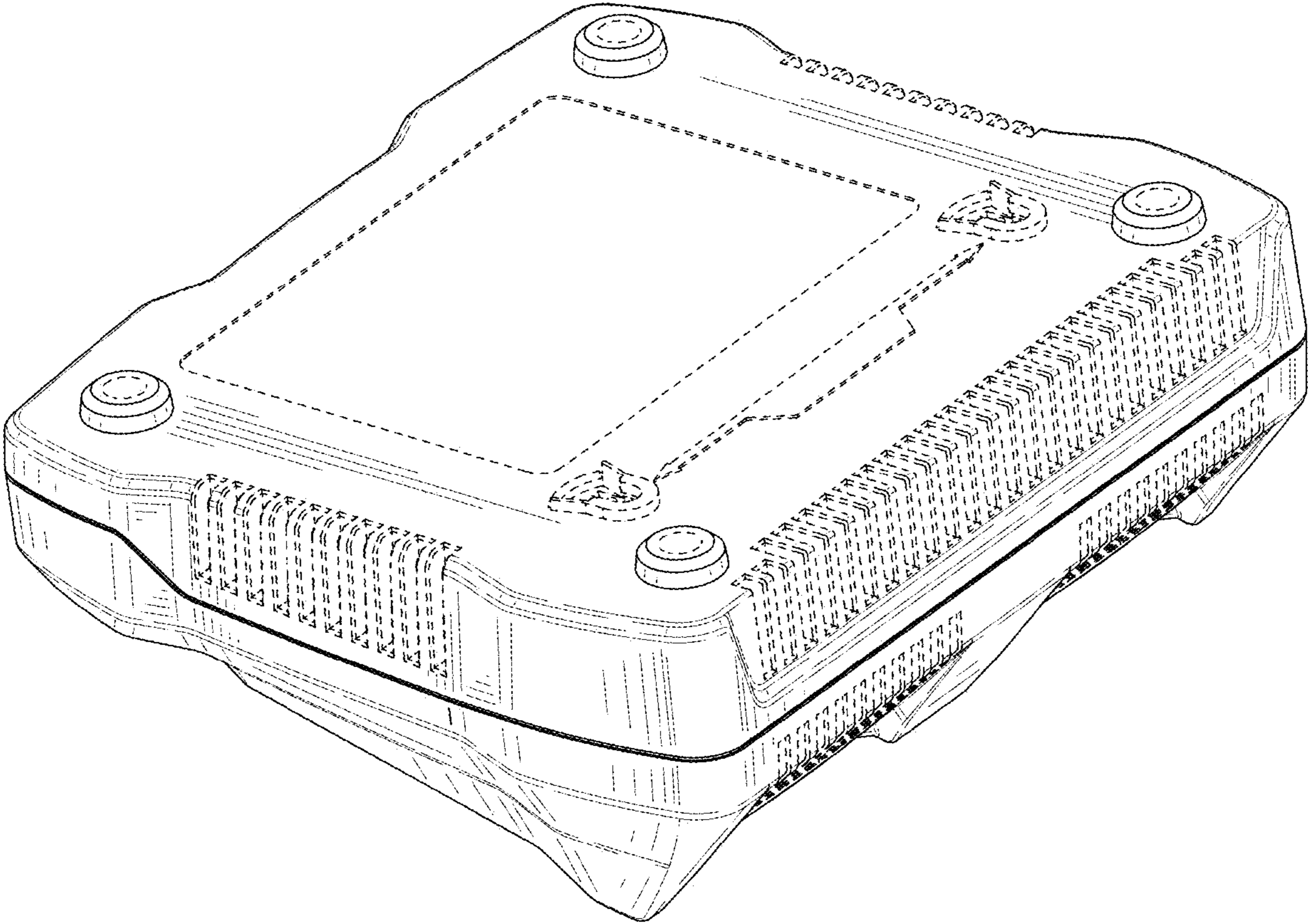

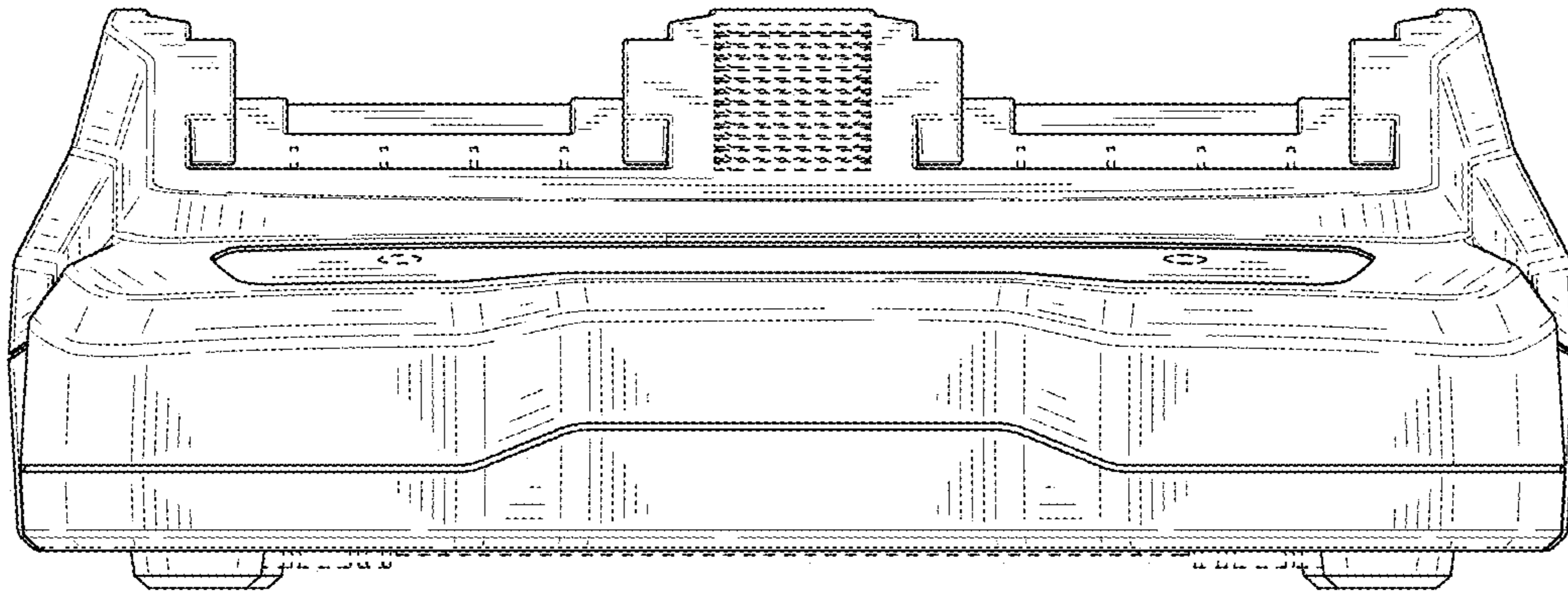

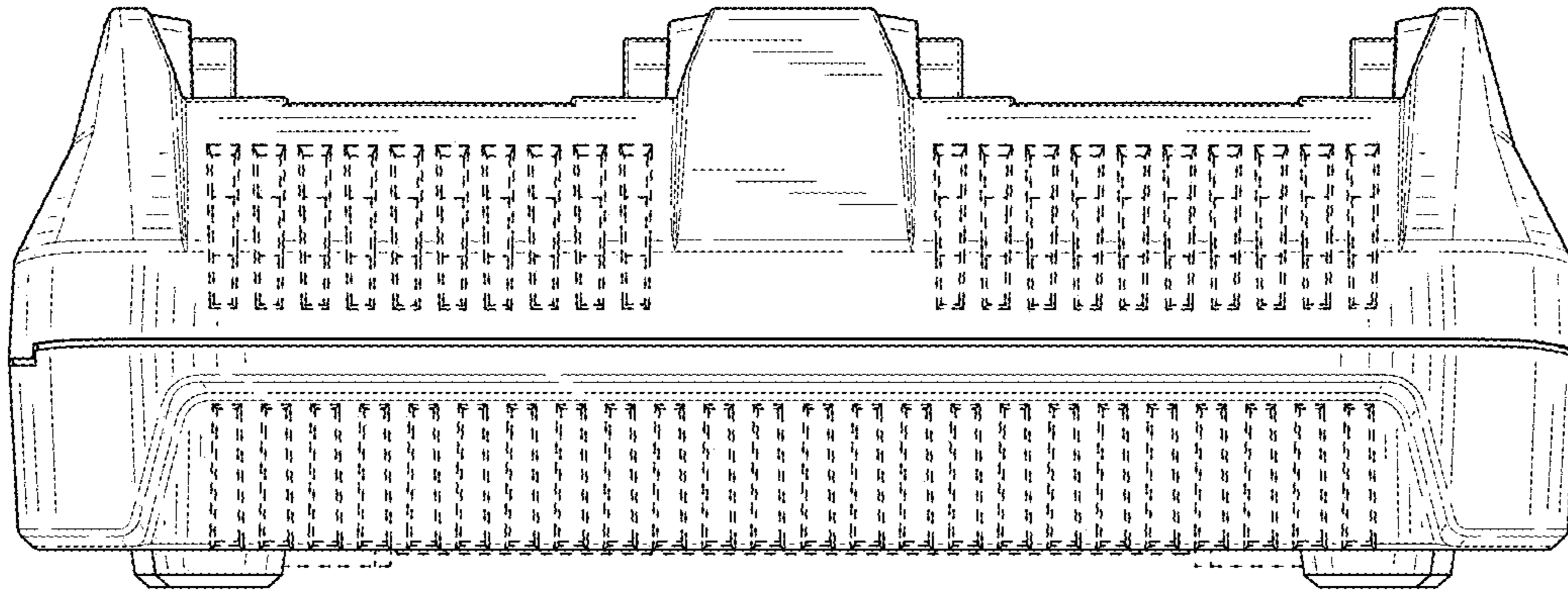

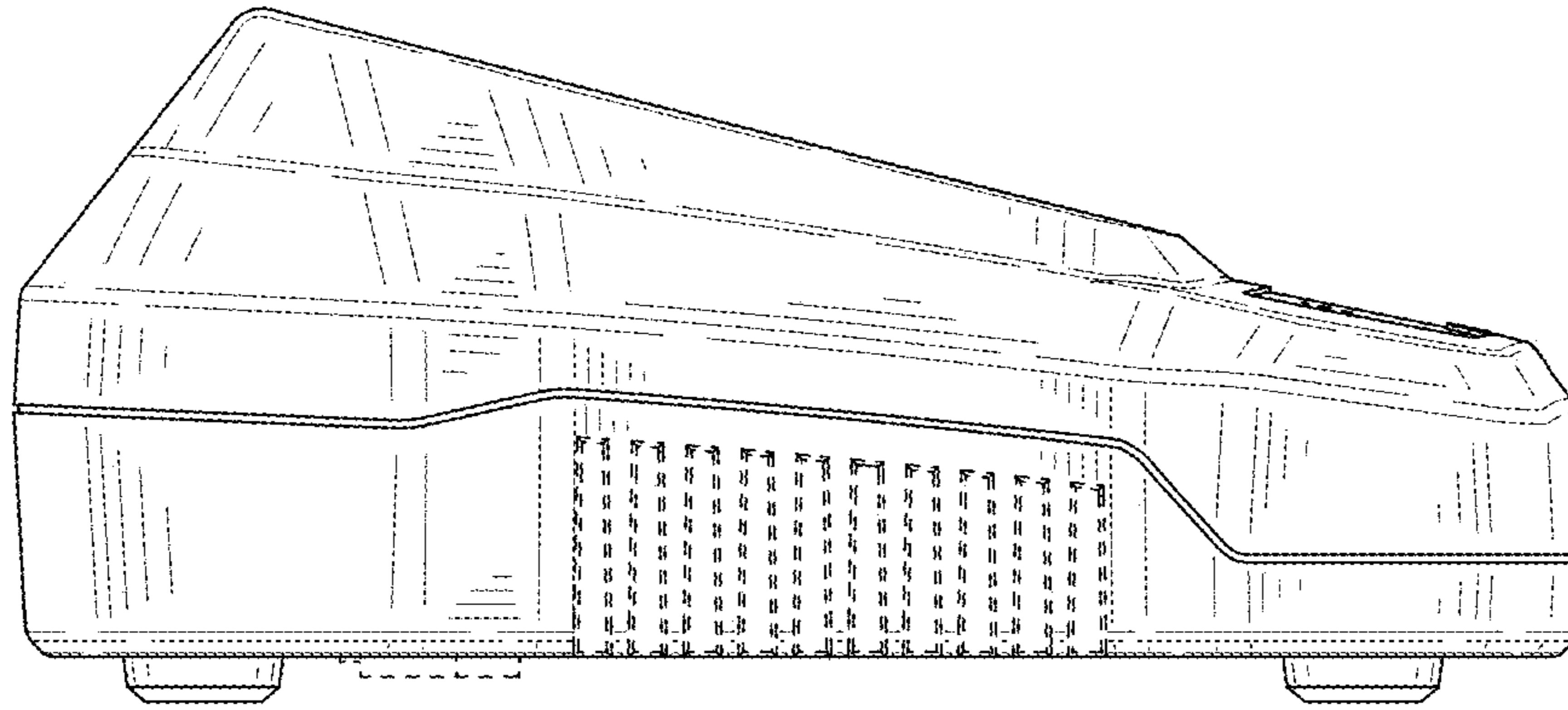

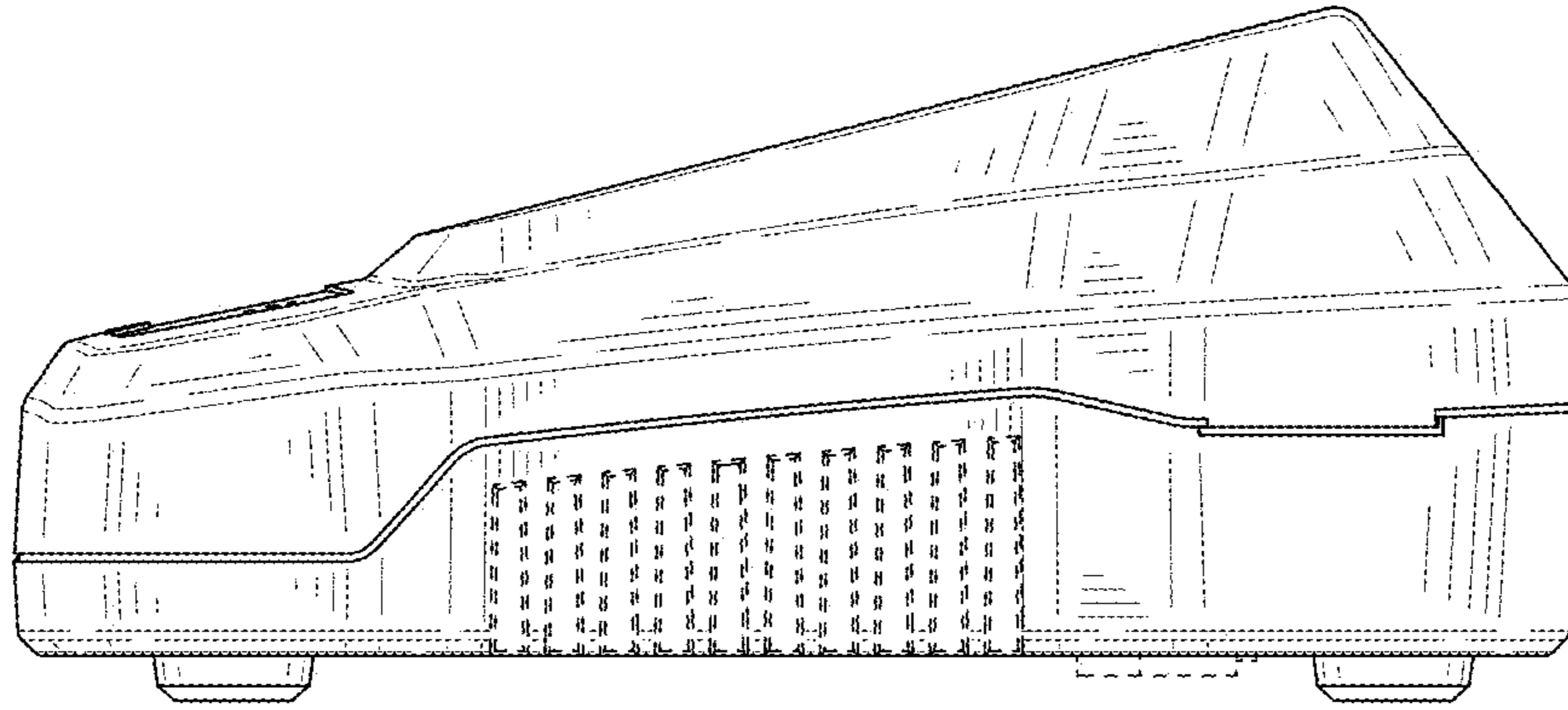

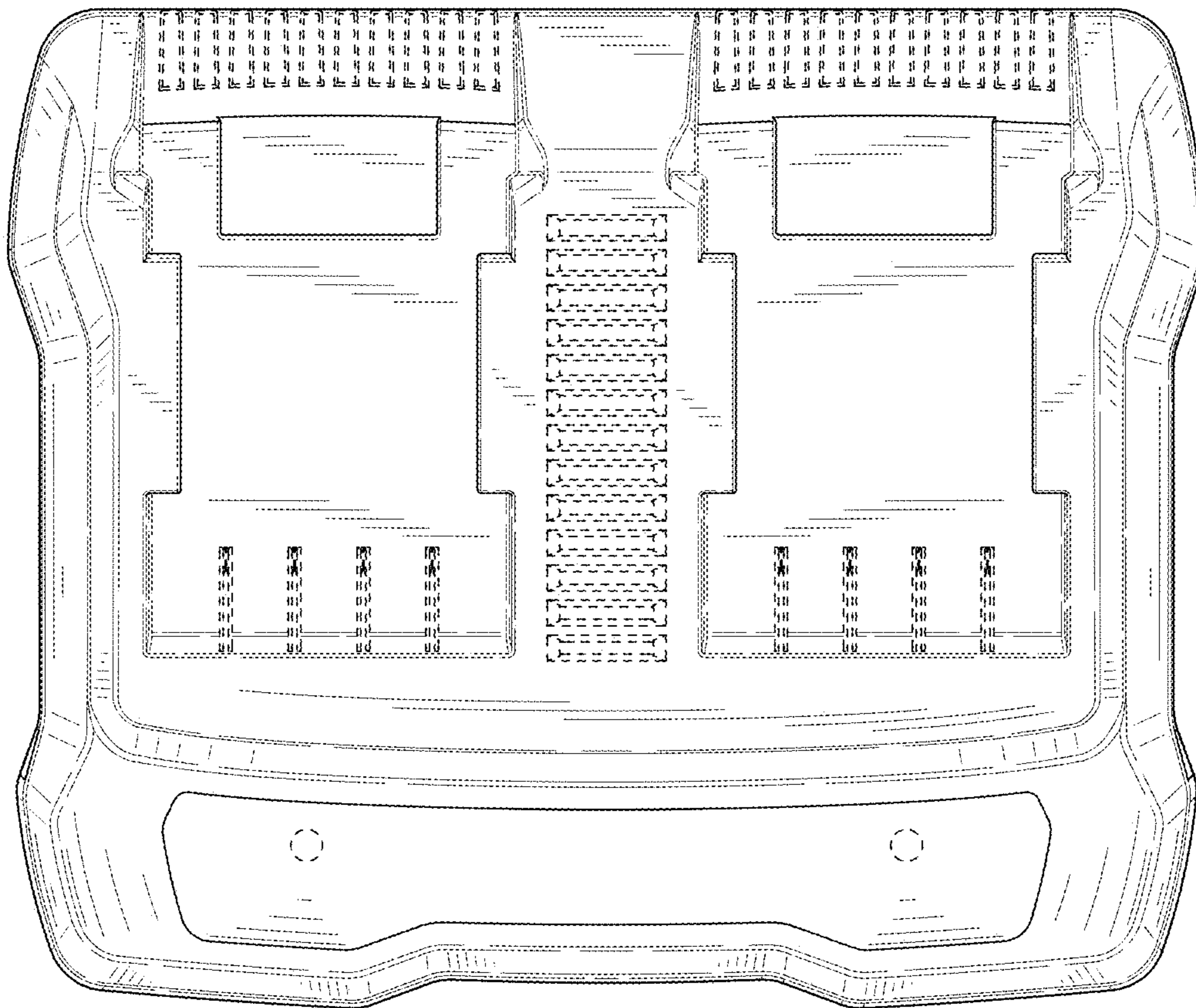

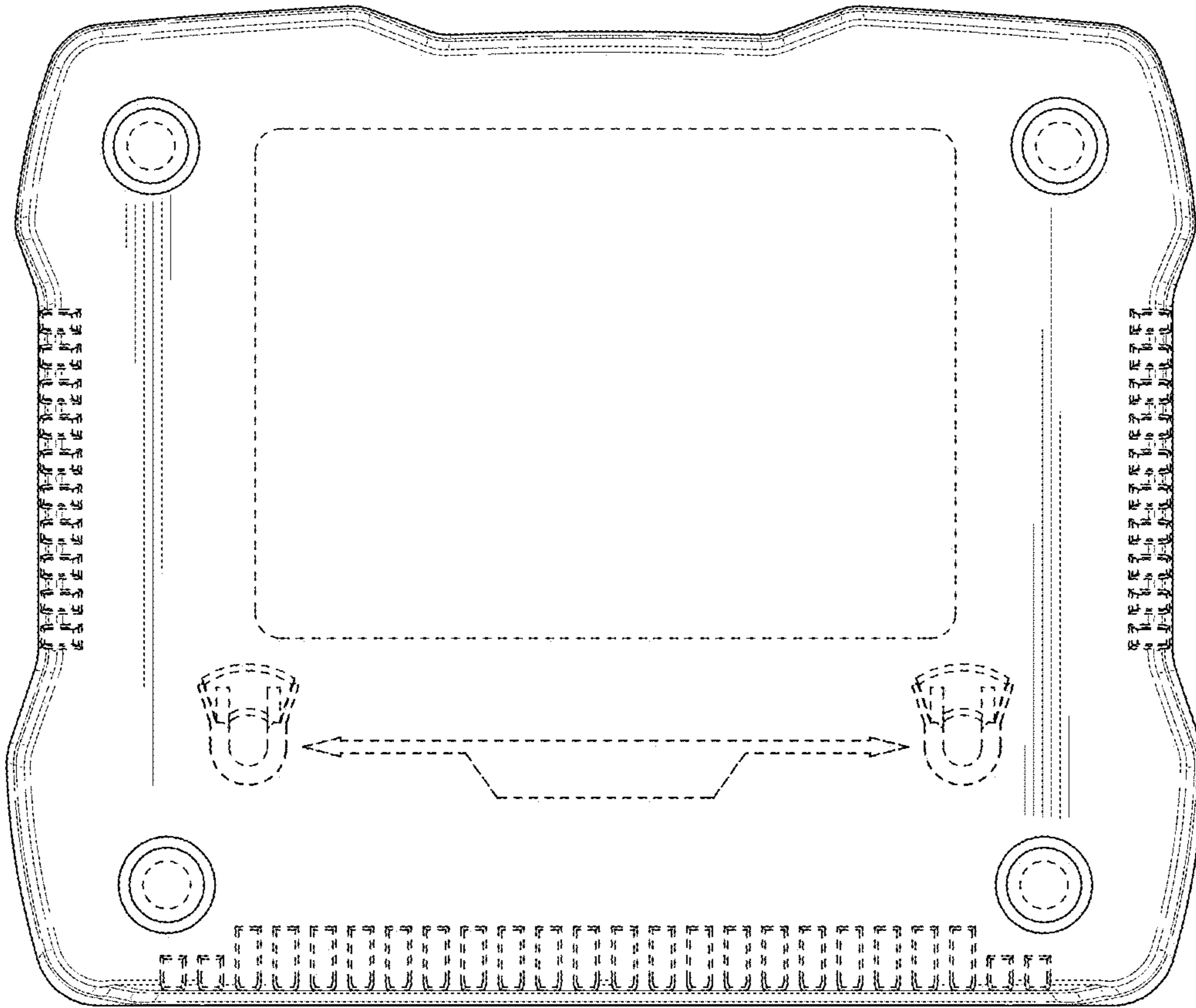
