DESCRIPTION

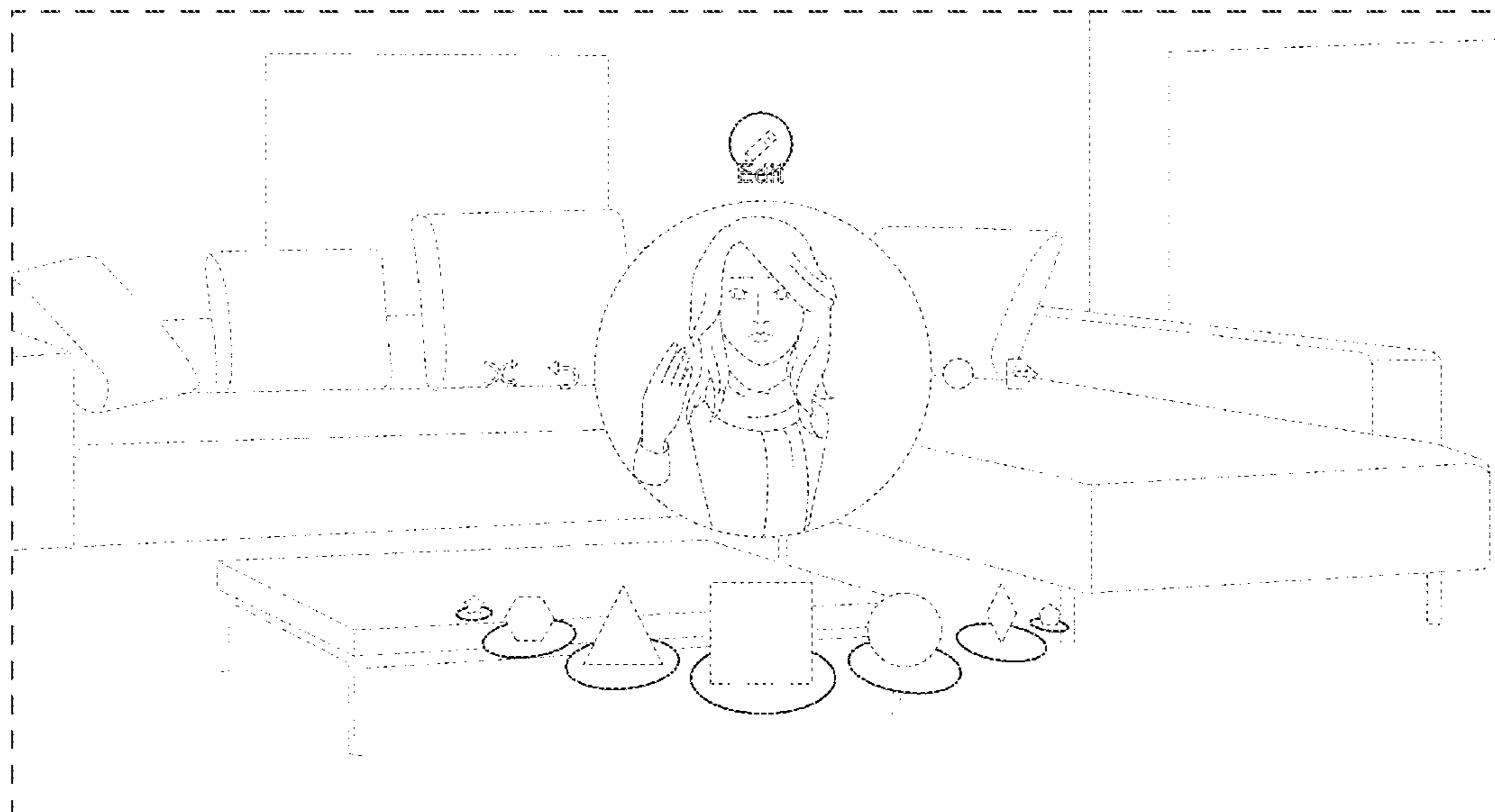
FIG. 1 is a front view of a display panel or portion thereof with a graphical user interface showing a first embodiment of our design; and,

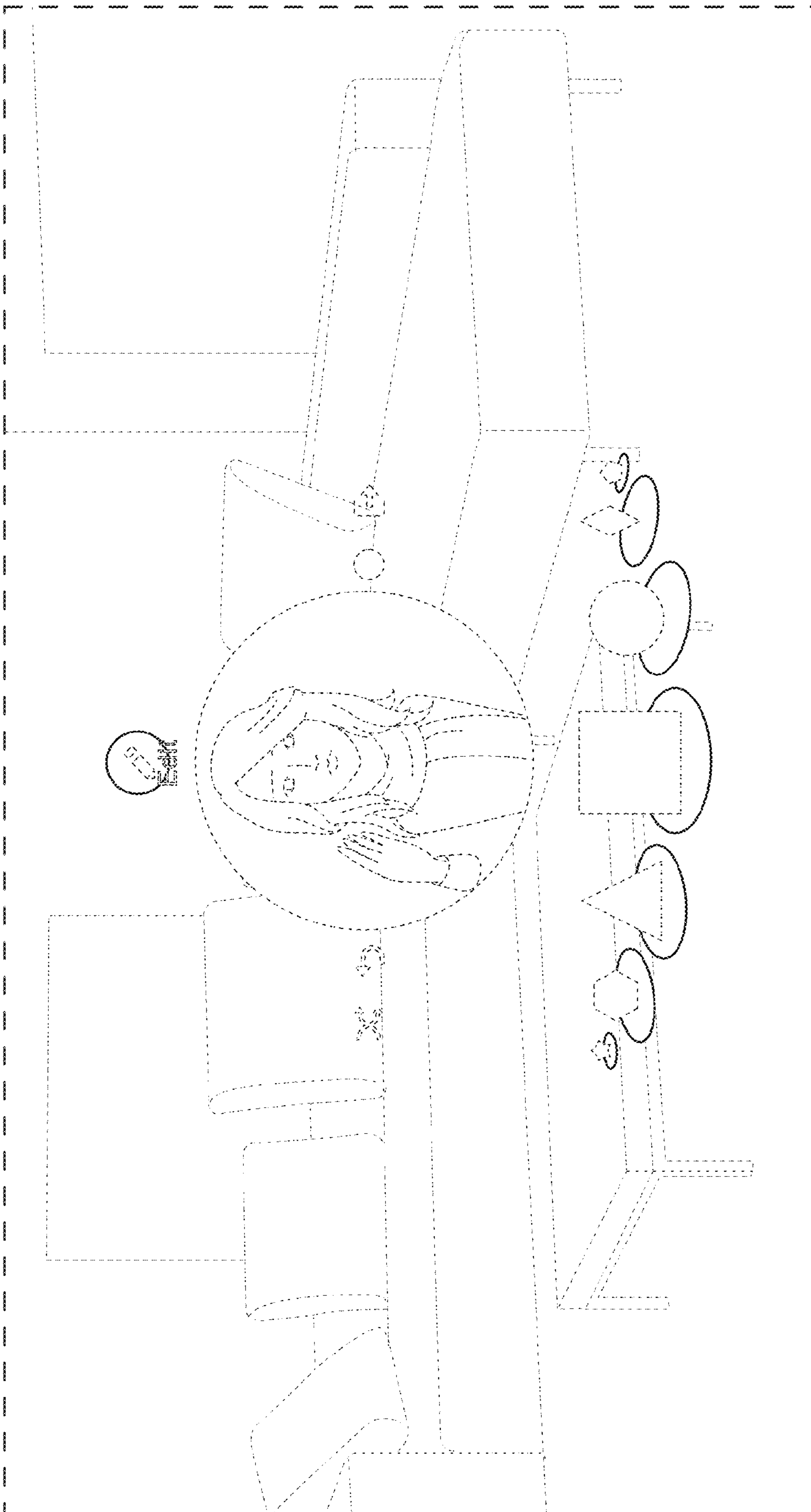

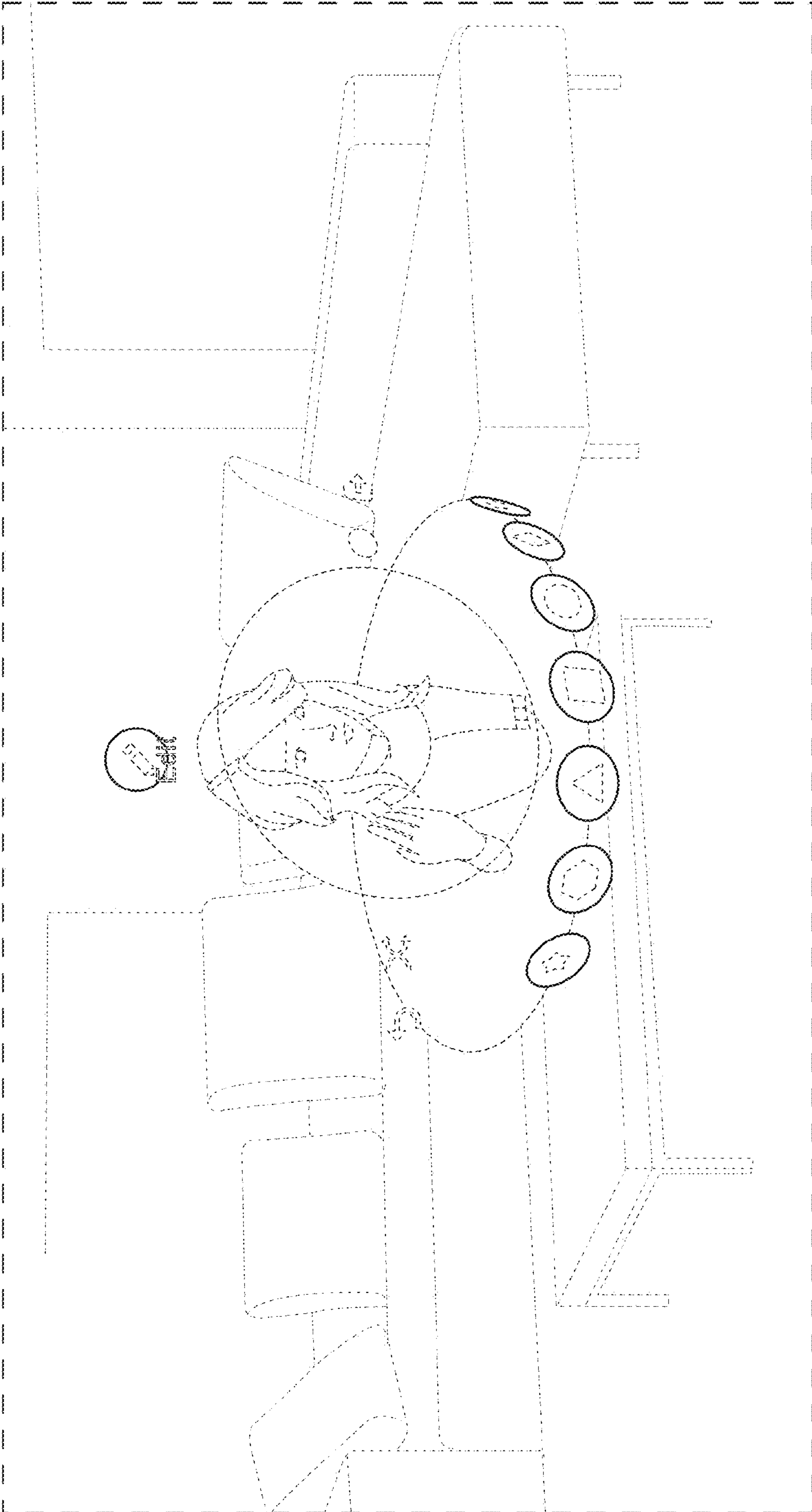
