The ornamental design for a massage knee pad, as shown and described.

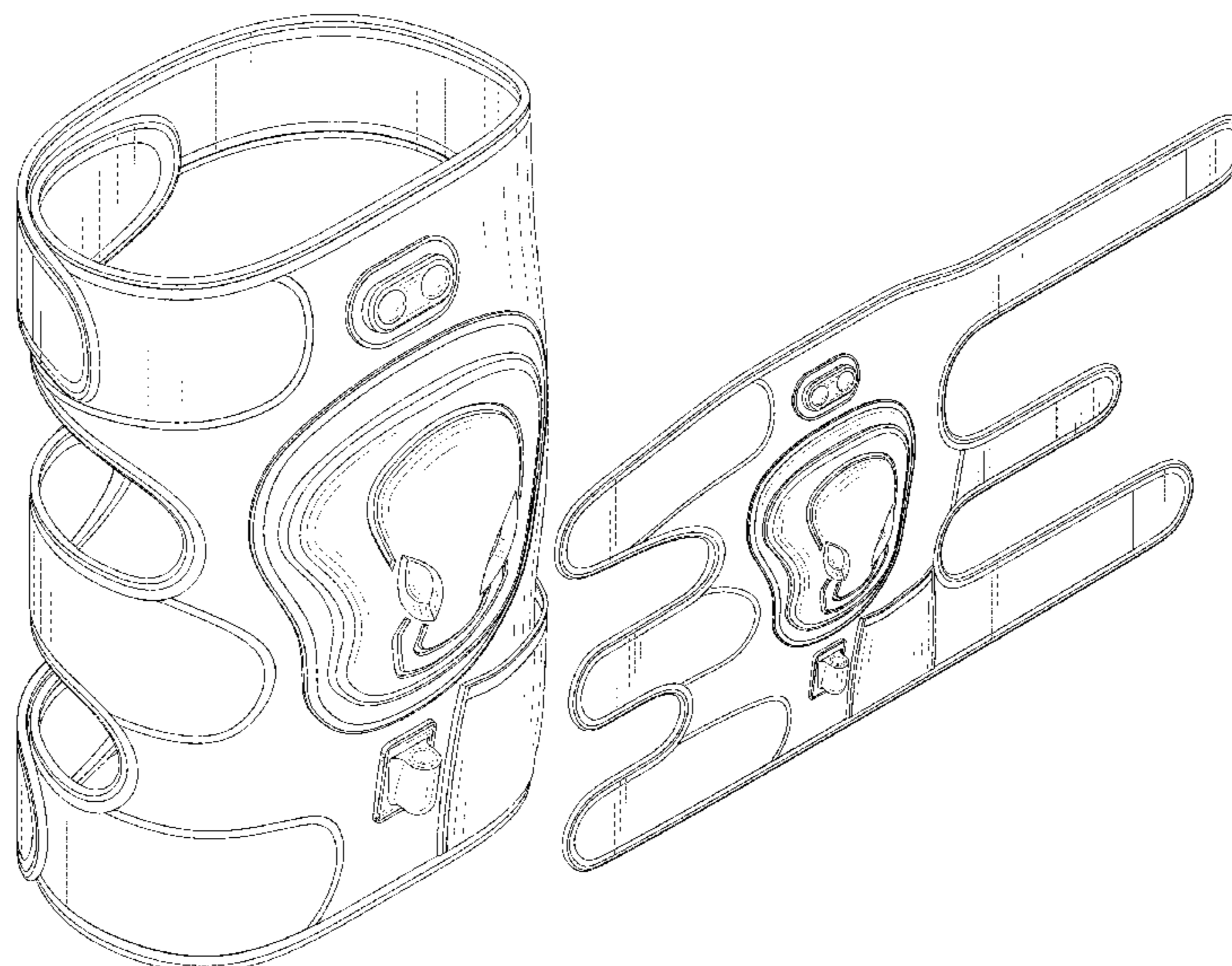
**DESCRIPTION**

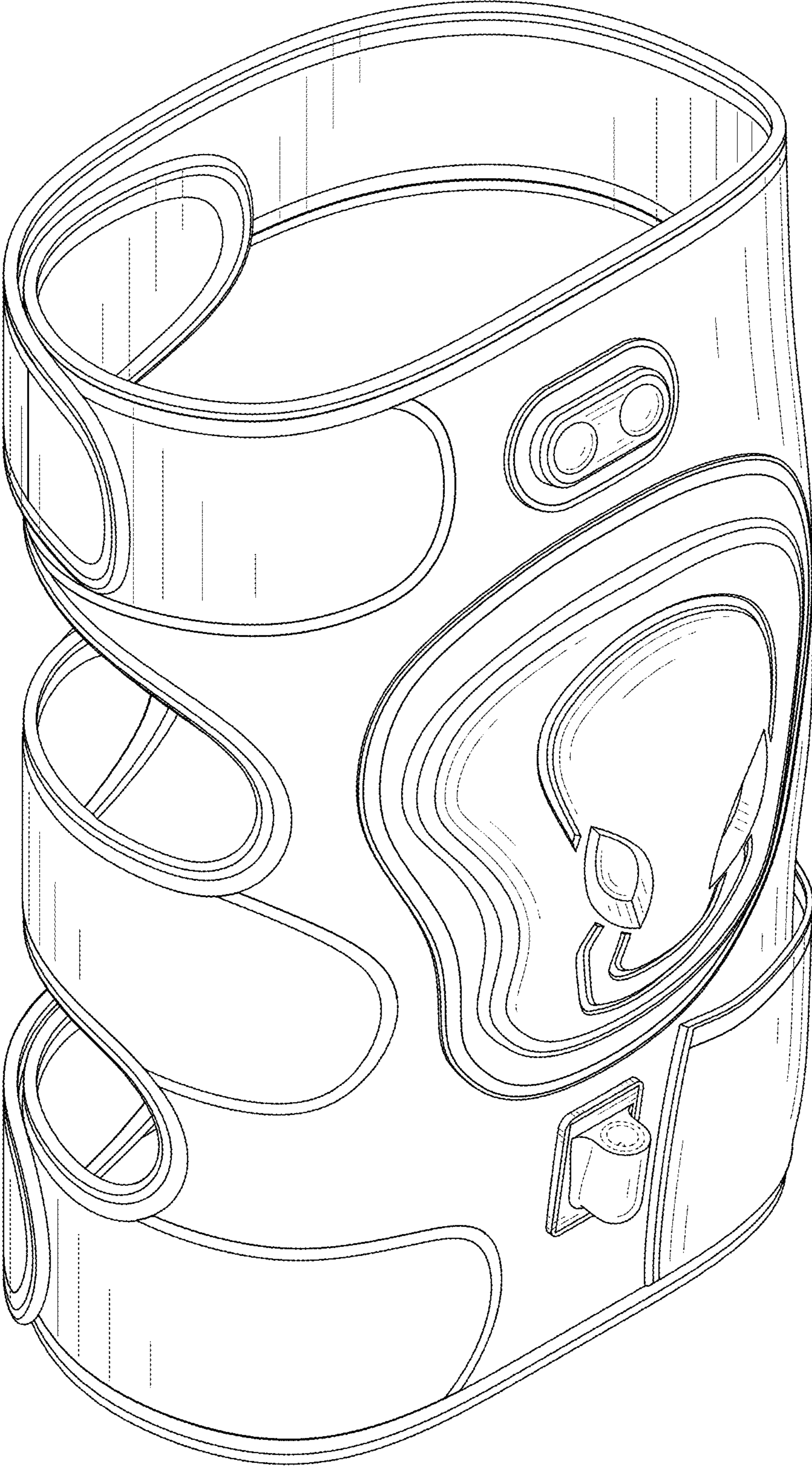

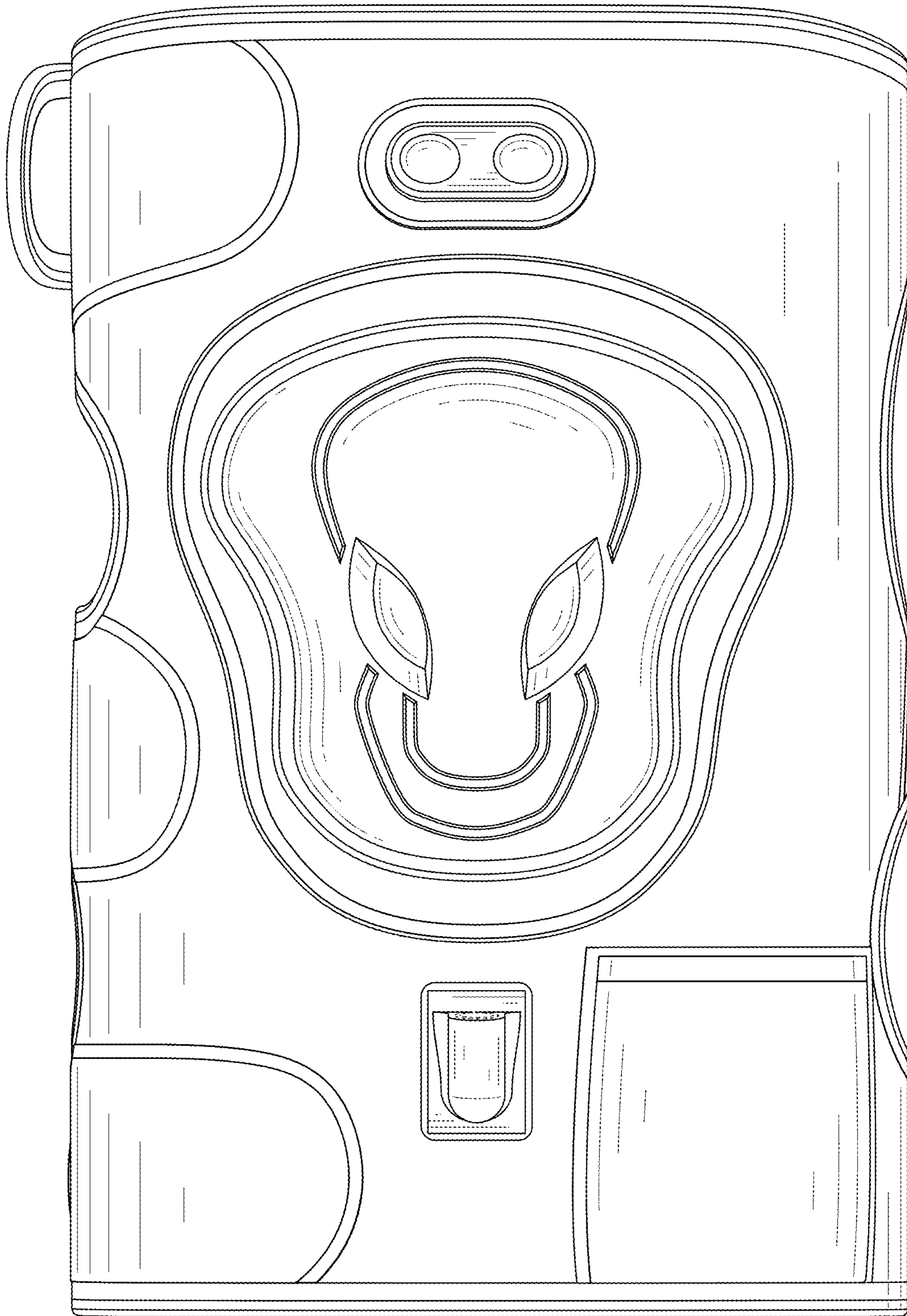

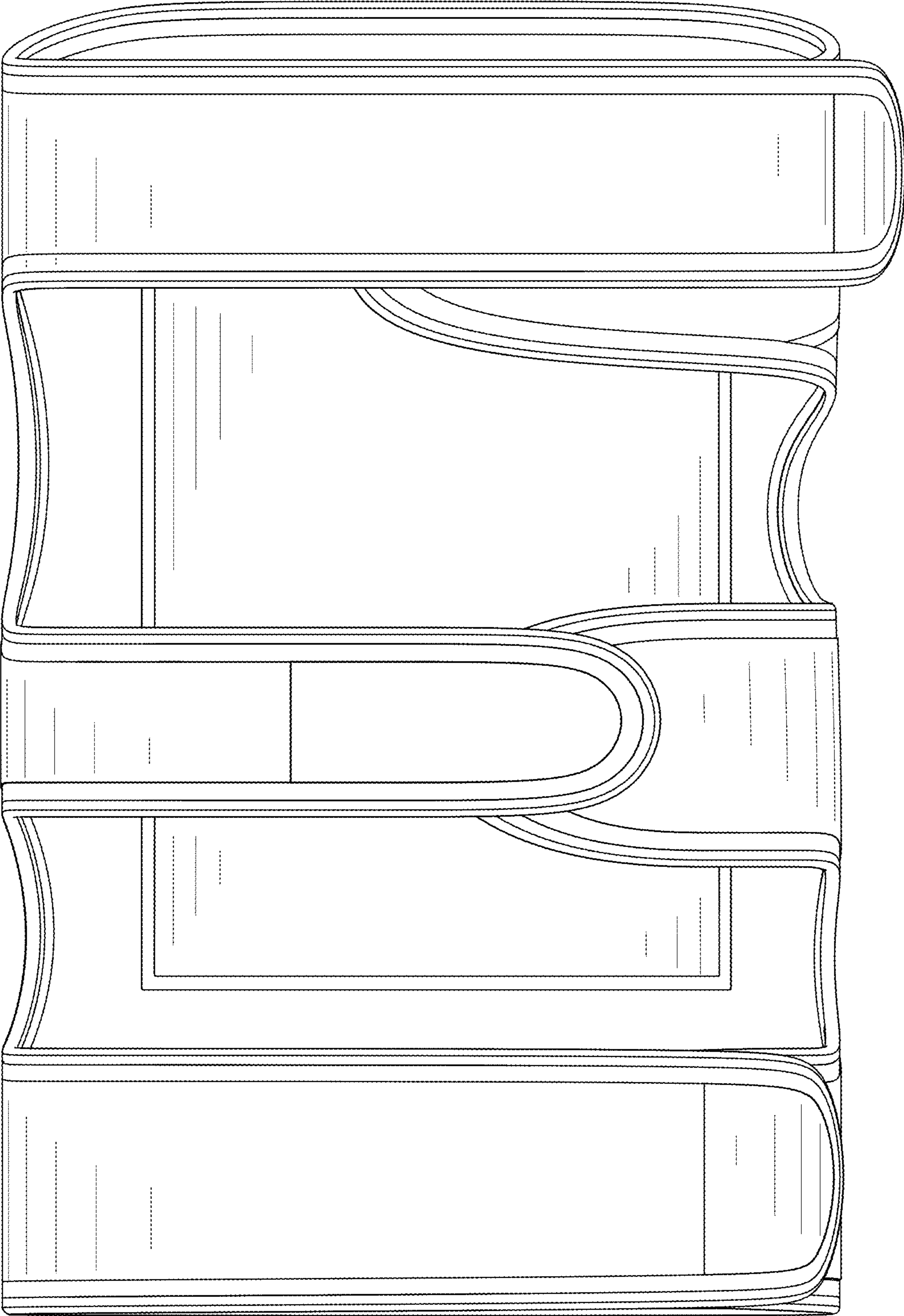

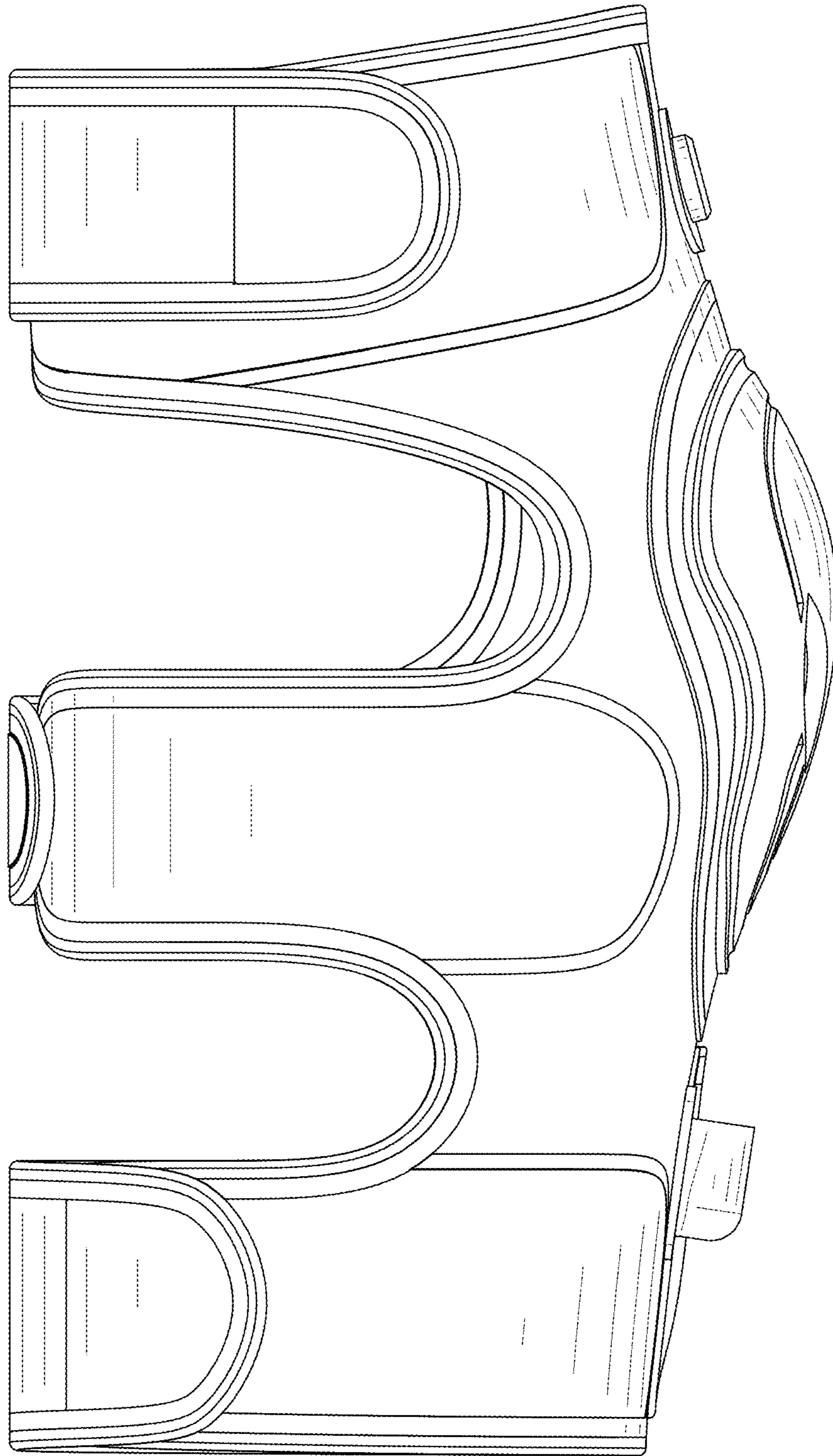

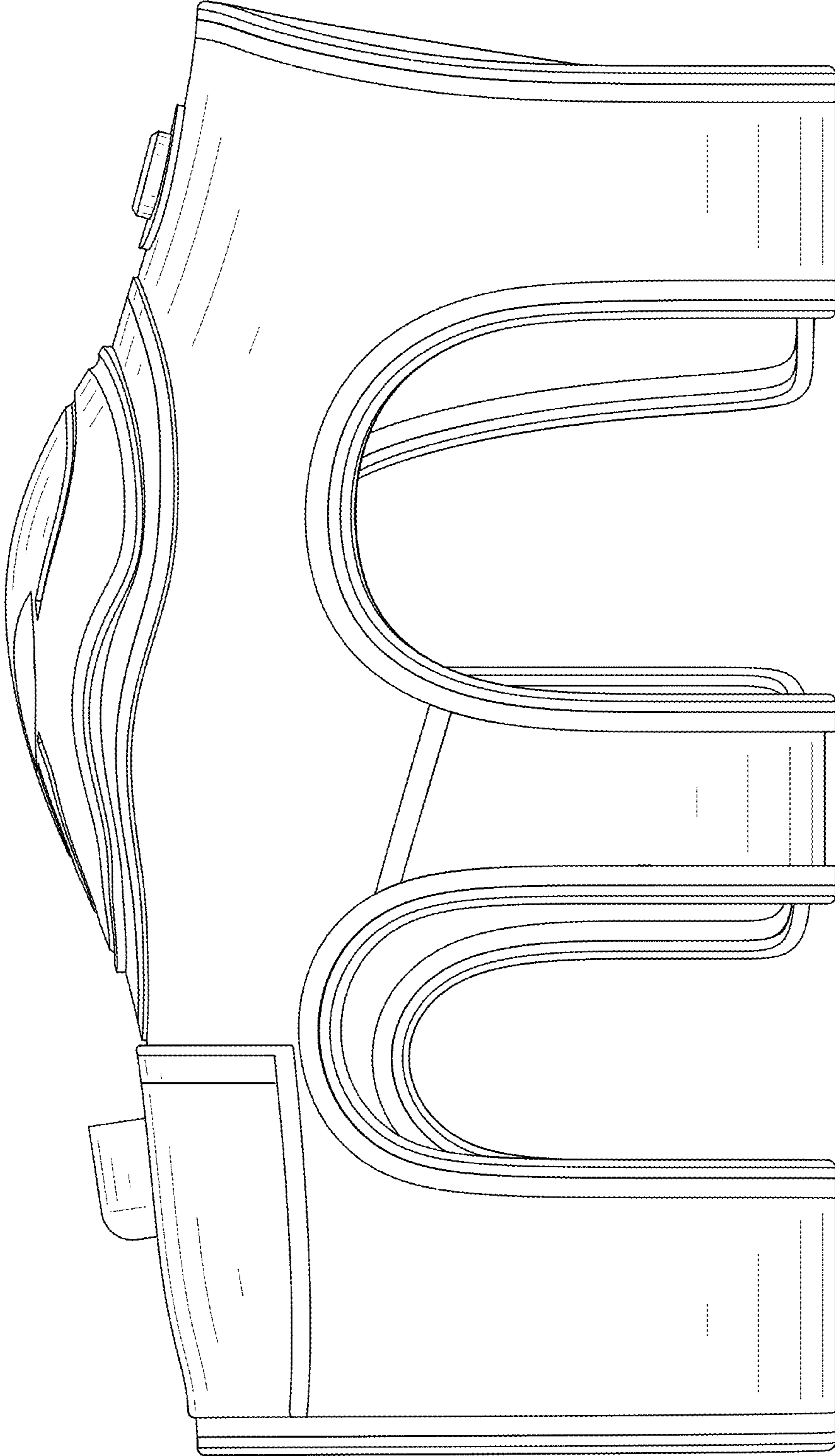

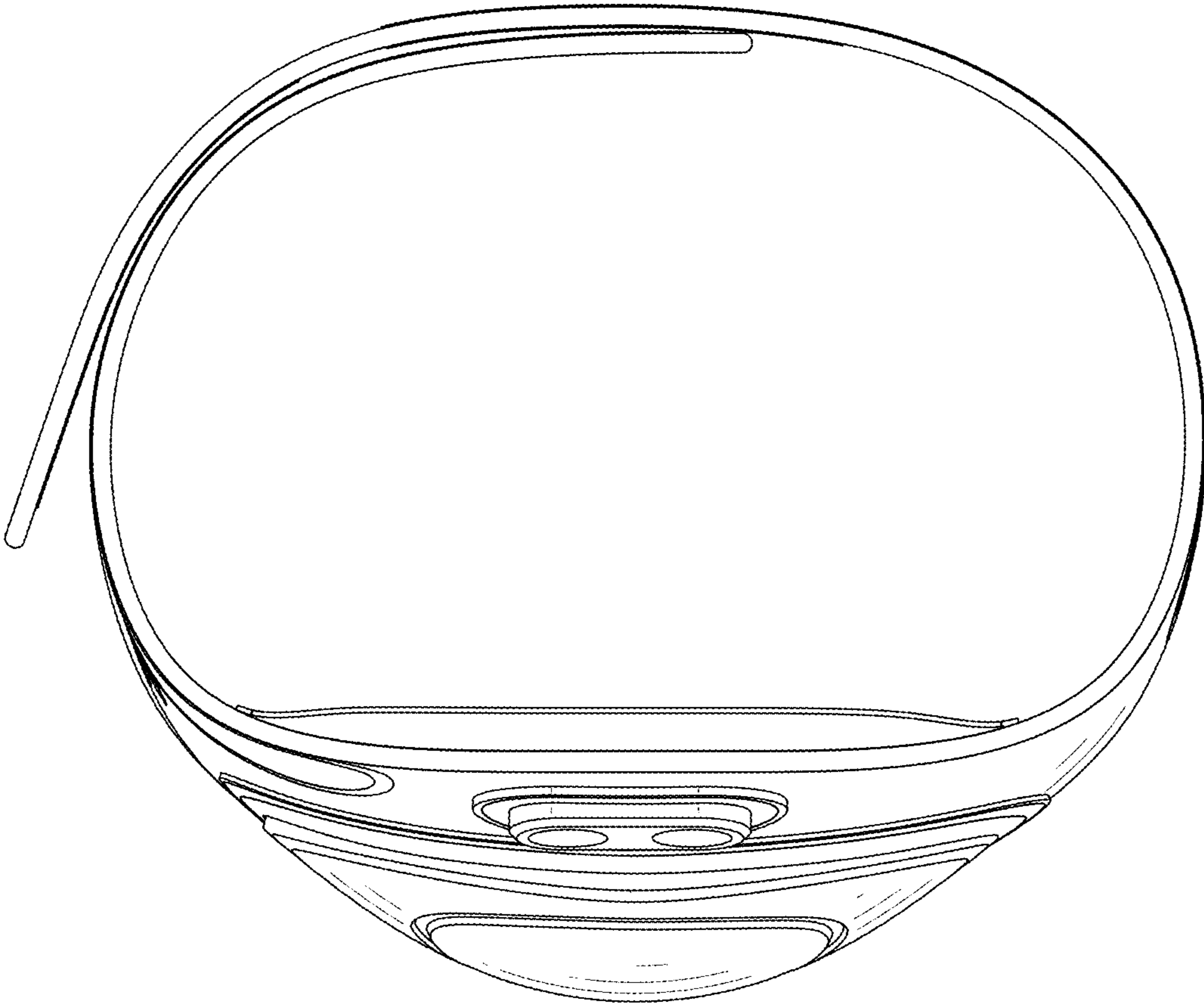

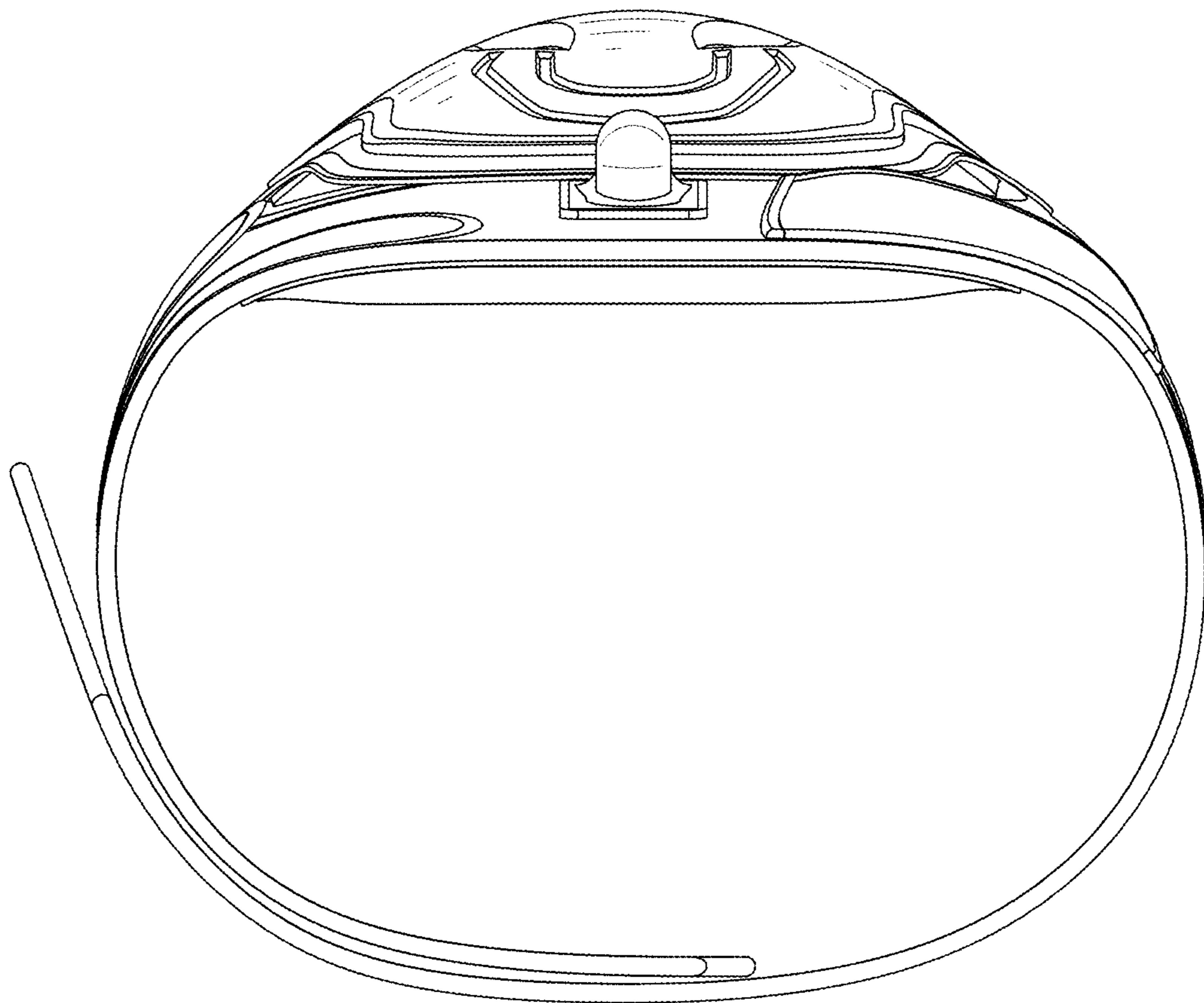

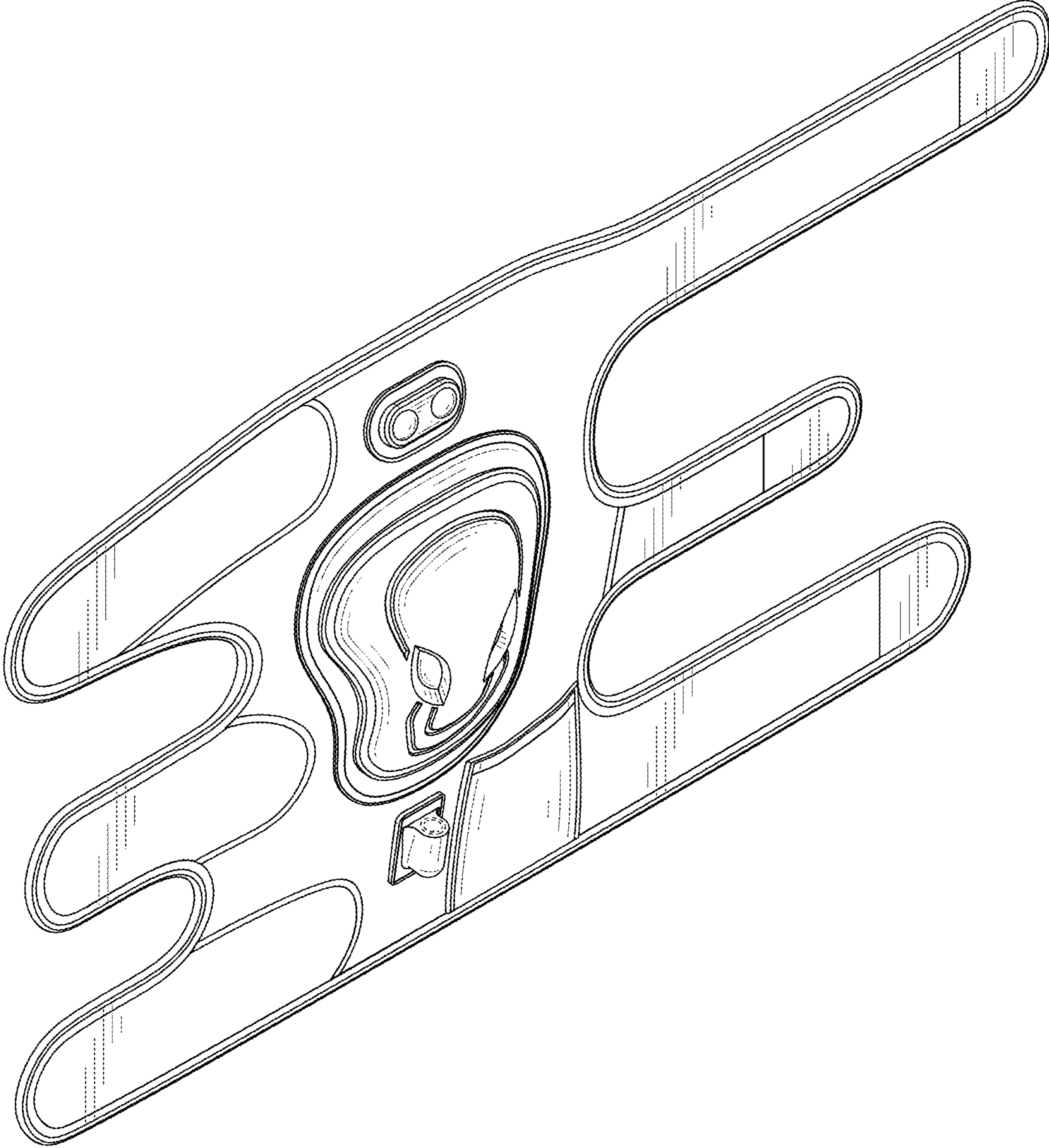

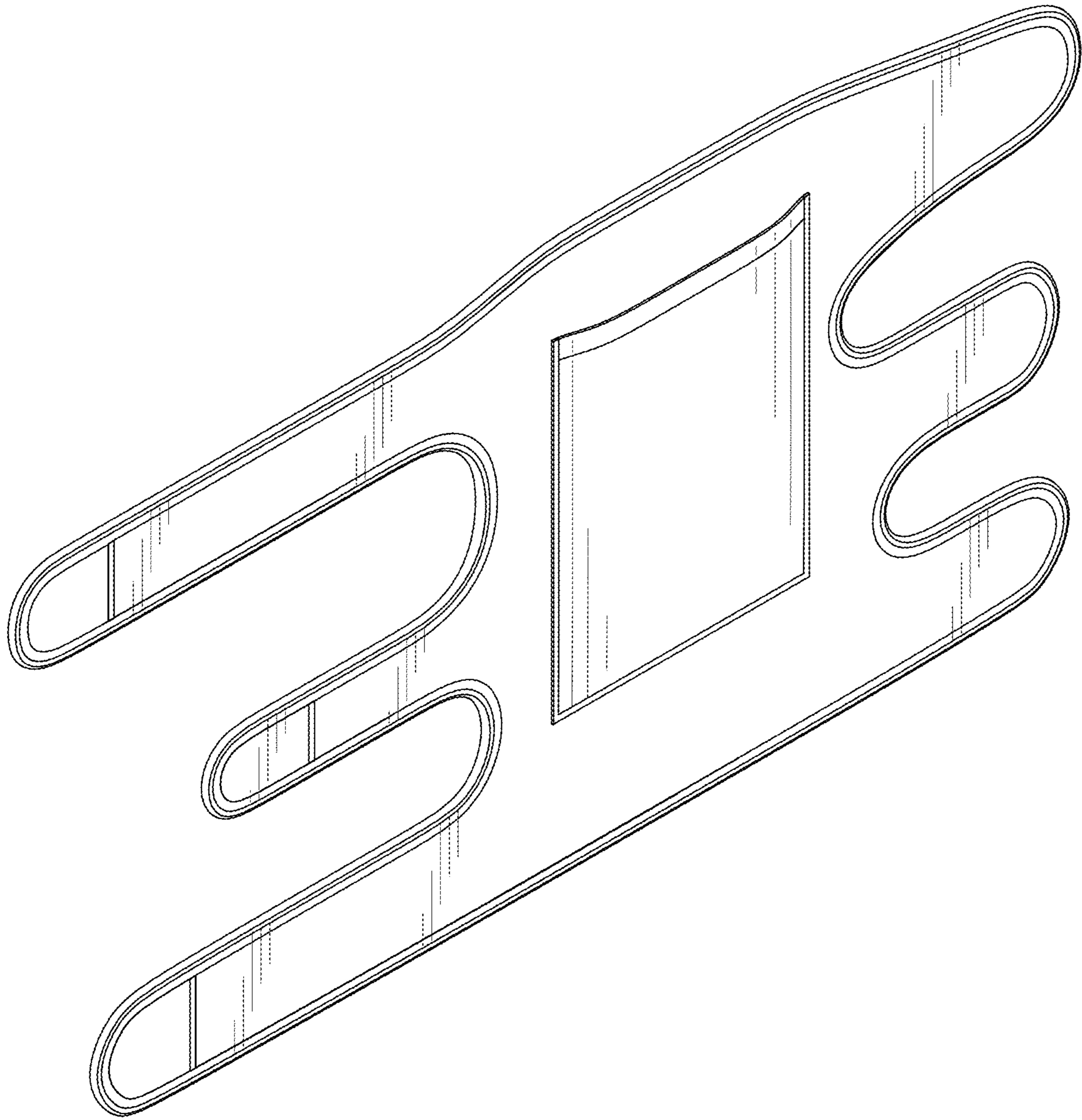
