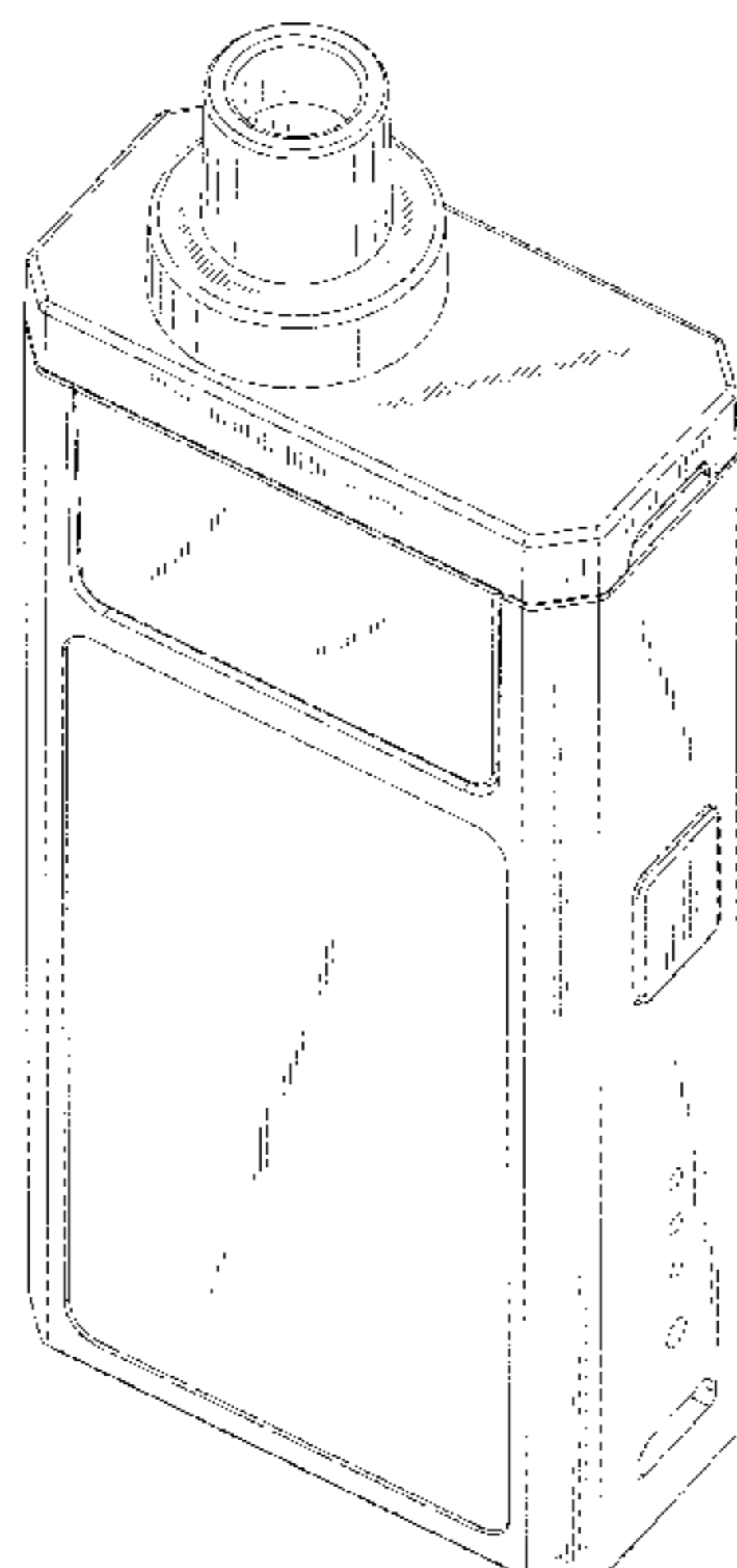
(57) **CLAIM**

The ornamental design for an electronic cigarette, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an electronic cigarette; FIG. 2 is a rear elevation view thereof; FIG. 3 is a left-side elevation view thereof; FIG. 4 is a right-side elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view thereof; and, FIG. 8 is a bottom perspective view thereof. 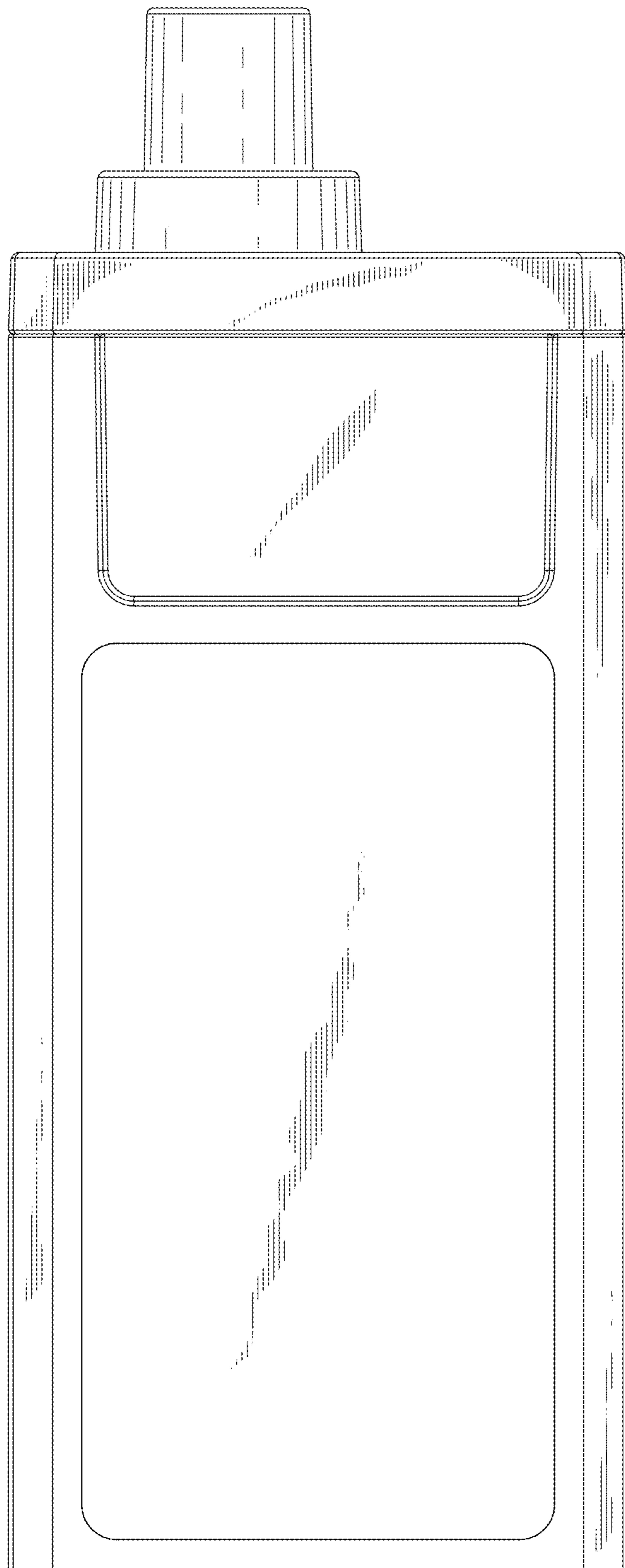

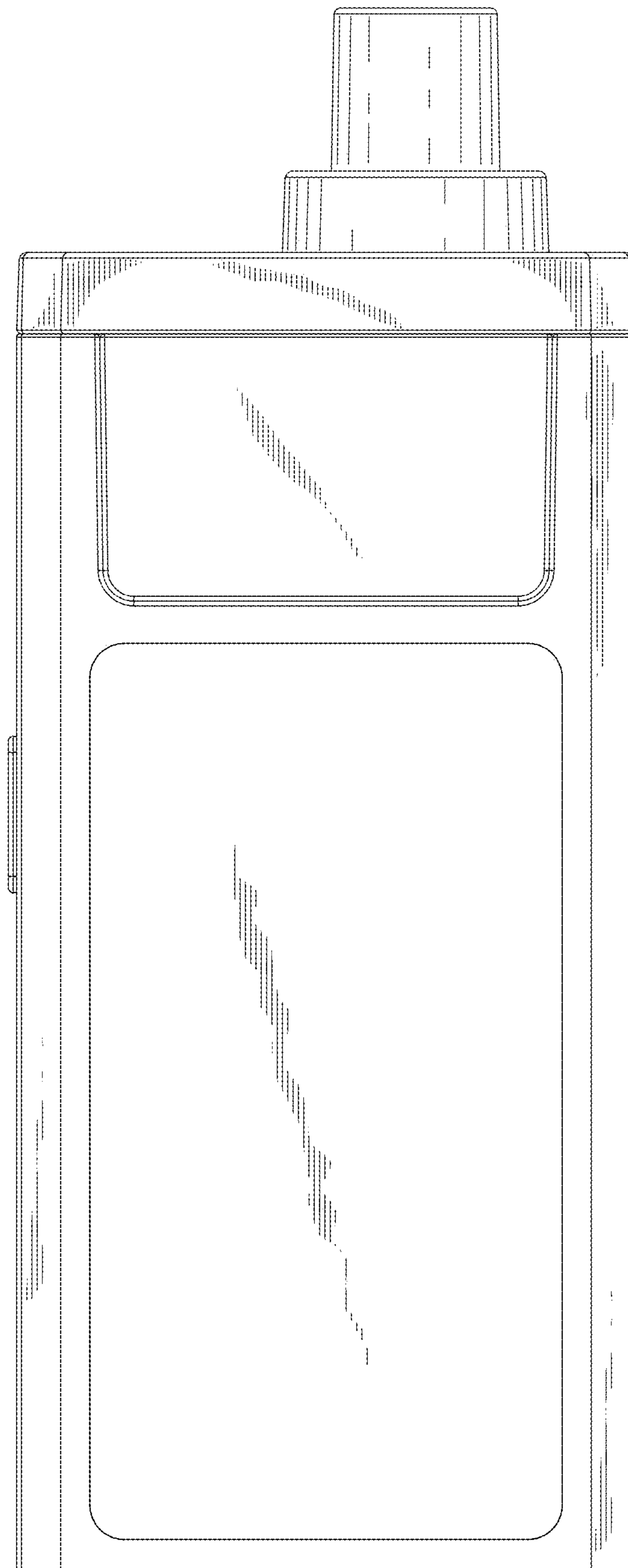

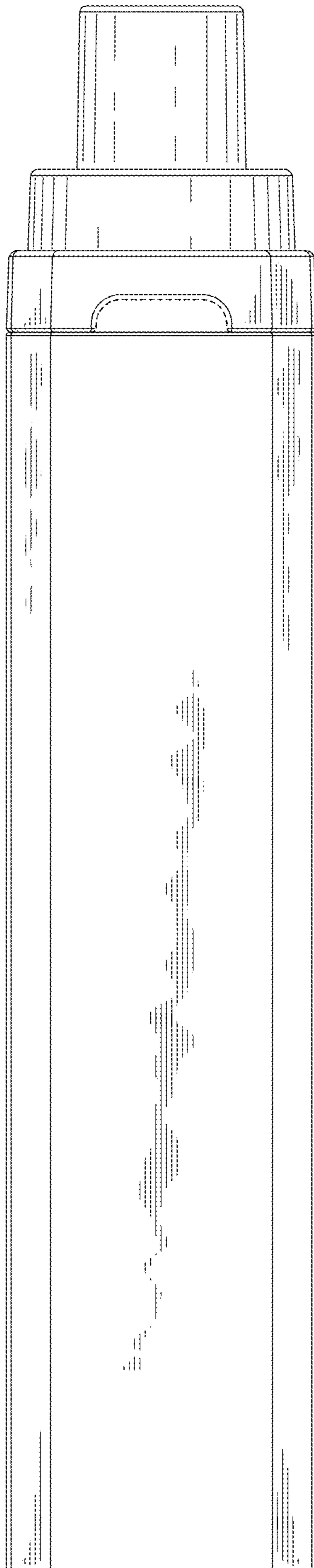

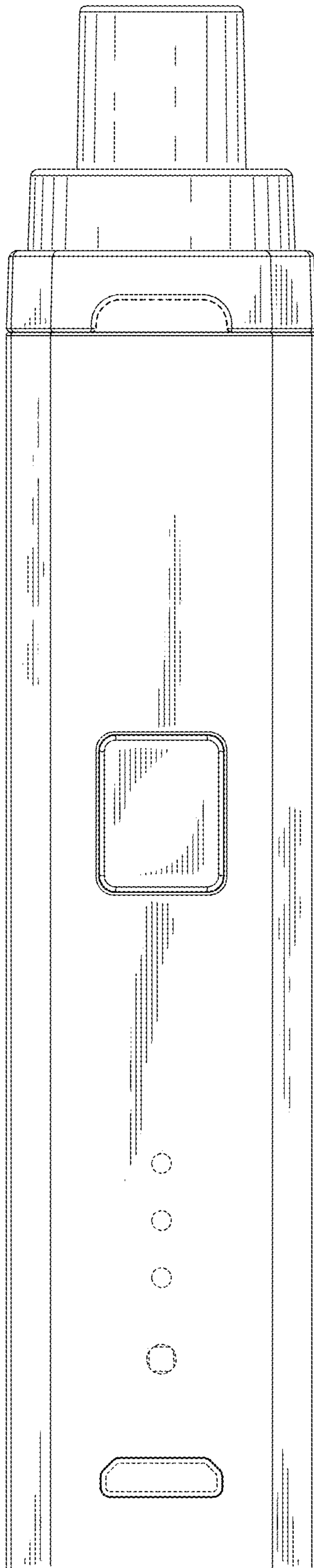

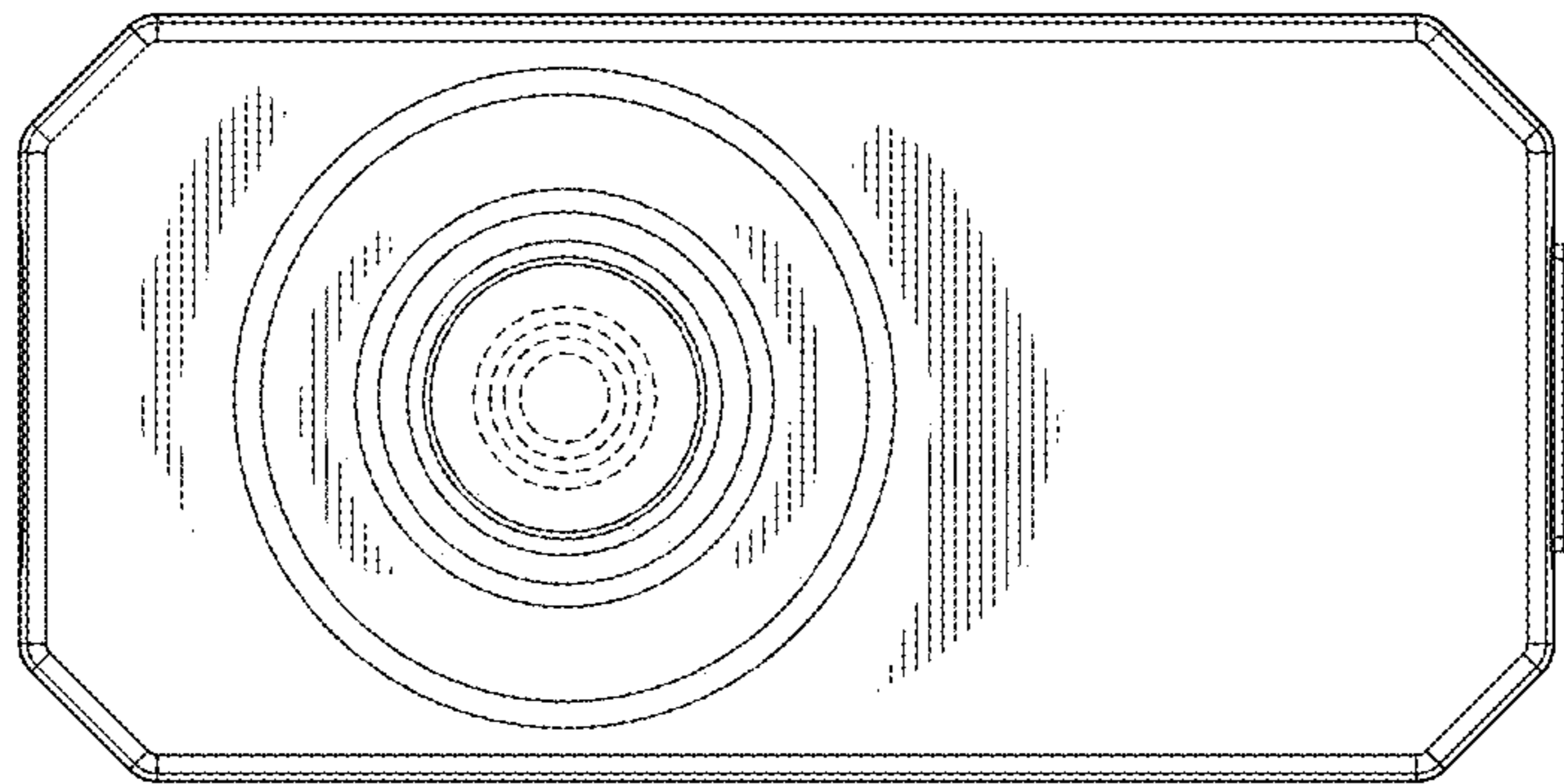

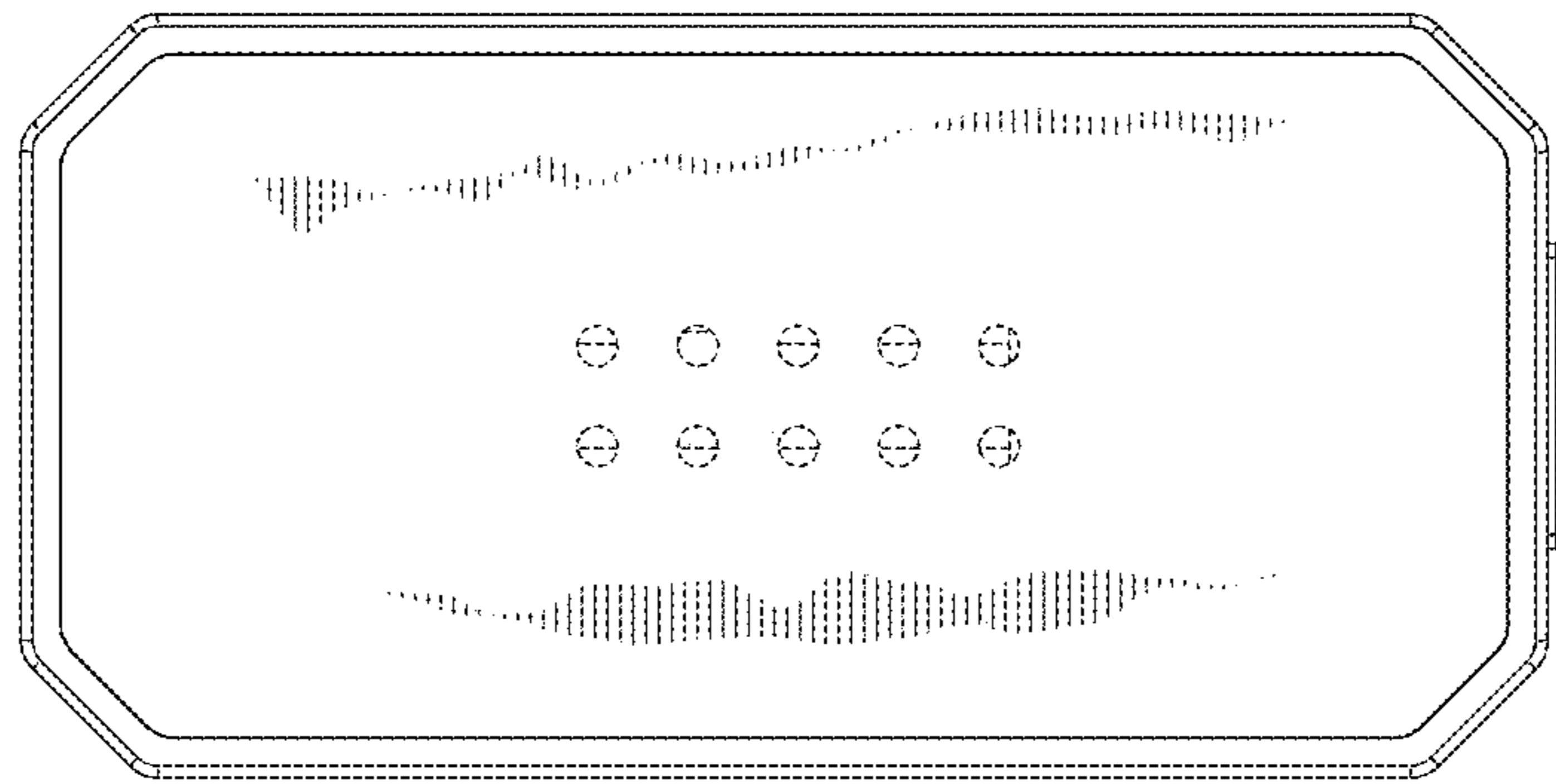

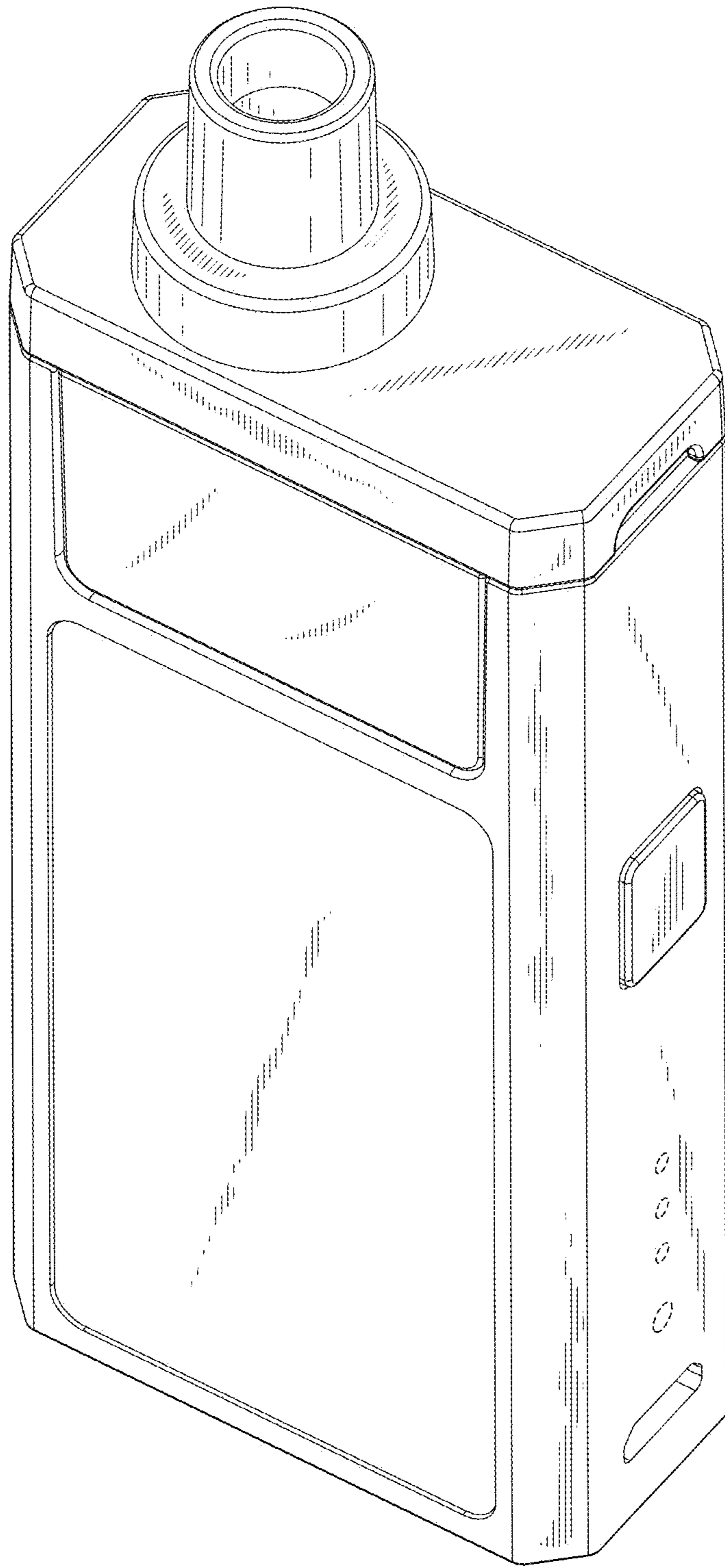

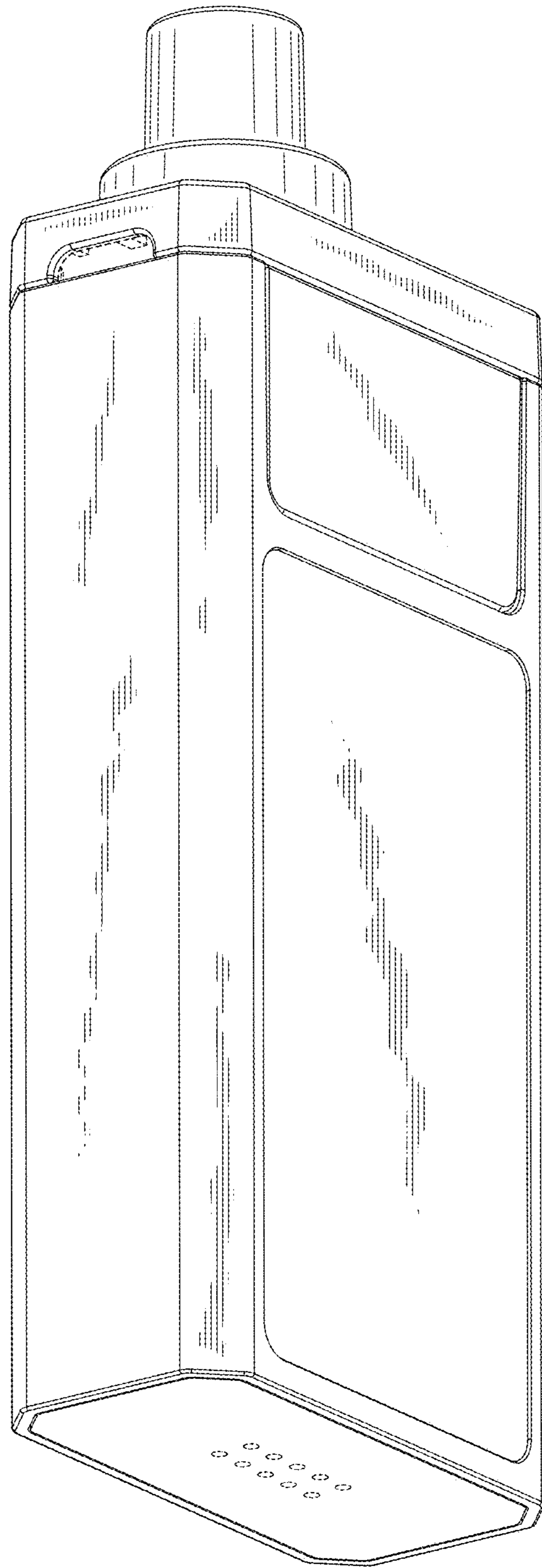
