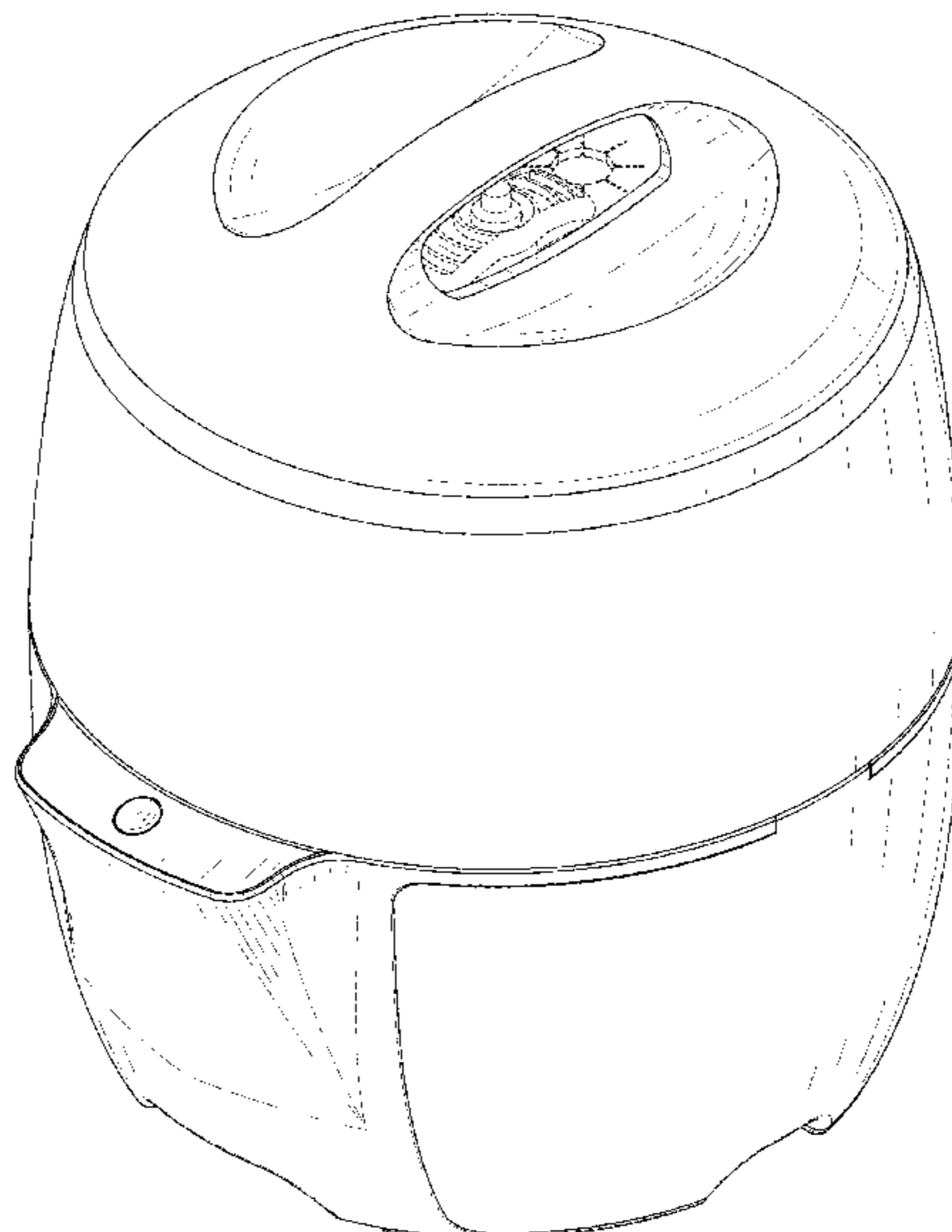
FIG. 1 is a front elevation view of a cosmetic brush cleaning machine, showing my new design;

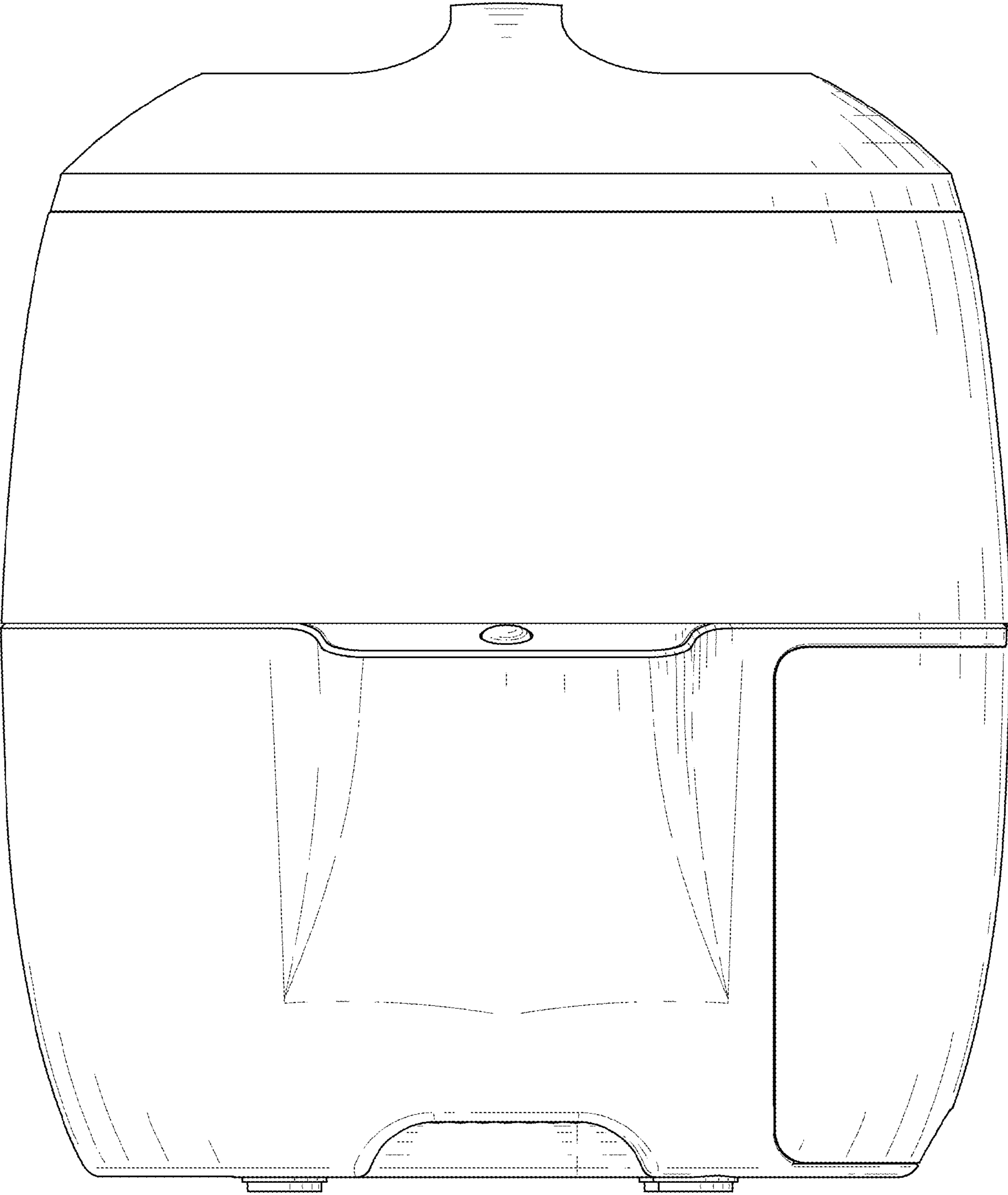

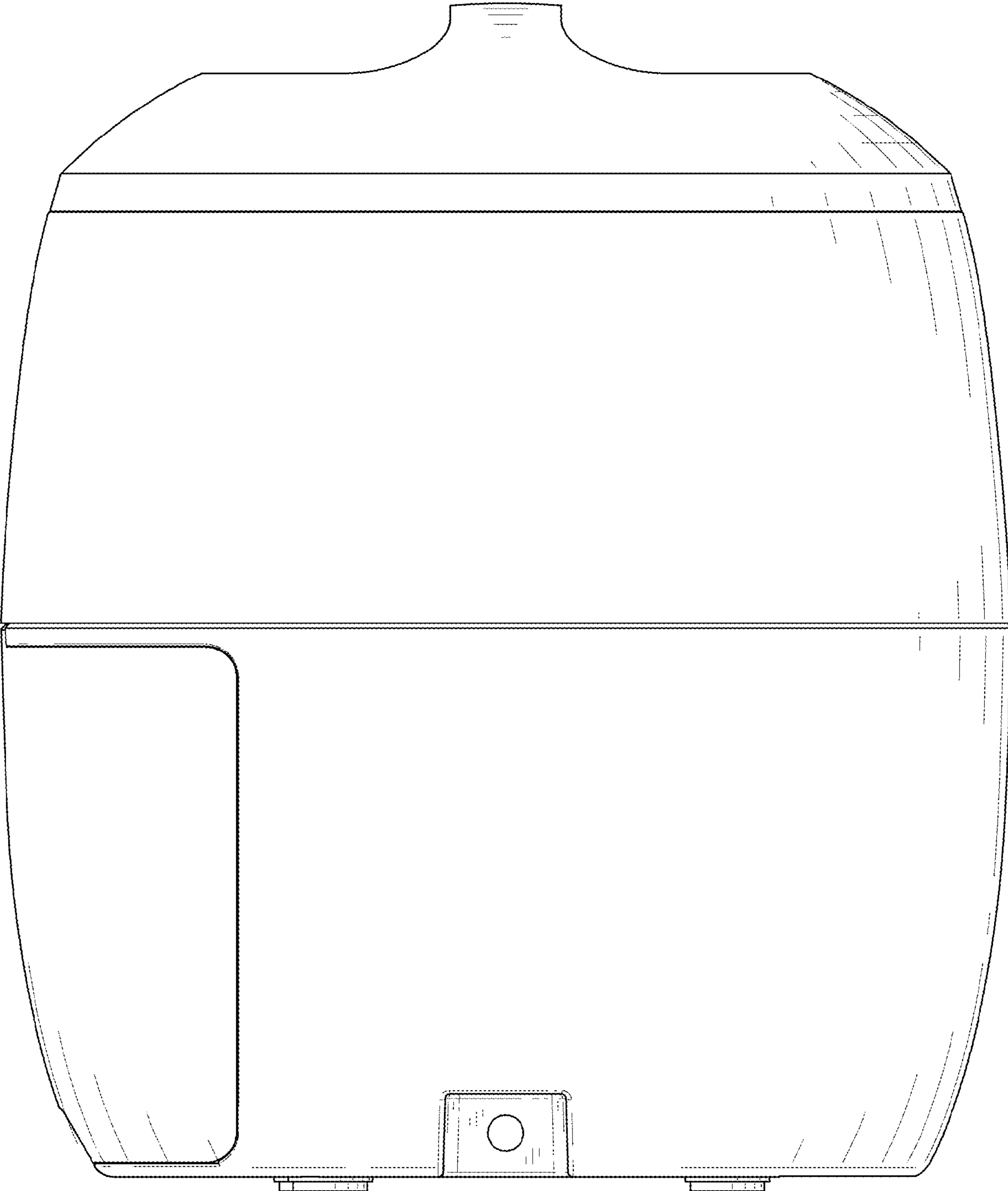

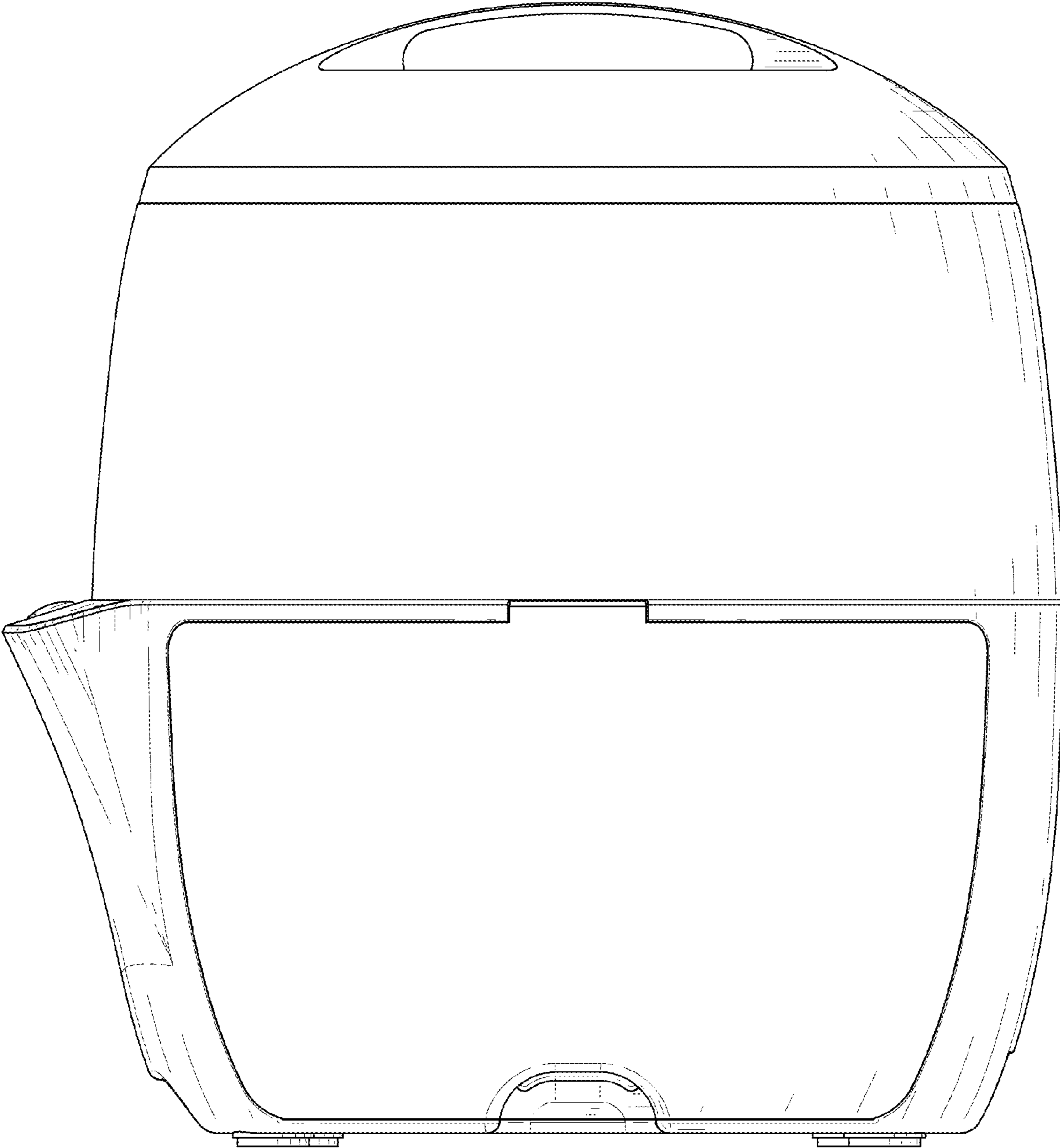

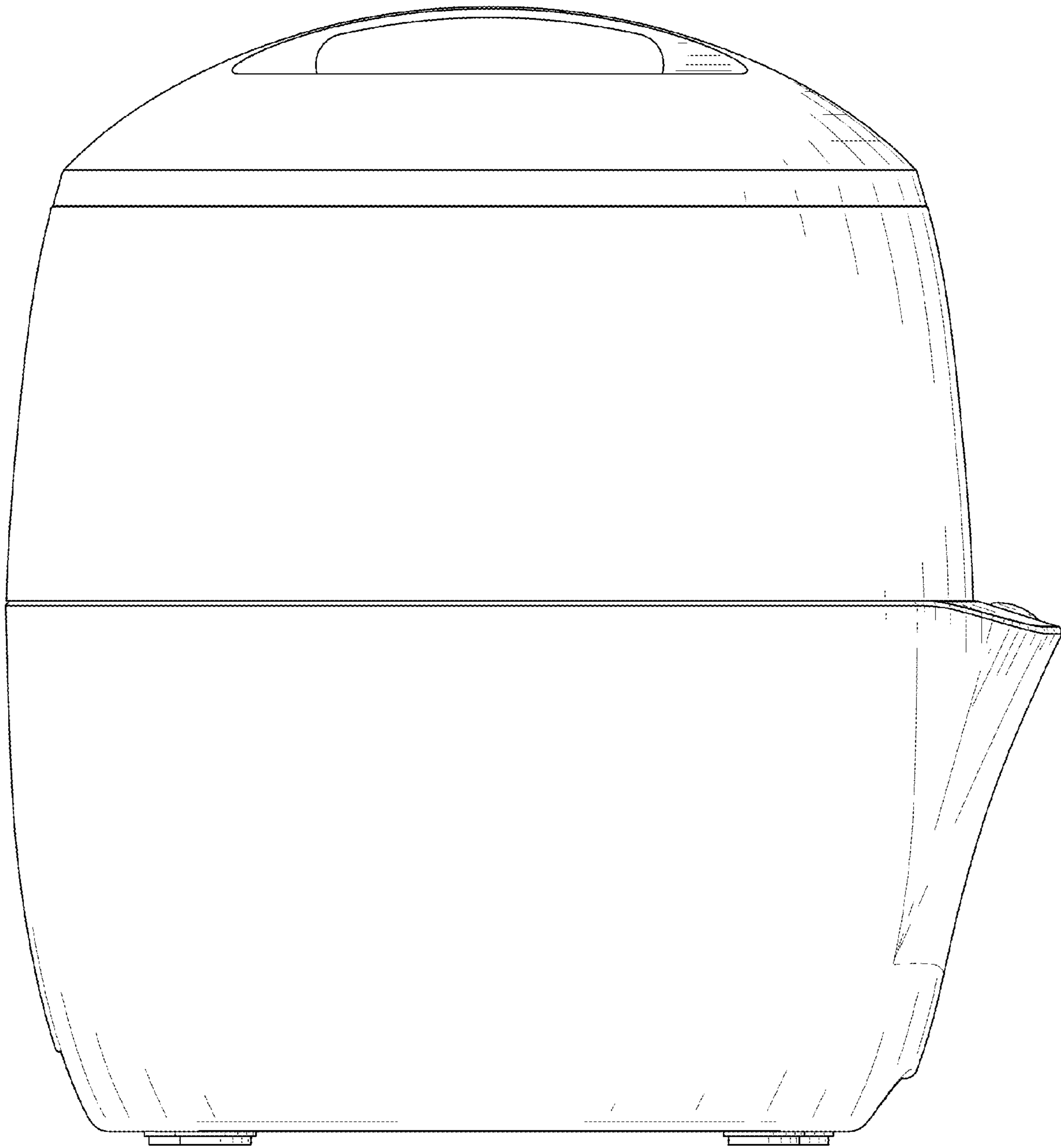

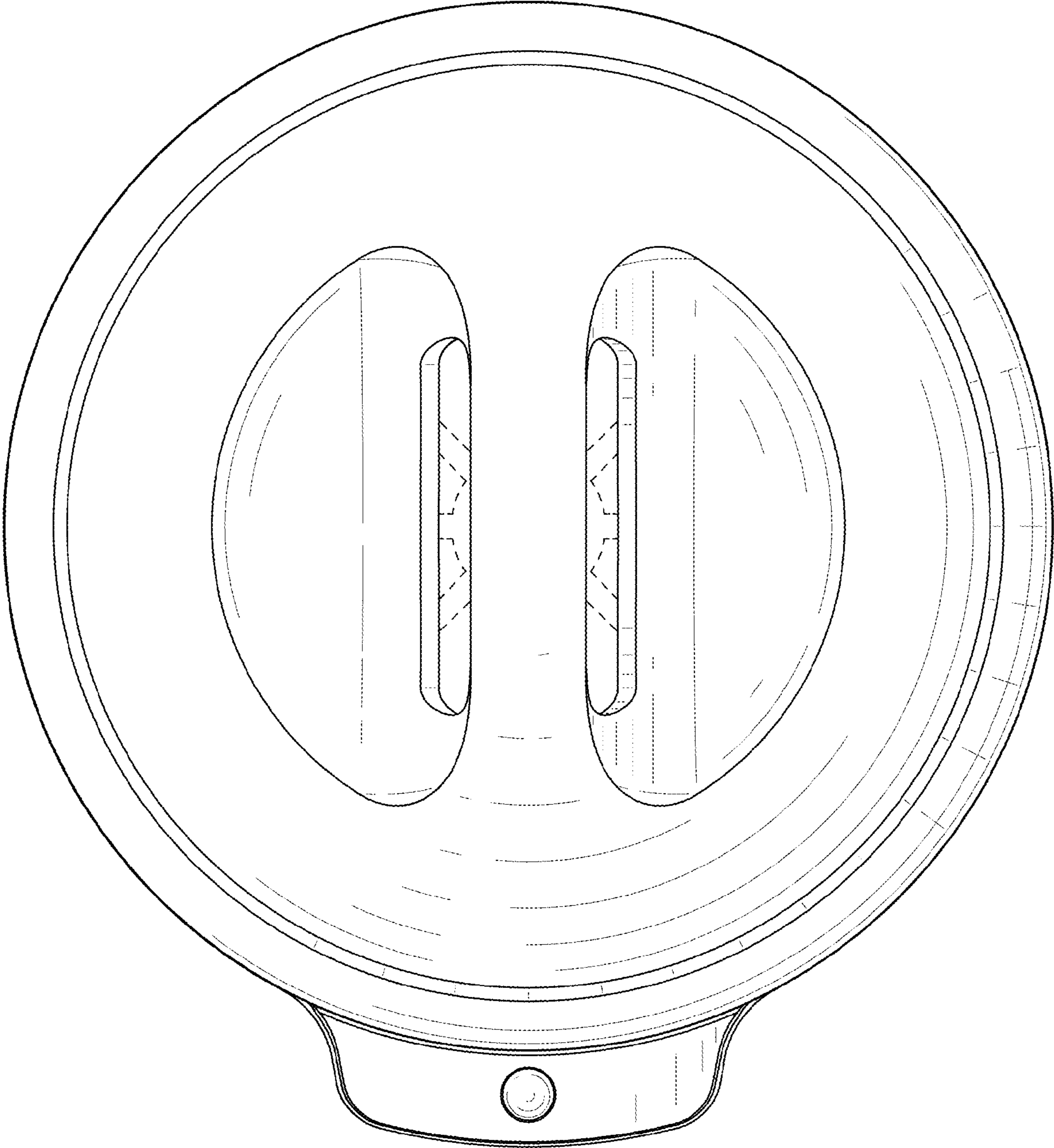

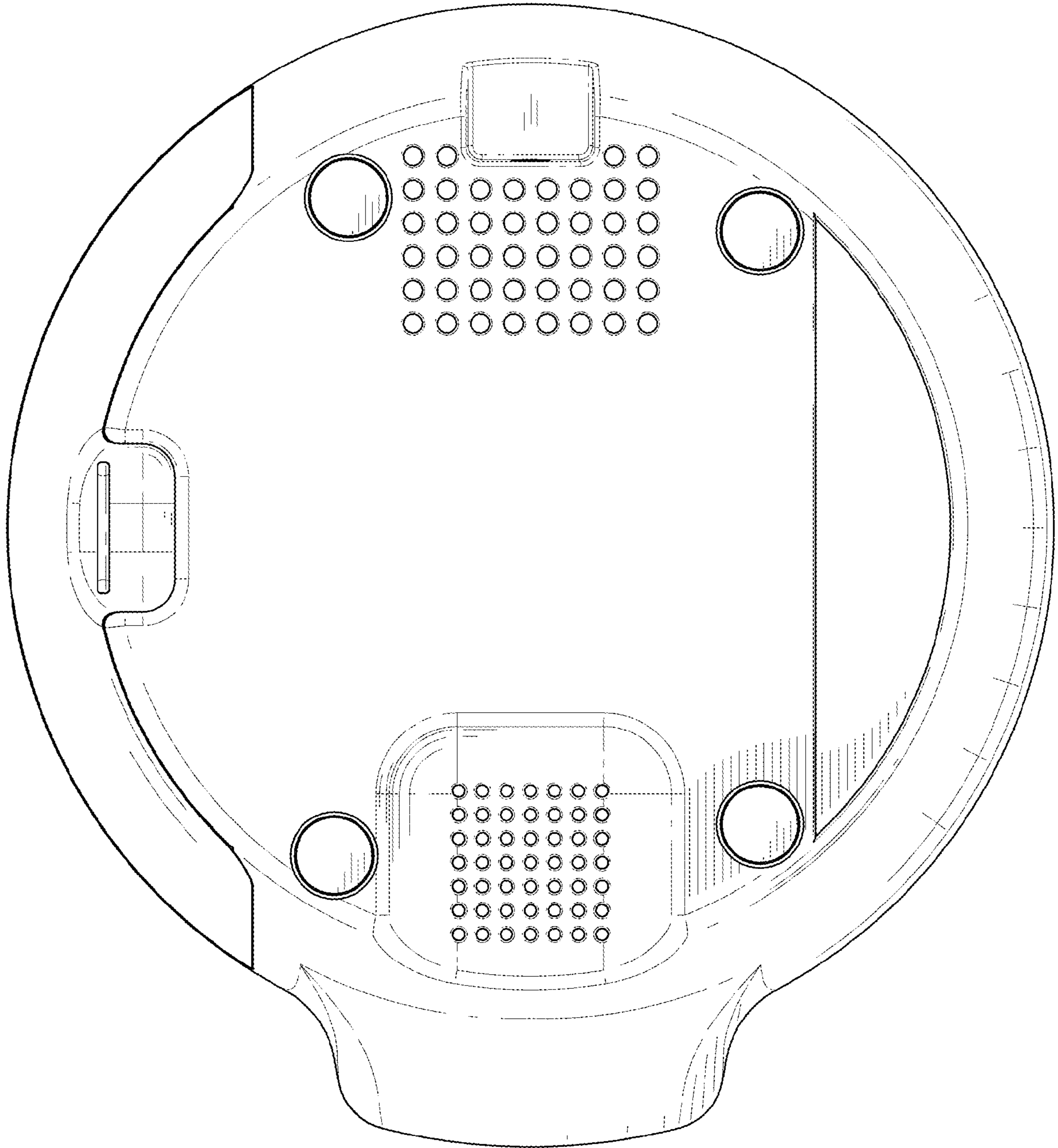

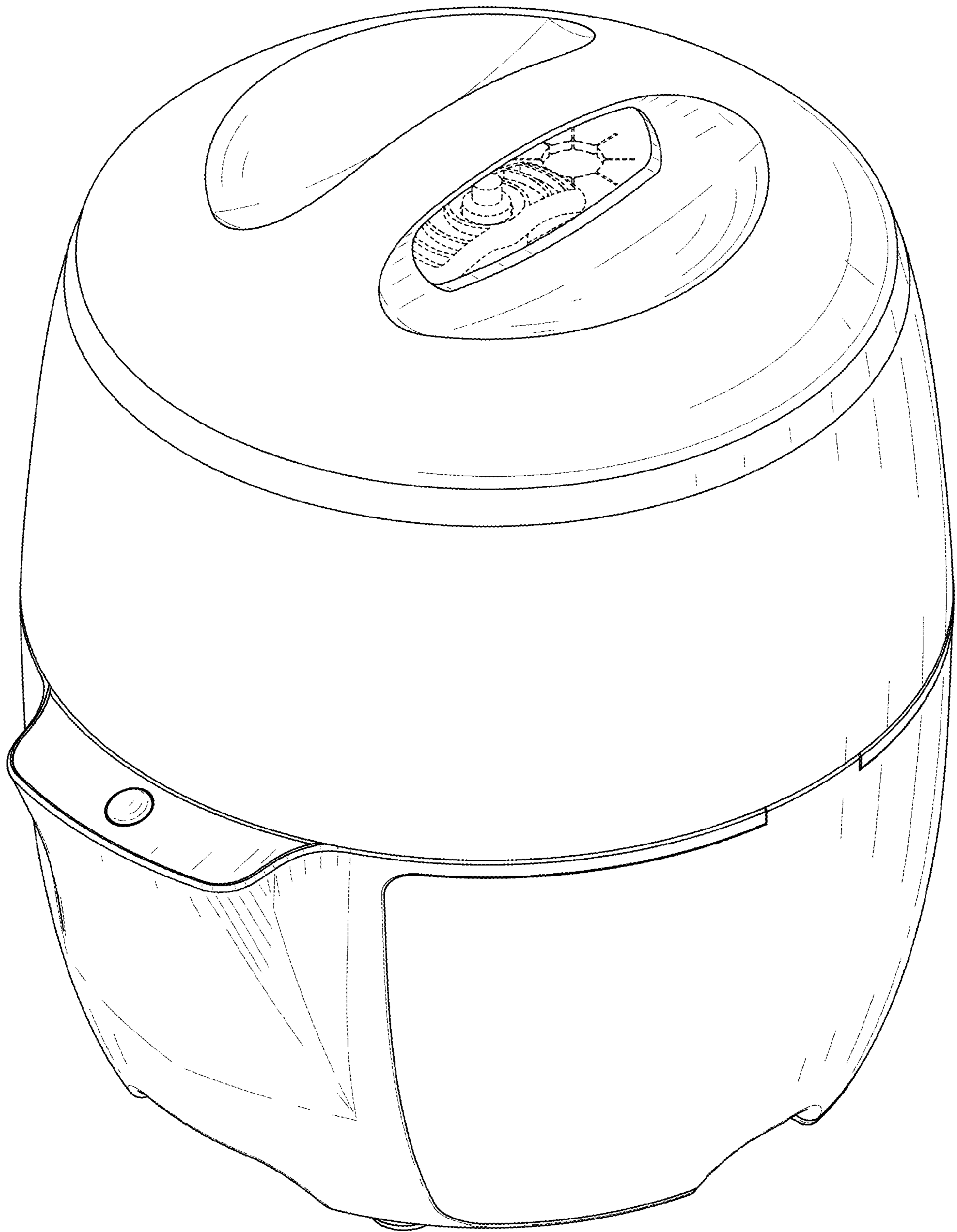

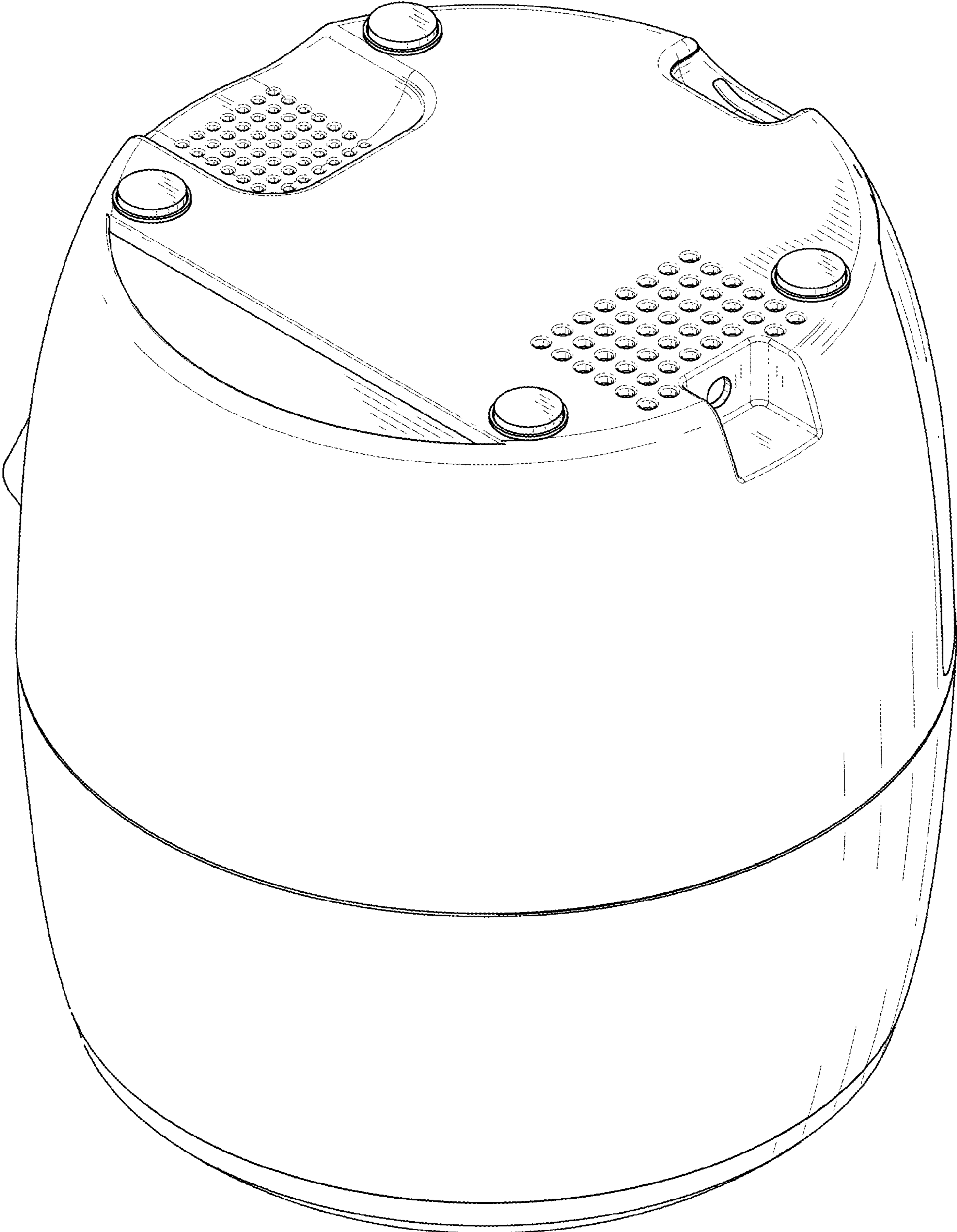
