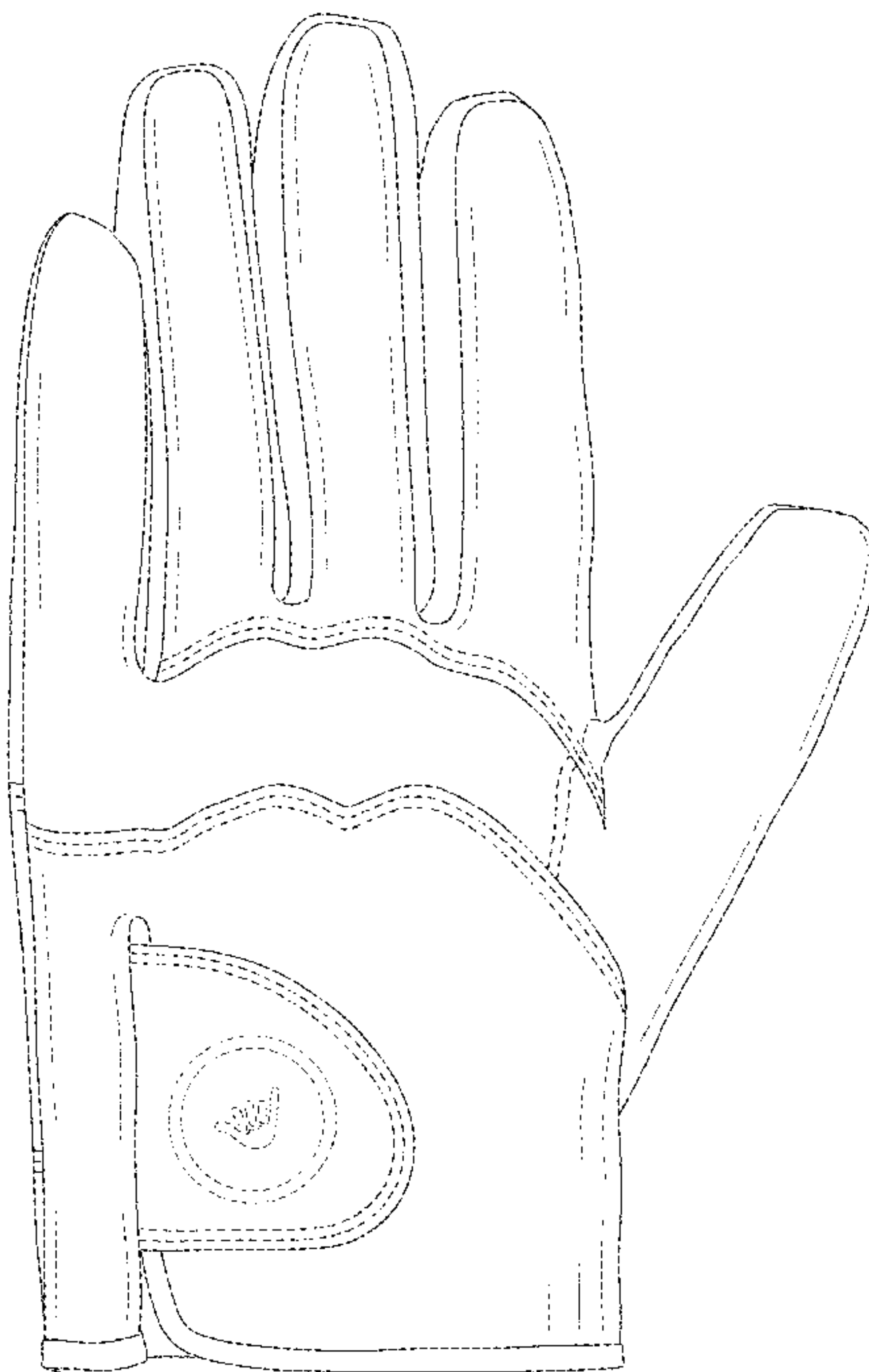
(57) **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a glove; FIG. 2 is a back view of the glove of FIG. 1; FIG. 3 is a front view of a second embodiment of the glove; and, FIG. 4 is a back view of the glove of FIG. 3. The dash dash broken lines shown in FIGS. 1-4 are for the purpose of illustrating portions of the glove that form no part of the claimed design.

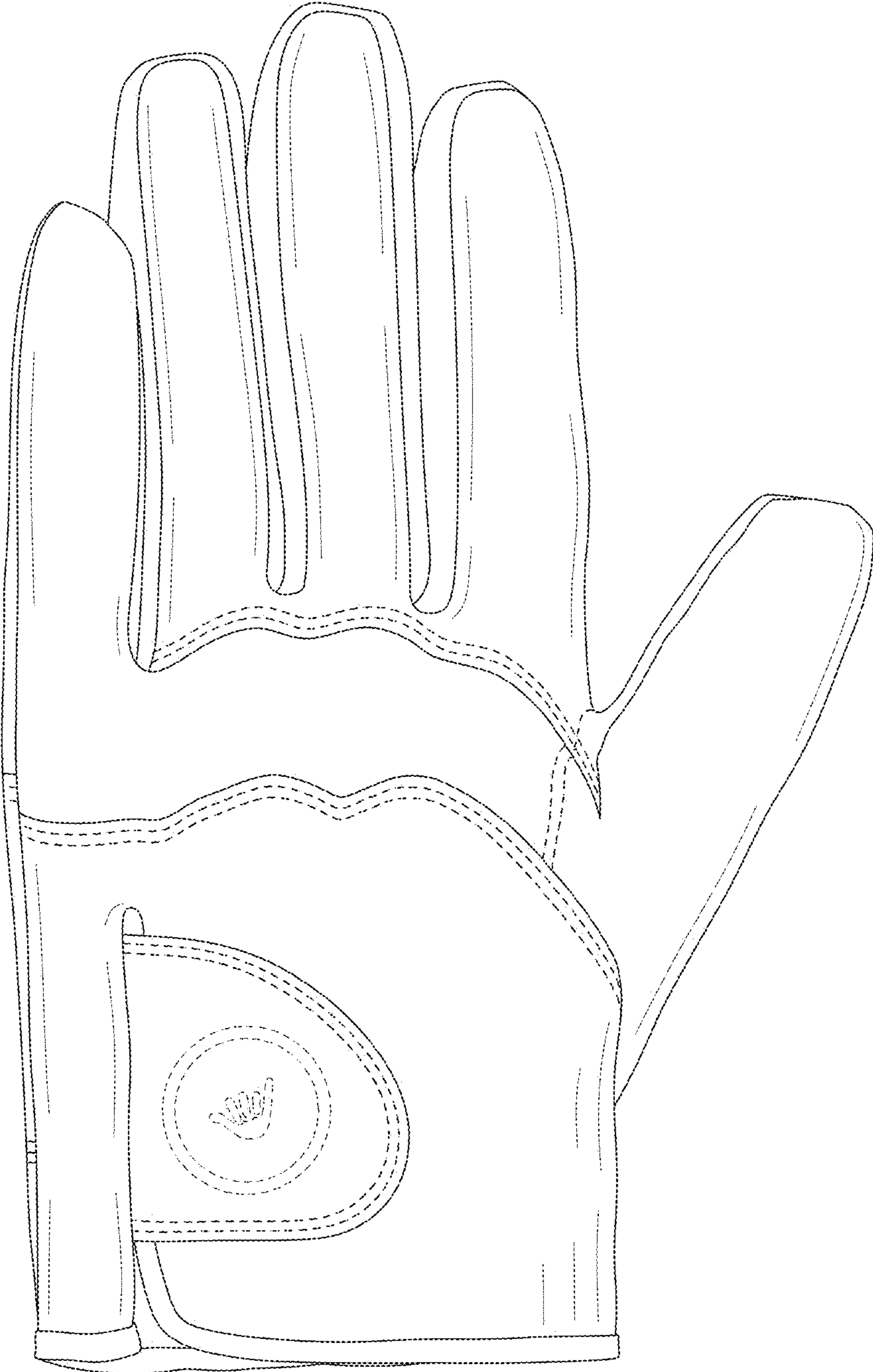

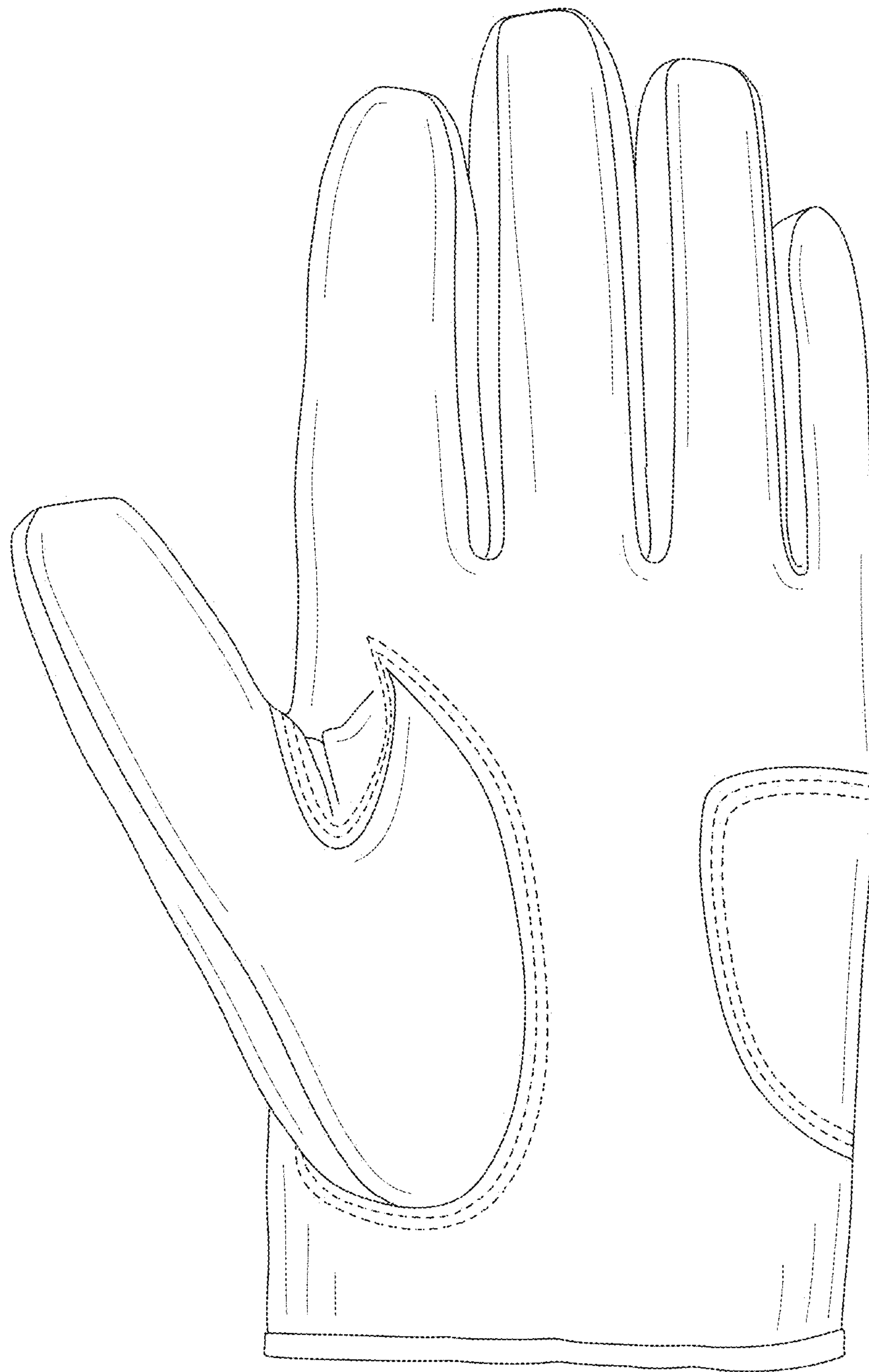

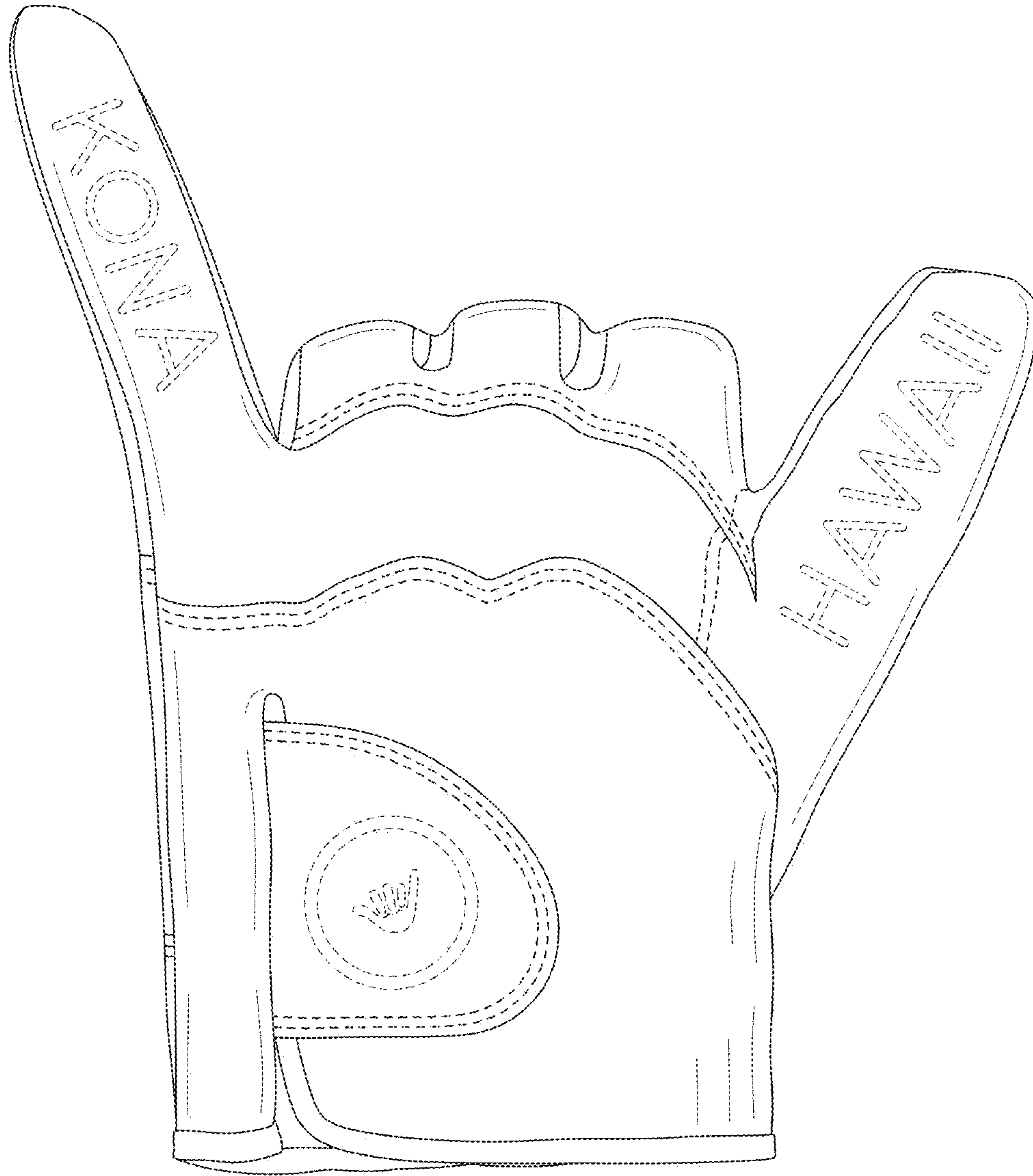

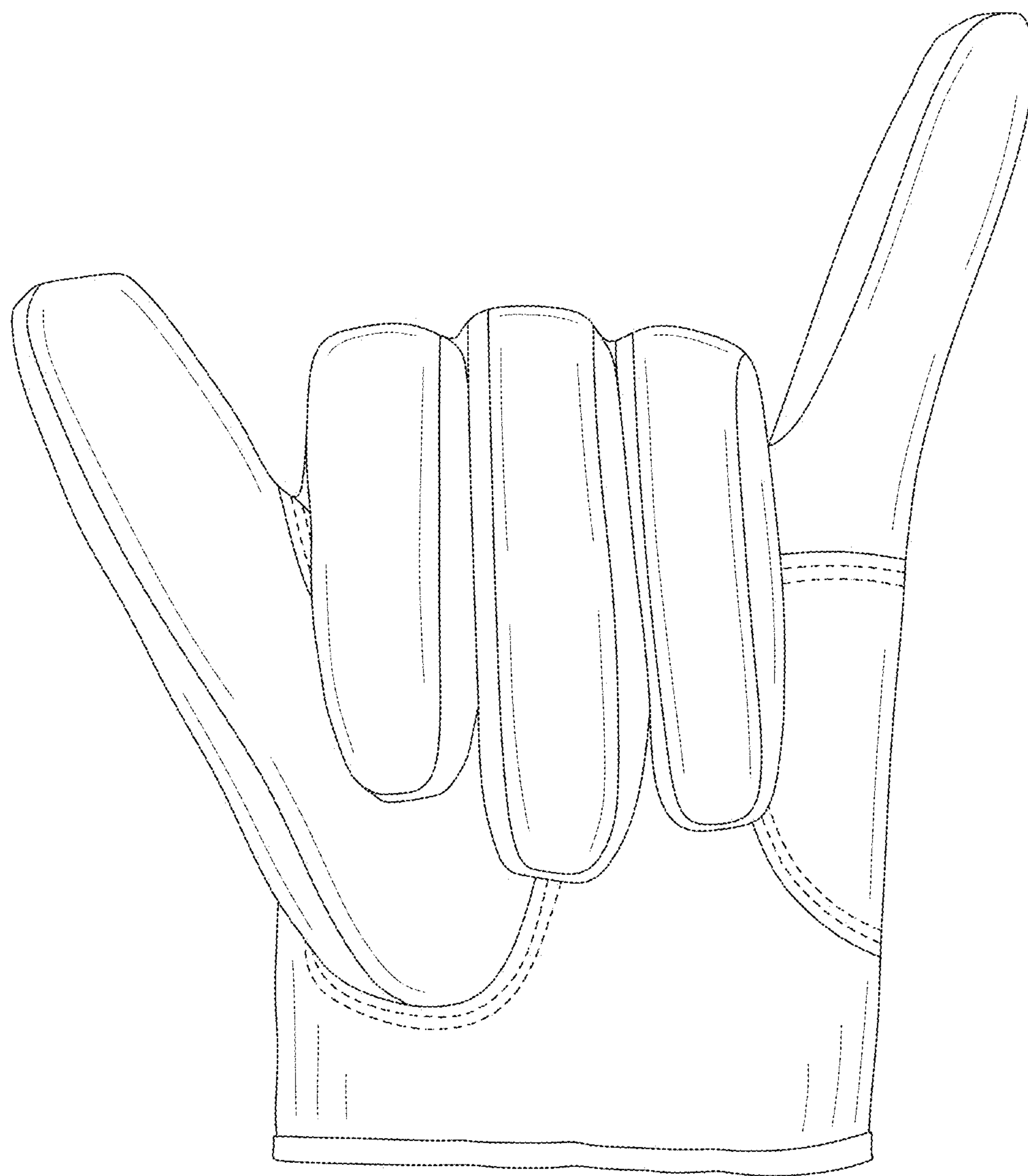
