1.6 : Top

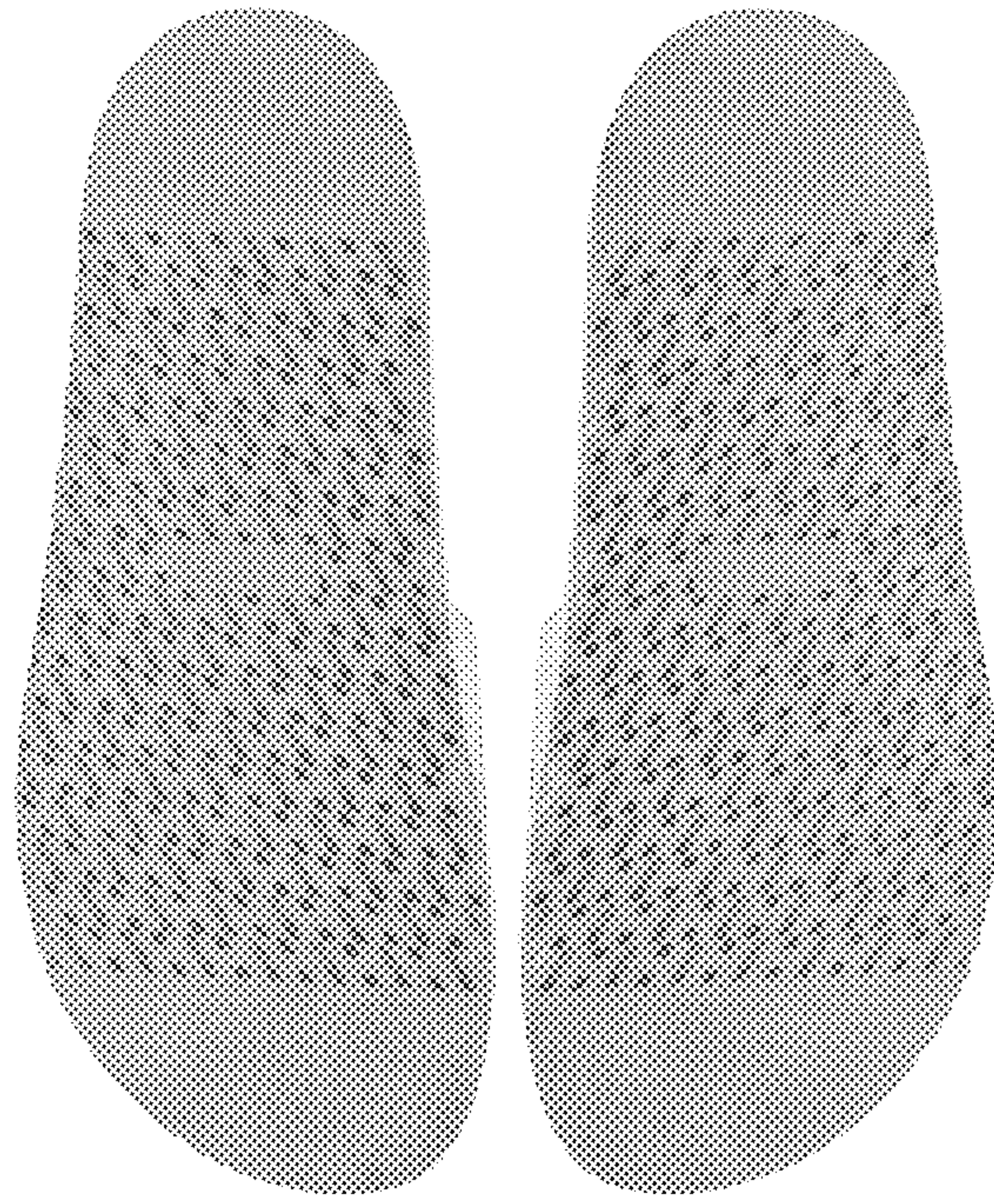
1.7 : Bottom

The dotted lines in the images represent seams and are not claimed.

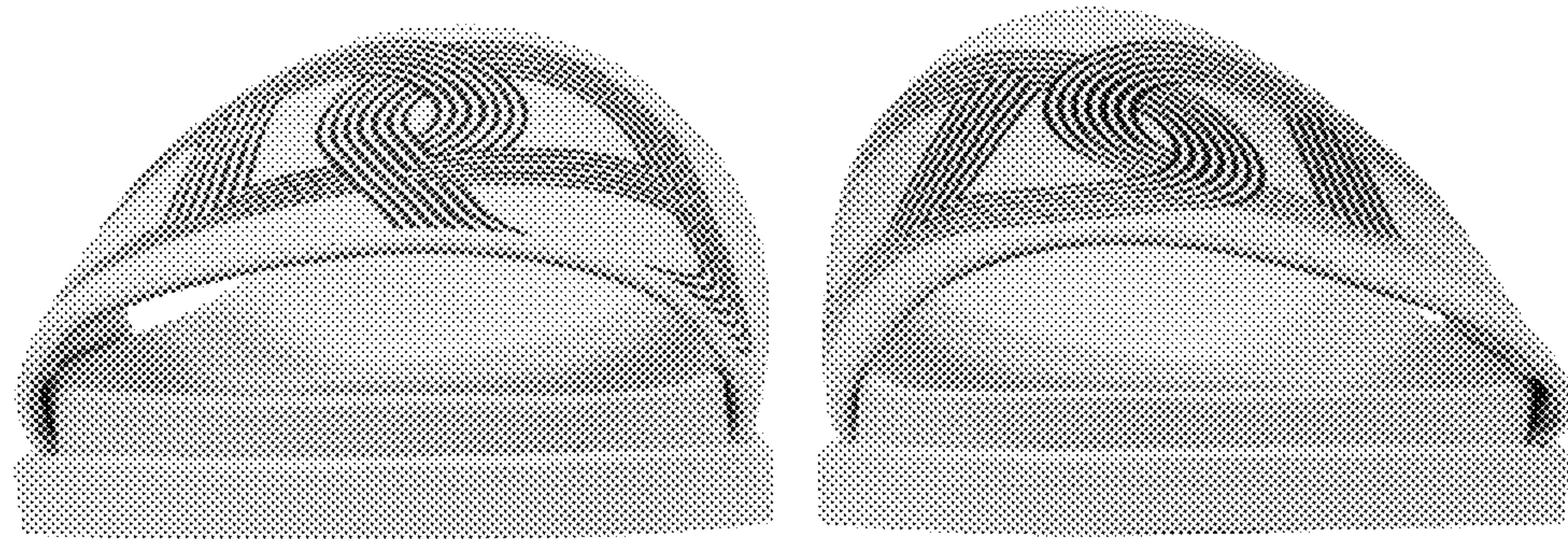

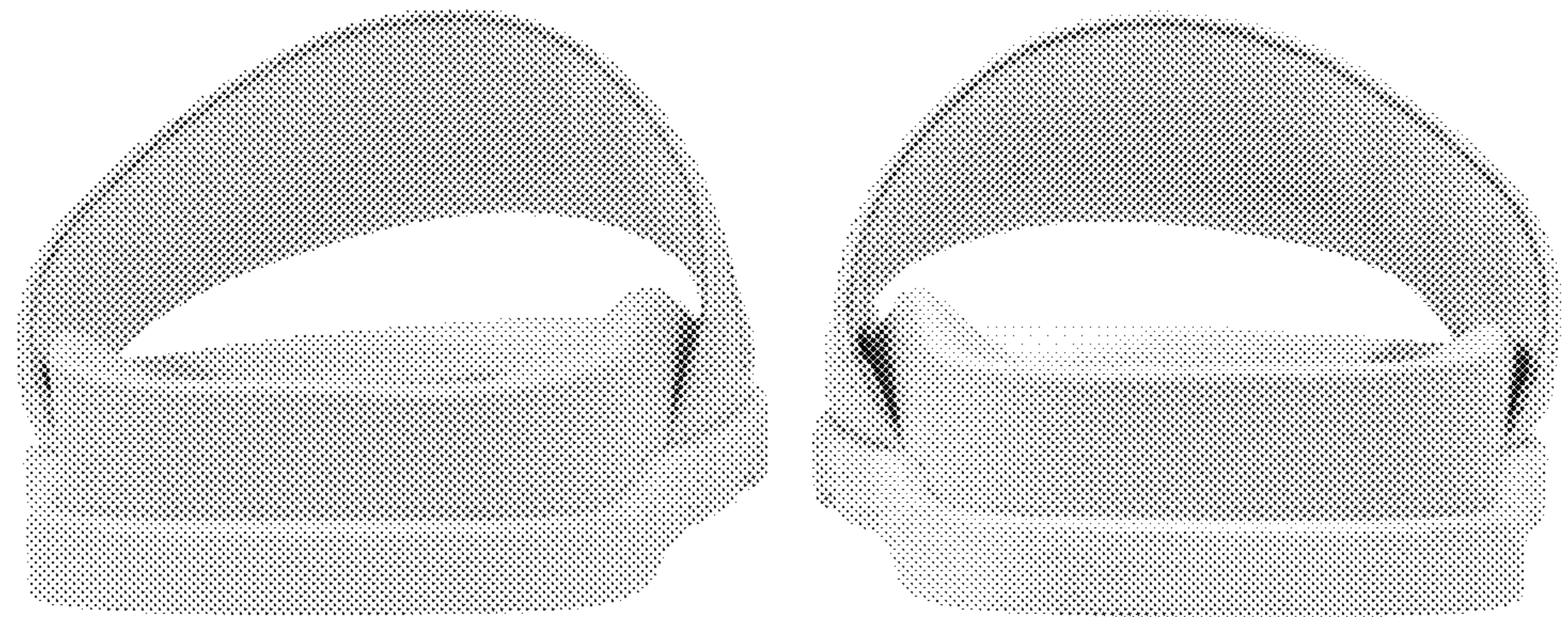

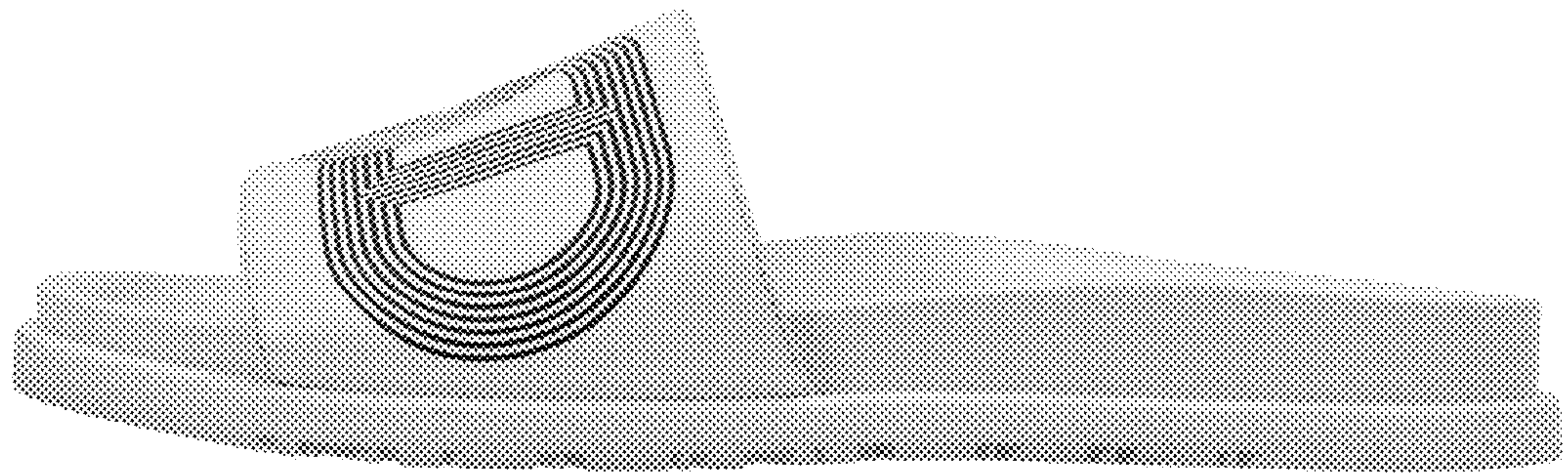

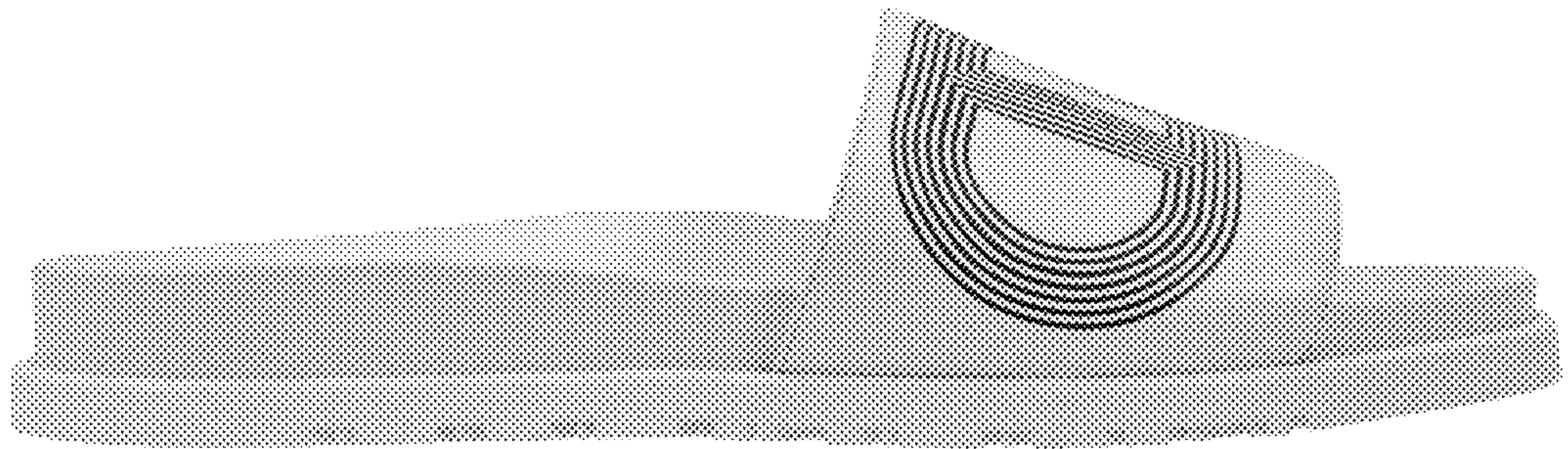

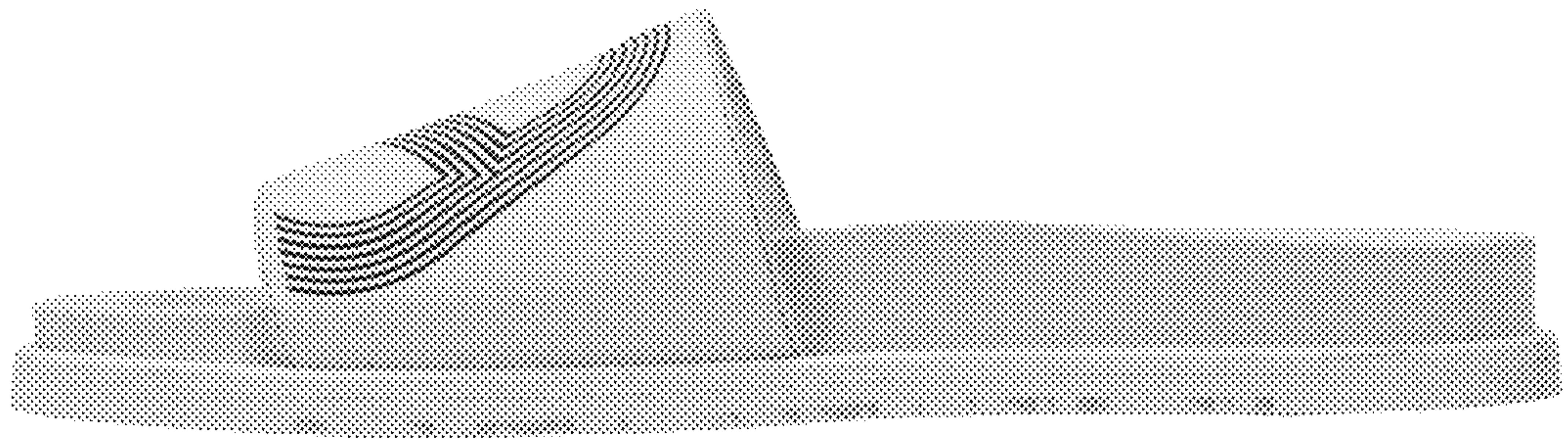
