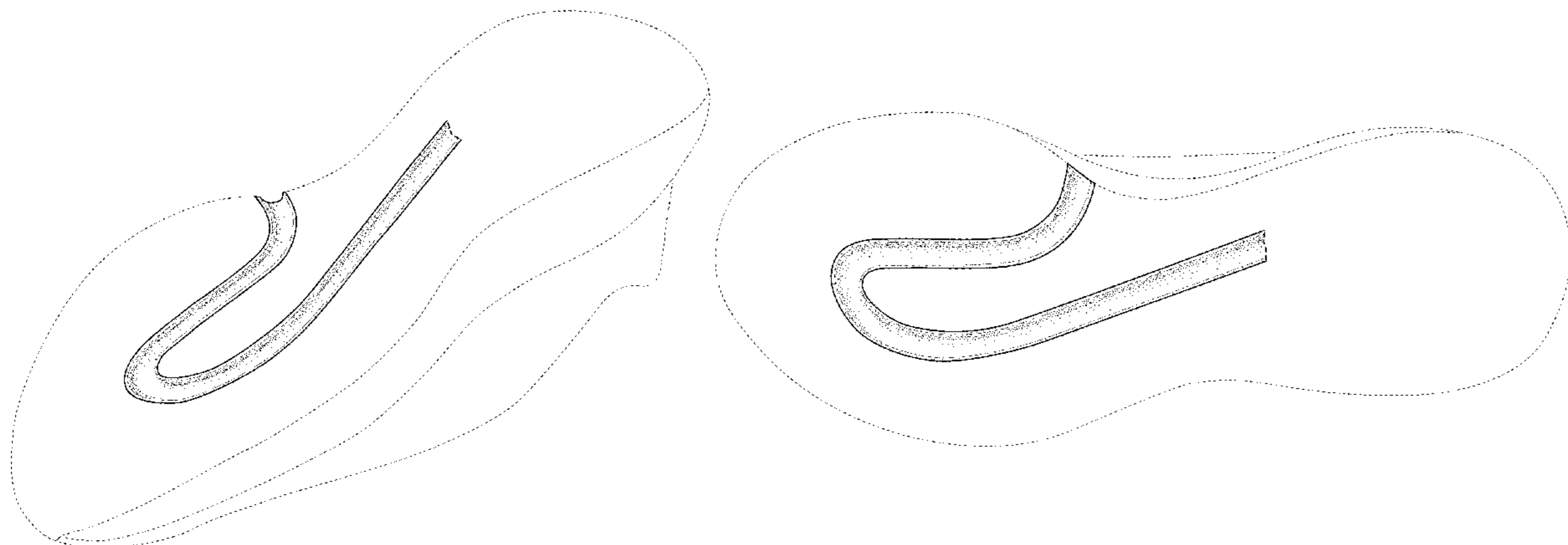
(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe, showing my new design;  
FIG. 2 is a bottom view thereof; and,  
FIG. 3 is a rear perspective view thereof.  
The dot-dot-dash broken line adjacent to the shaded area represents an unclaimed boundary of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

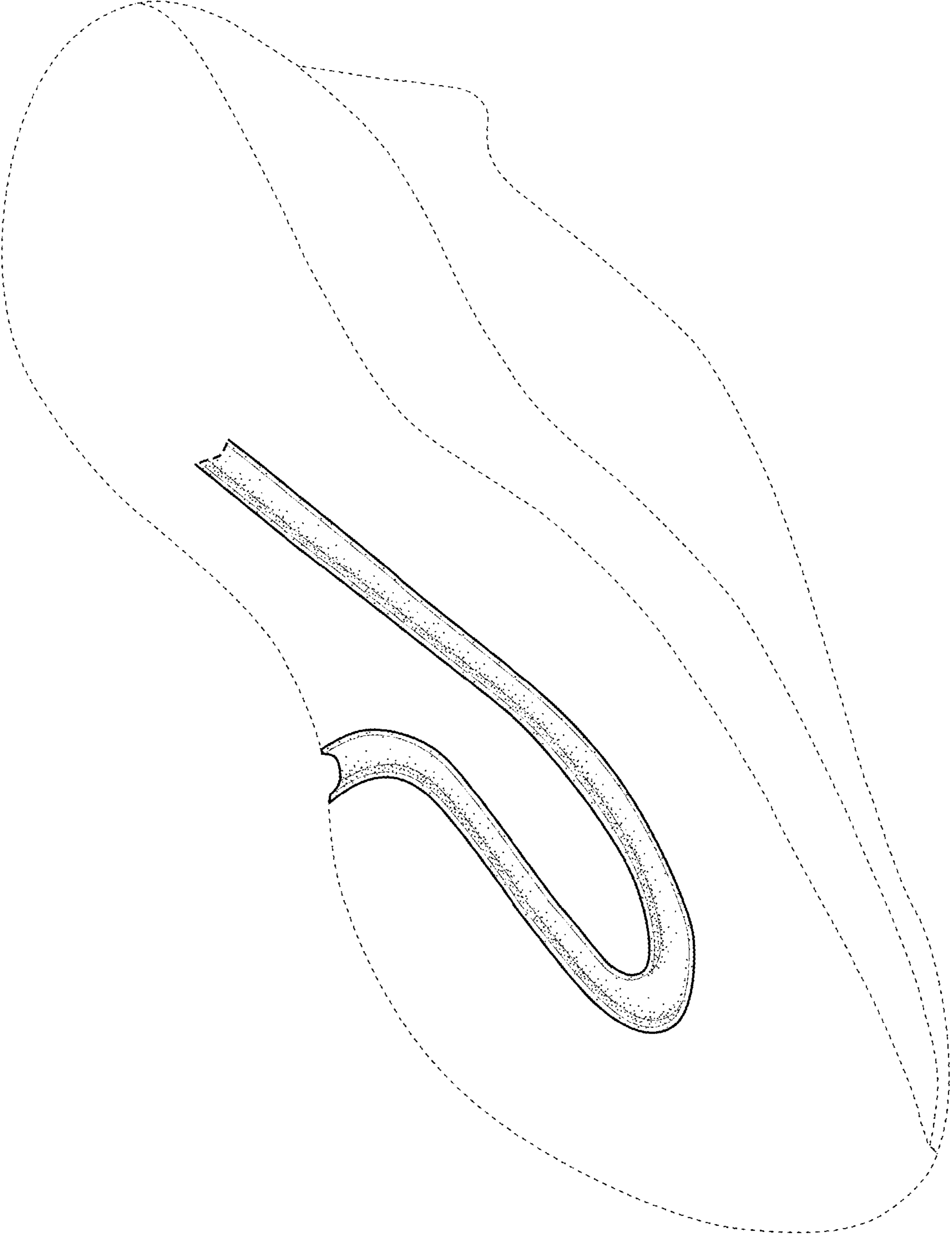

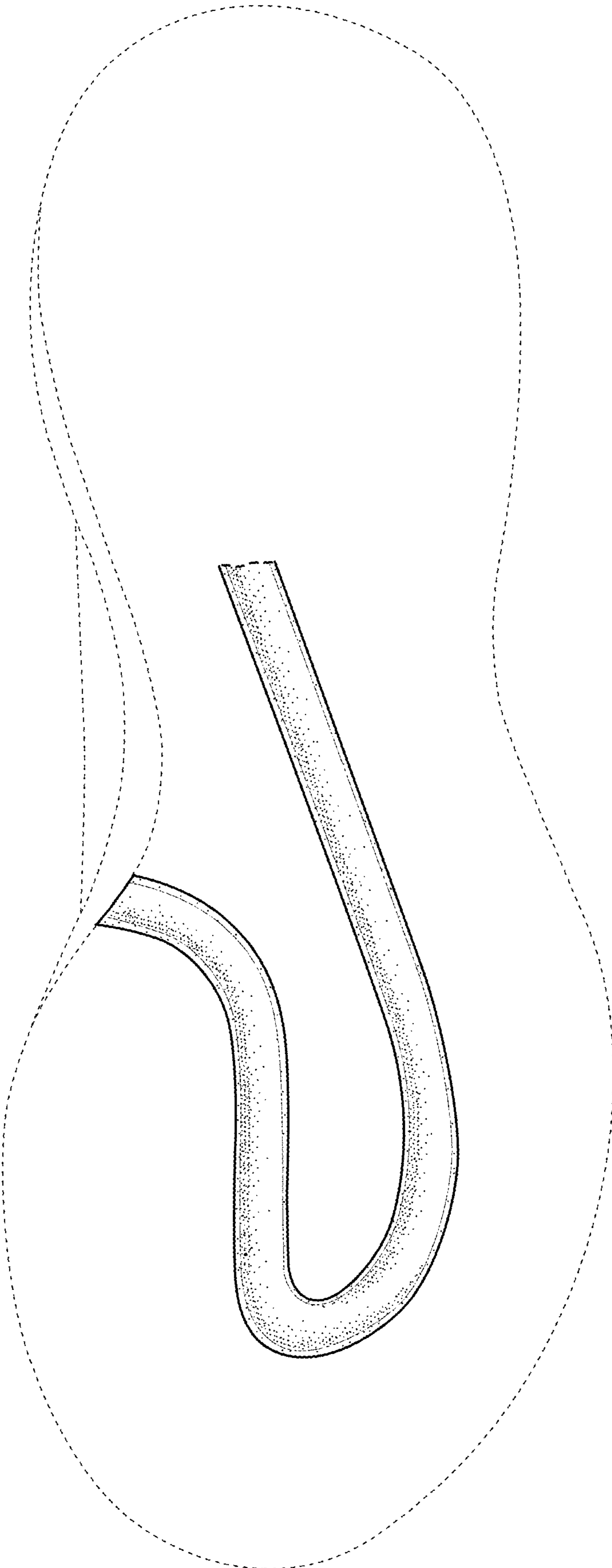

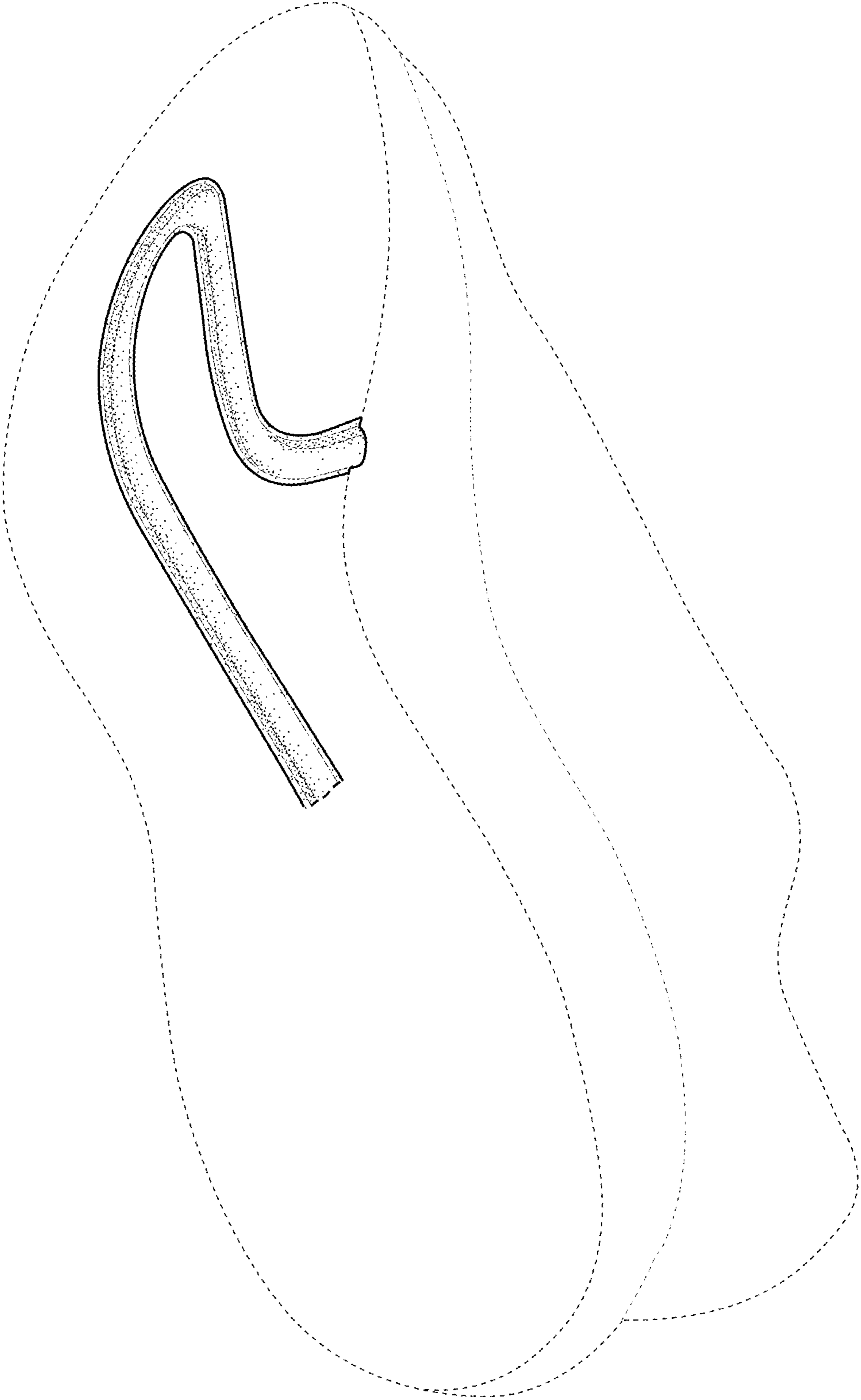
