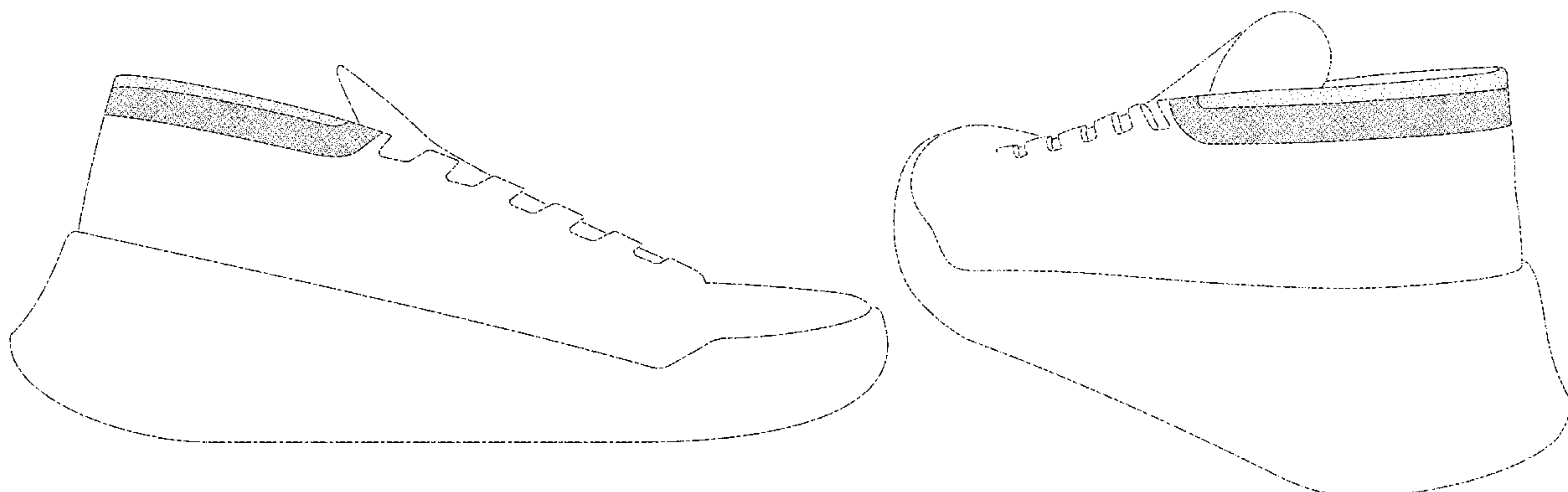
CLAIM

DESCRIPTION

FIG. 1 is a side view of a shoe showing our new design;

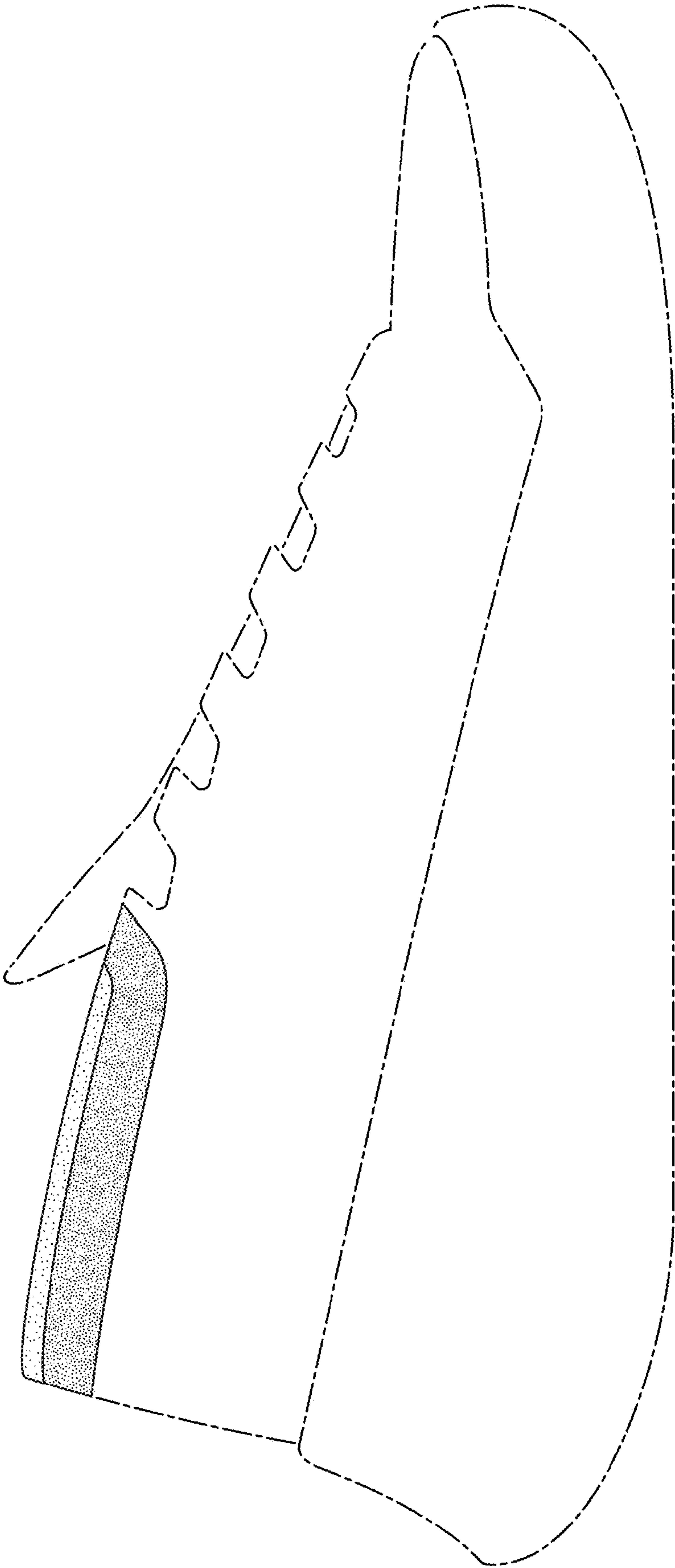

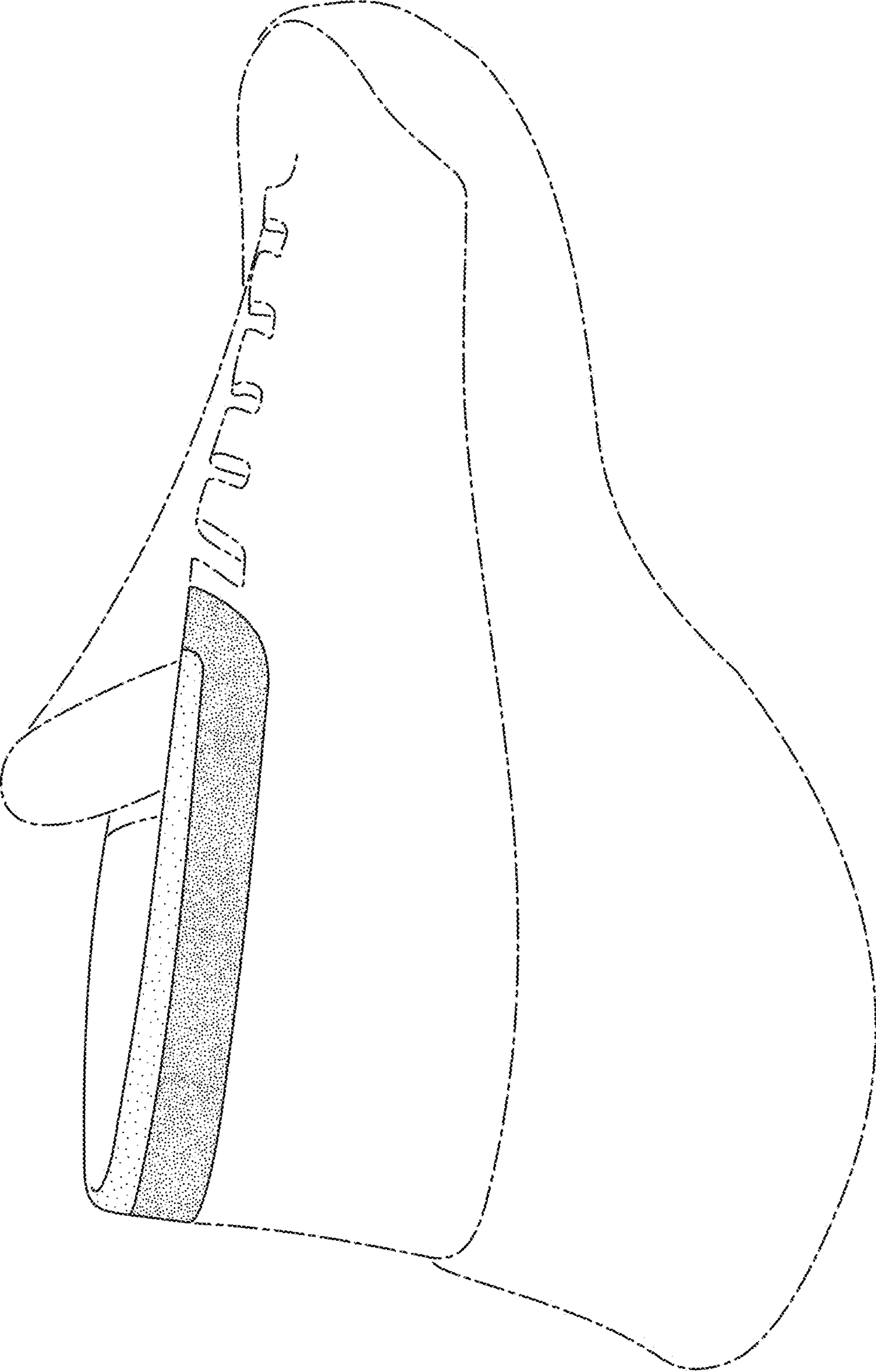

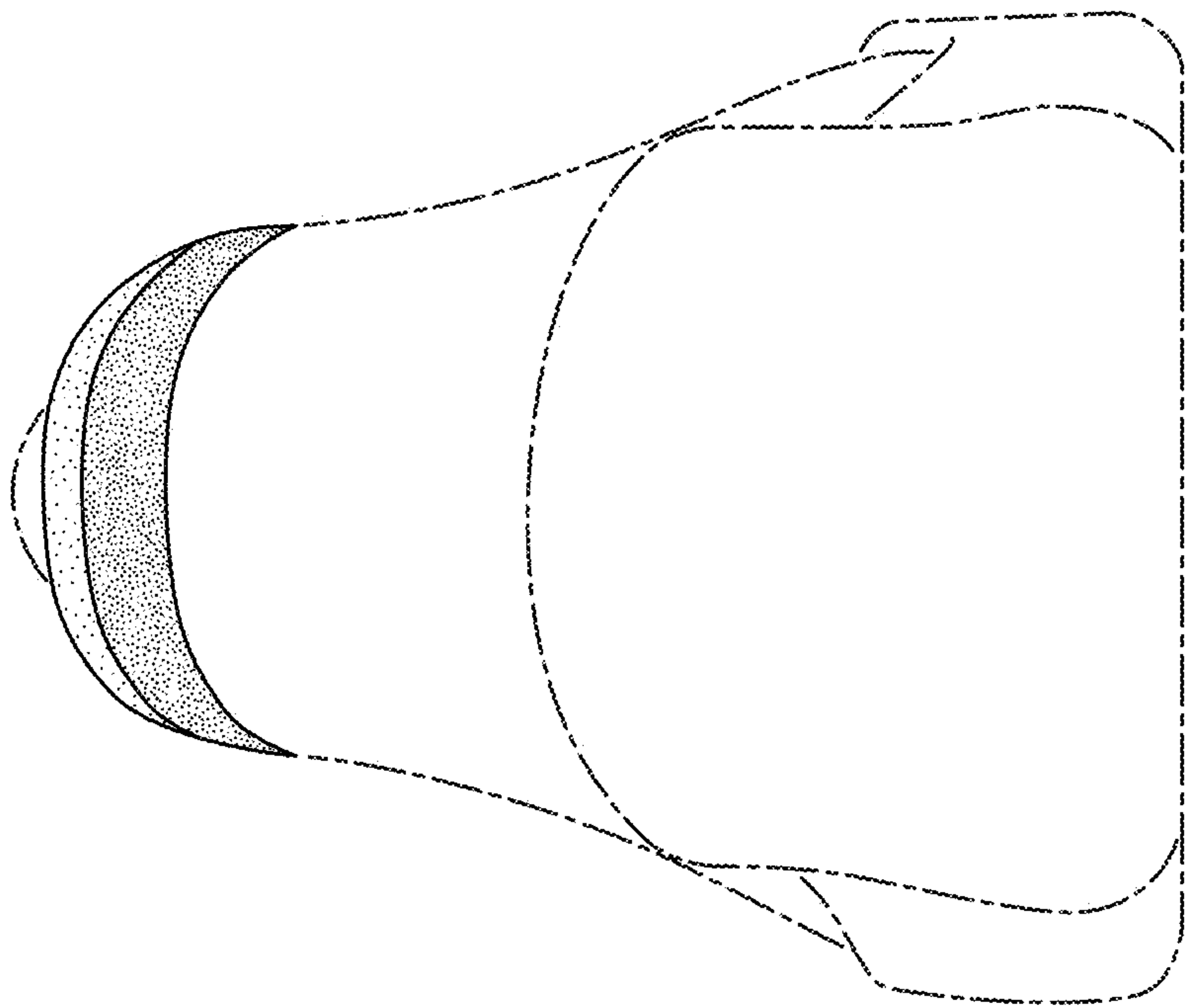

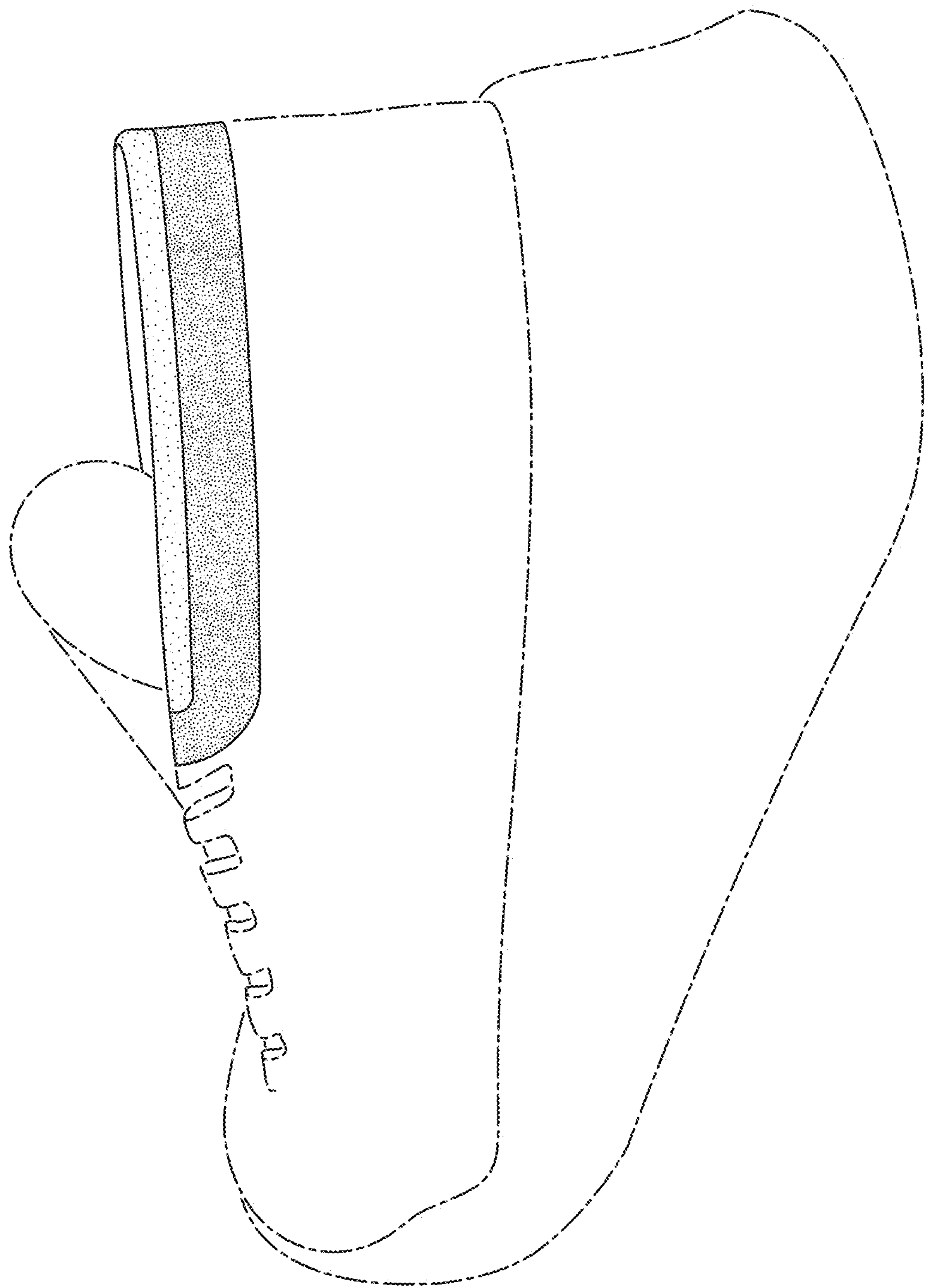

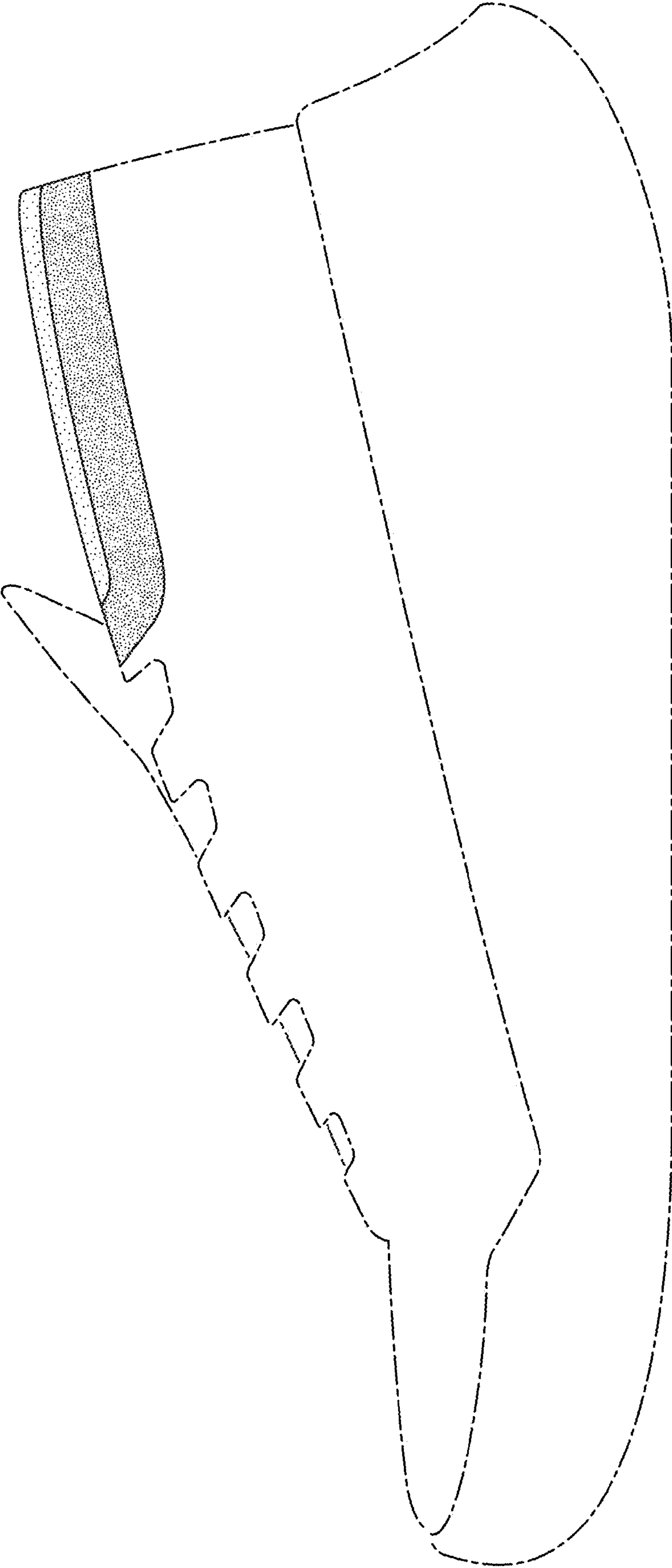
