FIG. 3 is a top view thereof;

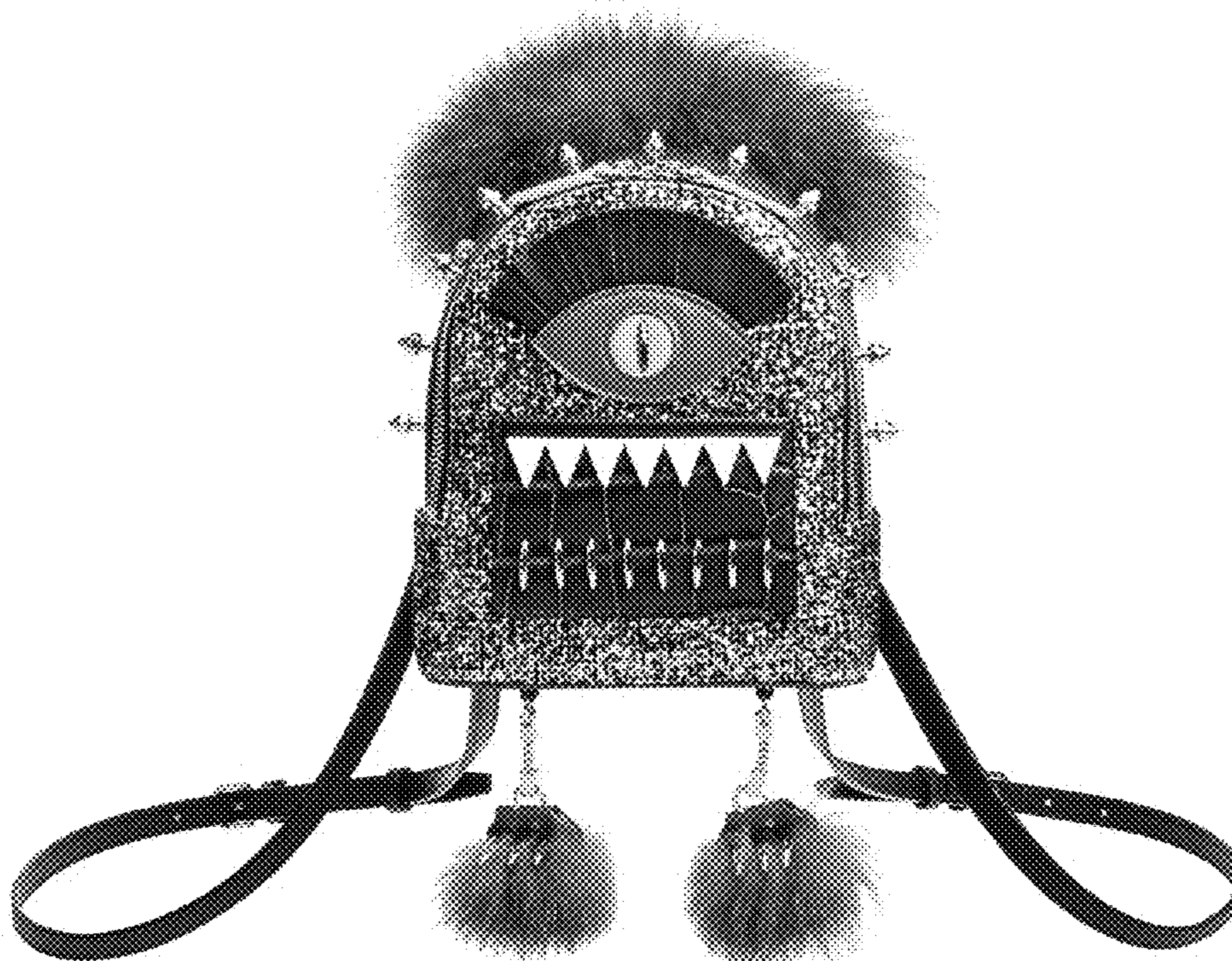
FIG. 4 is a bottom plan view thereof in an alternate position with the shoulder straps unfastened;

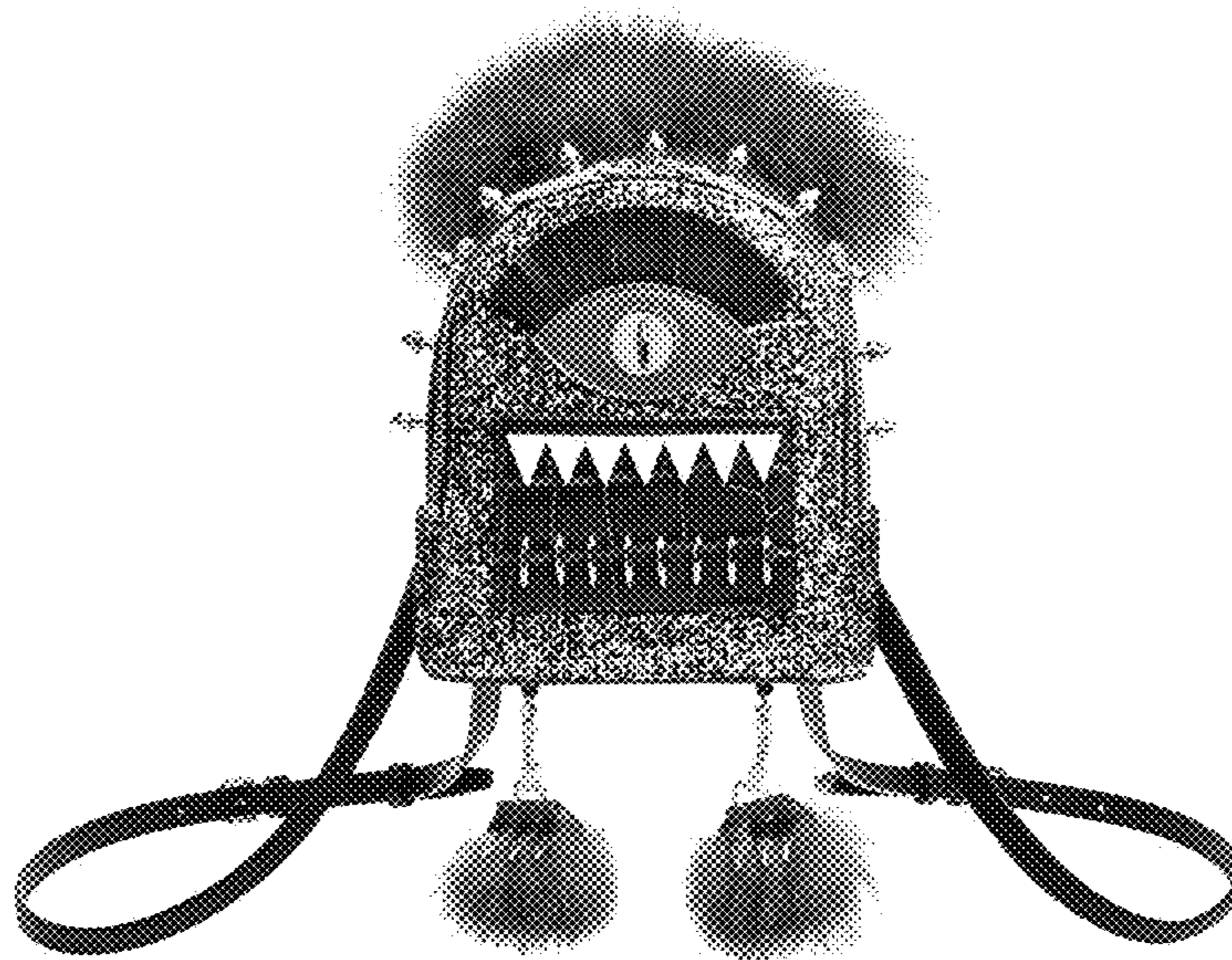

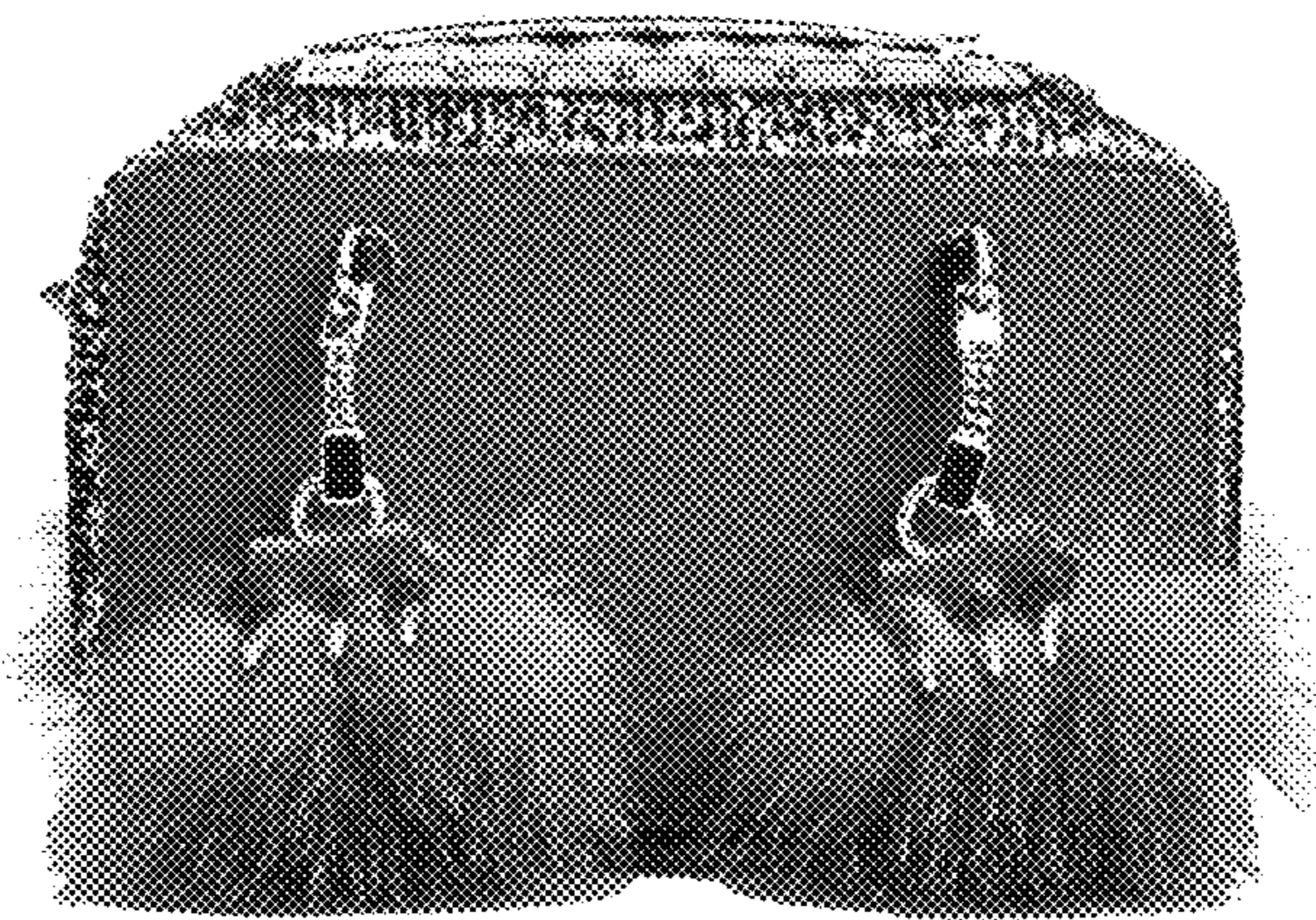
