I claim the ornamental design for toothbrush head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a toothbrush head;
FIG. 2 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;

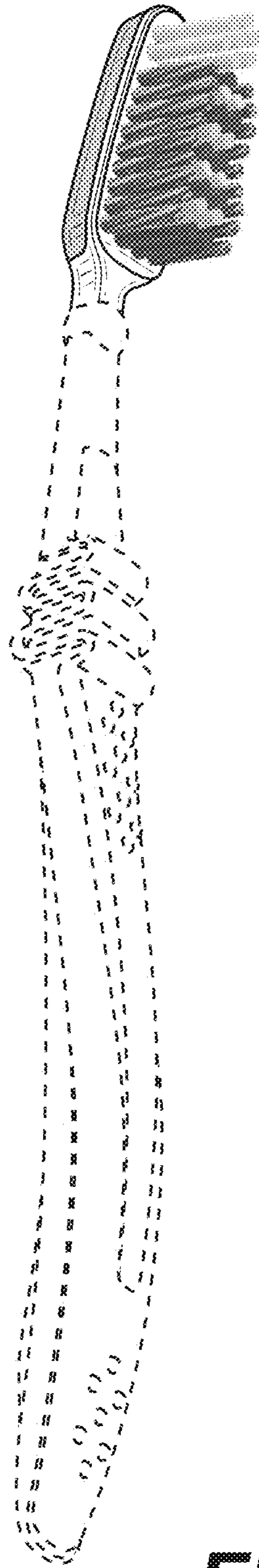

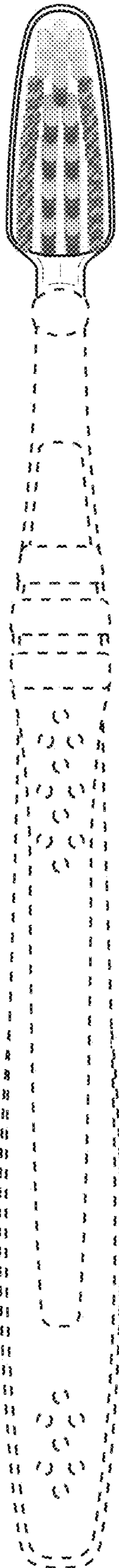

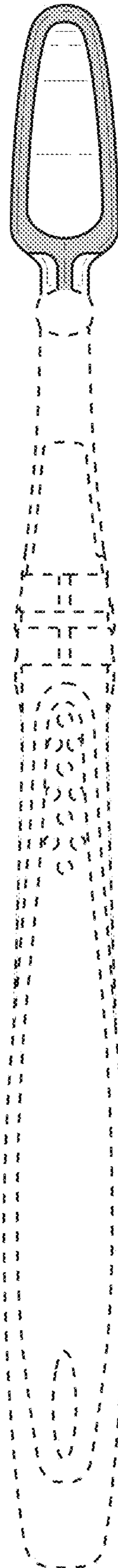

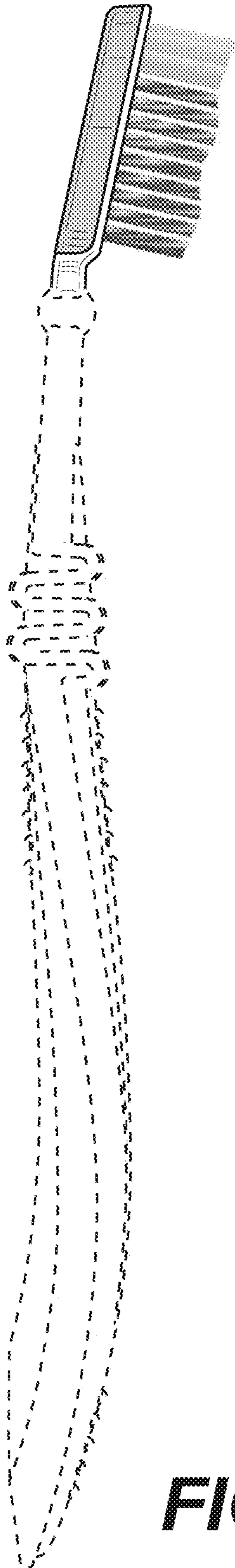

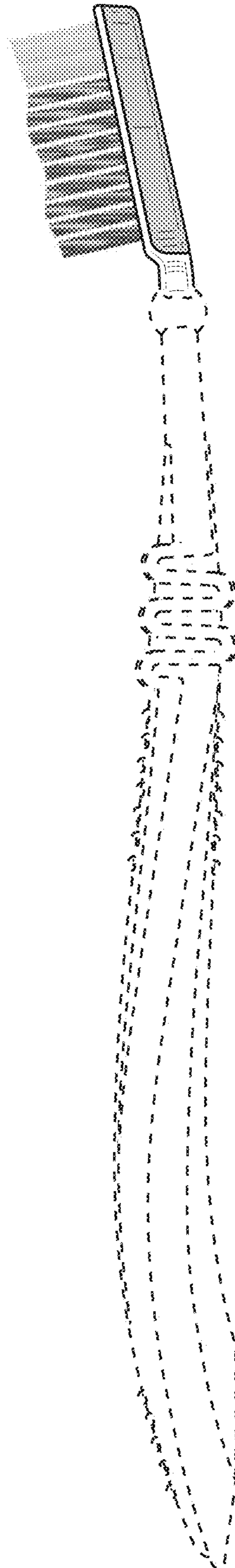

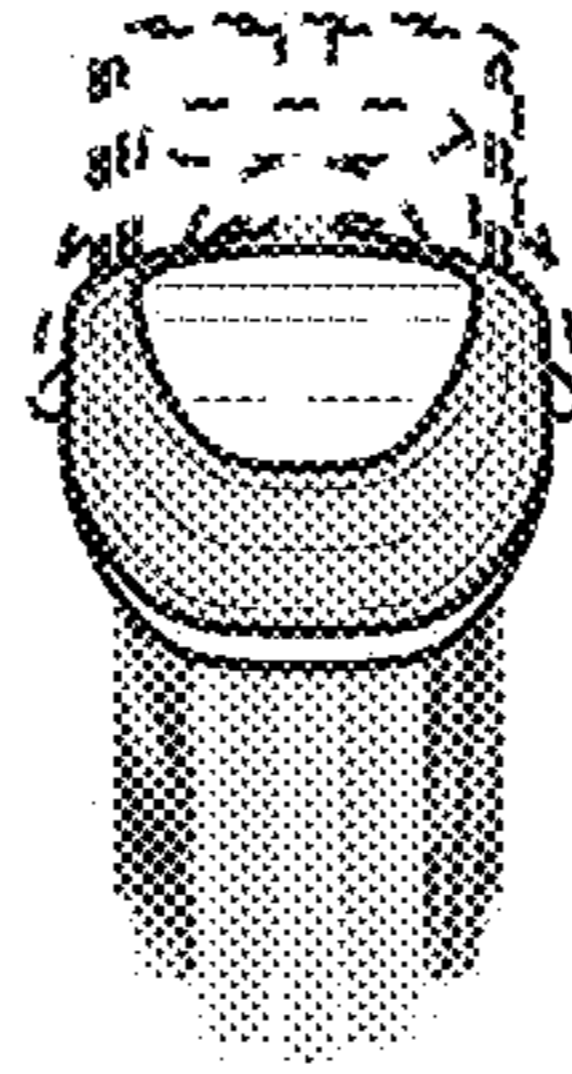

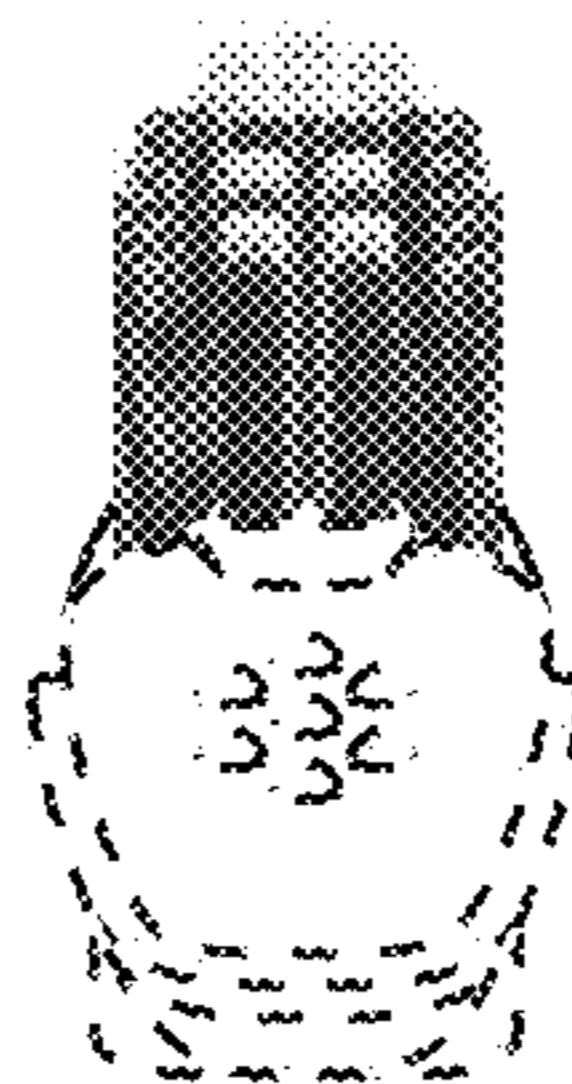
