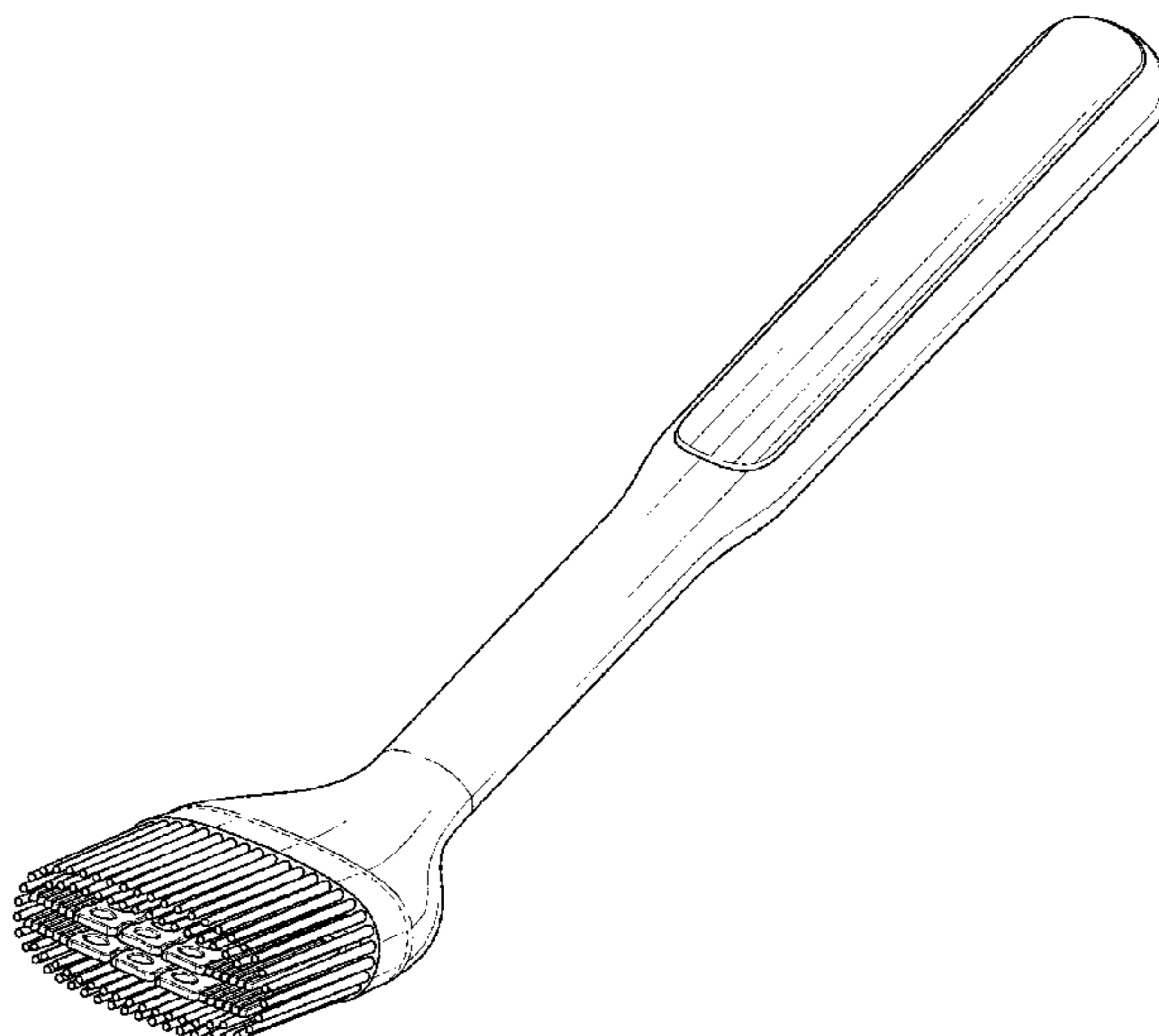
(57) **CLAIM**

The ornamental design for a basting brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a basting brush;
FIG. 2 is a front elevation view of the design shown in FIG. 1;
FIG. 3 is a rear elevation view of the design shown in FIG. 1;
FIG. 4 is a left side elevation view of the design shown in FIG. 1;
FIG. 5 is a right side elevation view of the design shown in FIG. 1;
FIG. 6 is a top plan view of the design shown in FIG. 1; and,
FIG. 7 is a bottom plan view of the design shown in FIG. 1.
The broken lines in the drawings depict portions of the basting brush that form no part of the claimed design.

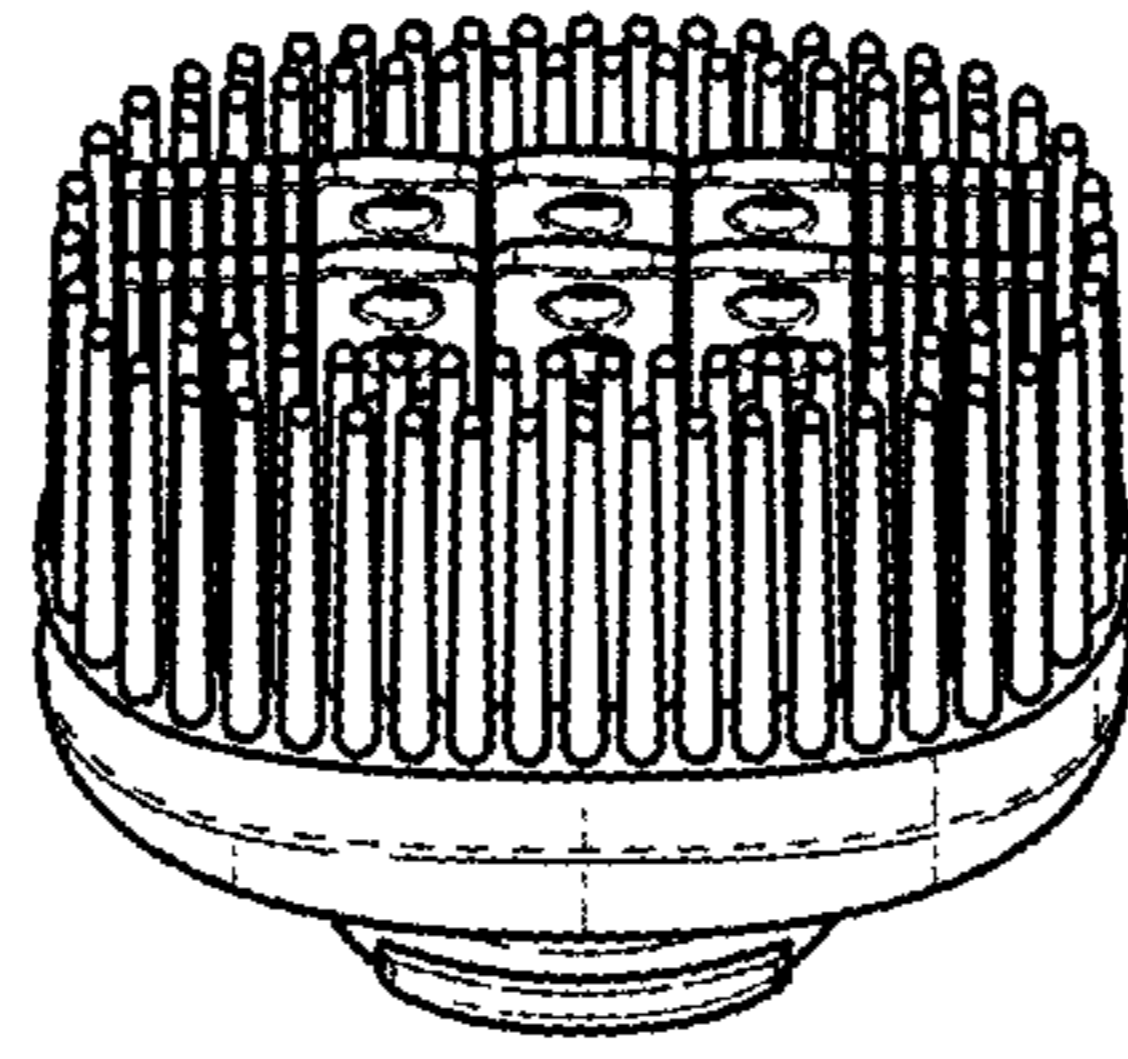

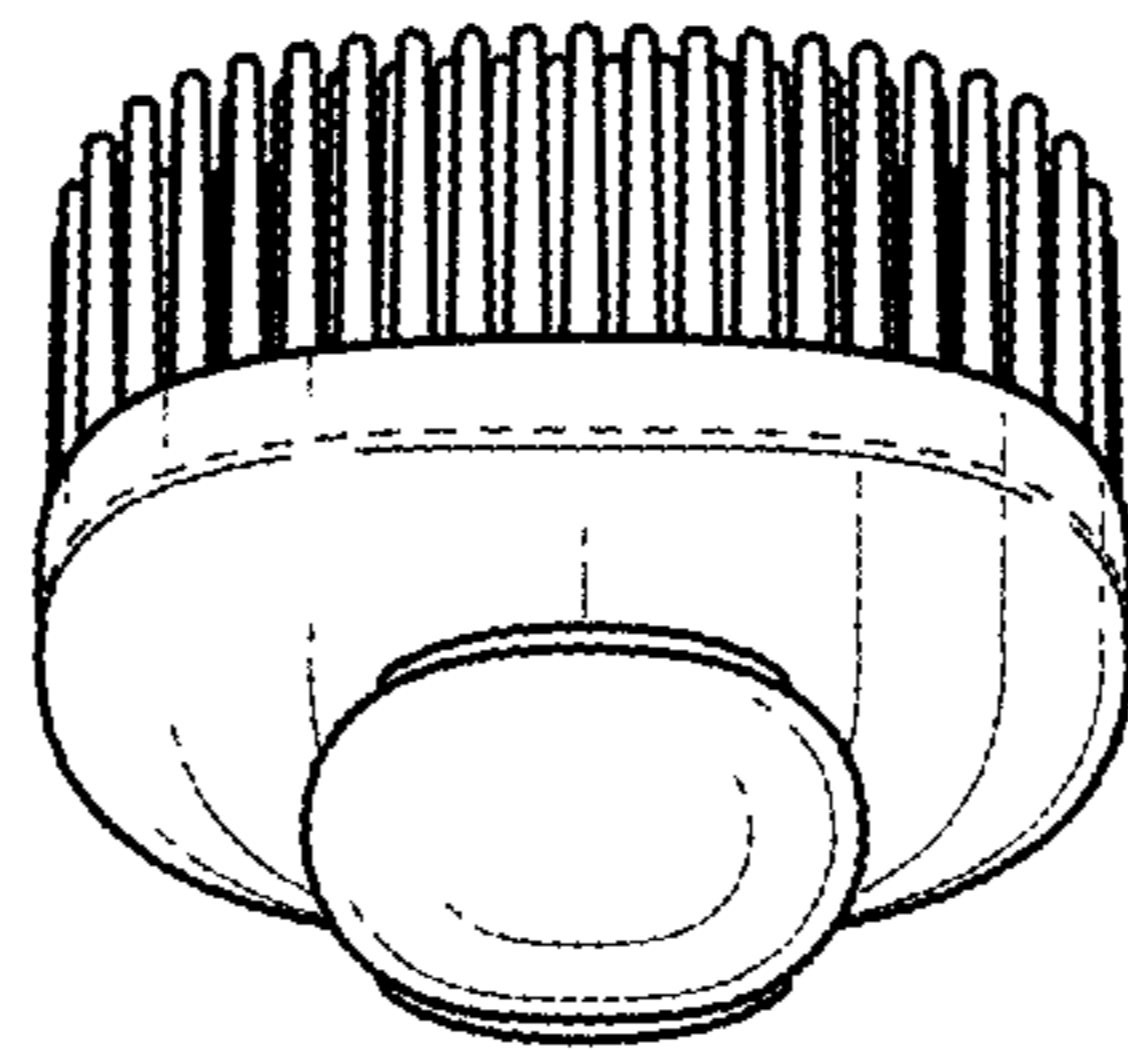

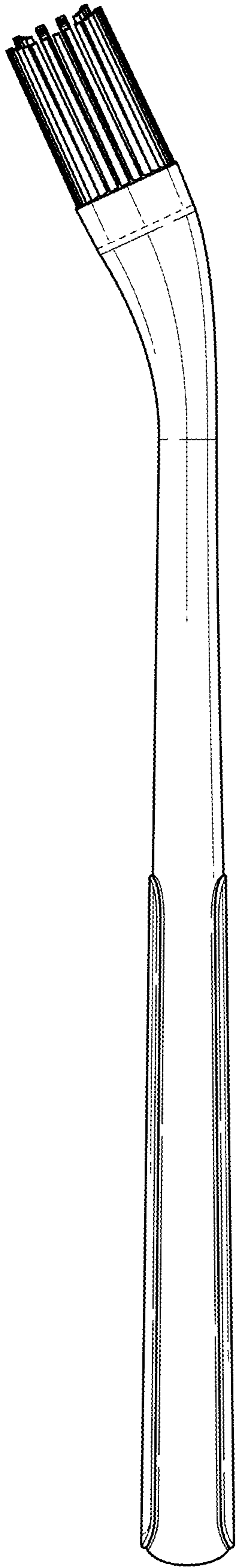

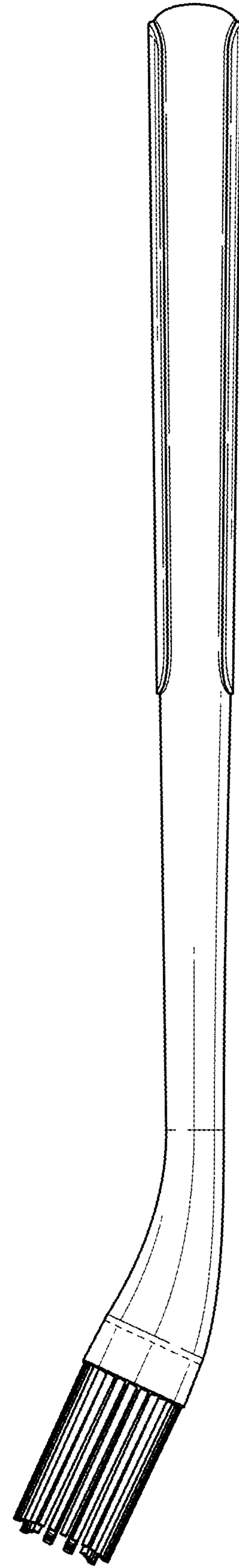

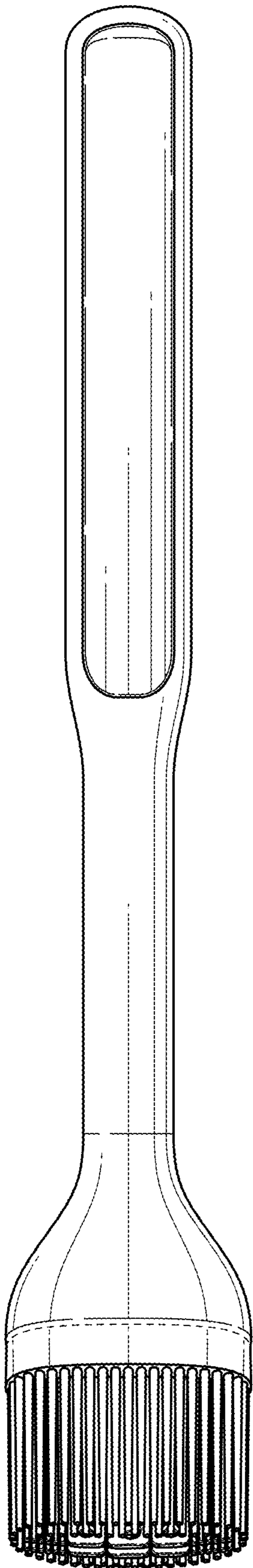

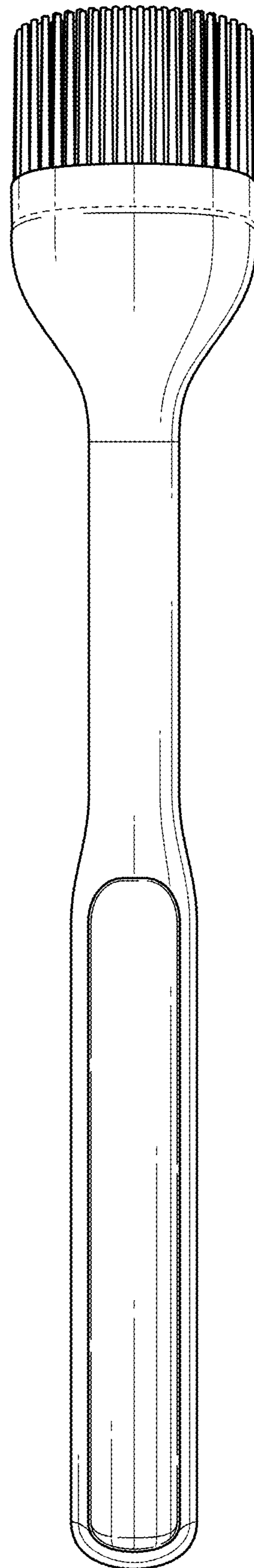
