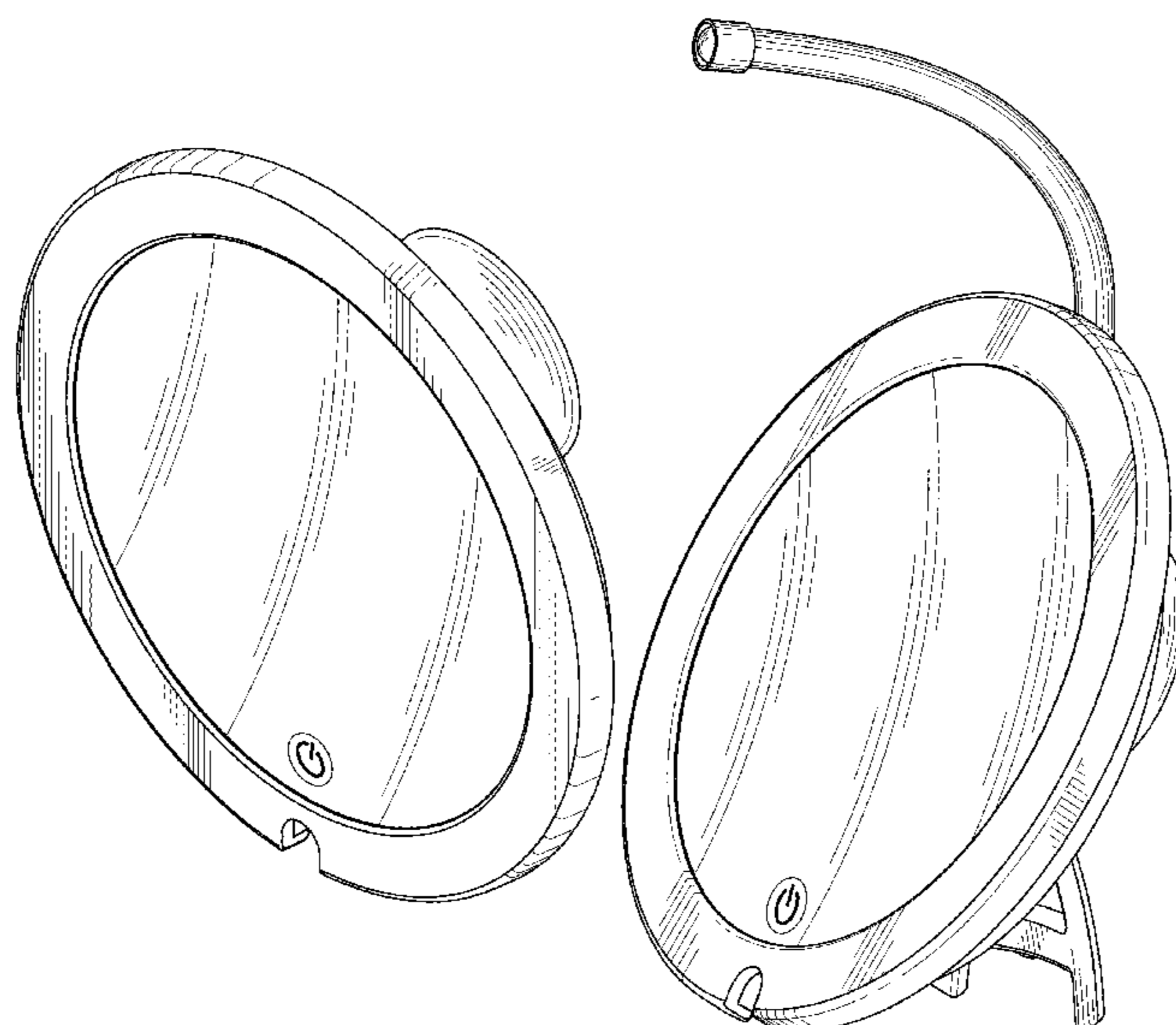
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of an embodiment of a new design showing a mirror apparatus according to the present invention;

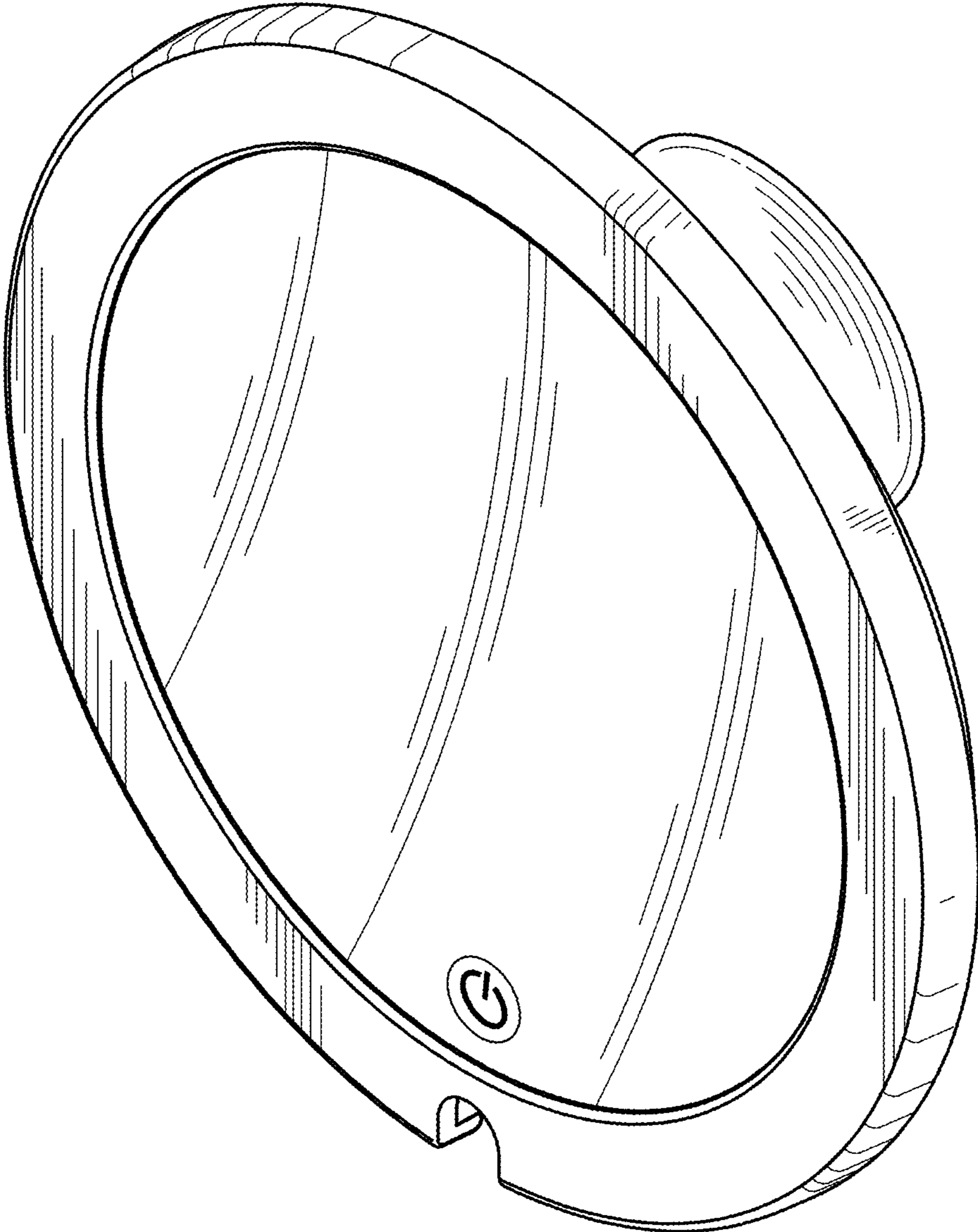

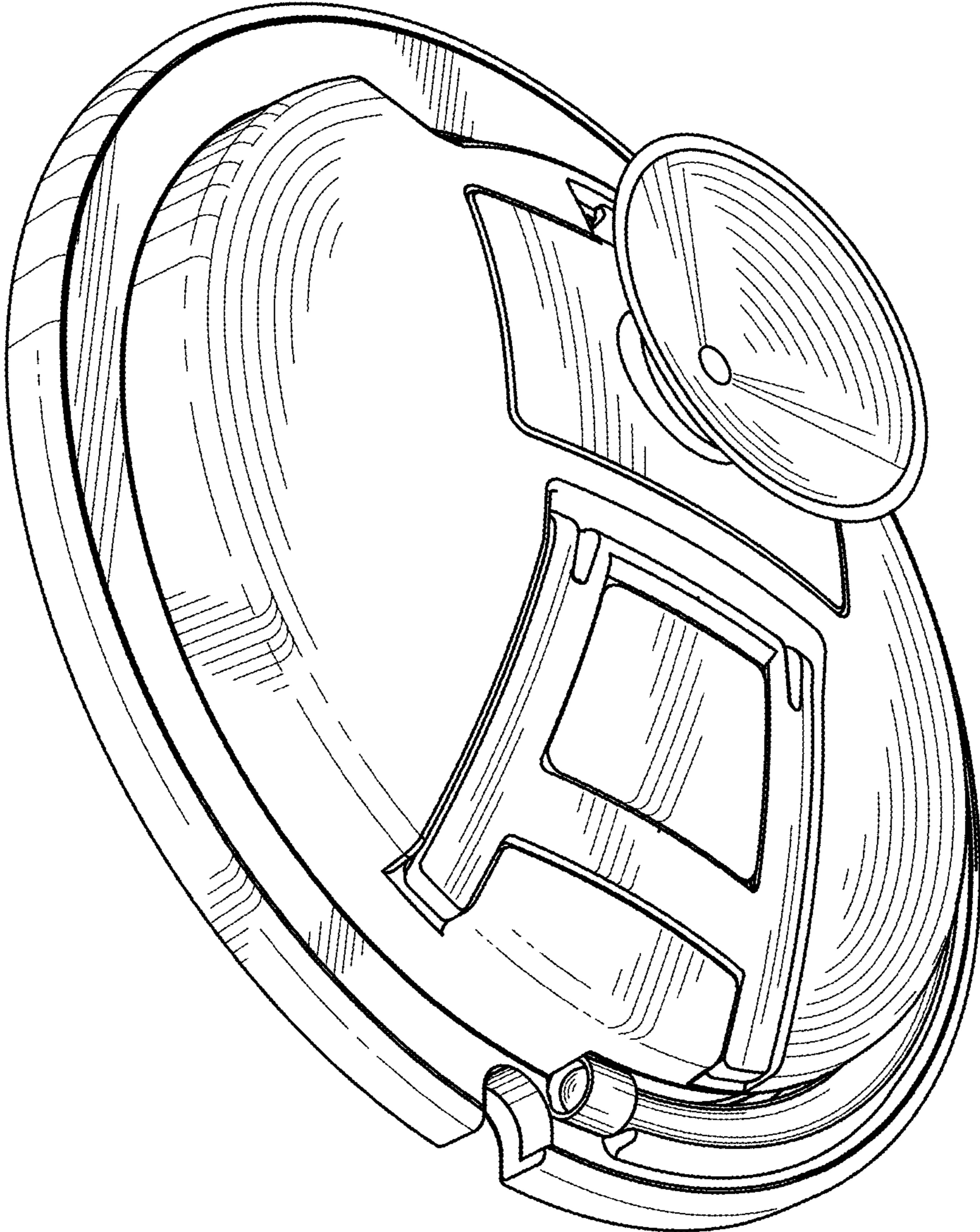

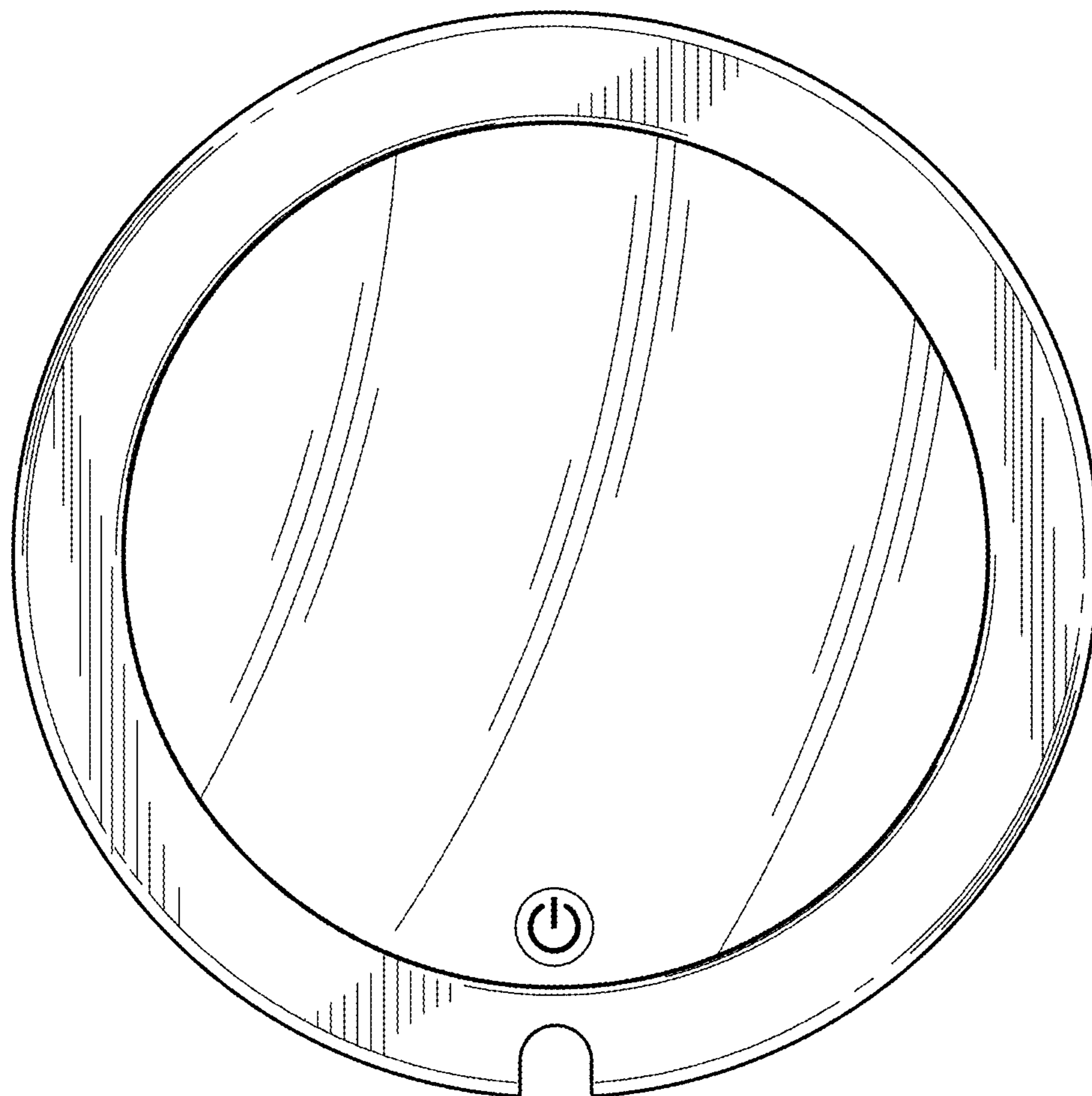

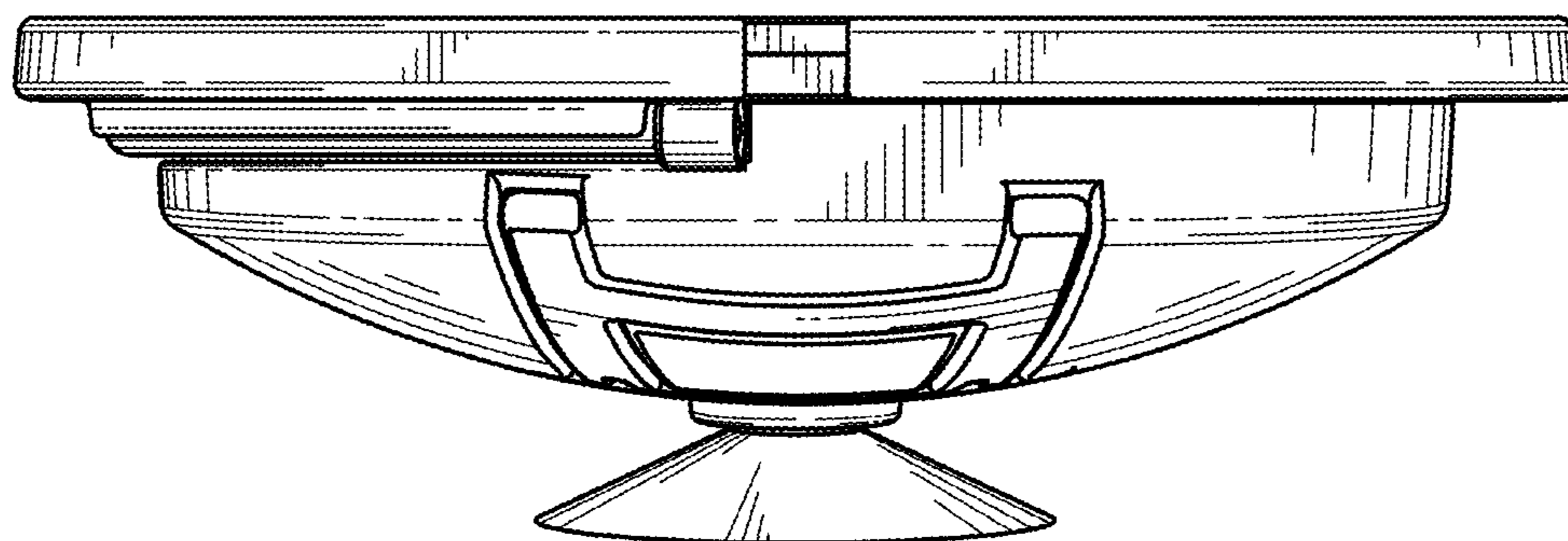

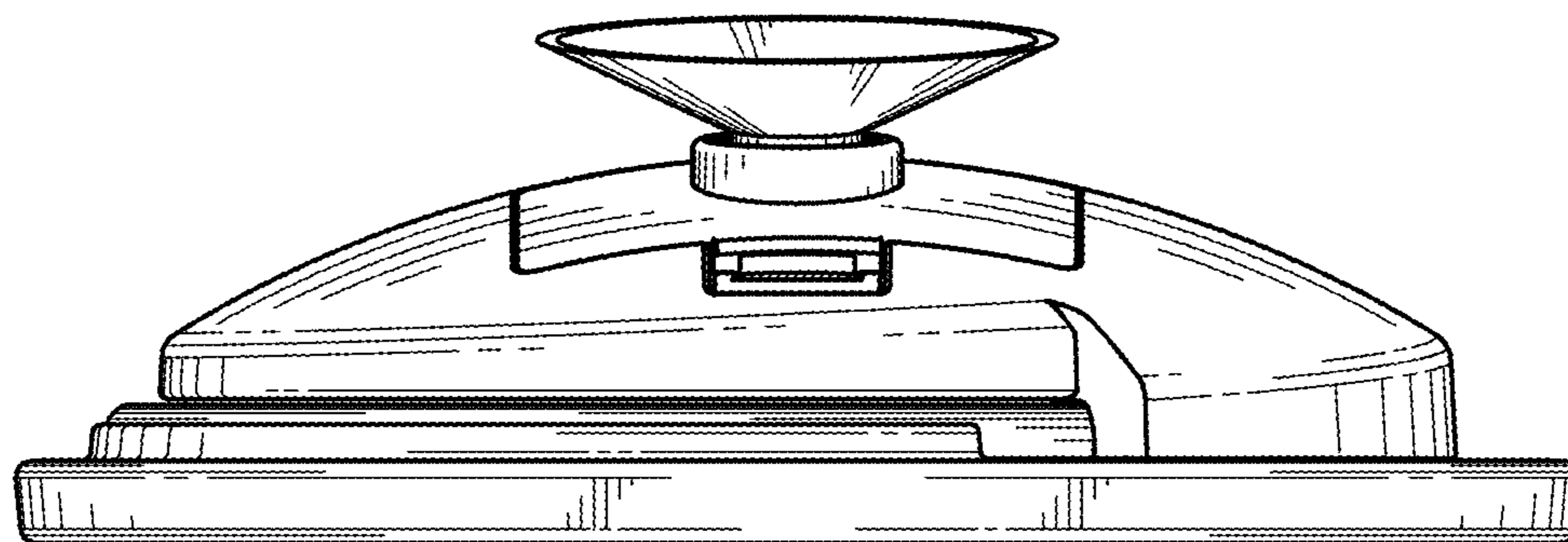

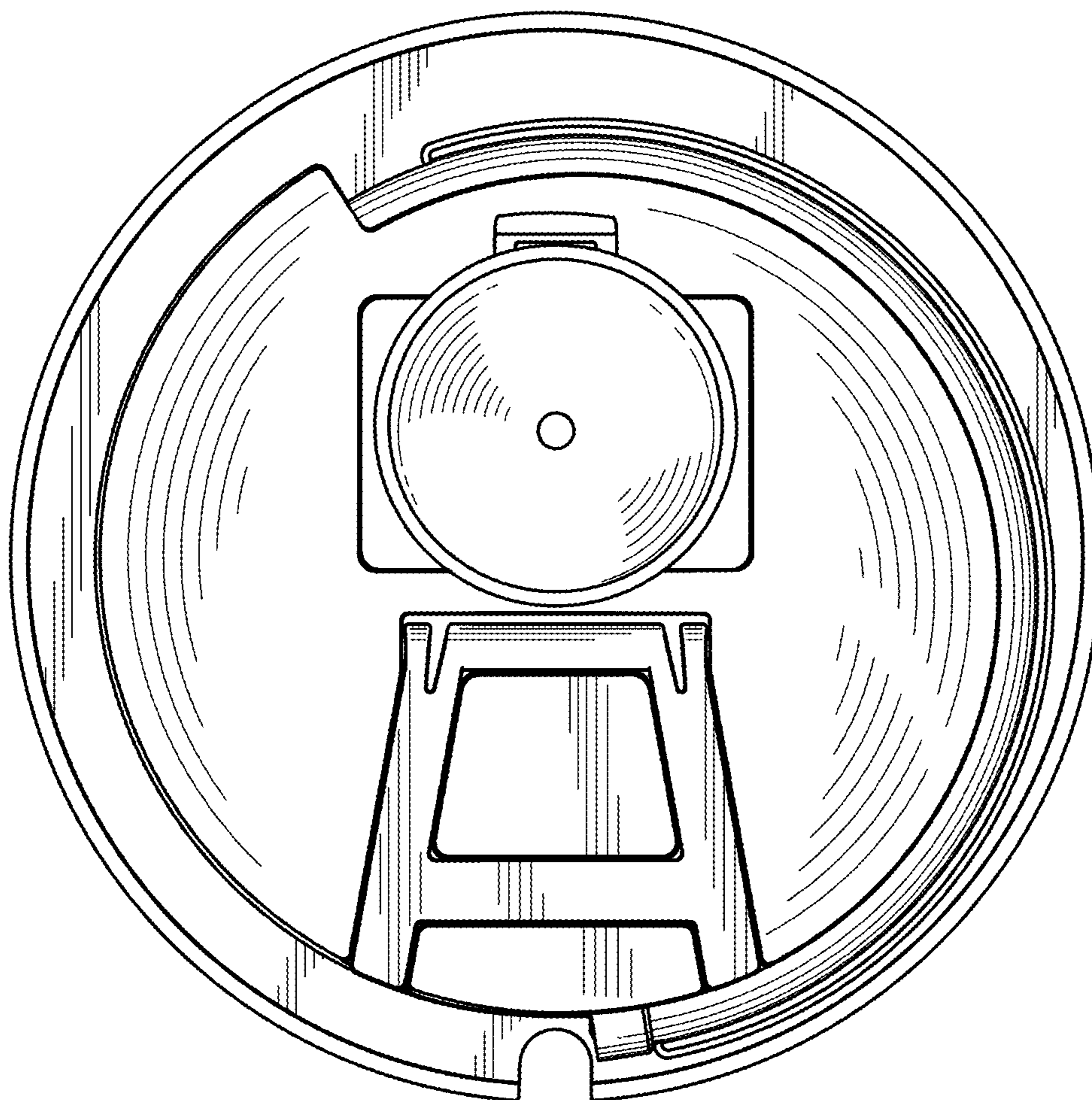

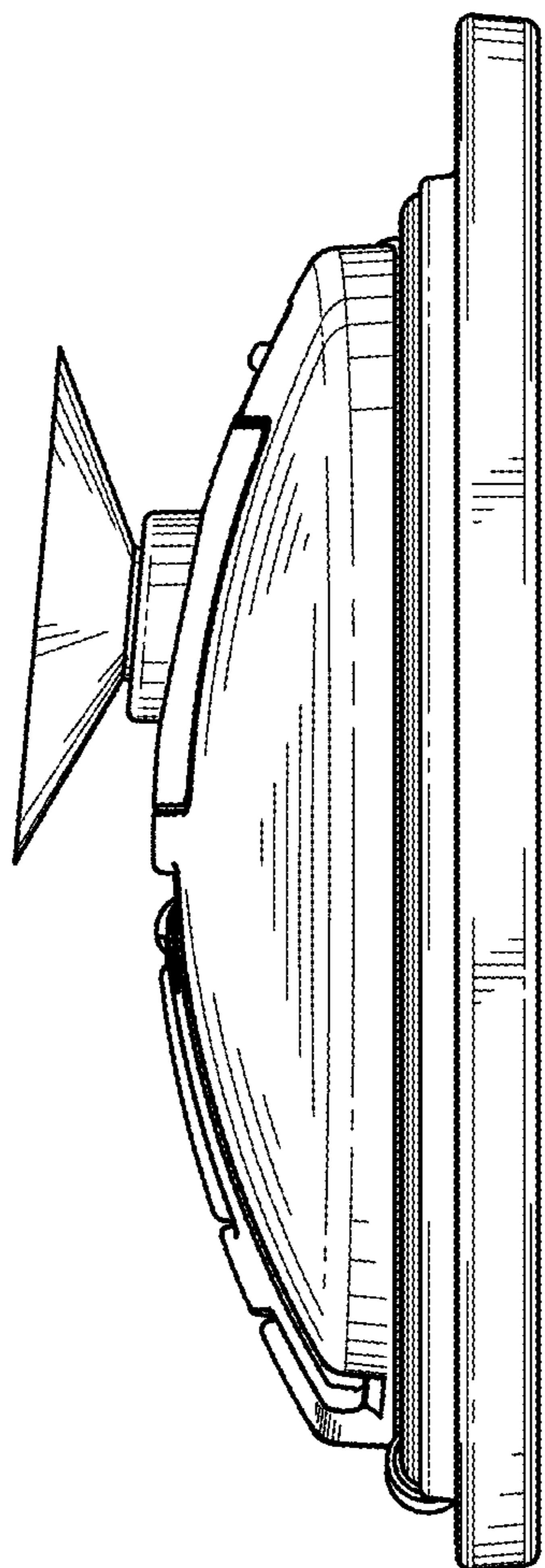

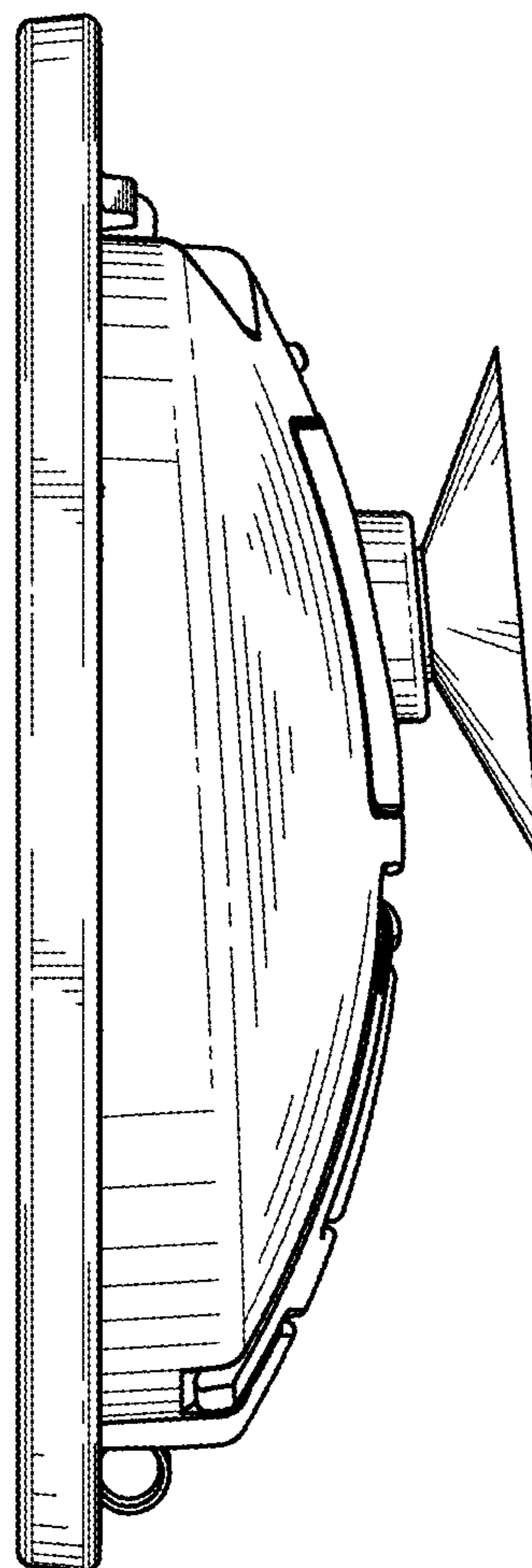

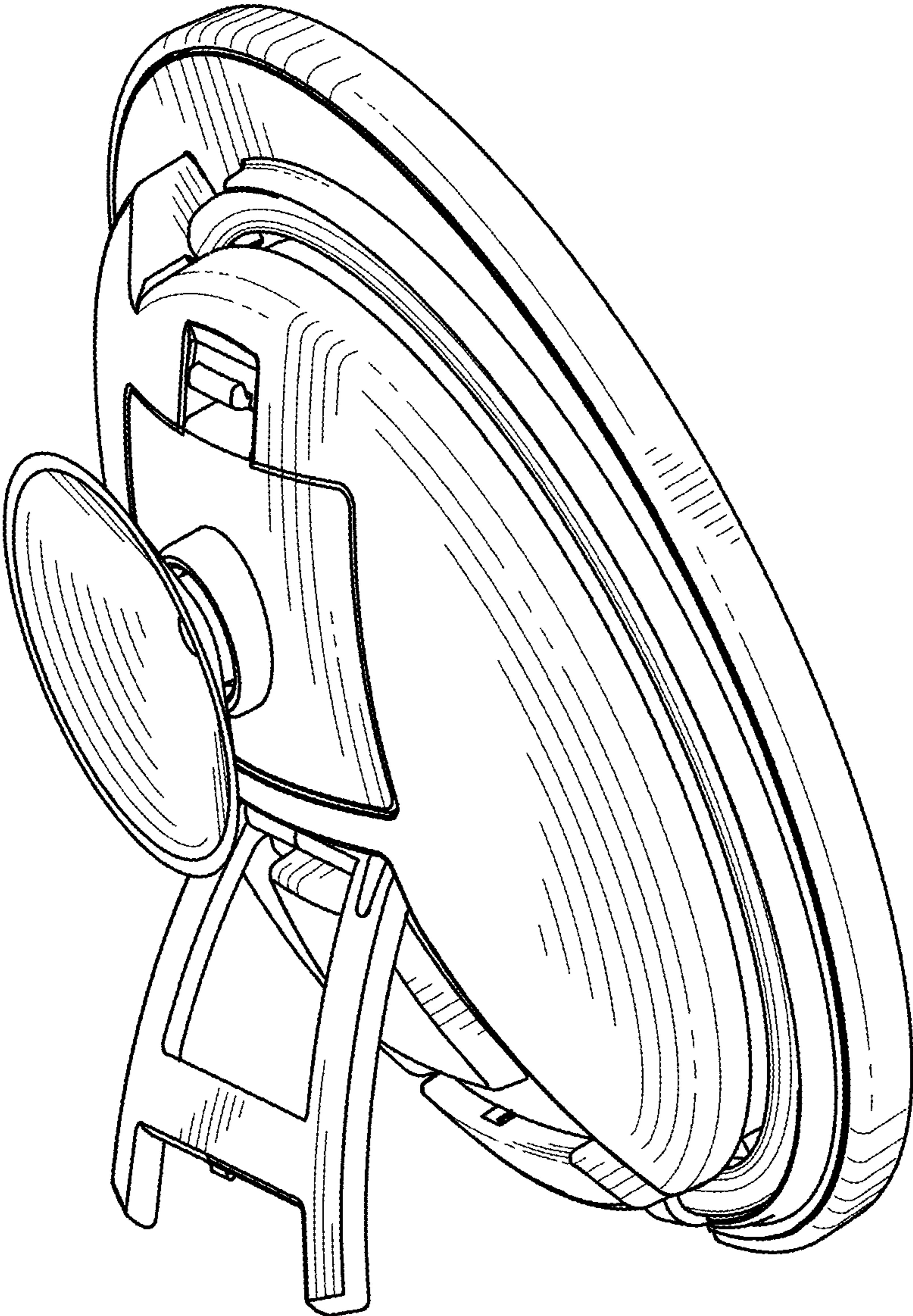

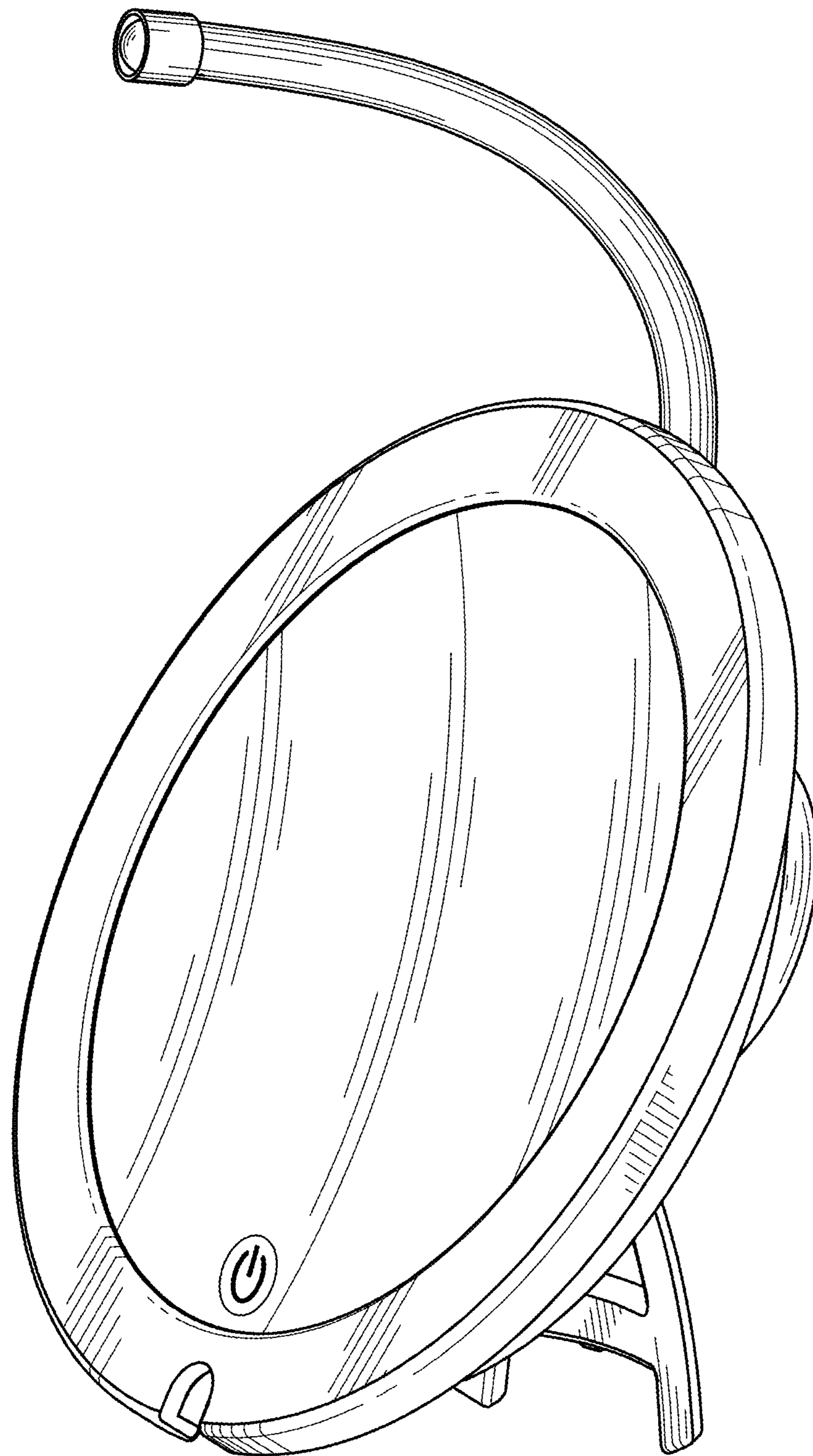
