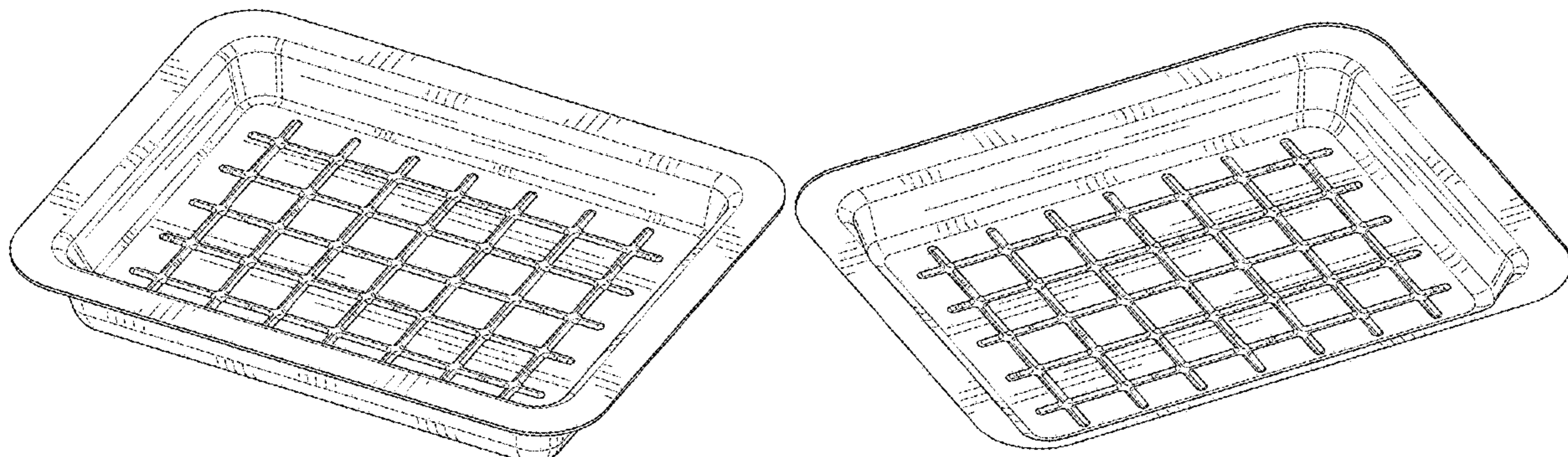


FIG. 5 is a right side view of the baking tray of FIG. 1.

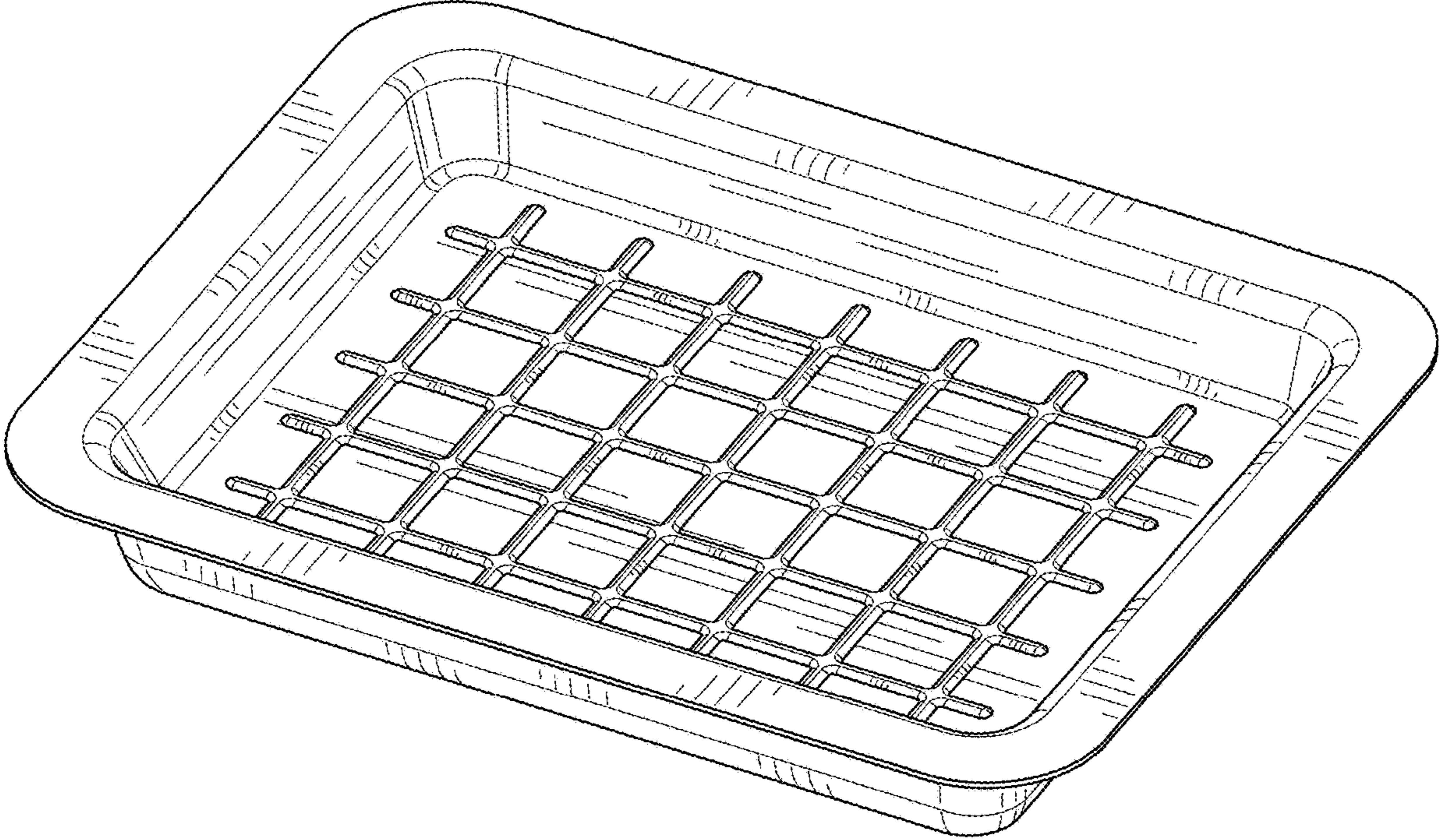

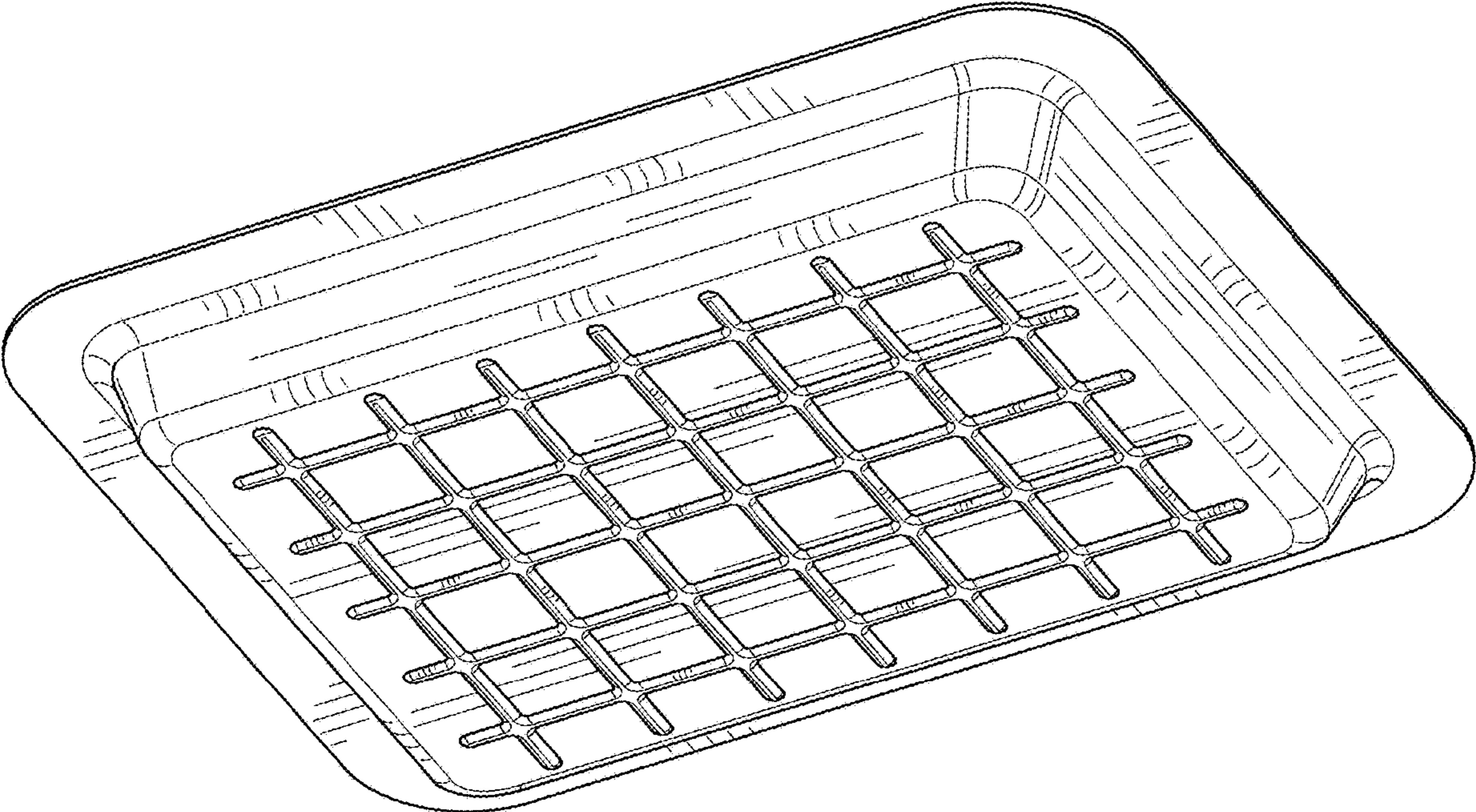

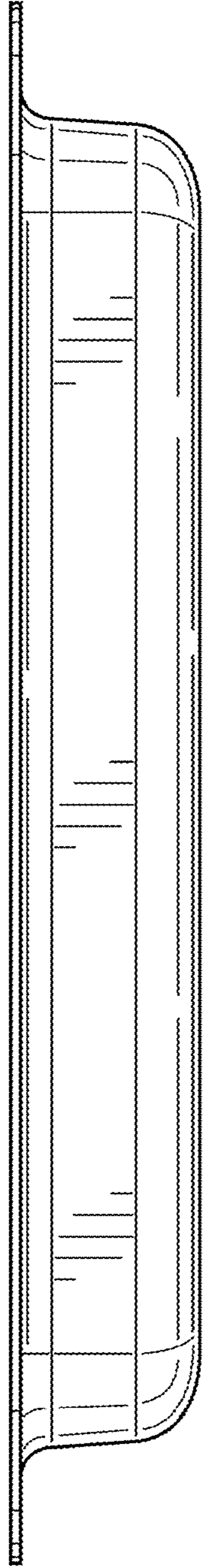

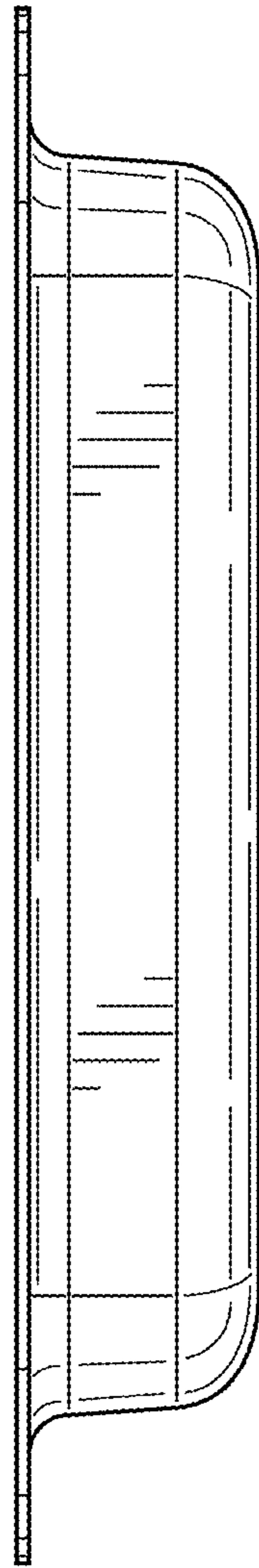

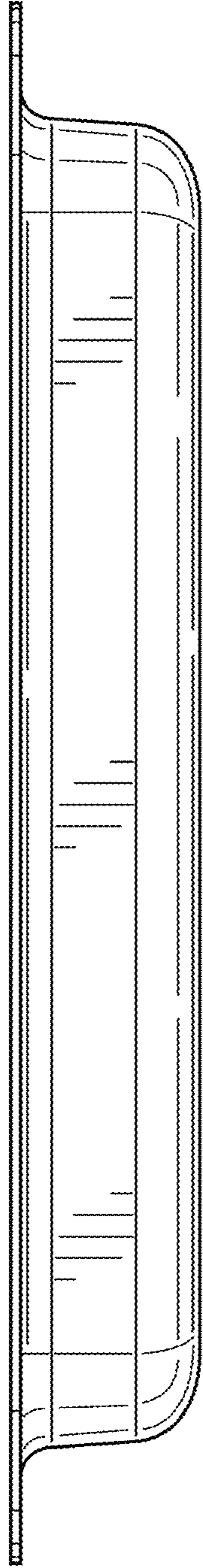

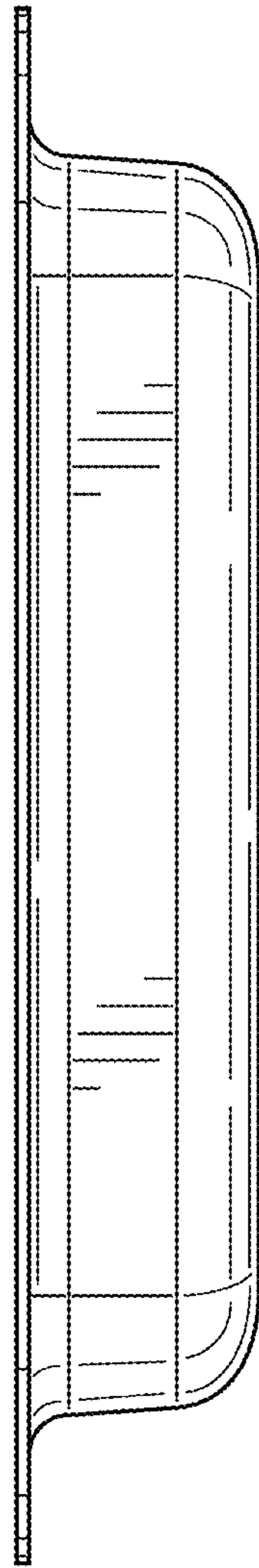

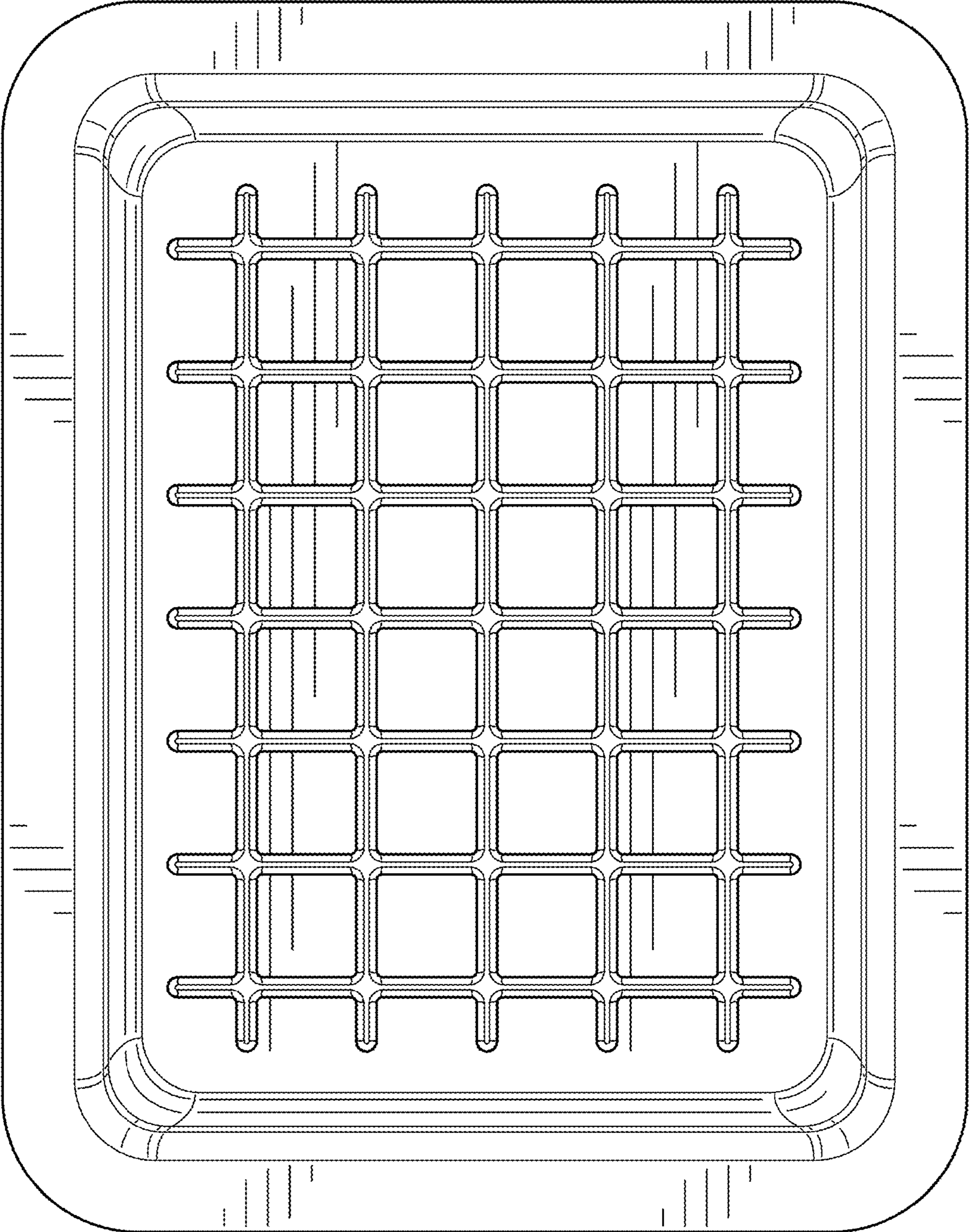

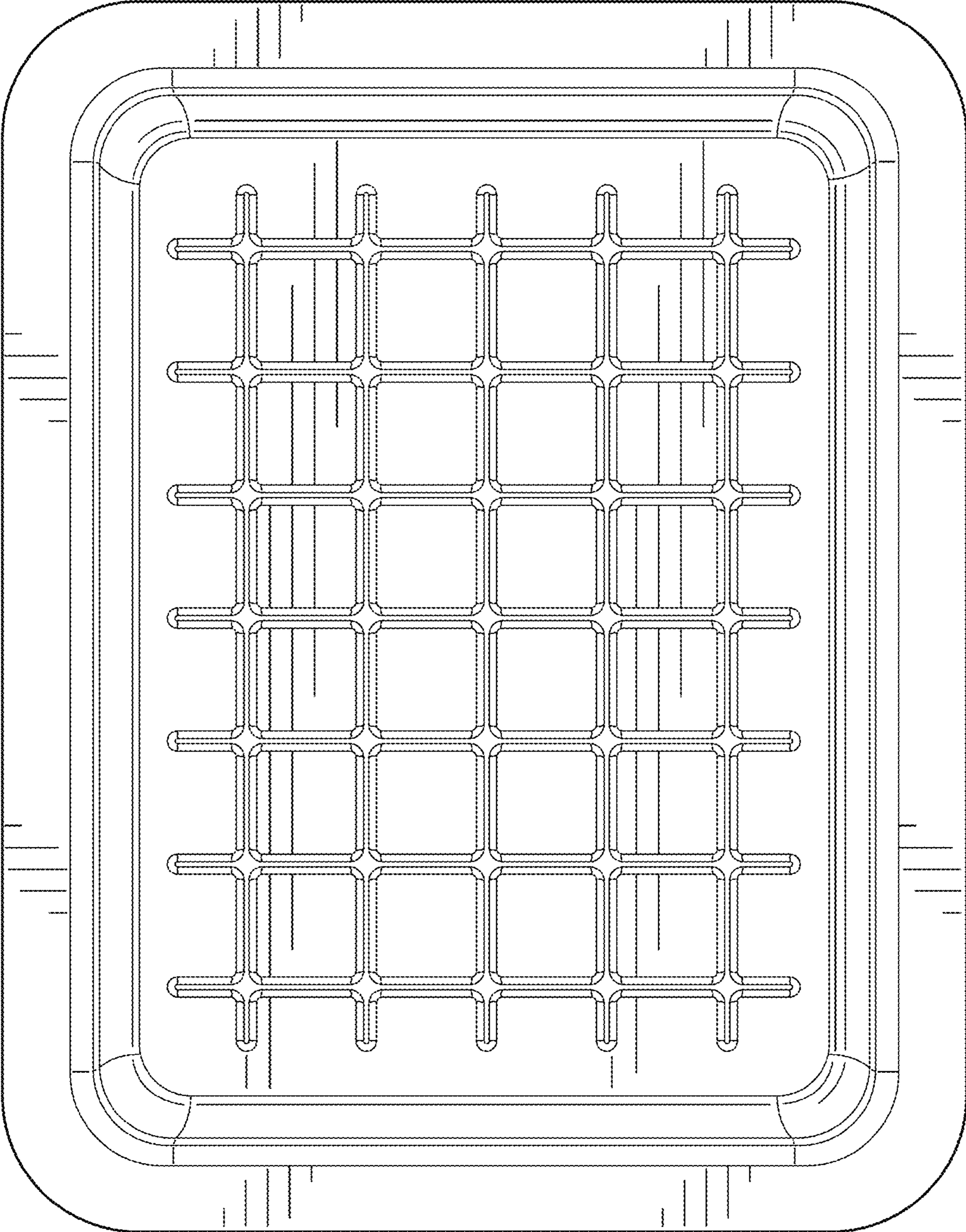
