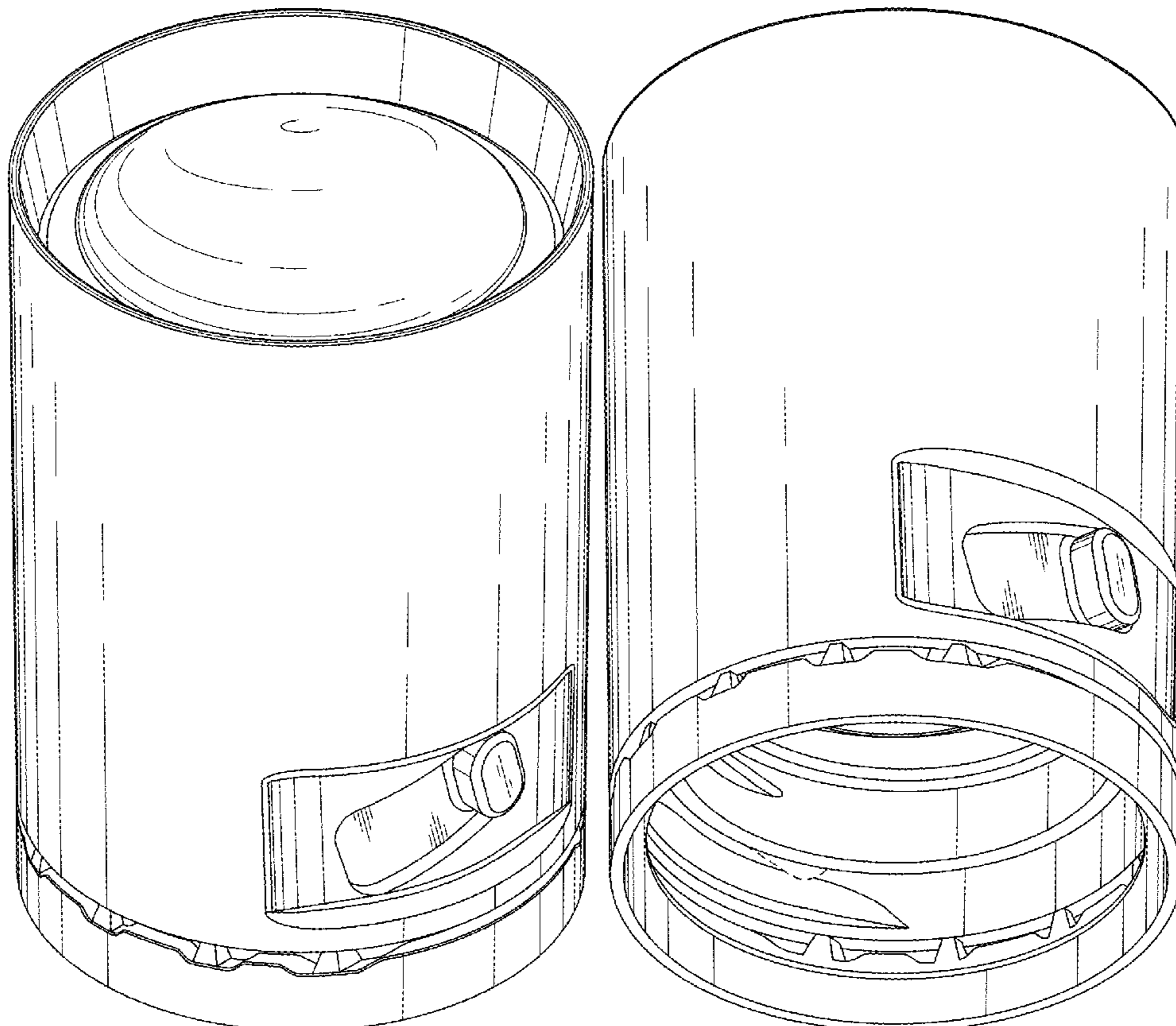
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front upper perspective view of a bottle closure with liquid dispenser, showing its new design;

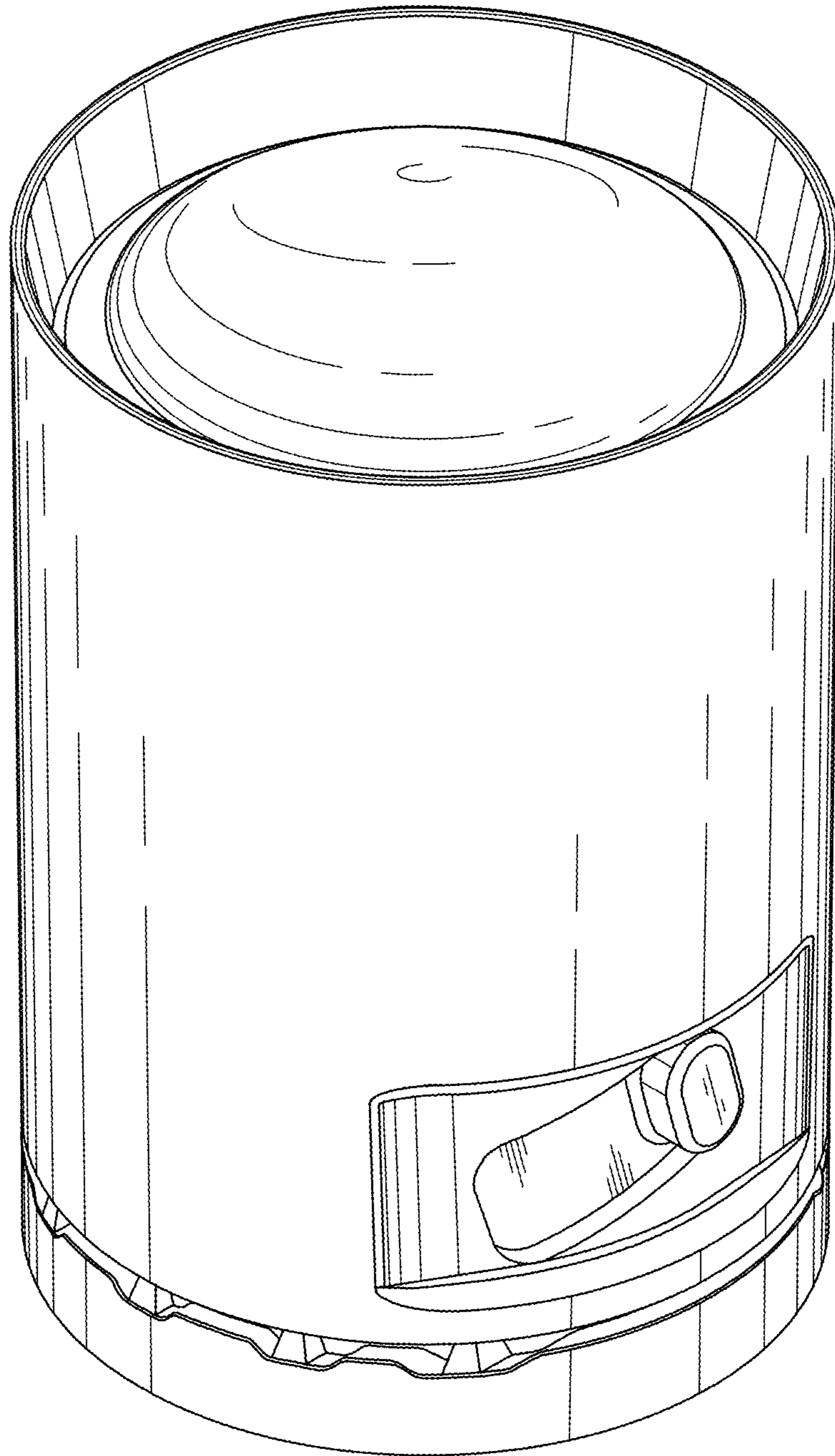

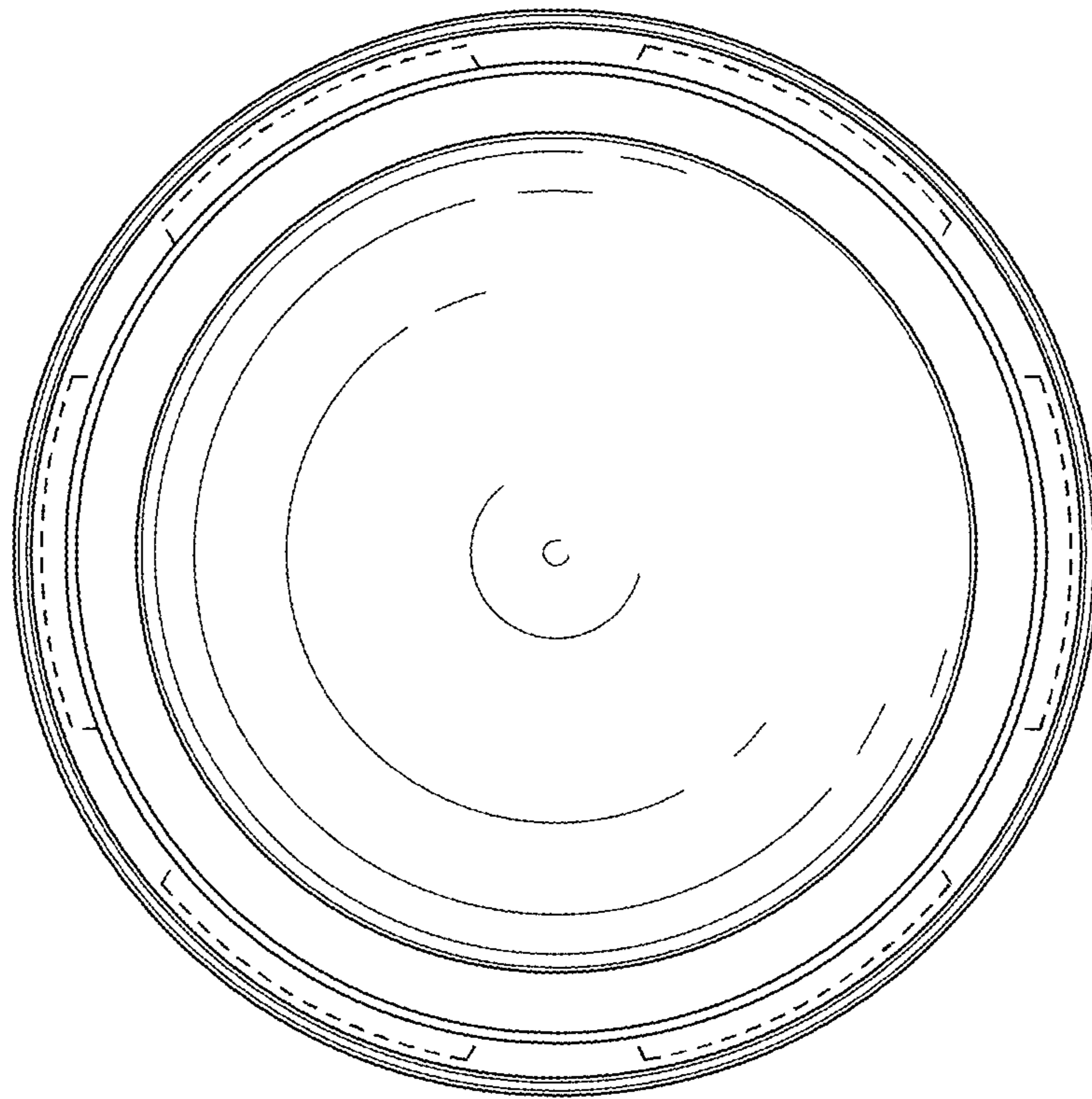

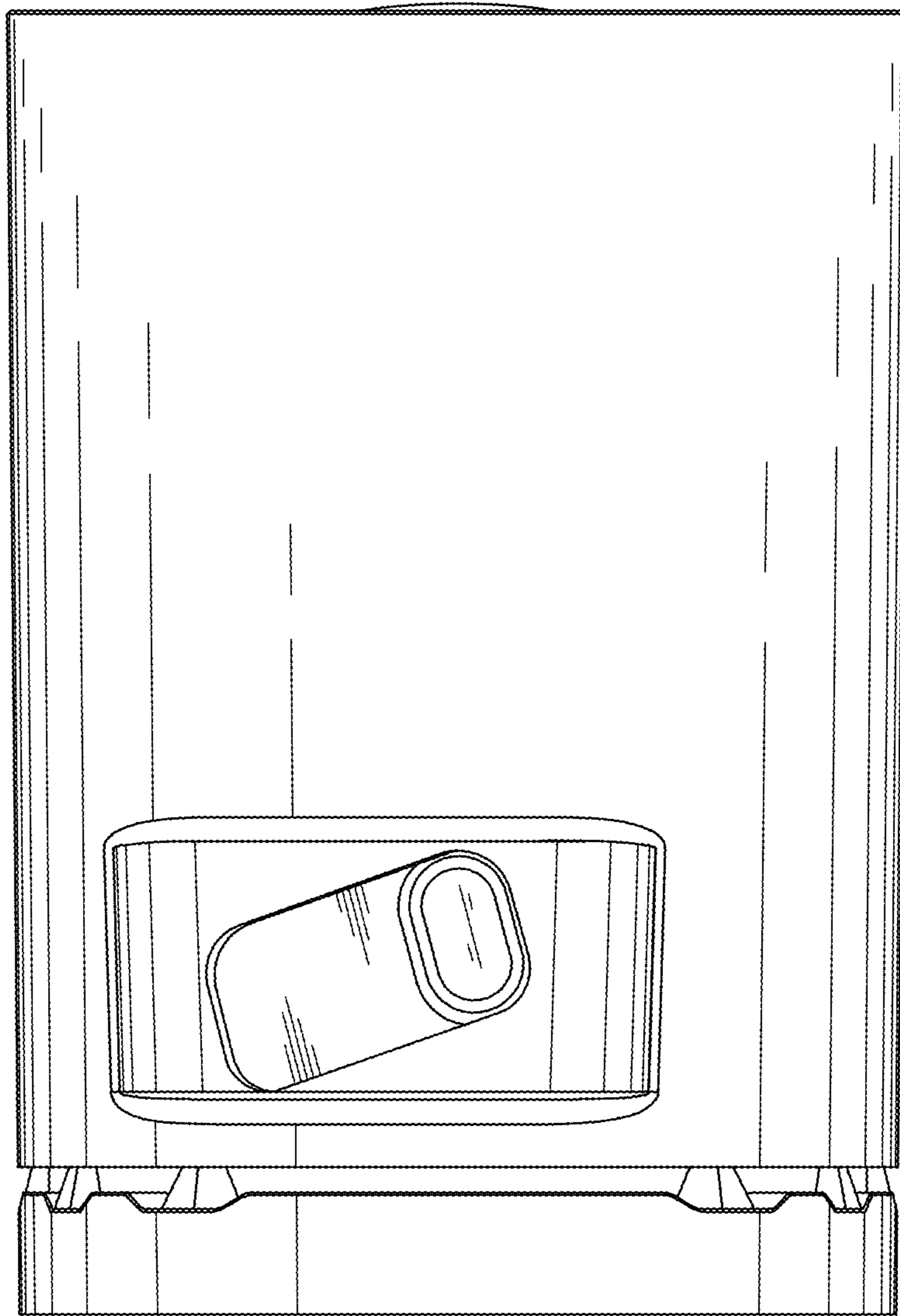

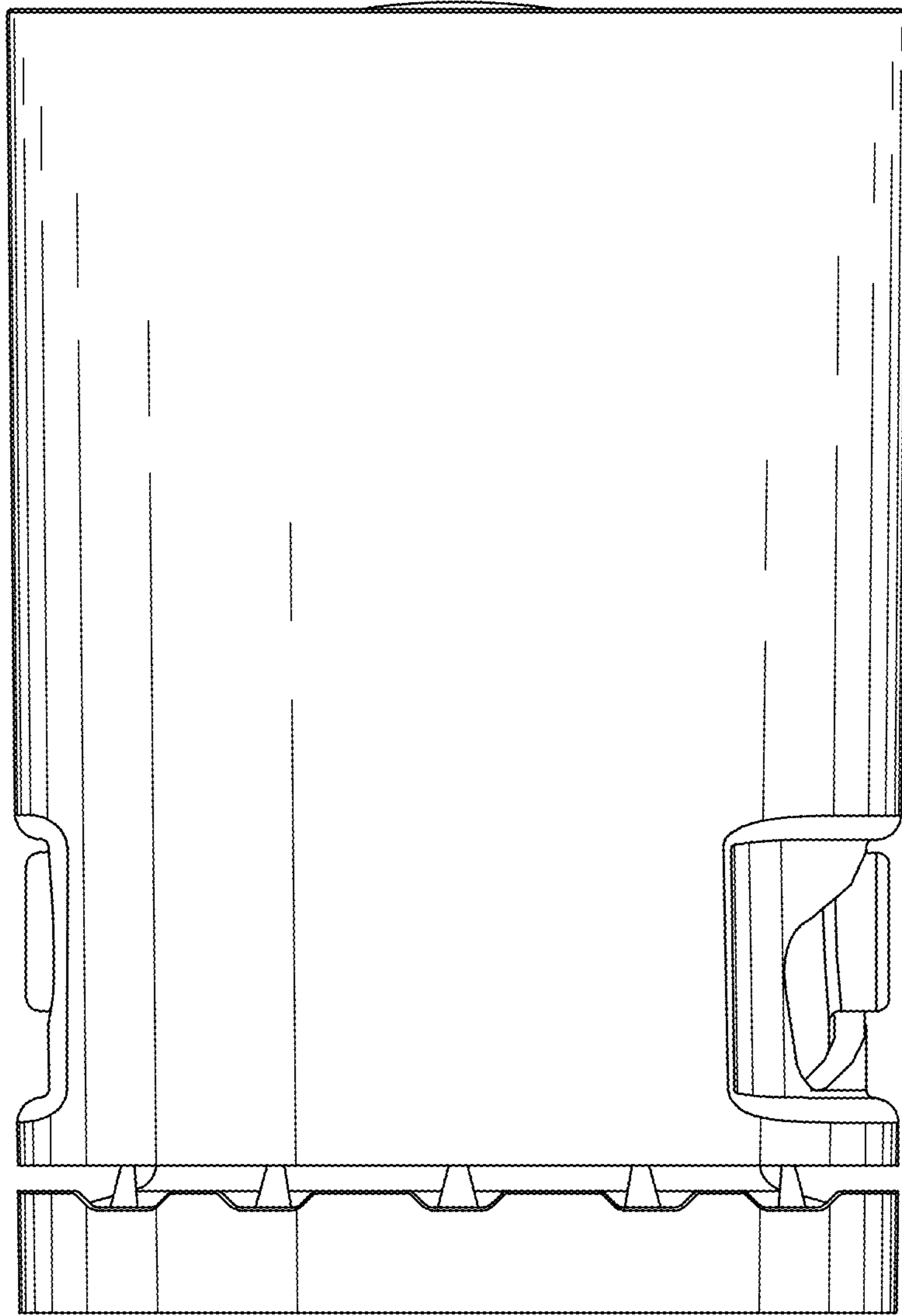

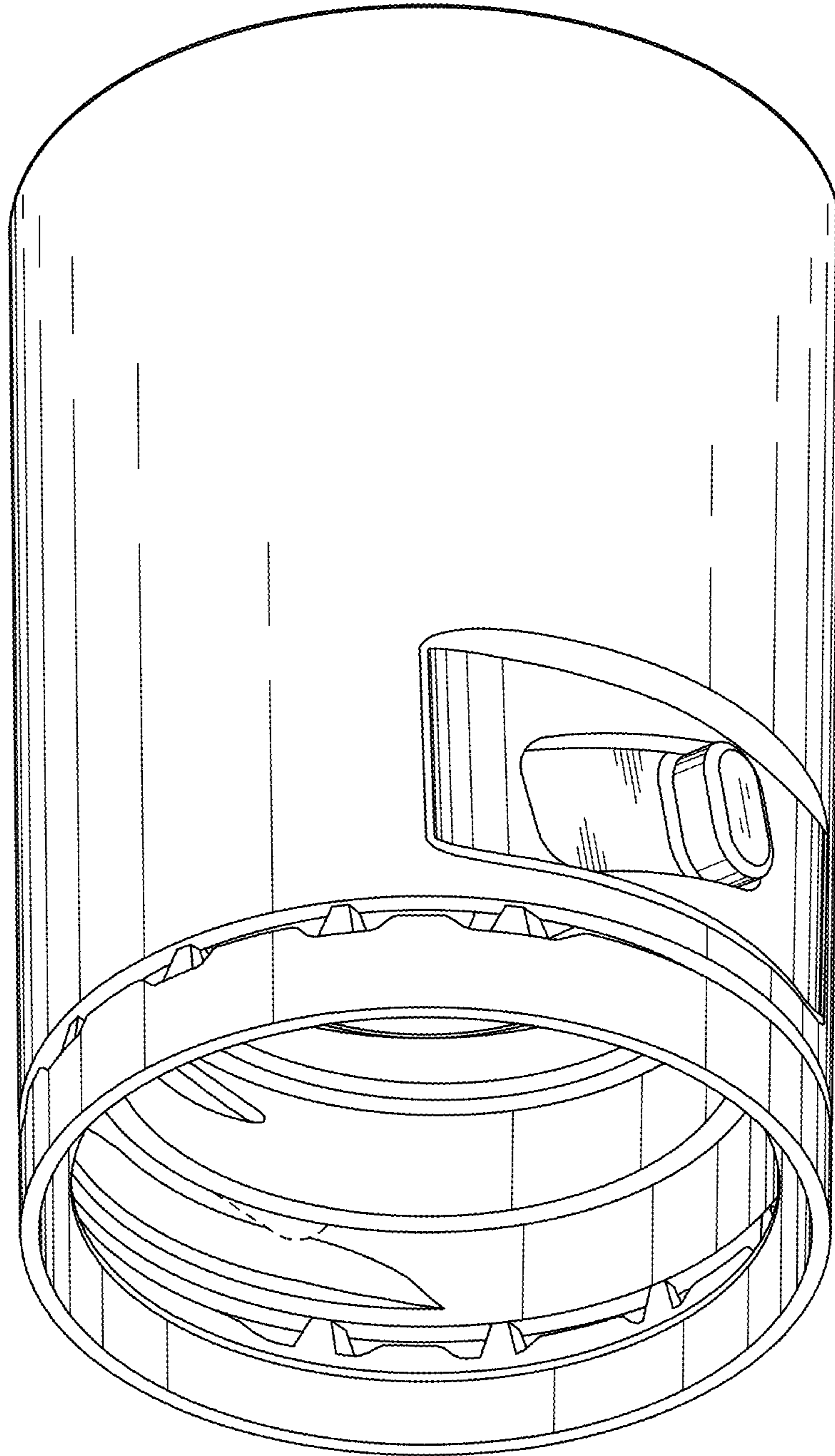

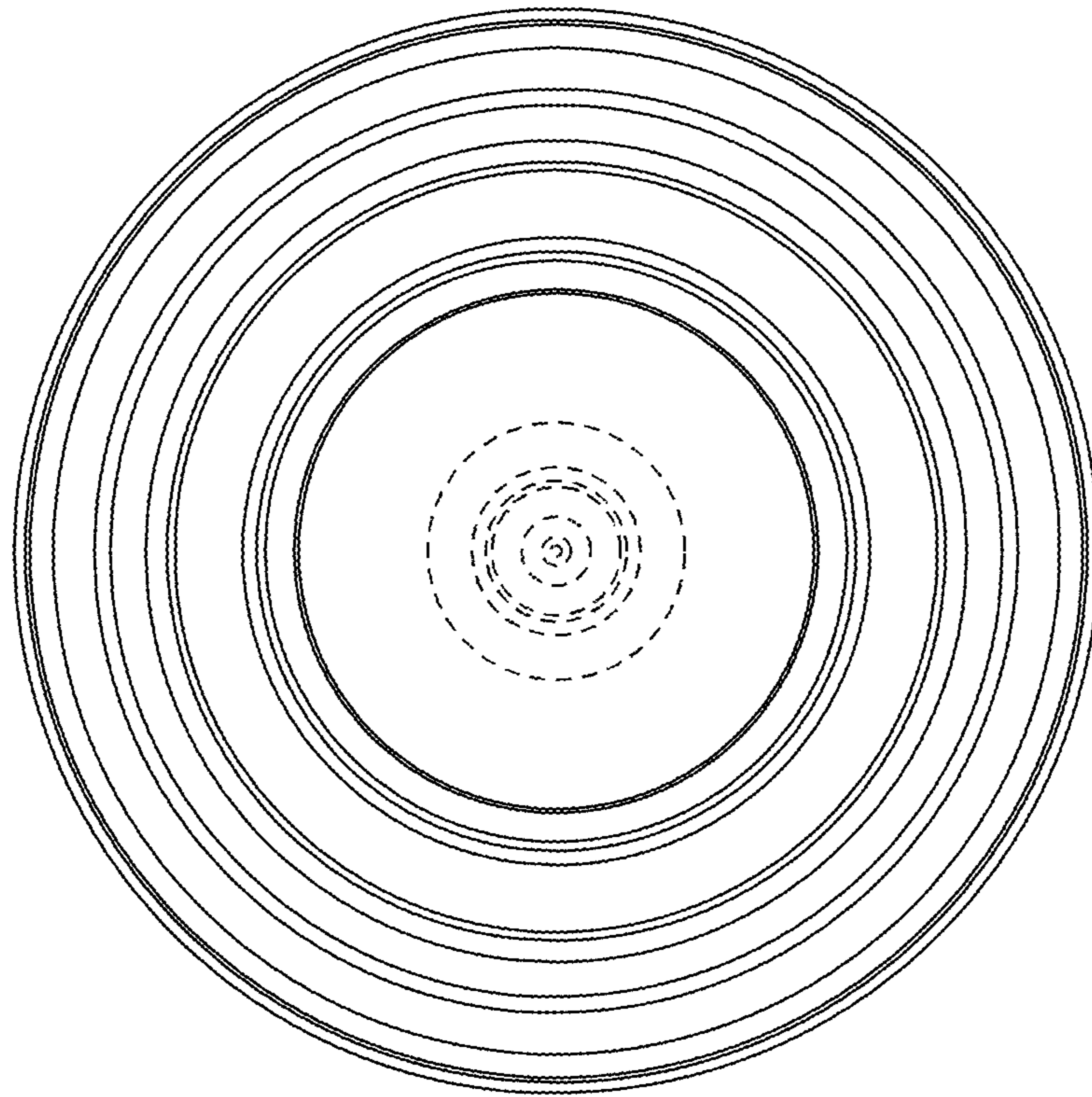
