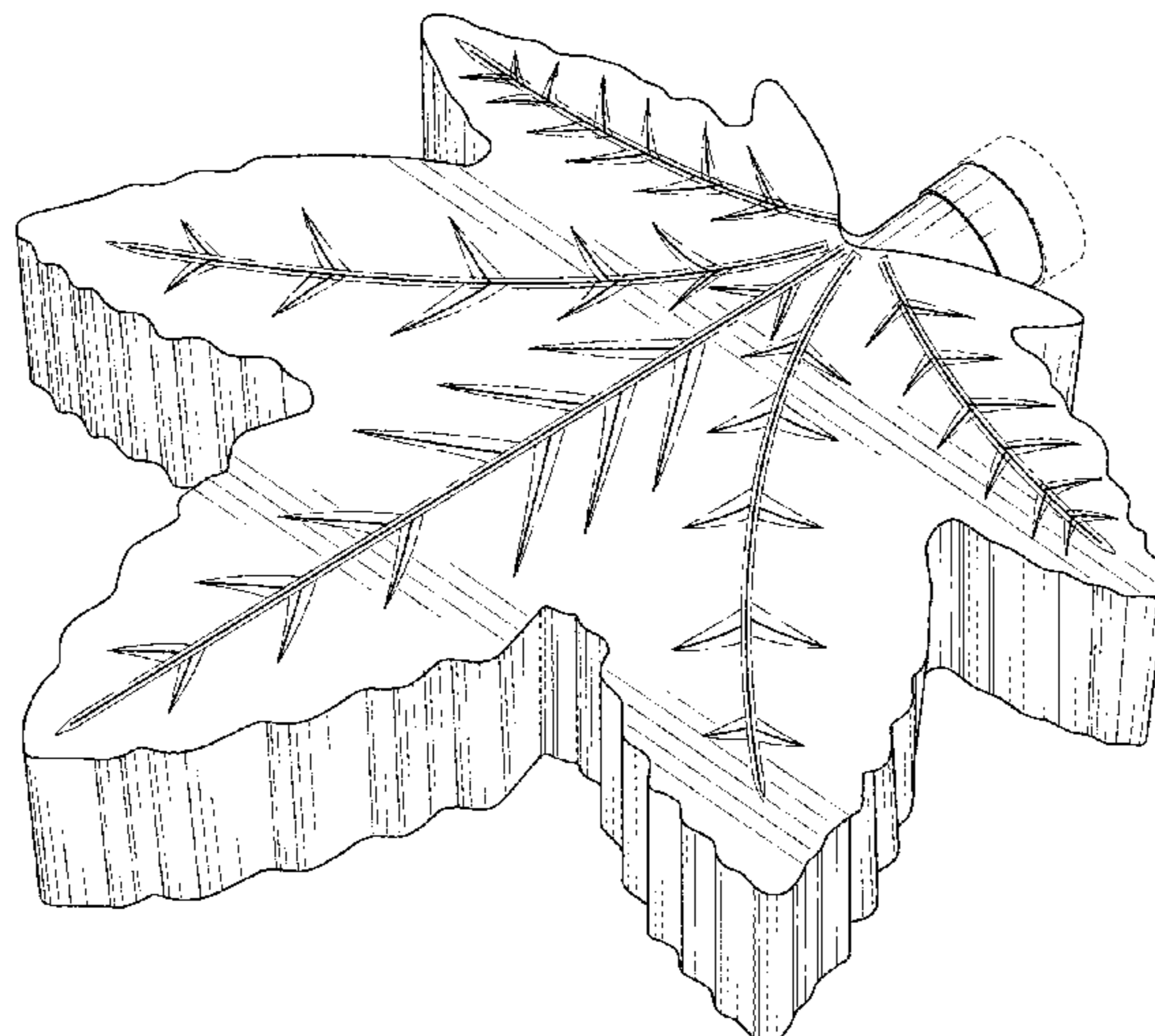
(57) **CLAIM**

The ornamental design for a decanter, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front-left perspective view of a decanter showing my new design;  
FIG. 2 is a bottom-rear-right perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left-side elevational view thereof;  
FIG. 6 is a right-side elevational view thereof;

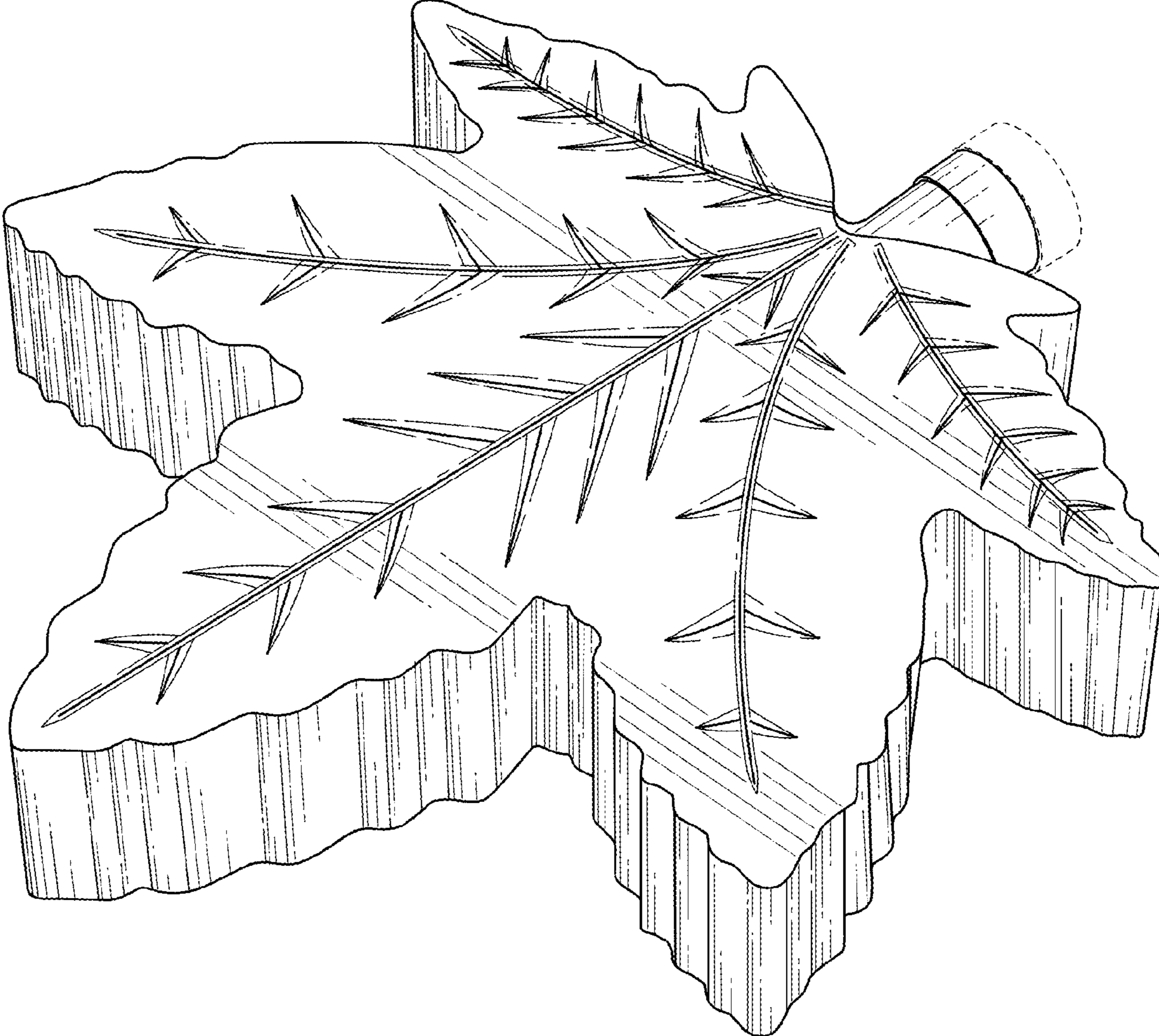

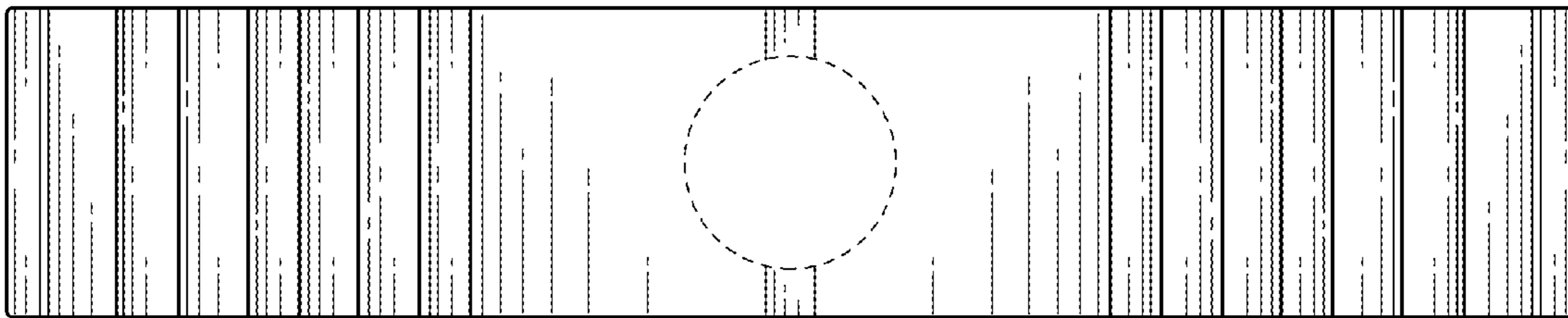

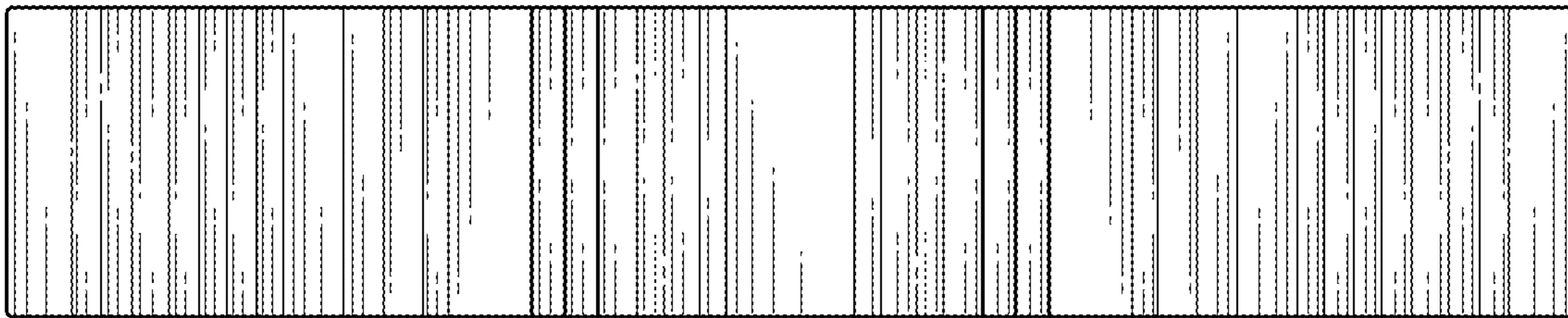

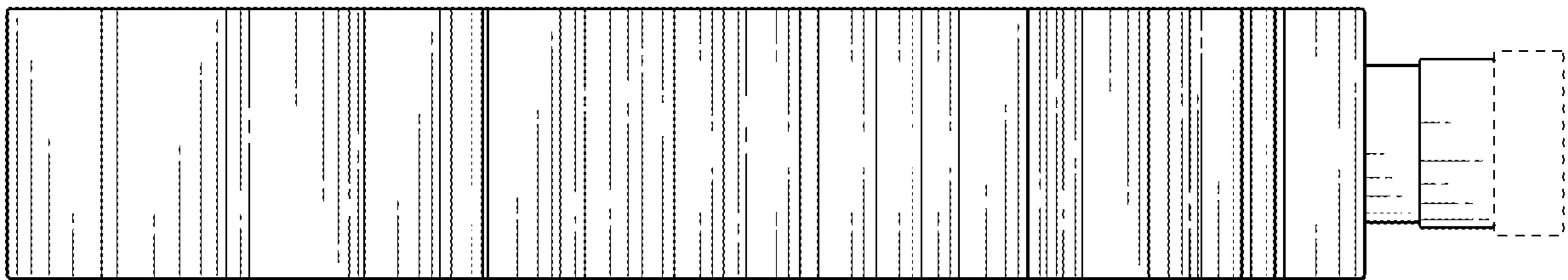

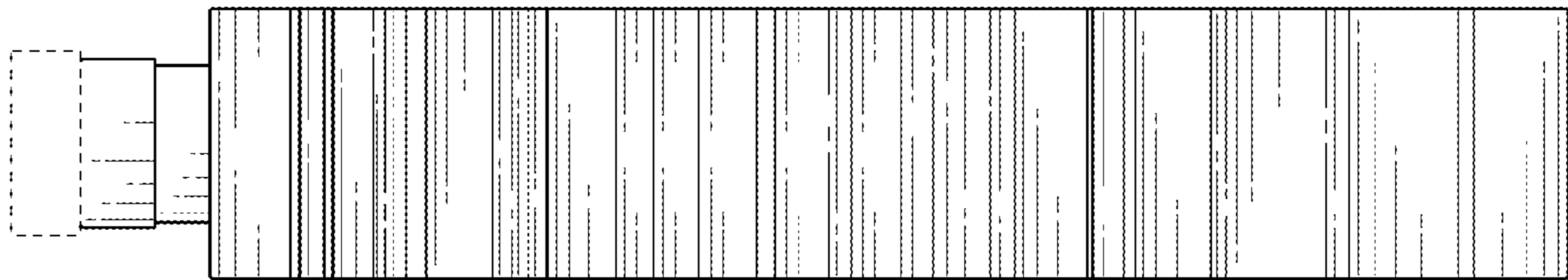

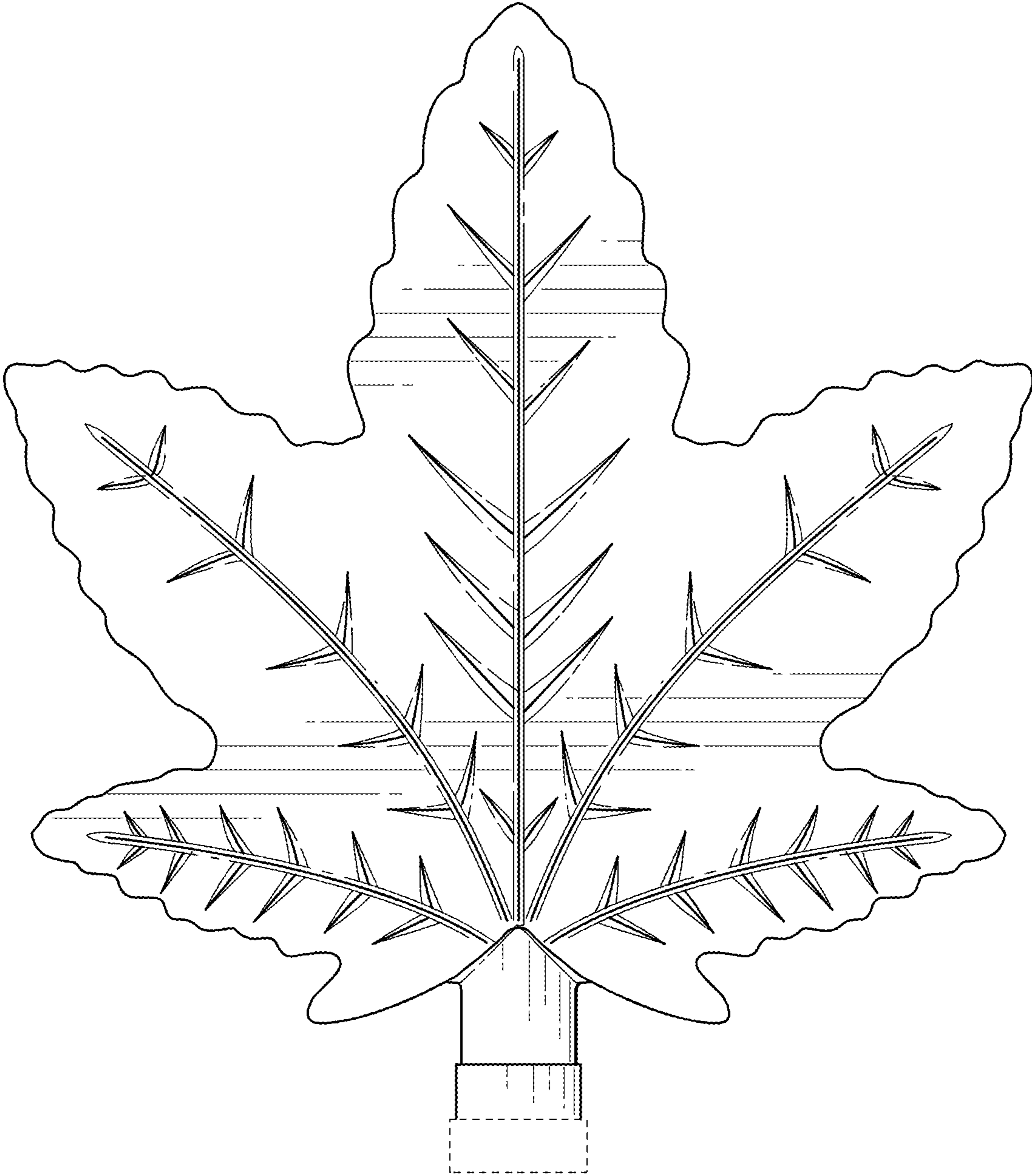

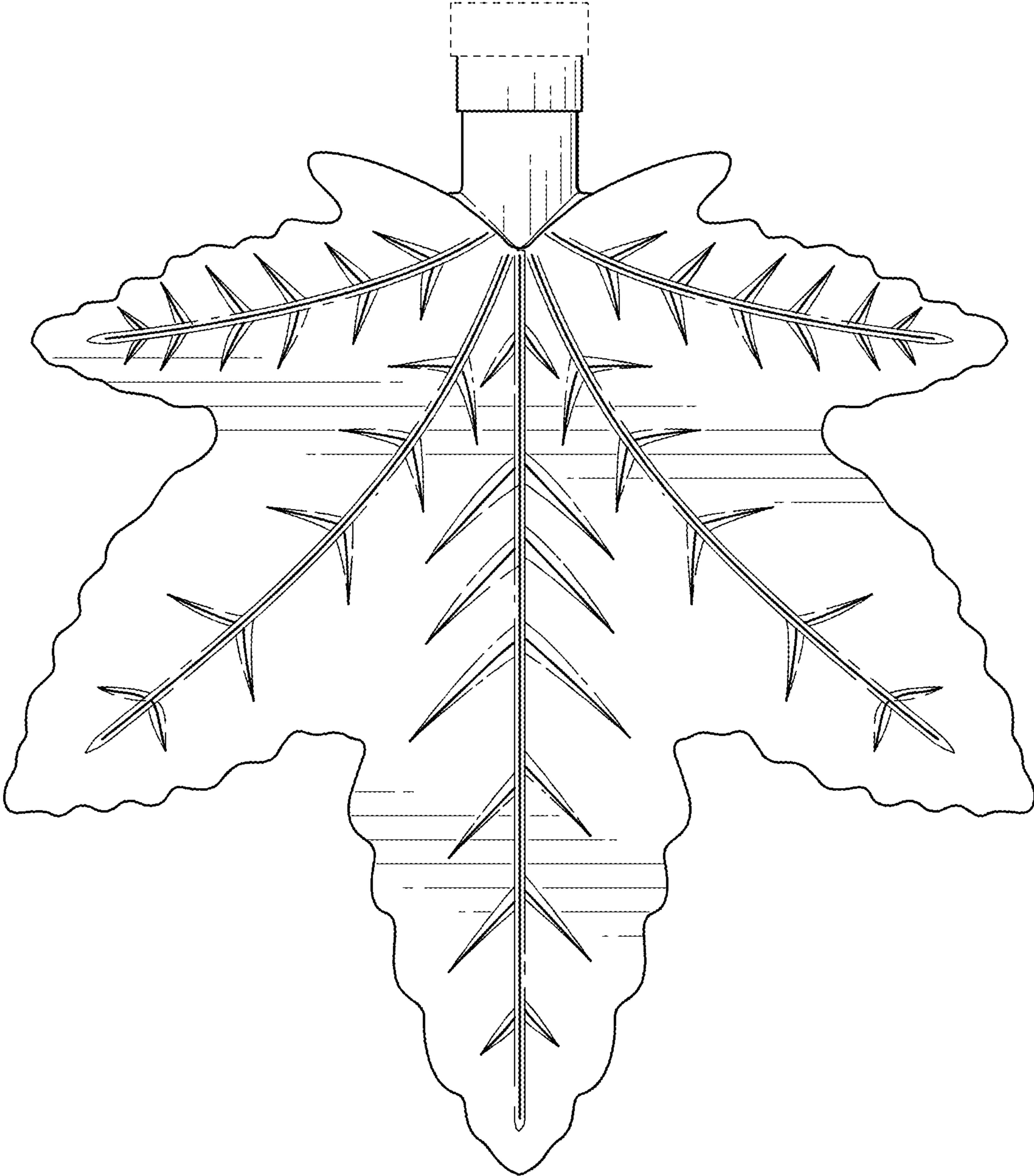
