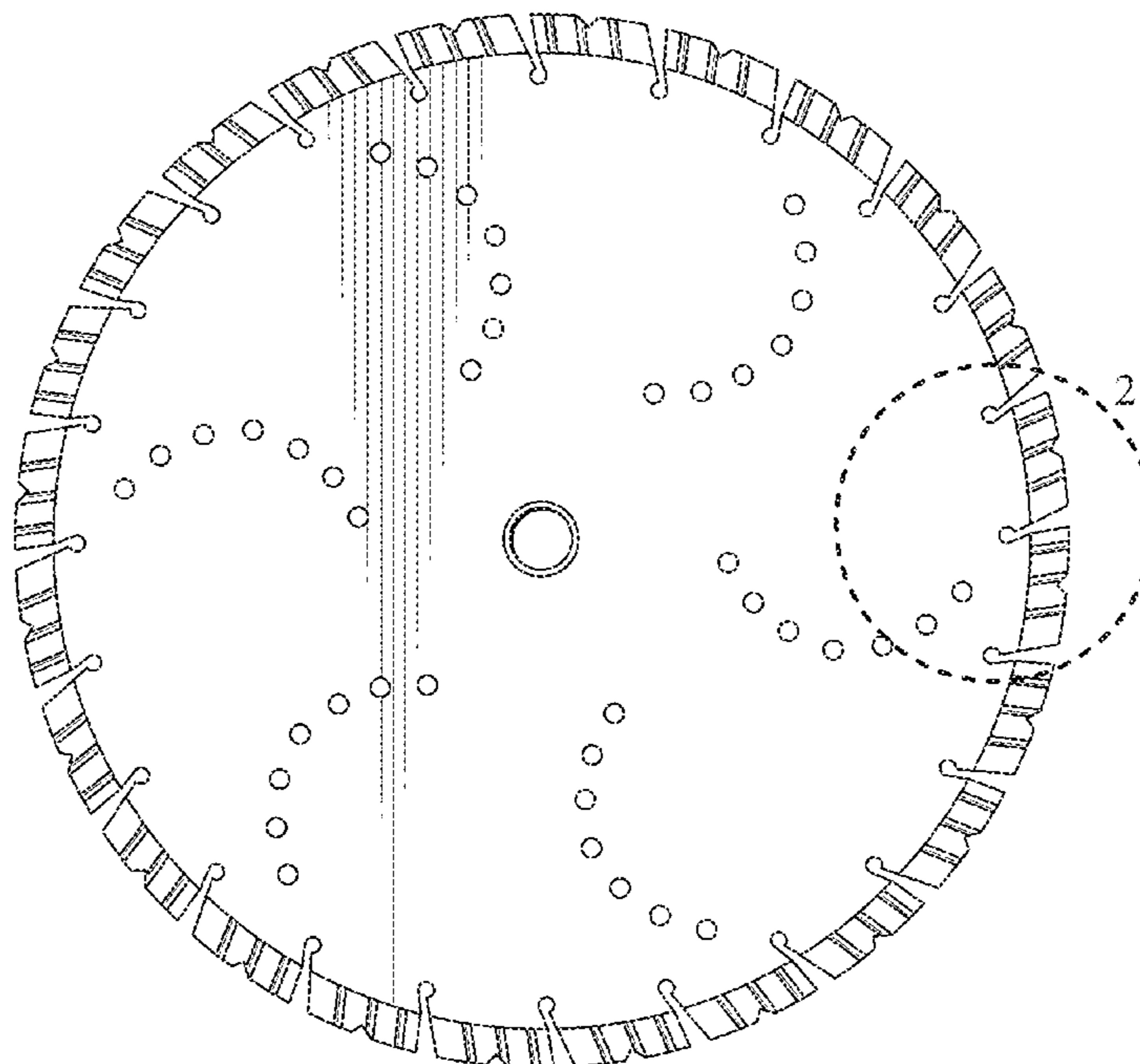

DESCRIPTION

FIG. 1 is a top view of a diamond saw blade, according to the new design. The bottom view is a mirror image of the top view; and,
FIG. 2 is detail view of the portion “2” identified in FIG. 1. The broken lines are included to identify the portion that is enlarged and form no part of the claimed design.

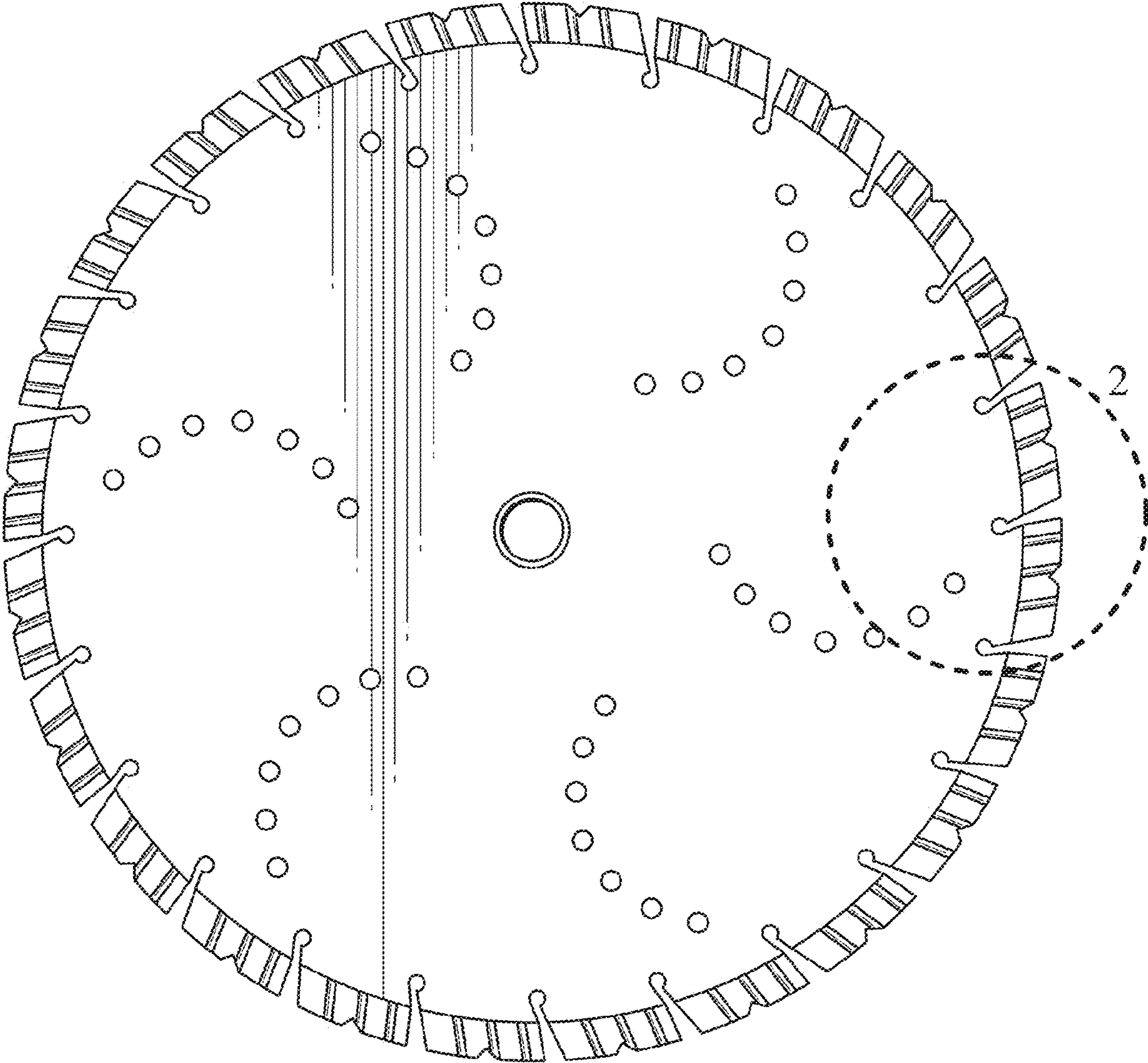

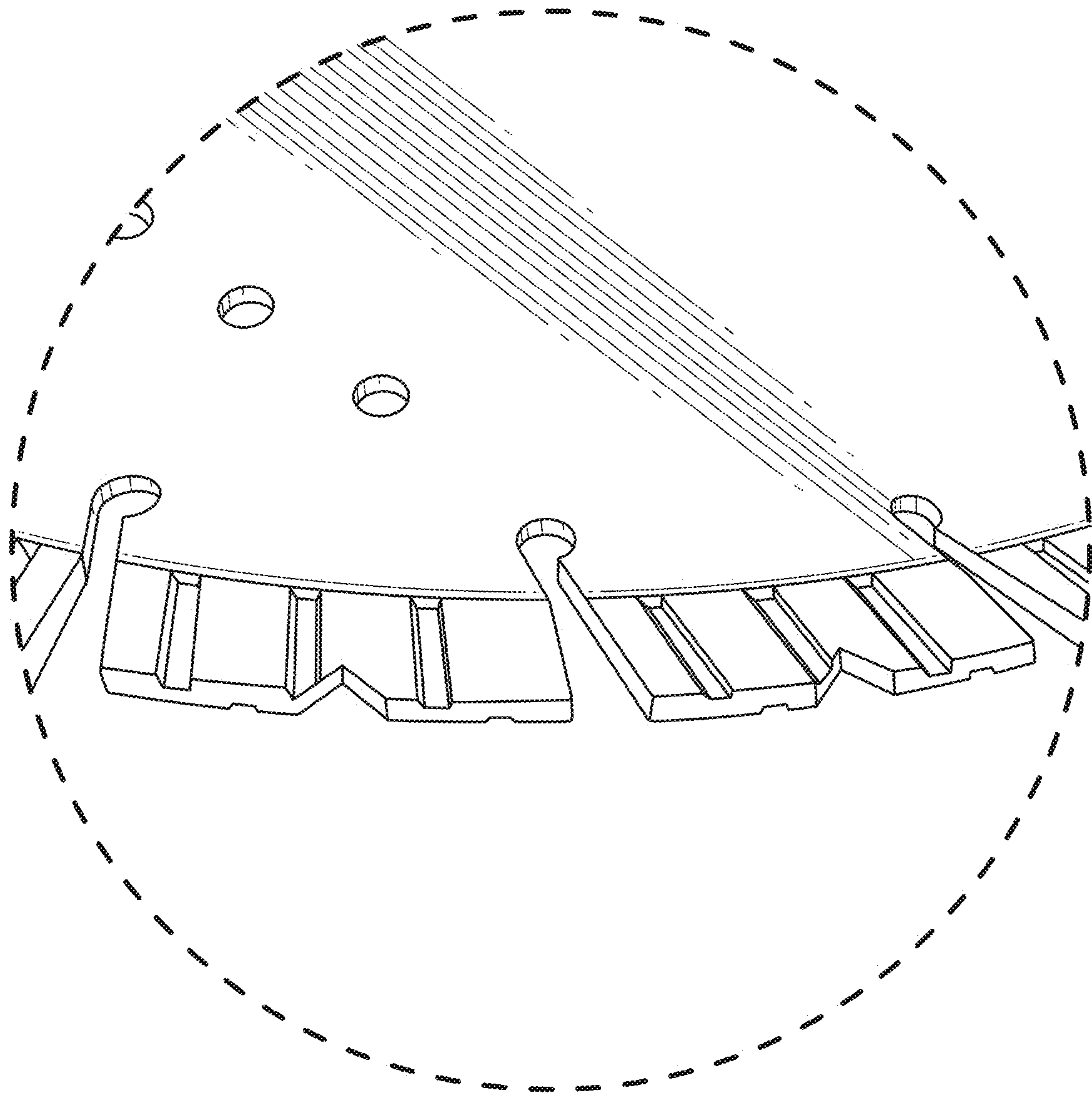
