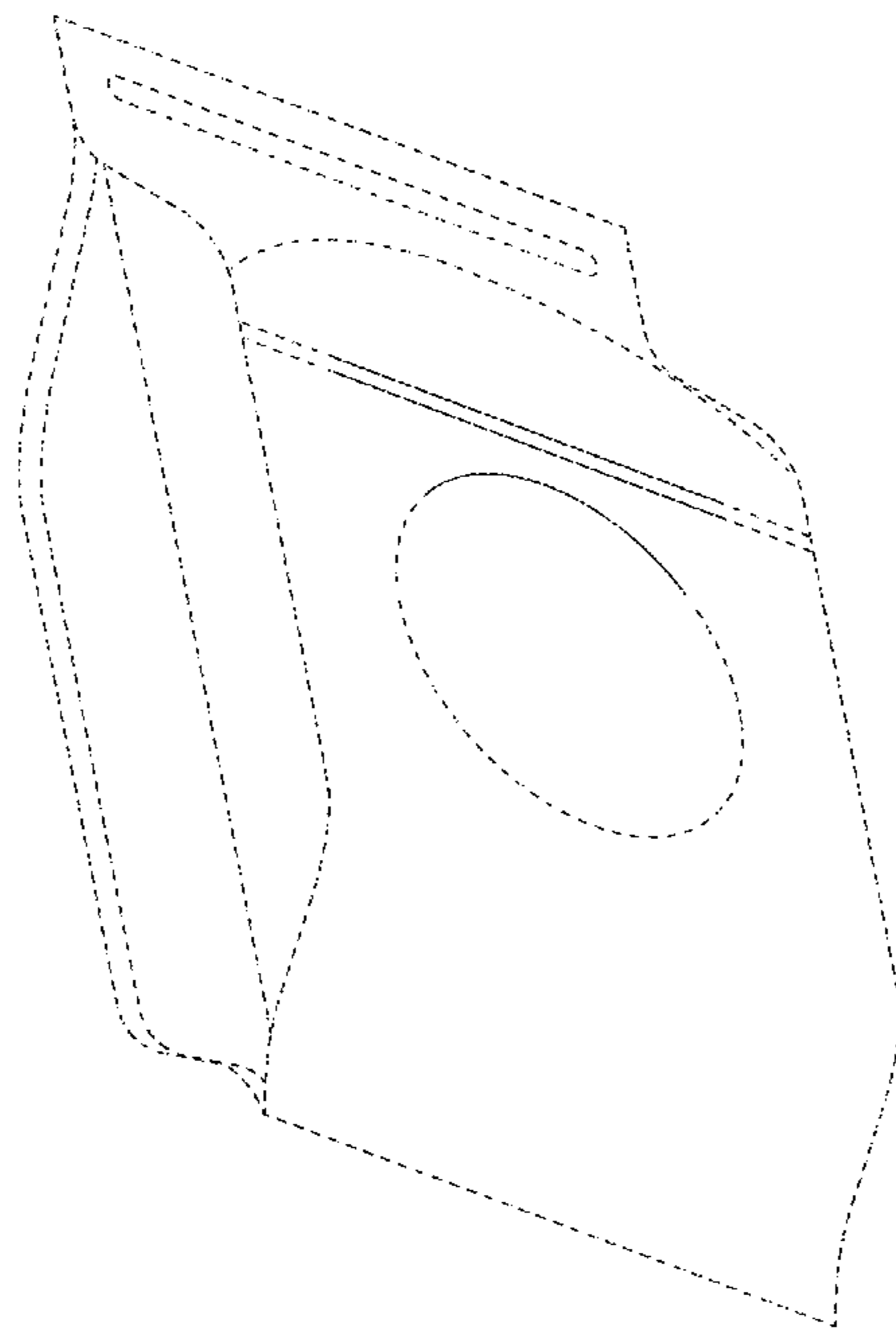
(57) **CLAIM**

DESCRIPTION

FIG. 1 is perspective view of a package showing my new design;

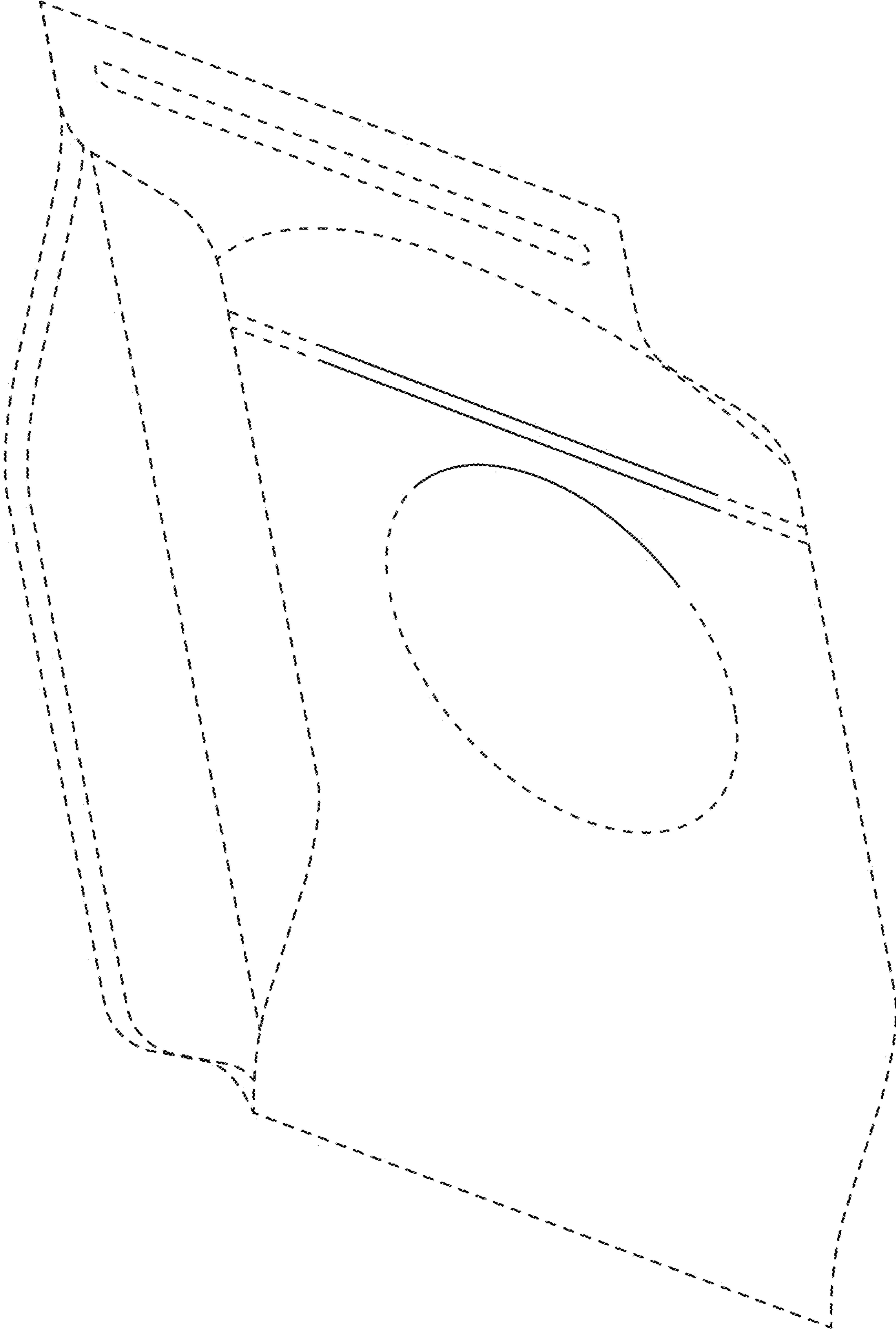

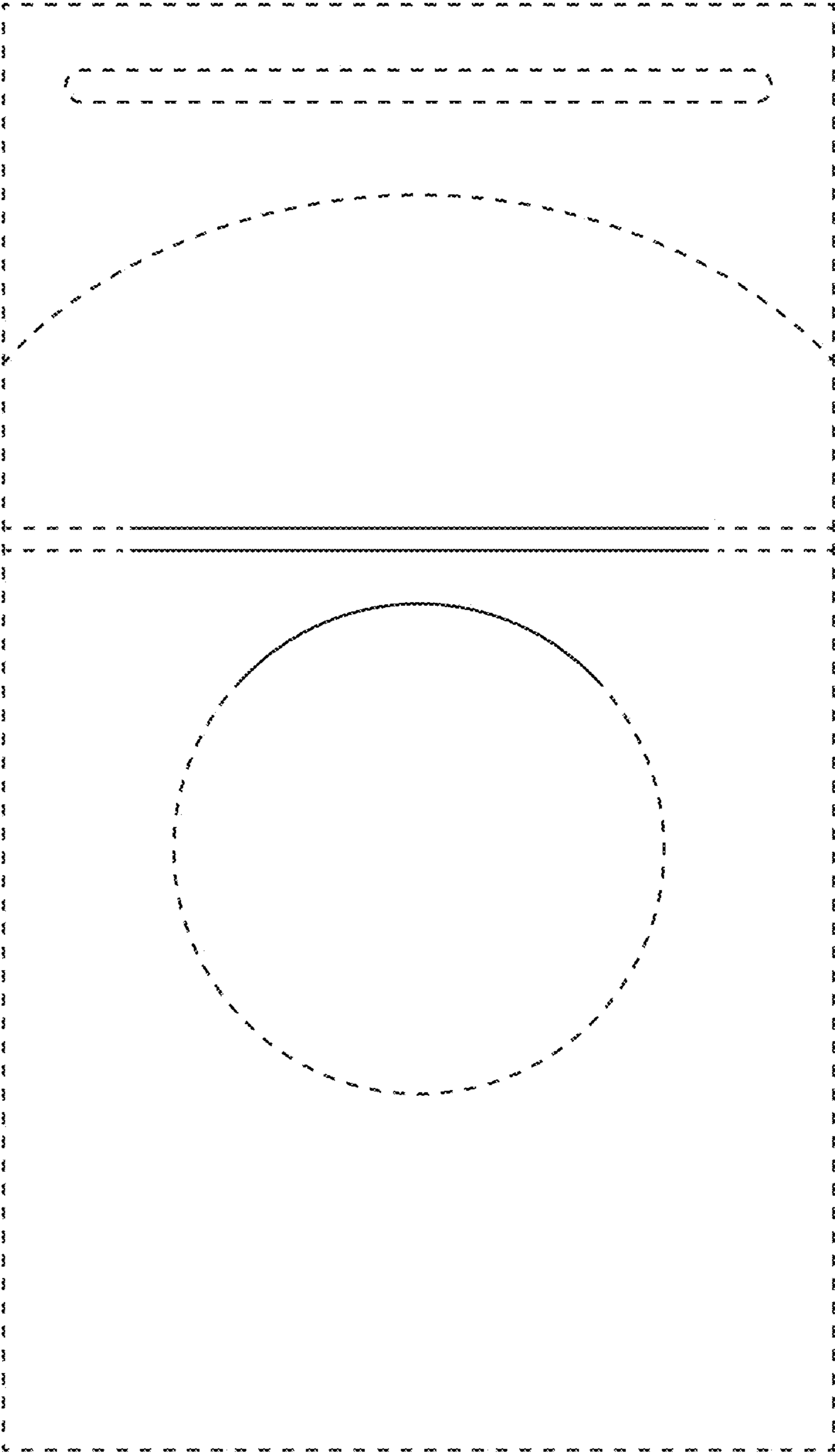

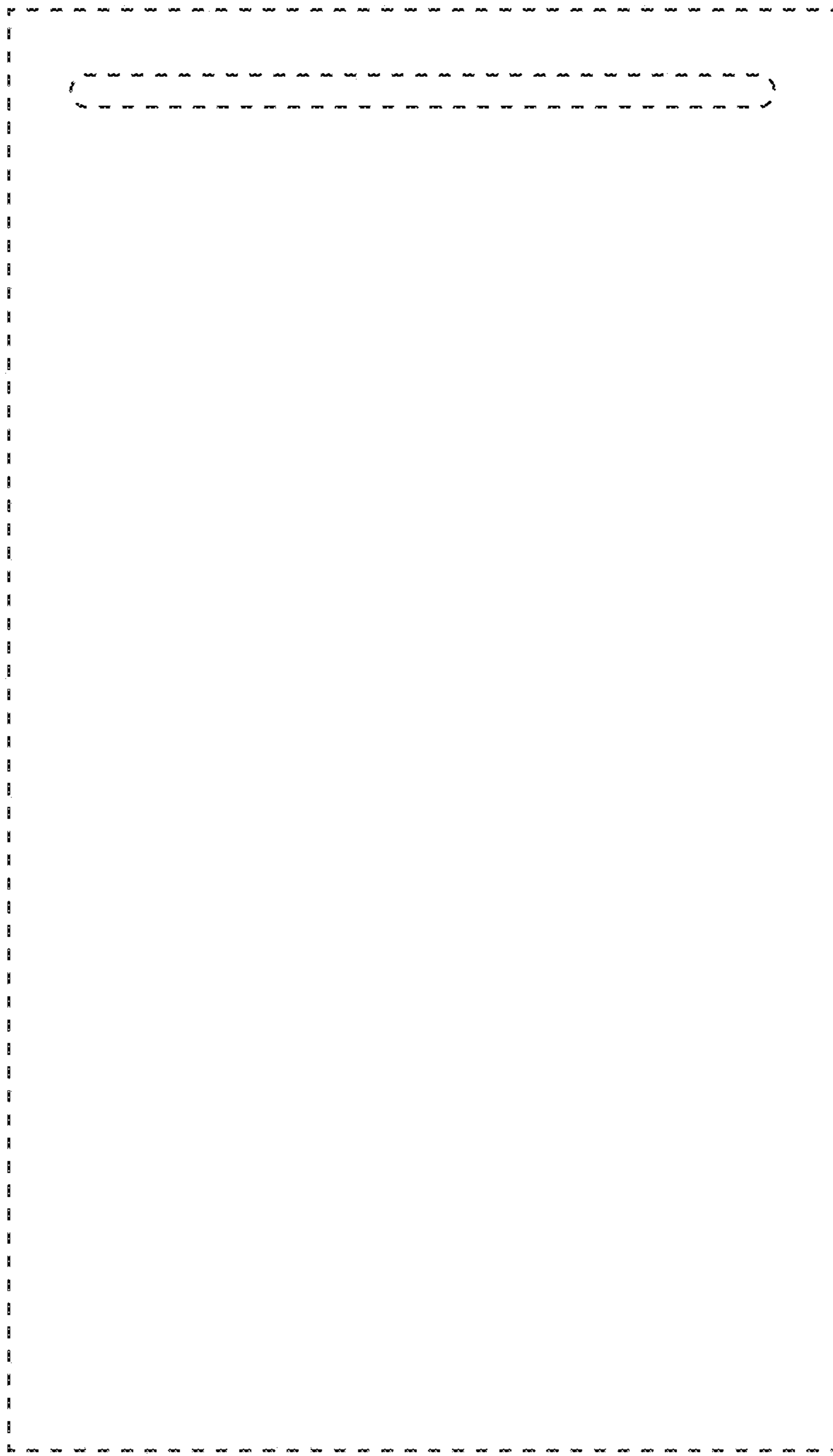

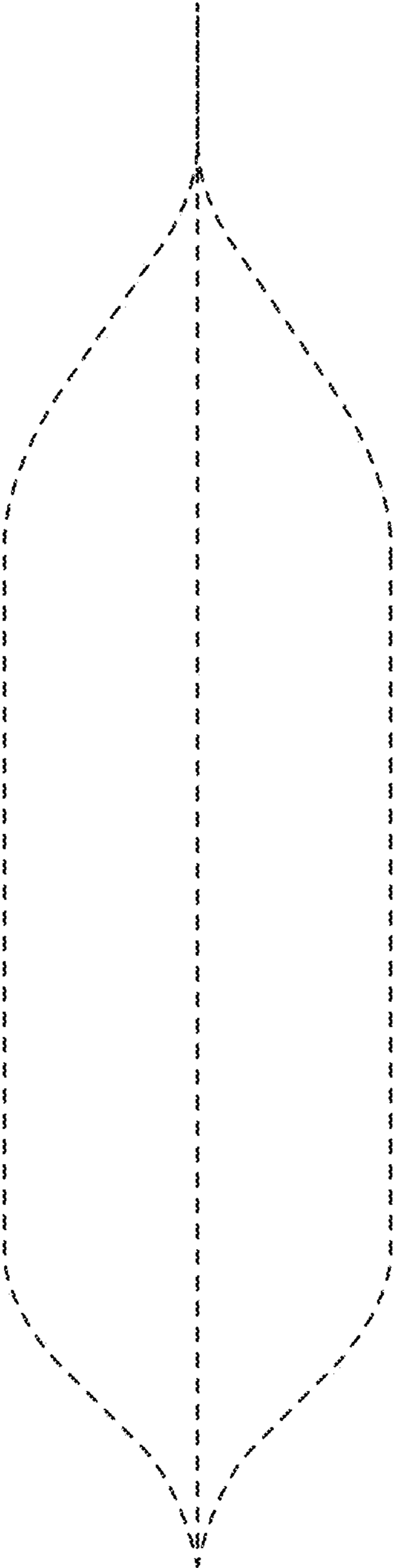

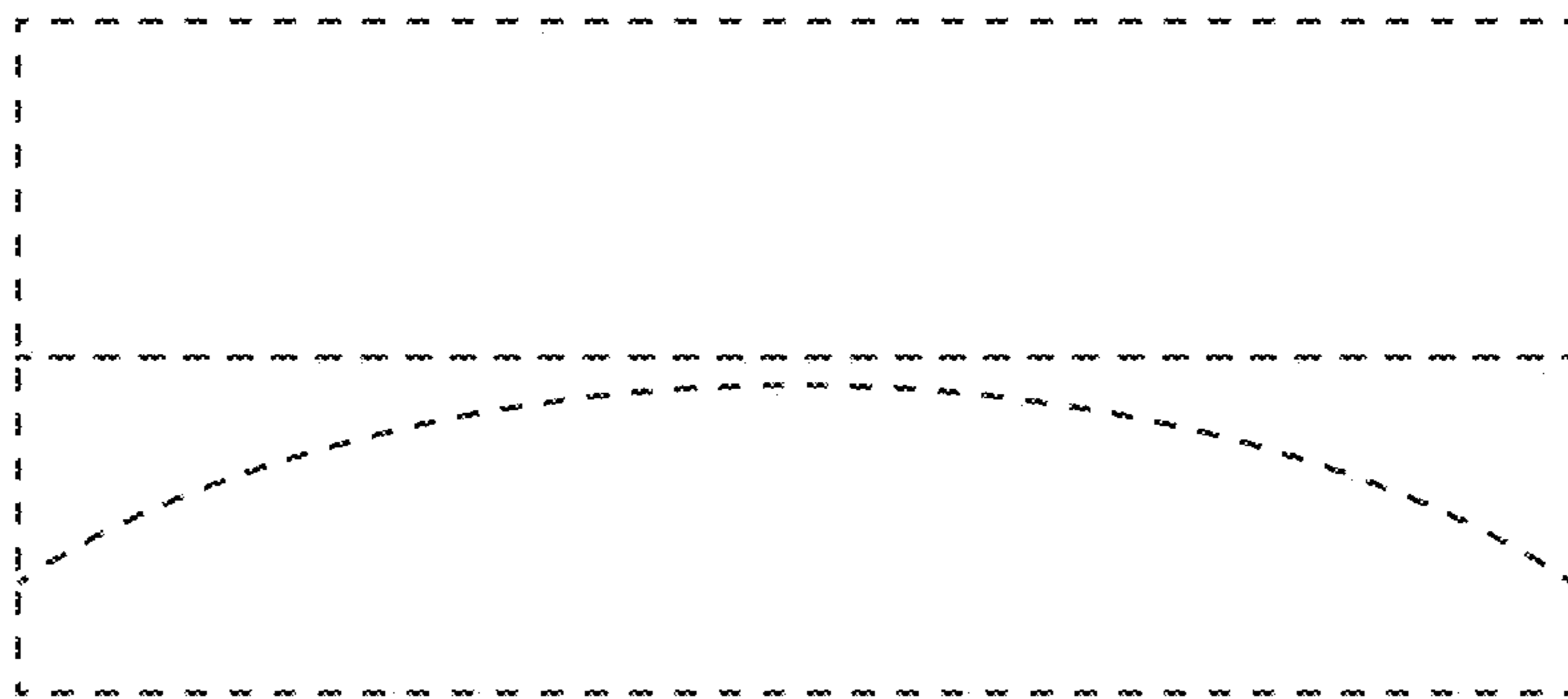
