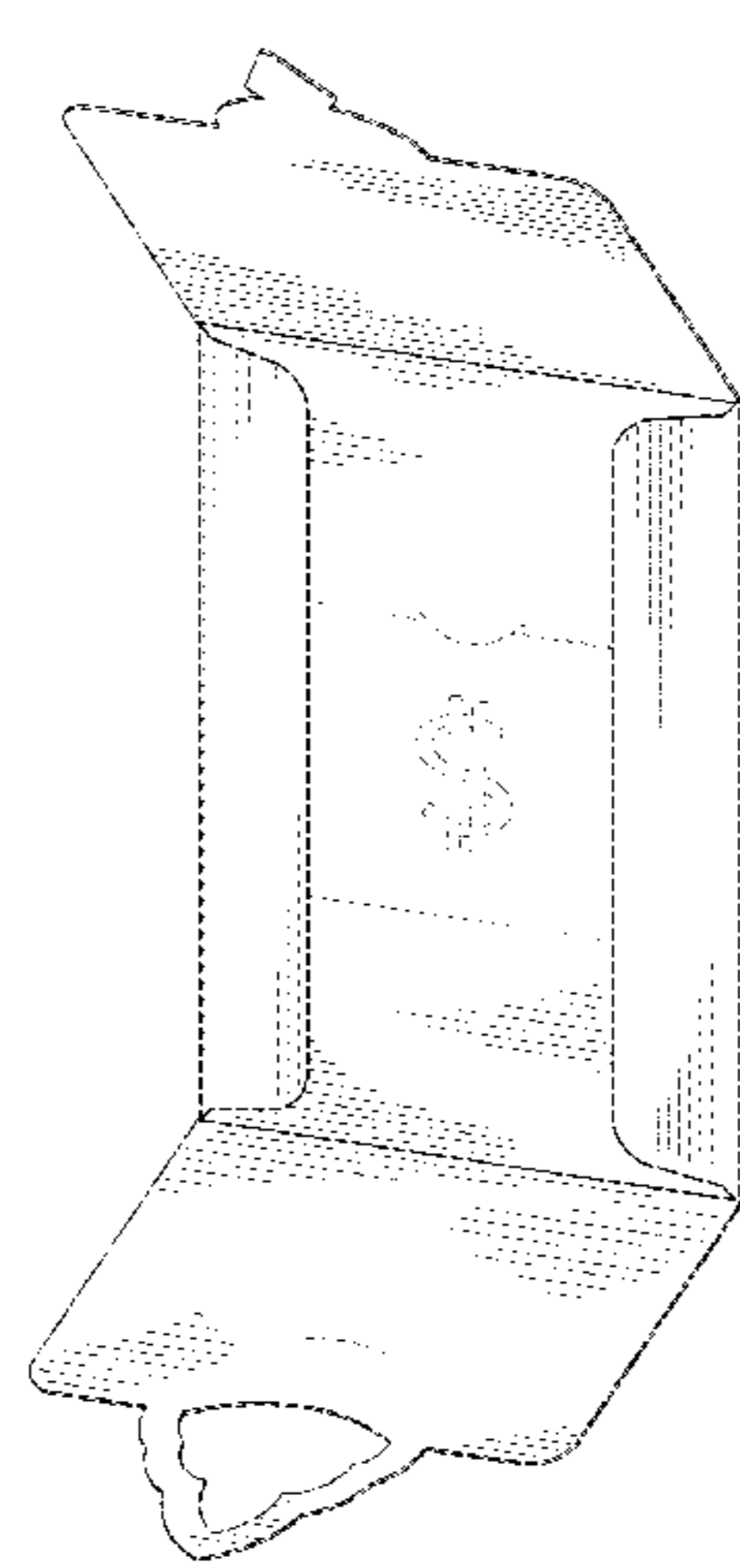

DESCRIPTION

FIG. 1 is a perspective view of the interlocking gift card sleeve of the present invention, in a closed position.
FIG. 2 is a front view of FIG. 1.
FIG. 3 is a rear view of FIG. 1.

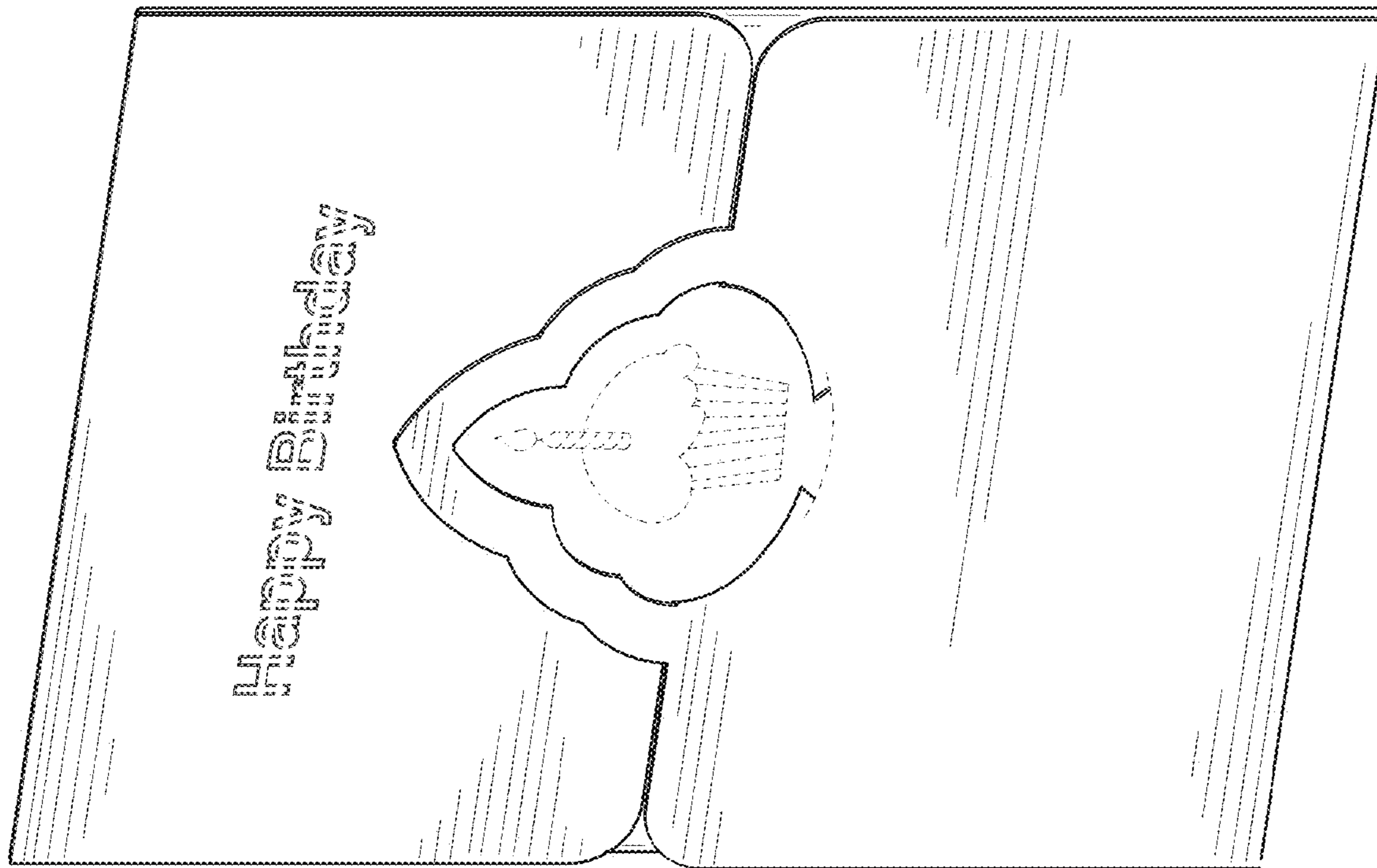

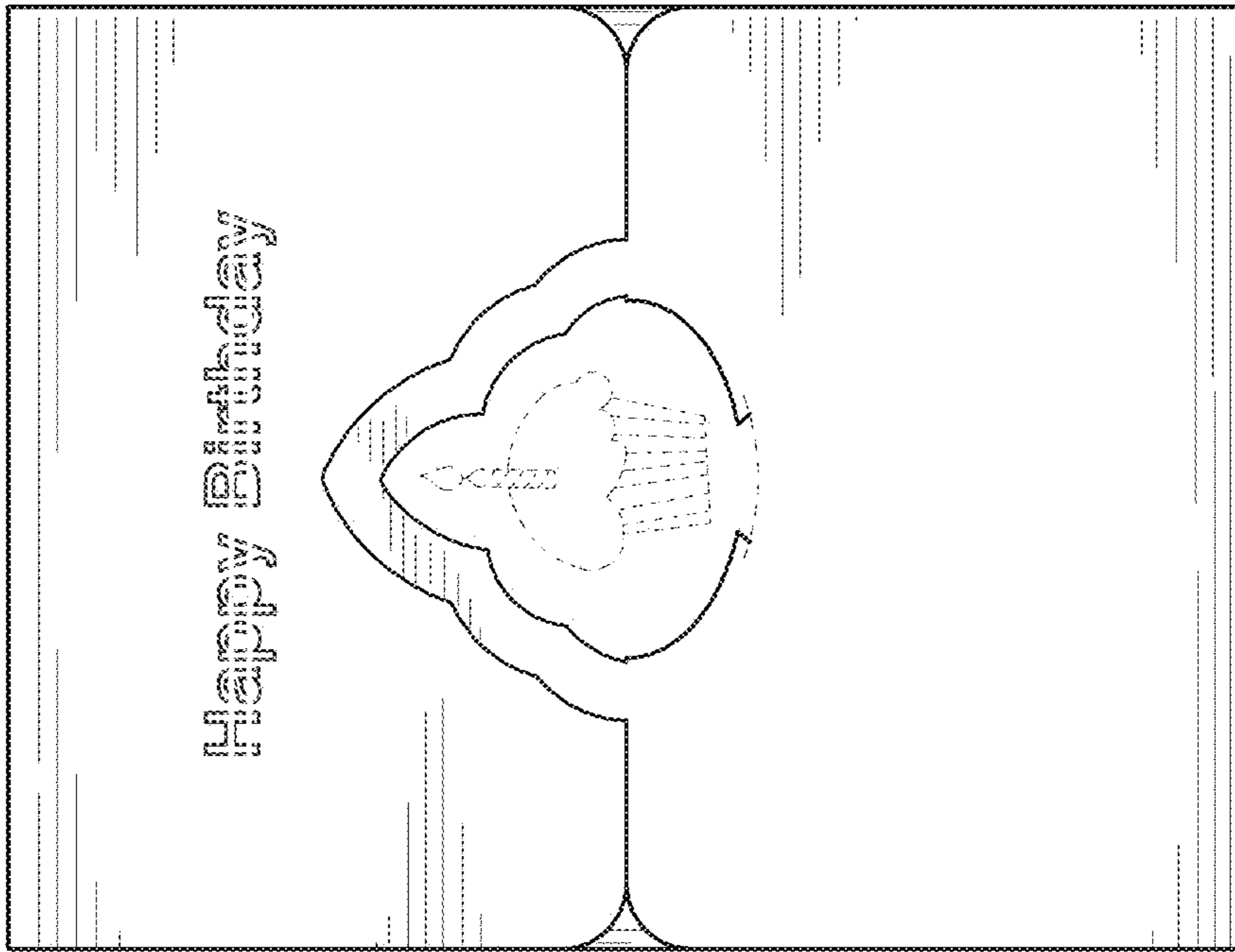

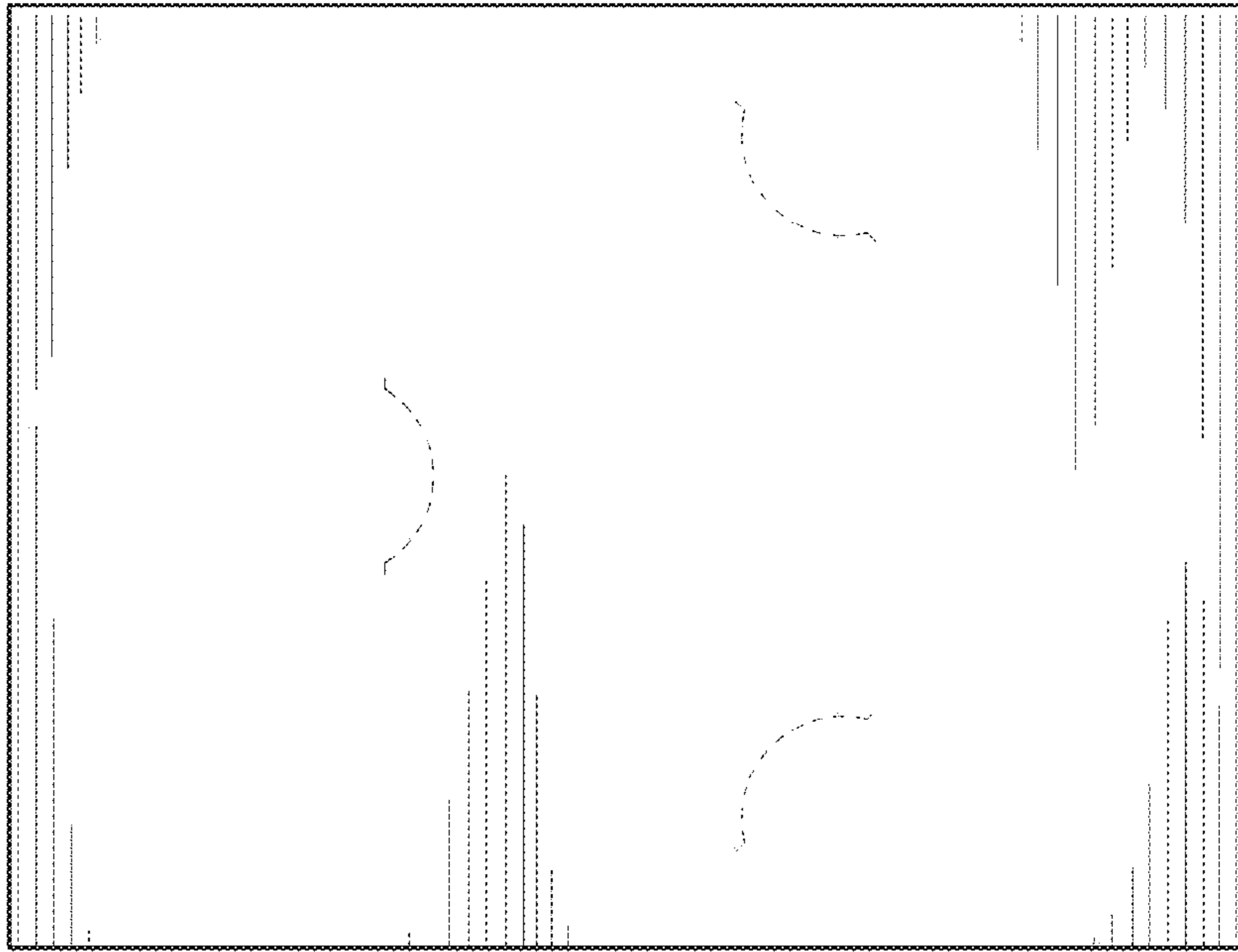

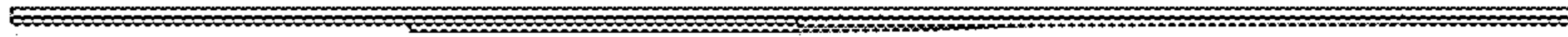

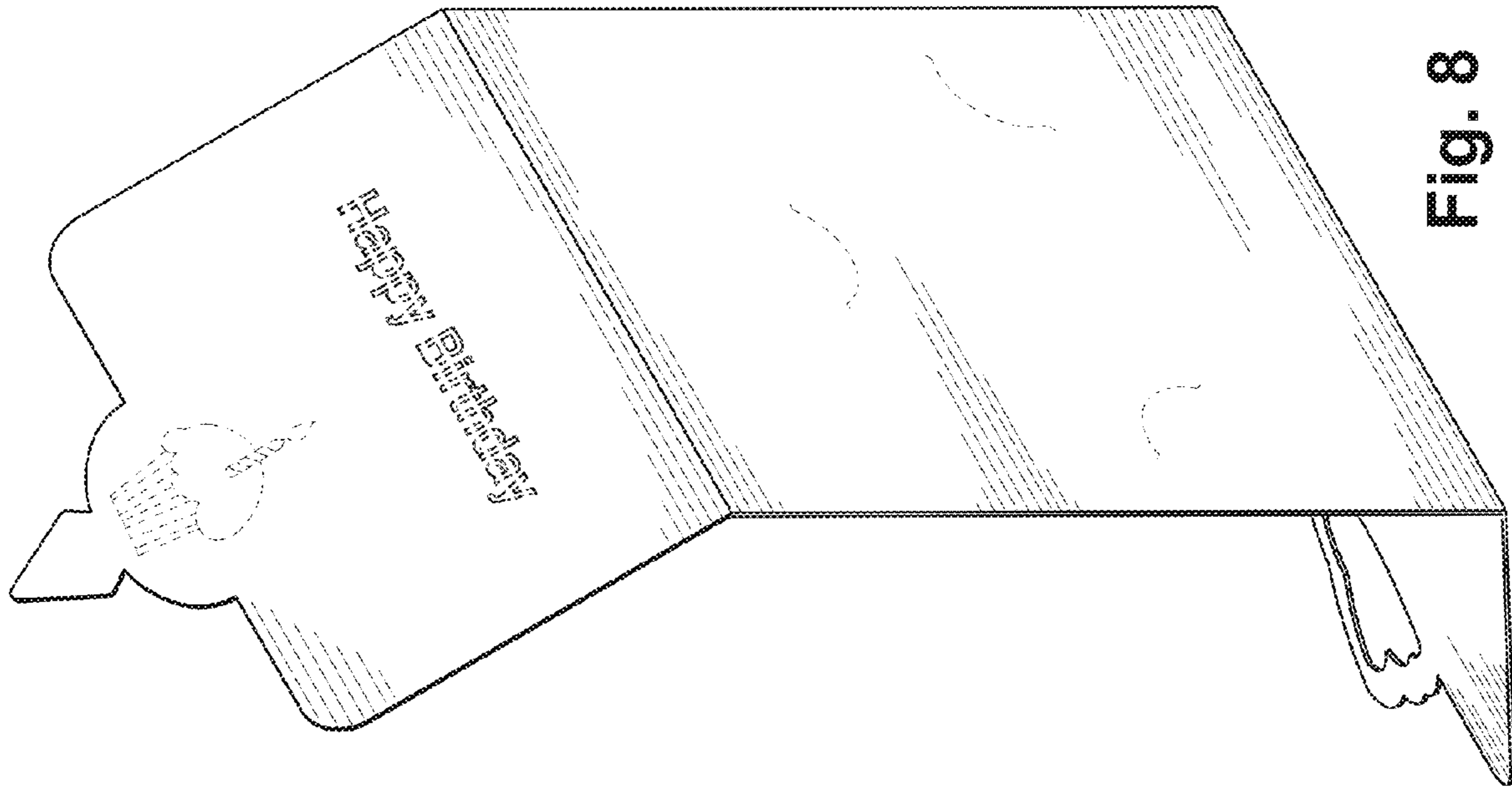

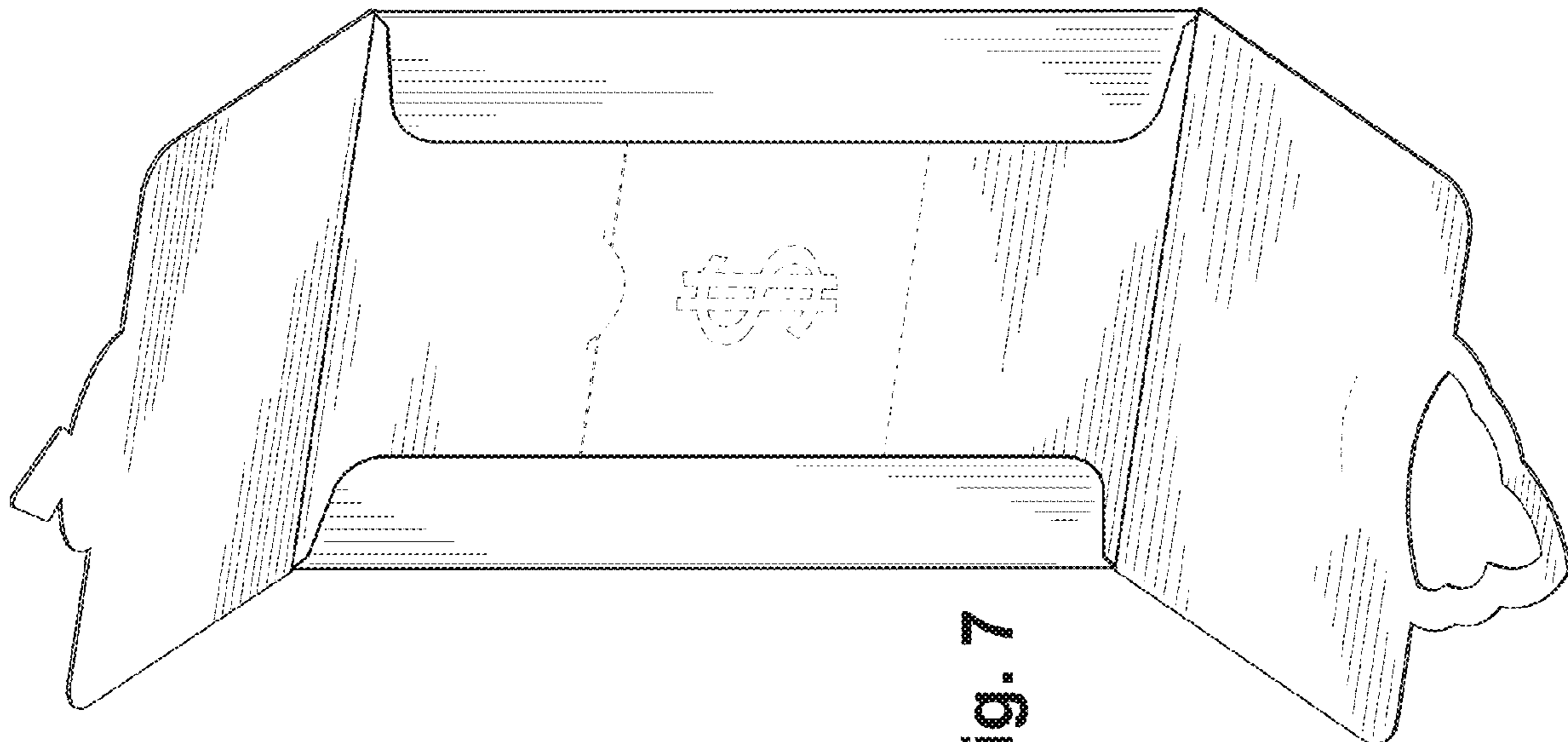
