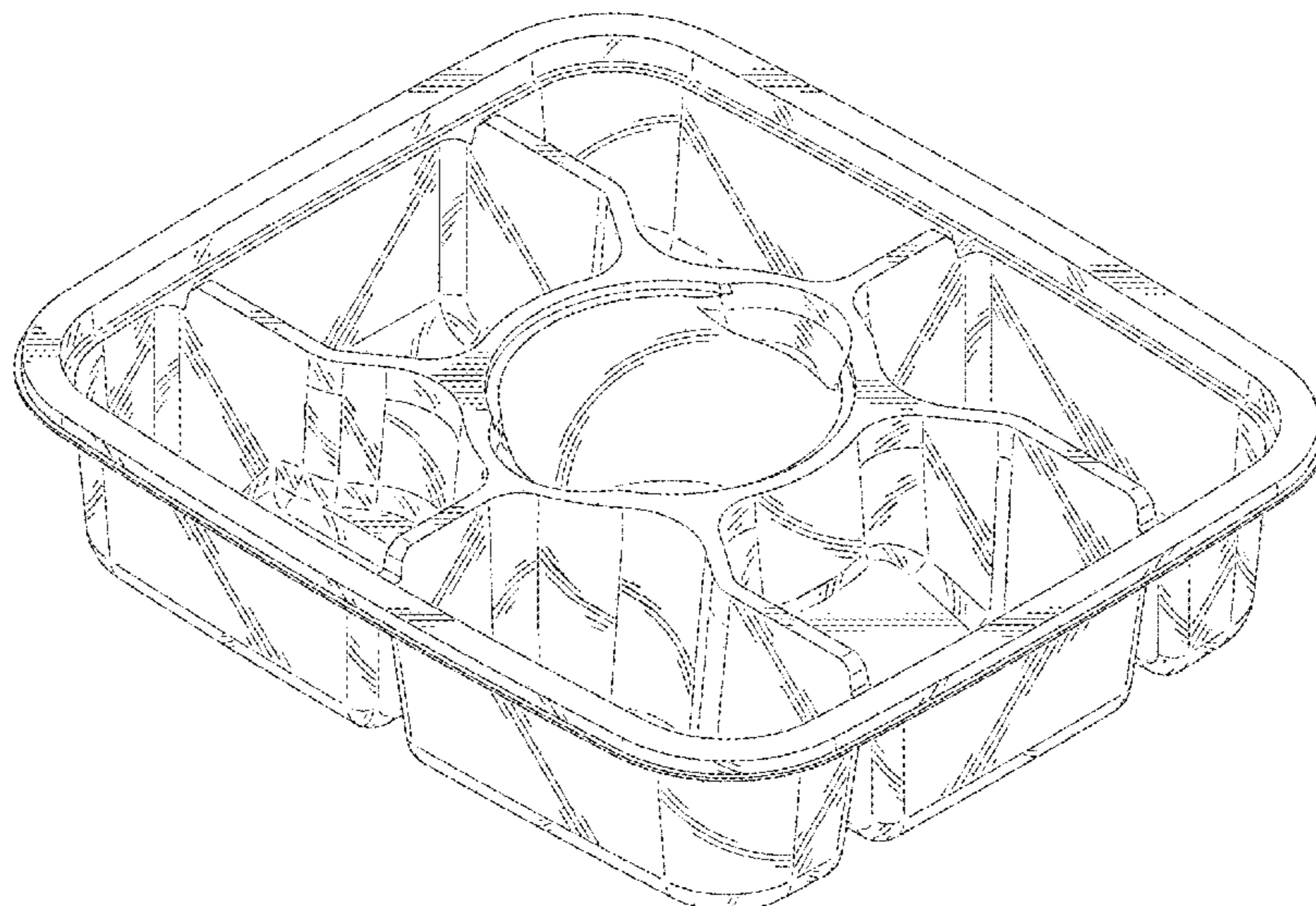
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front, top isometric view of a container of our new design.
FIG. 2 is a front elevational view of the container of FIG. 1, the rear elevational view being identical thereto.
FIG. 3 is a right elevational view of the container of FIG. 1, the left elevational view being identical thereto.
FIG. 4 is a top plan view of the container of FIG. 1.
FIG. 5 is a bottom plan view of the container of FIG. 1; and, FIG. 6 is a bottom perspective view of the container of FIG. 1.

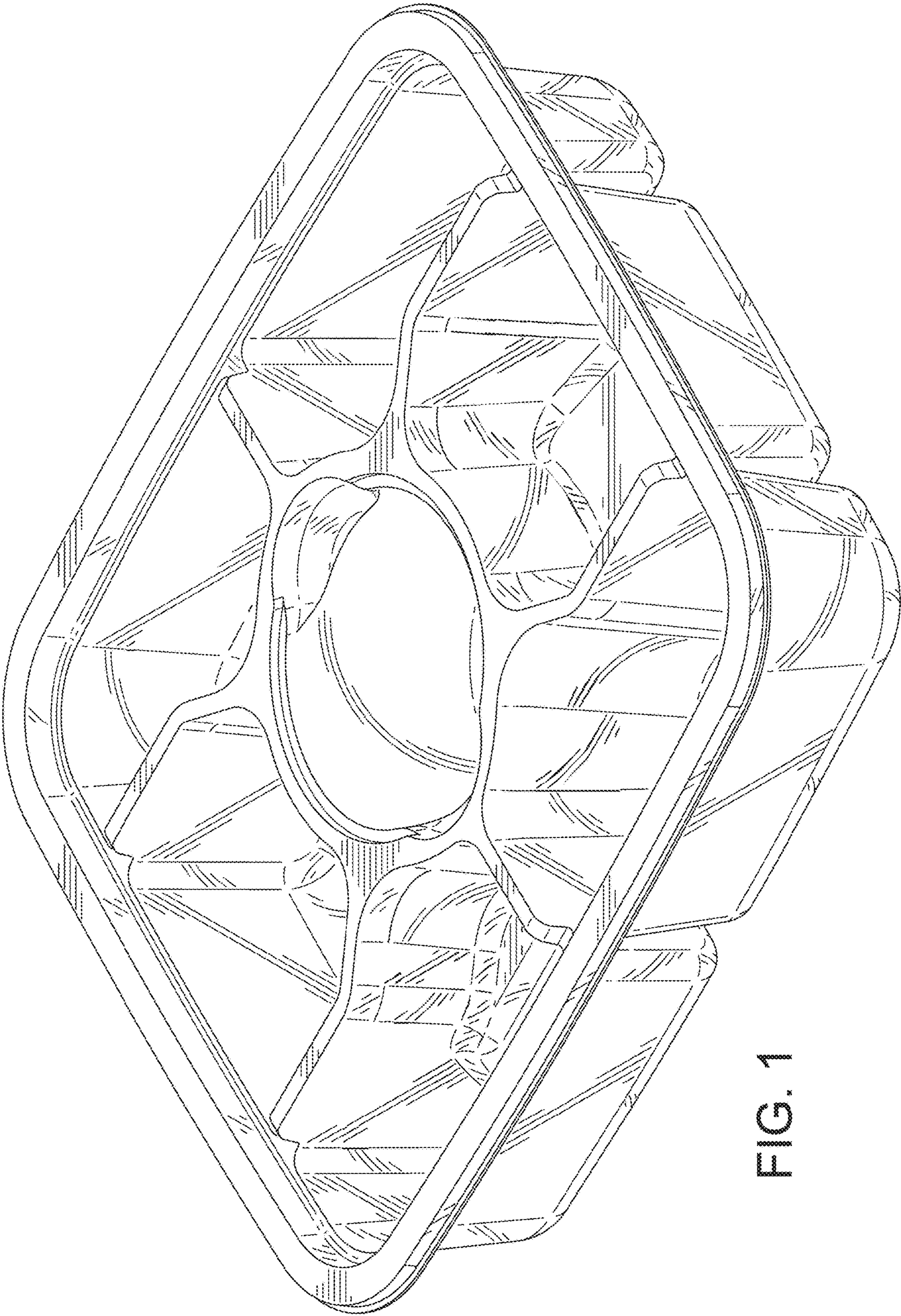

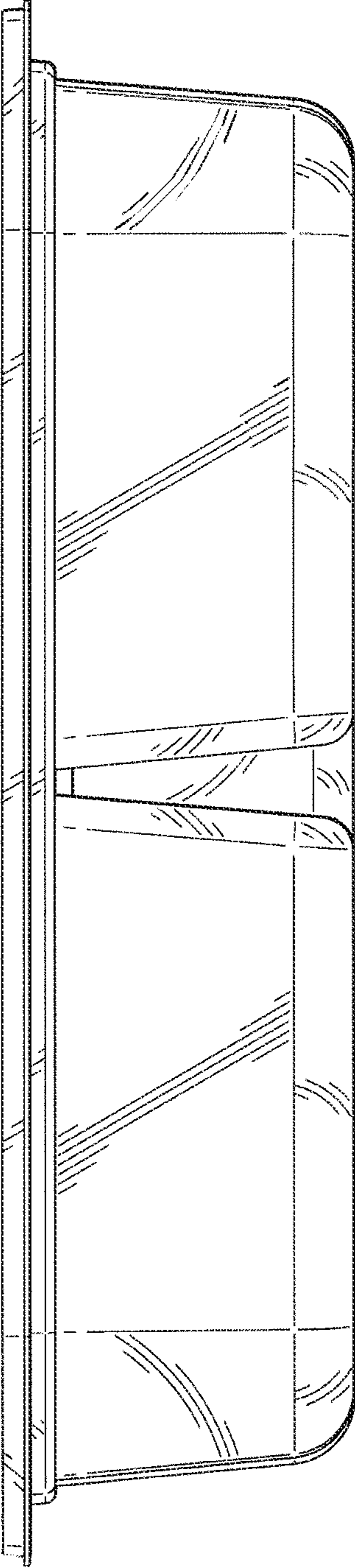

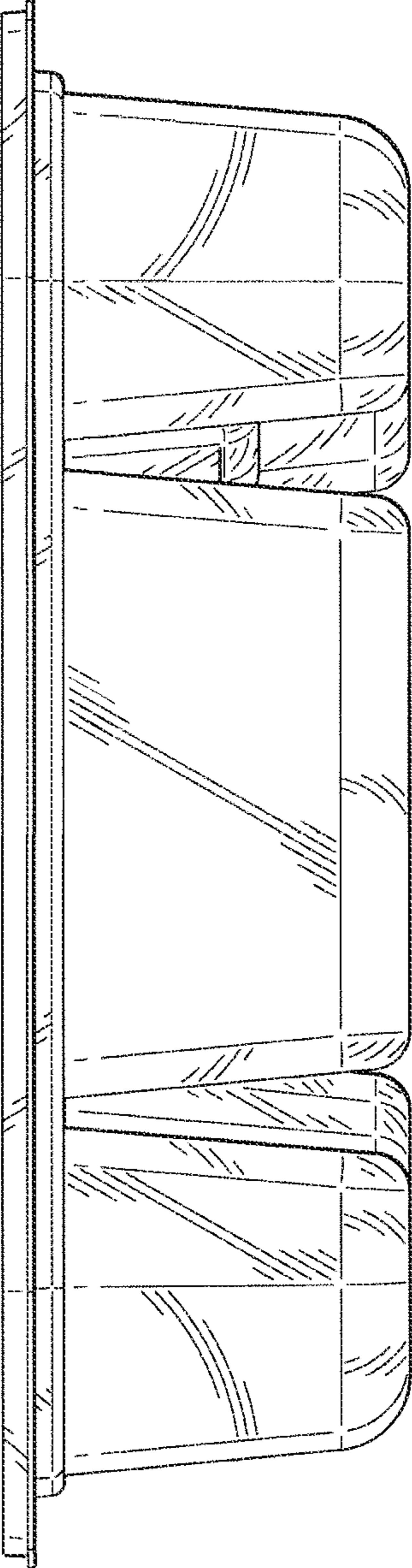

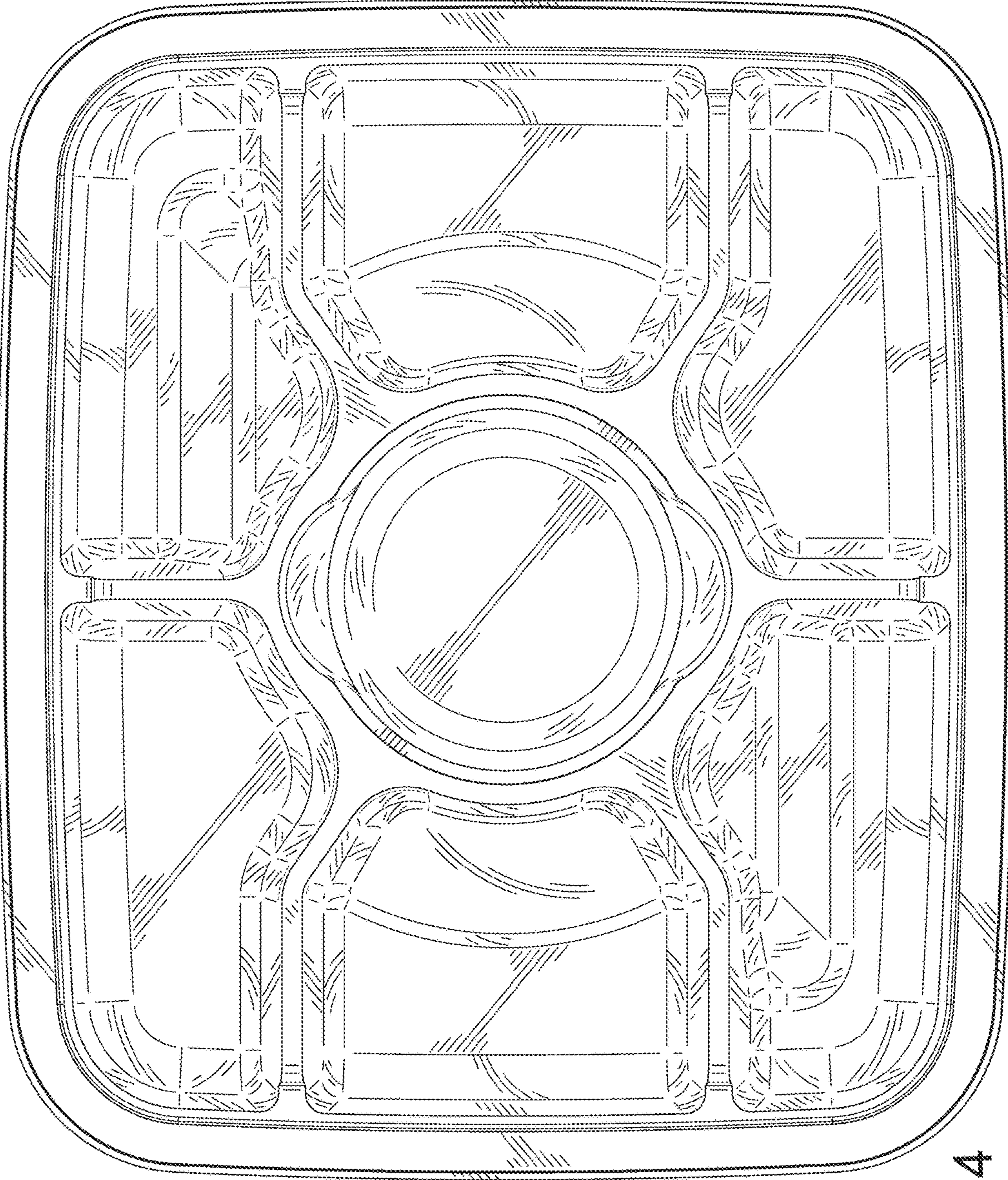

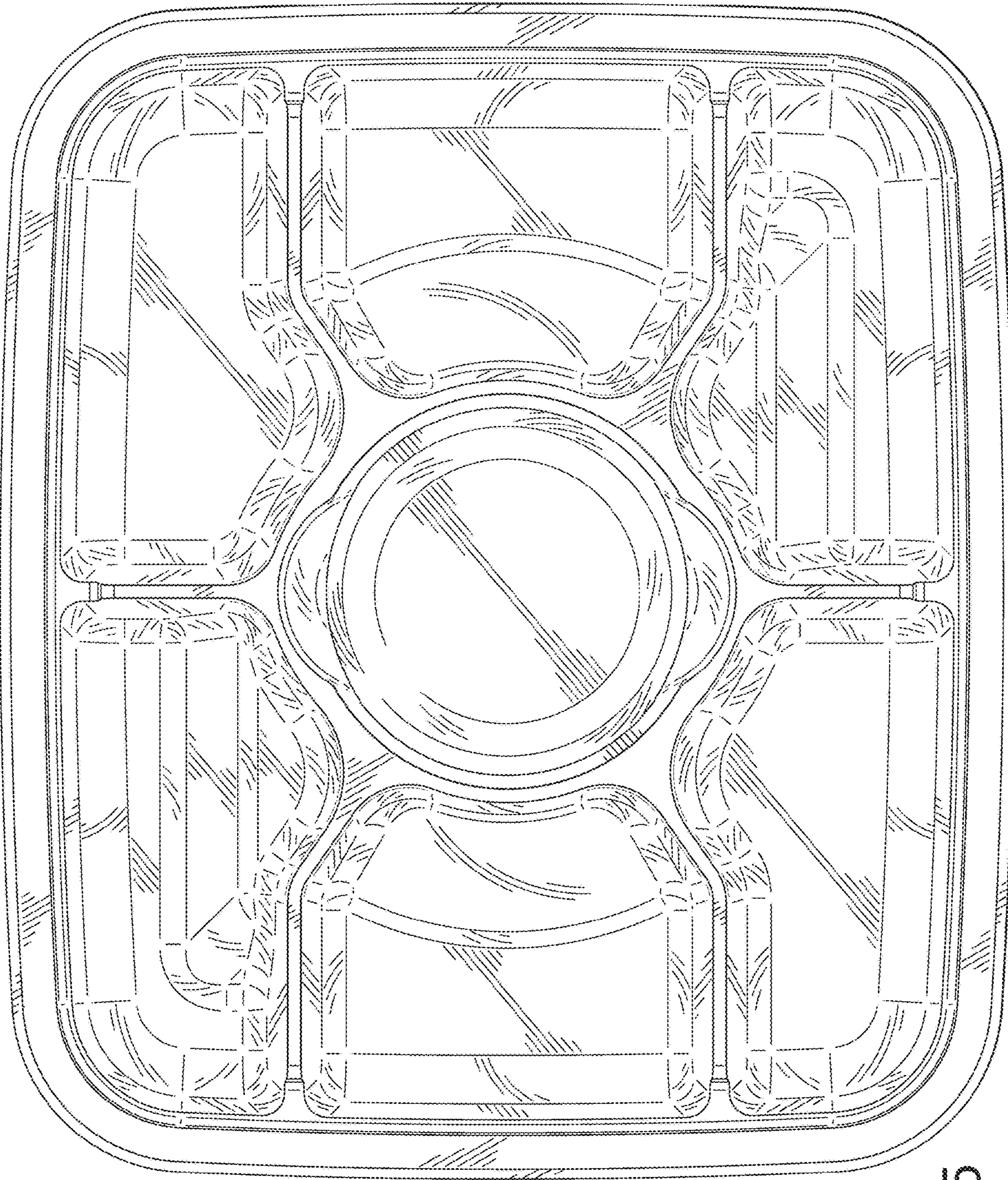

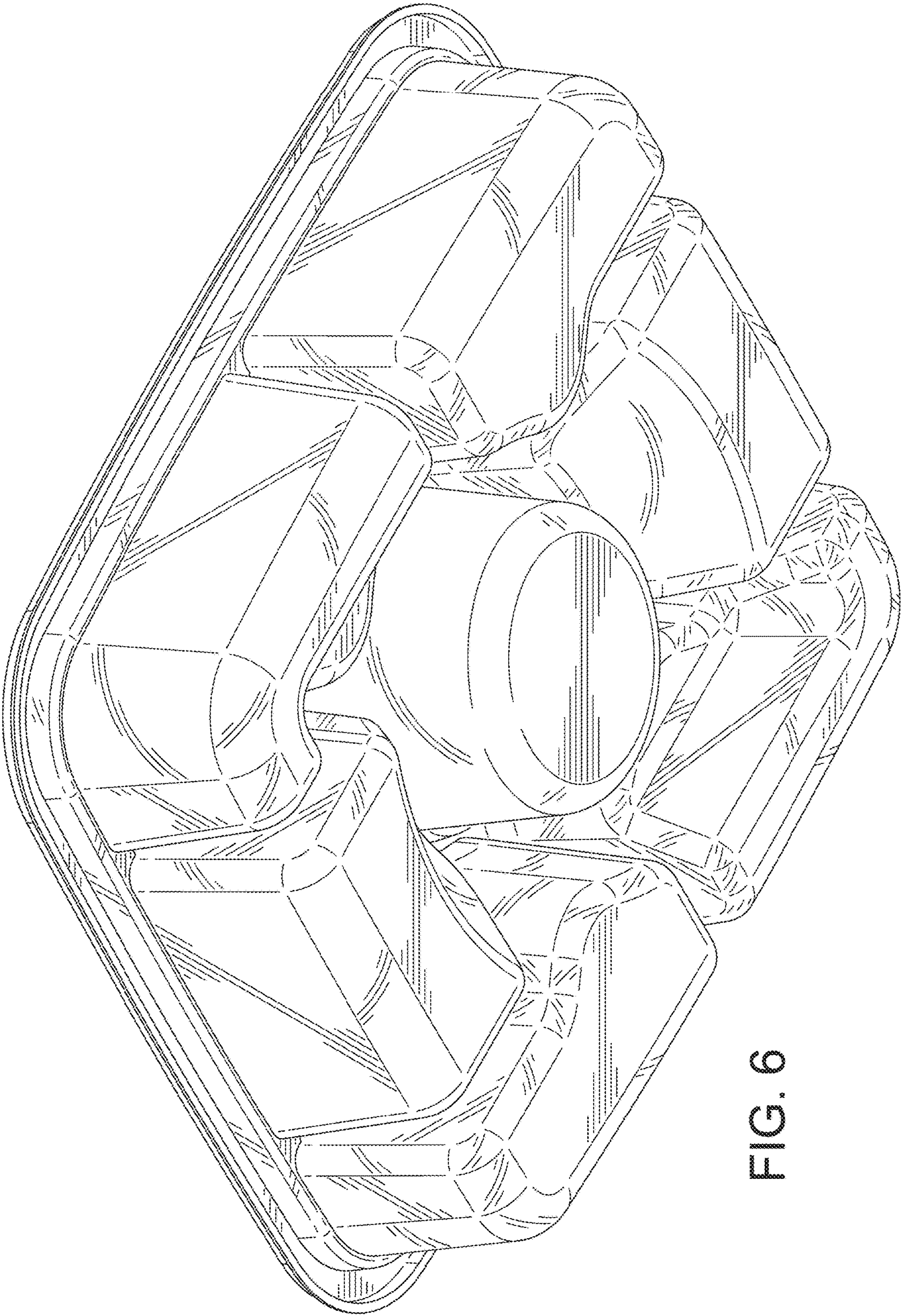
