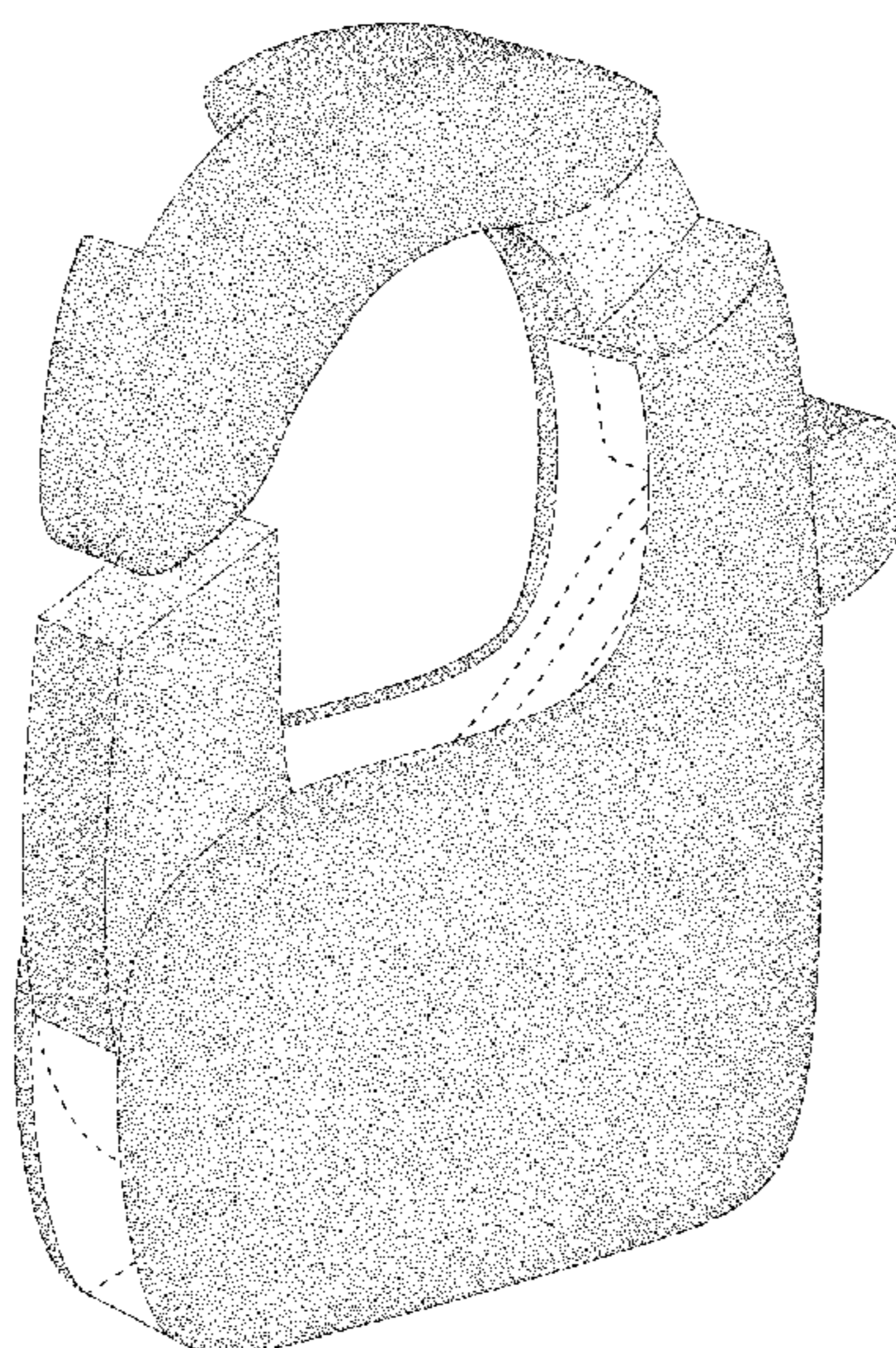
FIG. 1 is a perspective view of the new design for a clasp for jewelry item.

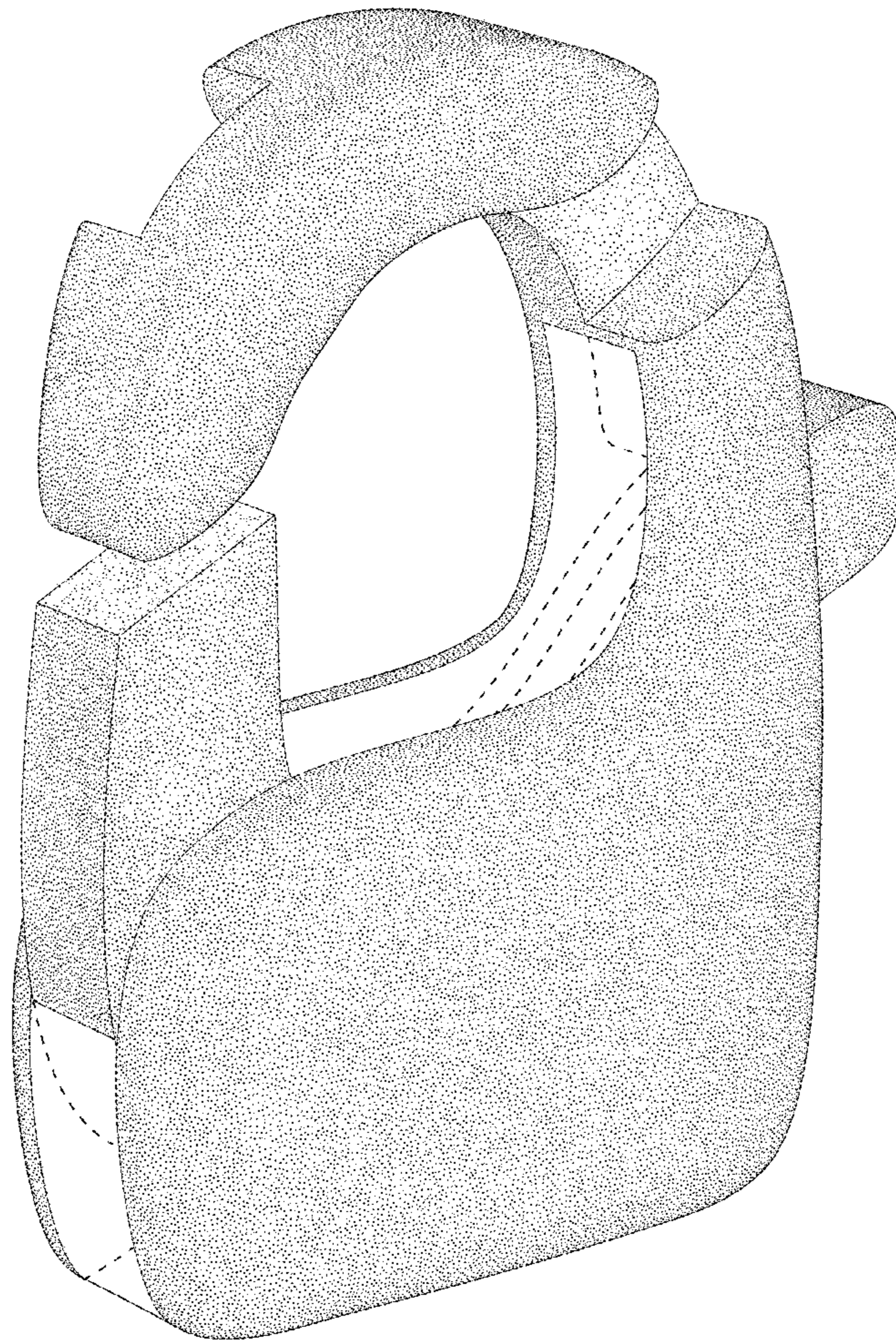

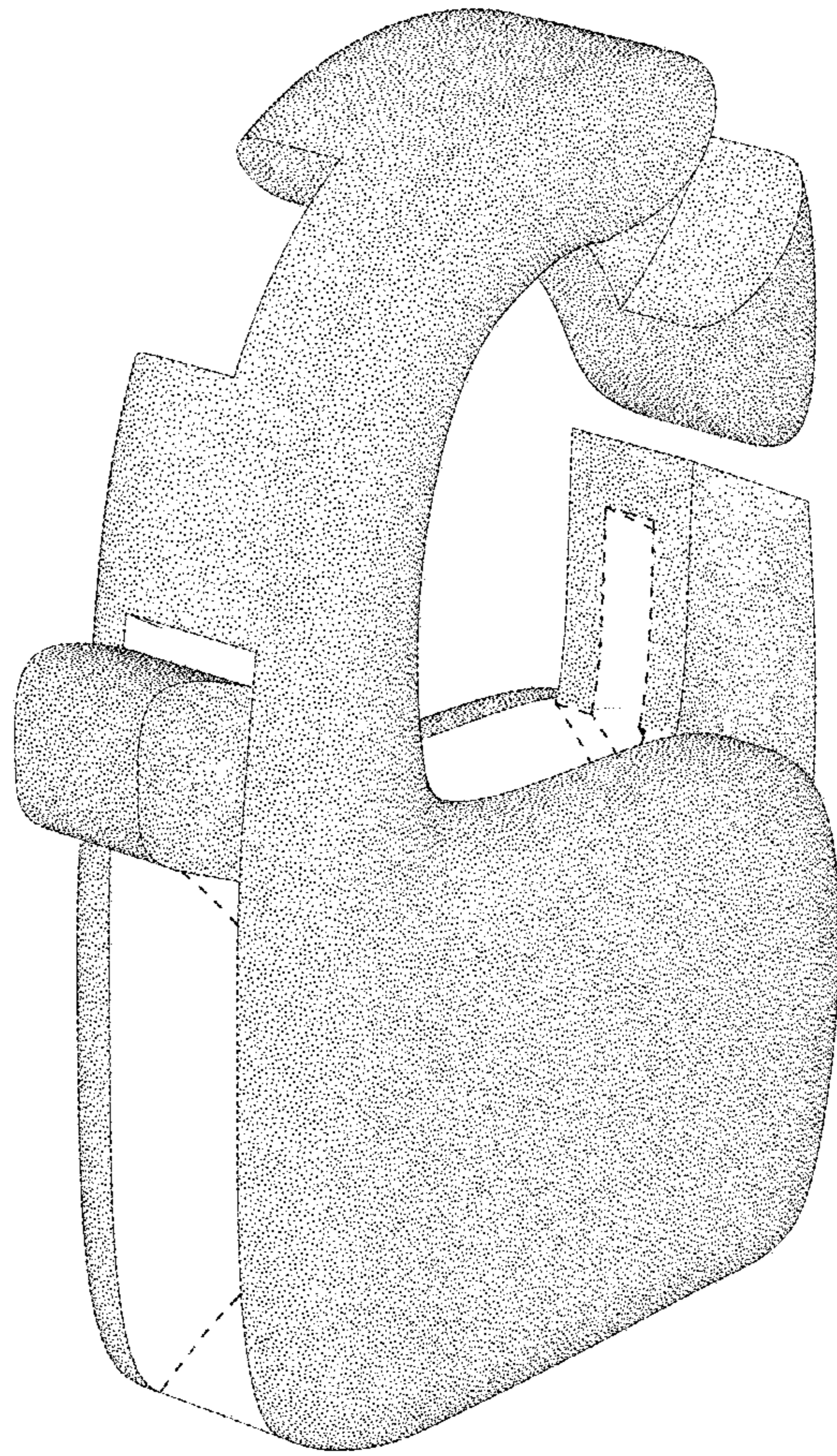

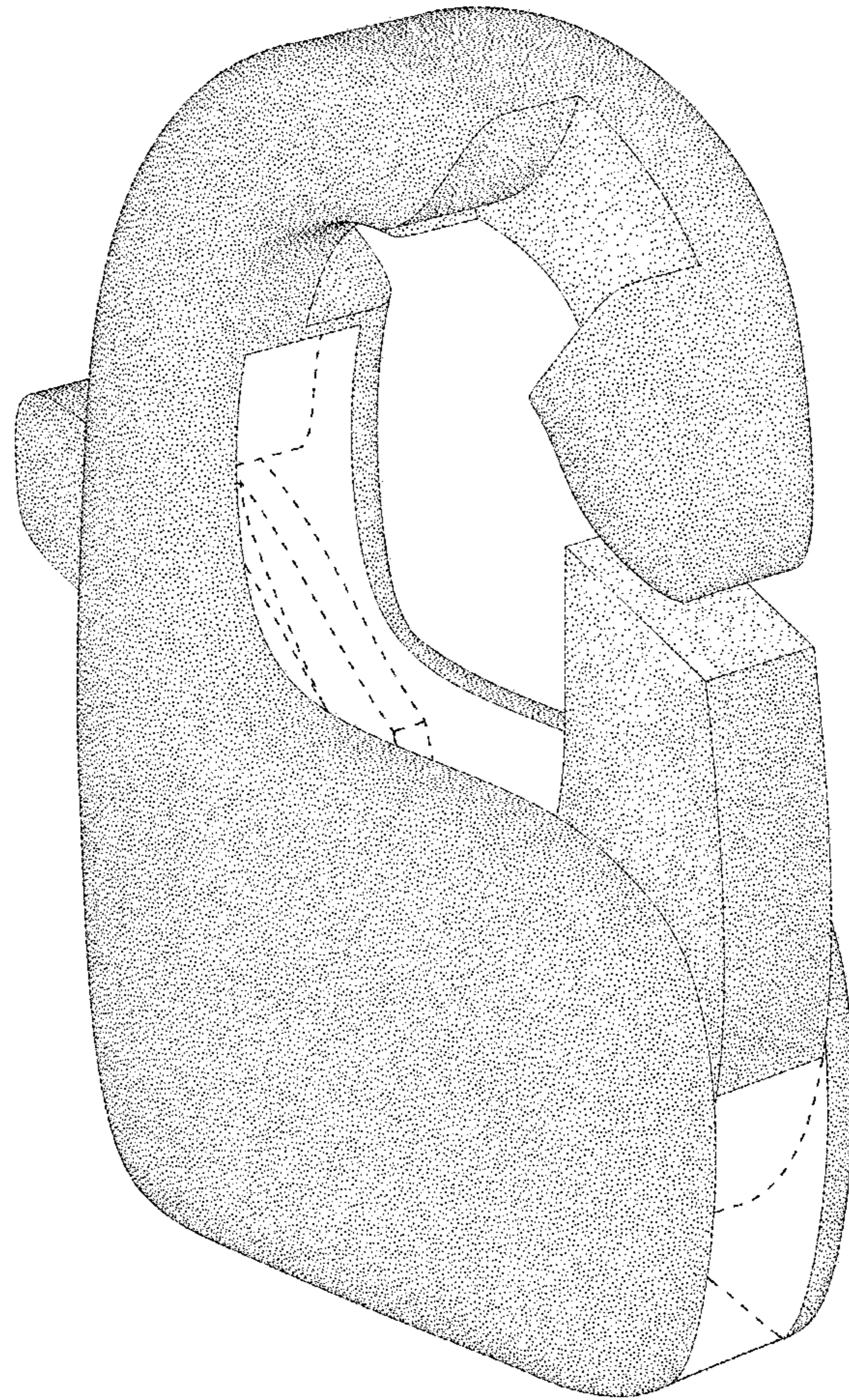

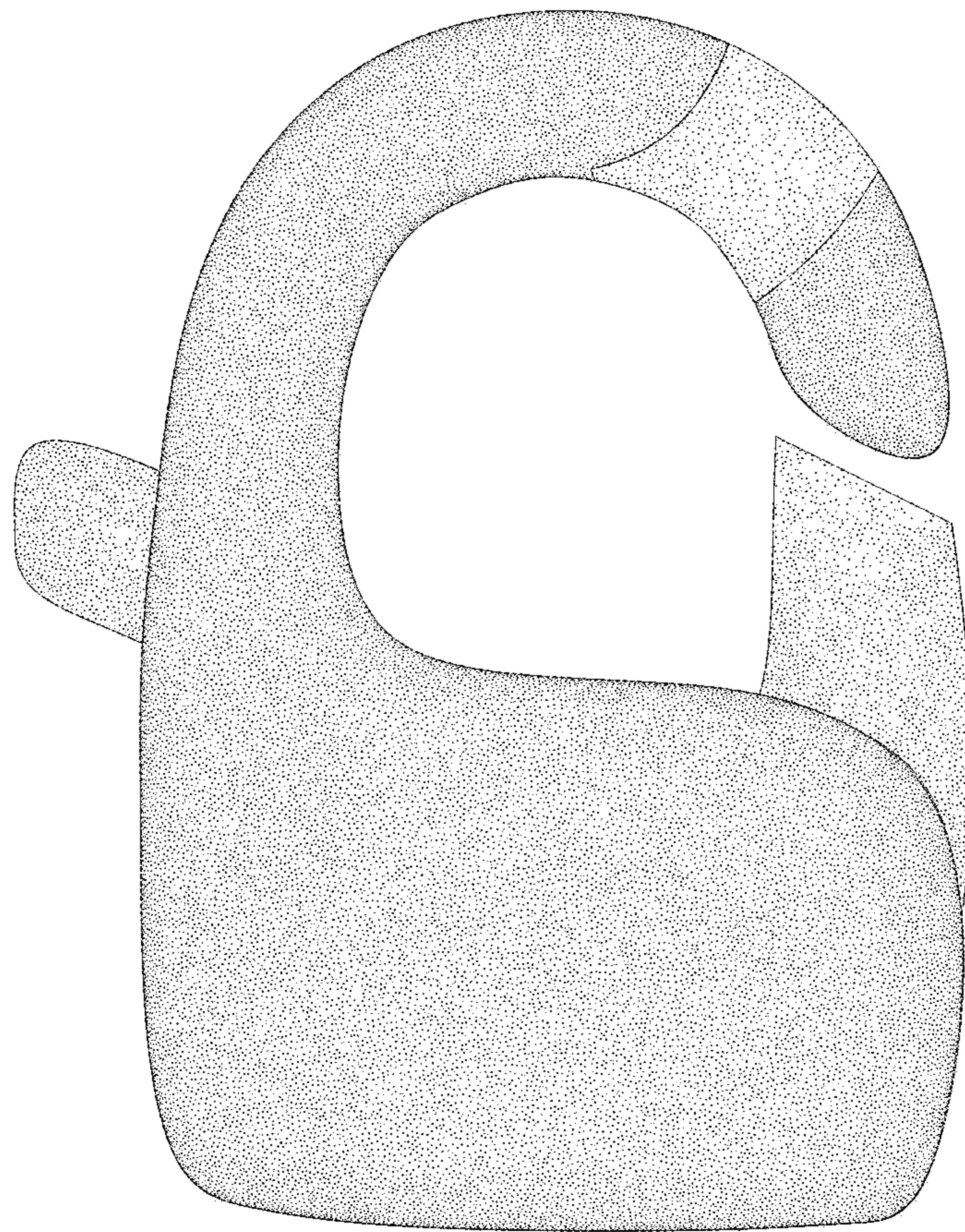

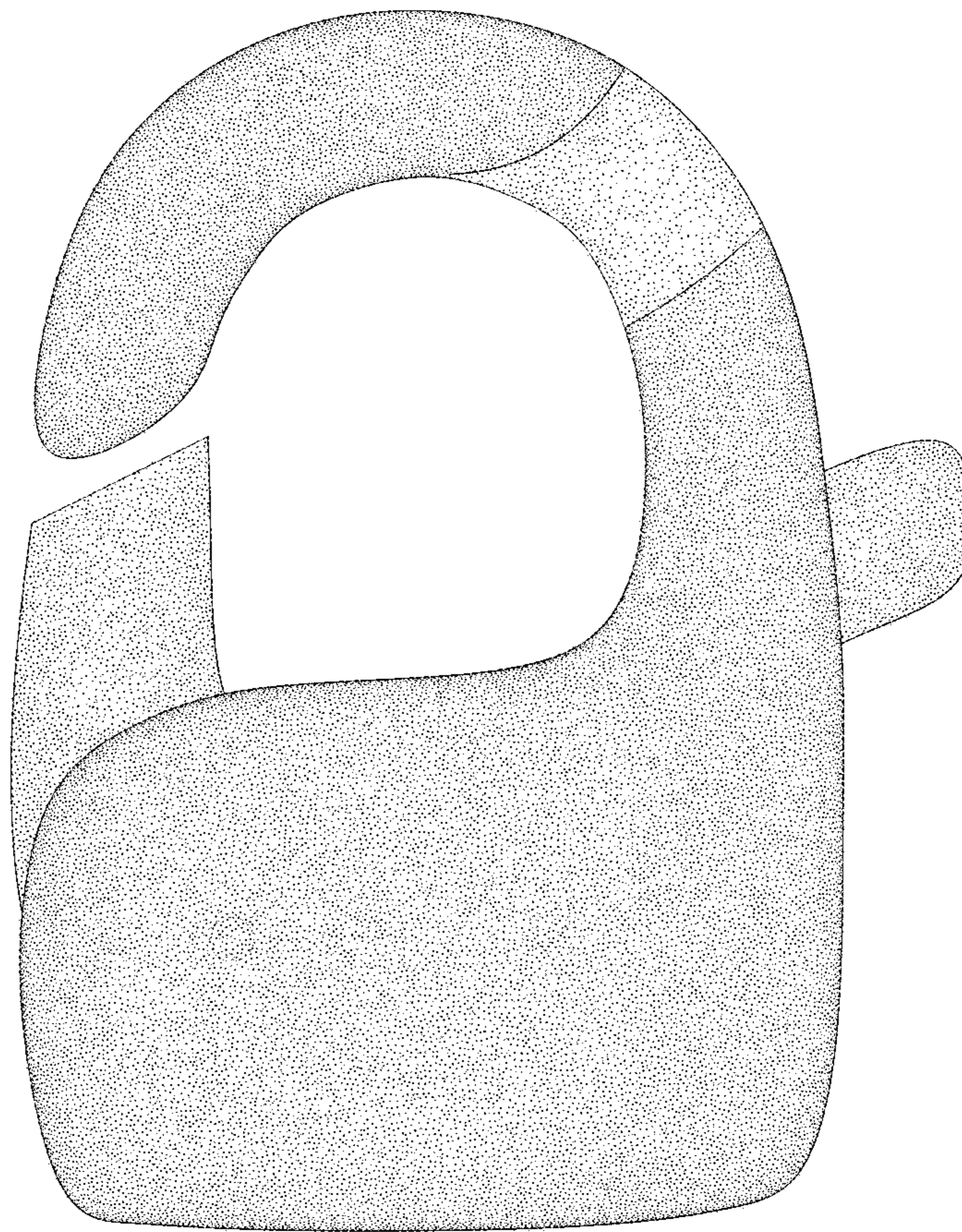

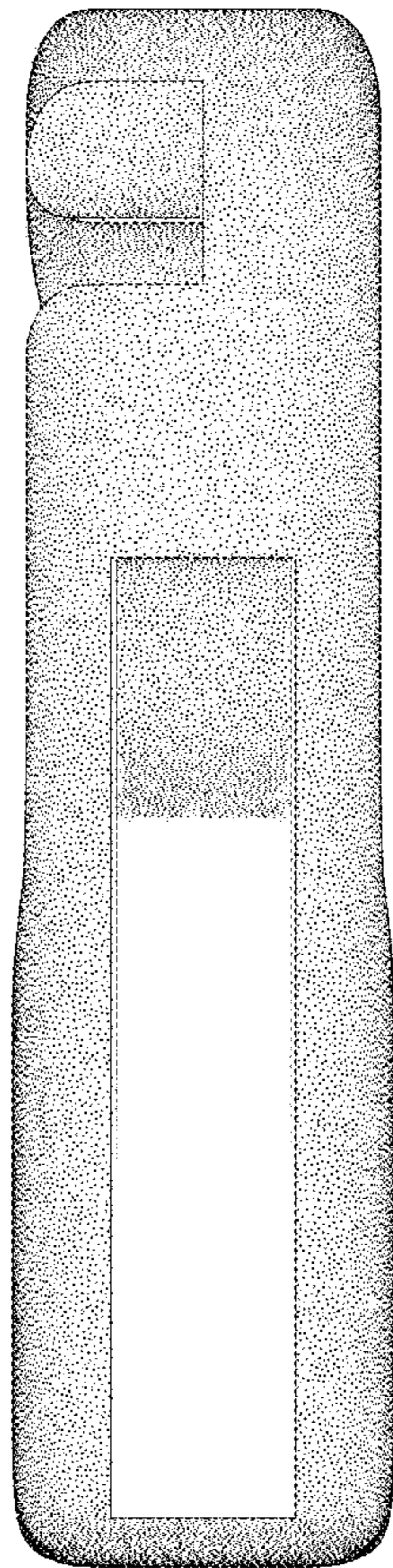

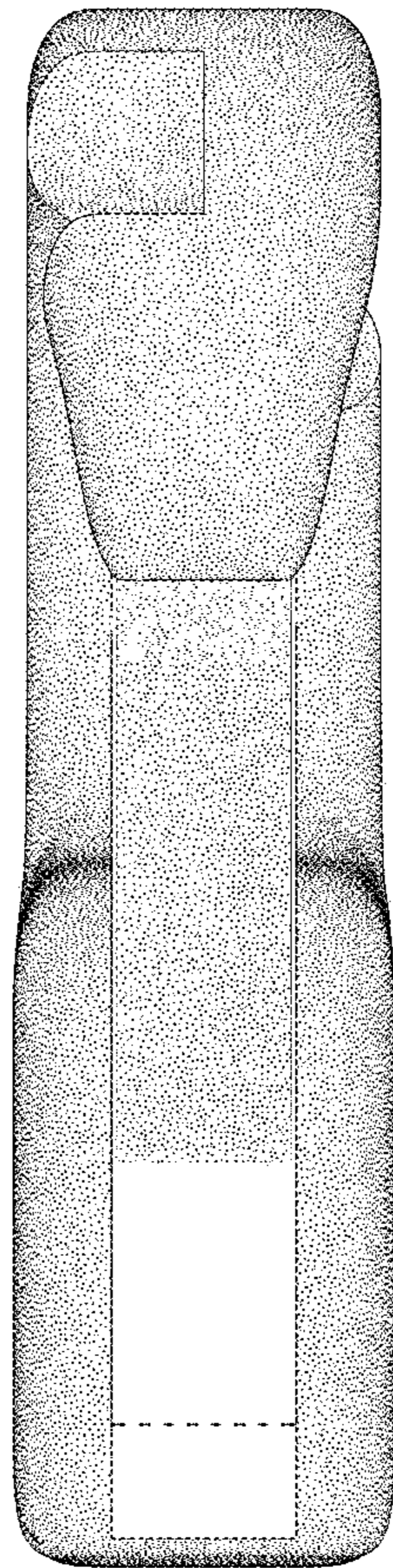

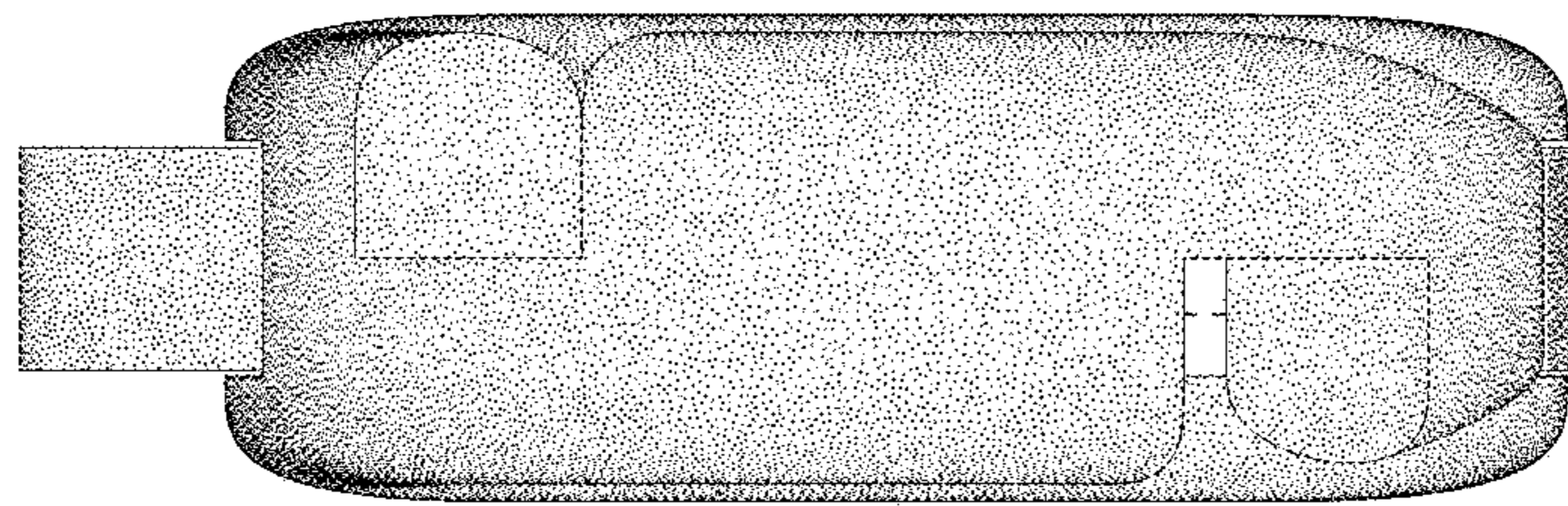

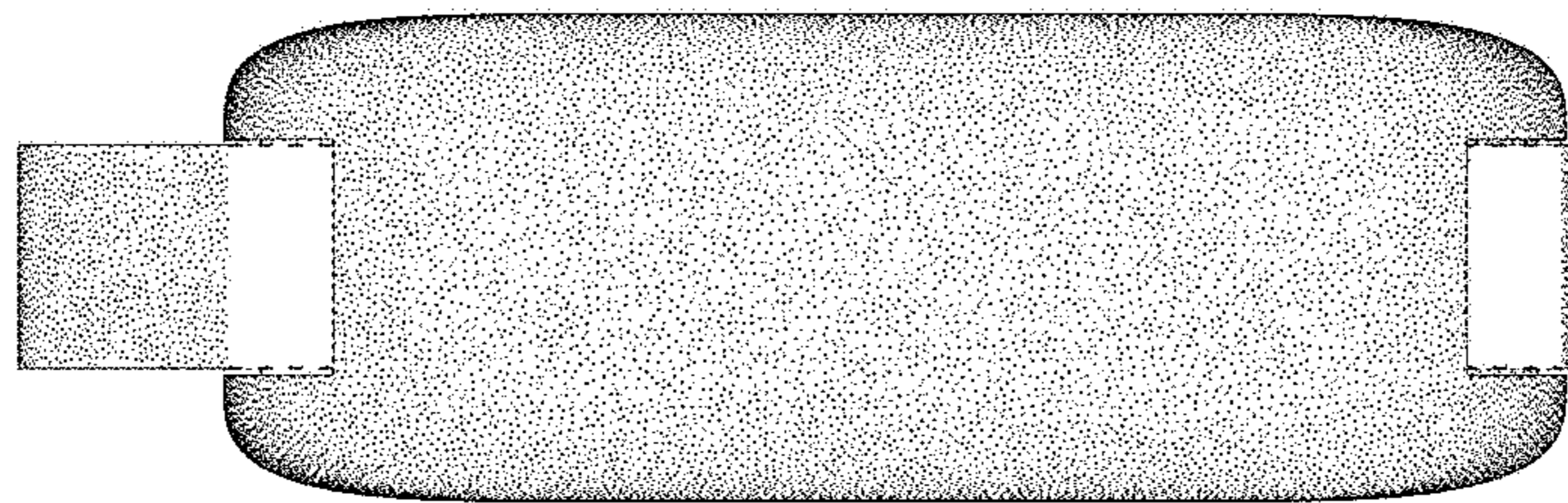
