(57) **CLAIM**

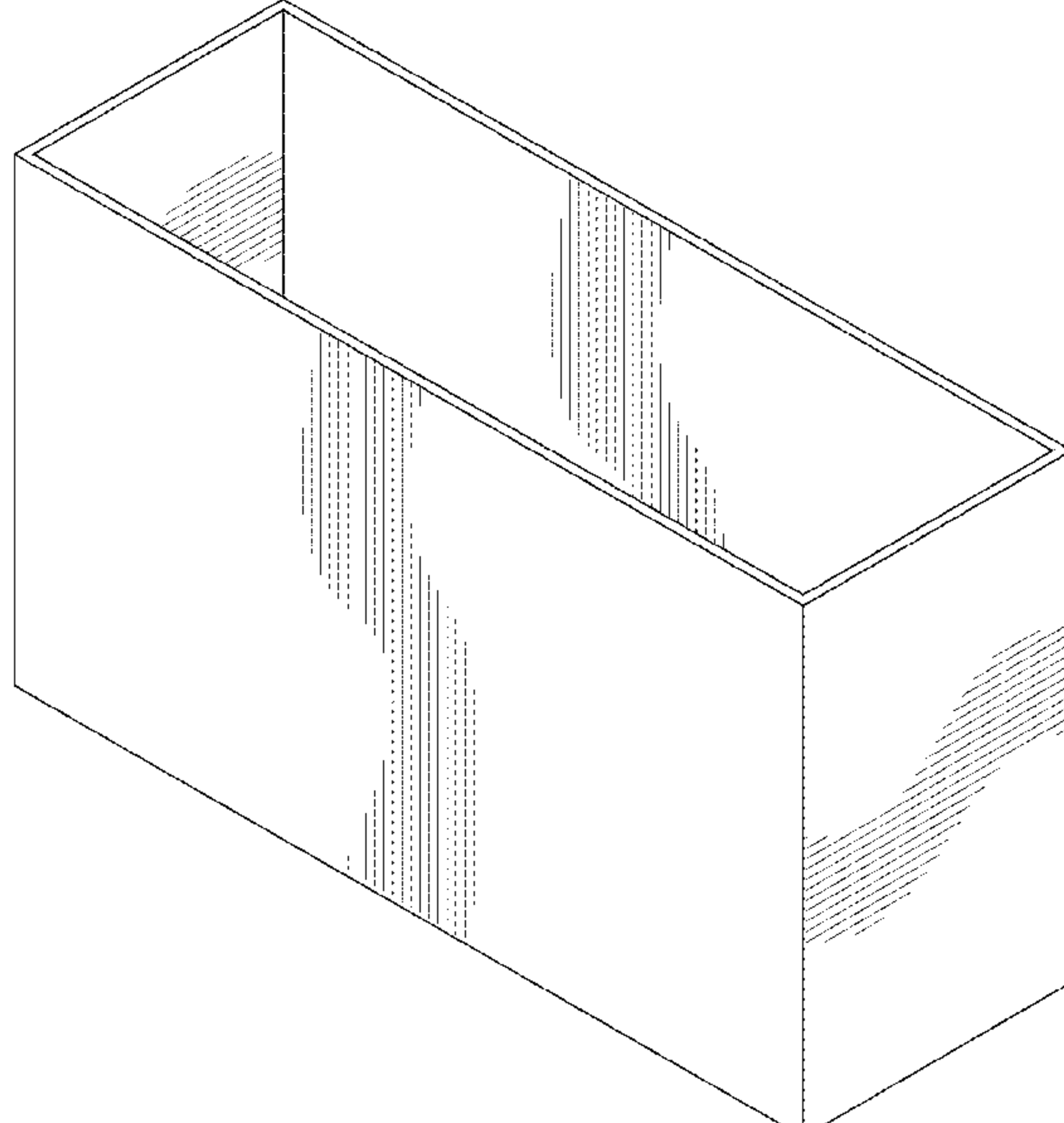
The ornamental design for a vegetation container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vegetation container showing our new design;
FIG. 2 is a top view of the vegetation container;
FIG. 3 is a front view of the vegetation container;
FIG. 4 is a cross-section front view of the vegetation container taken along the lines 4-4 of FIG. 2;
FIG. 5 is a side view of the vegetation container;
FIG. 6 is a cross-section side view of the vegetation container taken along the lines 6-6 of FIG. 2; and,
FIG. 7 is a bottom view of the vegetation container.

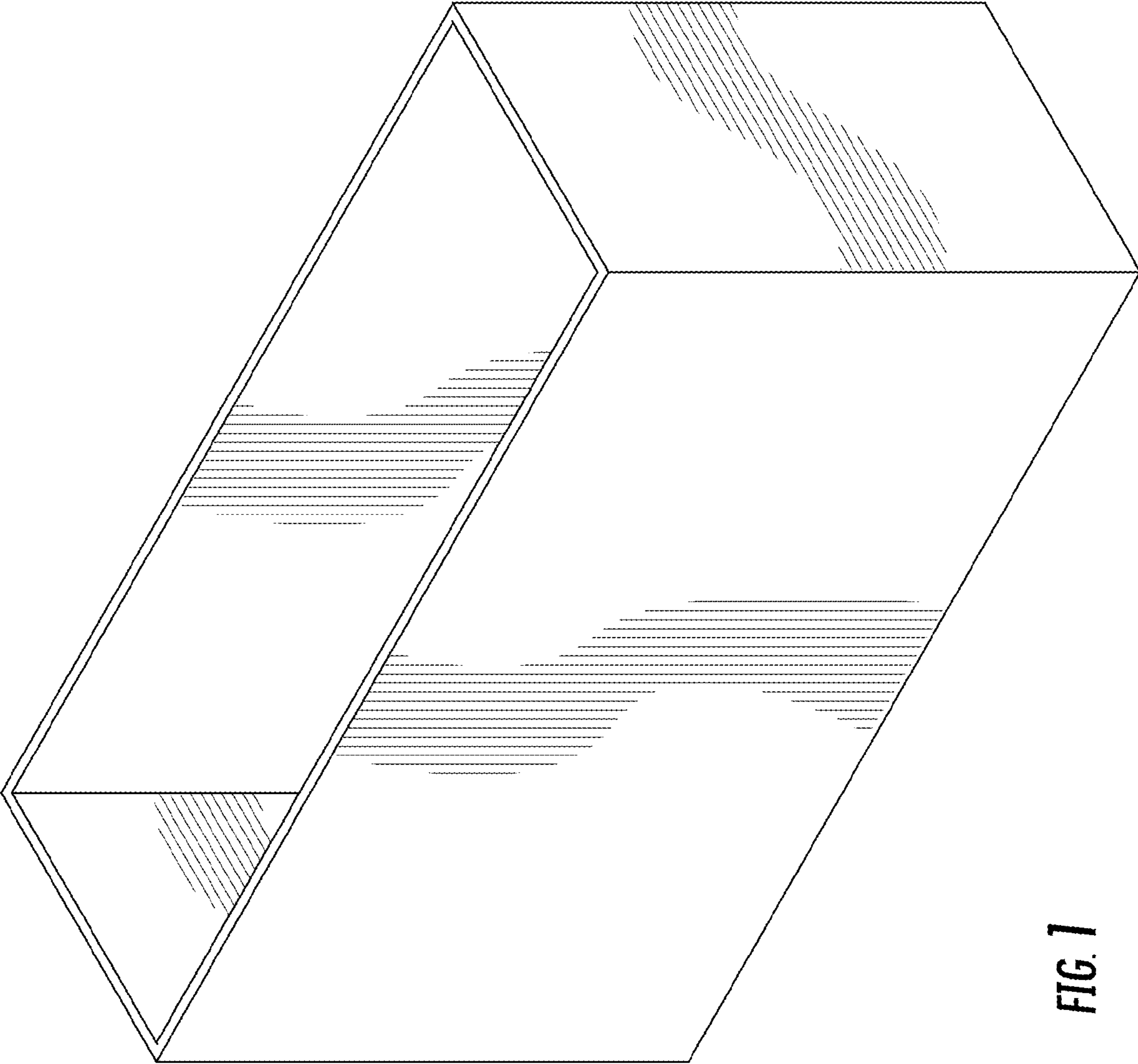

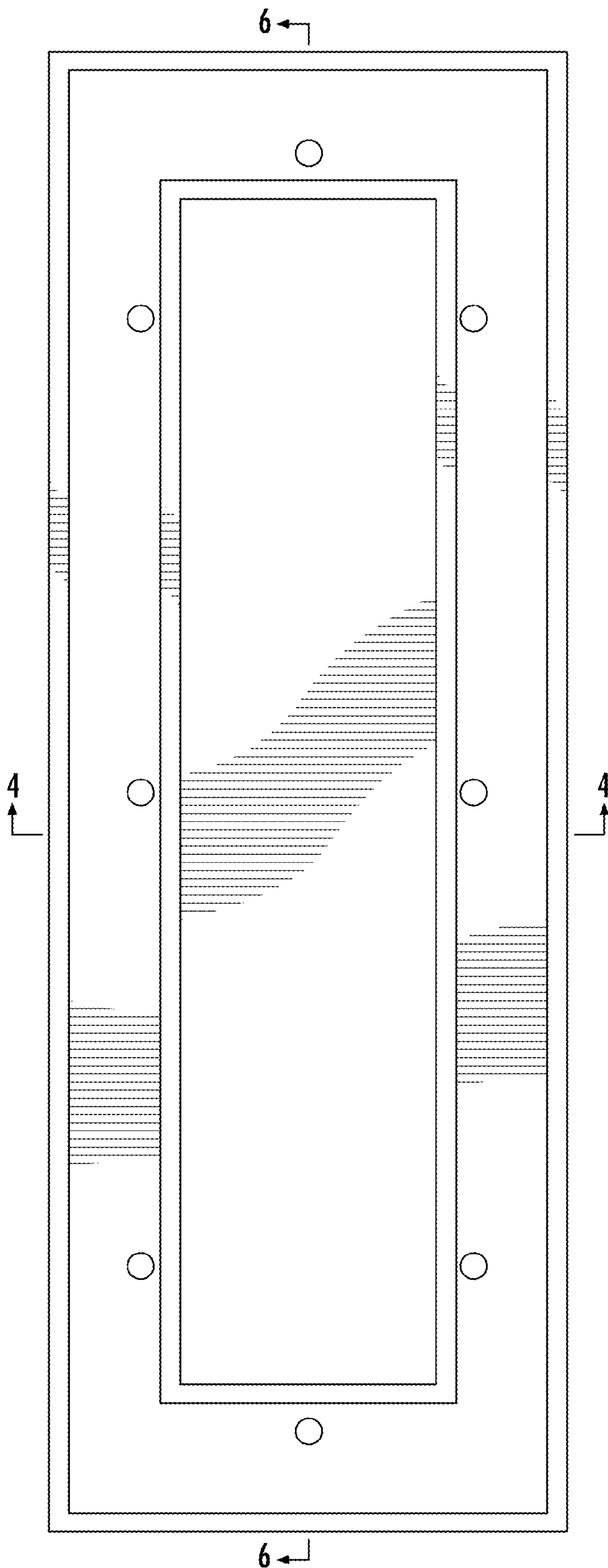

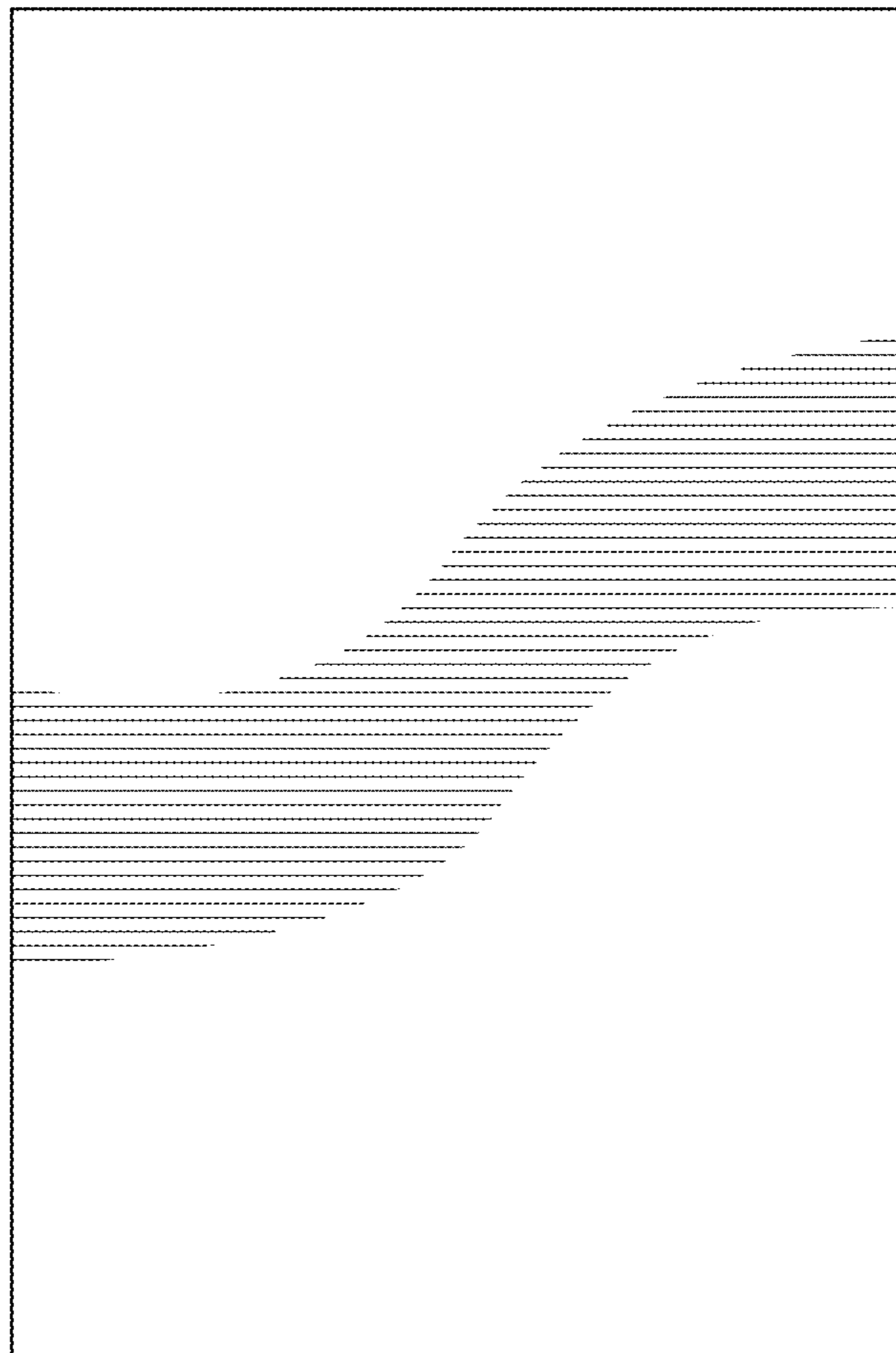

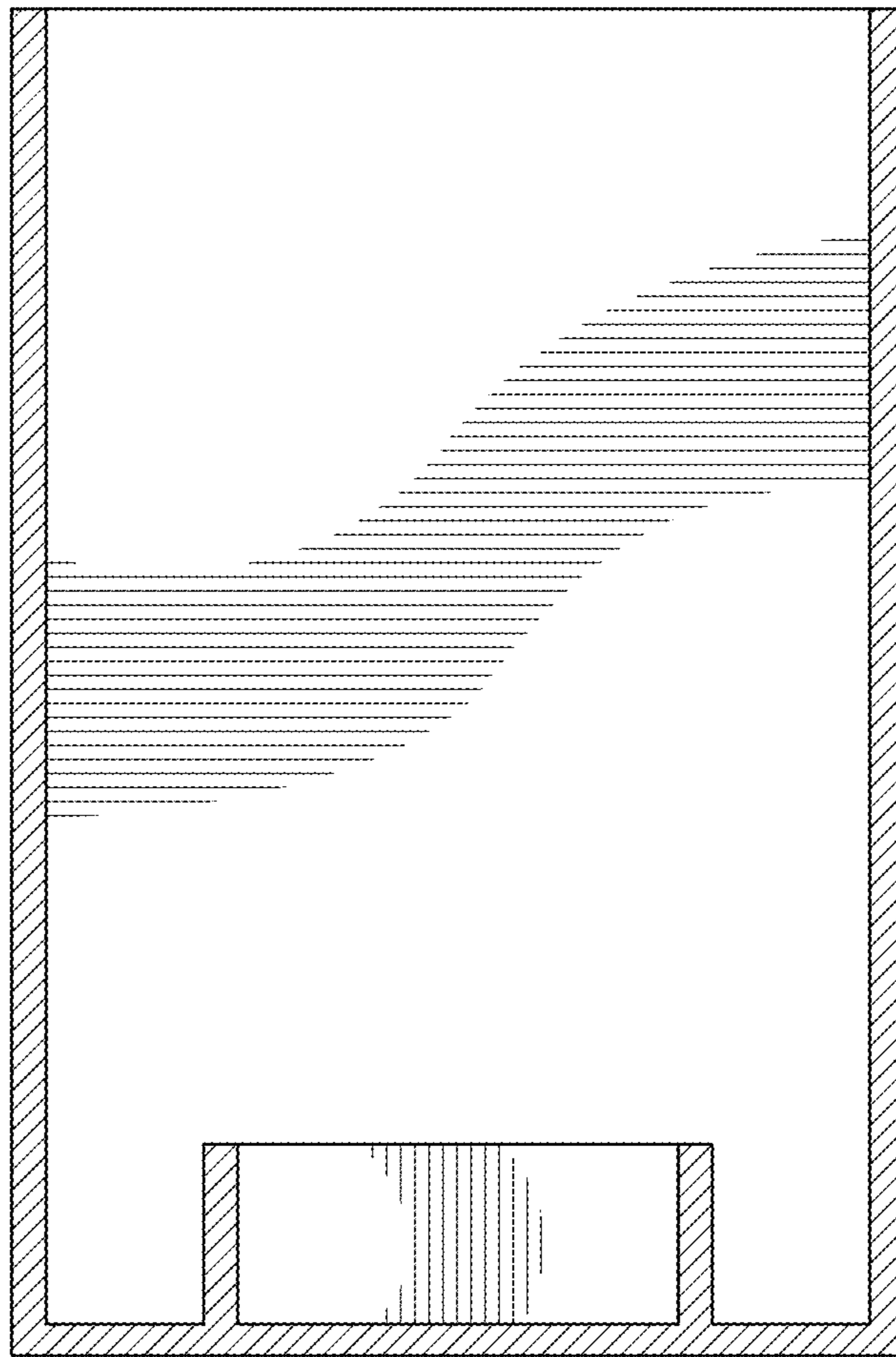

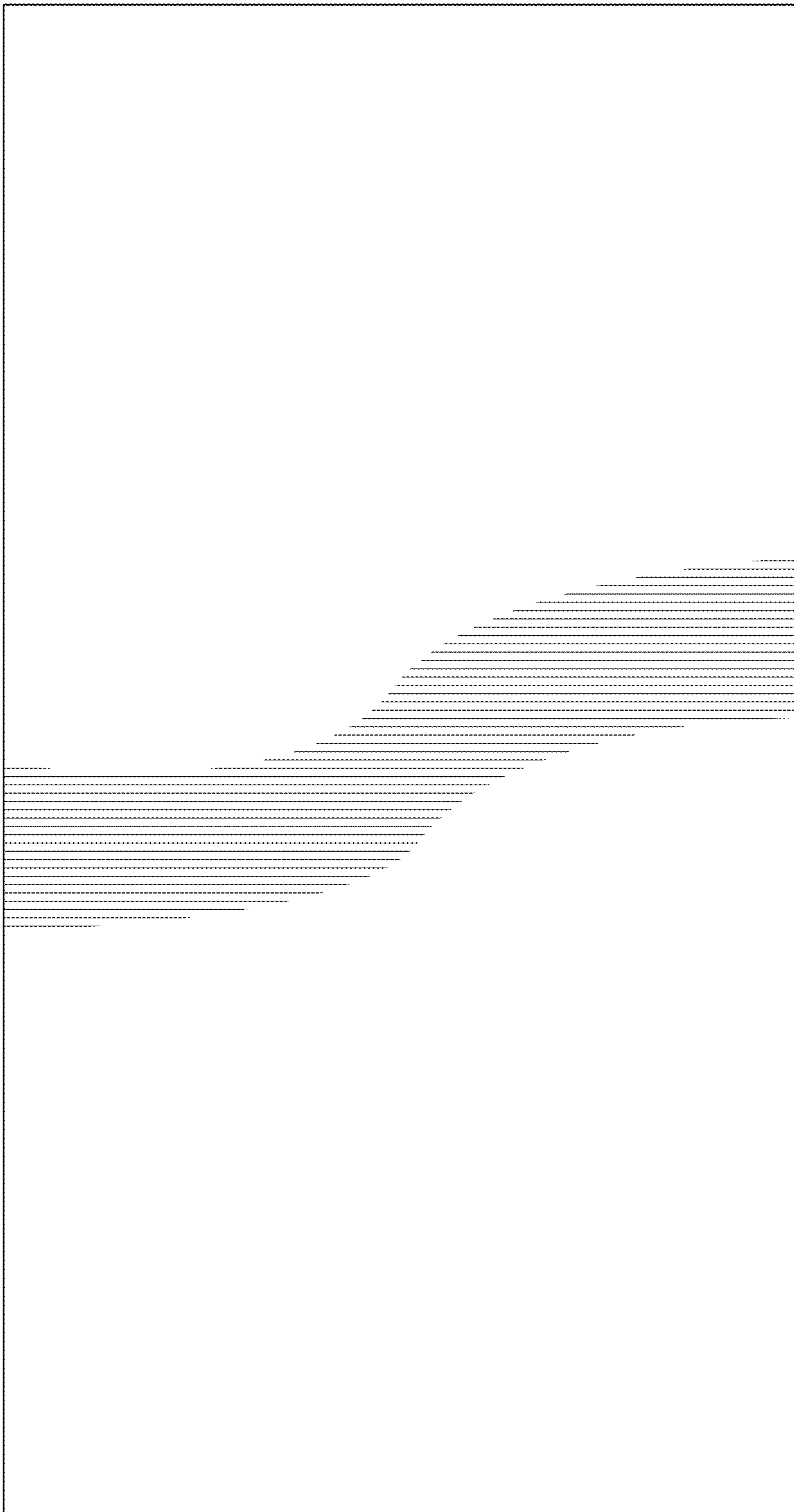

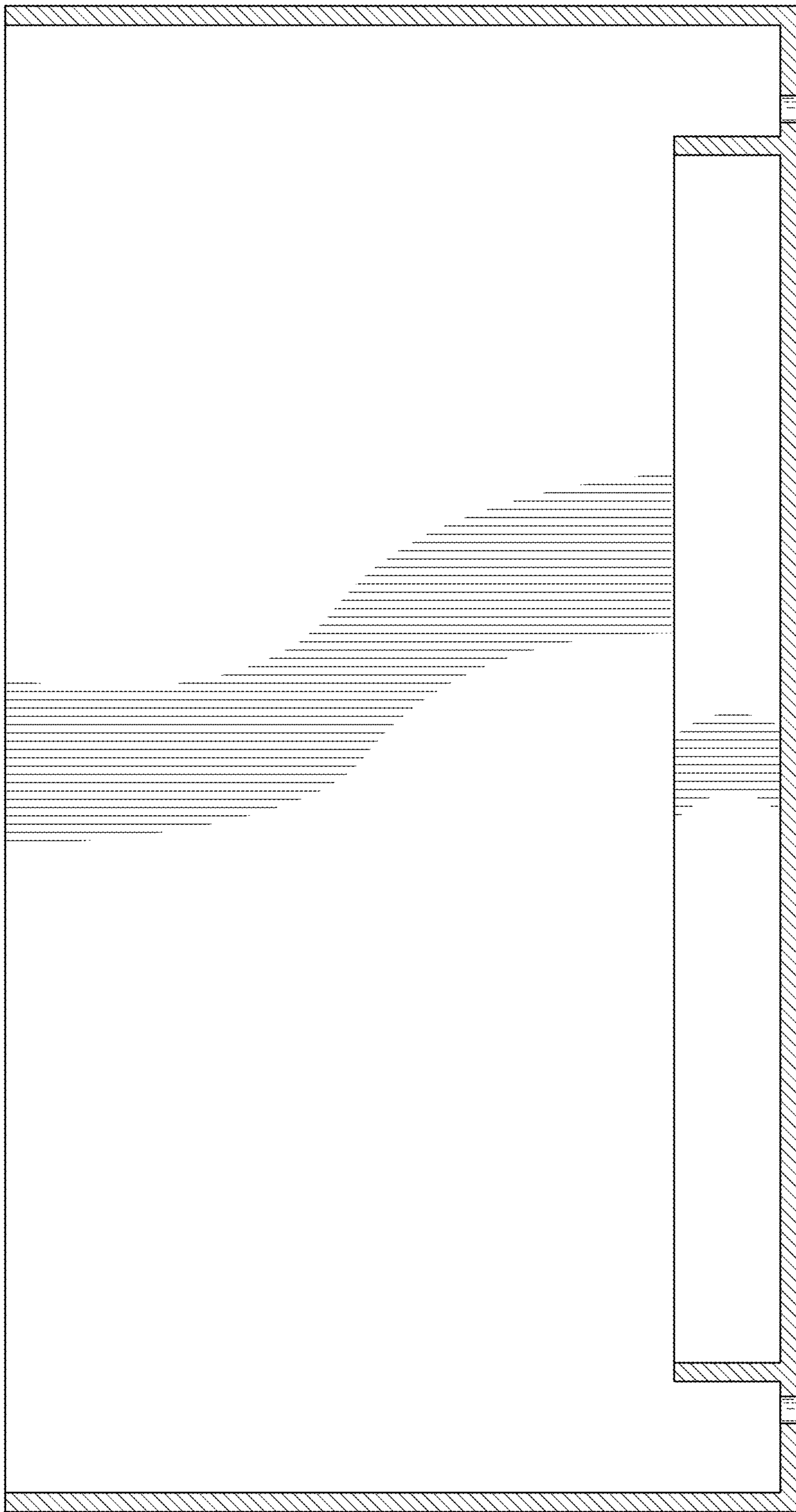

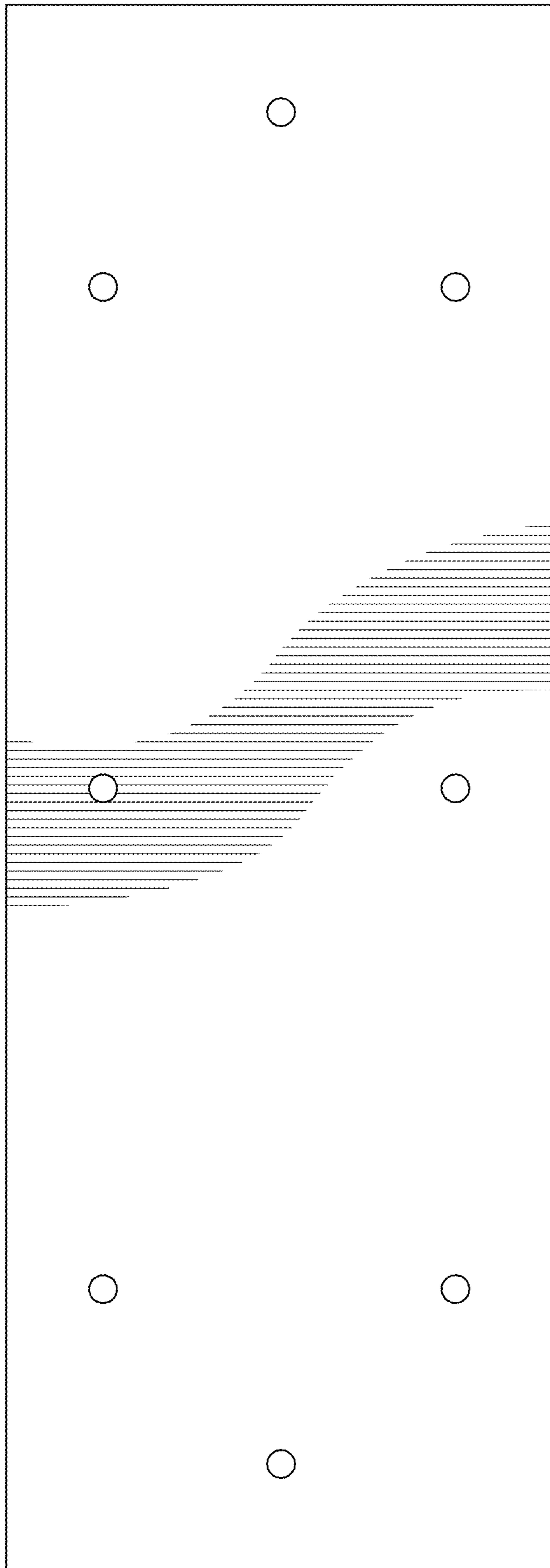
