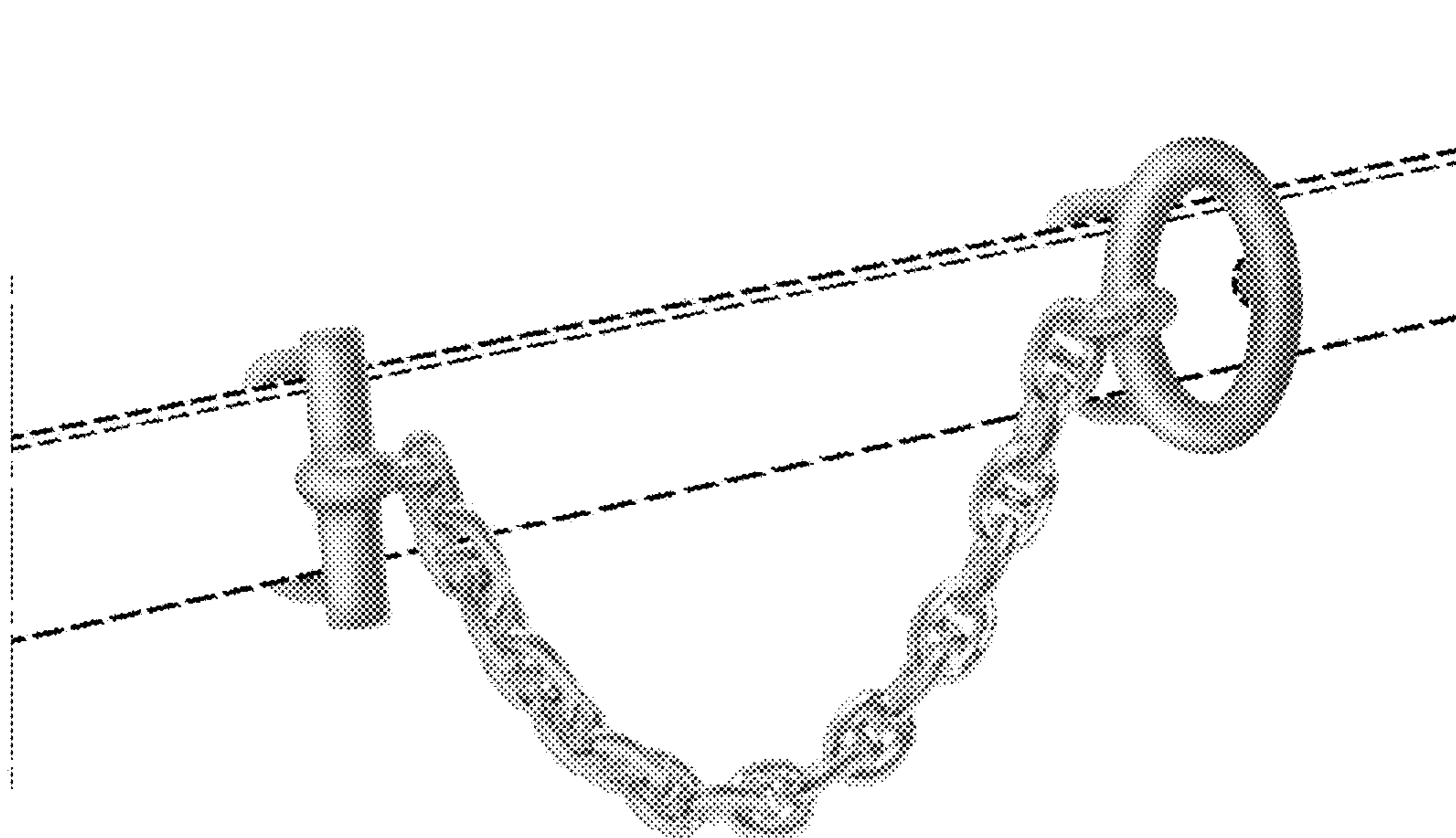
The ornamental design for belt buckle, as shown and described.

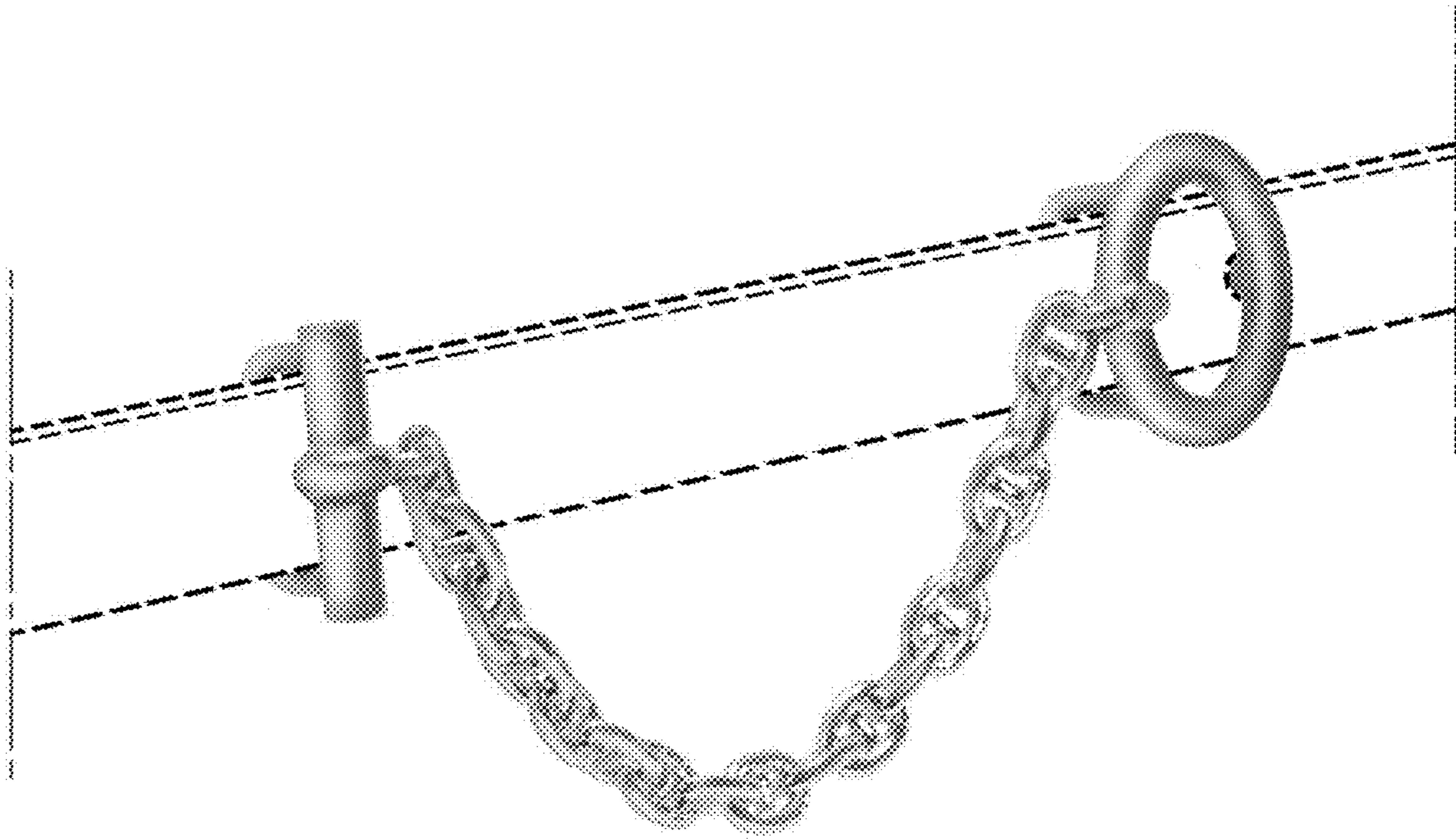
- 1. Belt buckle

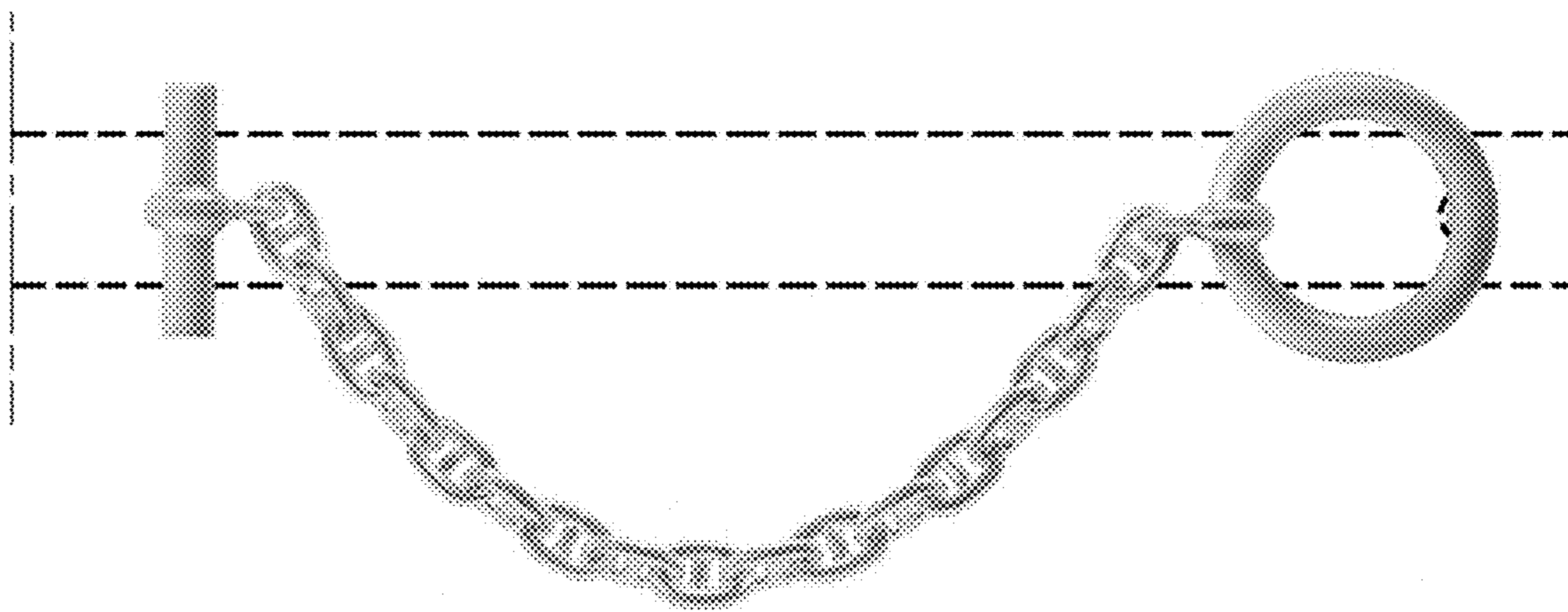

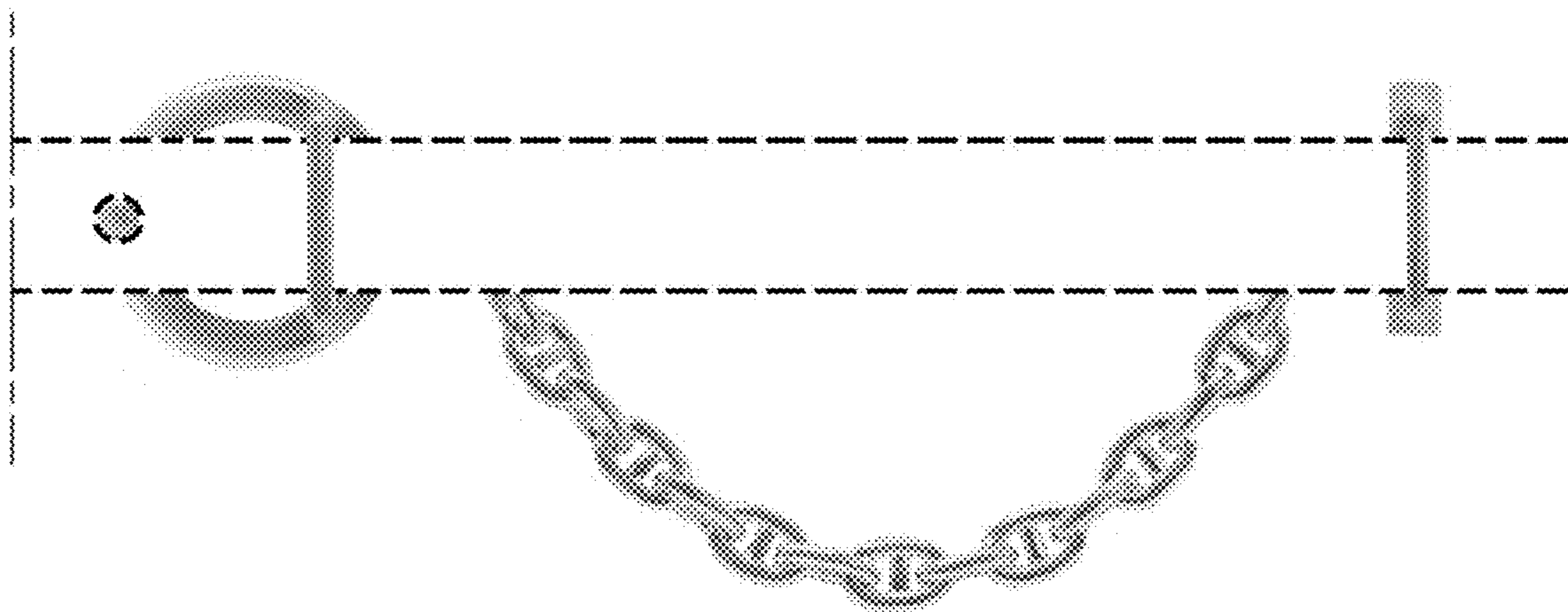

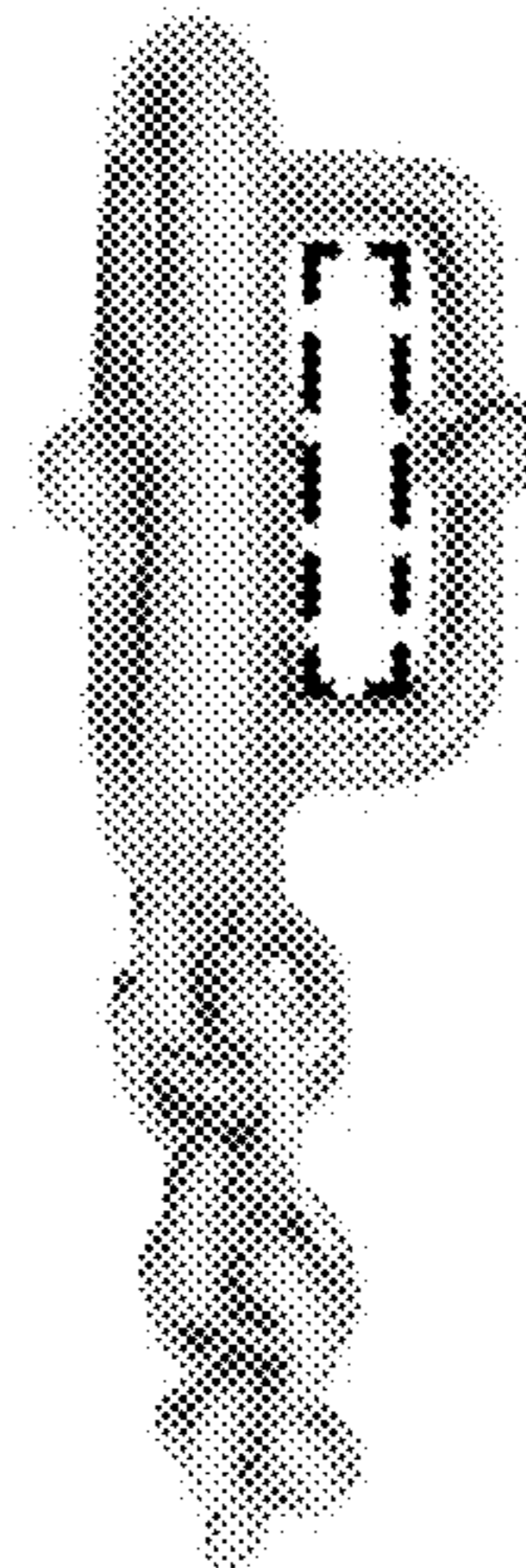

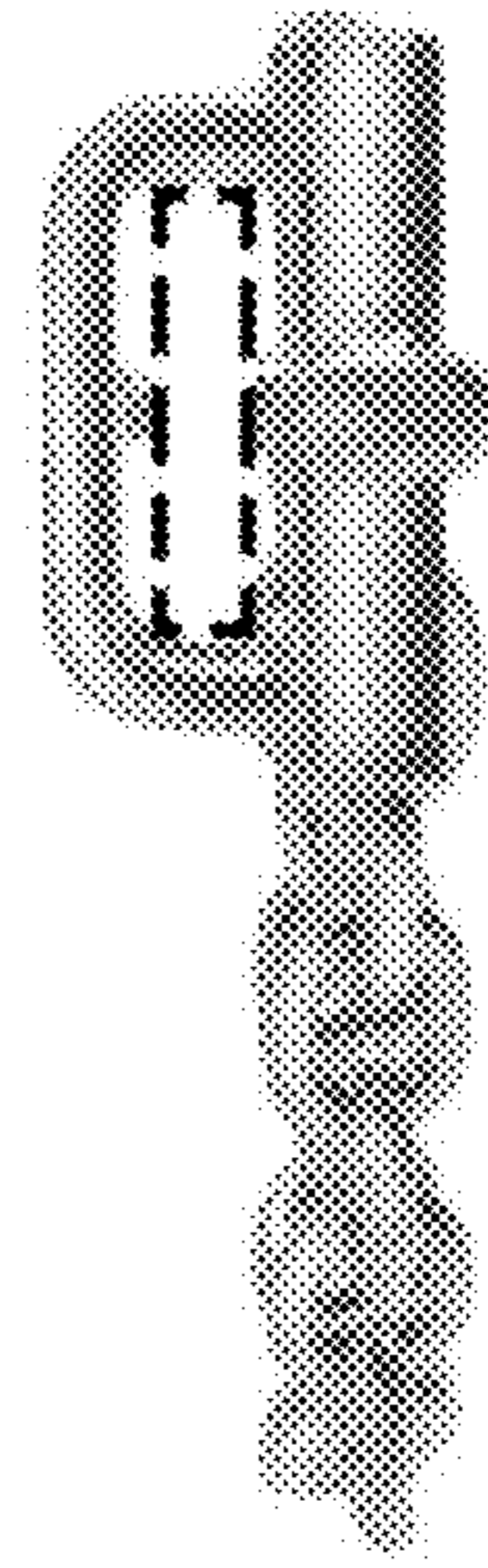

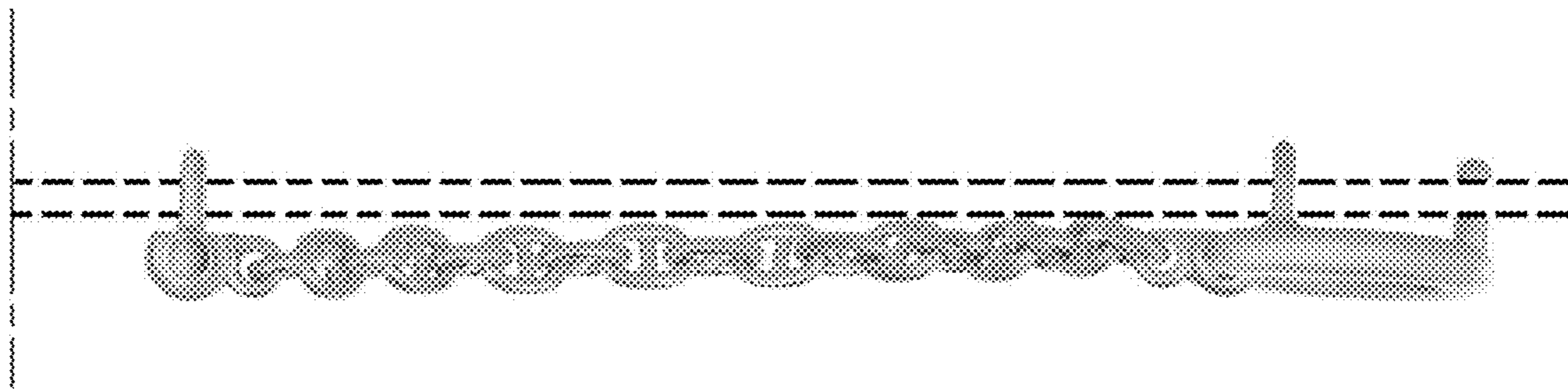
