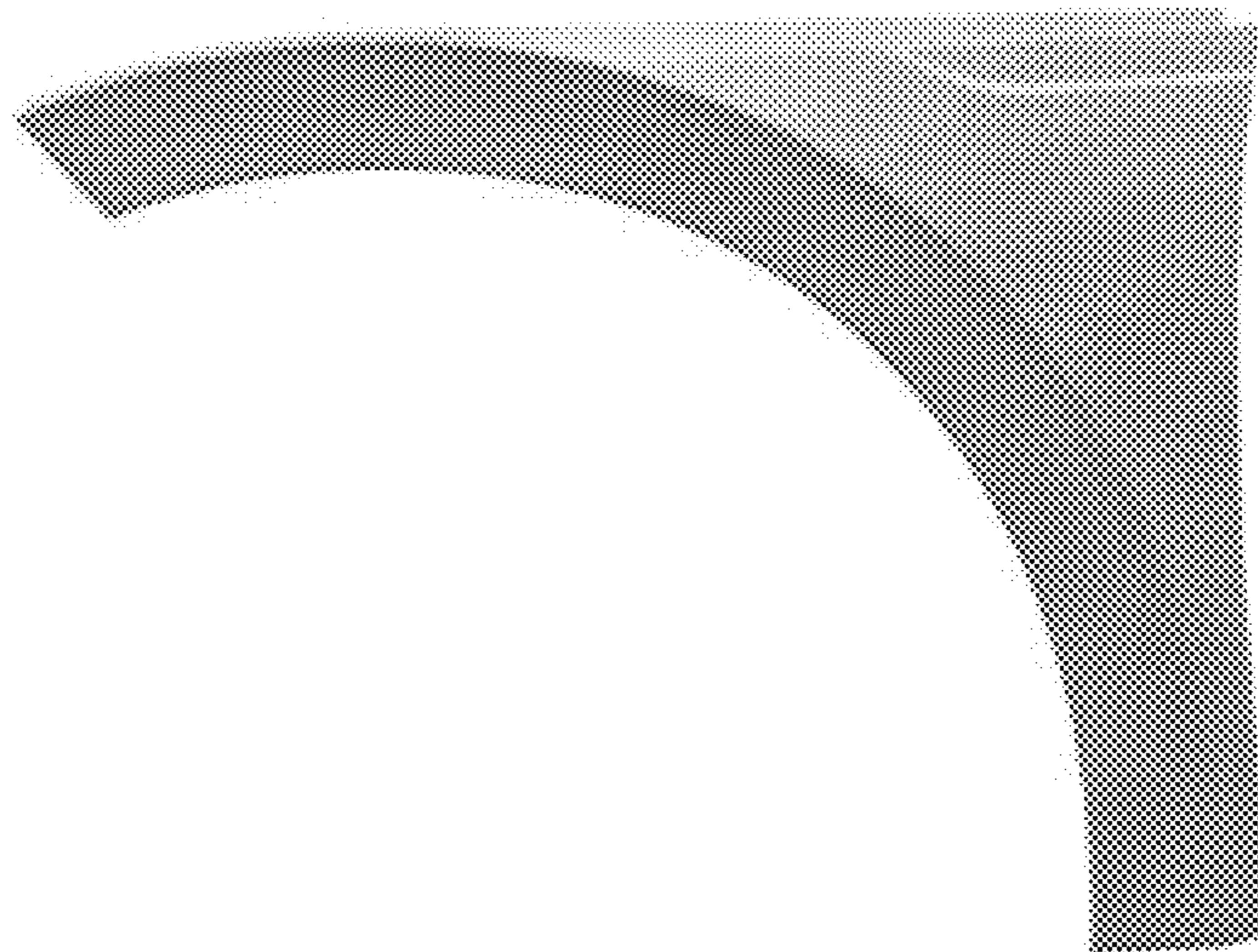
(57) **CLAIM**

The ornamental design for a vehicle fender, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a first embodiment of the vehicle fender of the present invention; FIG. 2 is a front and right side perspective view thereof; FIG. 3 is a rear and left side perspective view thereof; FIG. 4 is a rear and left side perspective view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a front view thereof; FIG. 7 is a left side view thereof; FIG. 8 is a right side view thereof; FIG. 9 is a bottom view thereof; FIG. 10 is a top view thereof; FIG. 11 is a front and right side perspective view of a second embodiment of the vehicle fender of the present invention, the second embodiment being a mirror image of the first embodiment; FIG. 12 is a front and left side perspective view thereof; FIG. 13 is a rear and right side perspective view thereof; FIG. 14 is a rear and right side perspective view thereof; FIG. 15 is a rear view thereof; FIG. 16 is a front view thereof; FIG. 17 is a left side view thereof; FIG. 18 is a right side view thereof; FIG. 19 is a bottom view thereof; and, FIG. 20 is a top view thereof.

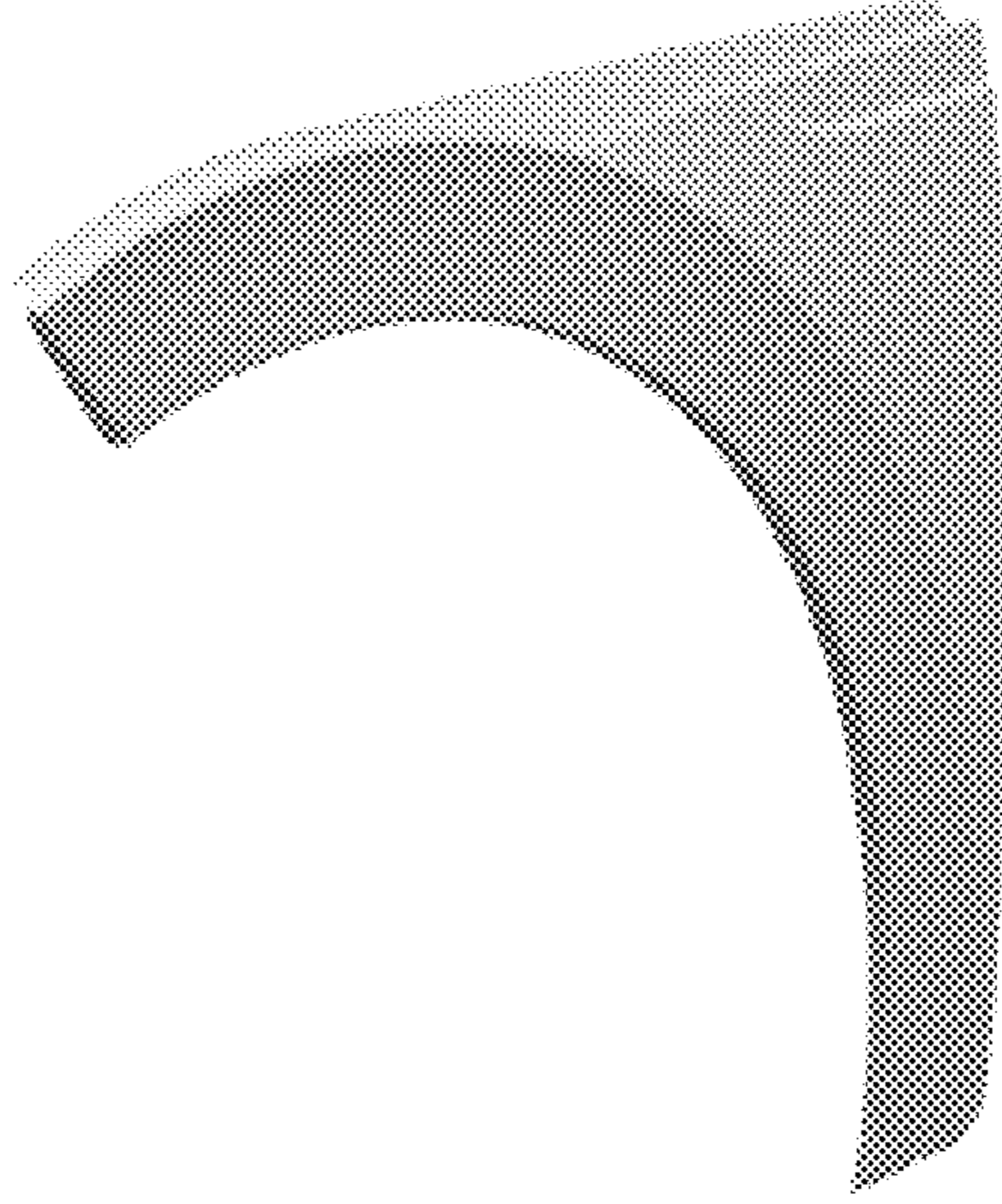

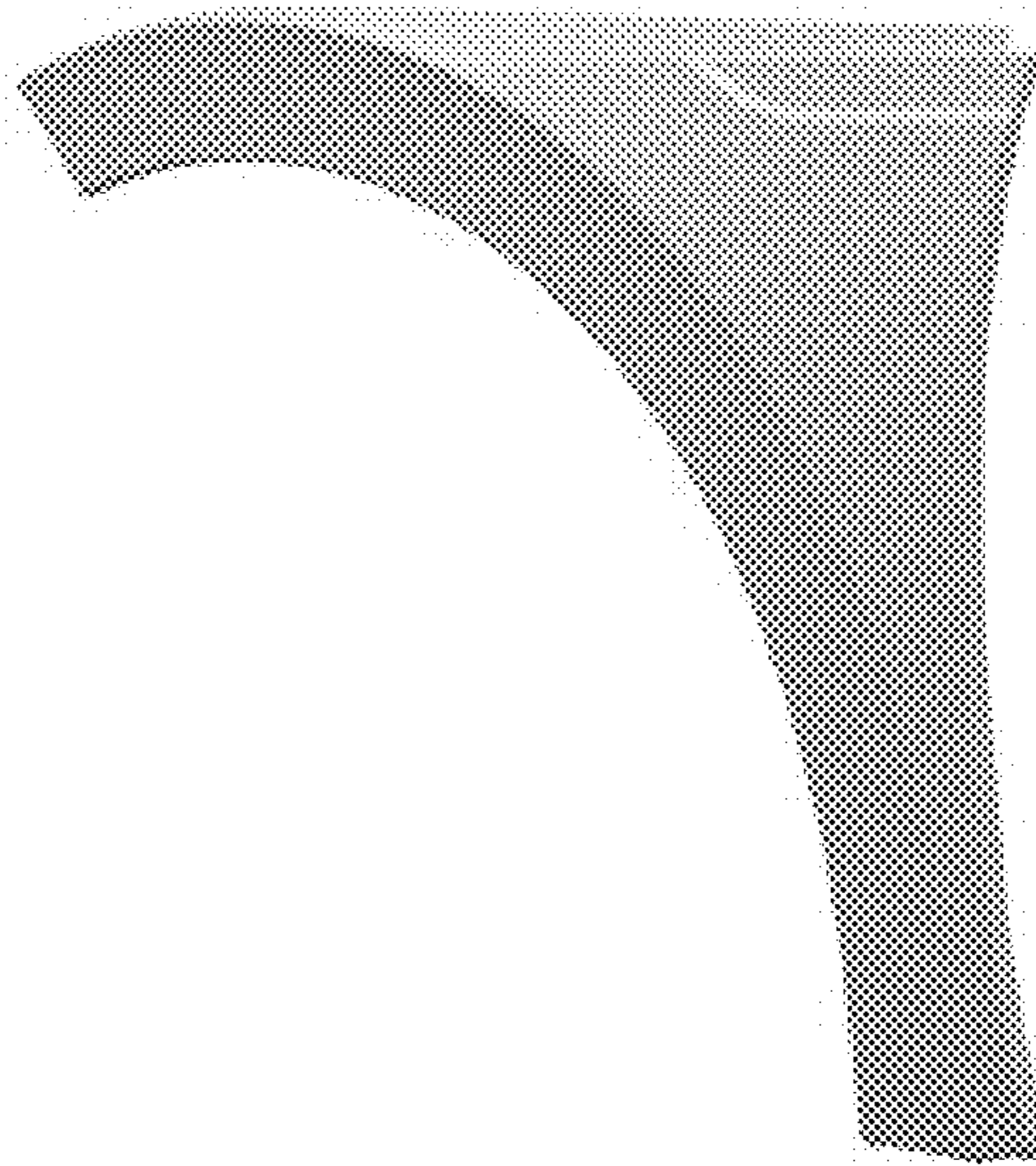

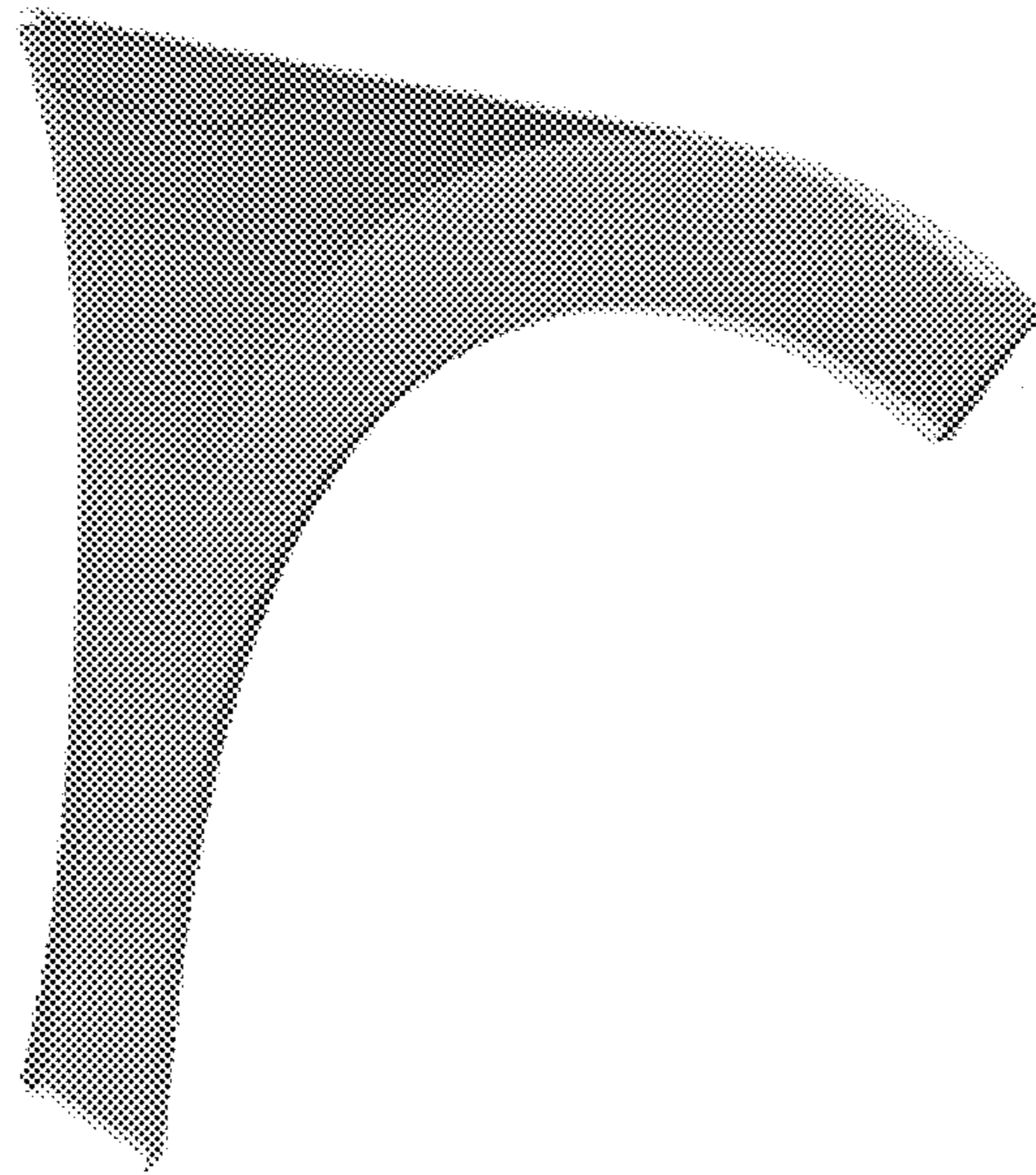

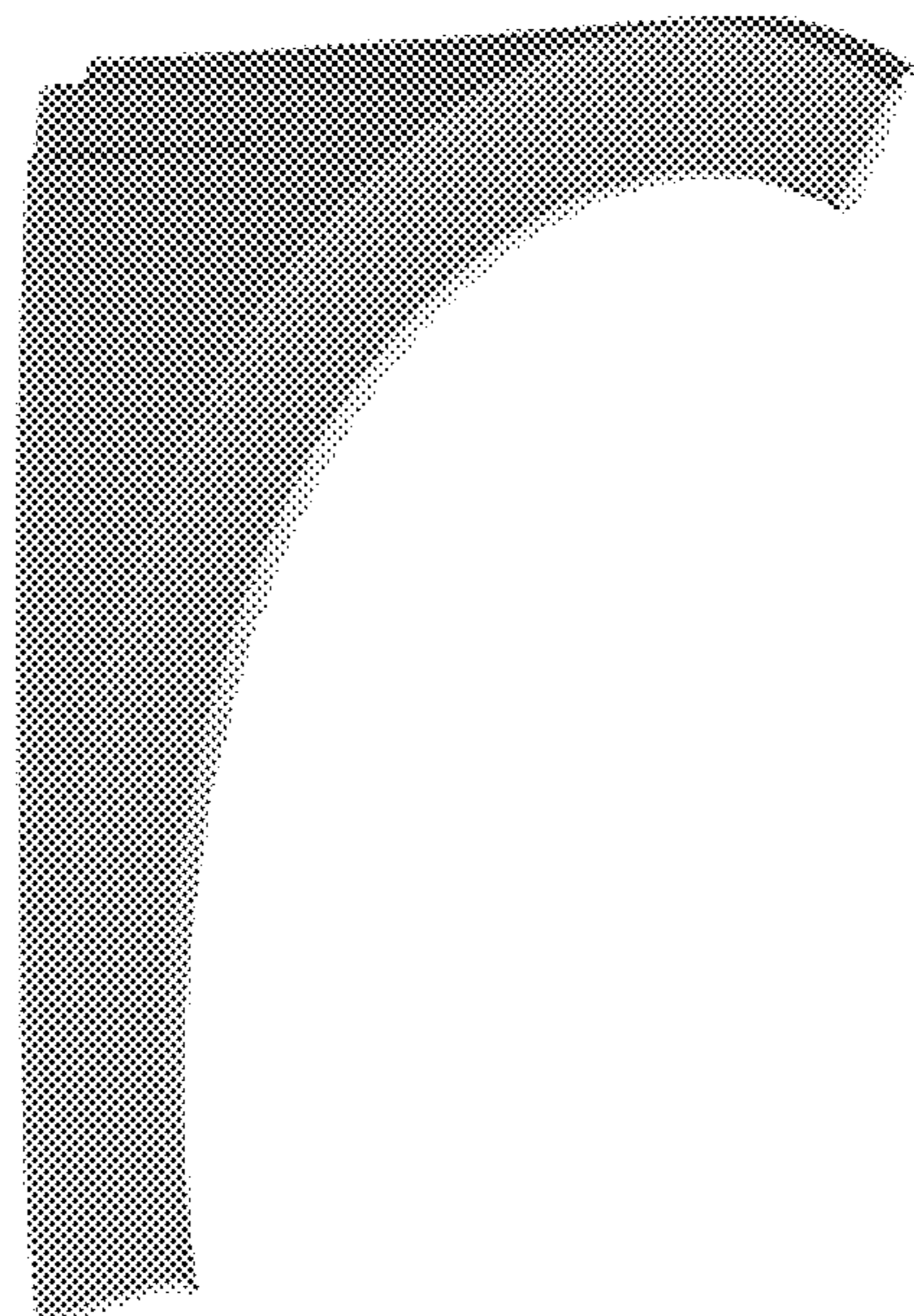

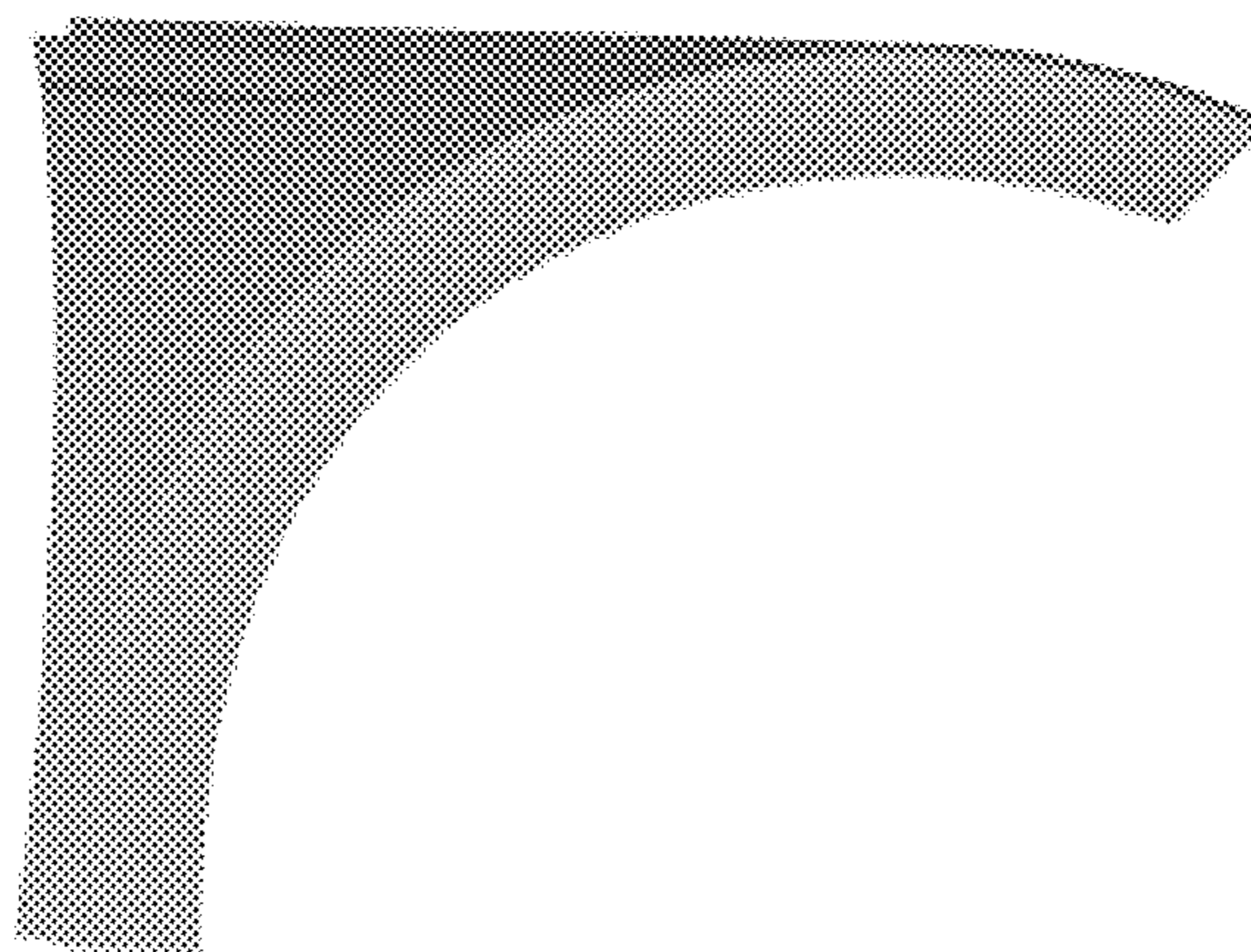

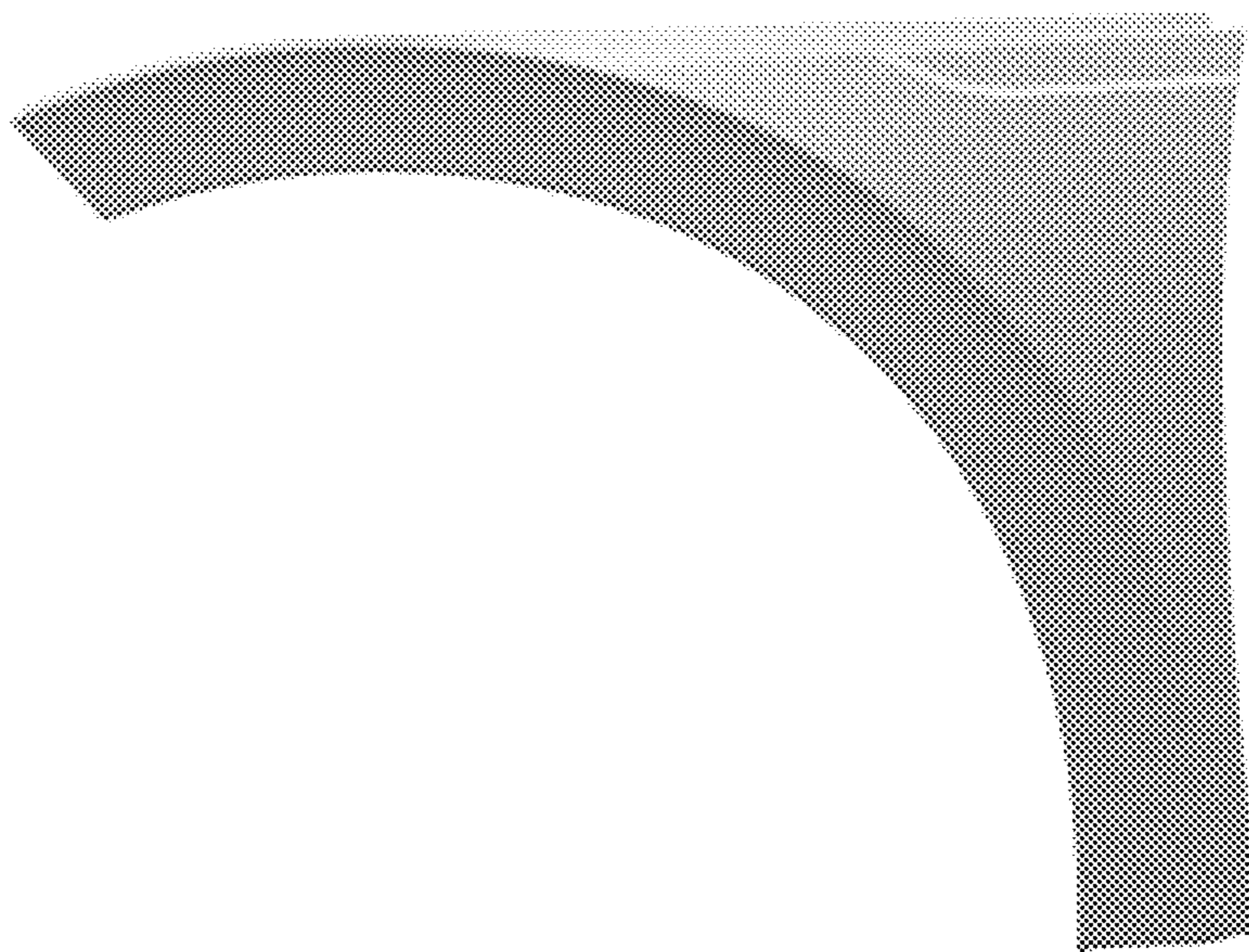

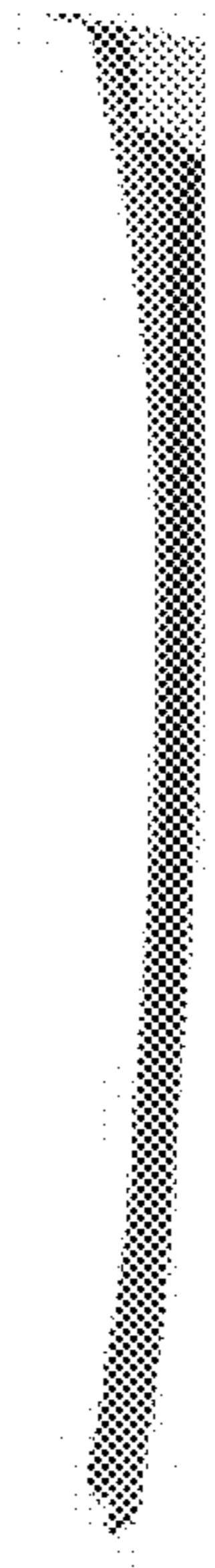

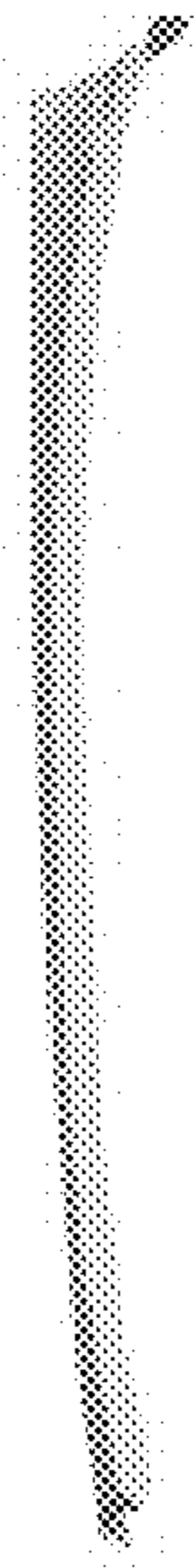

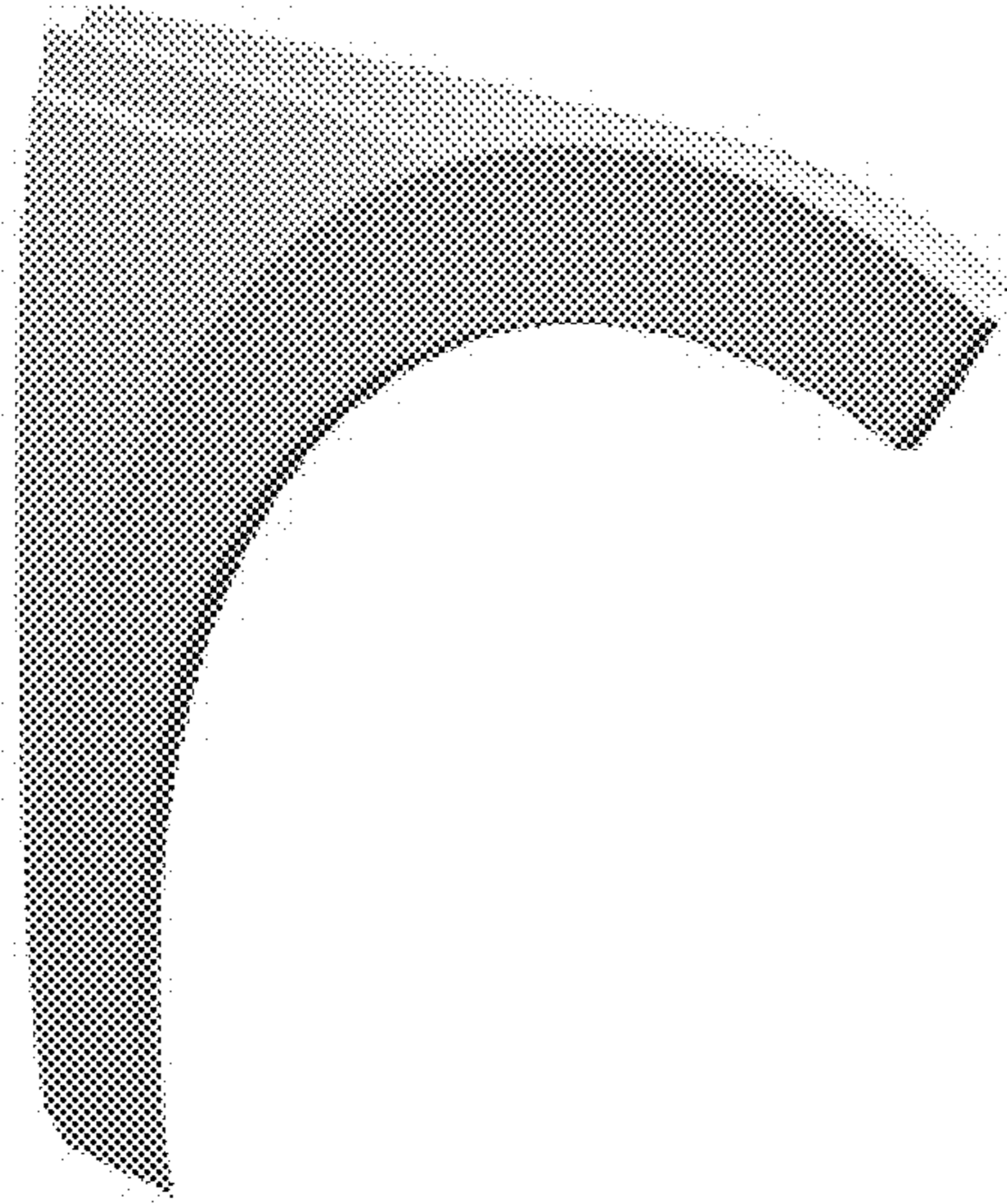

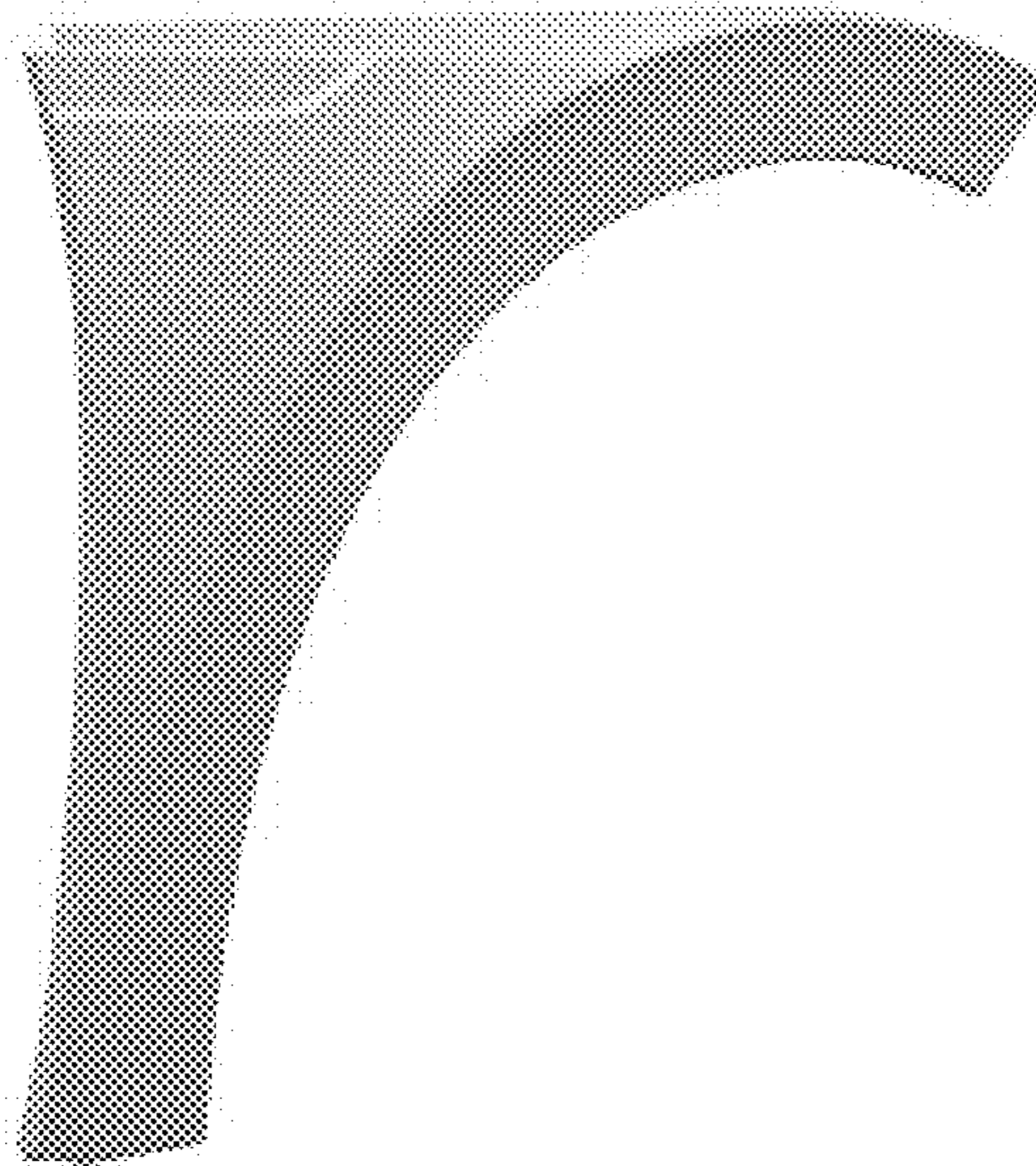

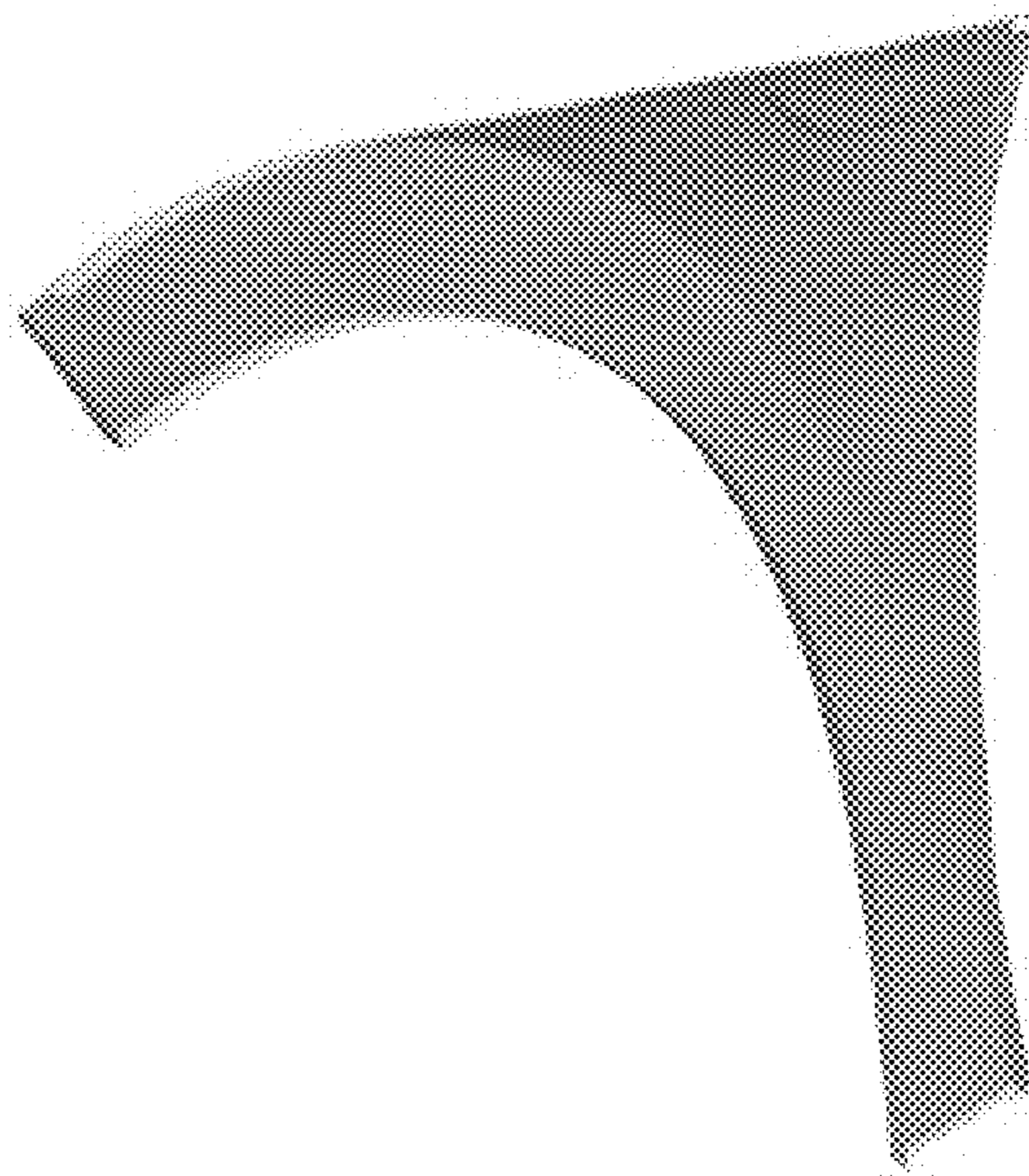

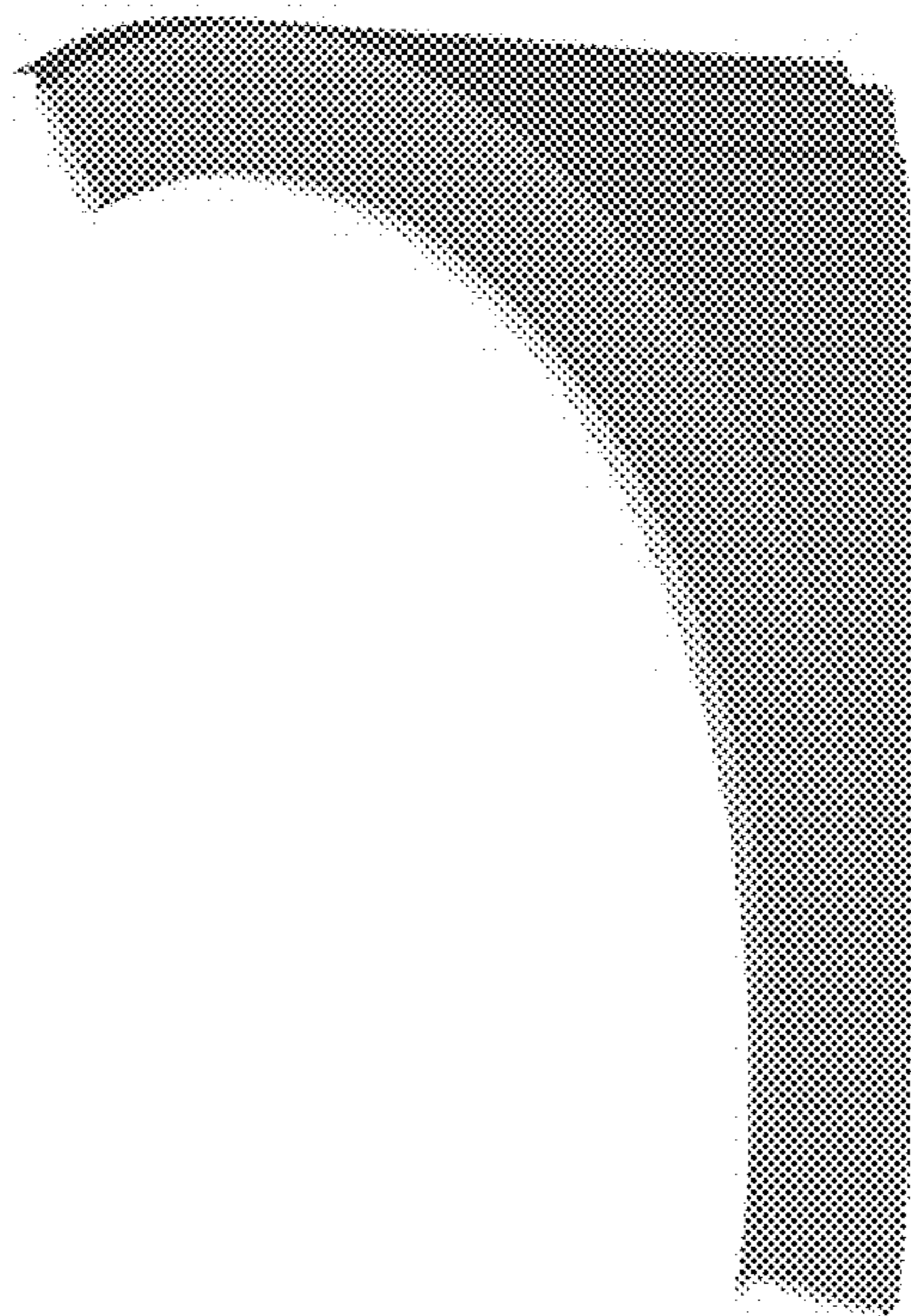

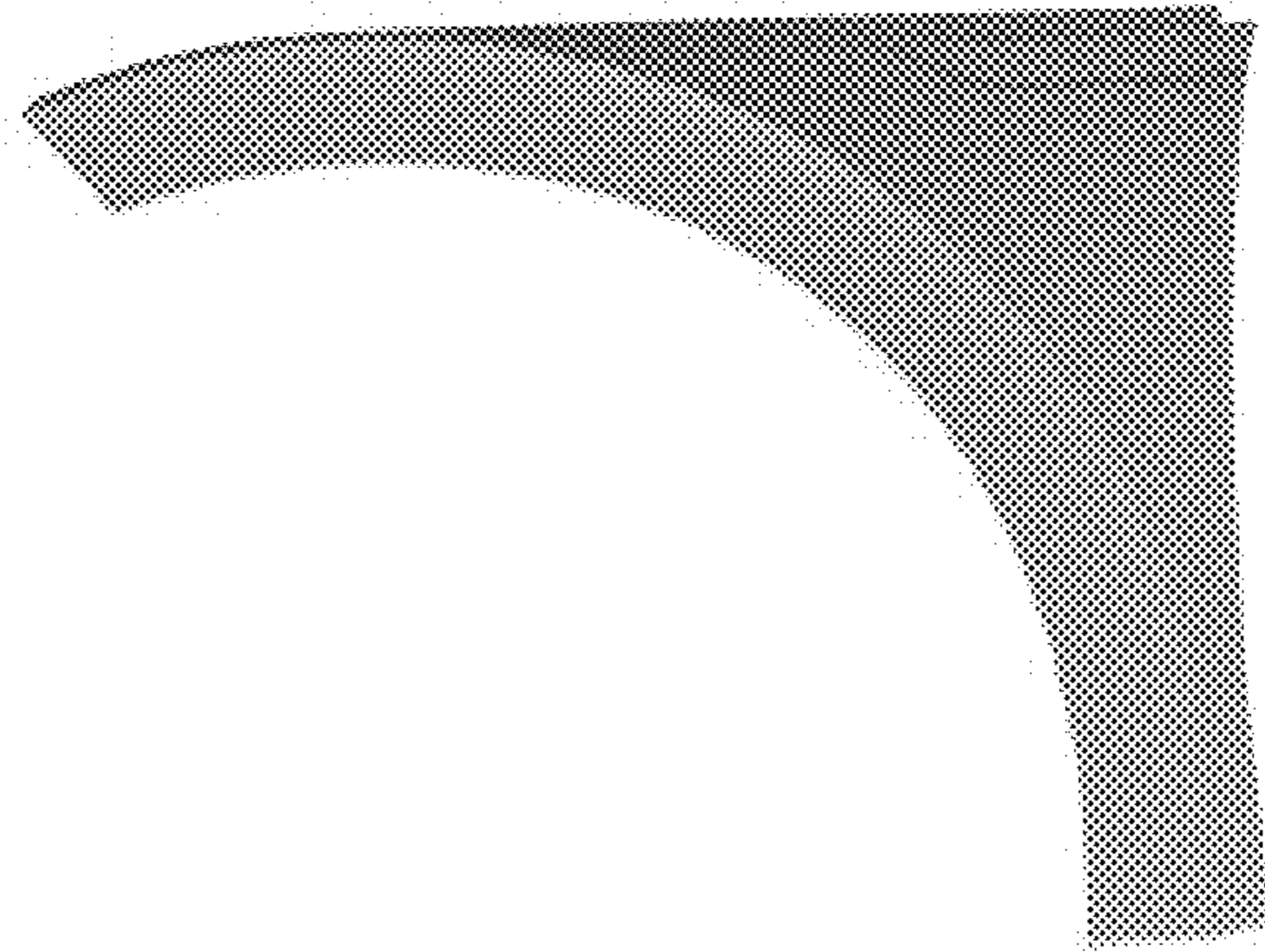

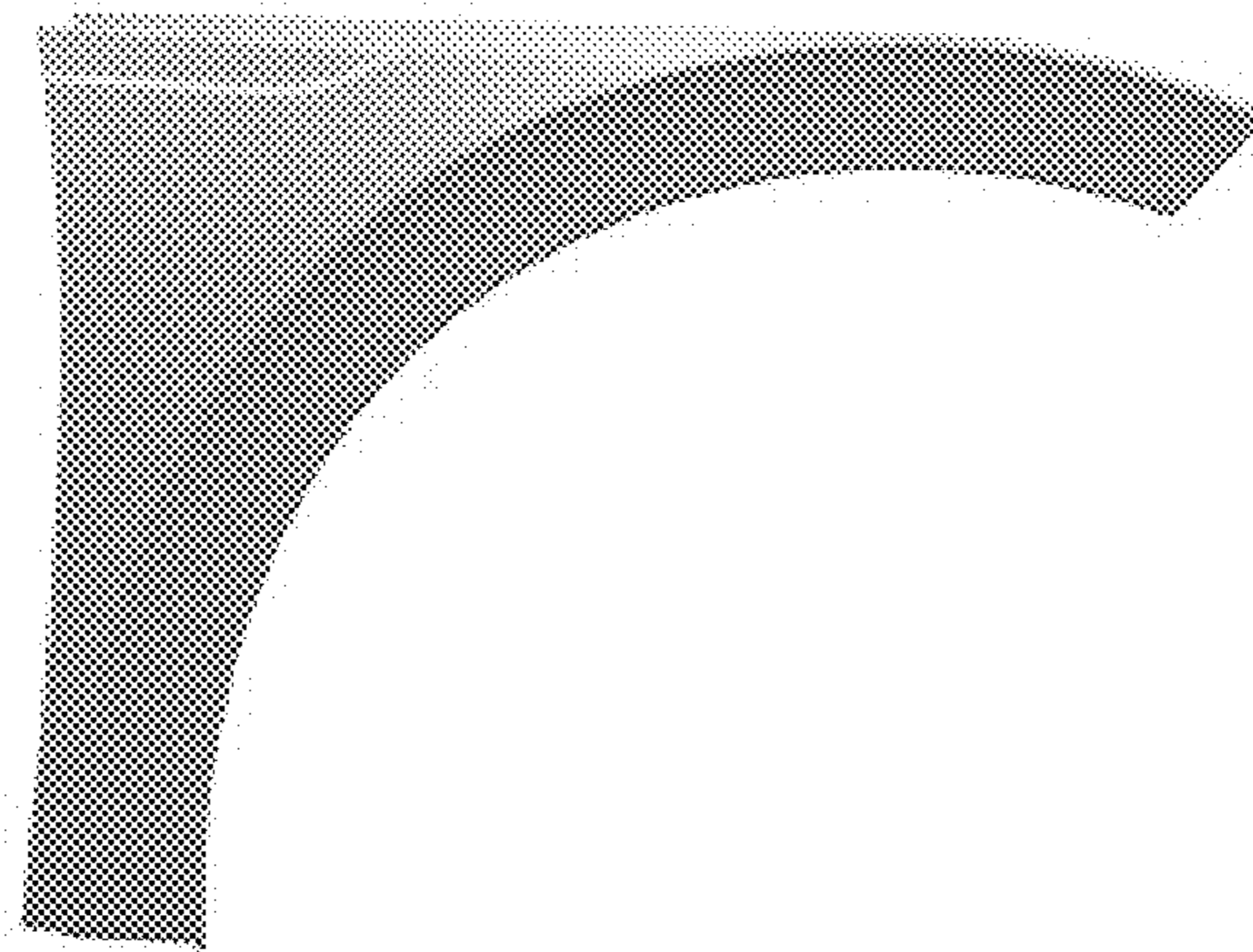

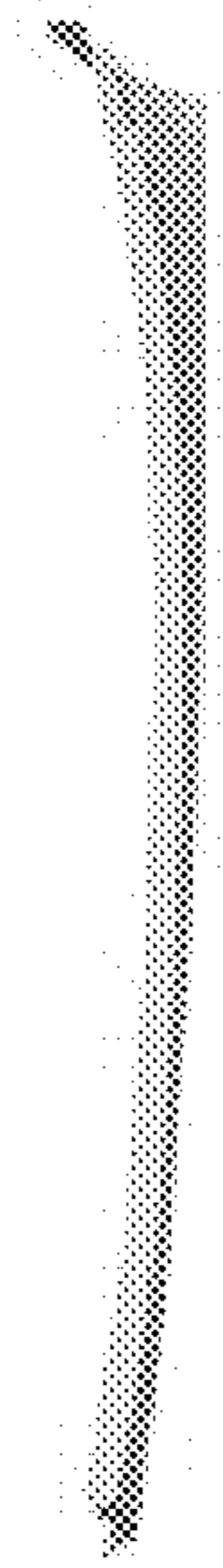

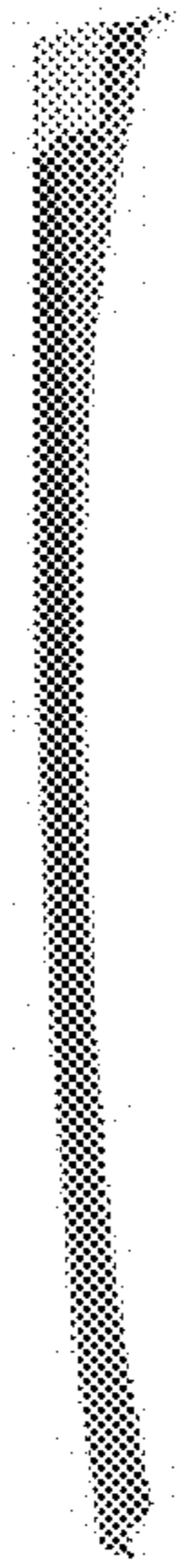

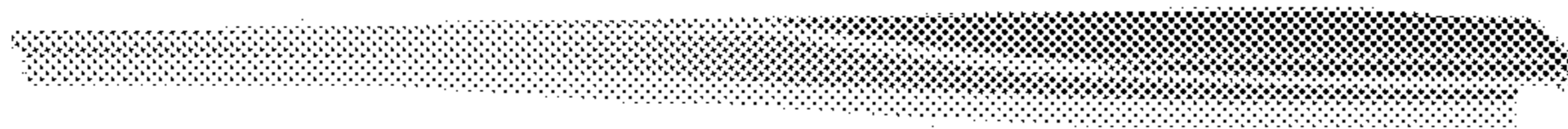
