(57) **CLAIM**

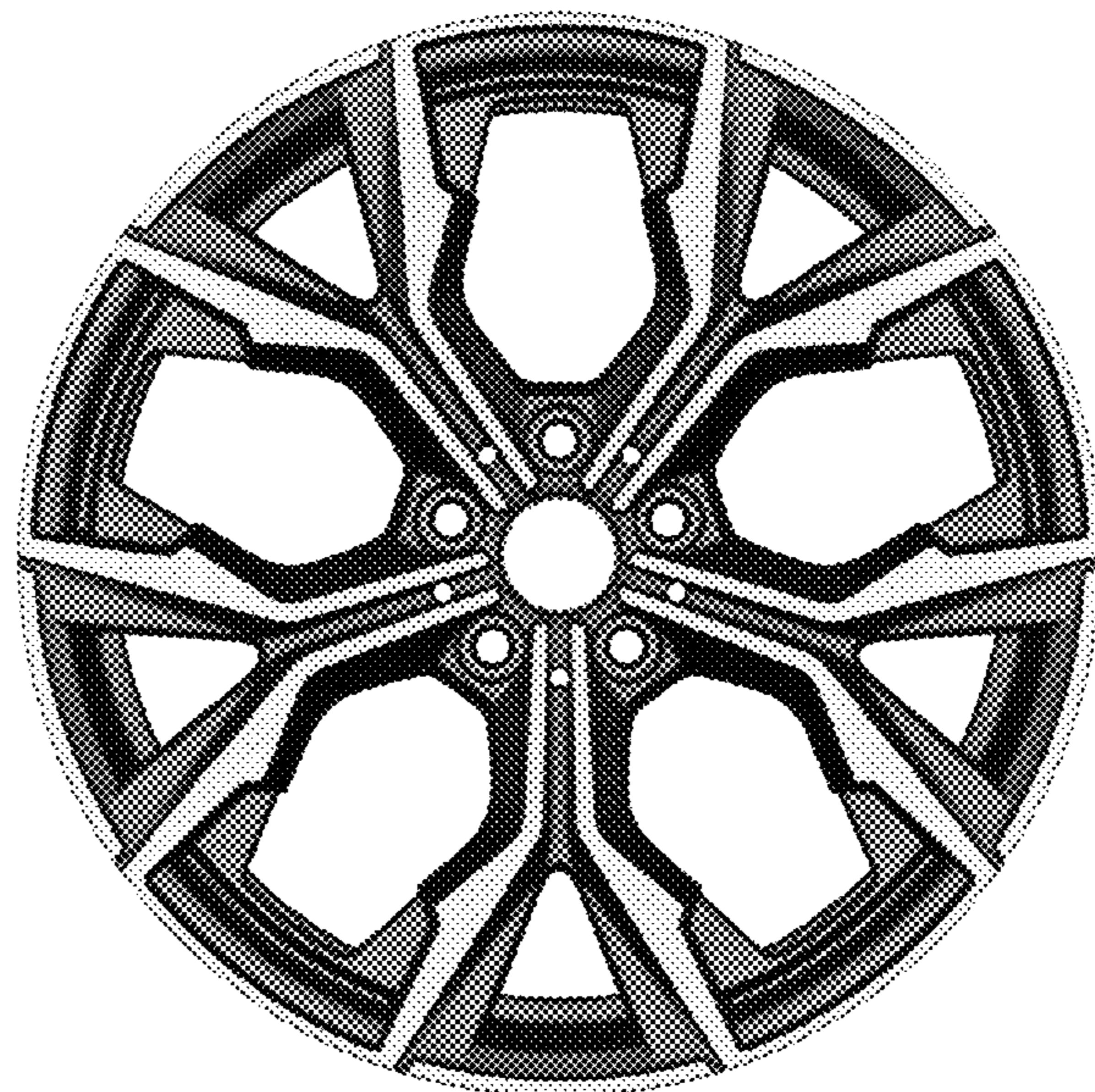
The ornamental design for a vehicle wheel, toy vehicle wheel, and/or replicas thereof, as shown and described.

**DESCRIPTION**

This application contains subject matter related to the following co-pending U.S. design patent application: Application Ser. No. 29/697,444, filed Jul. 9, 2019 and entitled “VEHICLE WHEEL, TOY VEHICLE WHEEL, AND/OR REPLICAS THEREOF.”

FIG. 1 is a perspective view of a vehicle wheel, toy vehicle wheel, and/or replicas thereof according to the design; FIG. 2 is an additional perspective view thereof; FIG. 3 is an additional perspective view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof in a lighter gray scale, representing environmental features that form no part of the claimed design; and, FIG. 6 is a side view thereof.

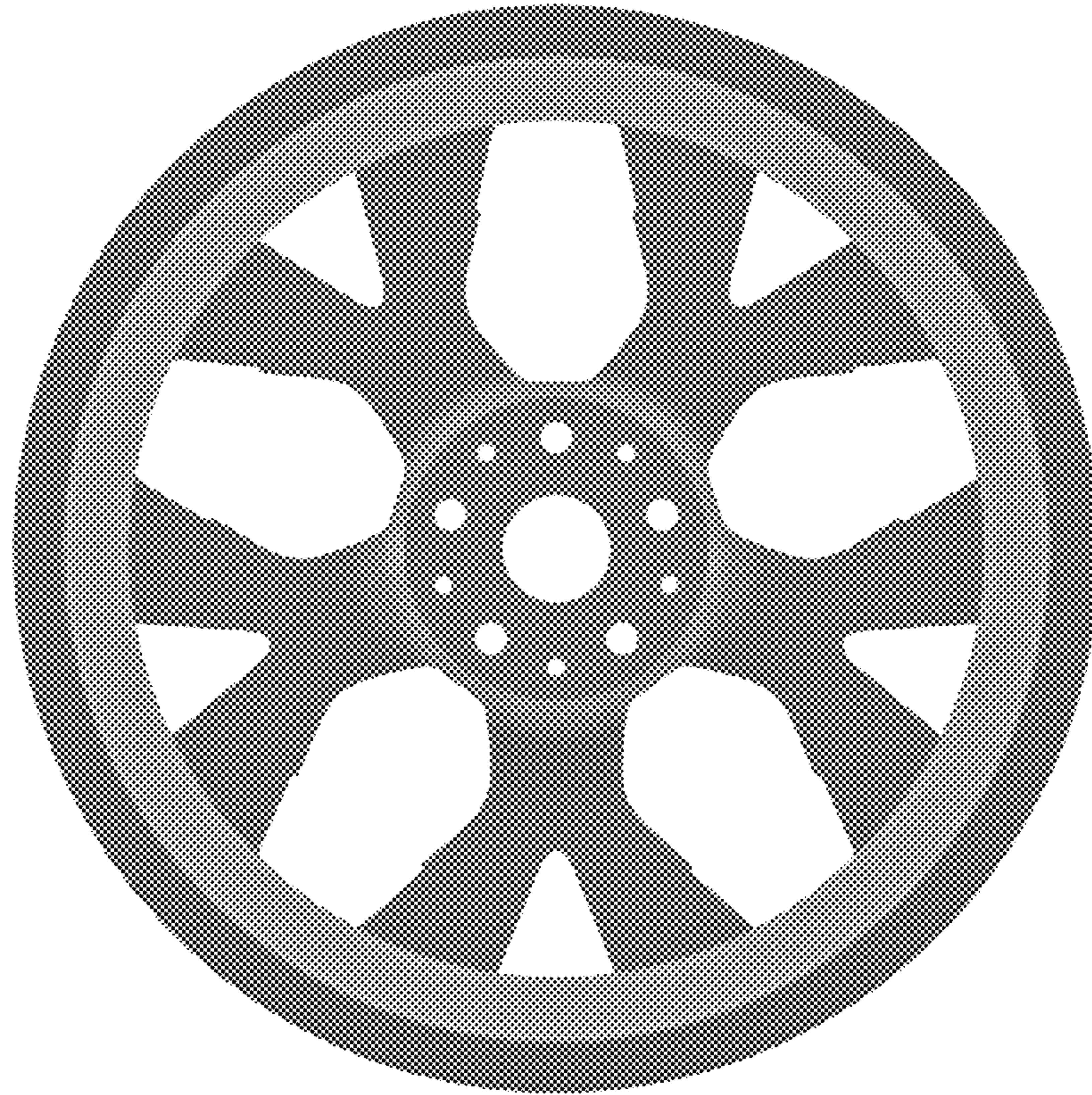

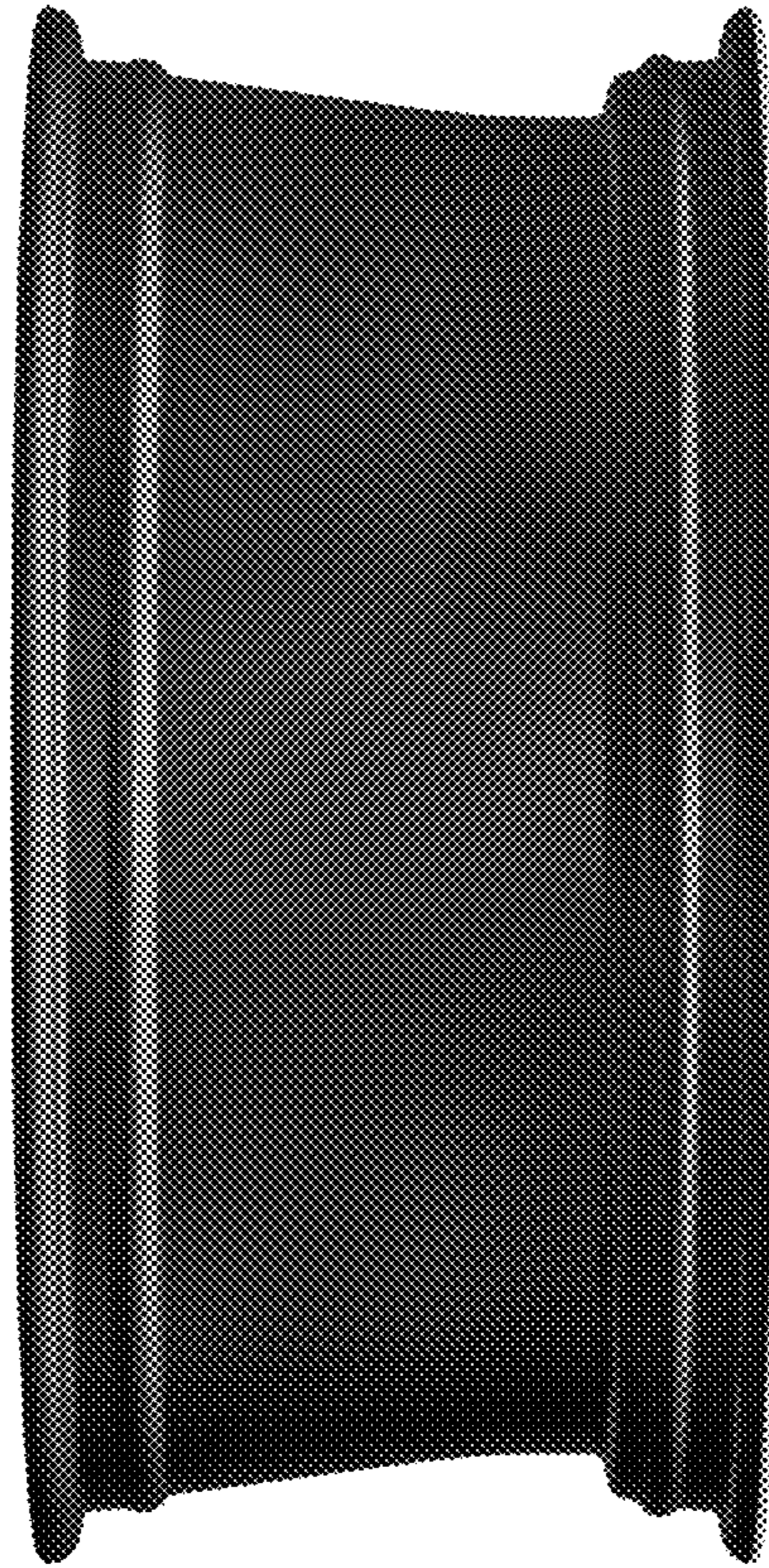
