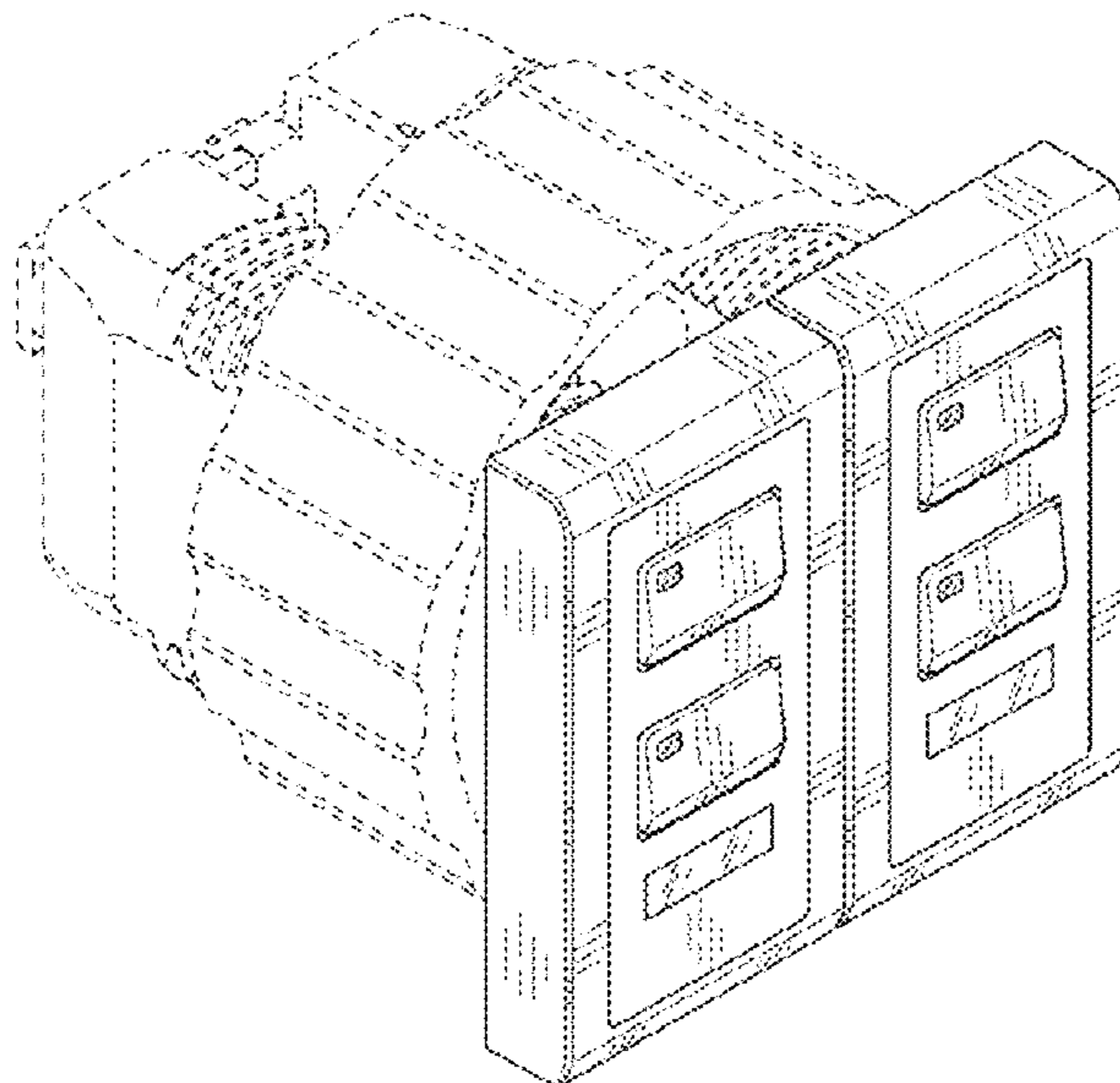
(57) **CLAIM**

The ornamental design for a switch panel for ships, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a switch panel for ships according to our new design; FIG. 2 is a rear elevational view of the first embodiment; FIG. 3 is a left side elevational view of the first embodiment; FIG. 4 is a right side elevational view of the first embodiment; FIG. 5 is a top plan view of the first embodiment; FIG. 6 is a bottom plan of the first embodiment; FIG. 7 is a perspective view of the switch panel for ships taken from the front, top and left side of the first embodiment; FIG. 8 is a front elevational view of a second embodiment of the switch panel for ships according to our new design; FIG. 9 is a rear elevational view of the second embodiment; FIG. 10 is a left side elevational view of the second embodiment; FIG. 11 is a right side elevational view of the second embodiment; FIG. 12 is a top plan view of the second embodiment; and, FIG. 13 is a bottom plan of the second embodiment. 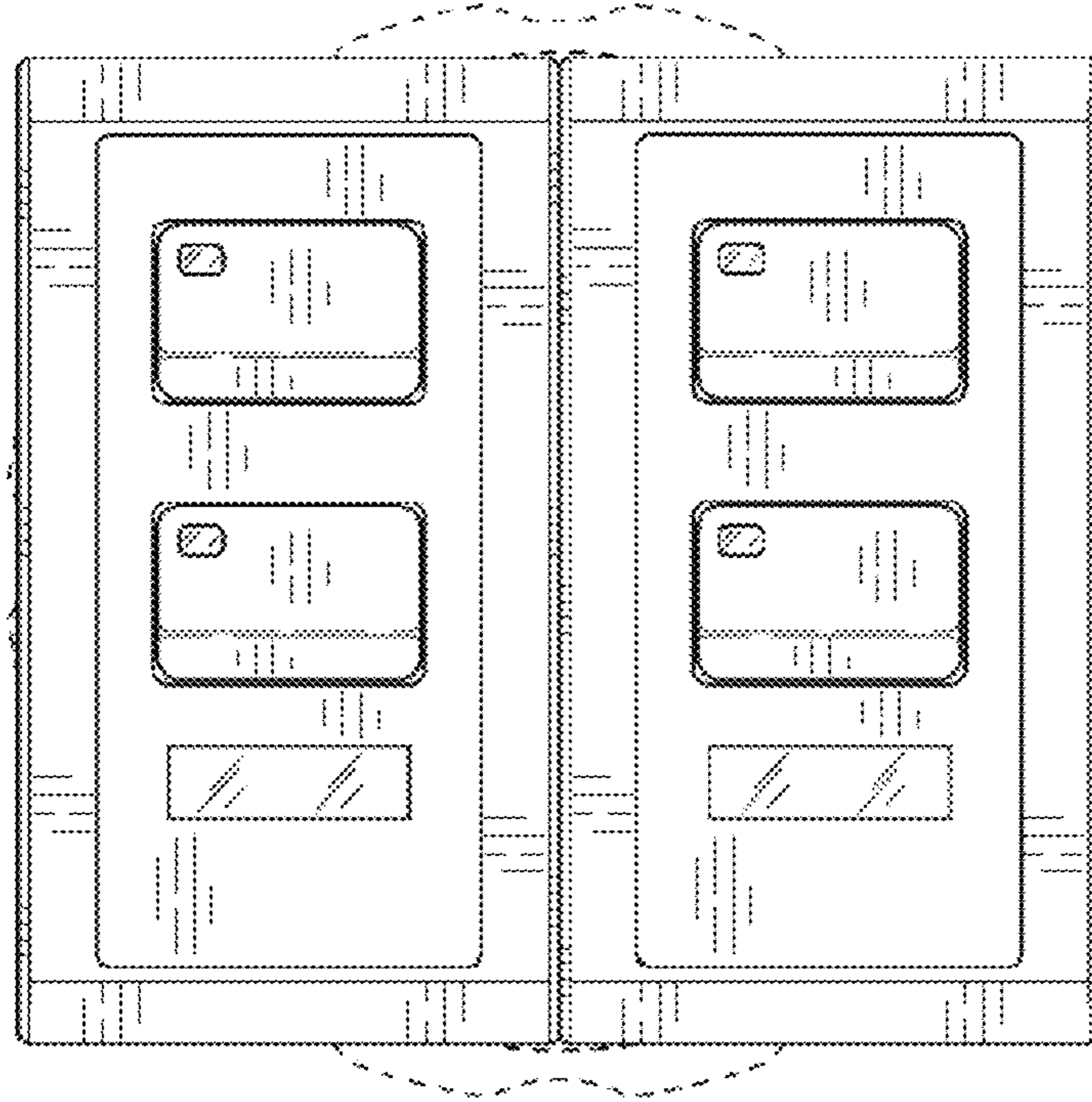

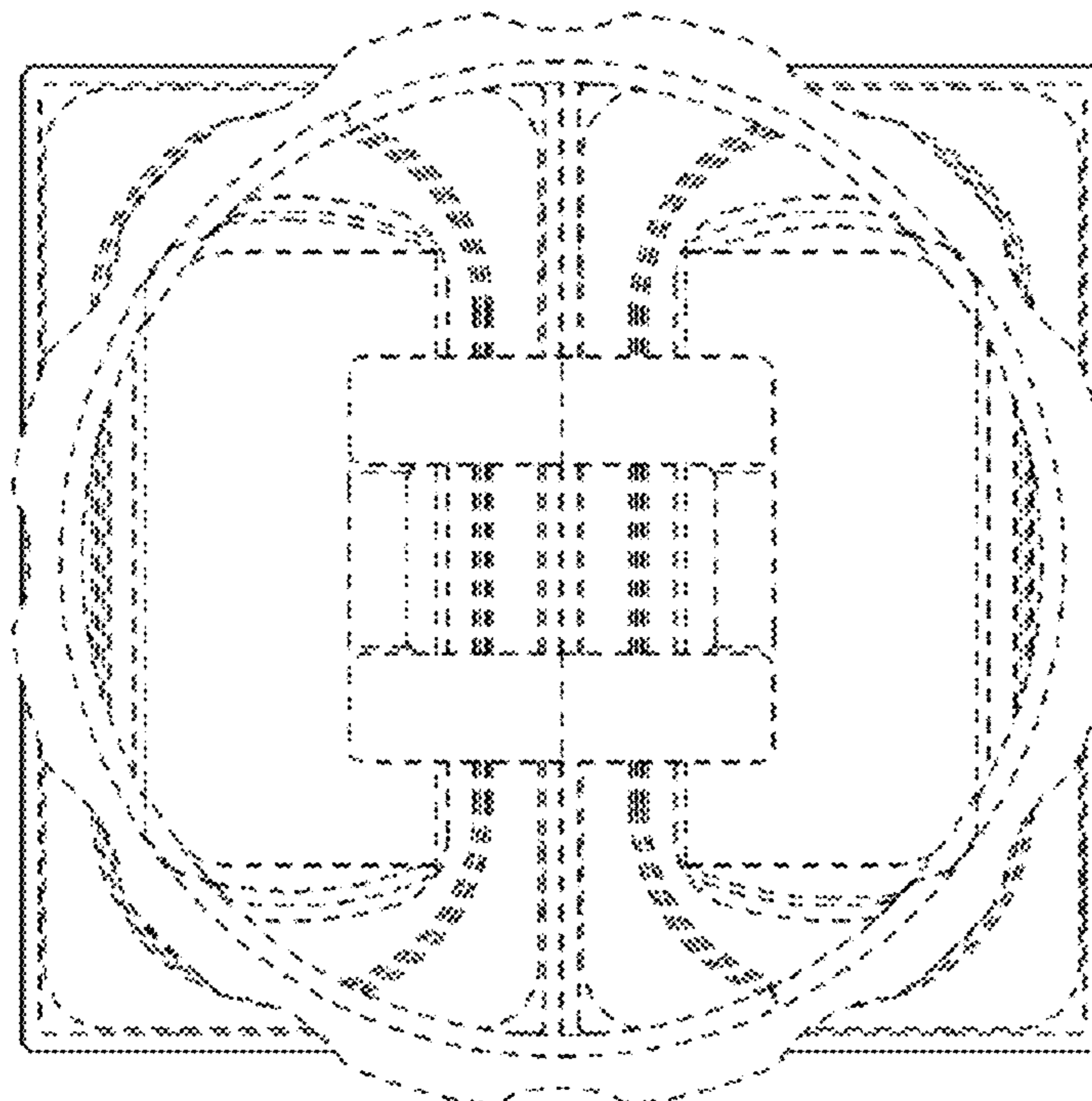

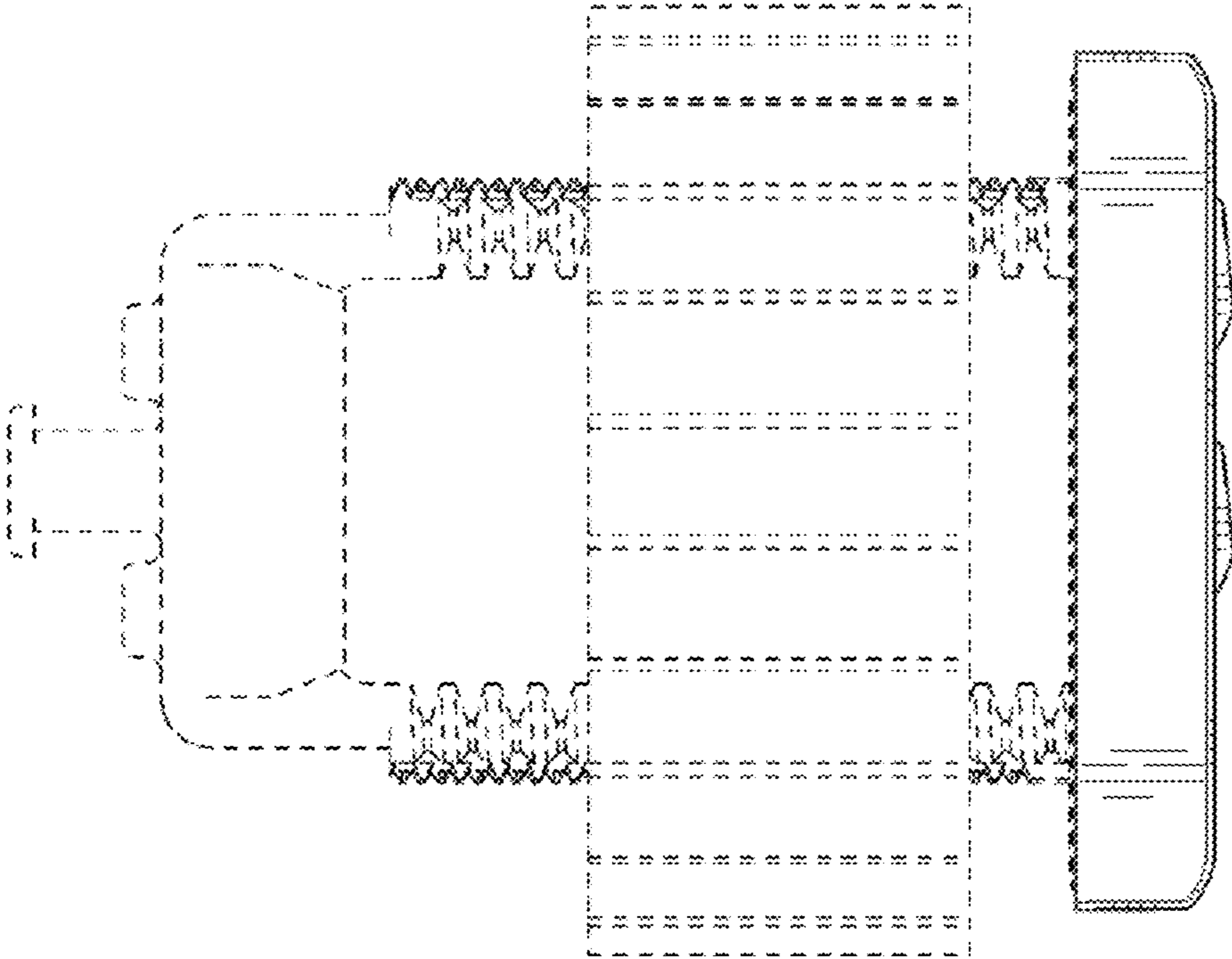

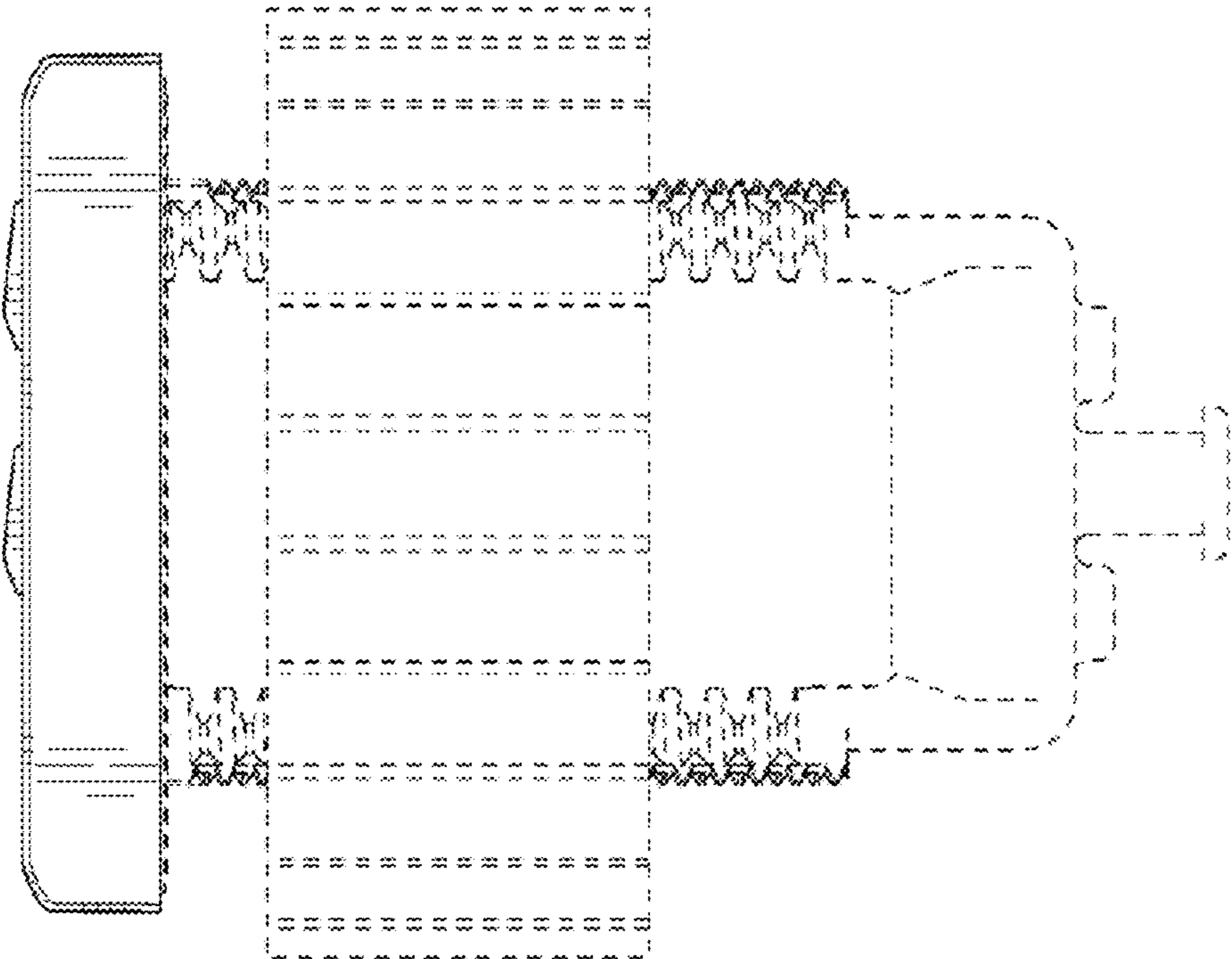

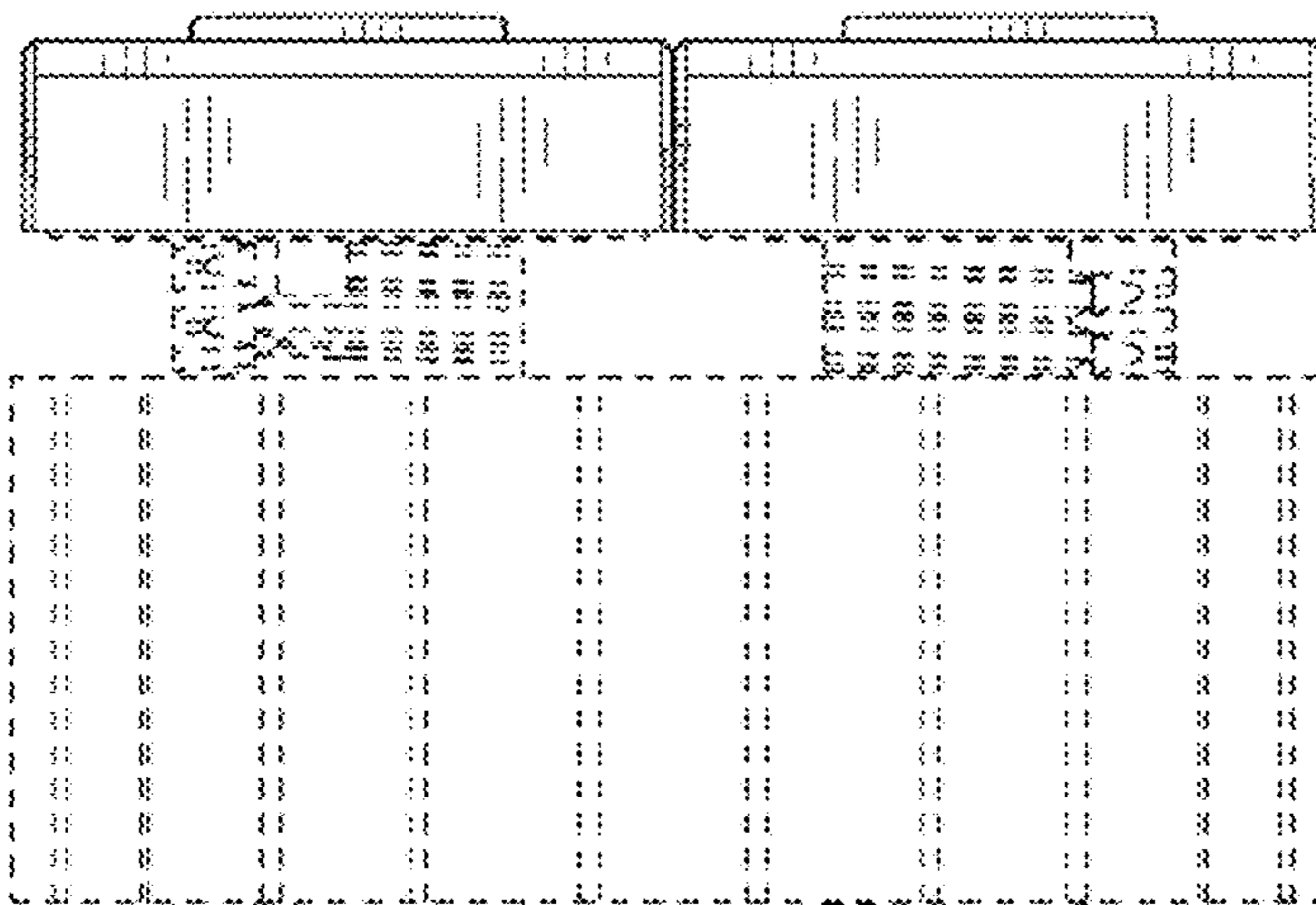
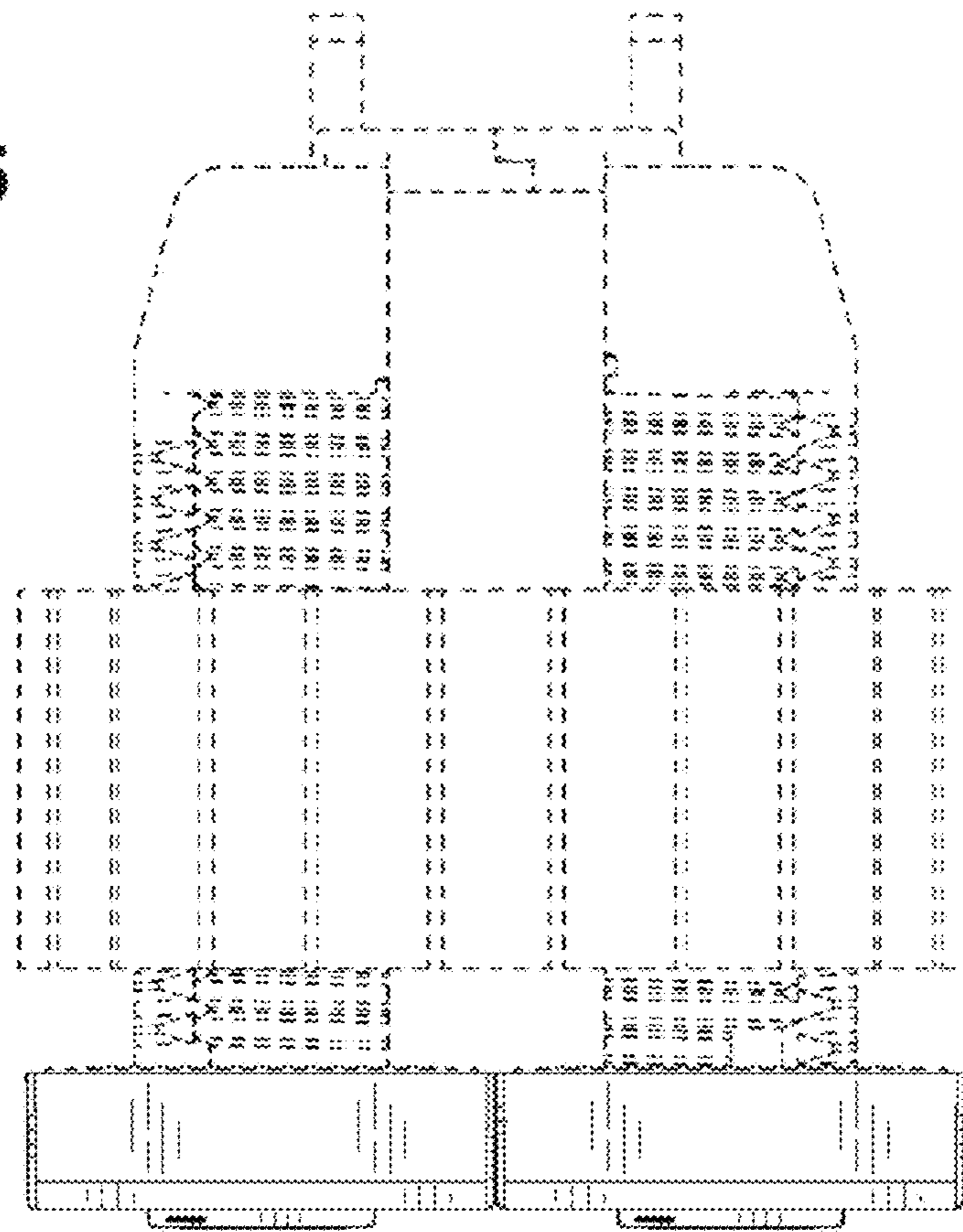

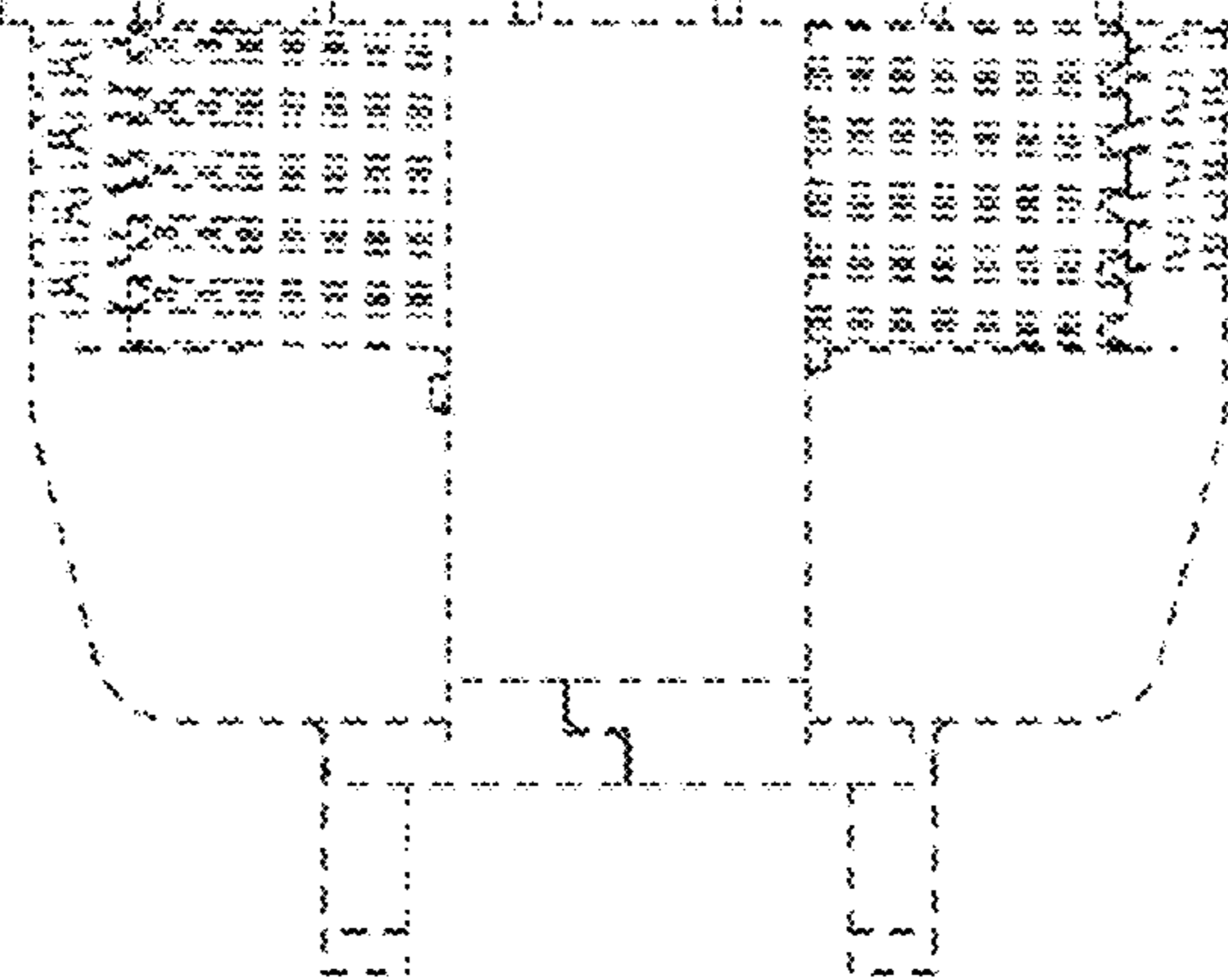

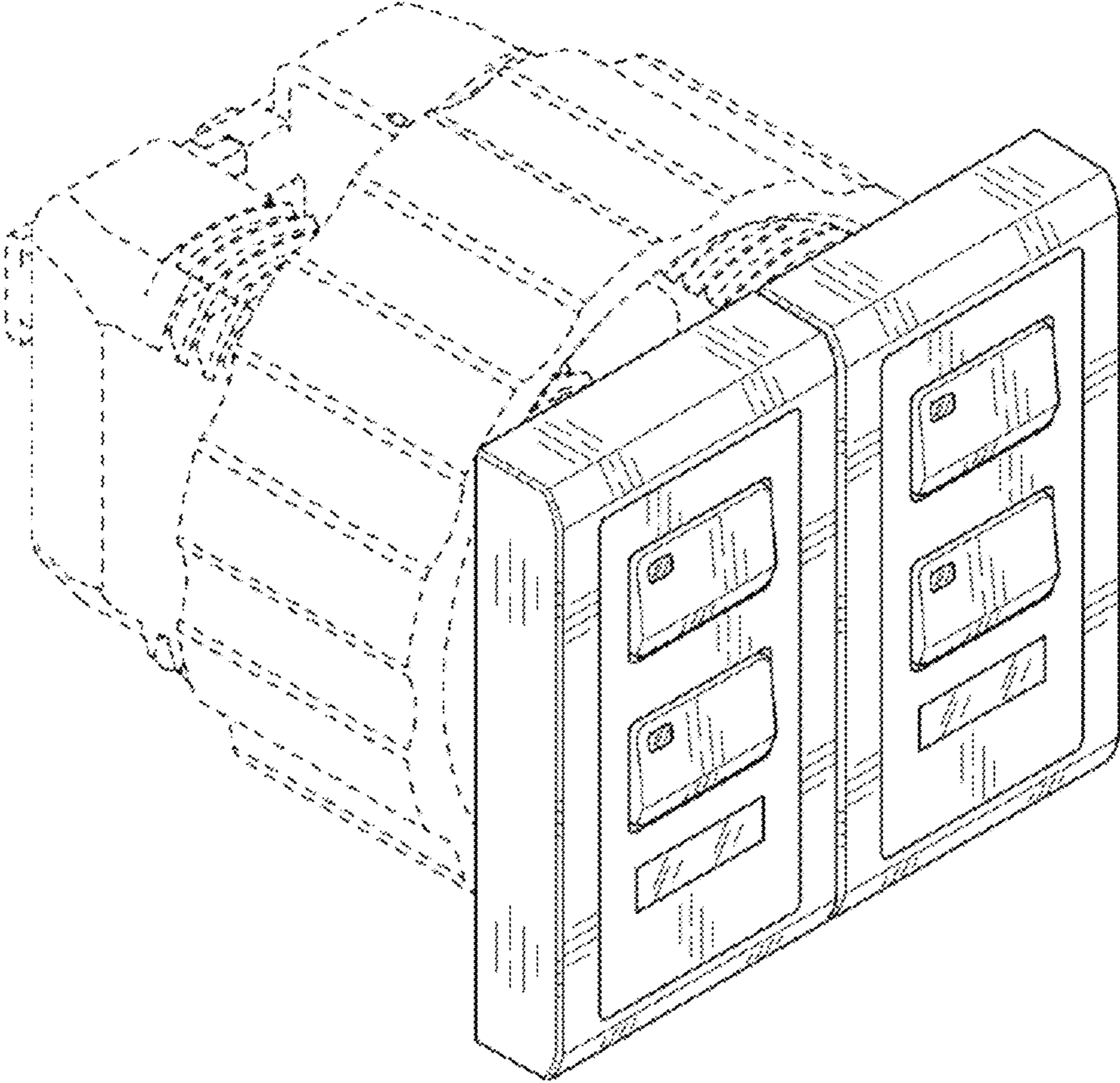

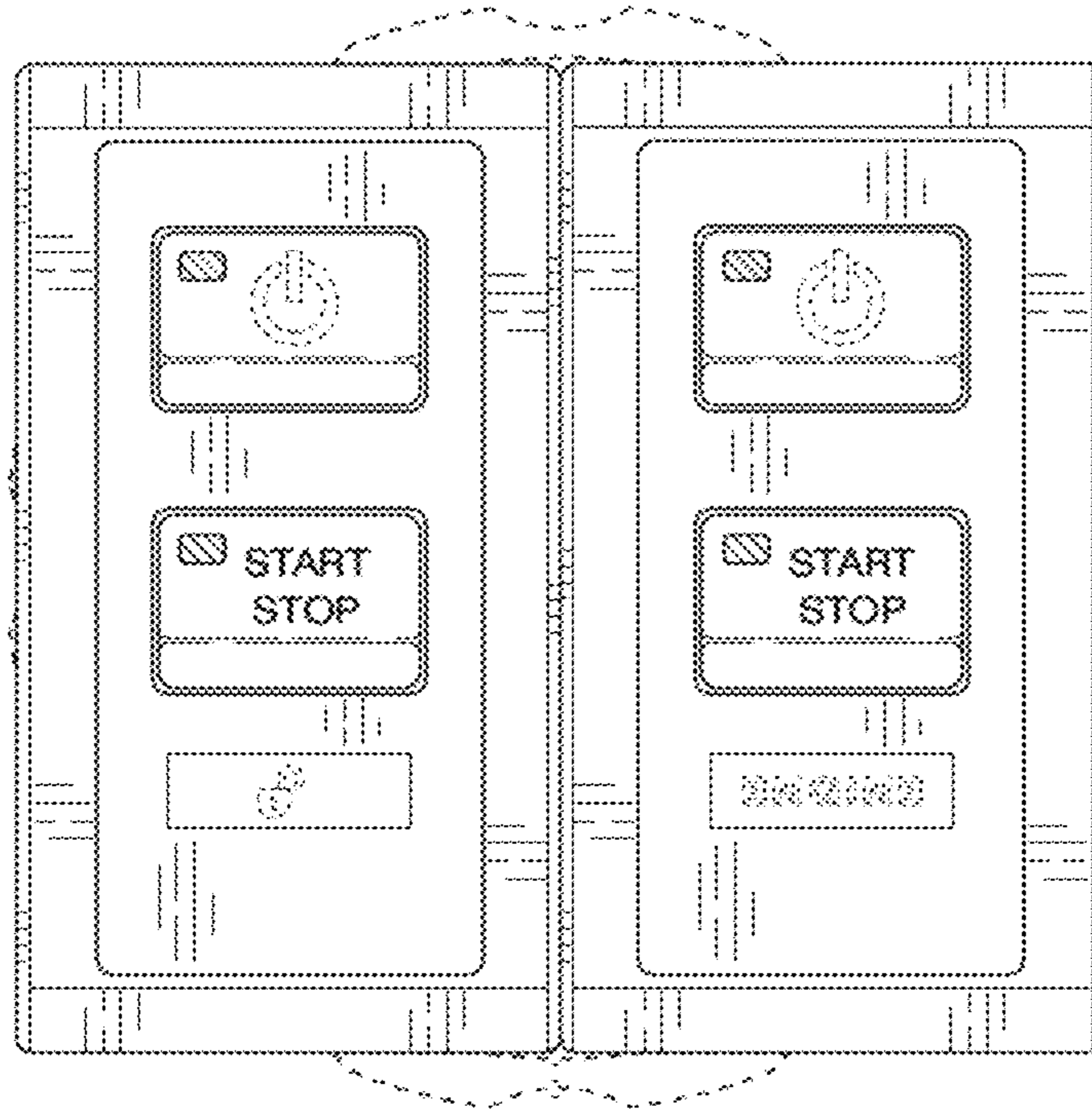

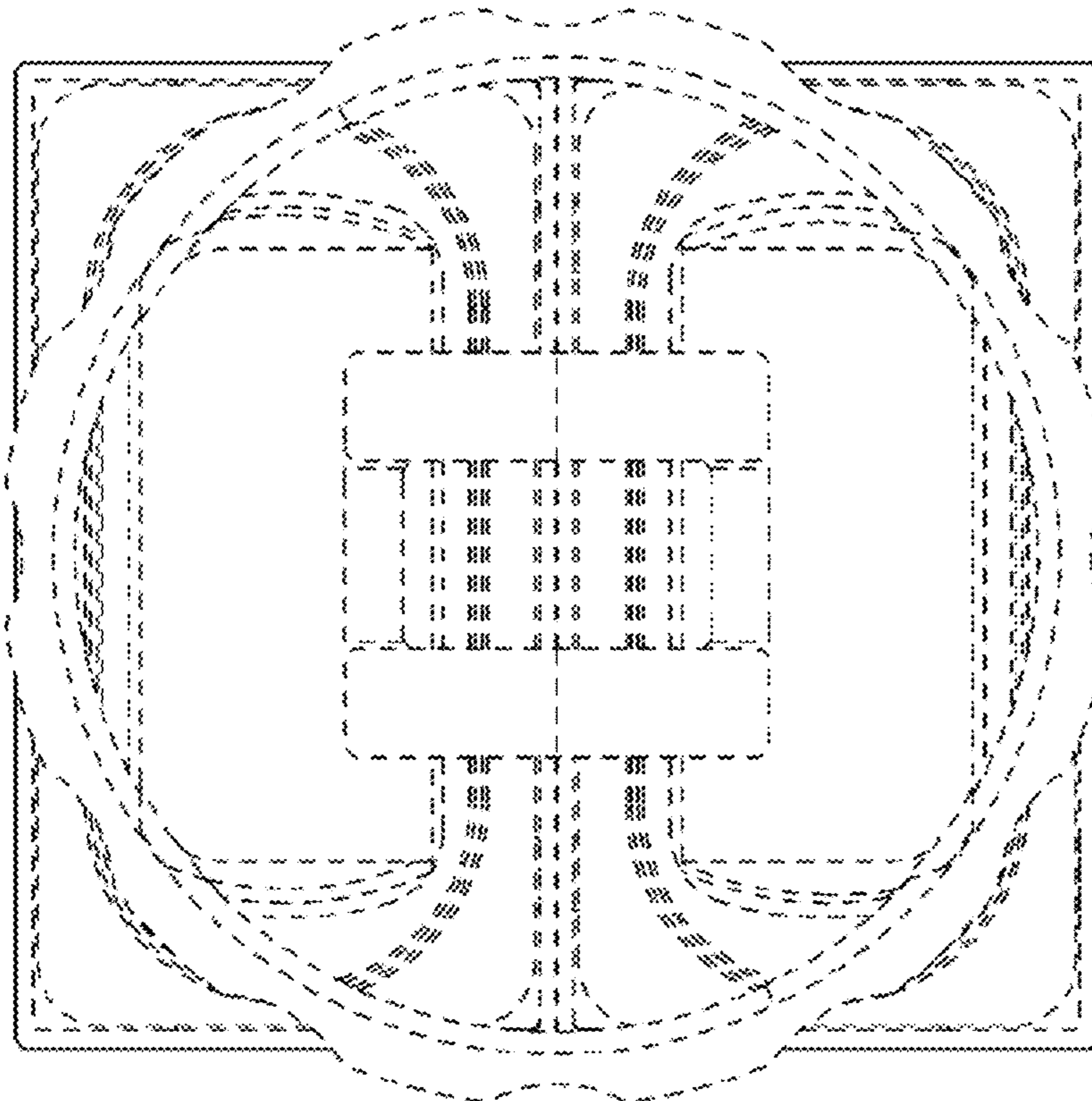

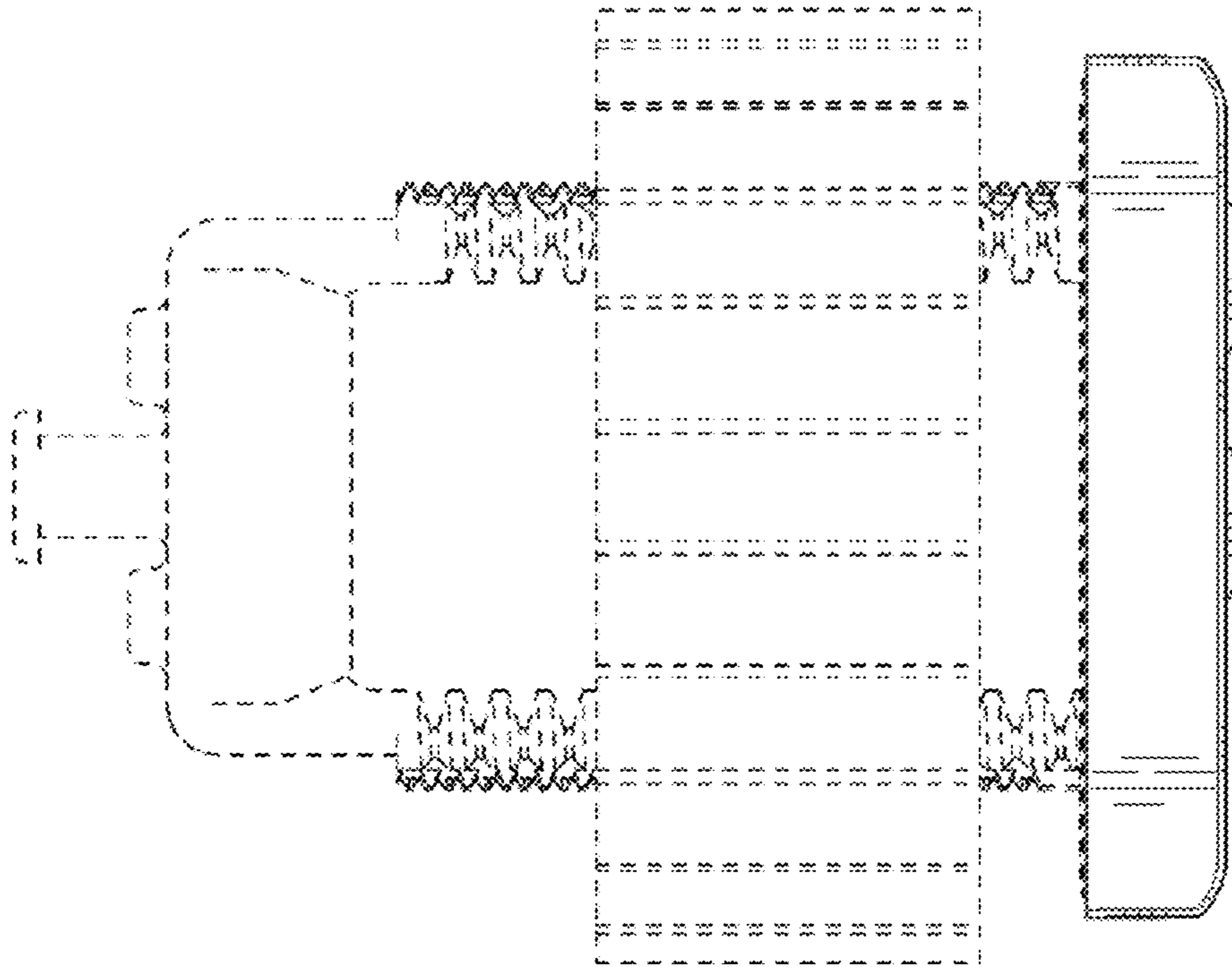

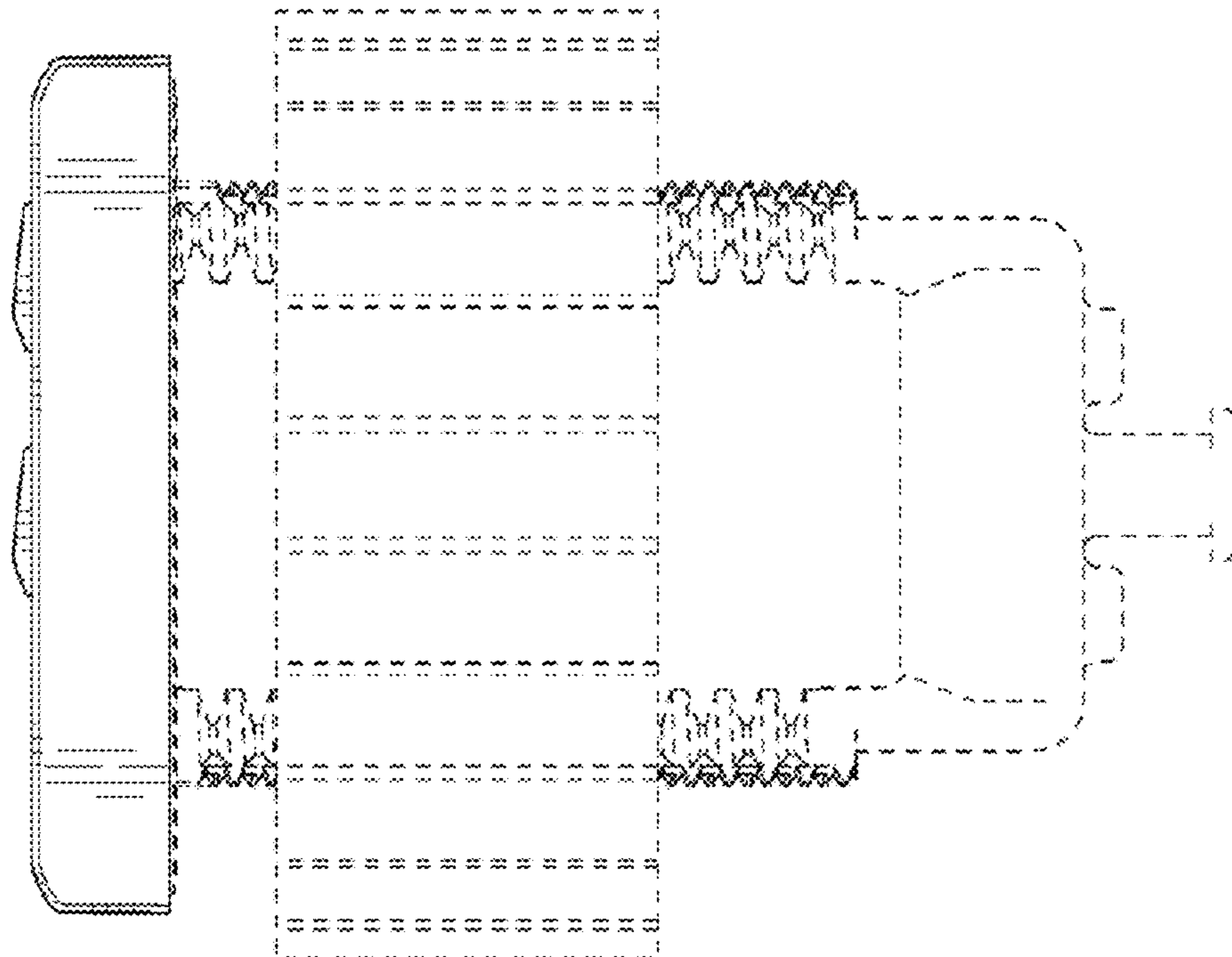

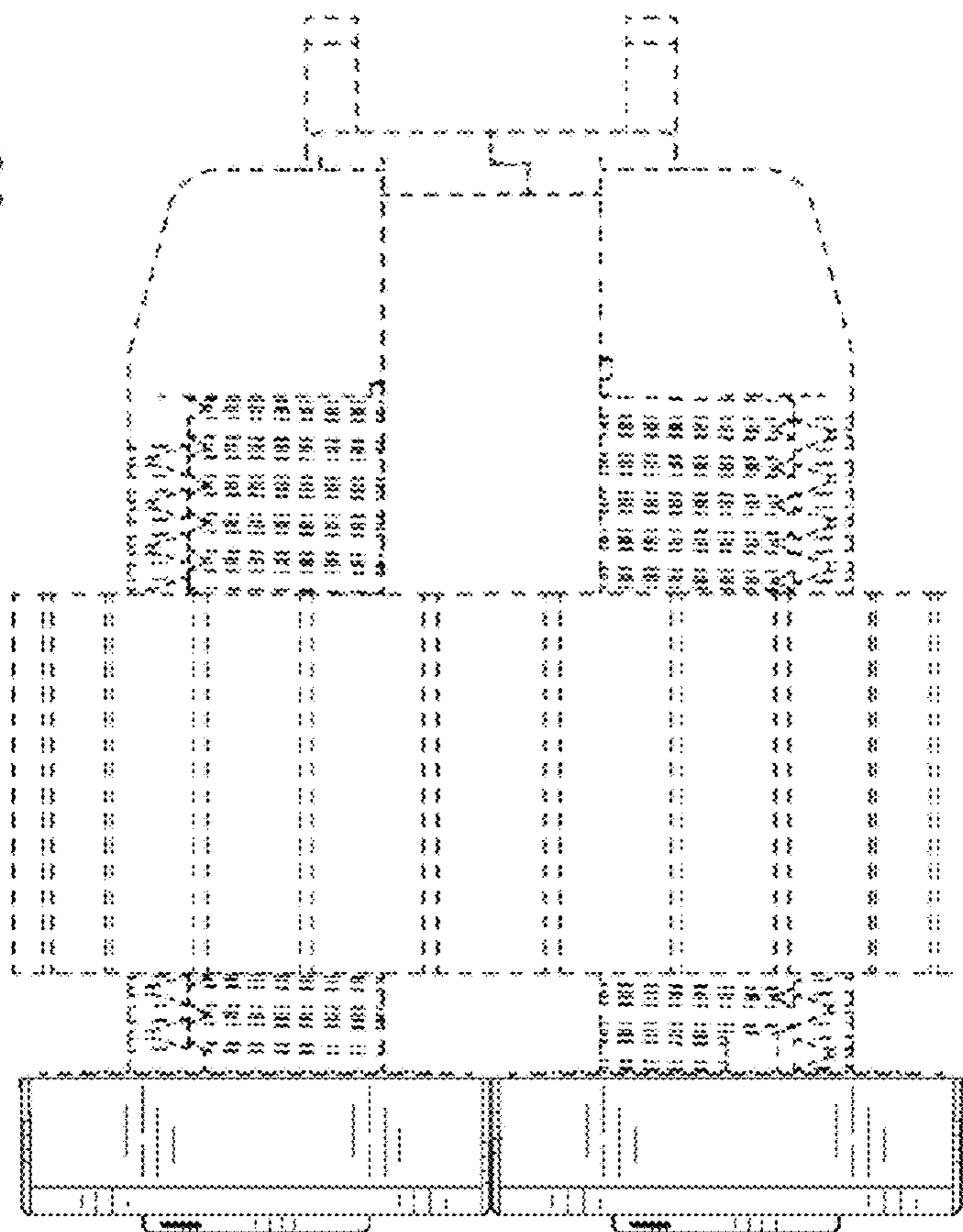
