(57) **CLAIM**

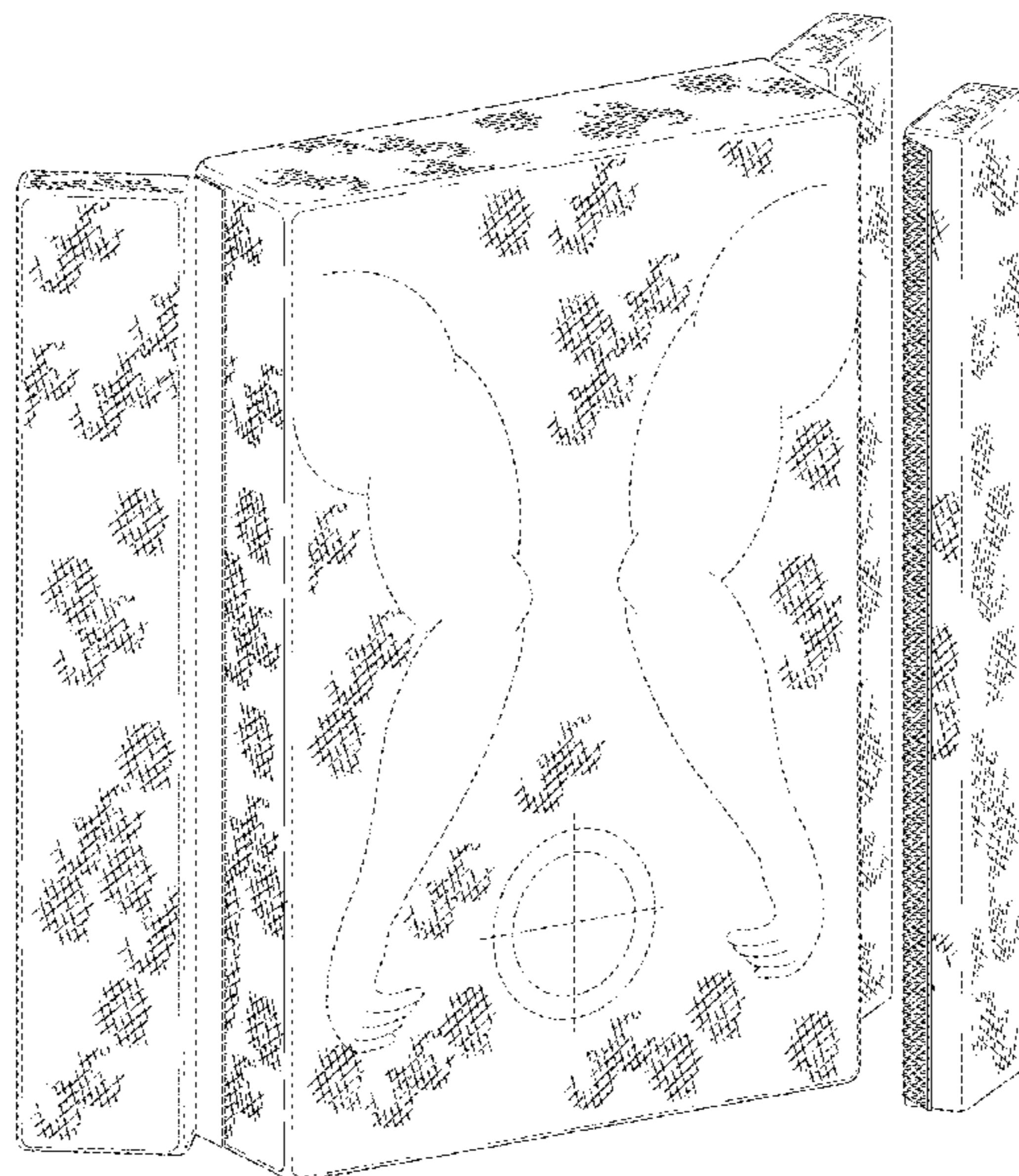
I claim the ornamental design for a convertible strike shield with removable safety panels, as shown and as described.

DESCRIPTION

FIG. 1 is a front perspective view of the front of the convertible strike shield with removable safety panels; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top side view thereof; FIG. 8 is a bottom side view thereof; FIG. 9 is a front perspective view of the front of the convertible strike shield with safety panels removed; FIG. 10 is a rear side perspective thereof; FIG. 11 is a front side view thereof; FIG. 12 is a rear side perspective view thereof; FIG. 13 is a right side view thereof; FIG. 14 is a left side view thereof; FIG. 15 is the top side view thereof; FIG. 16 is a the bottom view thereof; FIG. 17 is the front view of the safety panels with the shield removed; FIG. 18 is a right side perspective view thereof; FIG. 19 is a right side view thereof; FIG. 20 is a right side perspective thereof; FIG. 21 is a left side view thereof; FIG. 22 is a left side perspective view thereof; FIG. 23 is a top side view thereof; and, FIG. 24 is bottom side view thereof.

The broken line showing of the arms and target elements of the convertible strike shield with removable safety panels is for the purpose of illustrating portions of the articles and forms no part of the claimed design. The broken line features in FIGS. 2, 4, 10, and 12 represent stitching and form part of the claimed design.

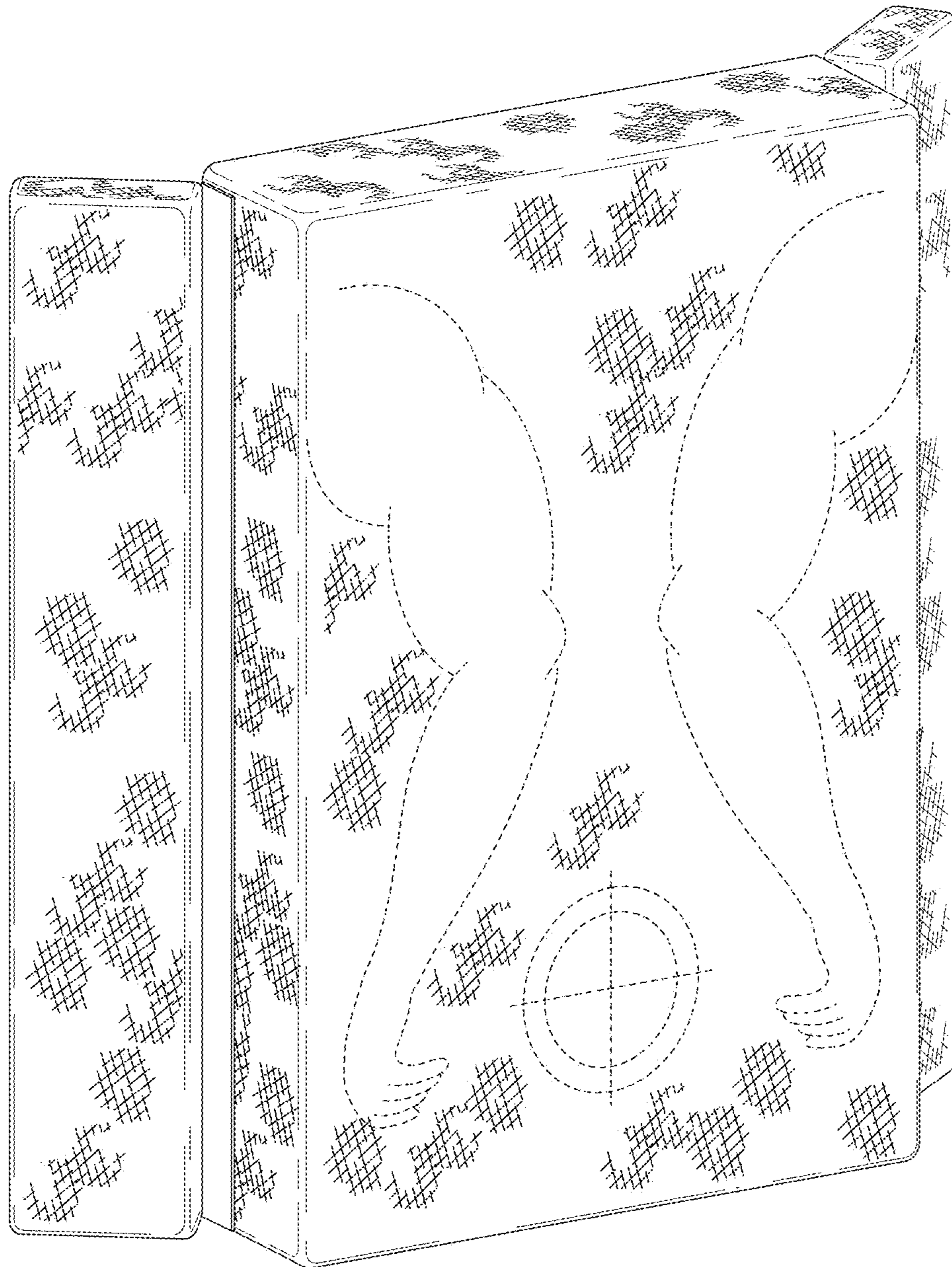

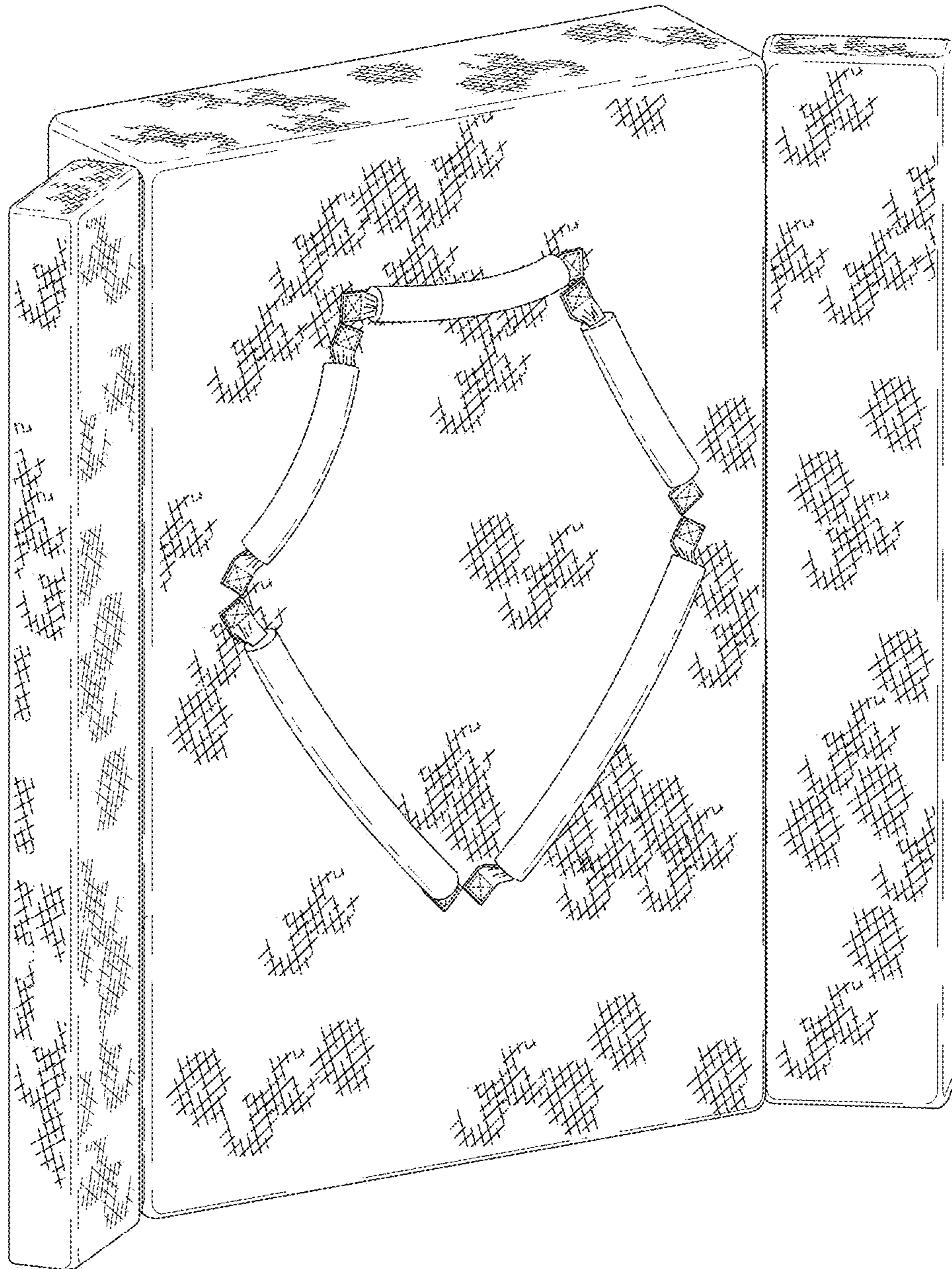

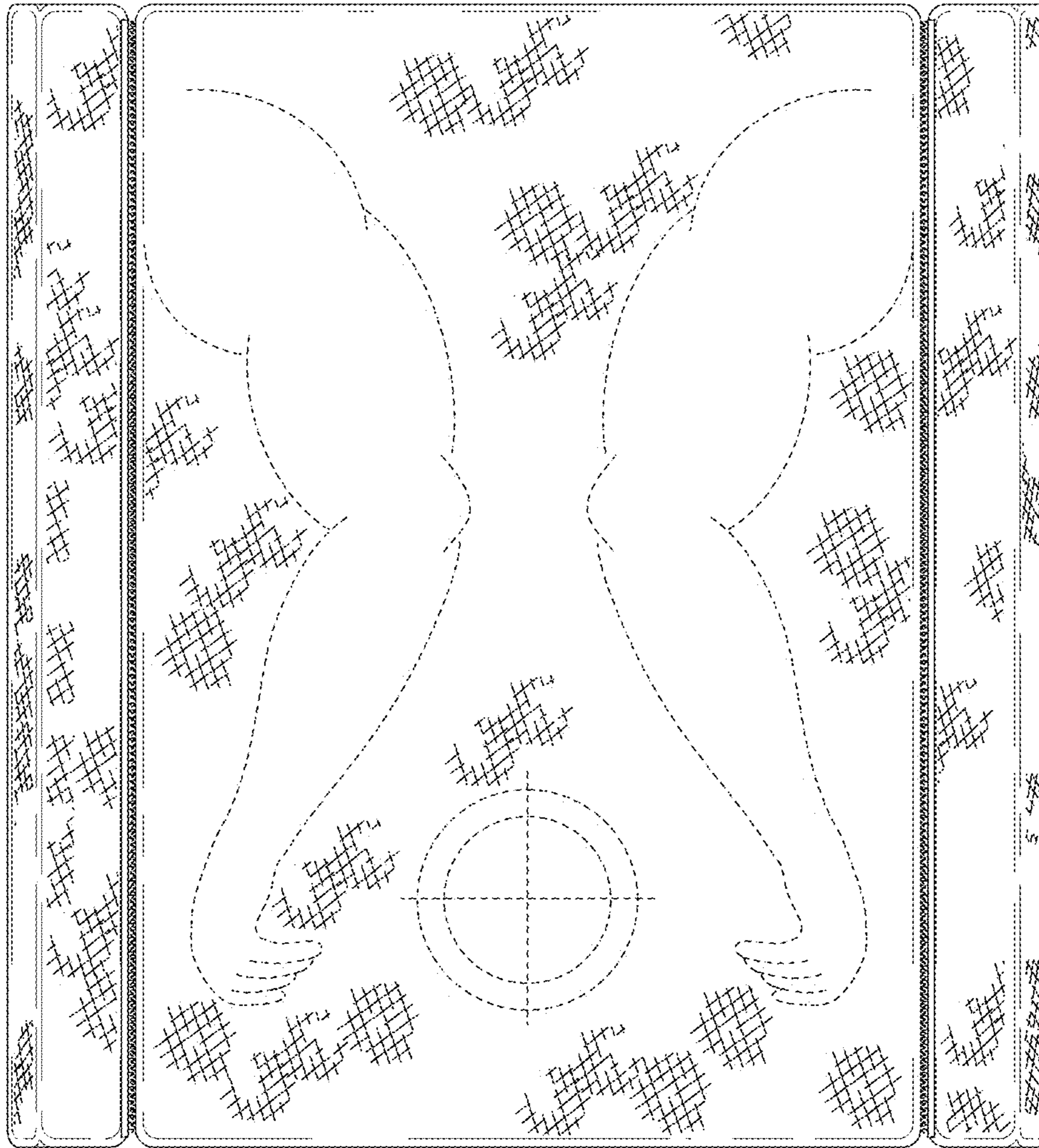

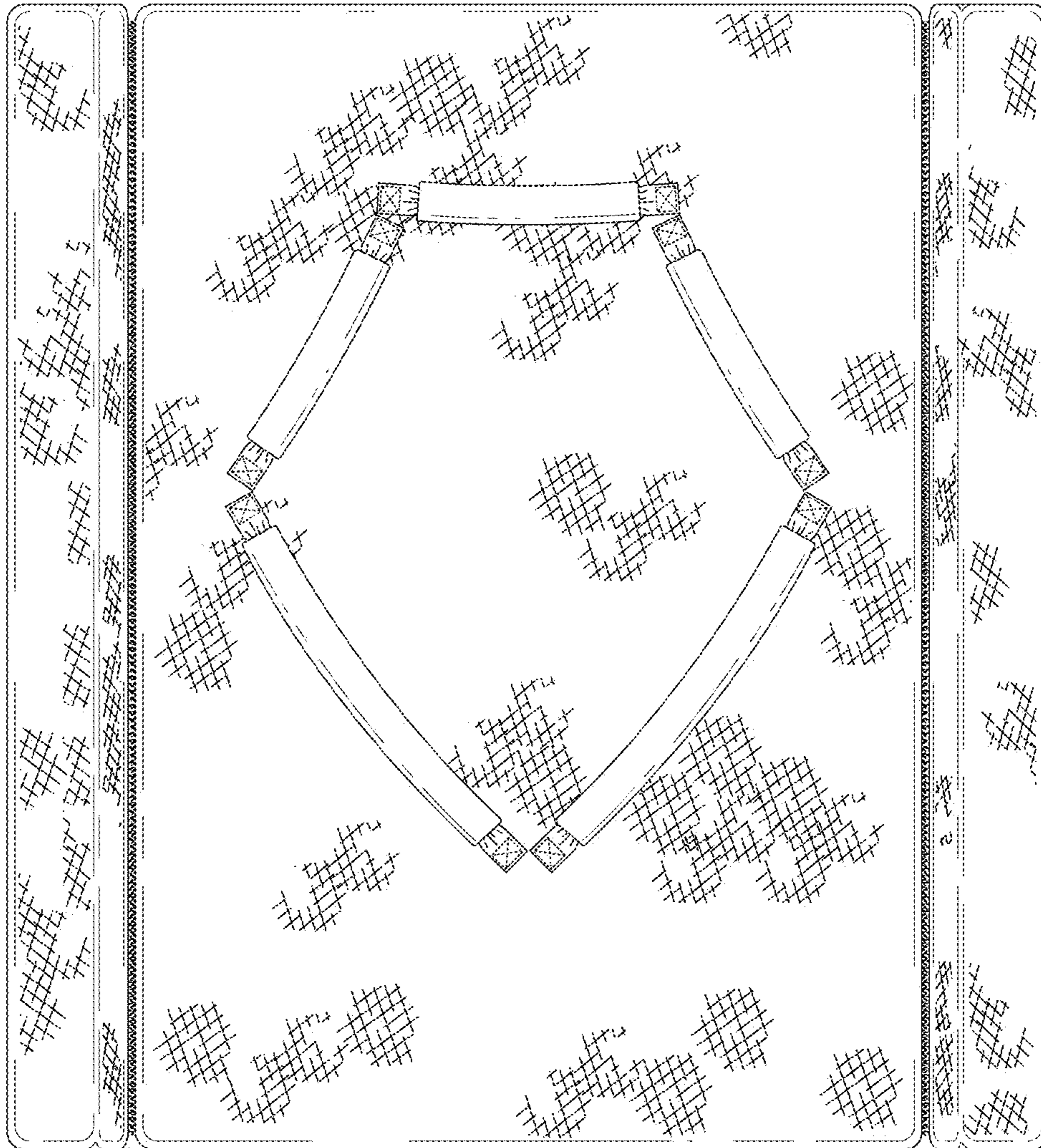

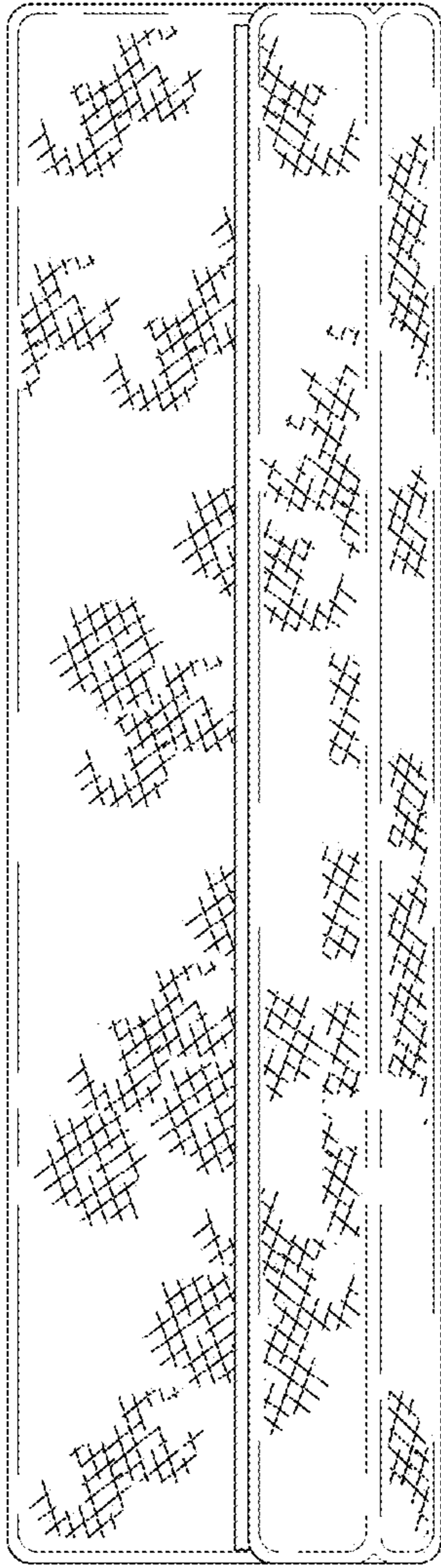

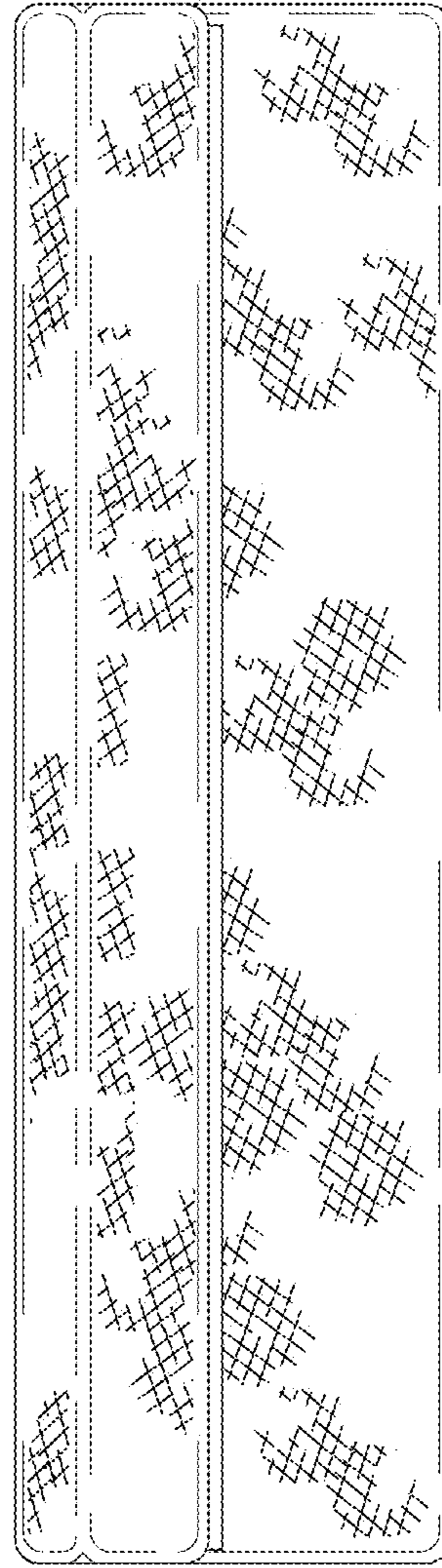

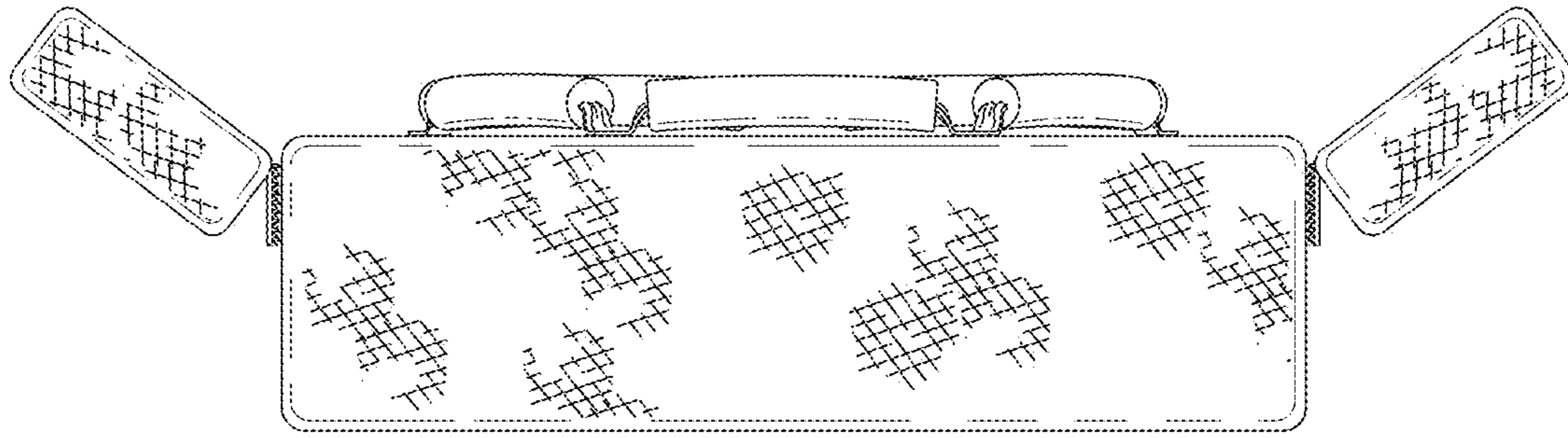

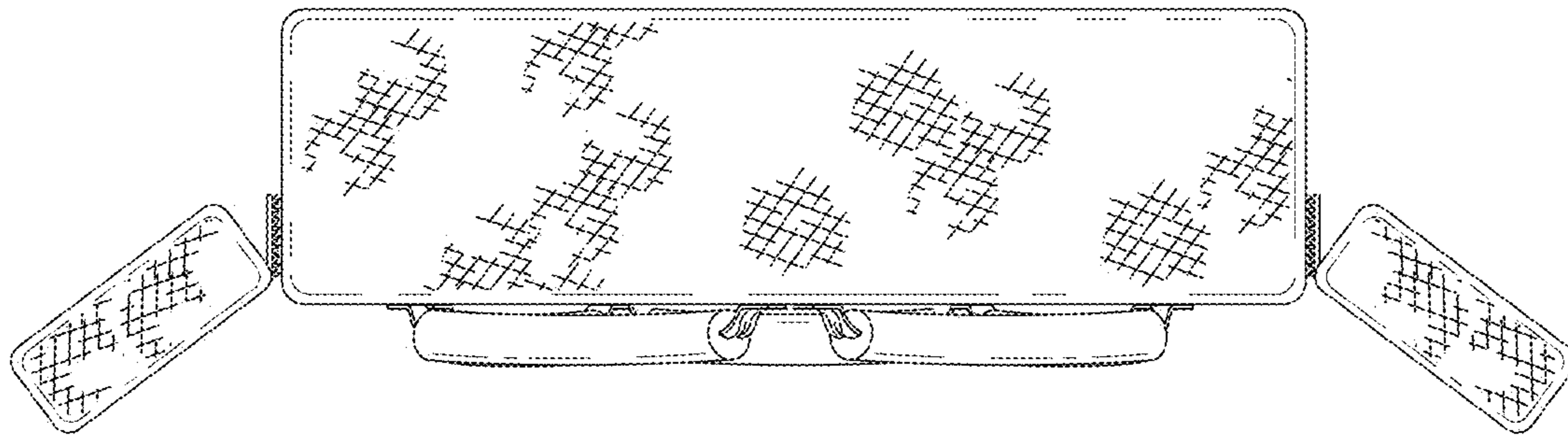

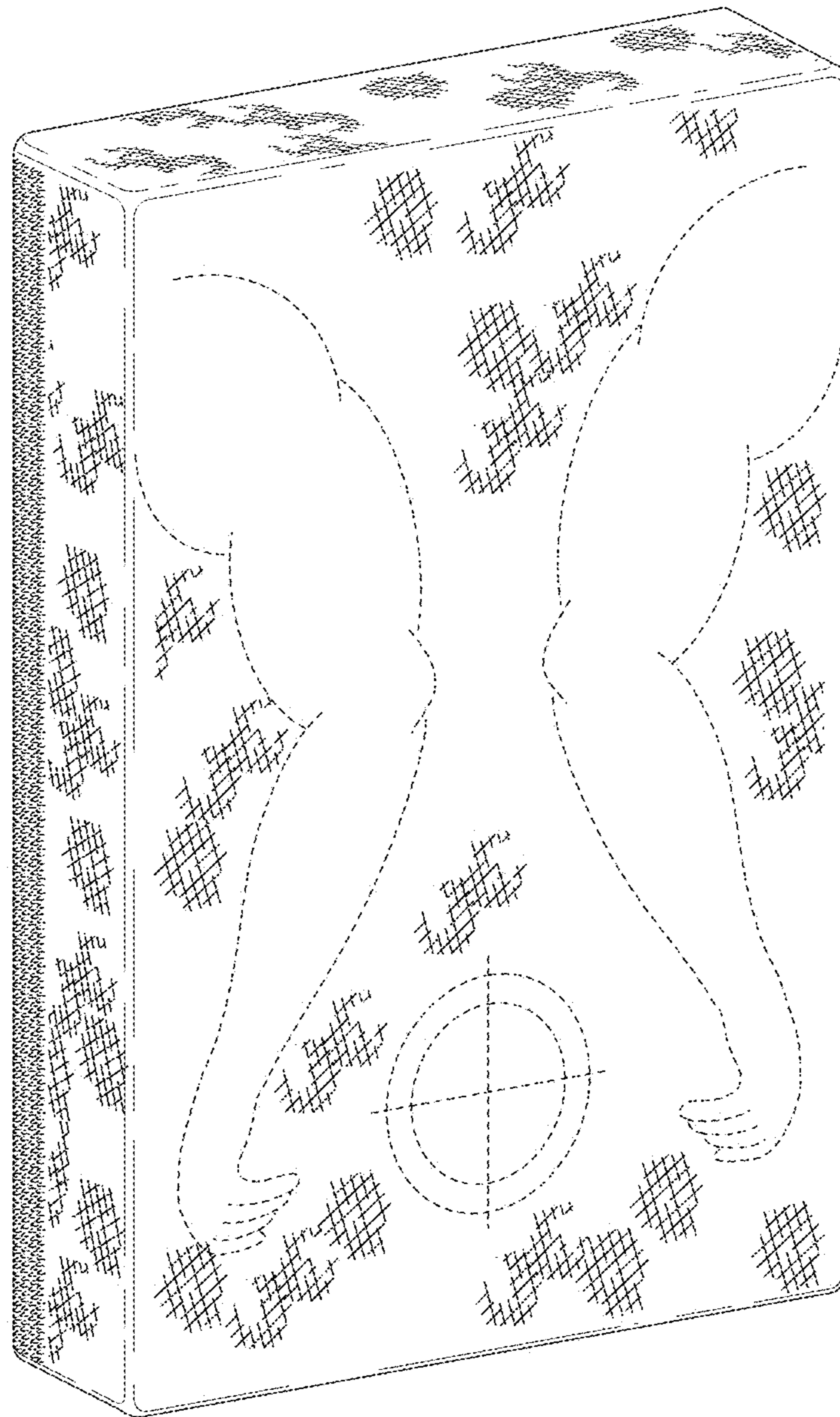

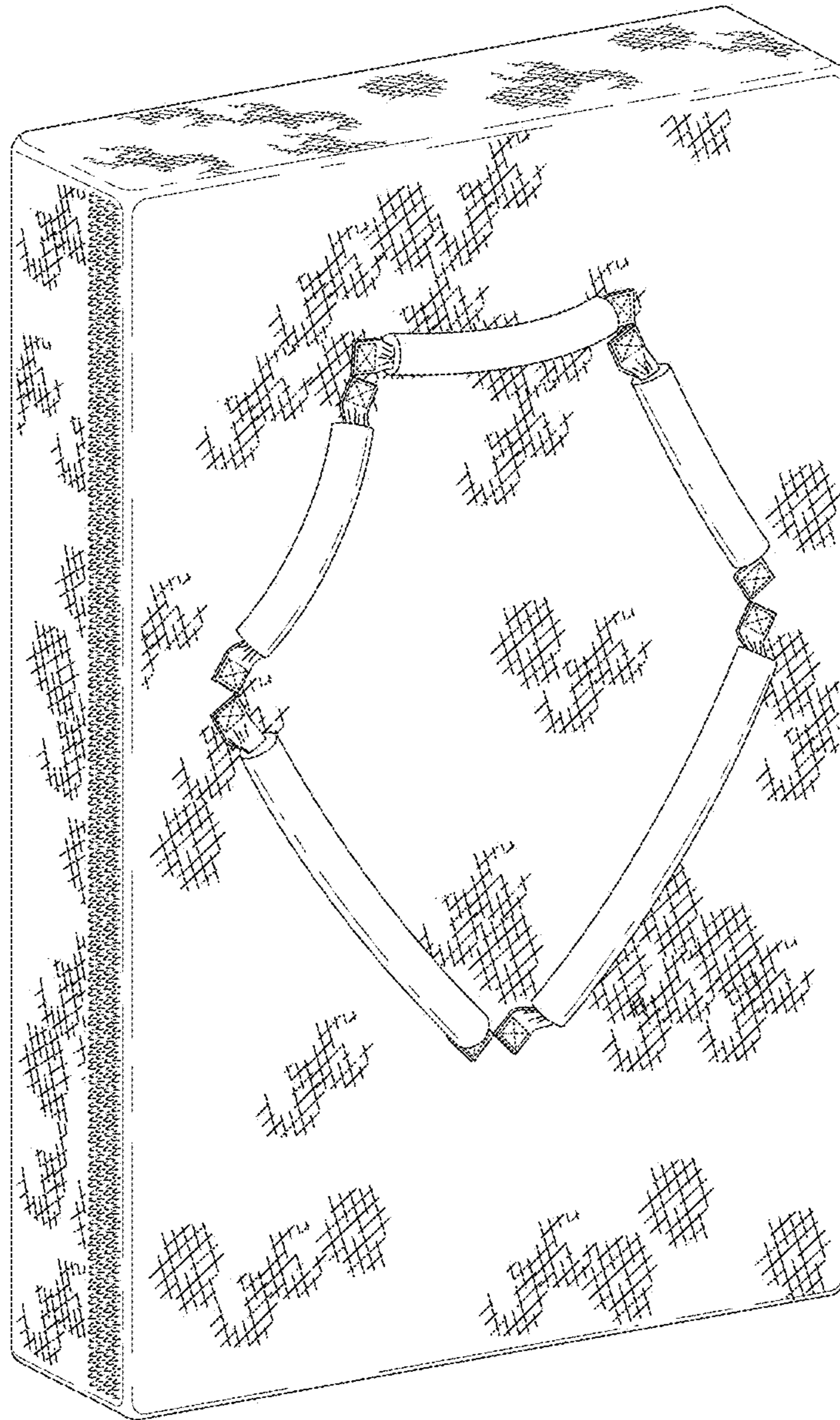

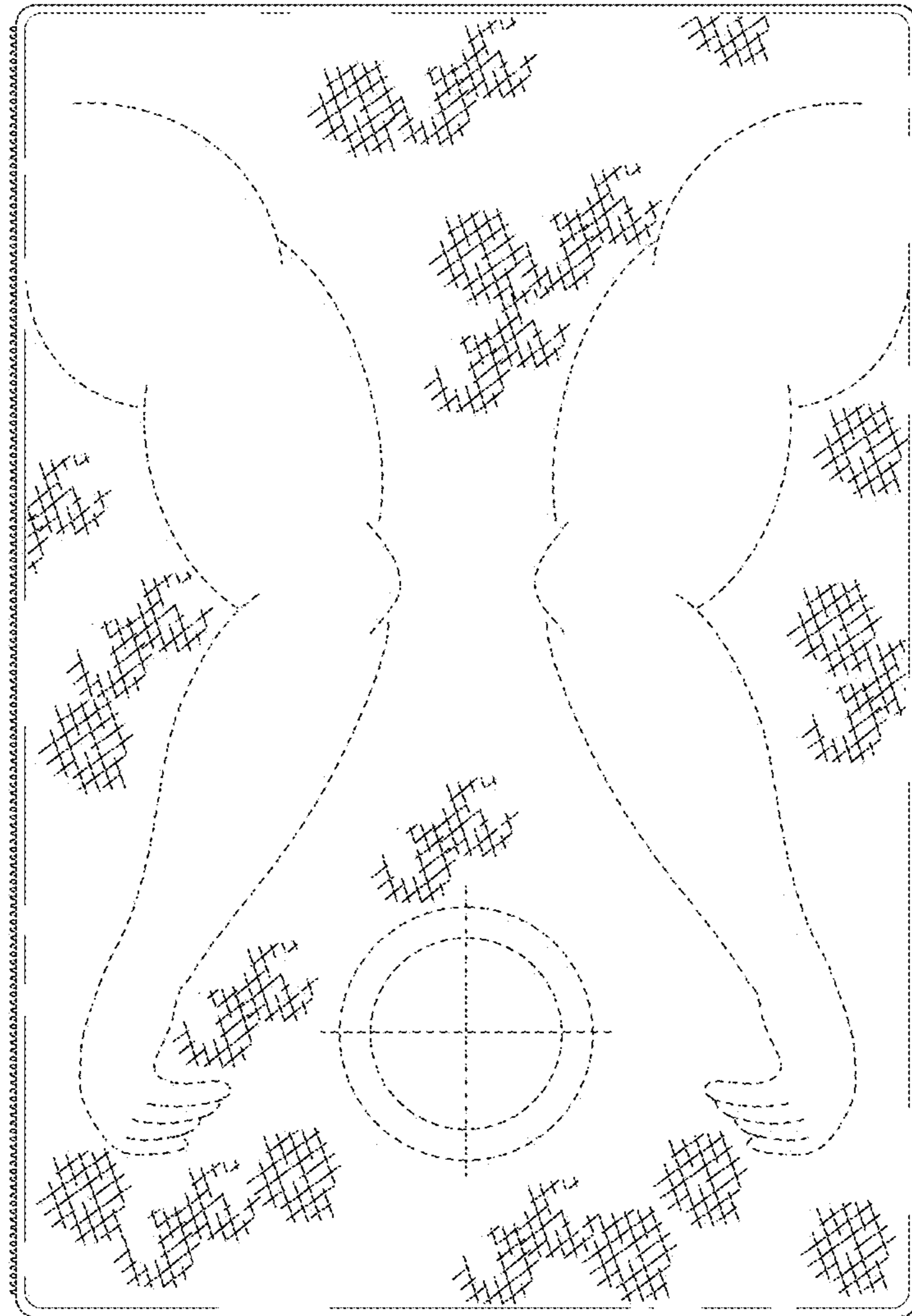

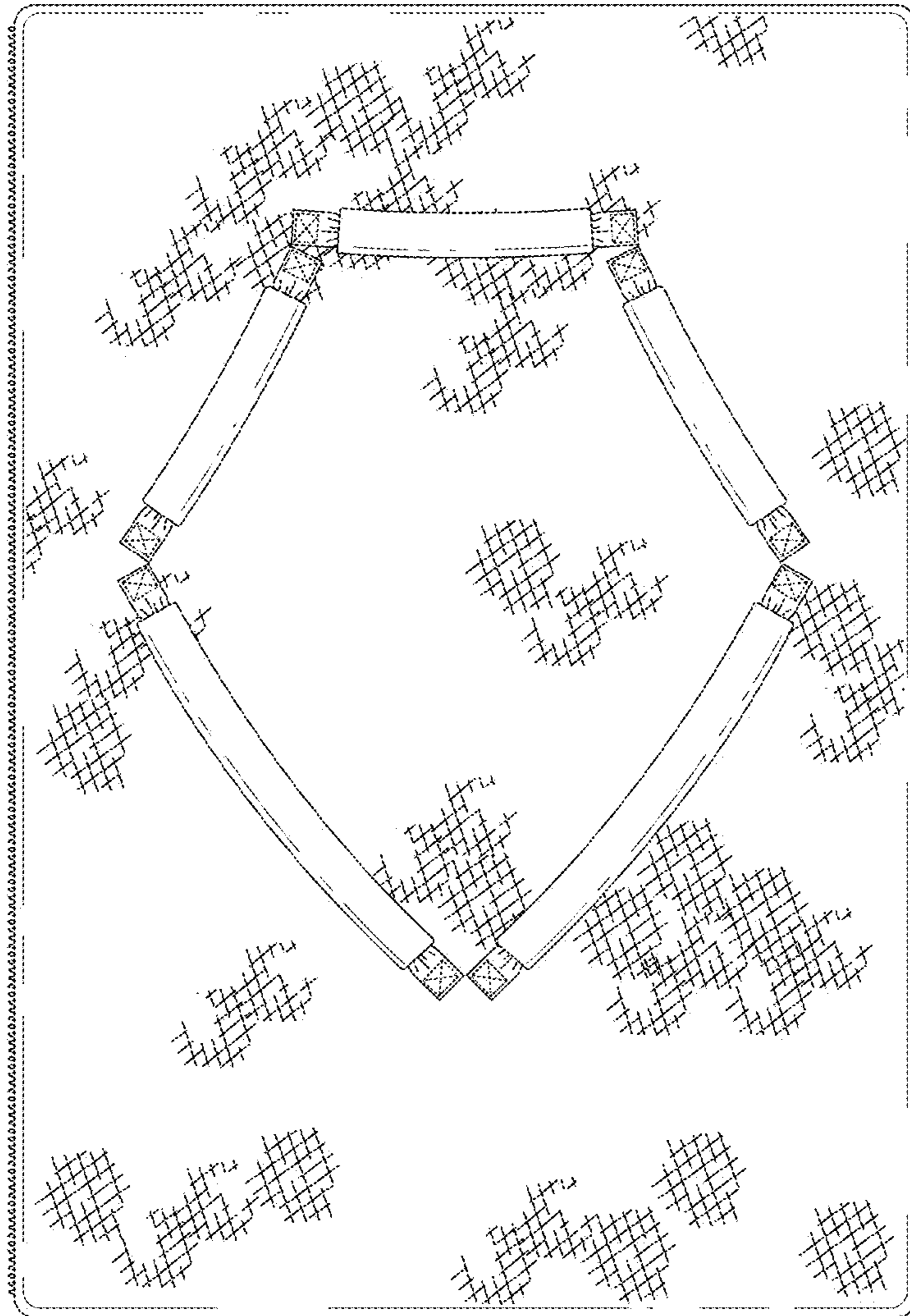

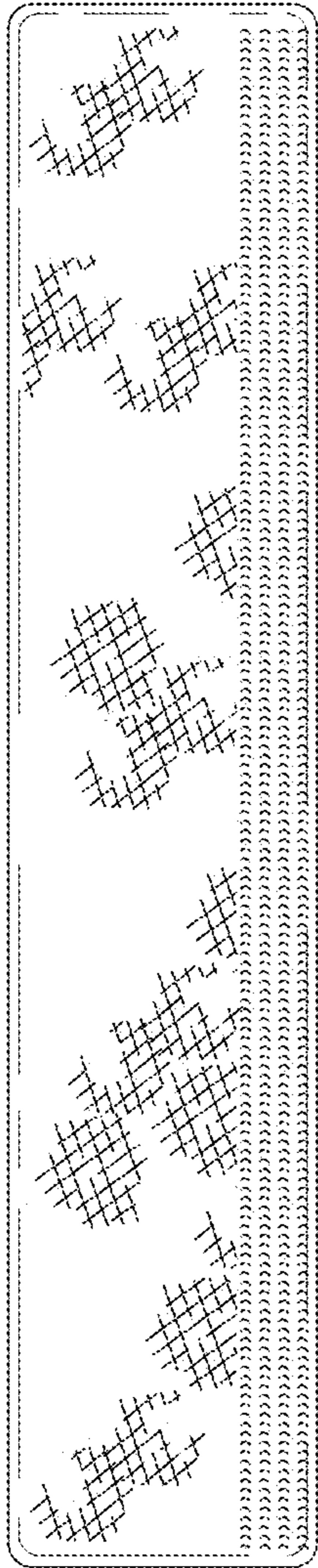

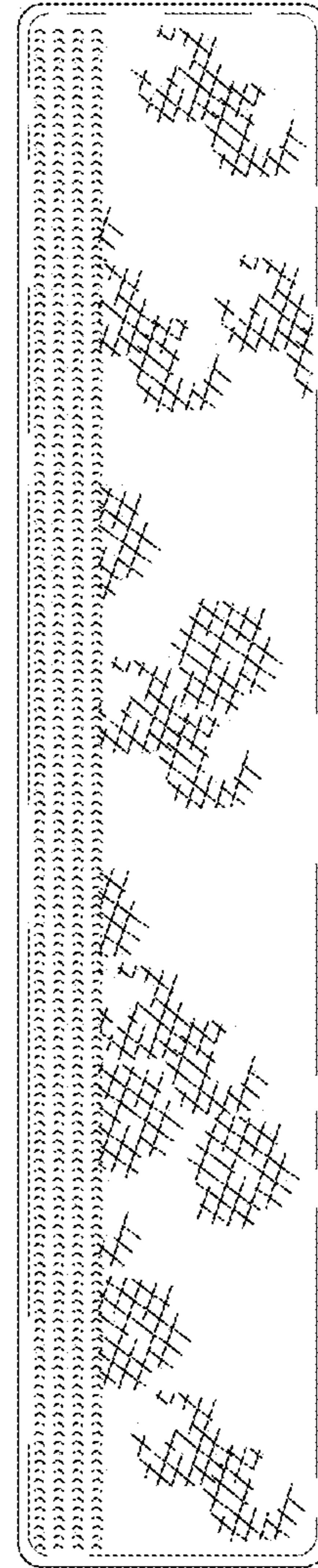

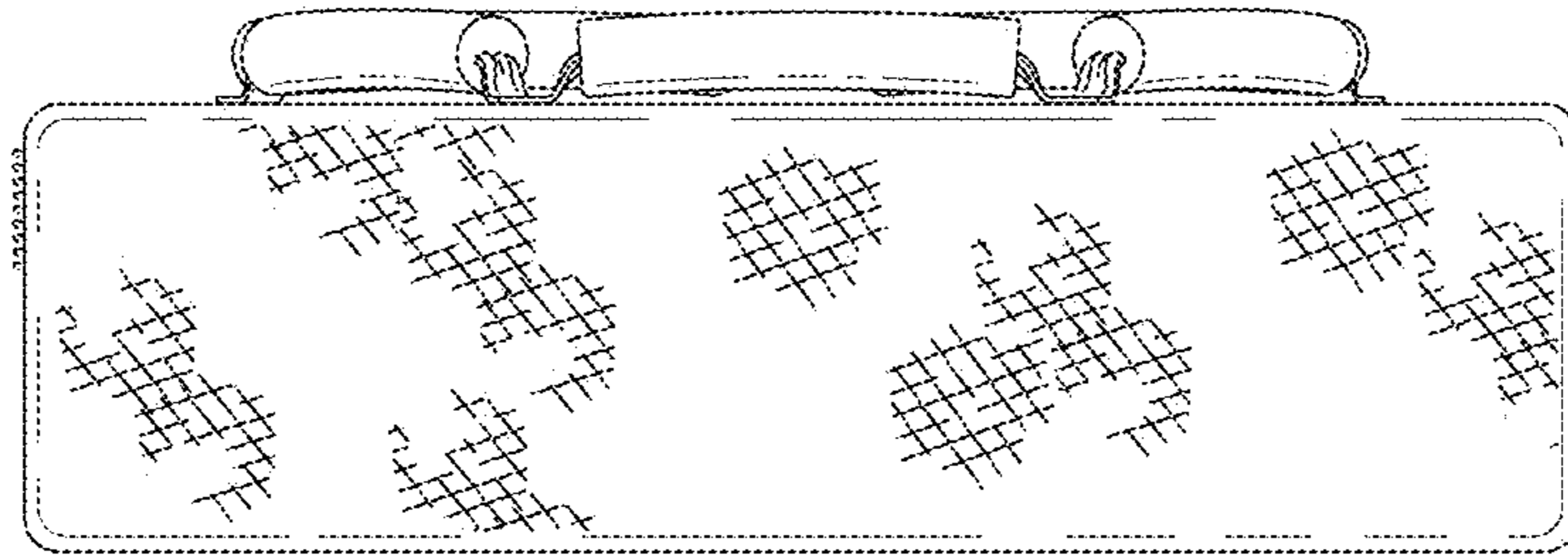

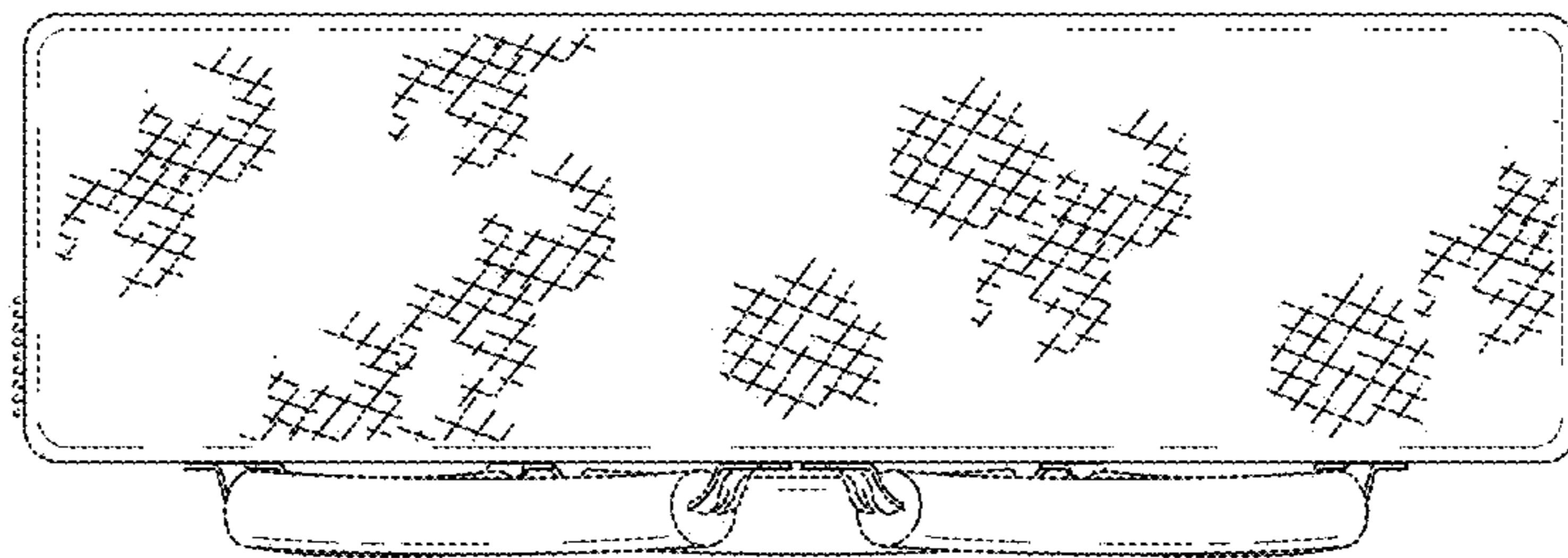

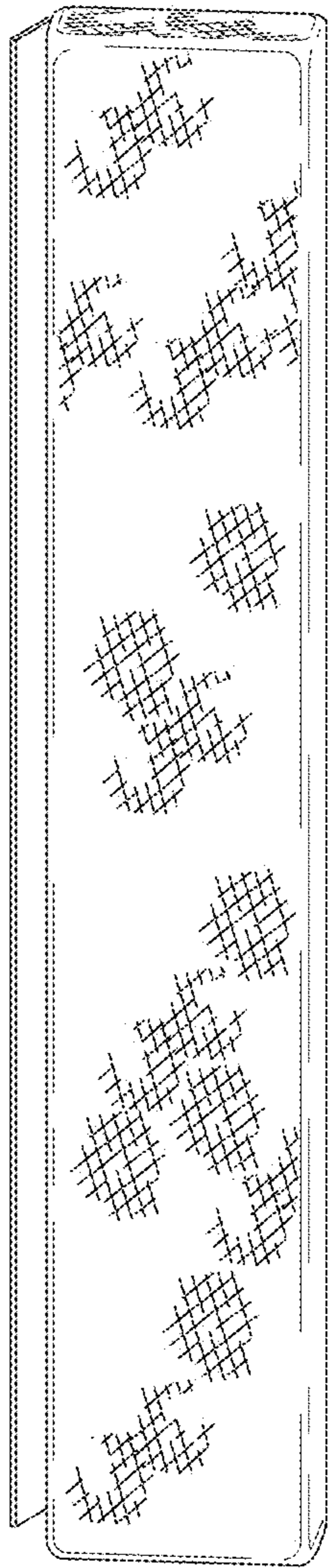

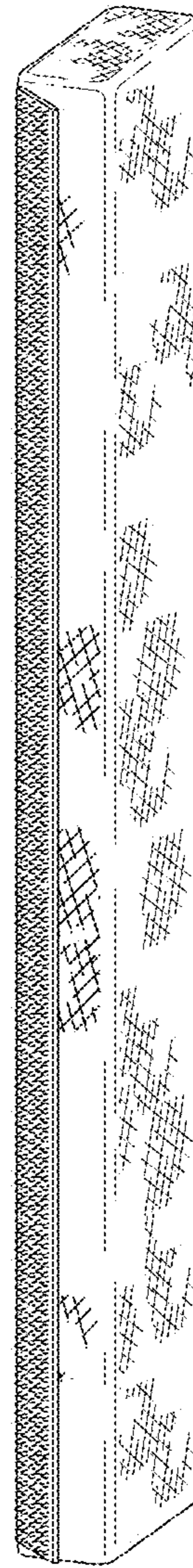

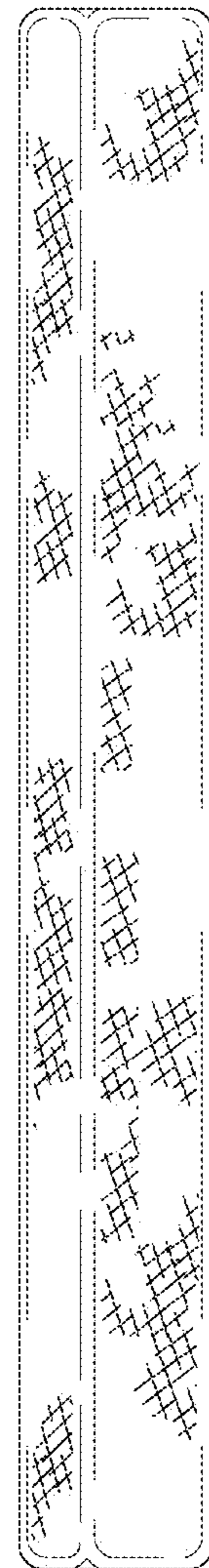
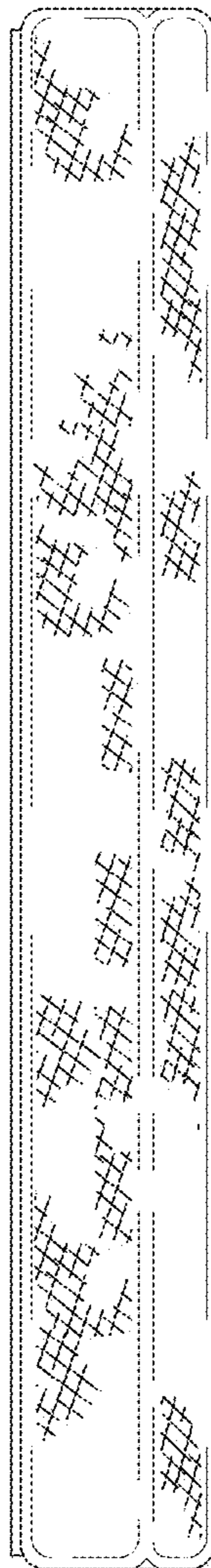
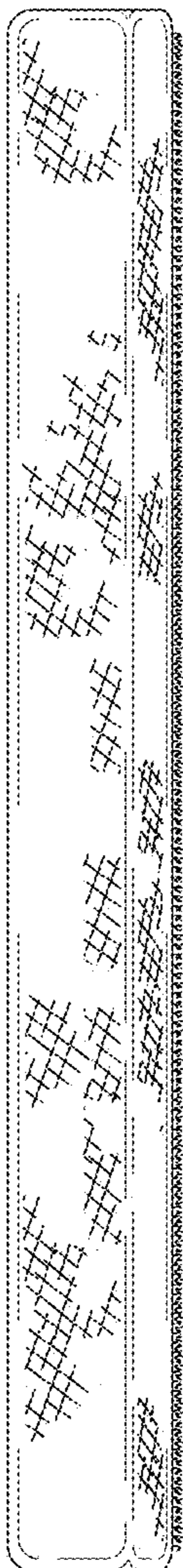

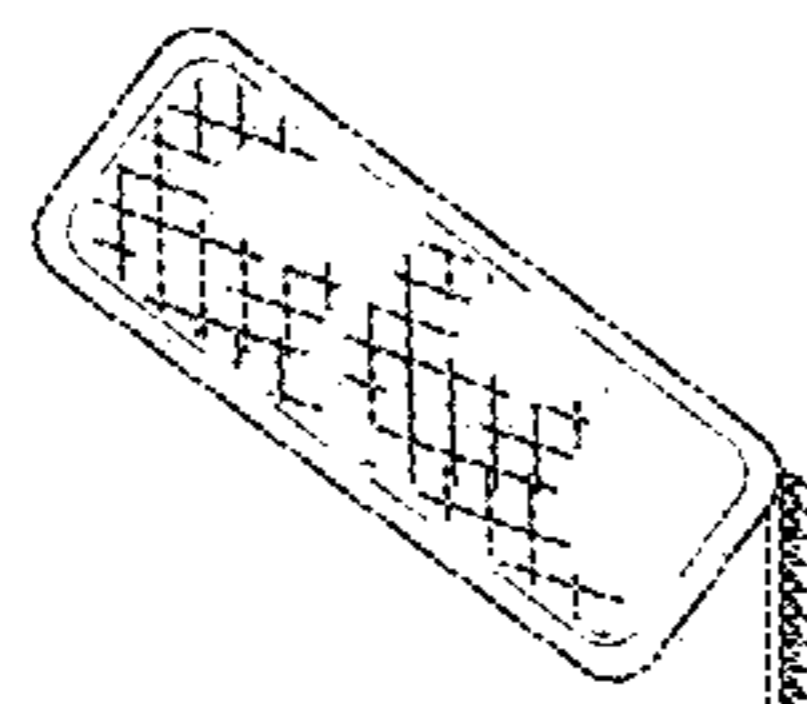

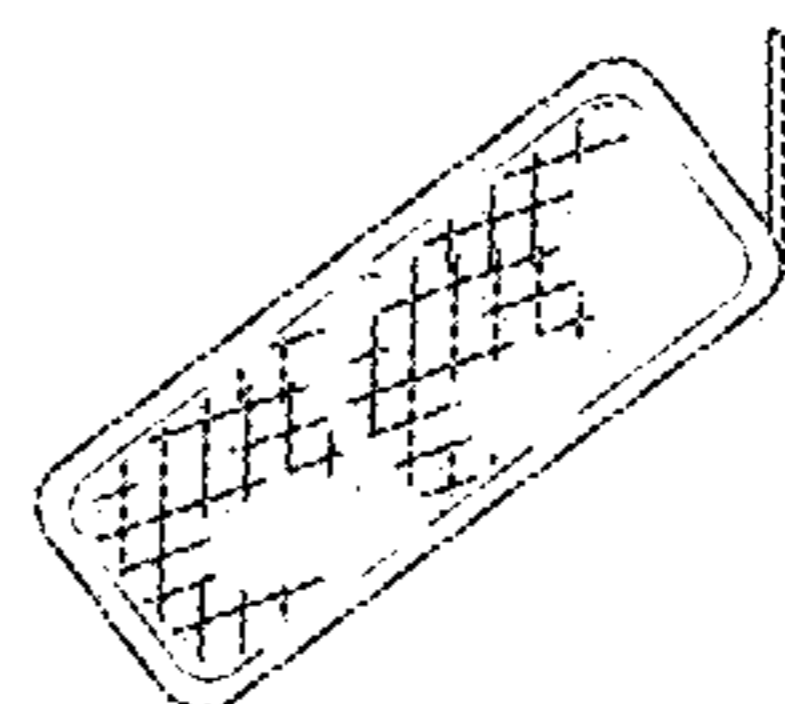
