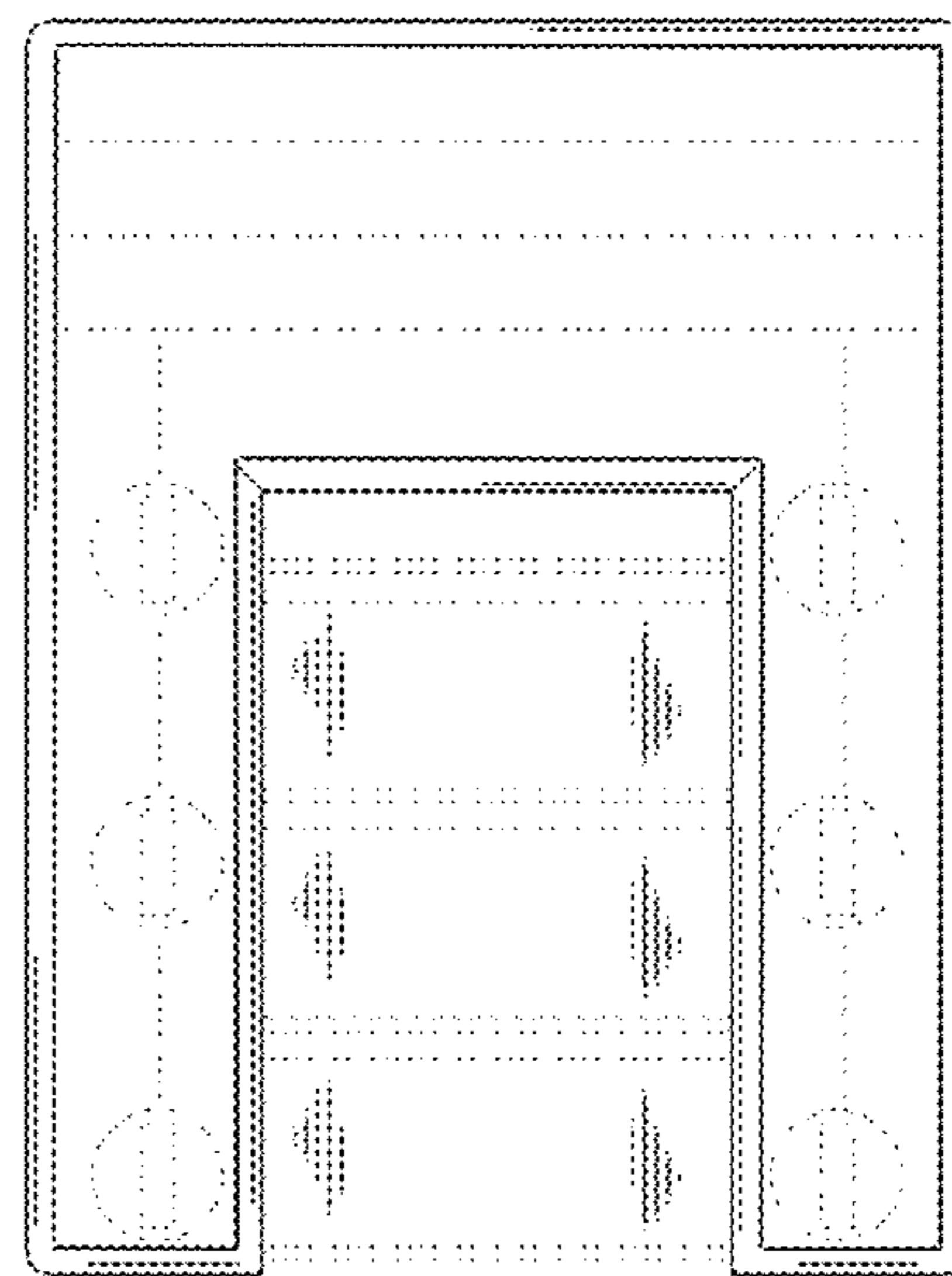
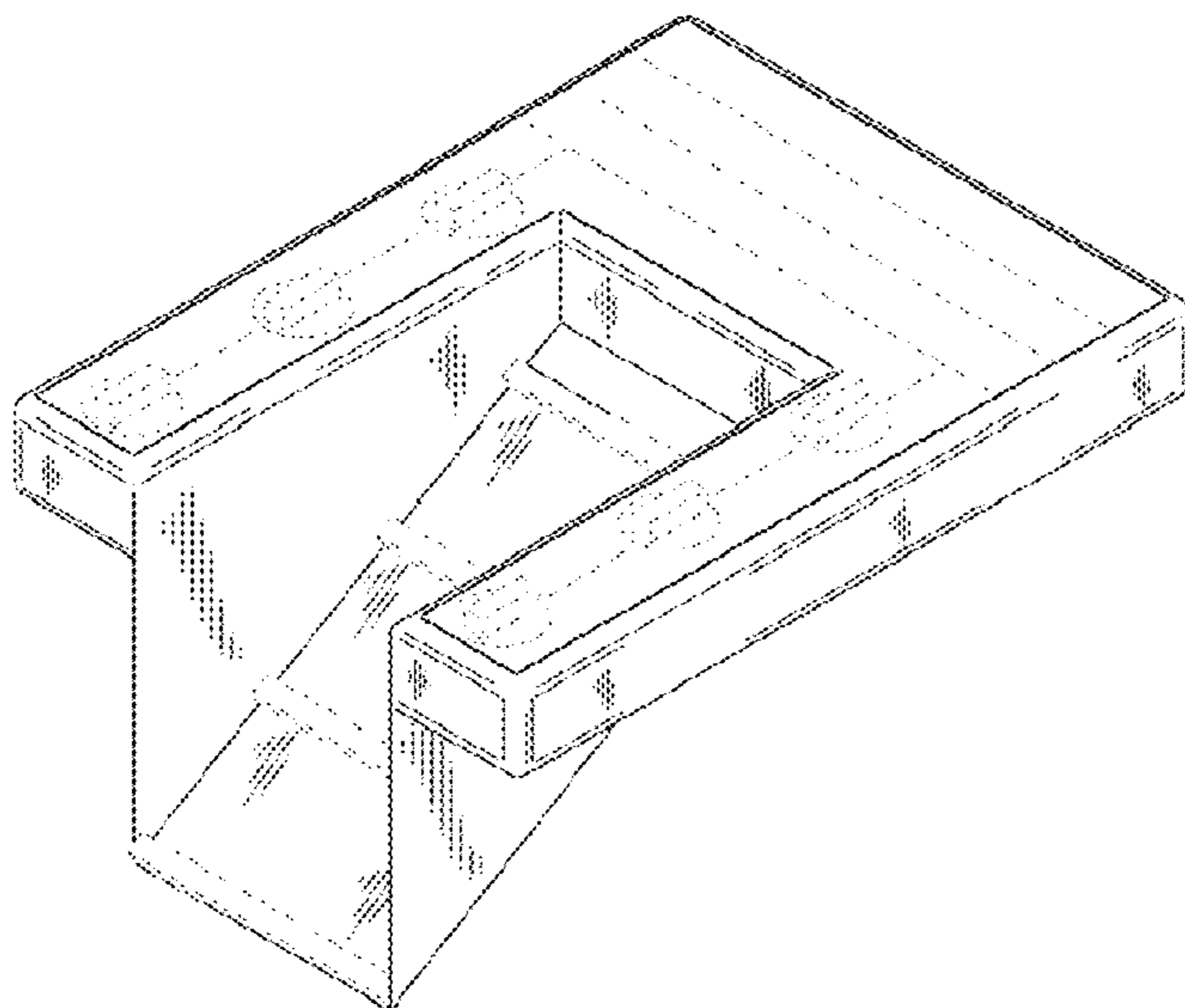
(57) **CLAIM**

The ornamental design for a waterpark float, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the waterpark float.
 FIG. 2 is a top view of the waterpark float.
 FIG. 3 is a bottom view of the waterpark float.
 FIG. 4 is a side view of the waterpark float.
 FIG. 5 is another side view of the waterpark float.
 FIG. 6 is a front view of the waterpark float; and,
 FIG. 7 is rear view of the waterpark float.
 The broken-line features of the waterpark float in FIGS. 1-2 and 4-7, and the broken-outlined bottom of the waterpark float in FIG. 3, are included to illustrate environment but form no part of the claimed design.

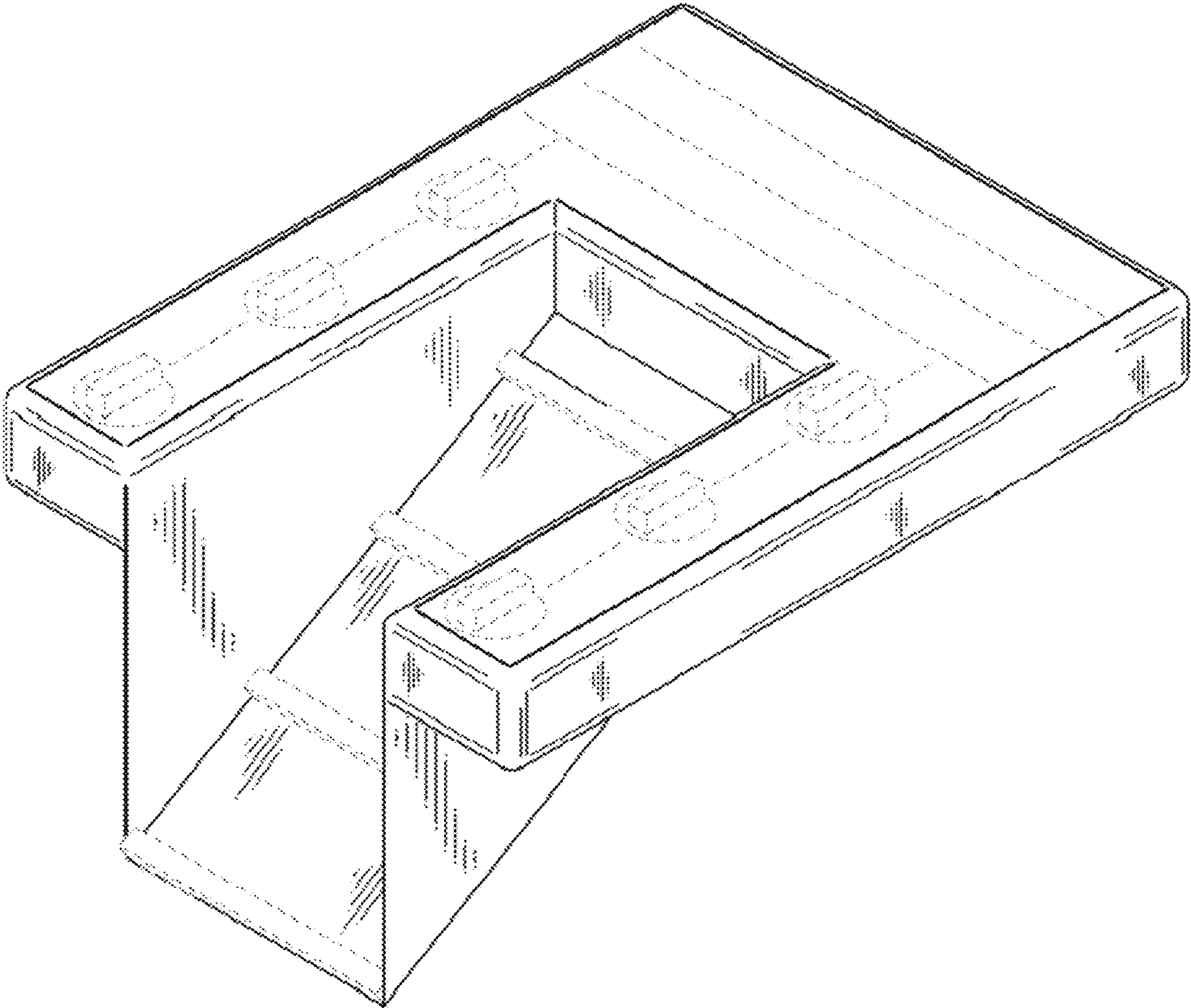

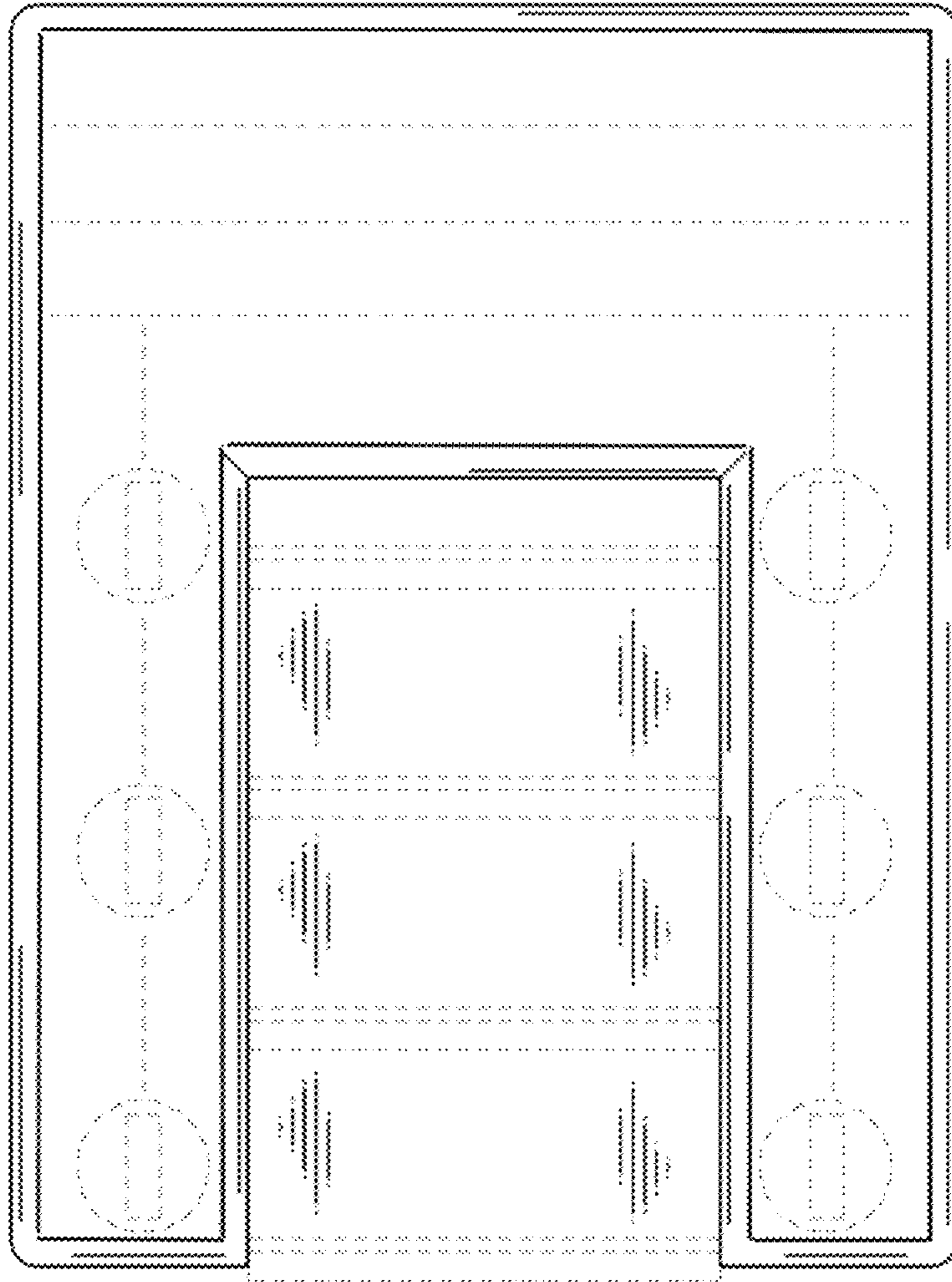

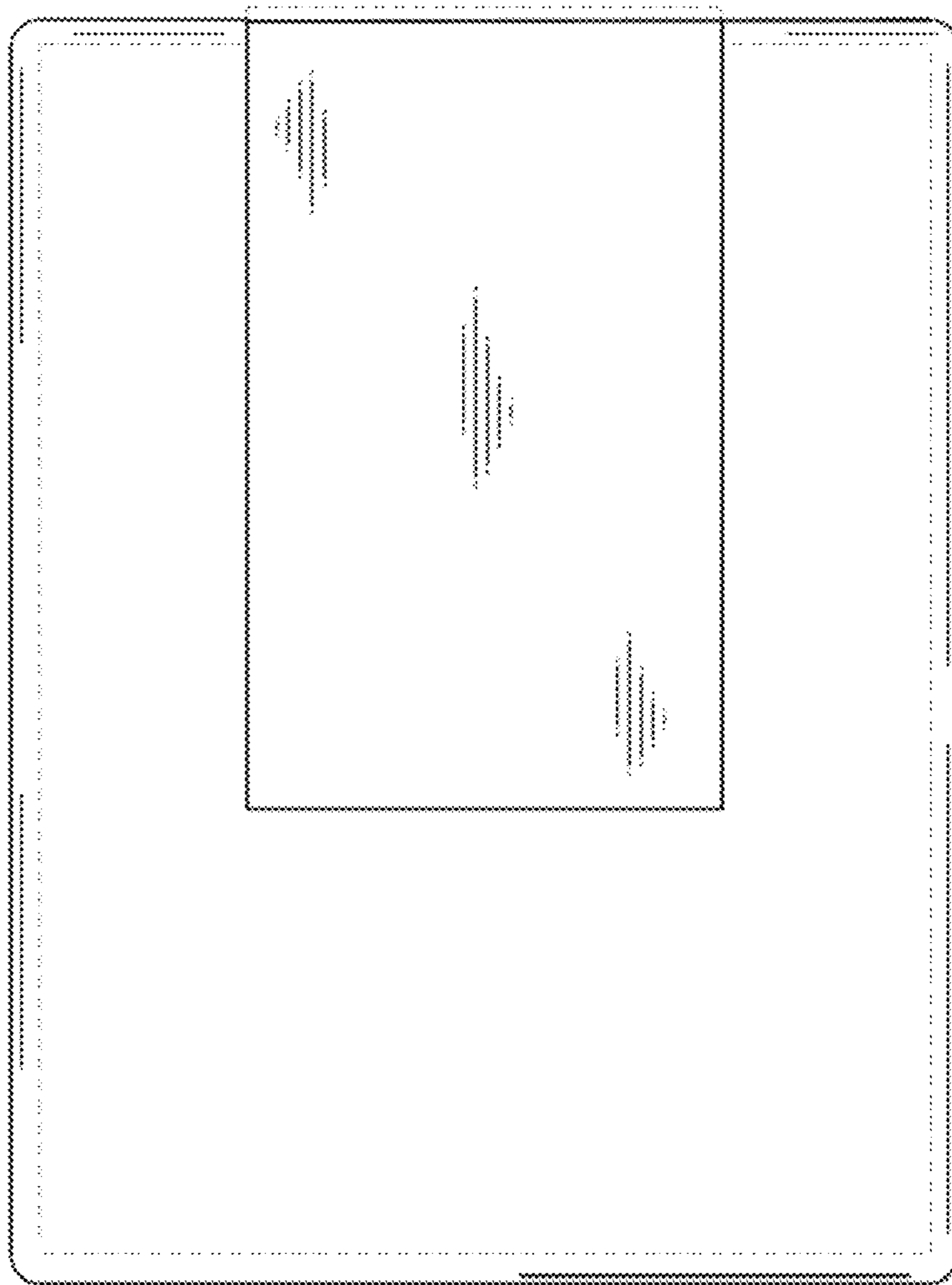

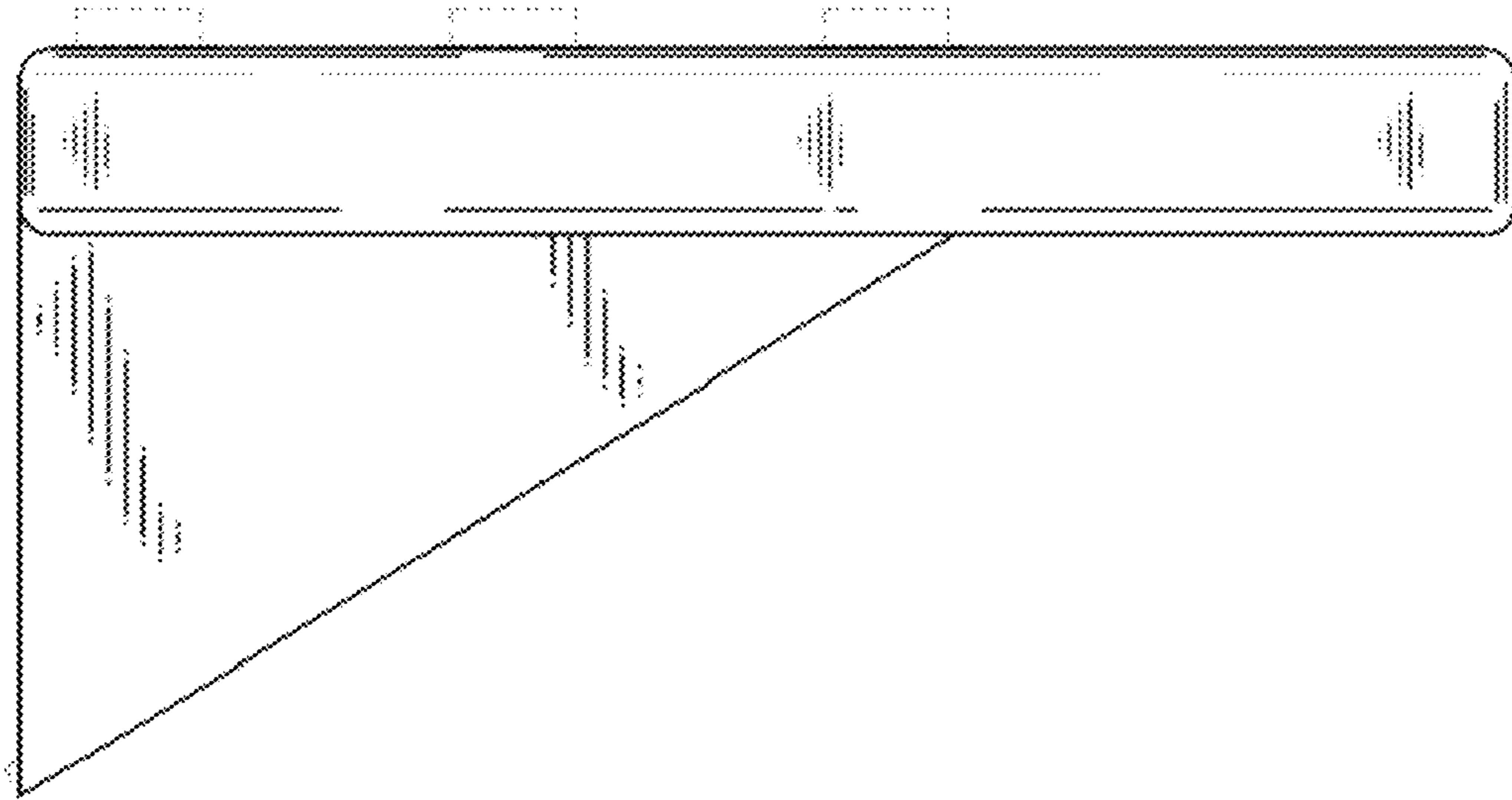

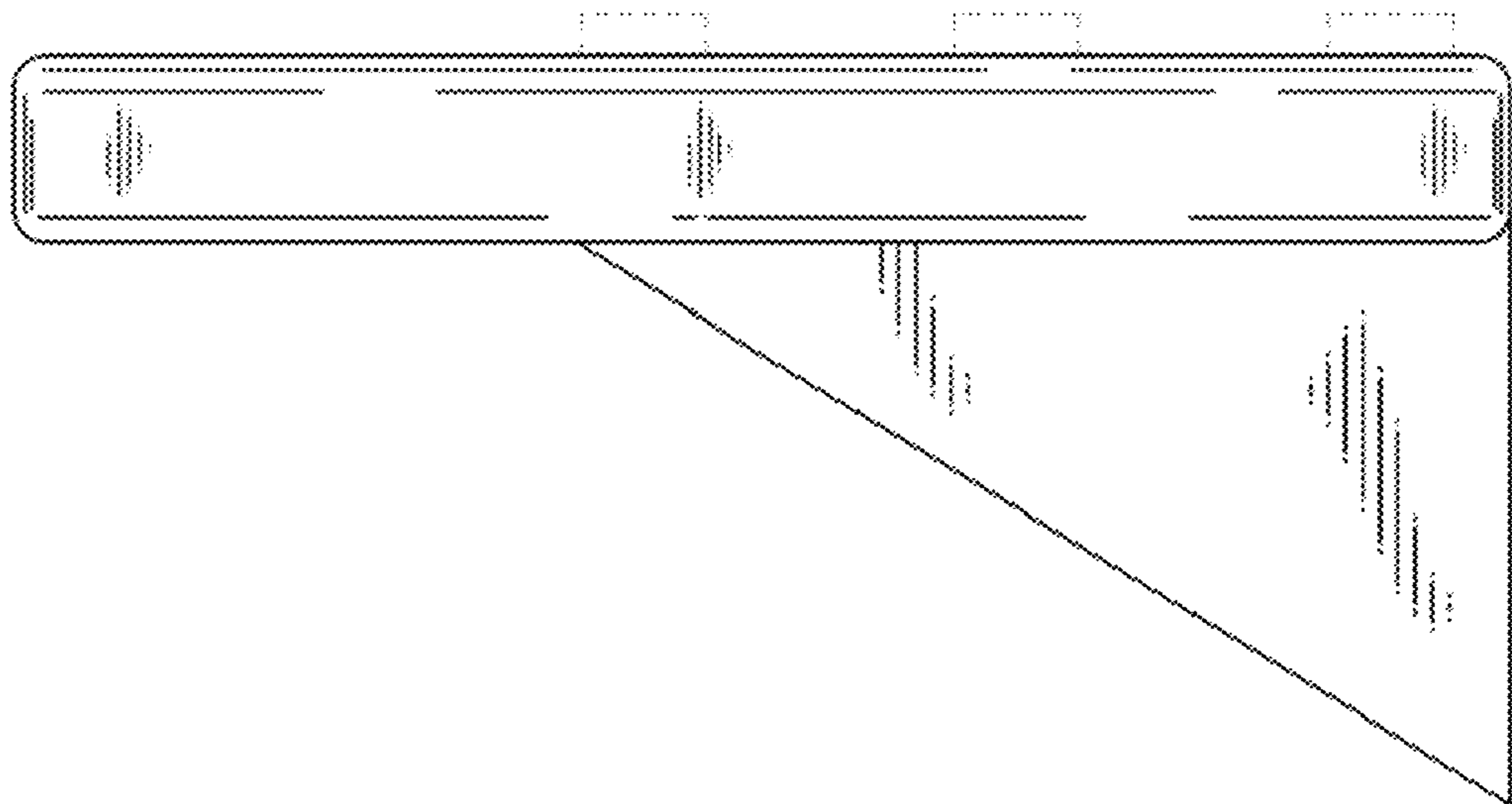

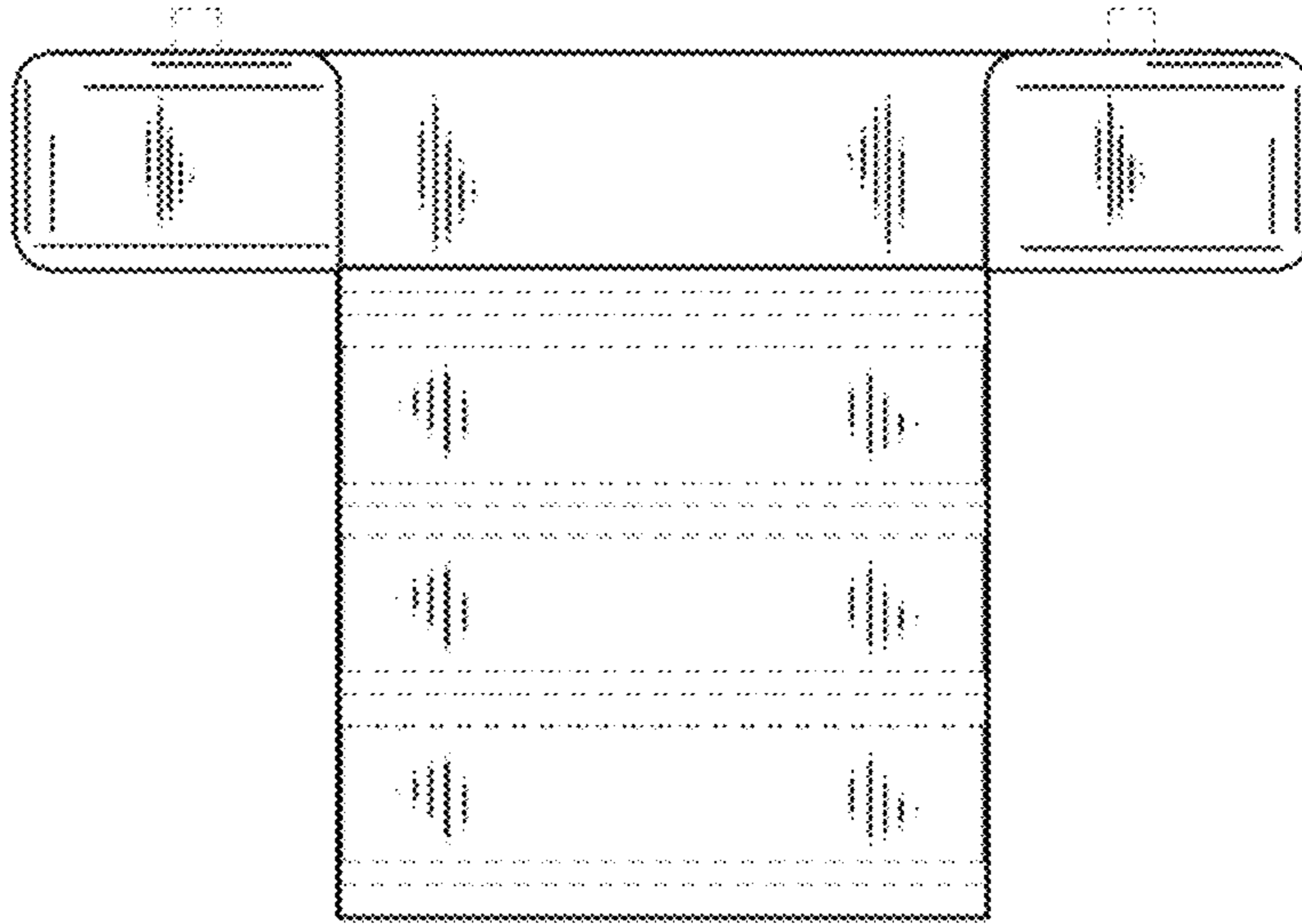

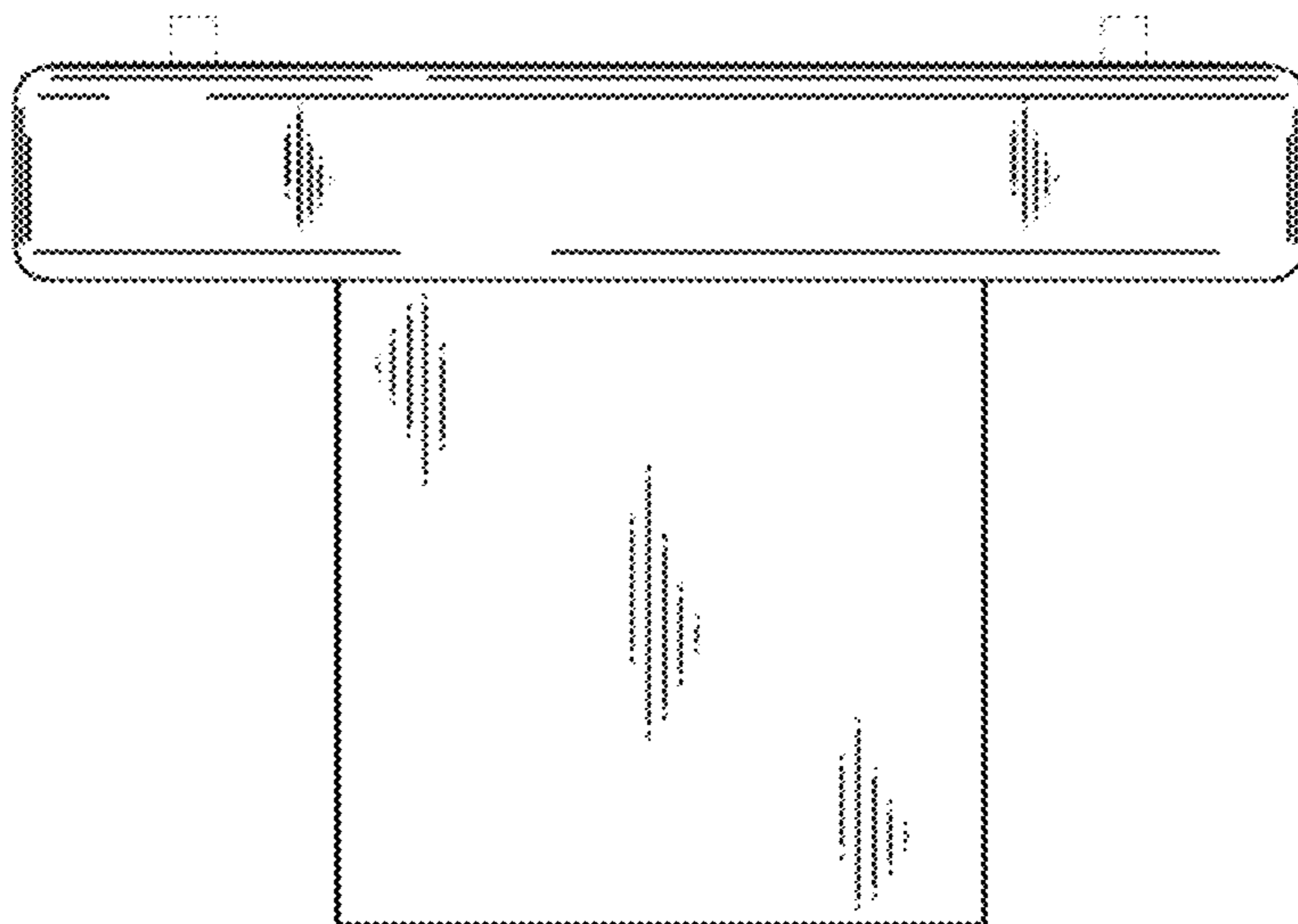
