(57) **CLAIM**

The ornamental design for a "diffuser," as shown and
described.

DESCRIPTION

FIG.1 is a bottom, perspective view of a diffuser in an
inflated state.

FIG. 2 is a front view of the diffuser of FIG. 1. The rear view
of the diffuser of FIG. 1 is the same as FIG. 2.

FIG. 3 is a left side view of the diffuser of FIG. 1.

FIG. 4 is a right side view of the diffuser of FIG. 1.

FIG. 5 is a bottom view of the diffuser of FIG. 1.

FIG. 6 is a bottom, perspective view of a diffuser in a
deflated state.

FIG. 7 is a front view of the diffuser of FIG. 6. The rear view
of the diffuser of FIG. 6 is the same as FIG. 7.

FIG. 8 is a left side view of the diffuser of FIG. 6.

FIG. 9 is a right side view of the diffuser of FIG. 6.

FIG. 10 is a bottom view of the diffuser of FIG. 6.

FIG. 11 is a bottom, perspective view of a diffuser in an
inflated state.

FIG. 12 is a front view of the diffuser of FIG. 11. The rear
view of the diffuser of FIG. 11 is the same as FIG. 12.

FIG. 13 is a left side view of the diffuser of FIG. 11.

FIG. 14 is a right side view of the diffuser of FIG. 11.

FIG. 15 is a bottom view of the diffuser of FIG. 11.

FIG. 16 is a bottom, perspective view of a diffuser in a
deflated state.

FIG. 17 is a front view of the diffuser of FIG. 16, The rear
view of the diffuser of FIG. 16 is the same as FIG. 17.

FIG. 18 is a left side view of the diffuser of FIG. 16.

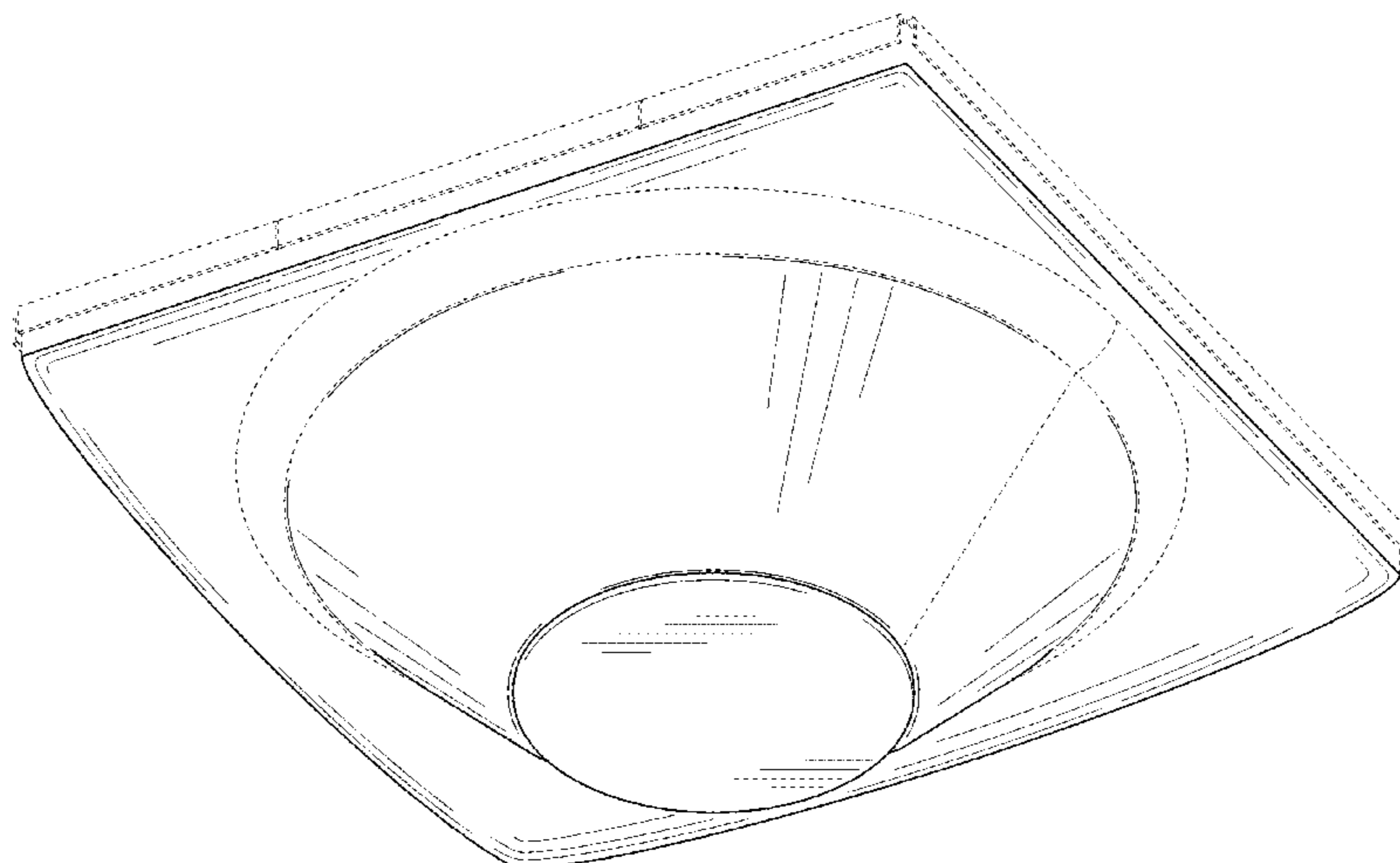
FIG. 19 is a right side view of the diffuser of FIG. 16; and,

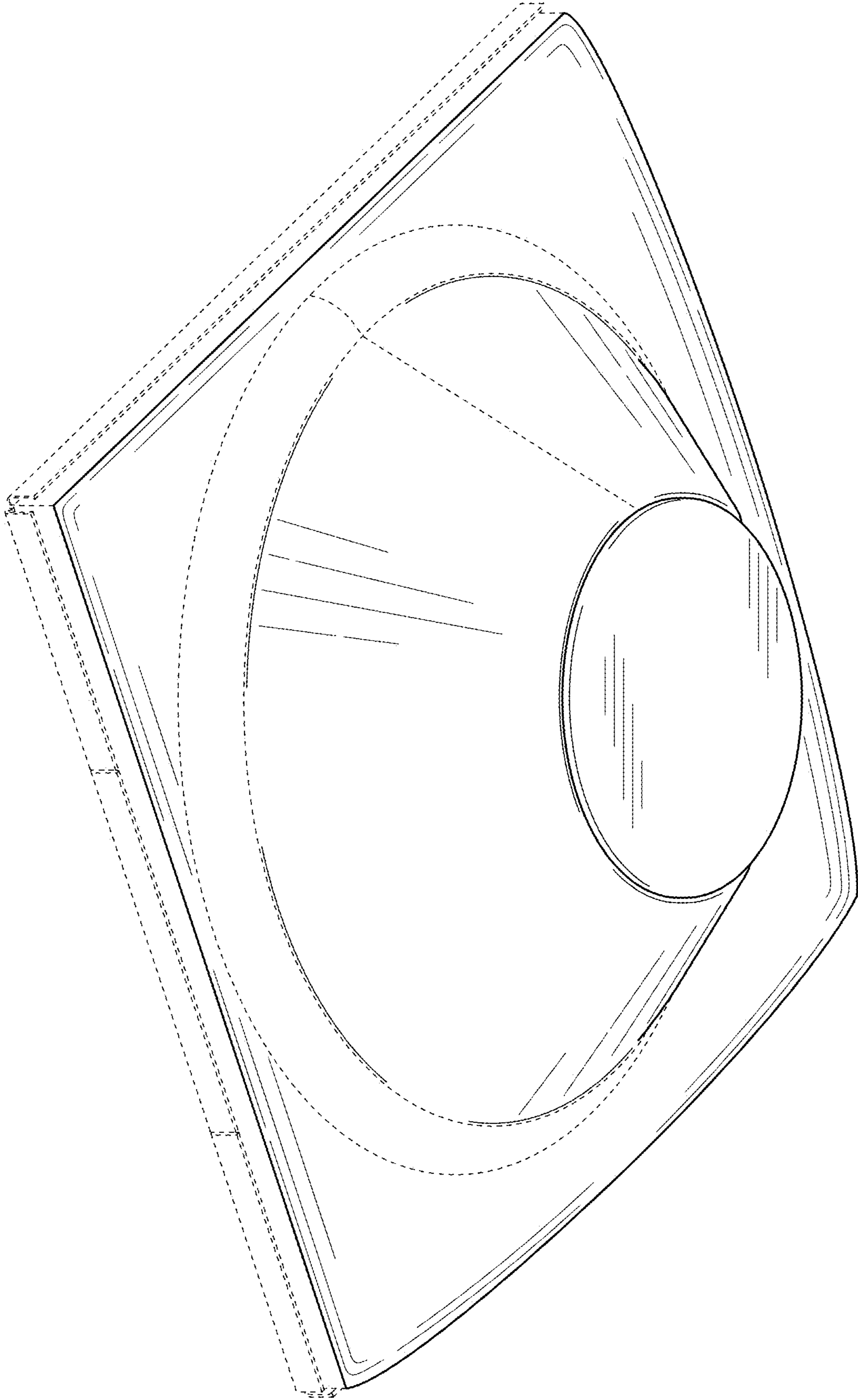

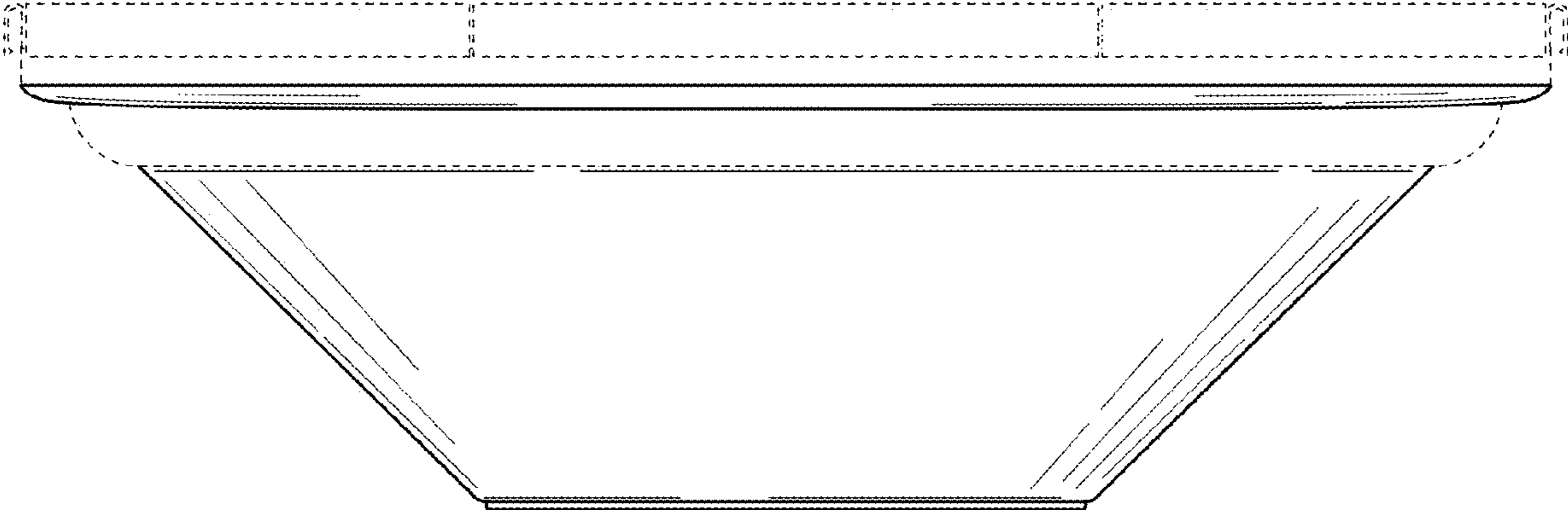

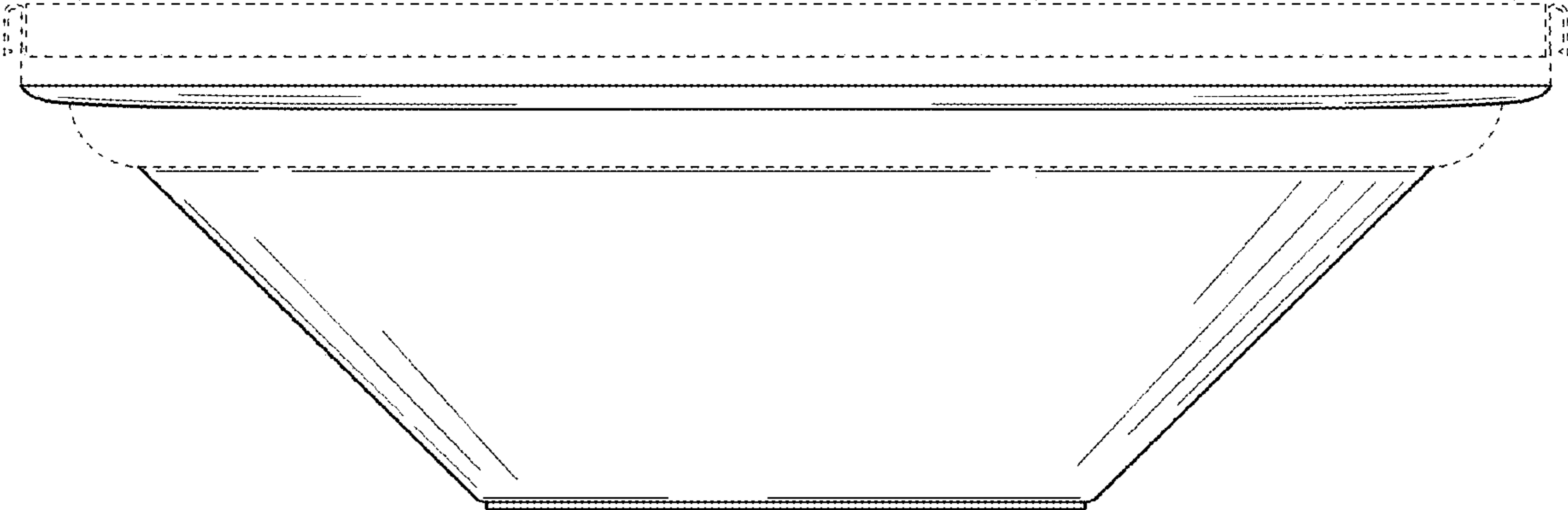

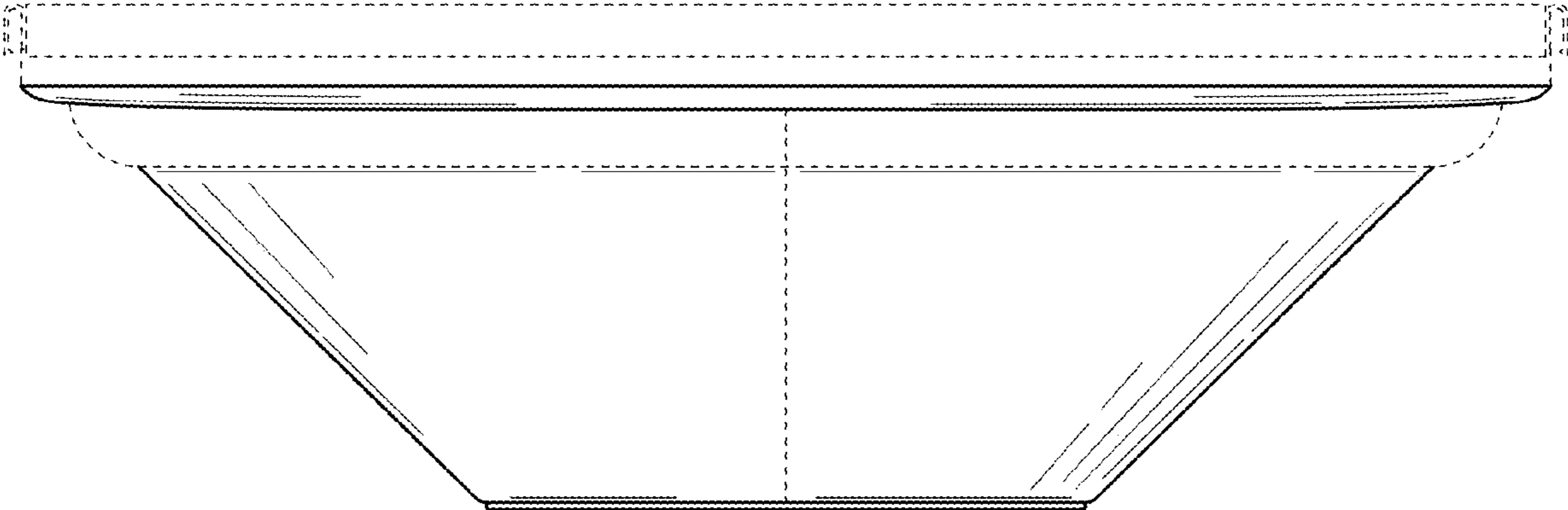

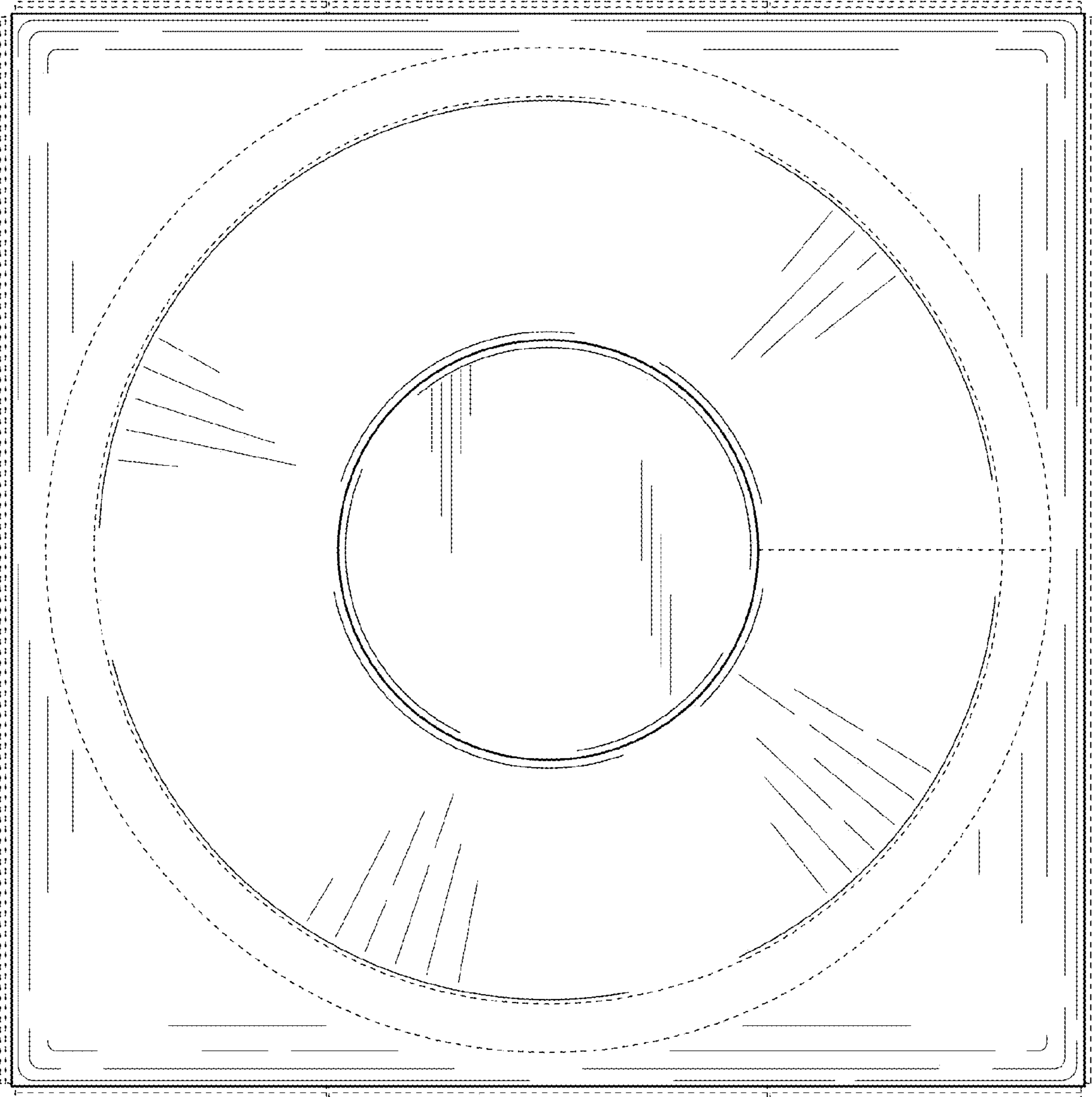

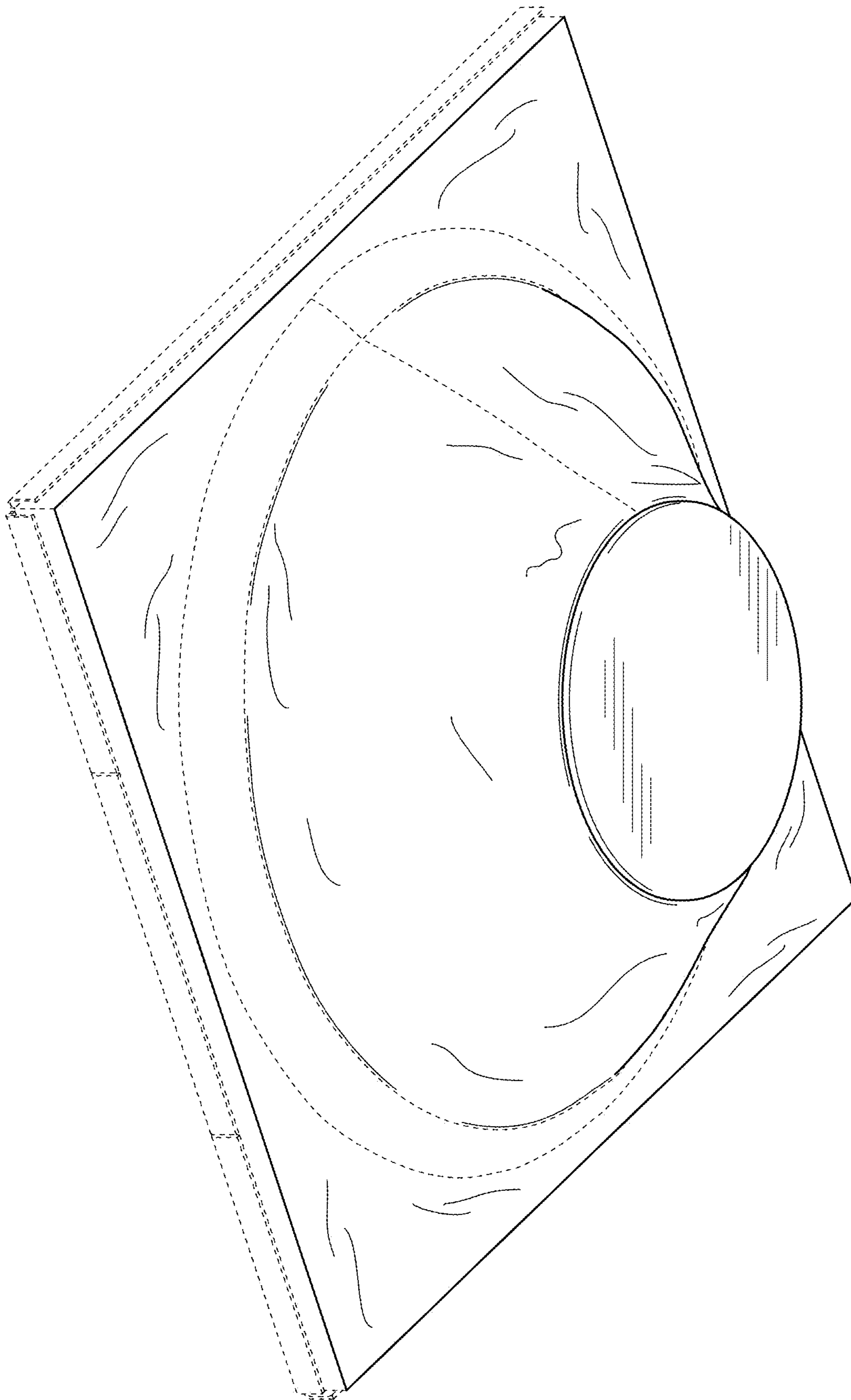

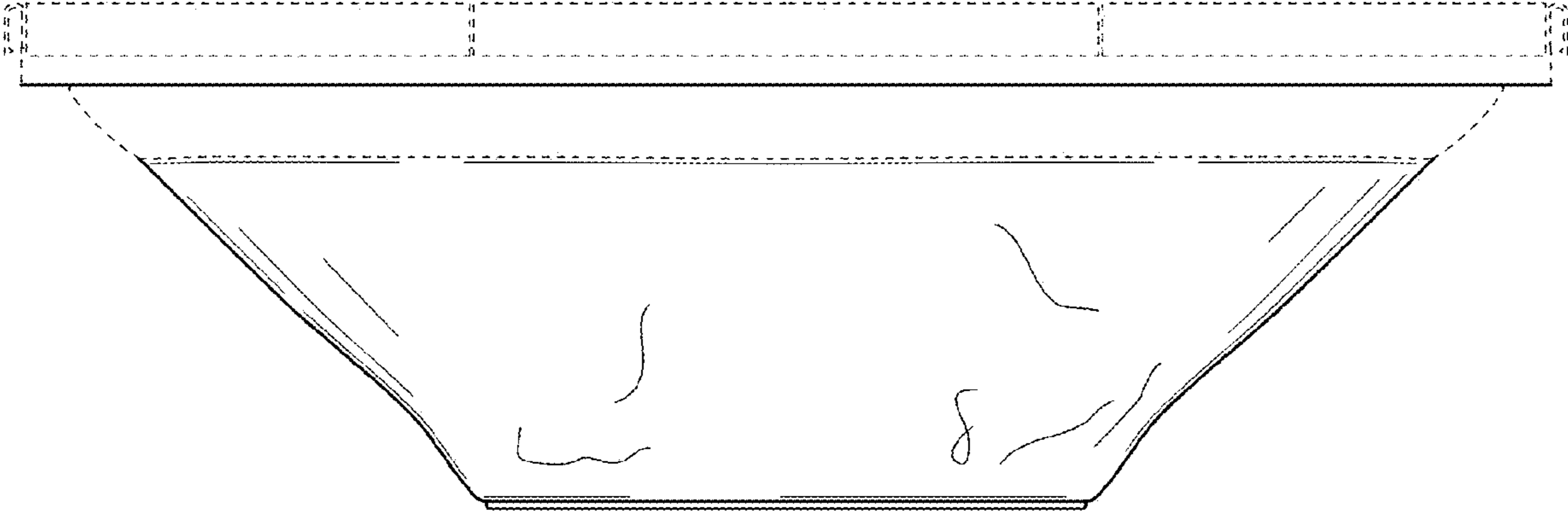

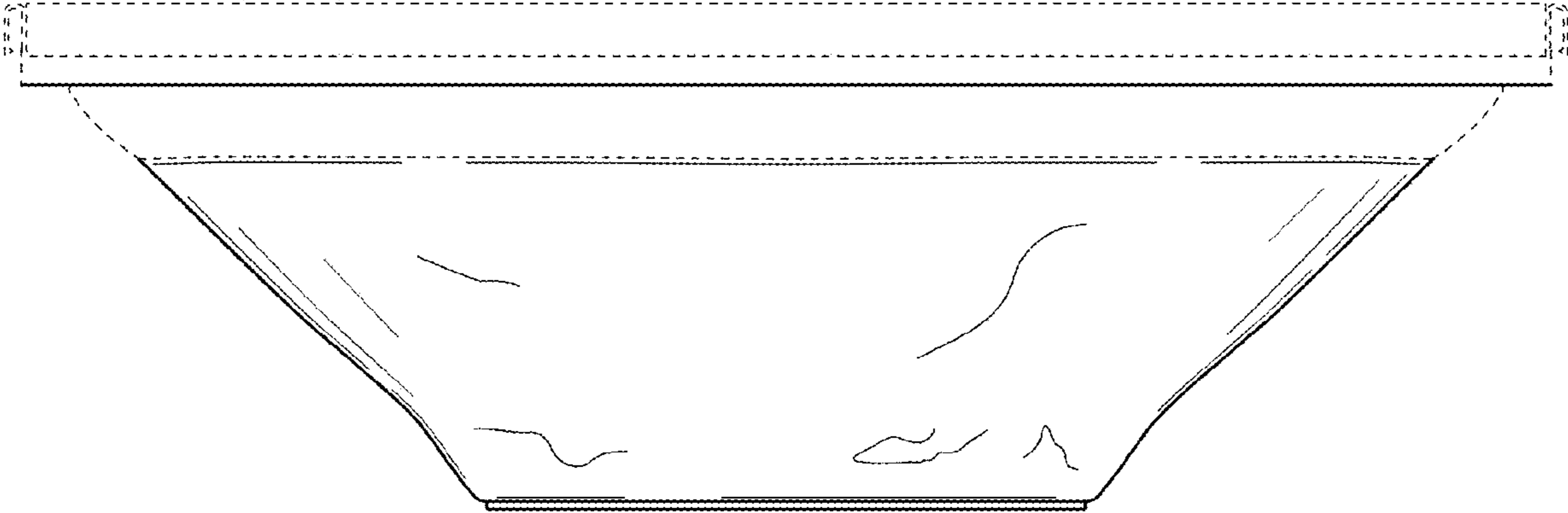

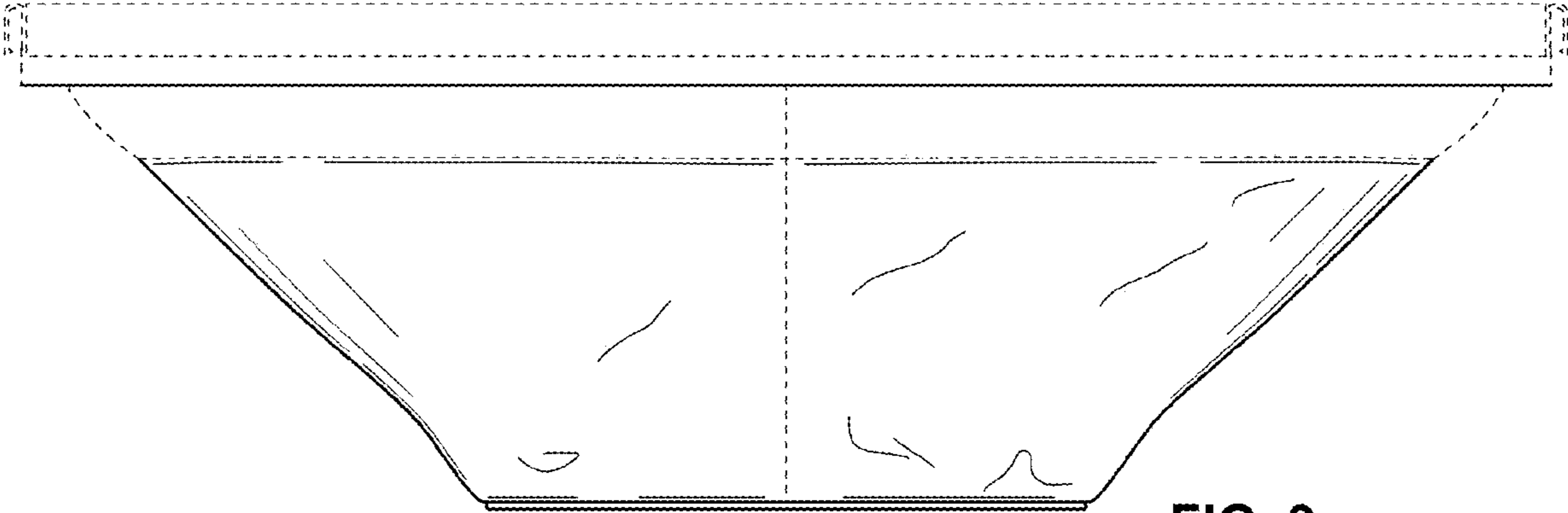

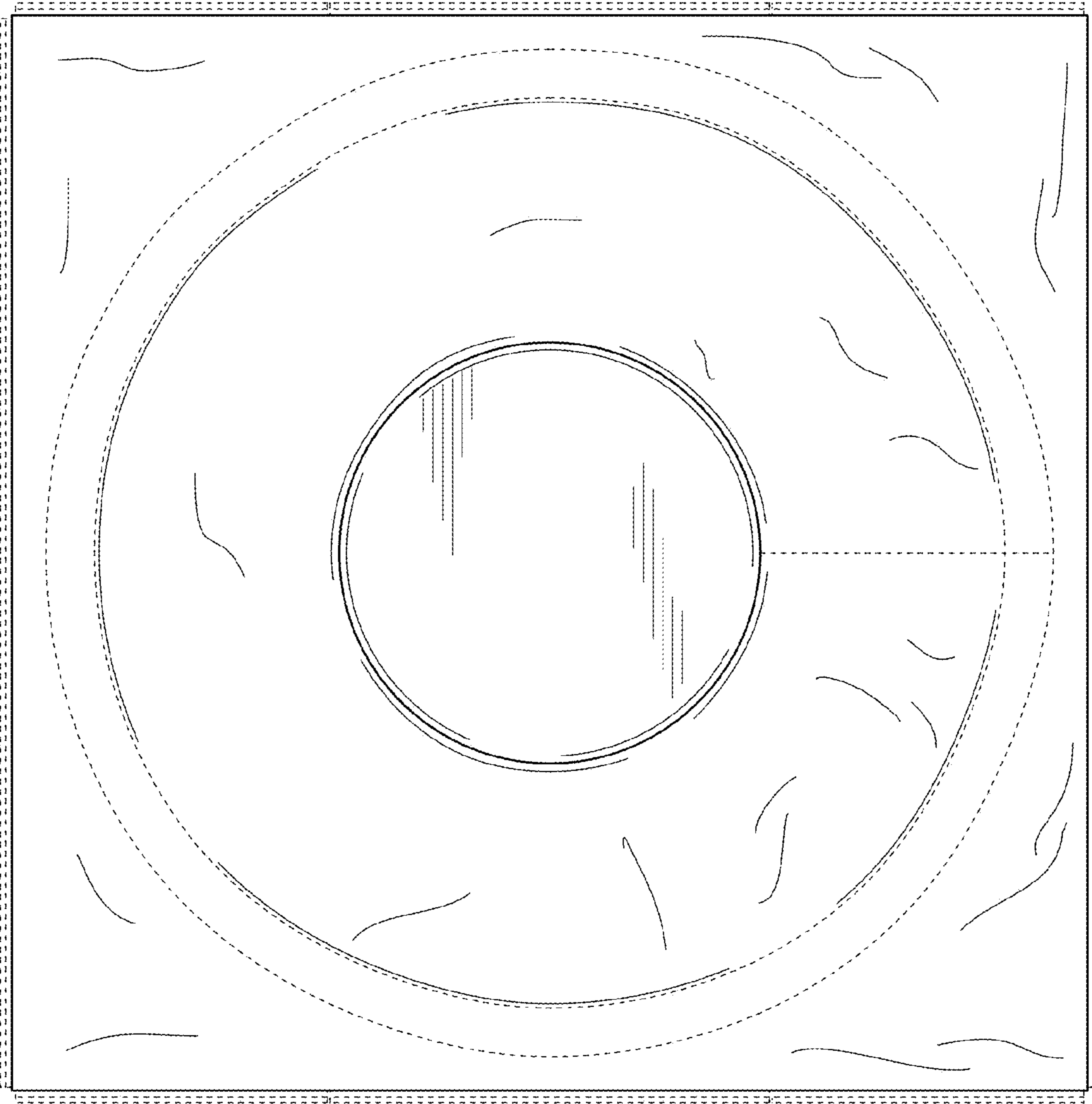

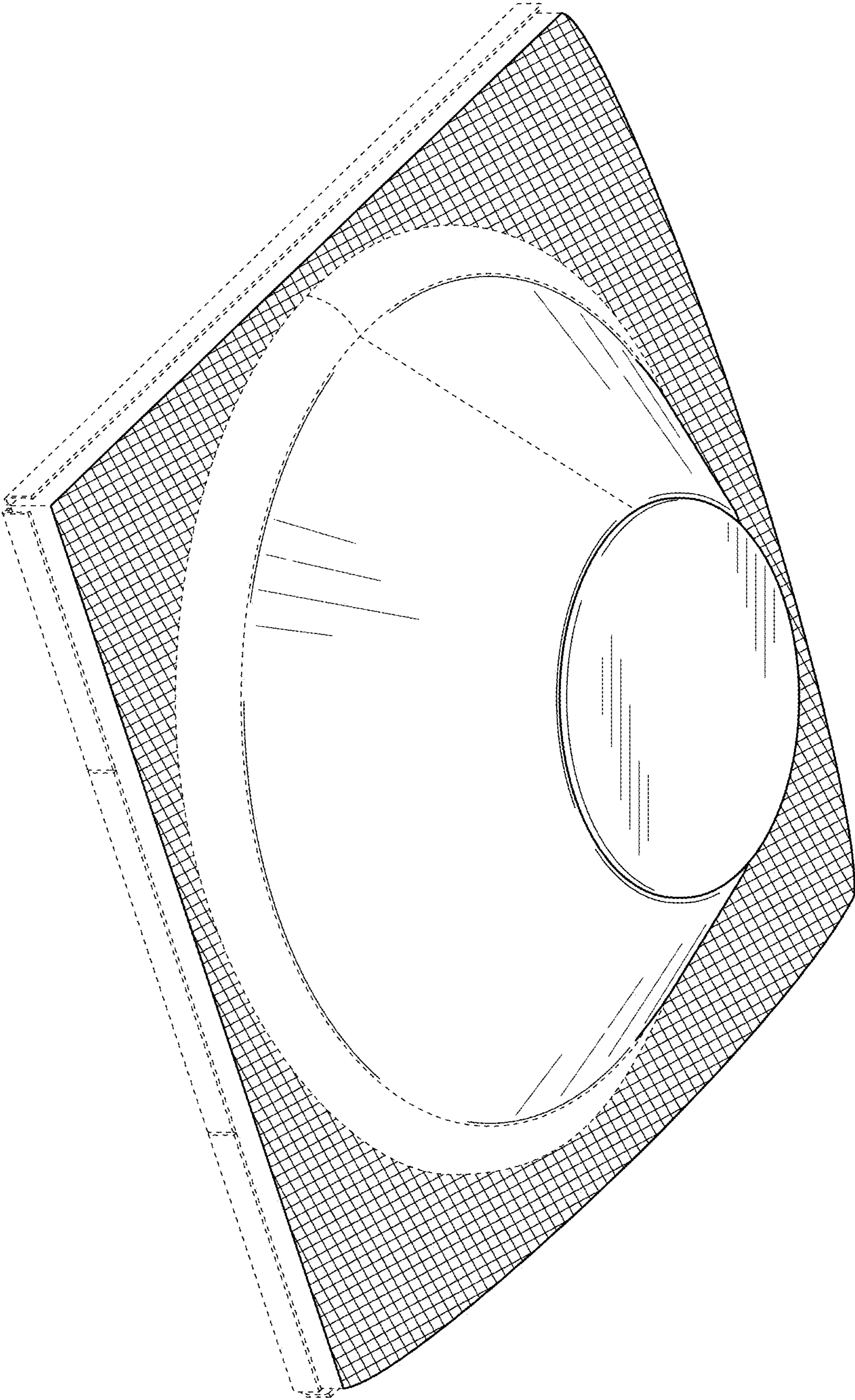

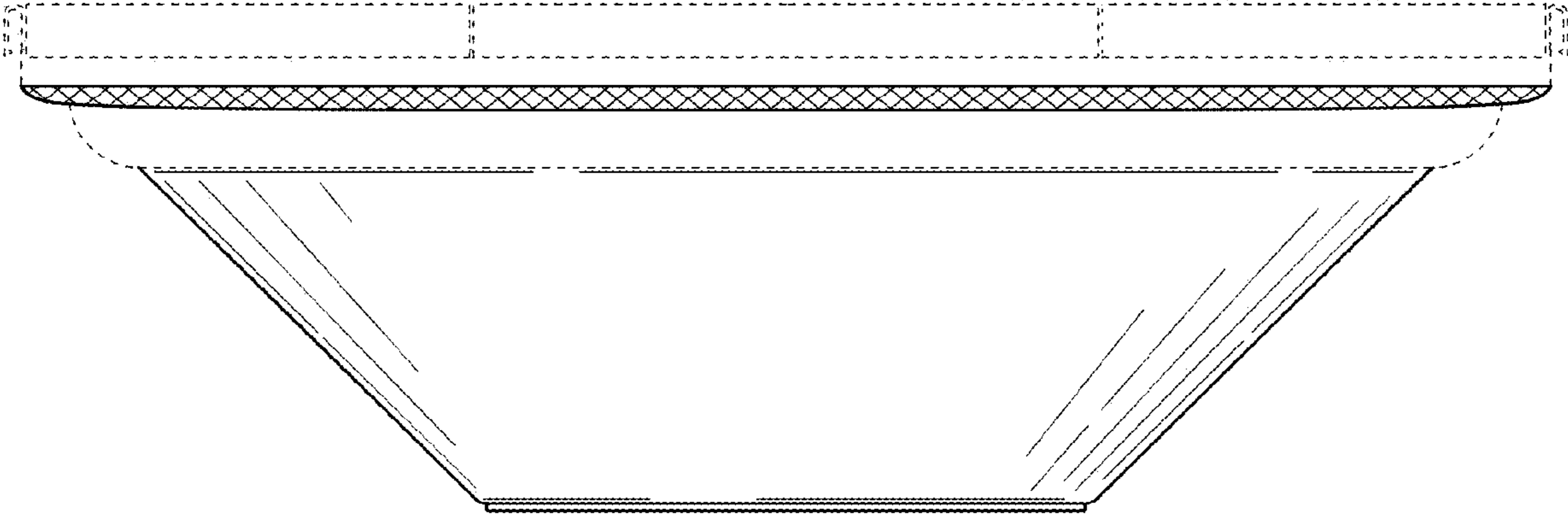

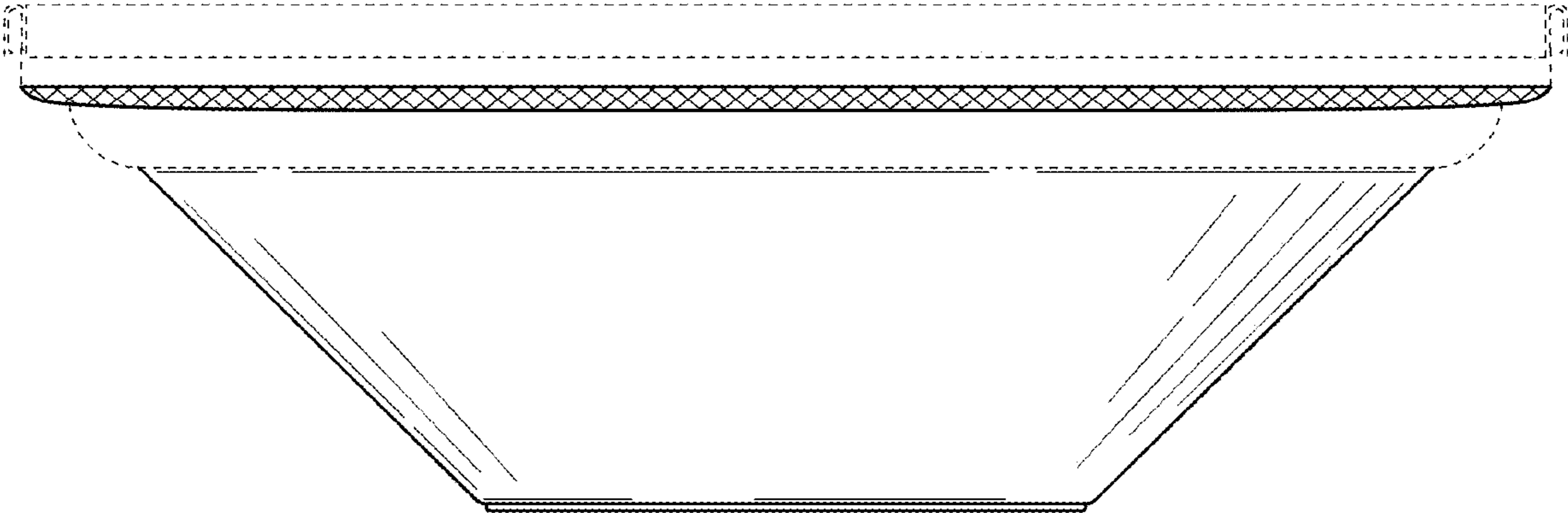

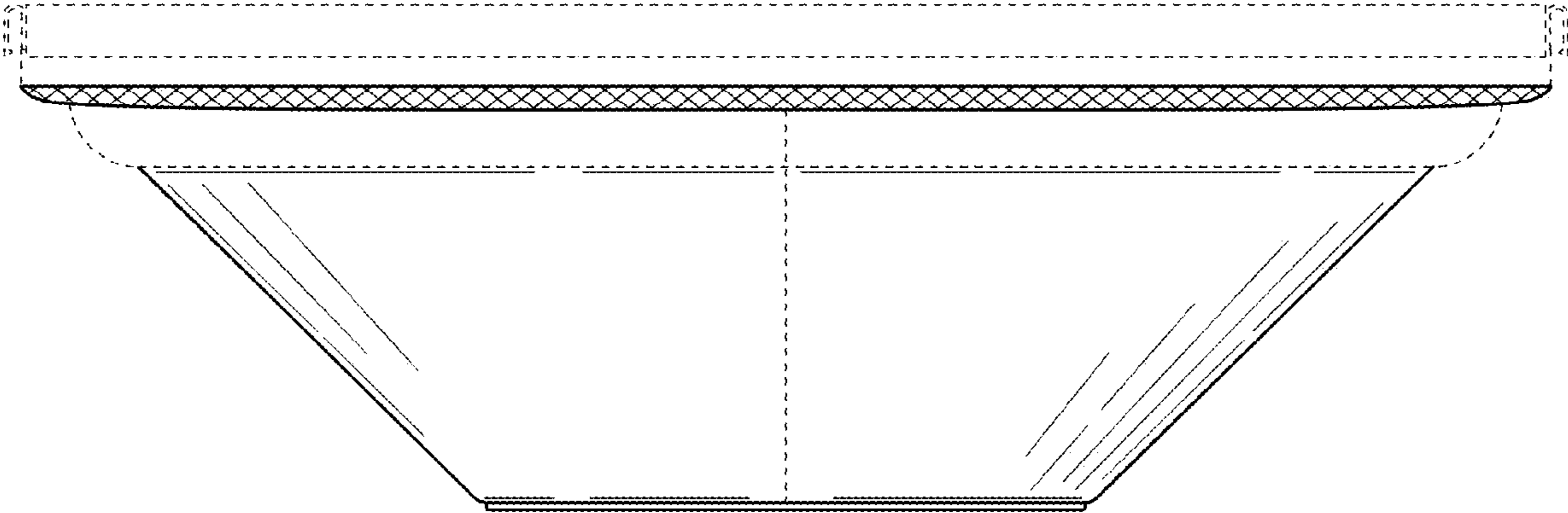

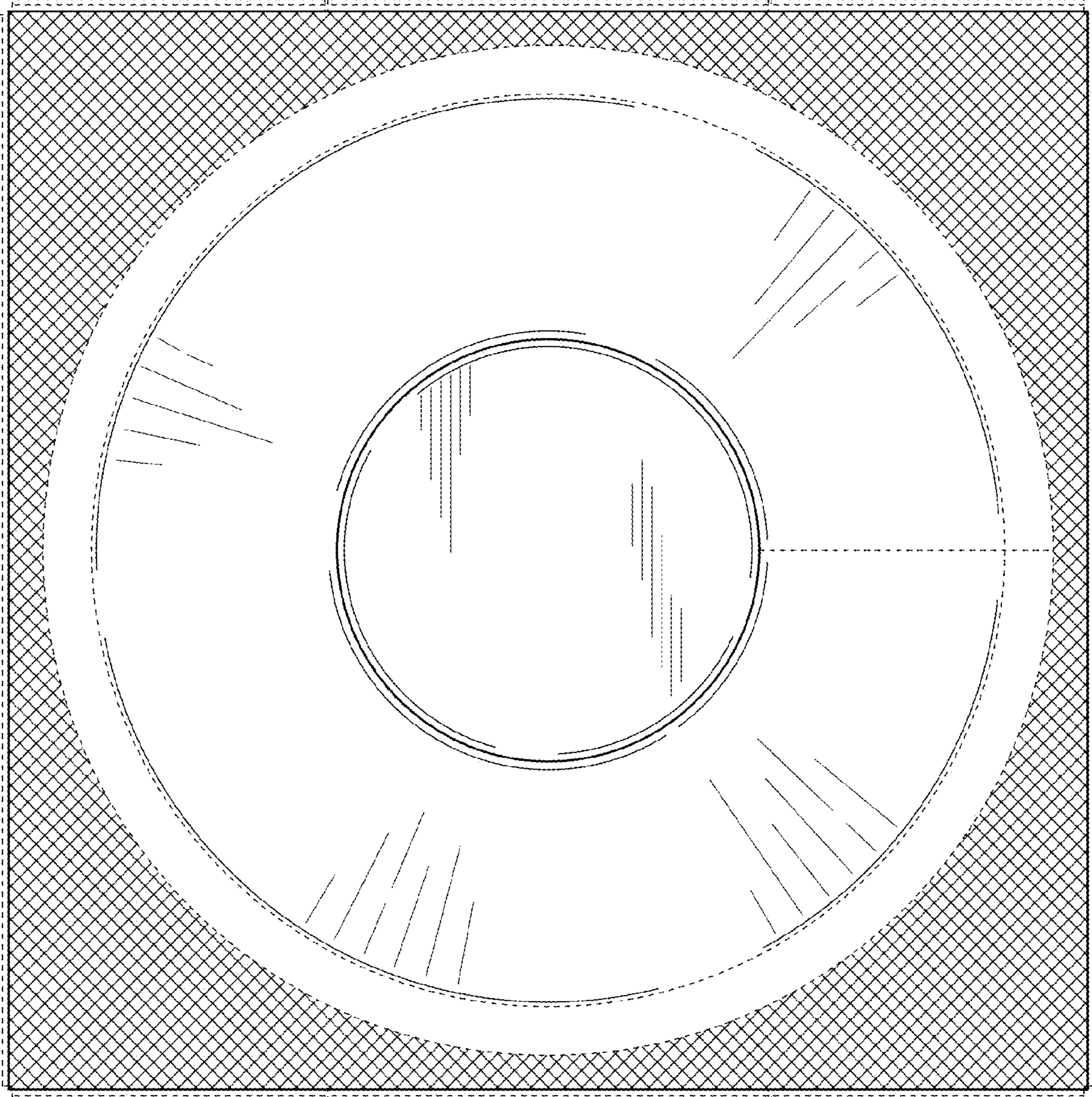

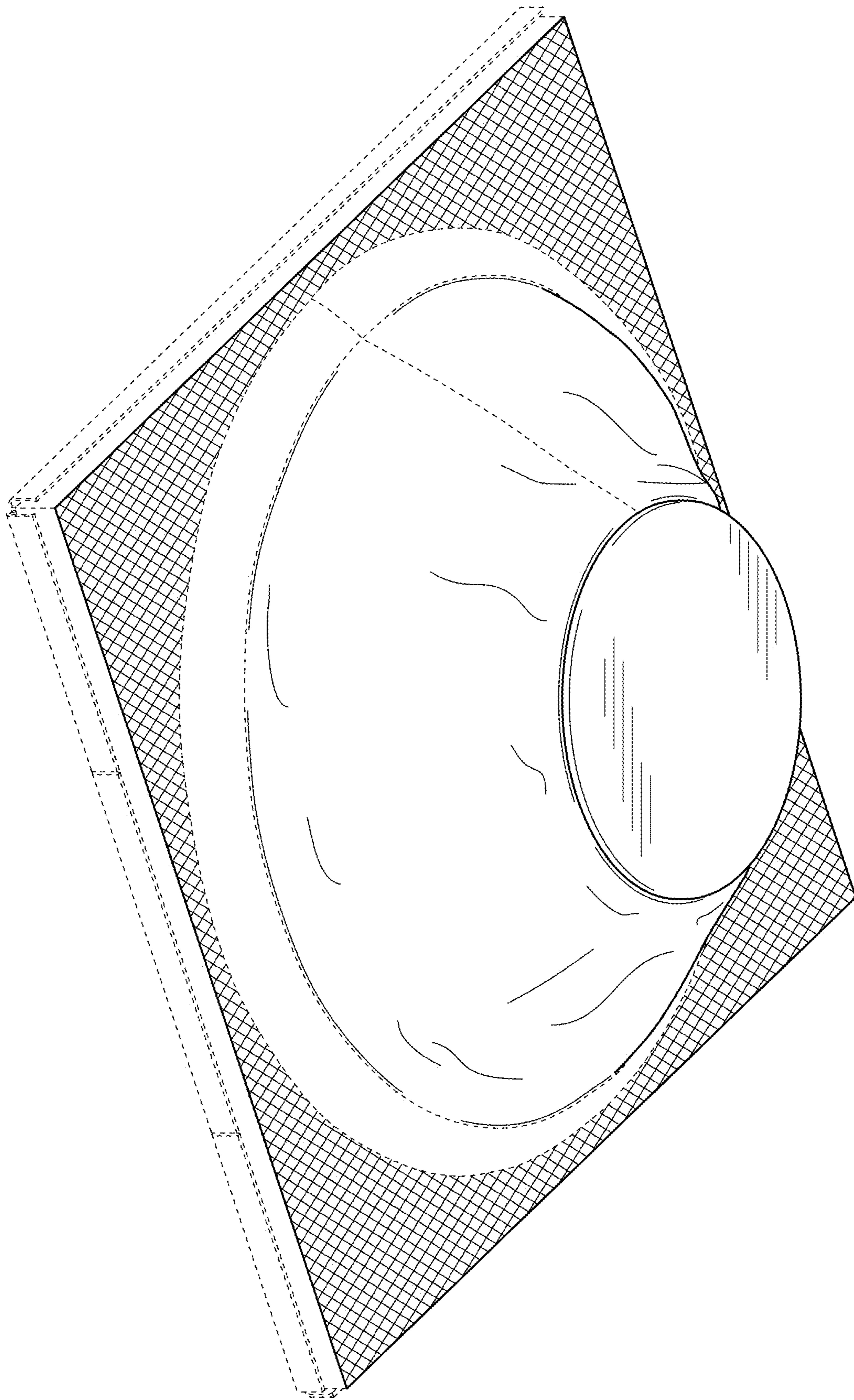

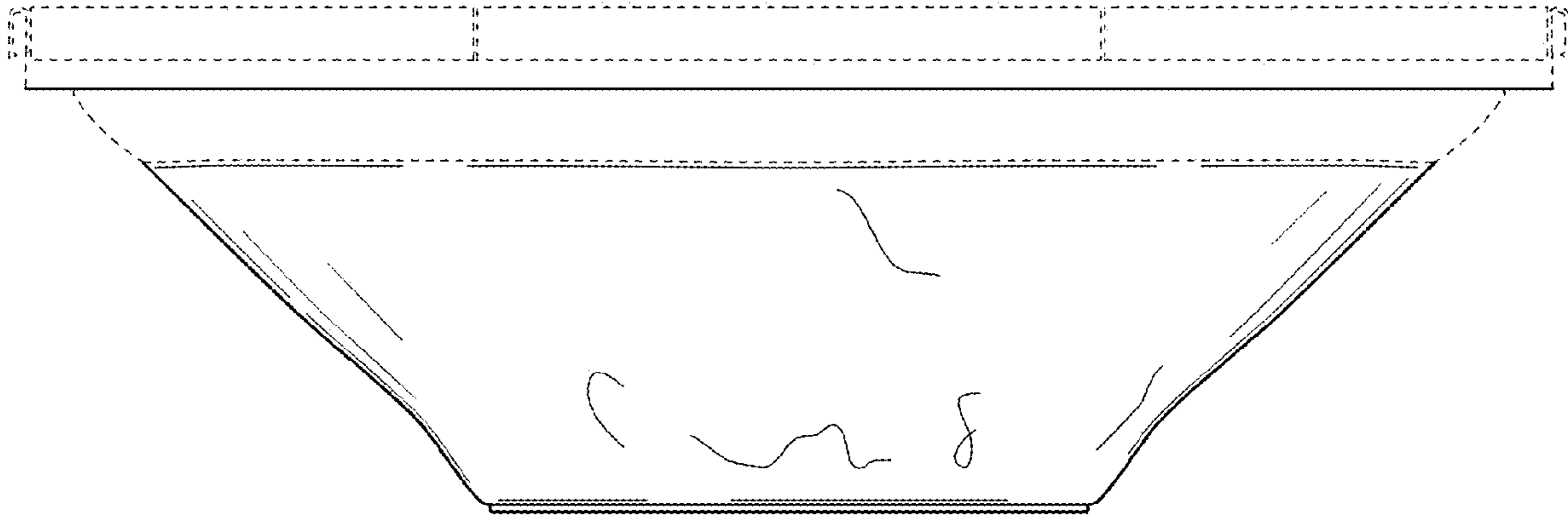

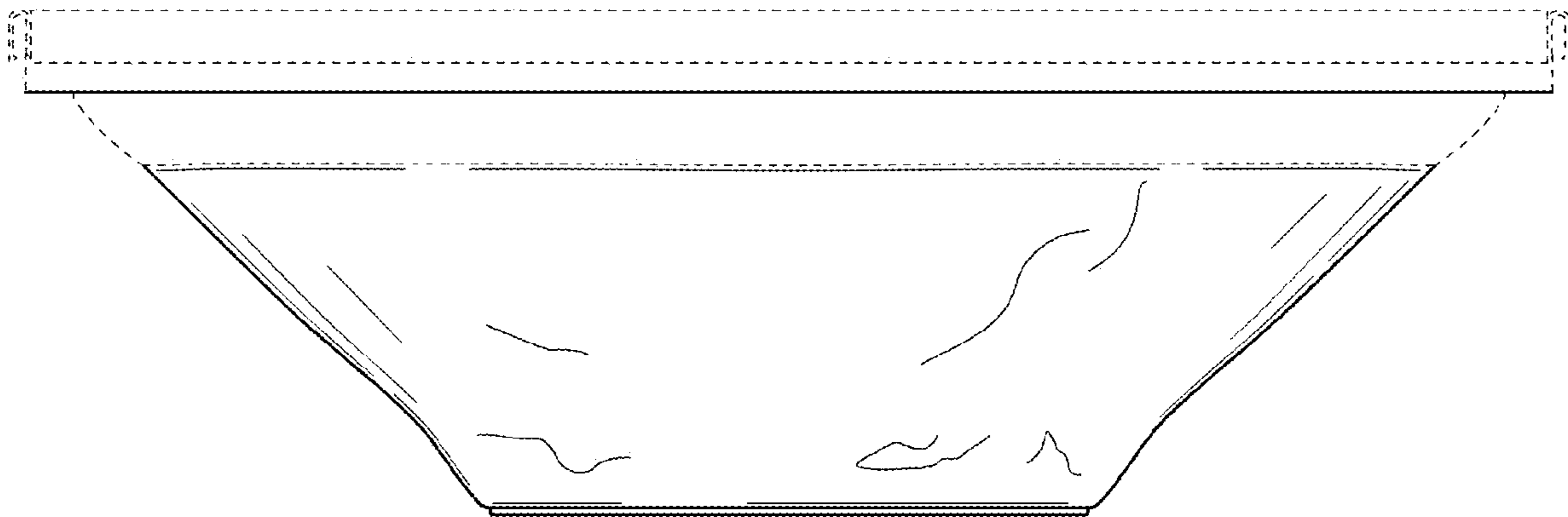

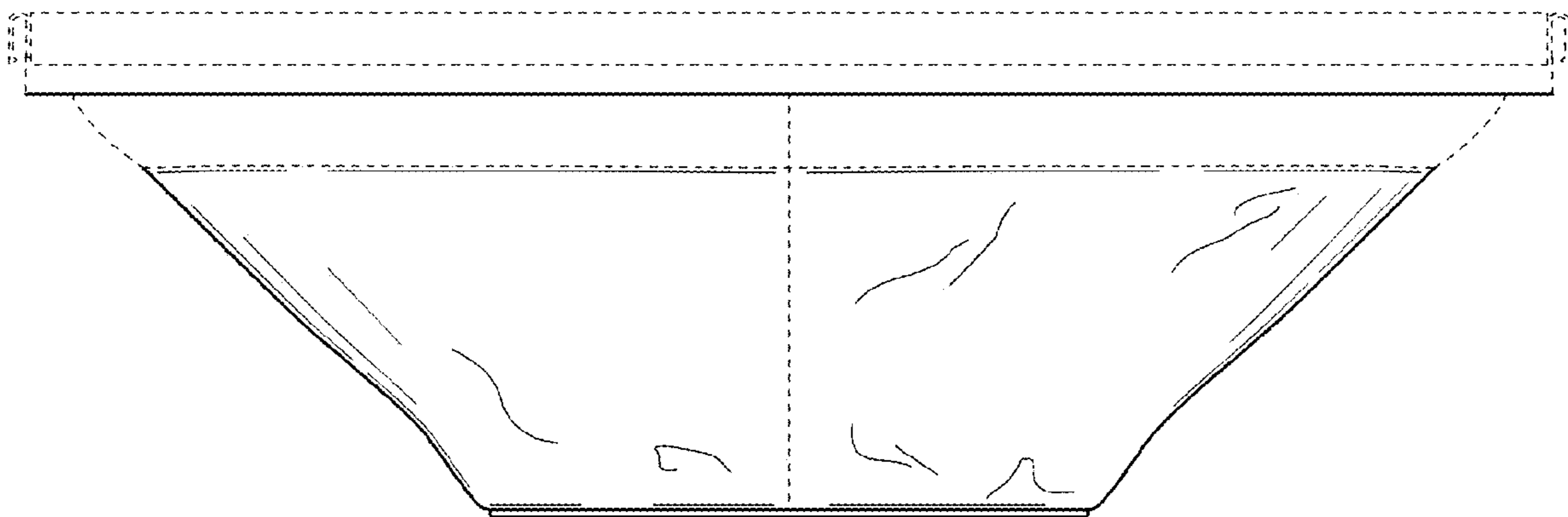

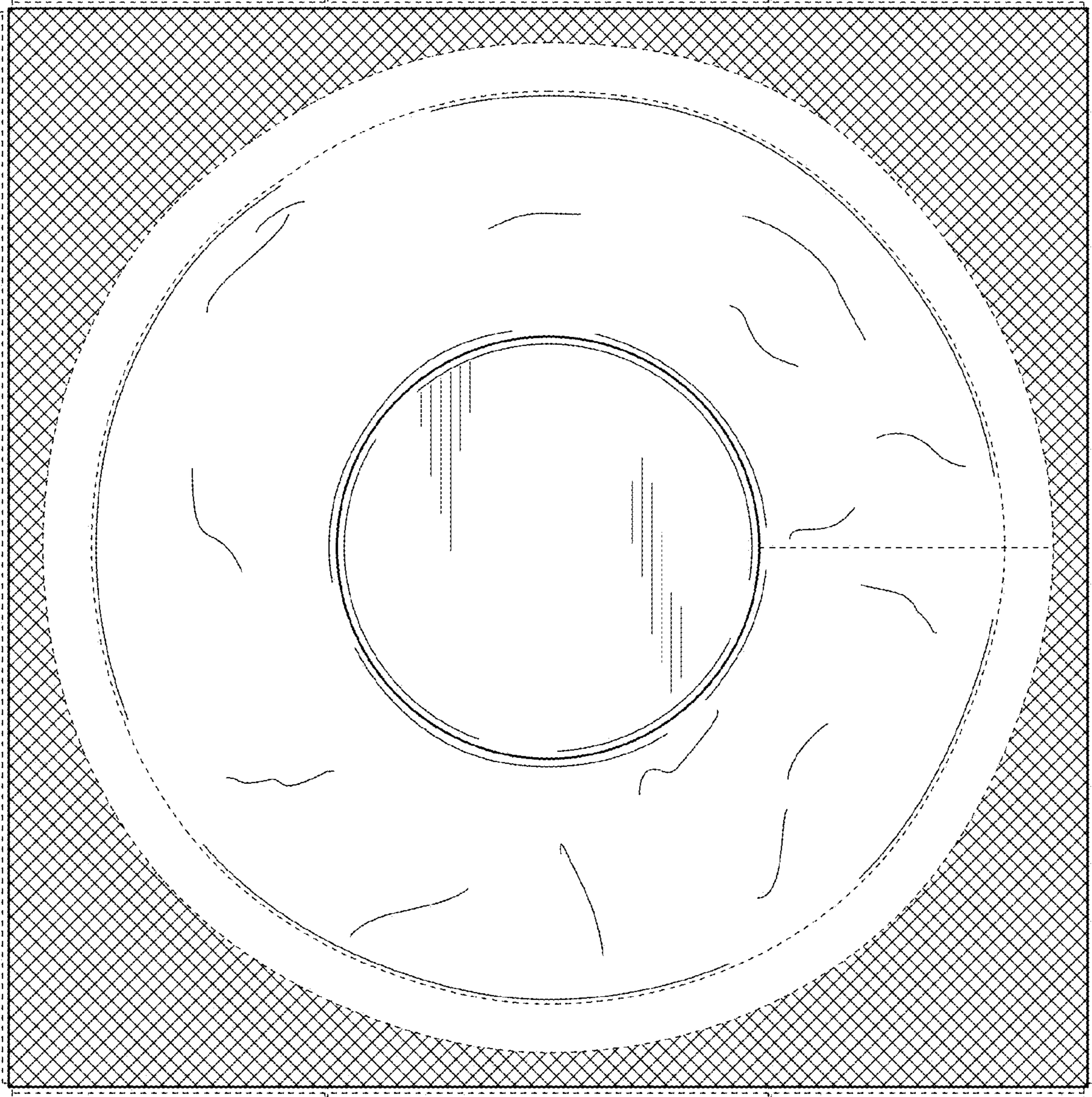
