**DESCRIPTION**

FIG. 1 is a perspective view of a charging base for ear cleaner showing my new design;  
FIG. 2 is another perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a top plan view thereof;  
FIG. 8 is a bottom plan view thereof; and,  
FIG. 9 is an exploded perspective view of the charging base for ear cleaner with the cover separated.  
The broken lines immediately adjacent to the shaded areas depict the bounds of the claimed design, while all other broken lines are directed to environment. The broken lines form no part of the claimed design. The unshaded surface that directly adjoins the claimed solid line edge with the dashed interior in FIG. 9 forms no part of the claimed design.

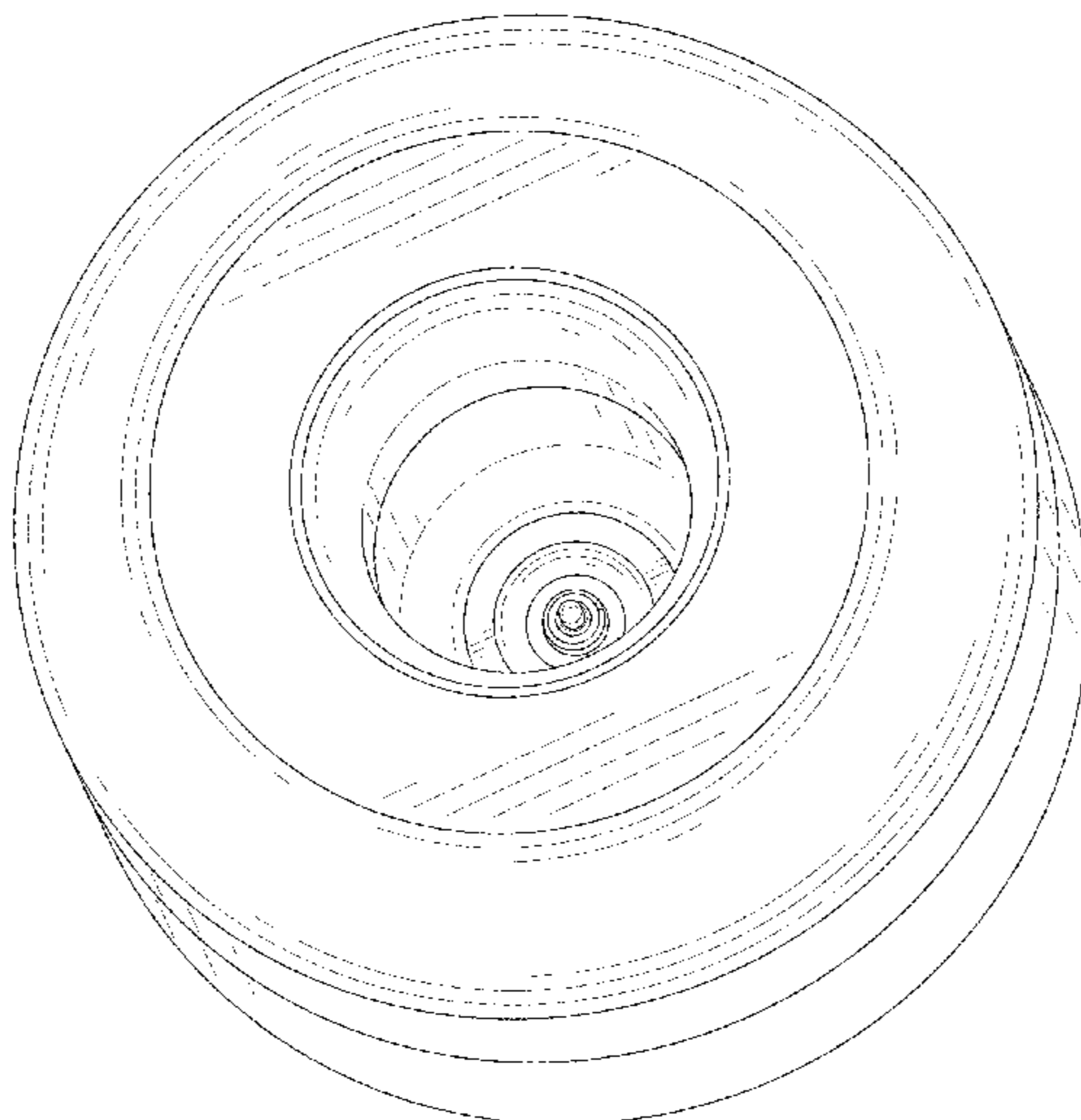

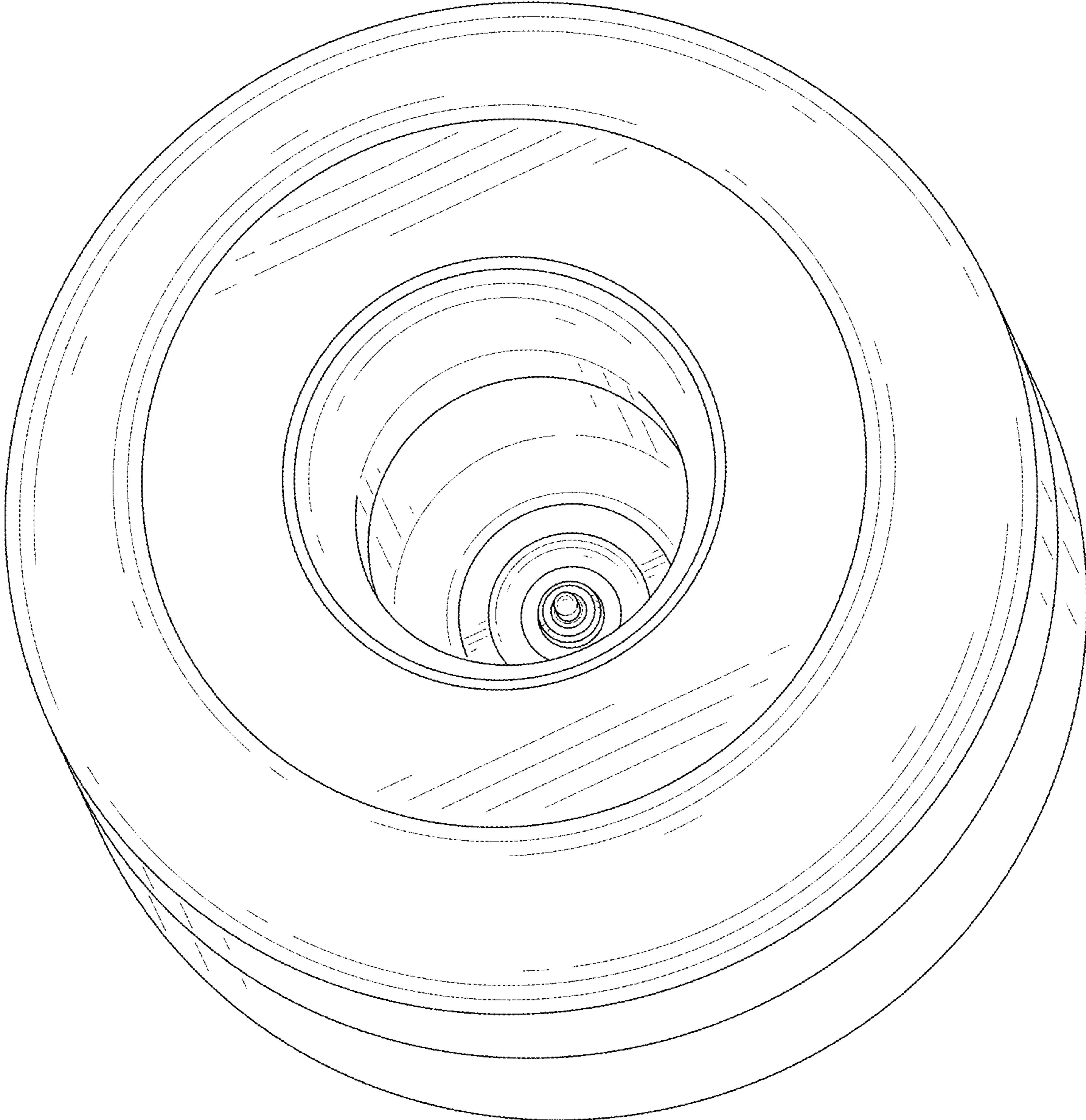

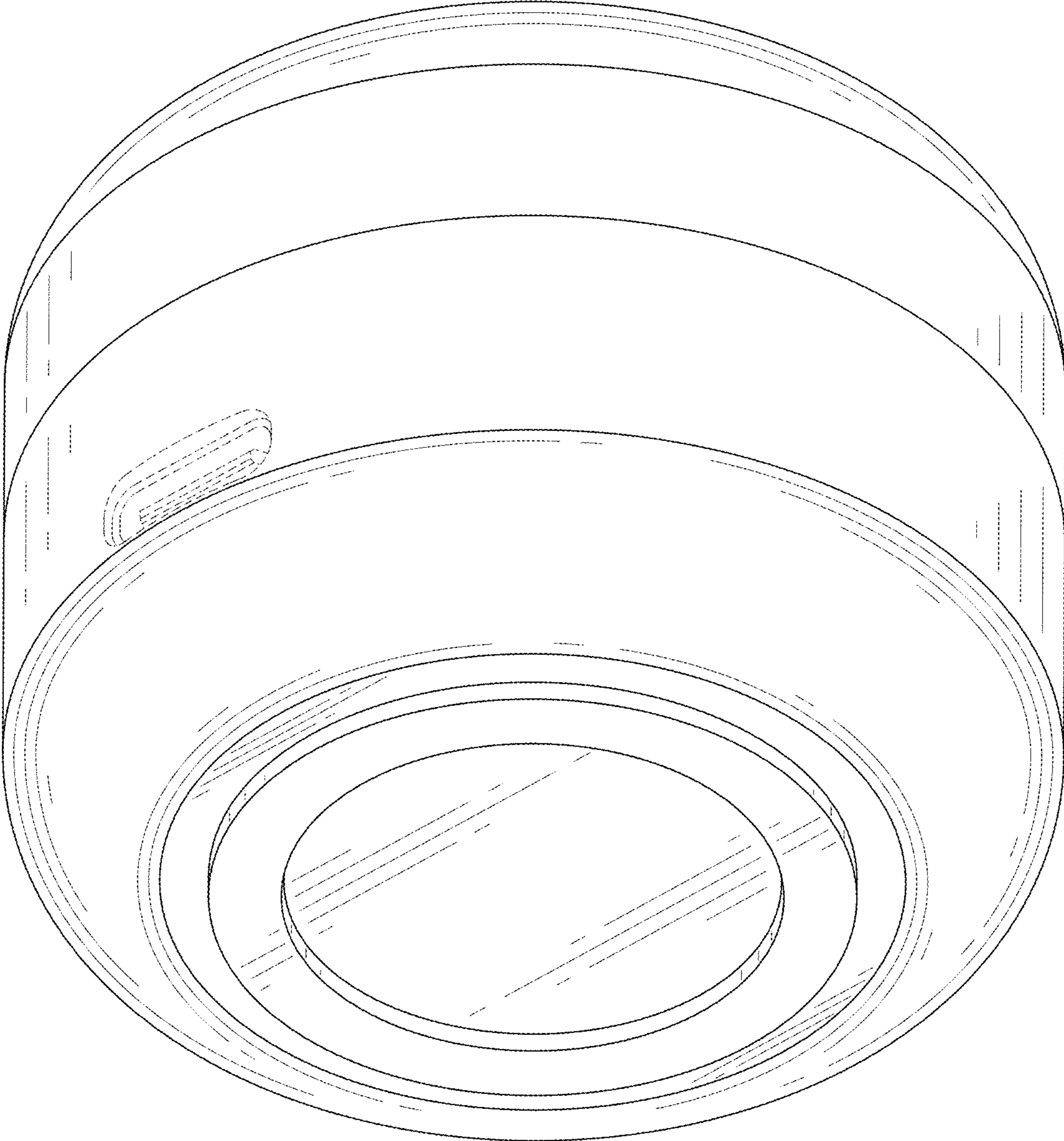

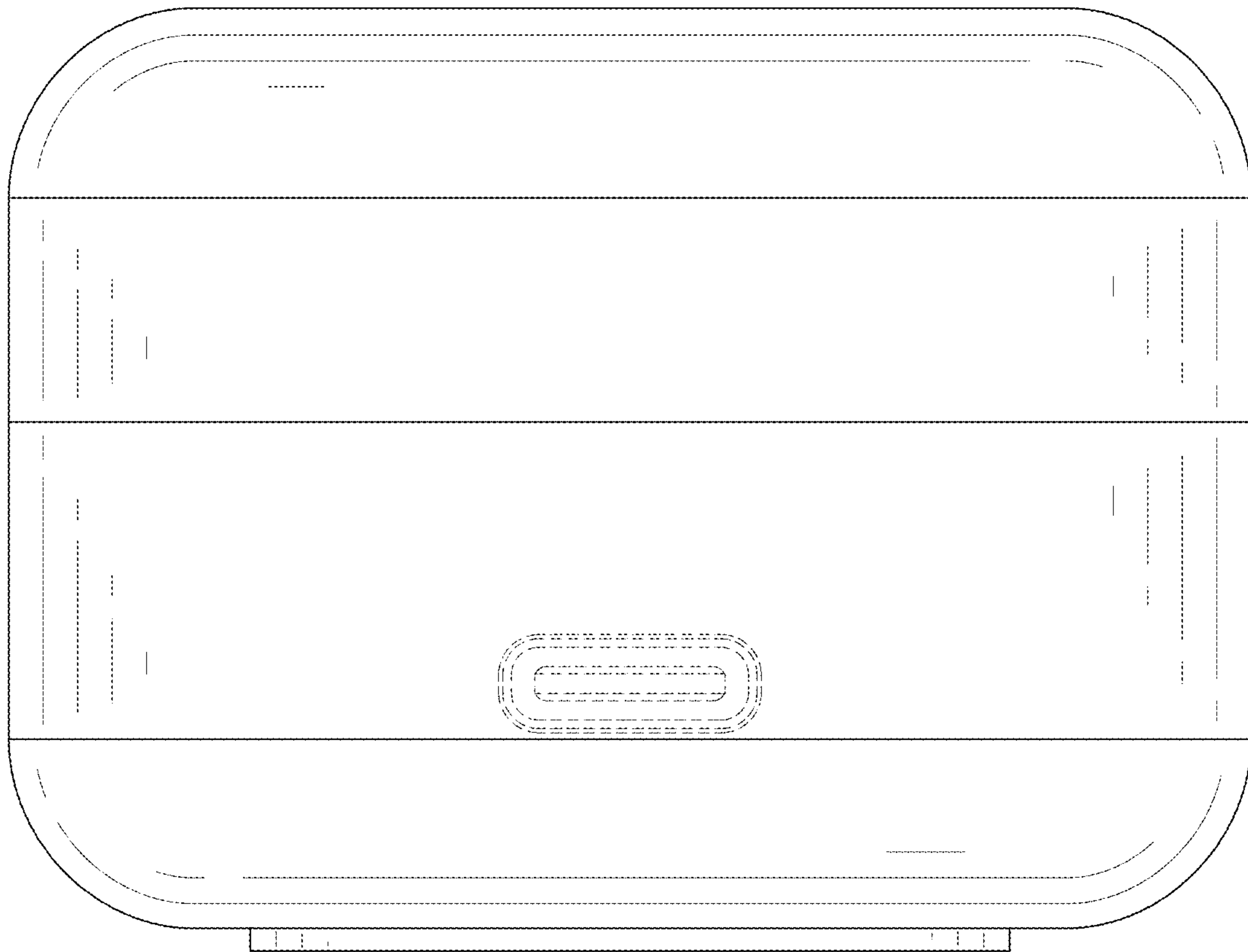

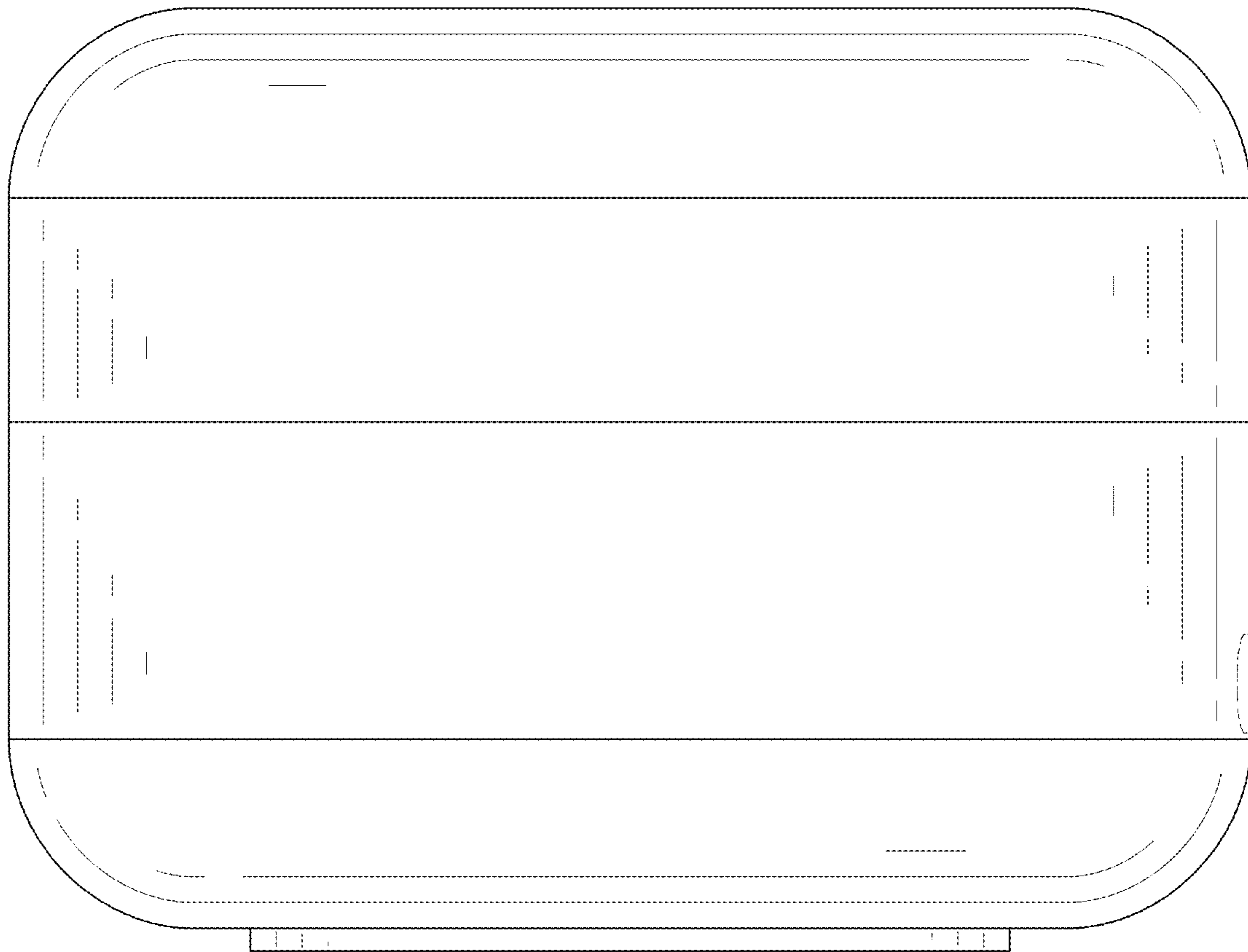

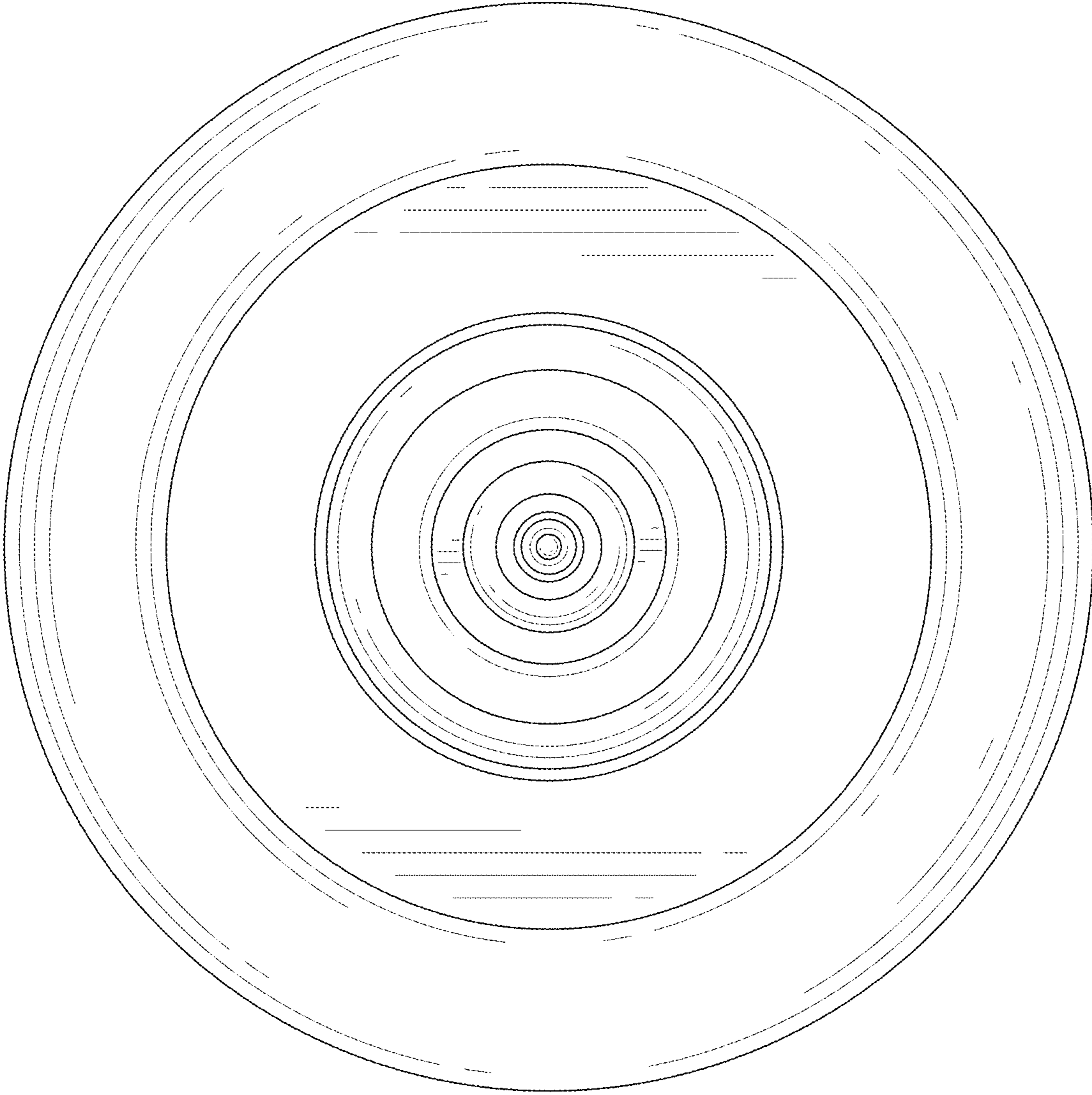

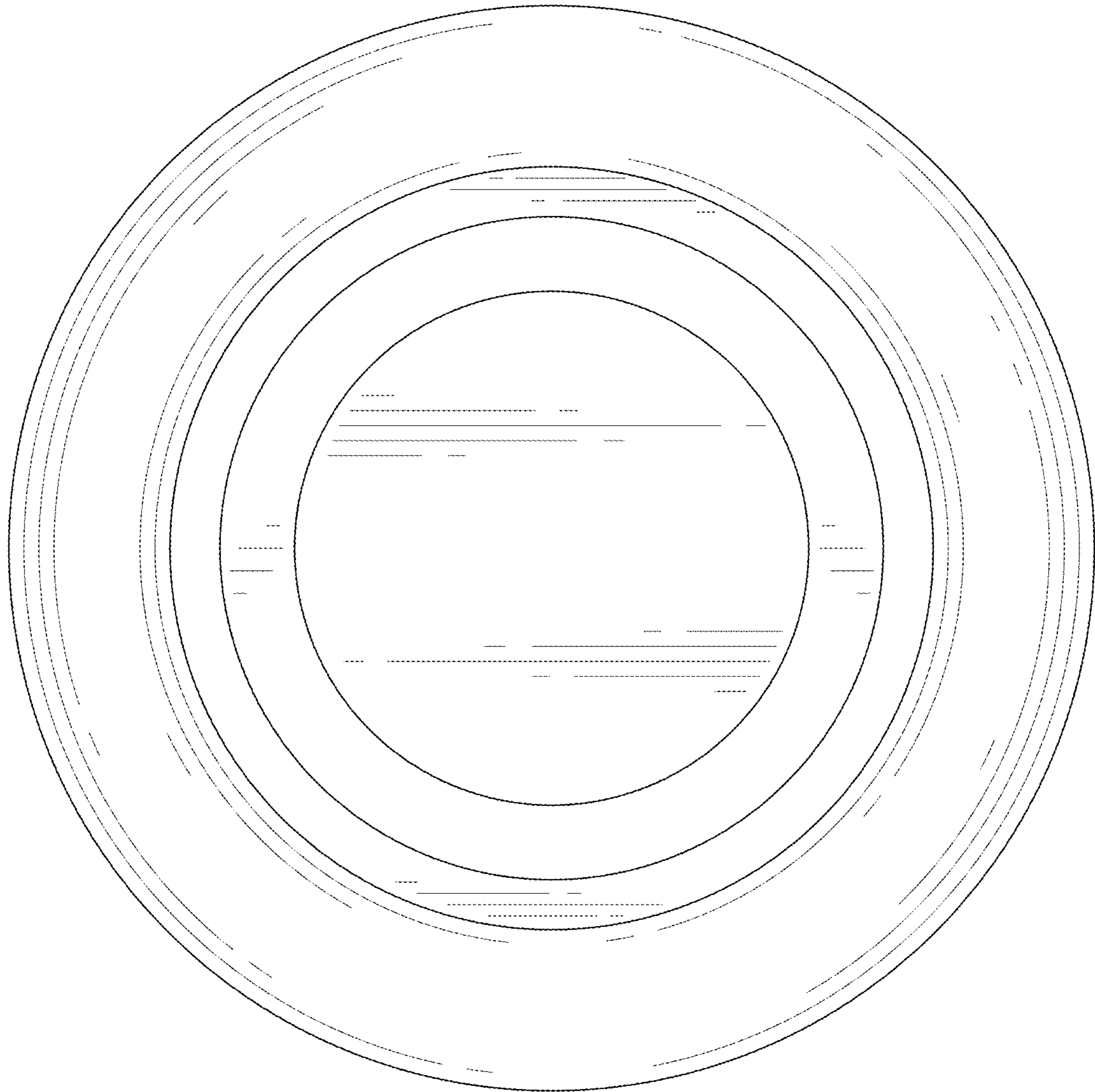
