3.1 is a perspective view of a partition wall.

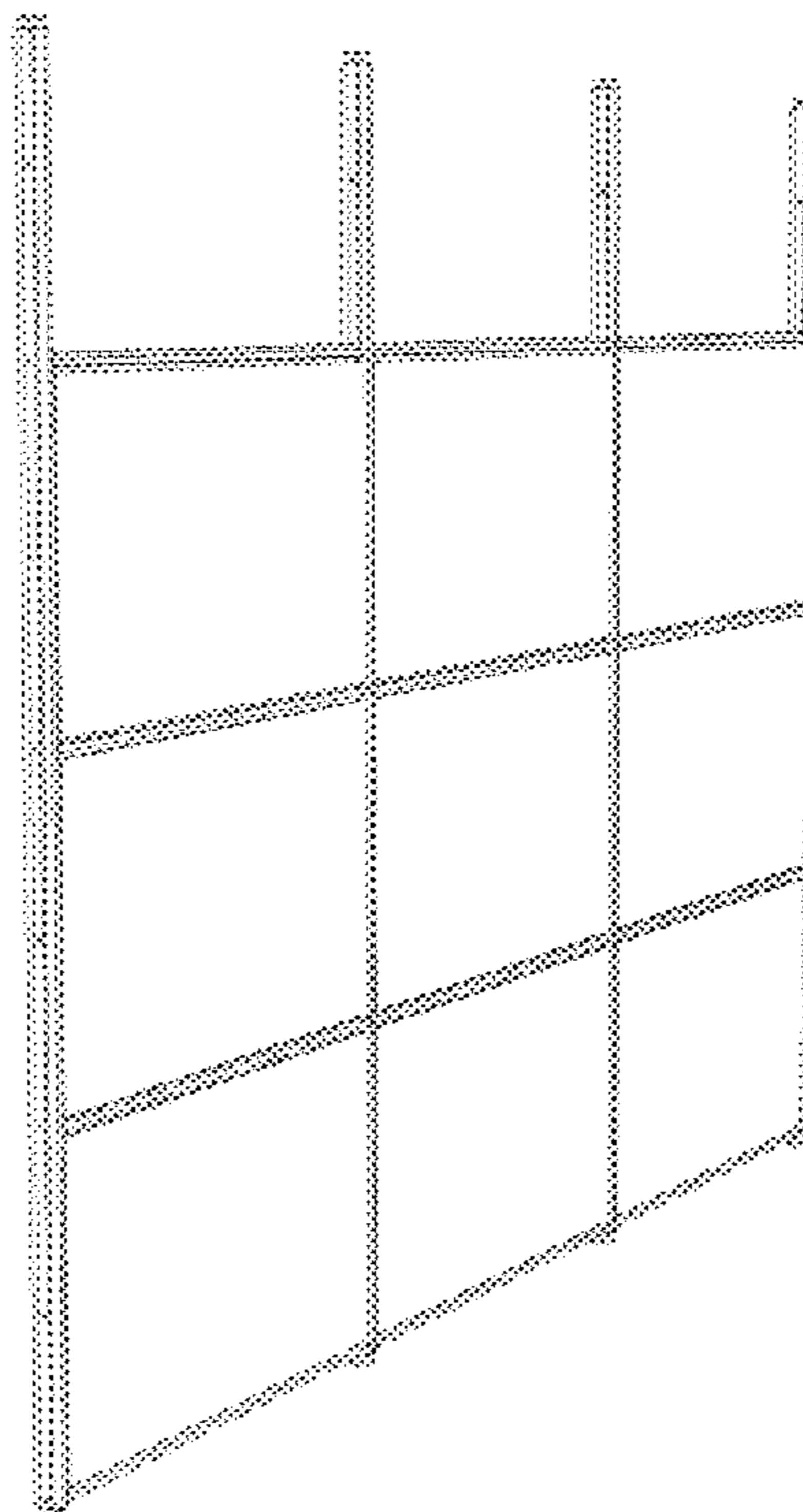
3.2 is a bottom view of a partition wall.

3.3 is a right view of a partition wall.

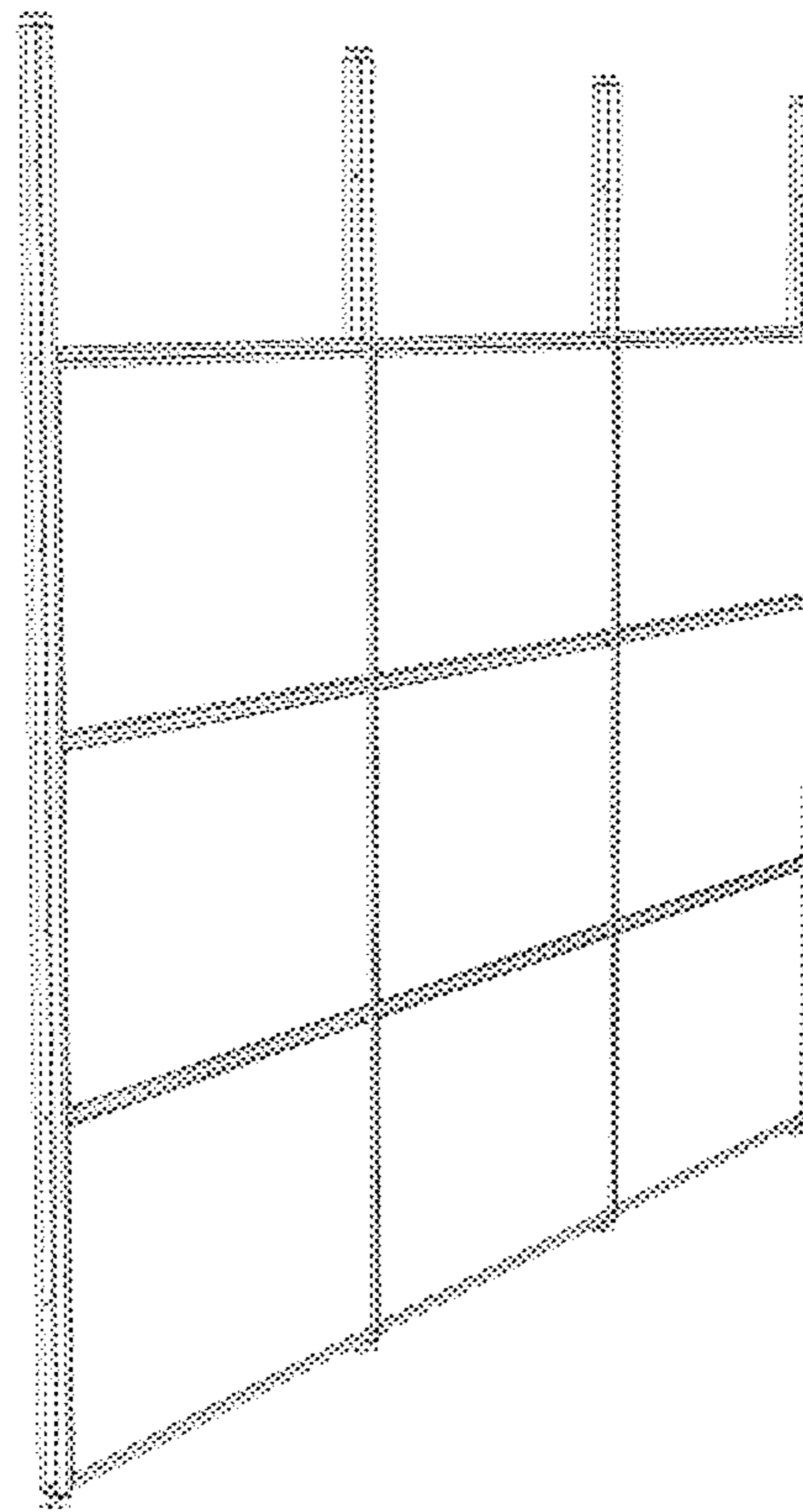
3.4 is a top view of a partition wall.

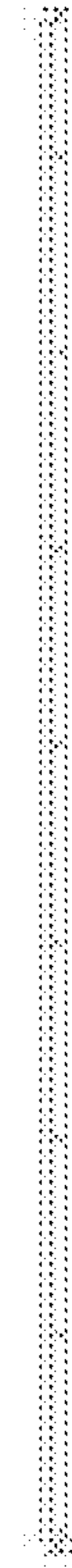

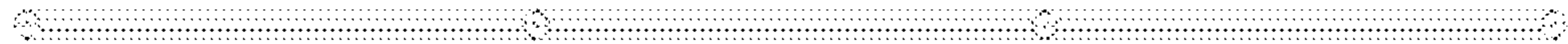
