FIG. 2 is a front, top, left, perspective view thereof;

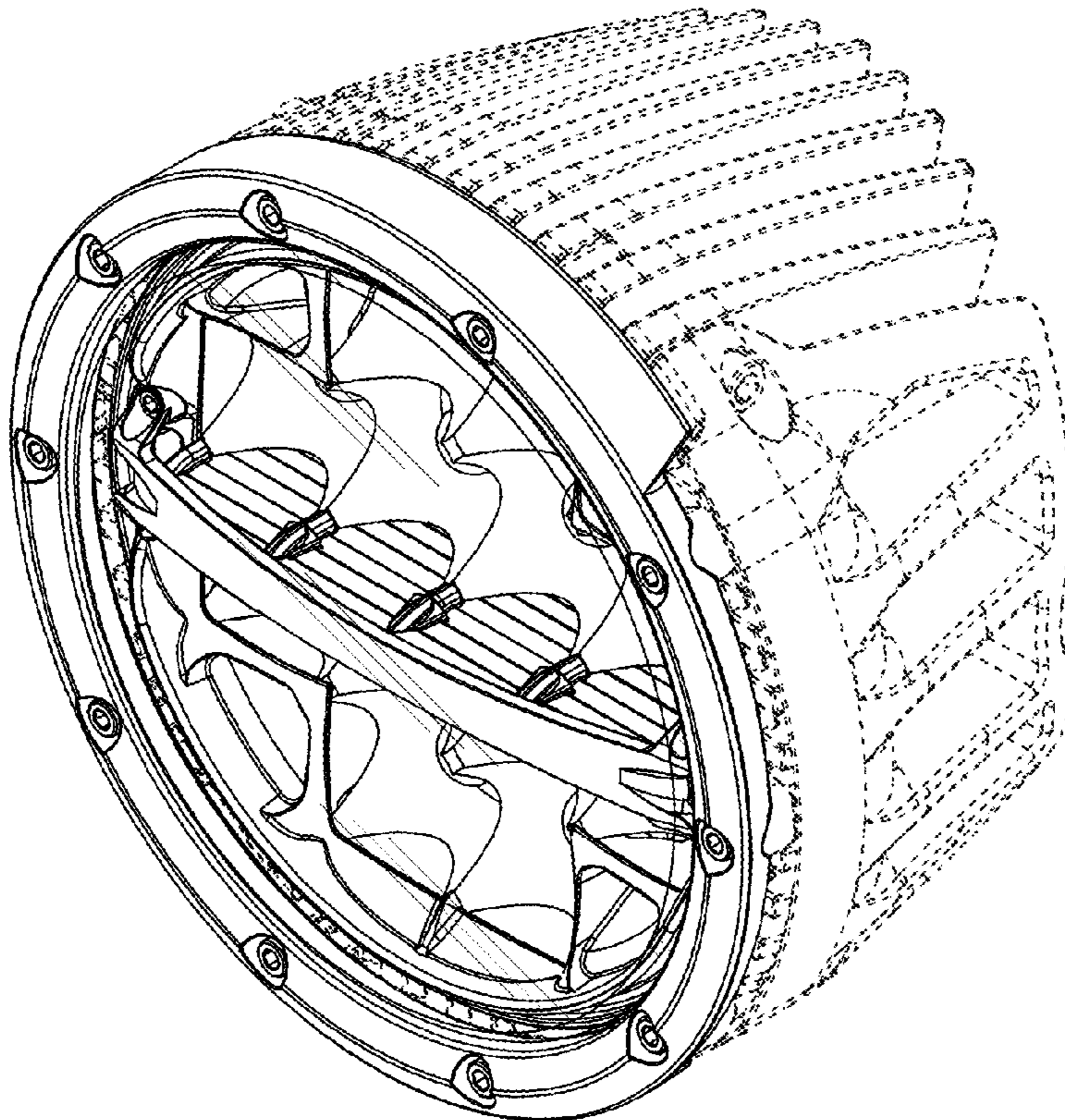
FIG. 3 is a front, bottom, right, perspective view thereof;

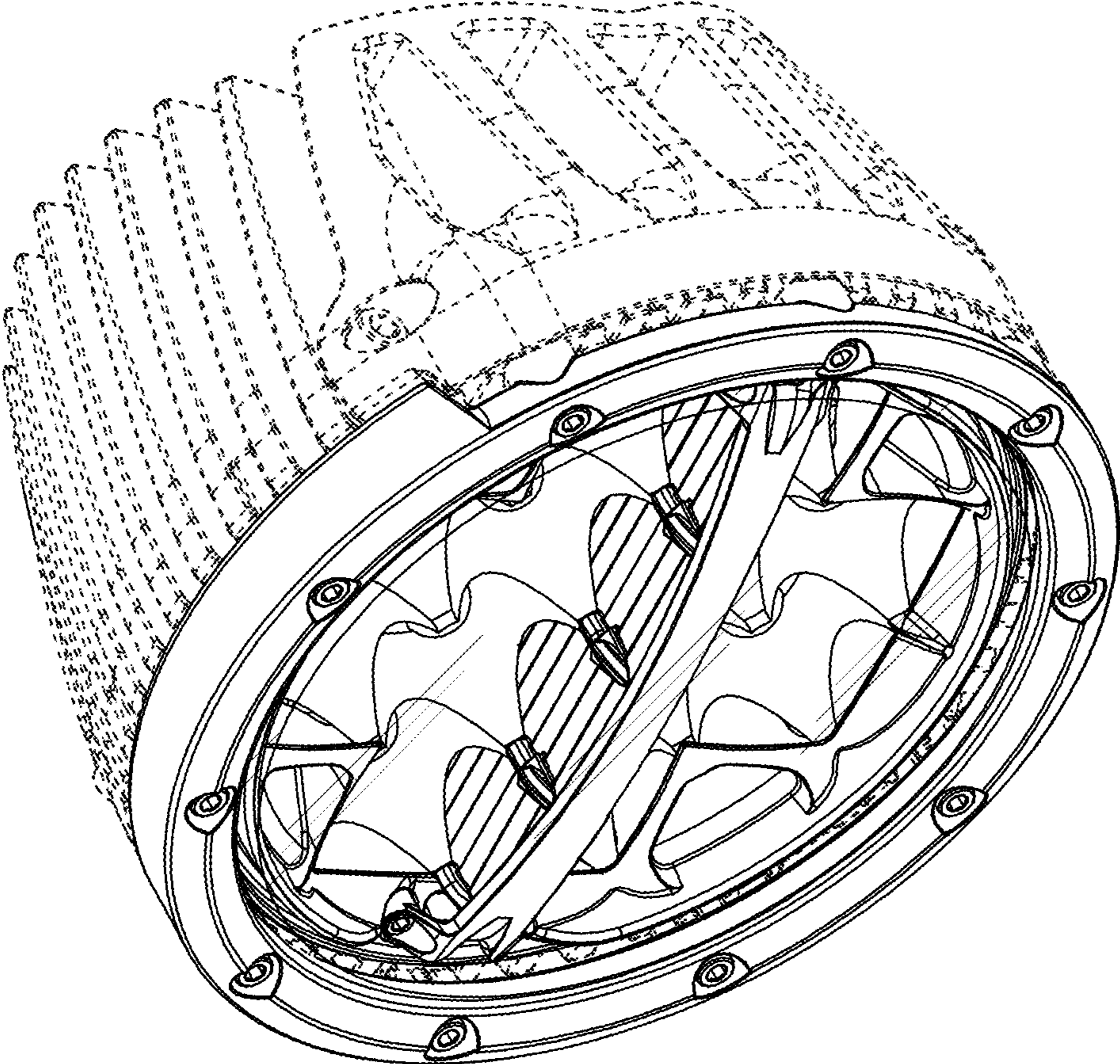

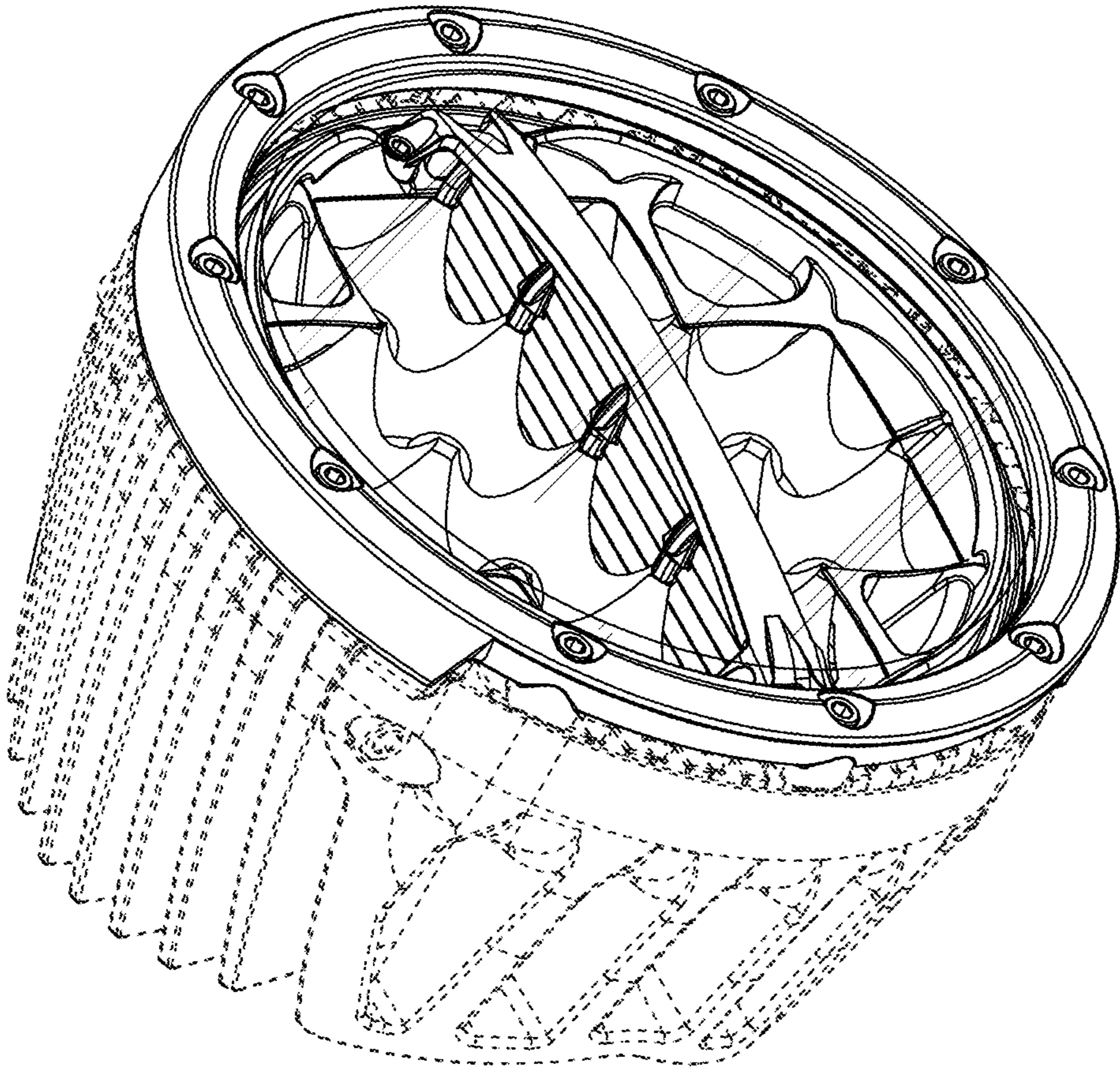

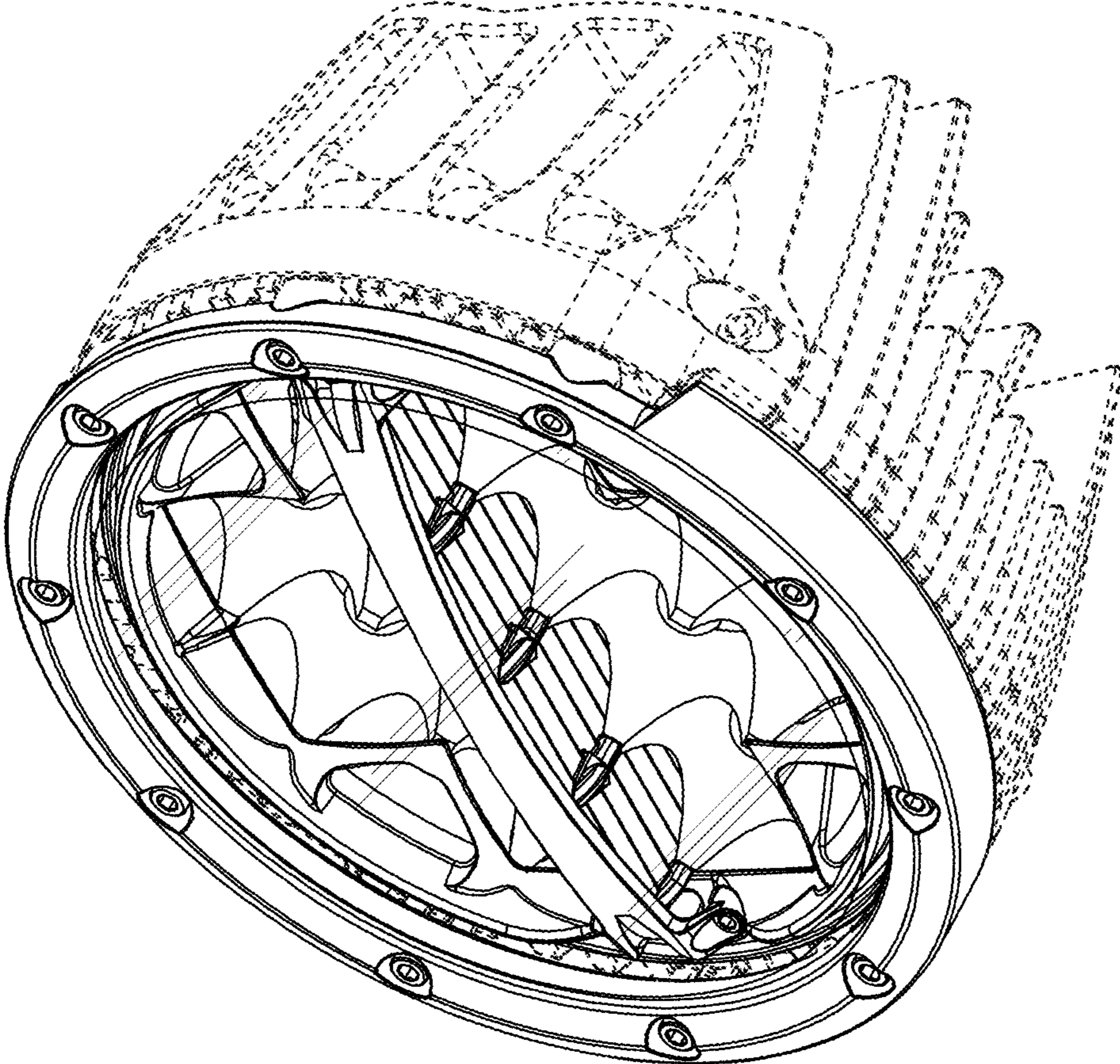

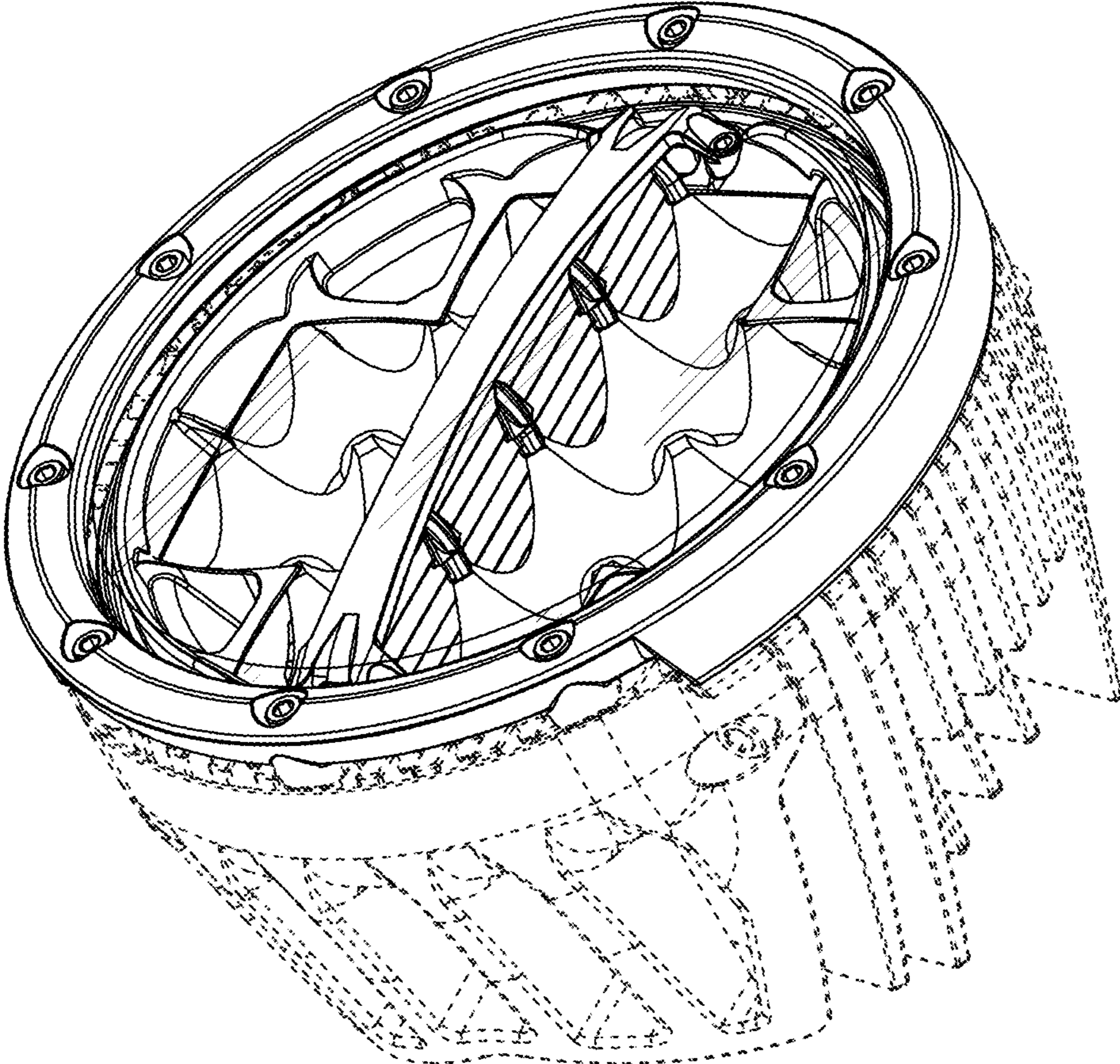

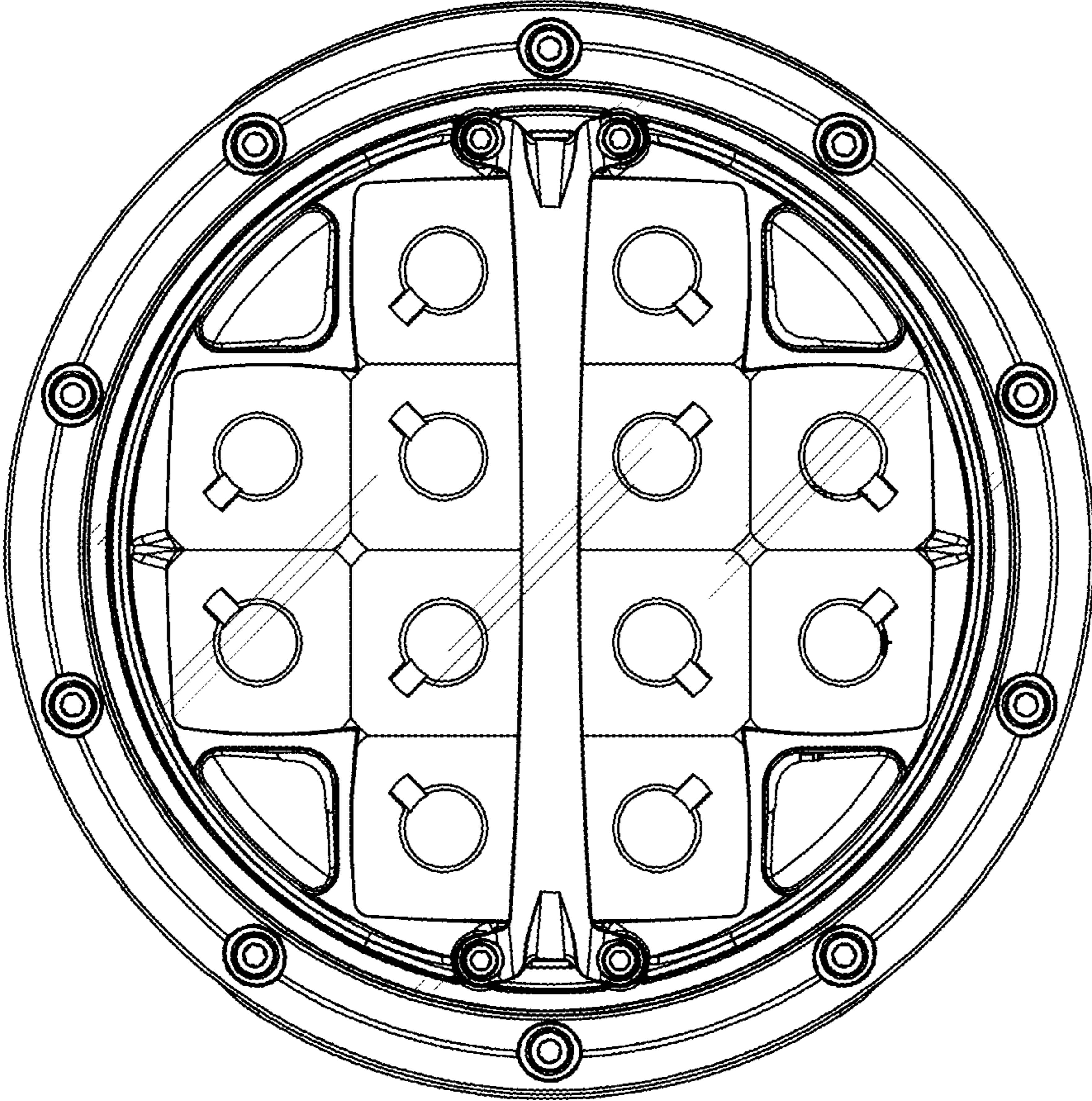
