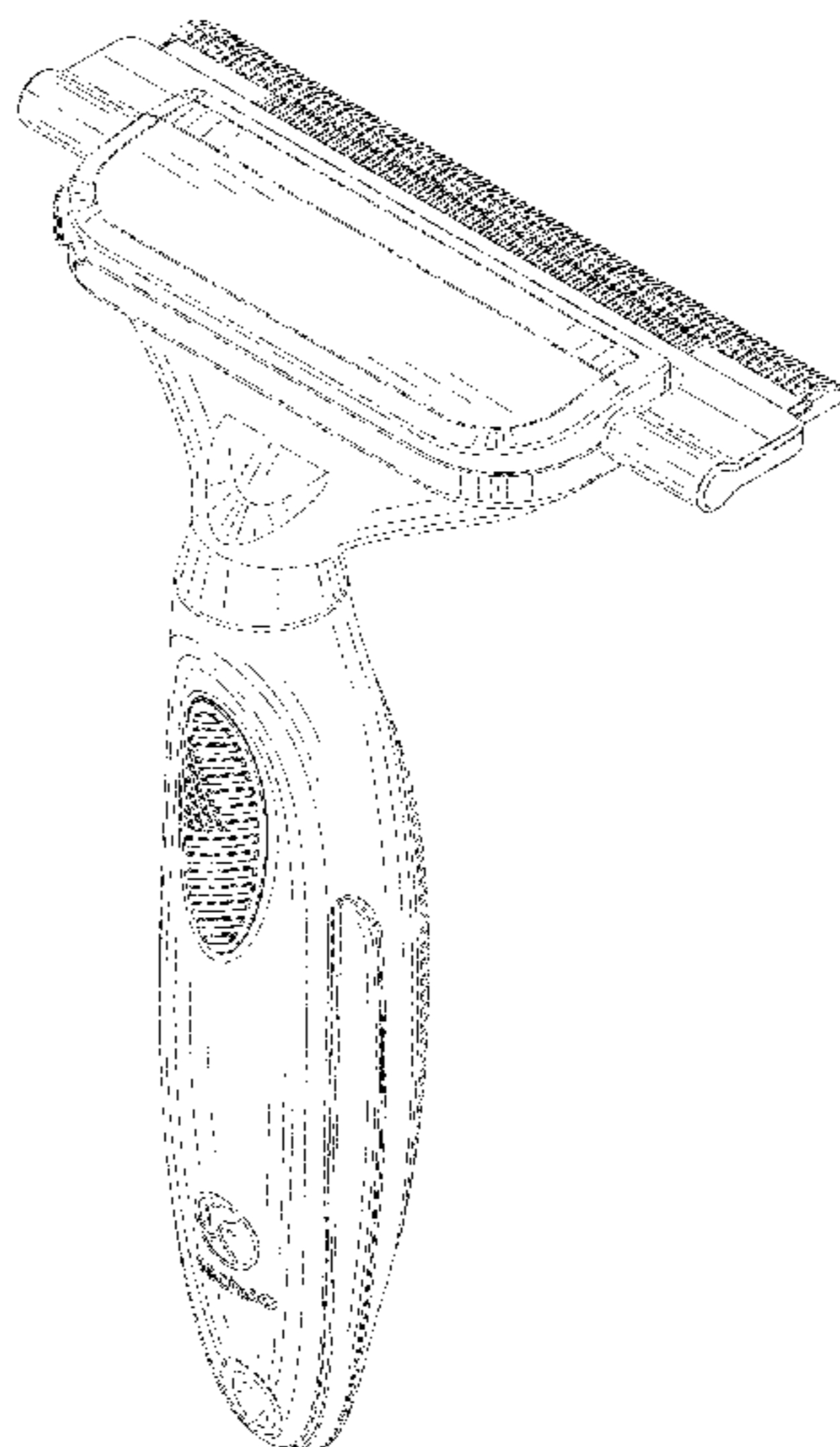
(57) **CLAIM**

The ornamental design for an undercoat deshedding tool, as shown and described.

DESCRIPTION

FIG. 1 is a top-down perspective view of an undercoat deshedding tool showing my new design; FIG. 2 is a bottom-up perspective view thereof; FIG. 3 is a front side elevational view thereof; FIG. 4 is a rear side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The “Veehoo” trademark forming part of the claimed design is a registered trademark of Wuhan Lewei Electronic Commerce Co., Ltd.

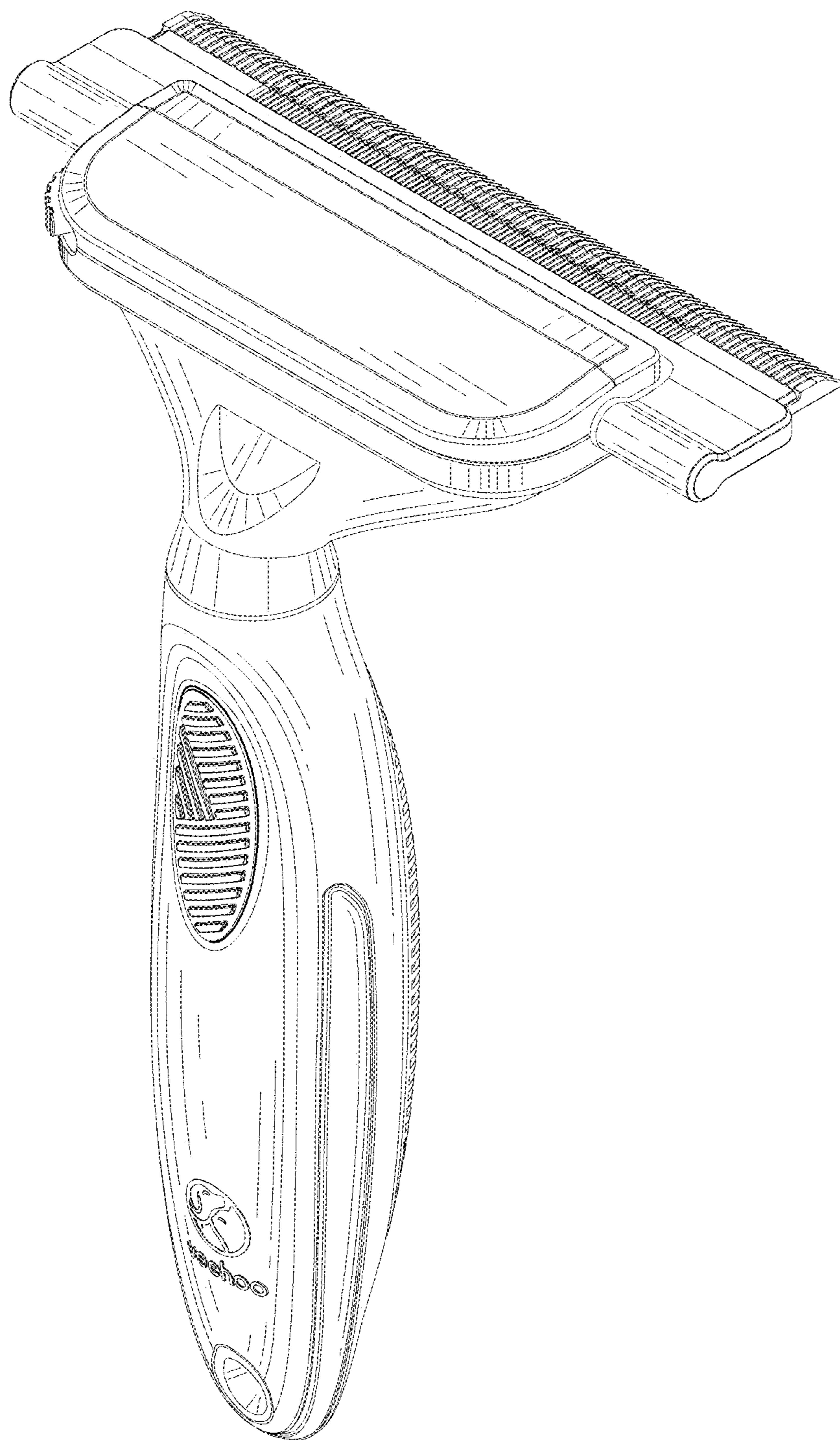

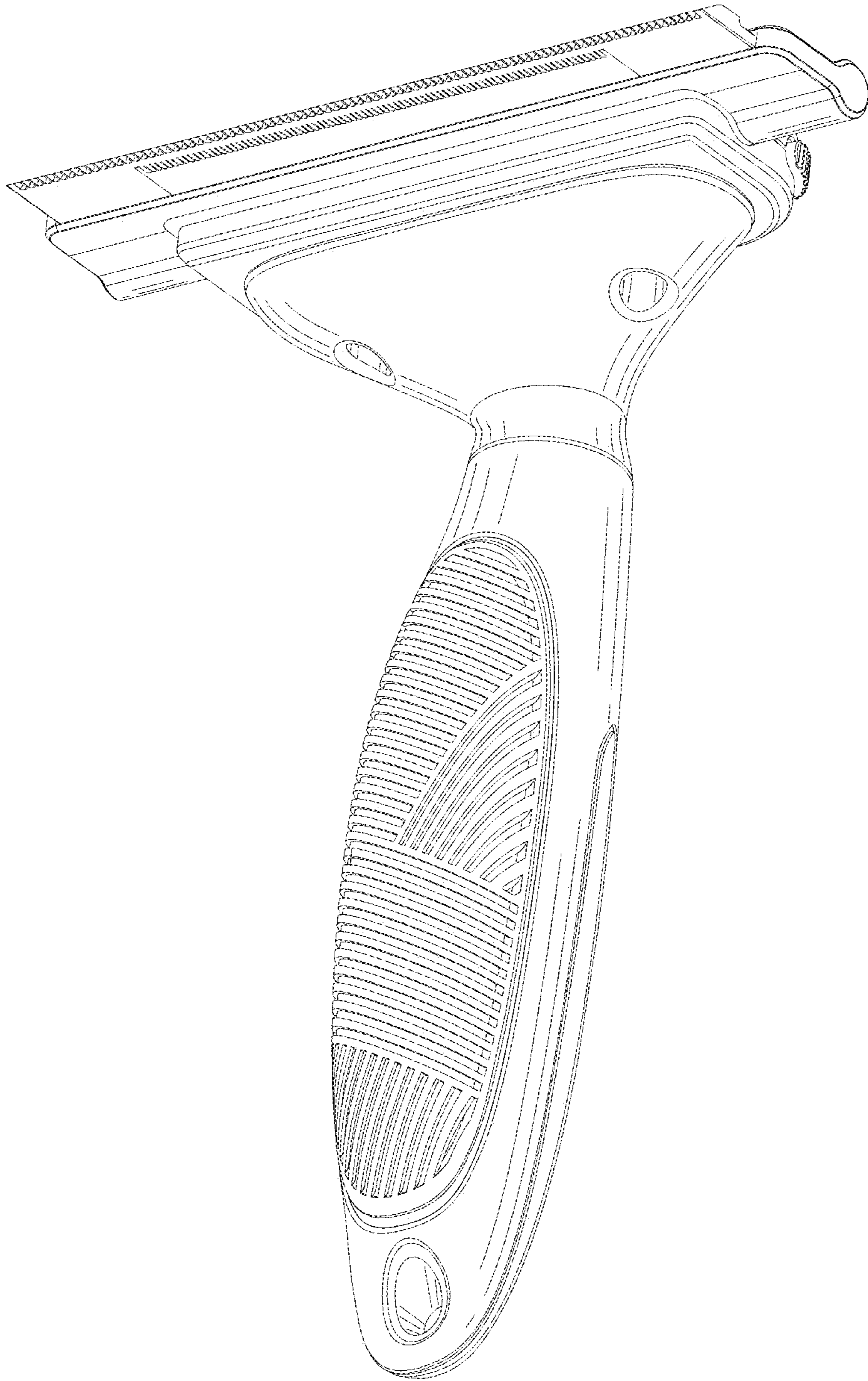

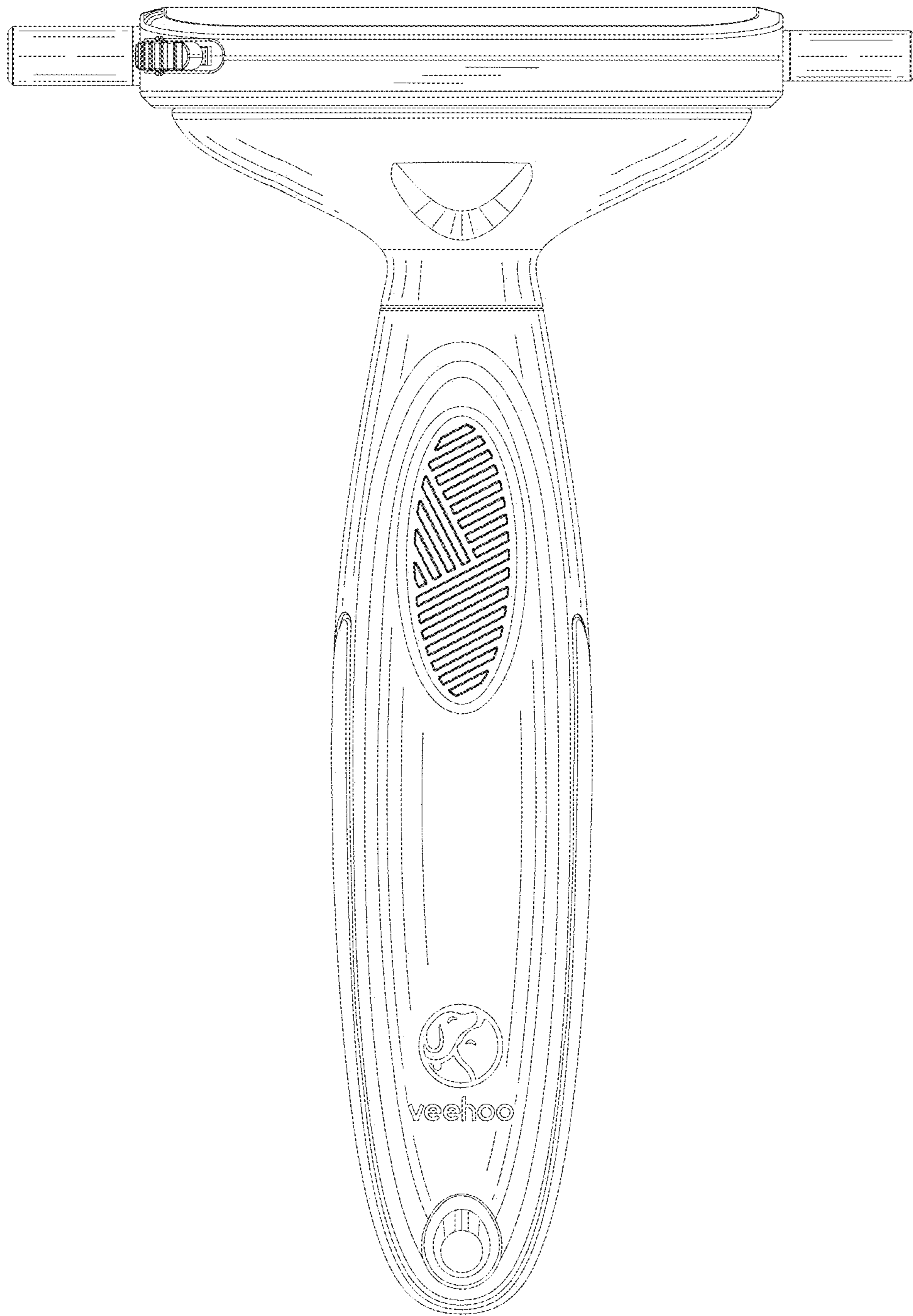

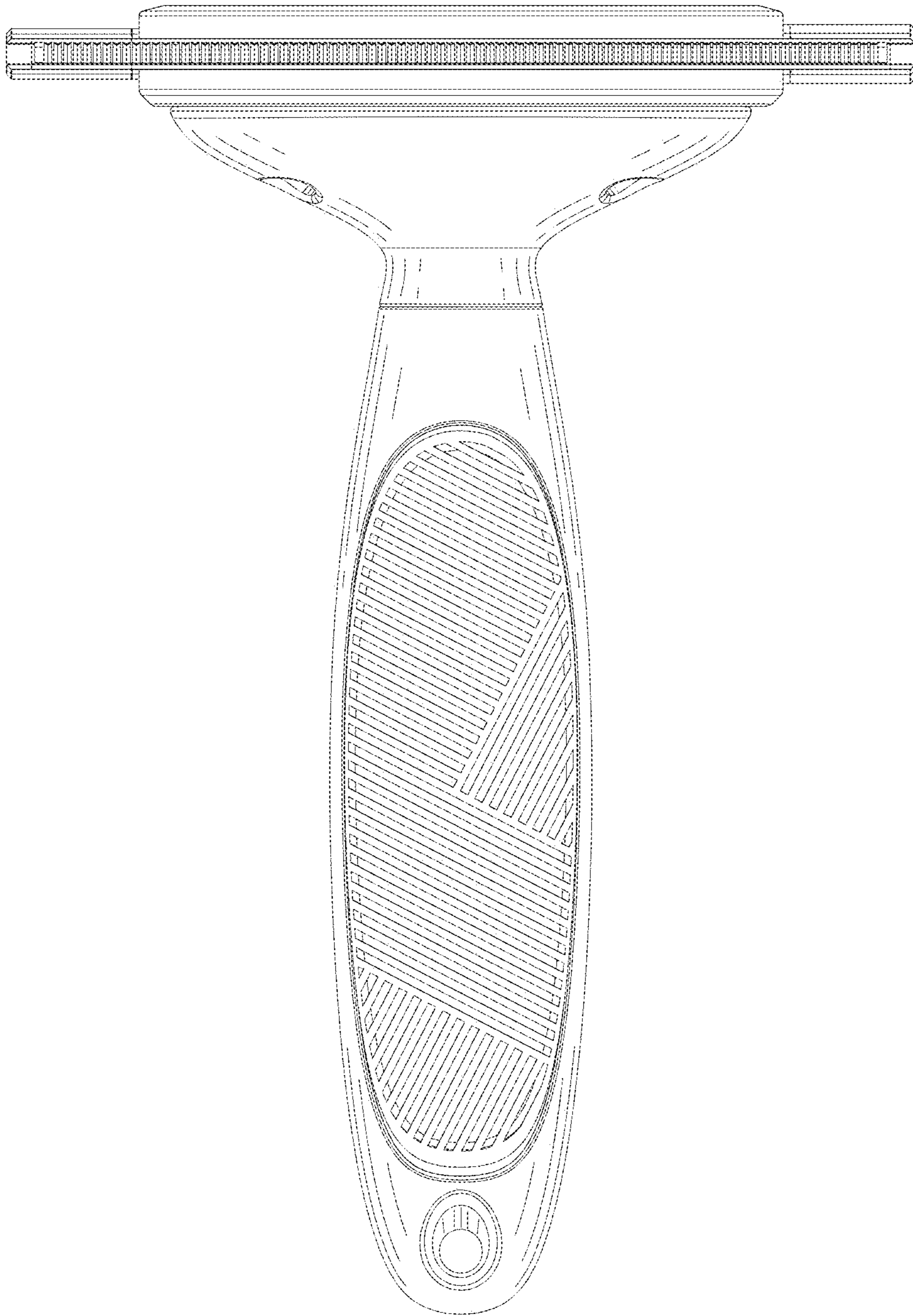

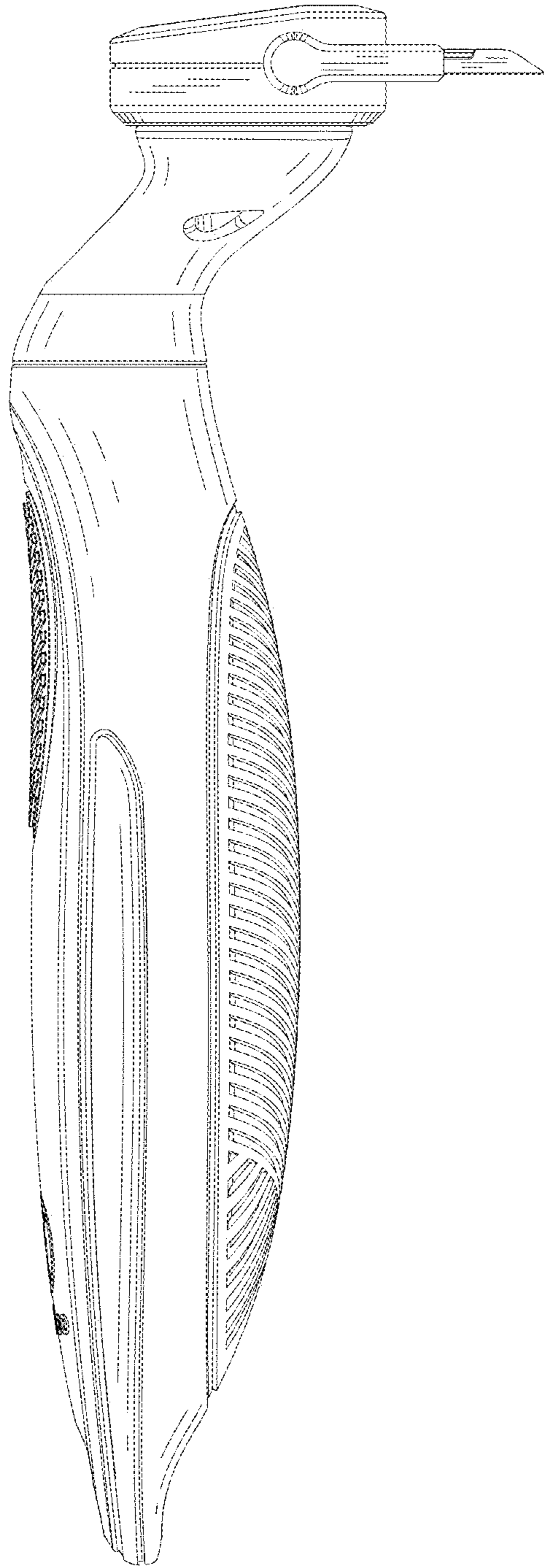

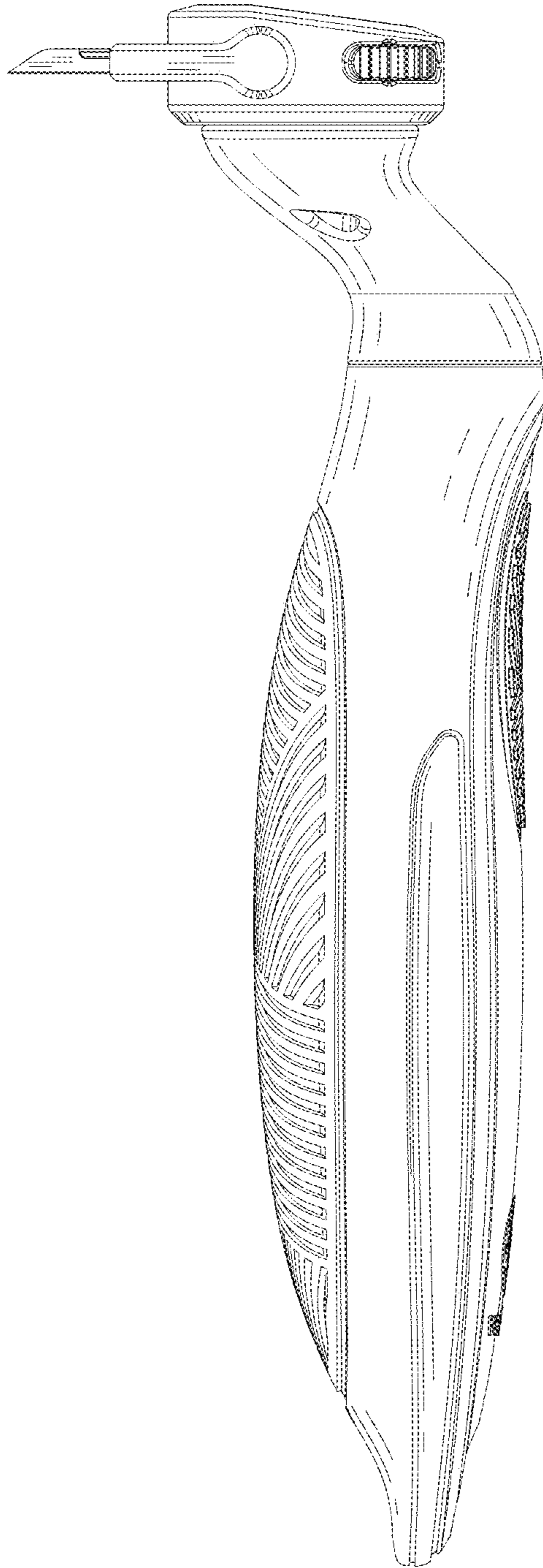

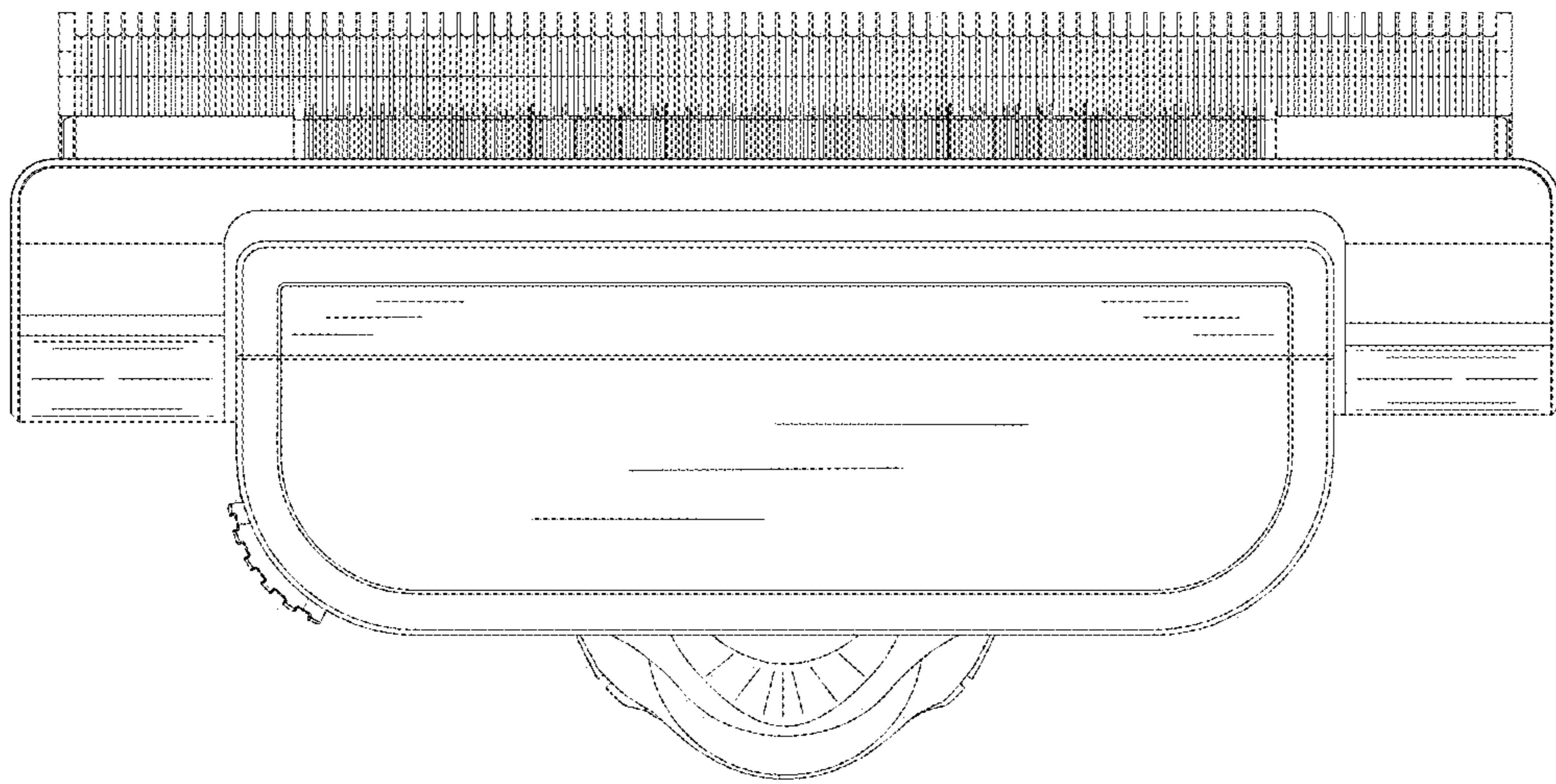

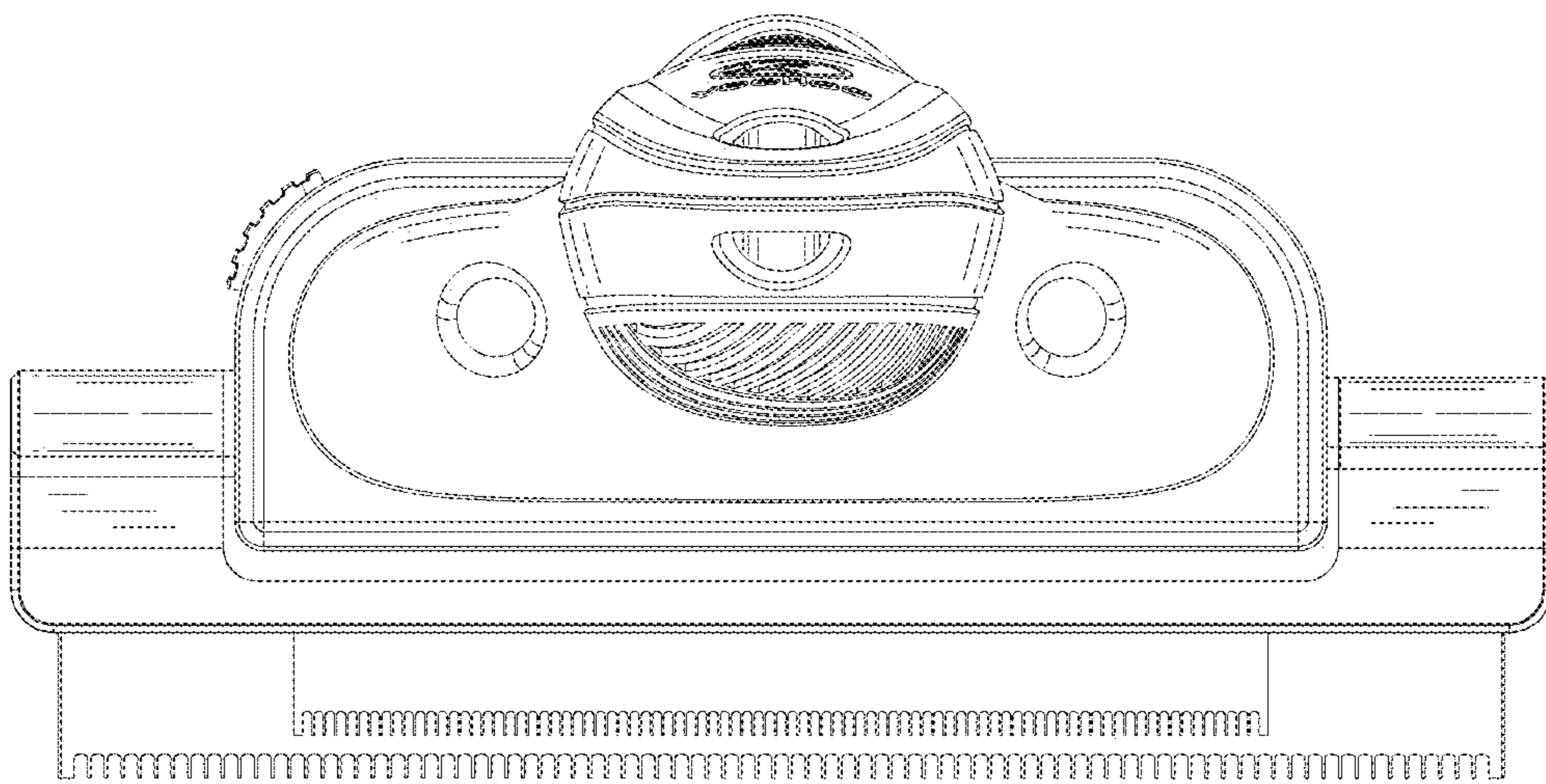
