FIG. 9 is a right side elevation view of the new design of FIG. 1; the left side being a mirror image thereof.

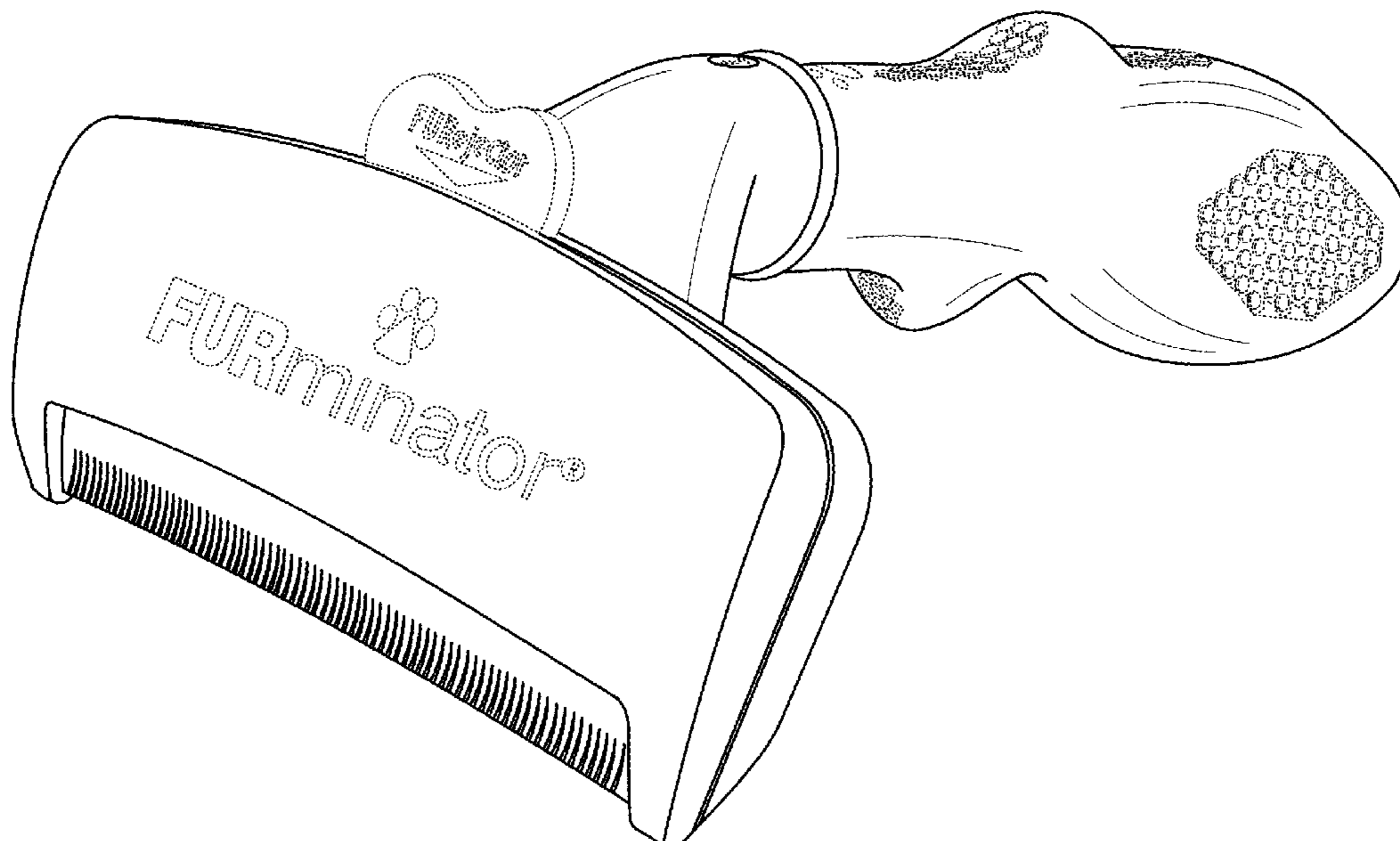

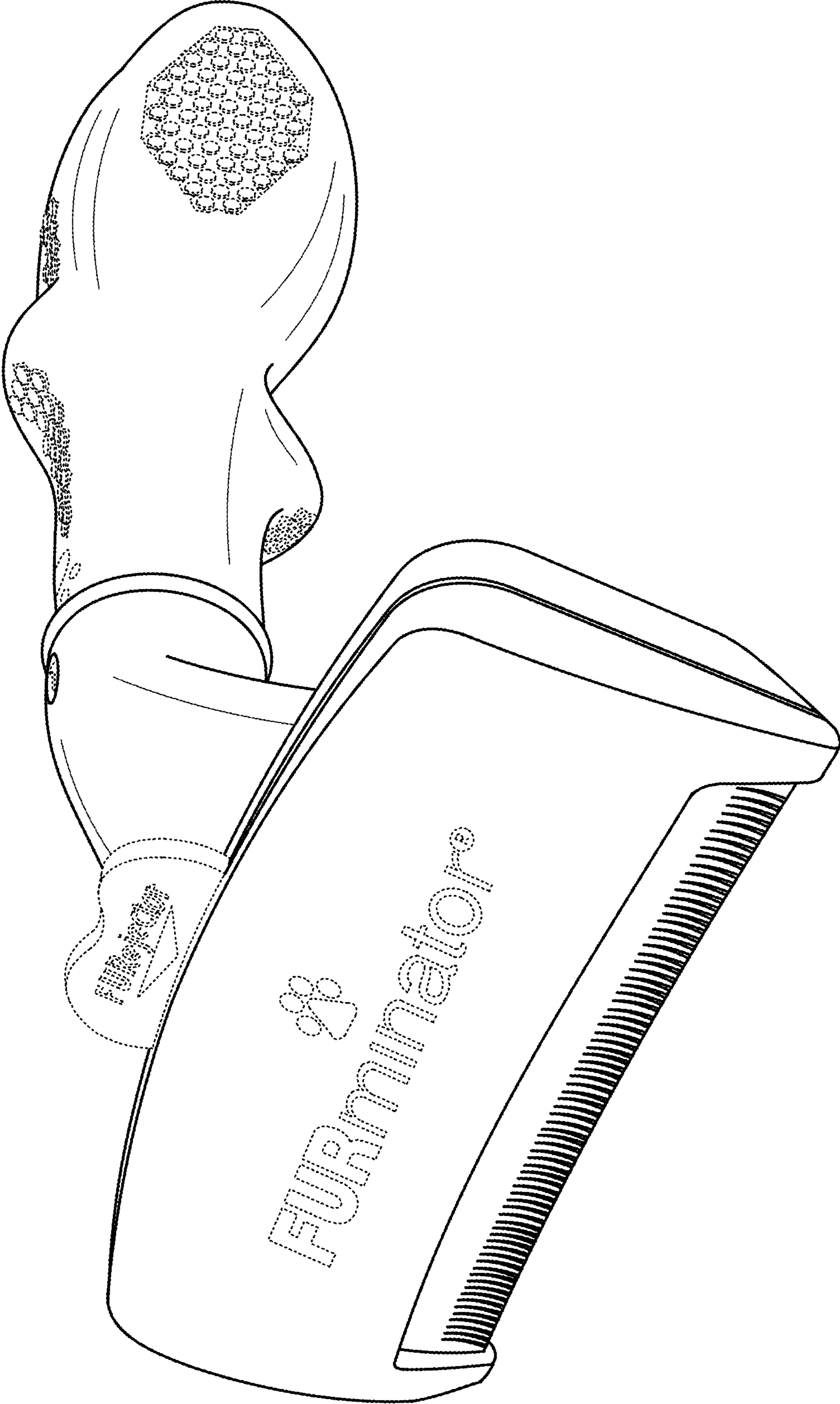

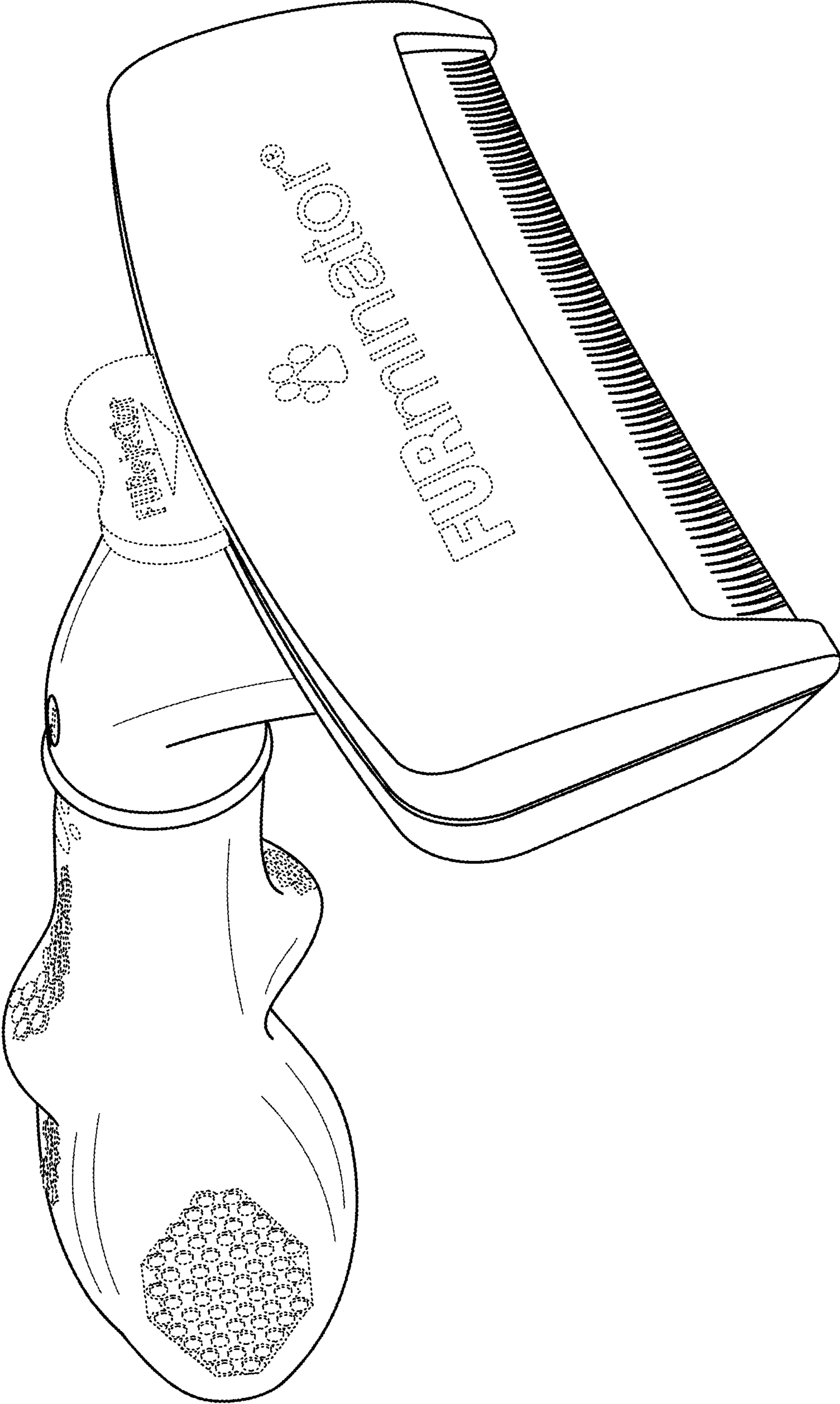
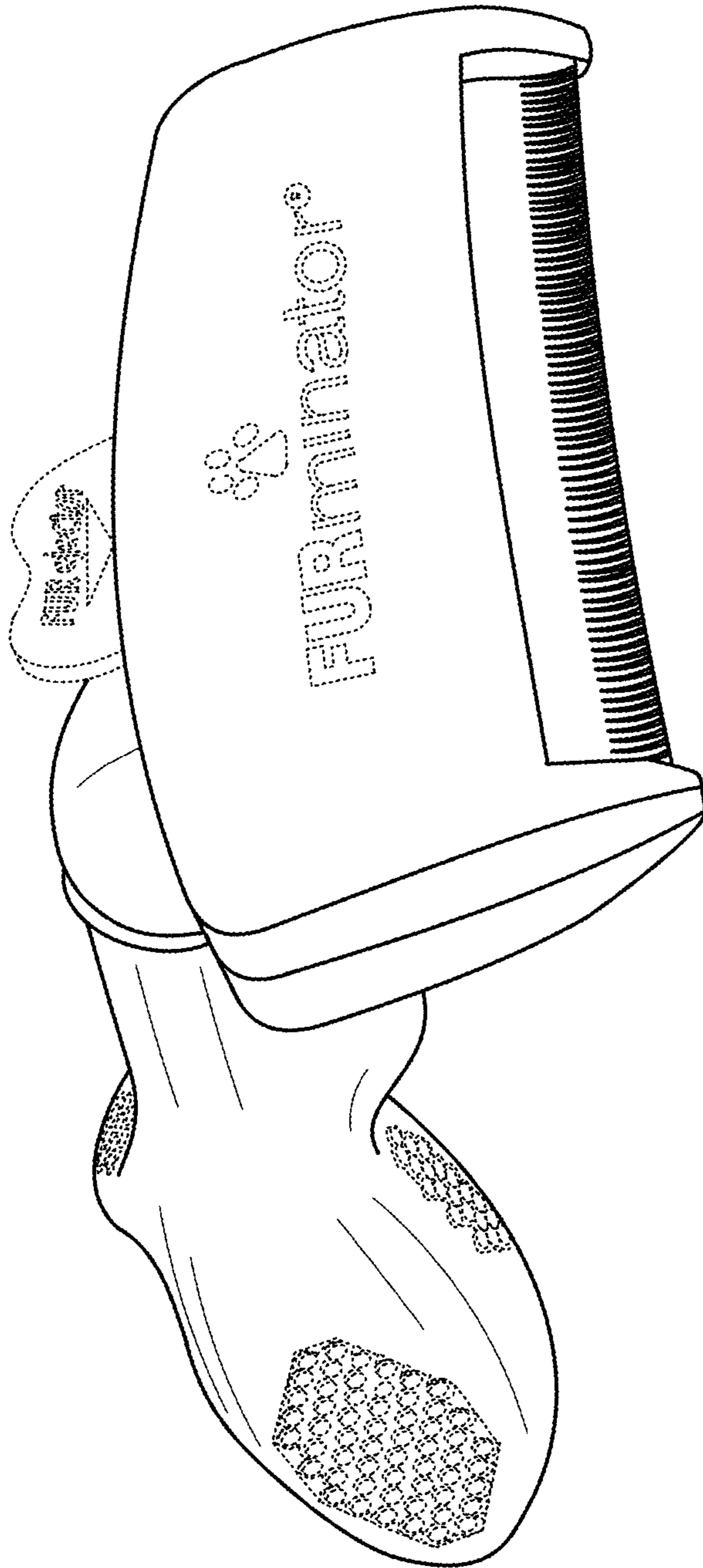
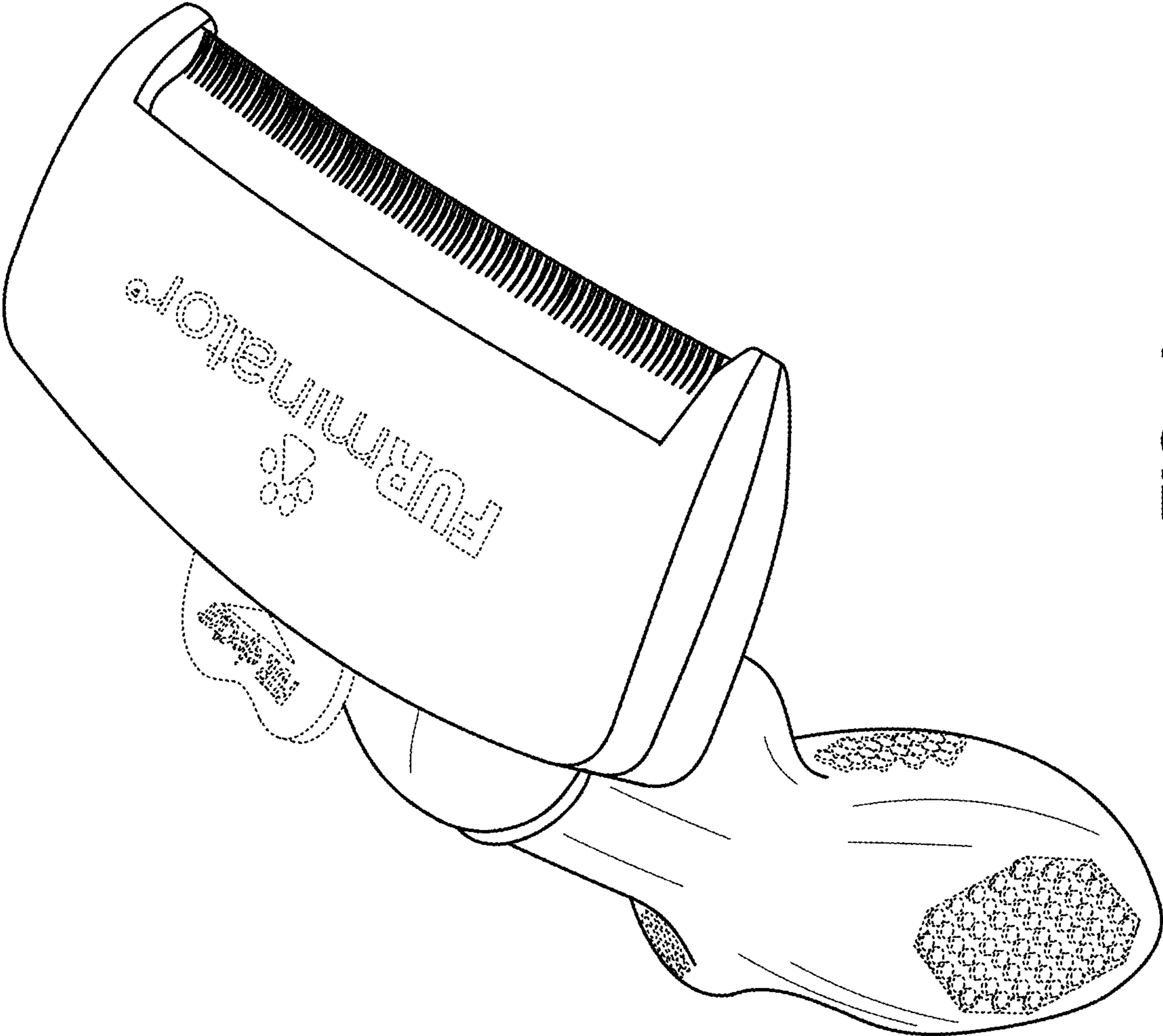

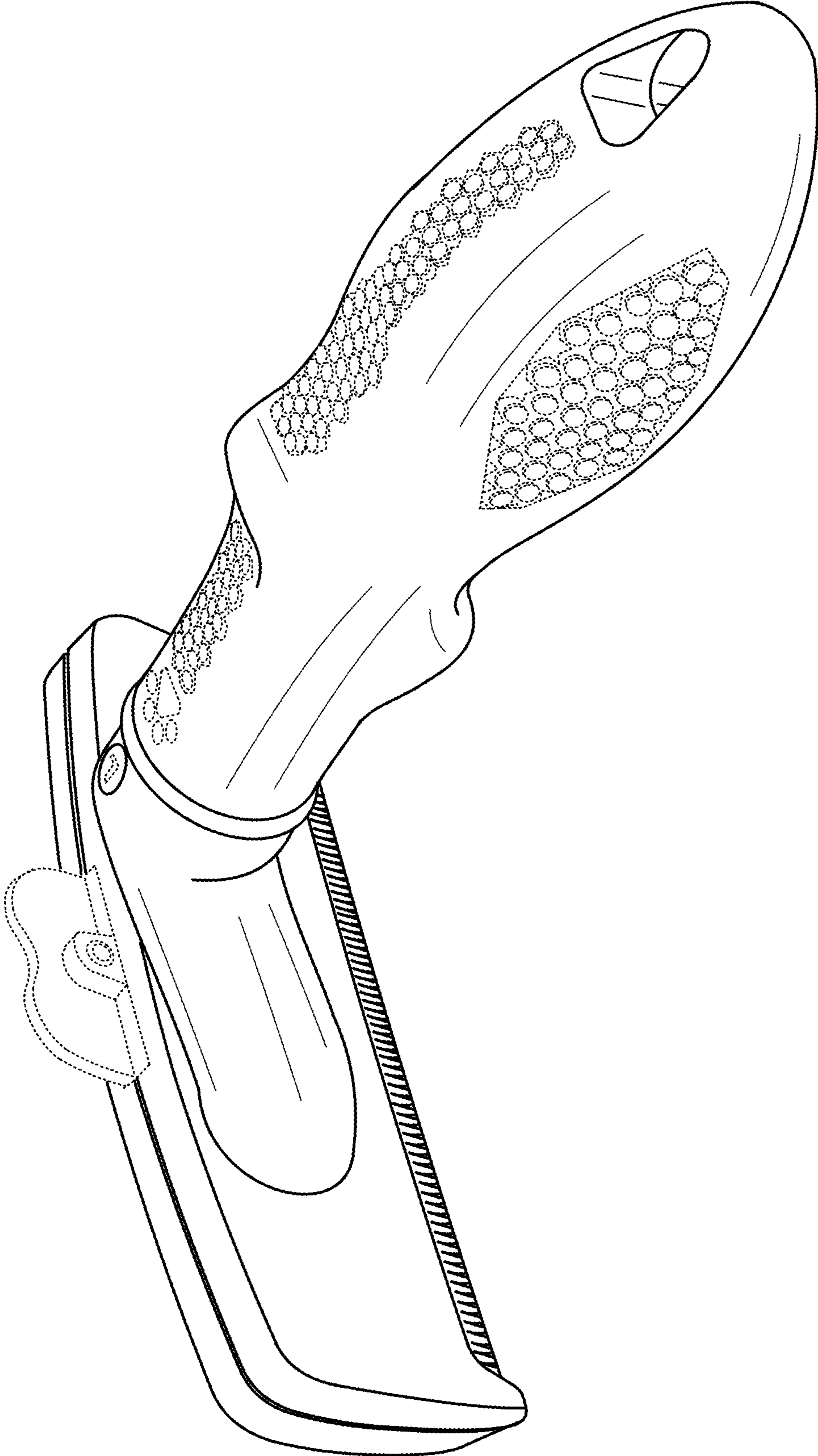
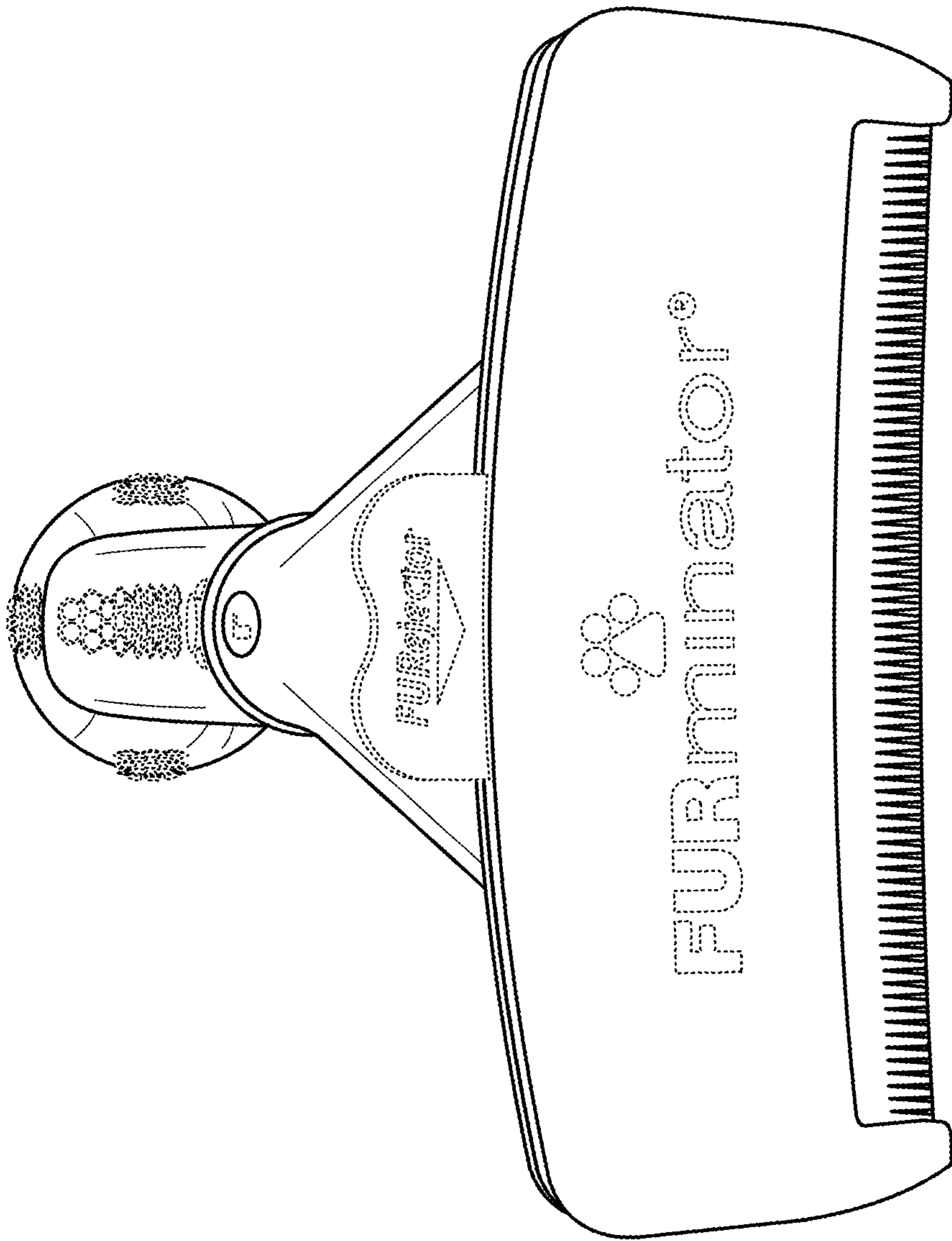
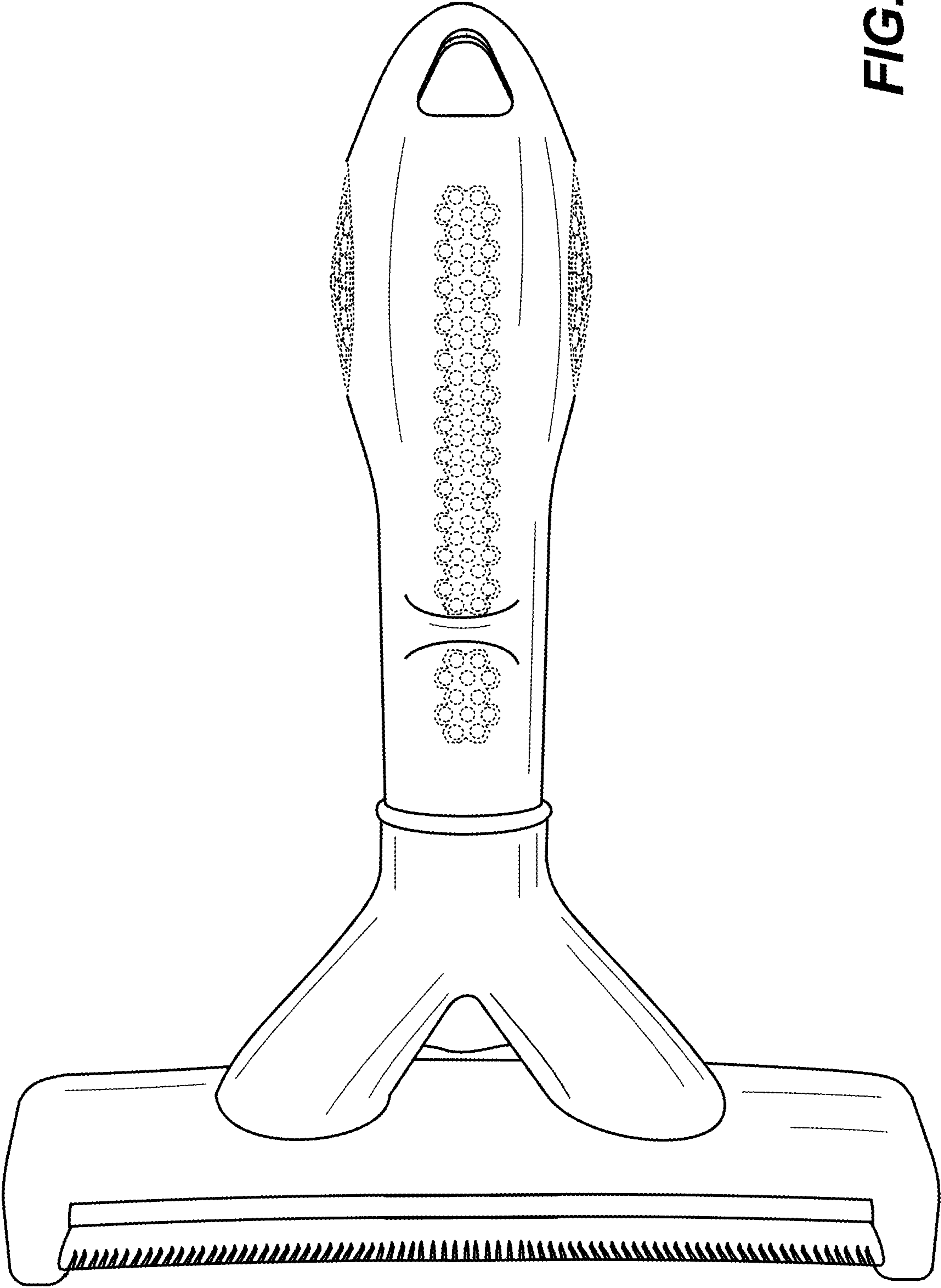

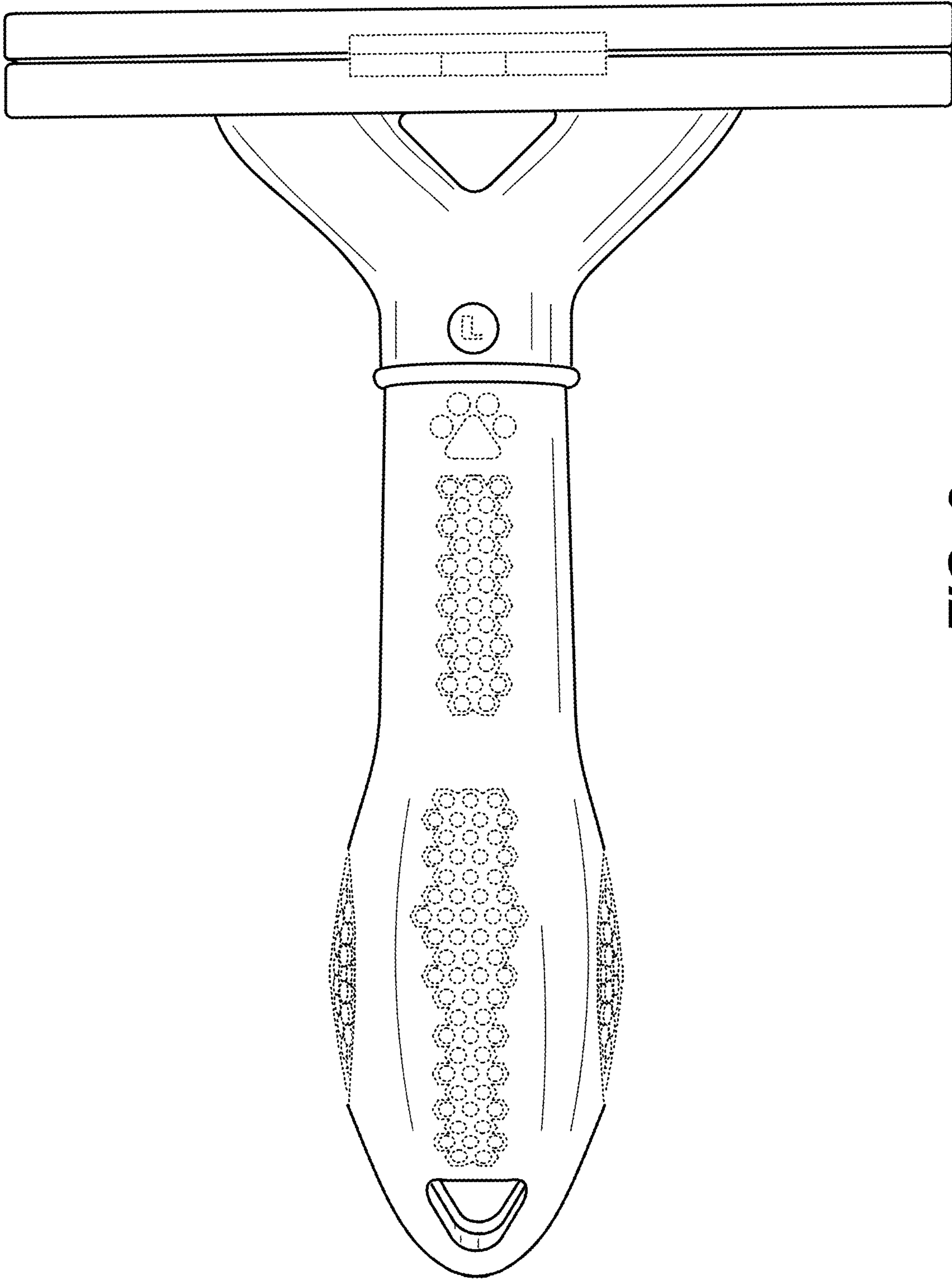

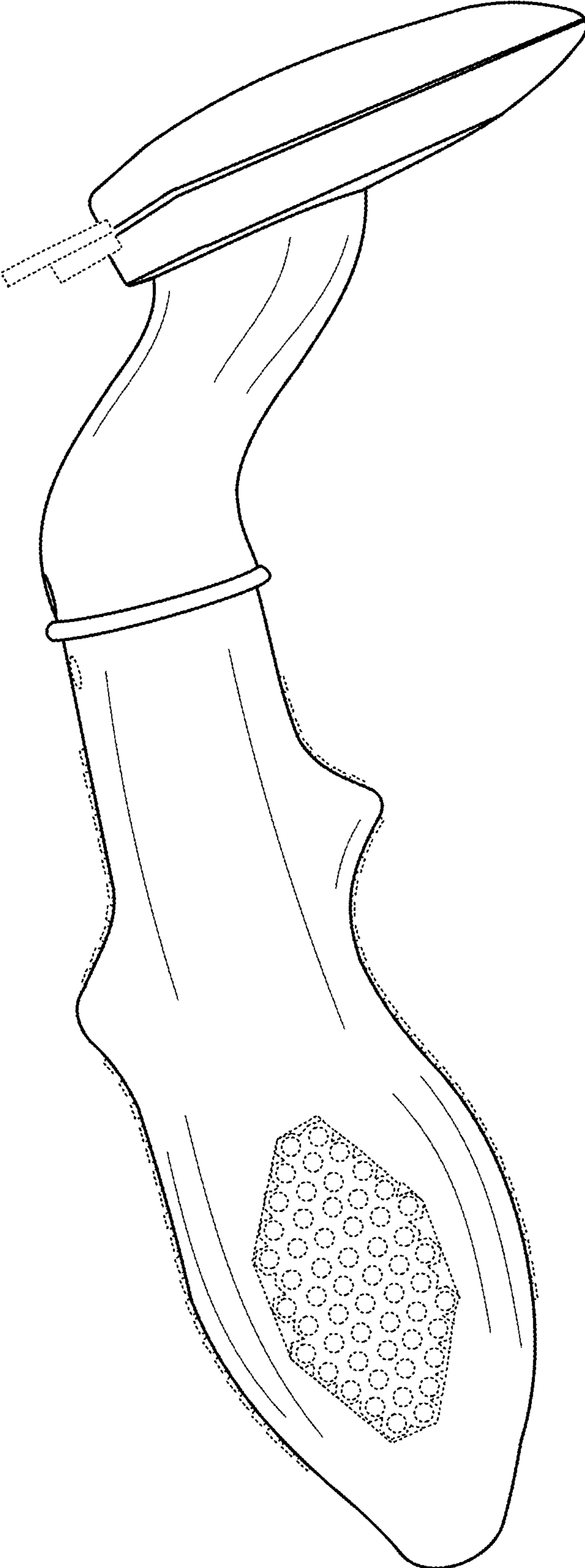
