**DESCRIPTION**

FIG. 1 is a front perspective view of a handbag showing my new design;

FIG. 2 is a front view thereof with the strap not visible;

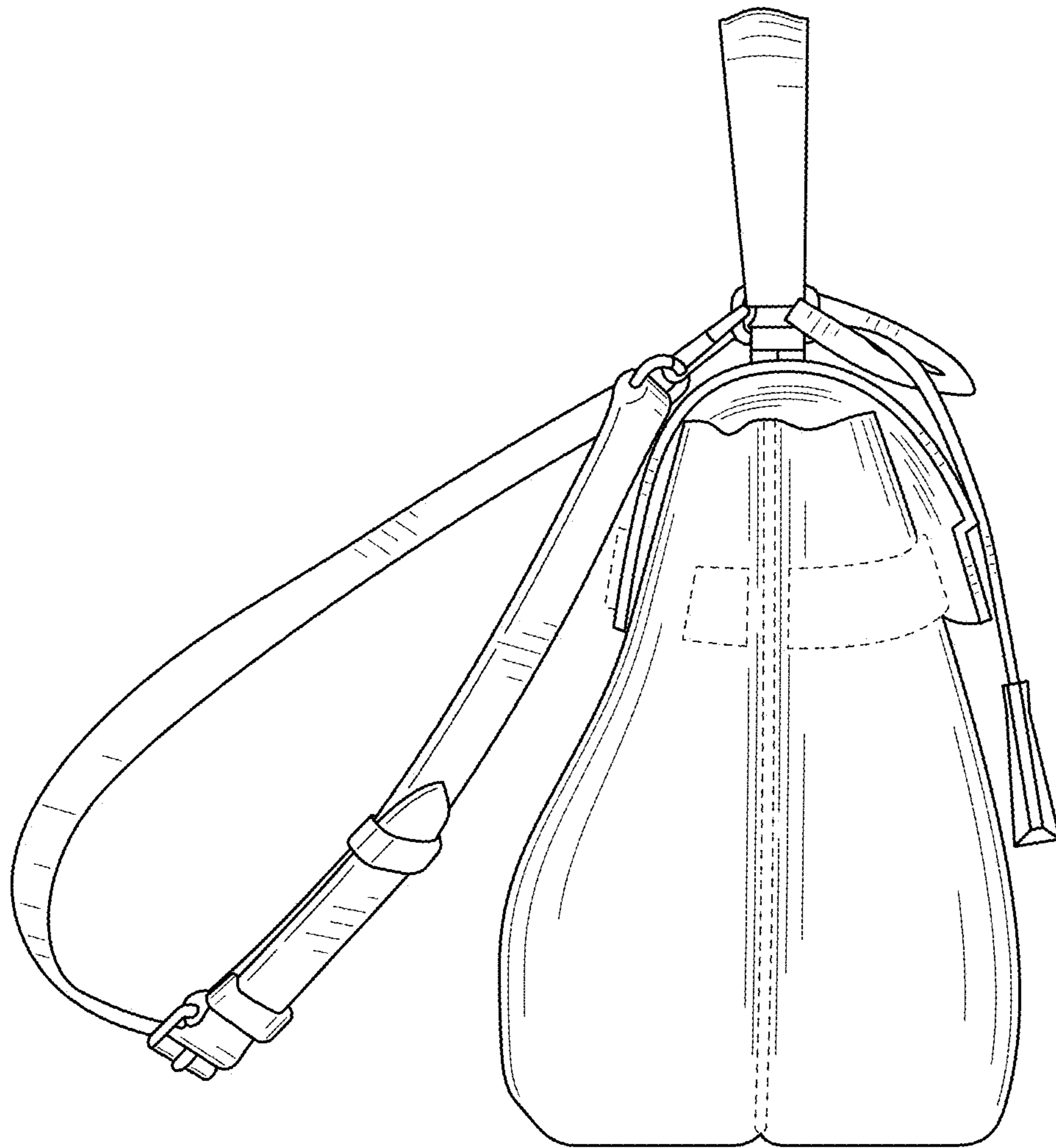

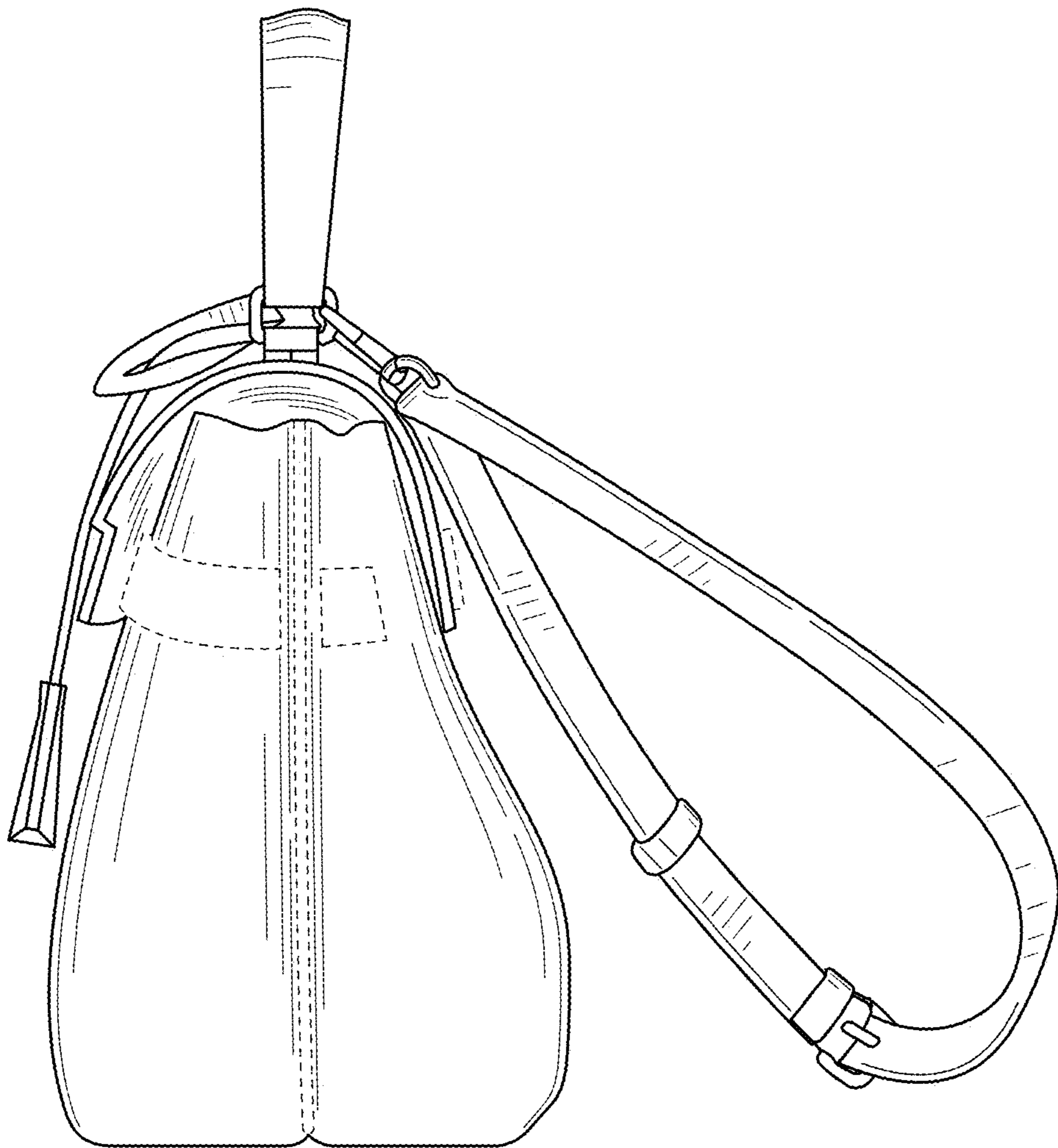

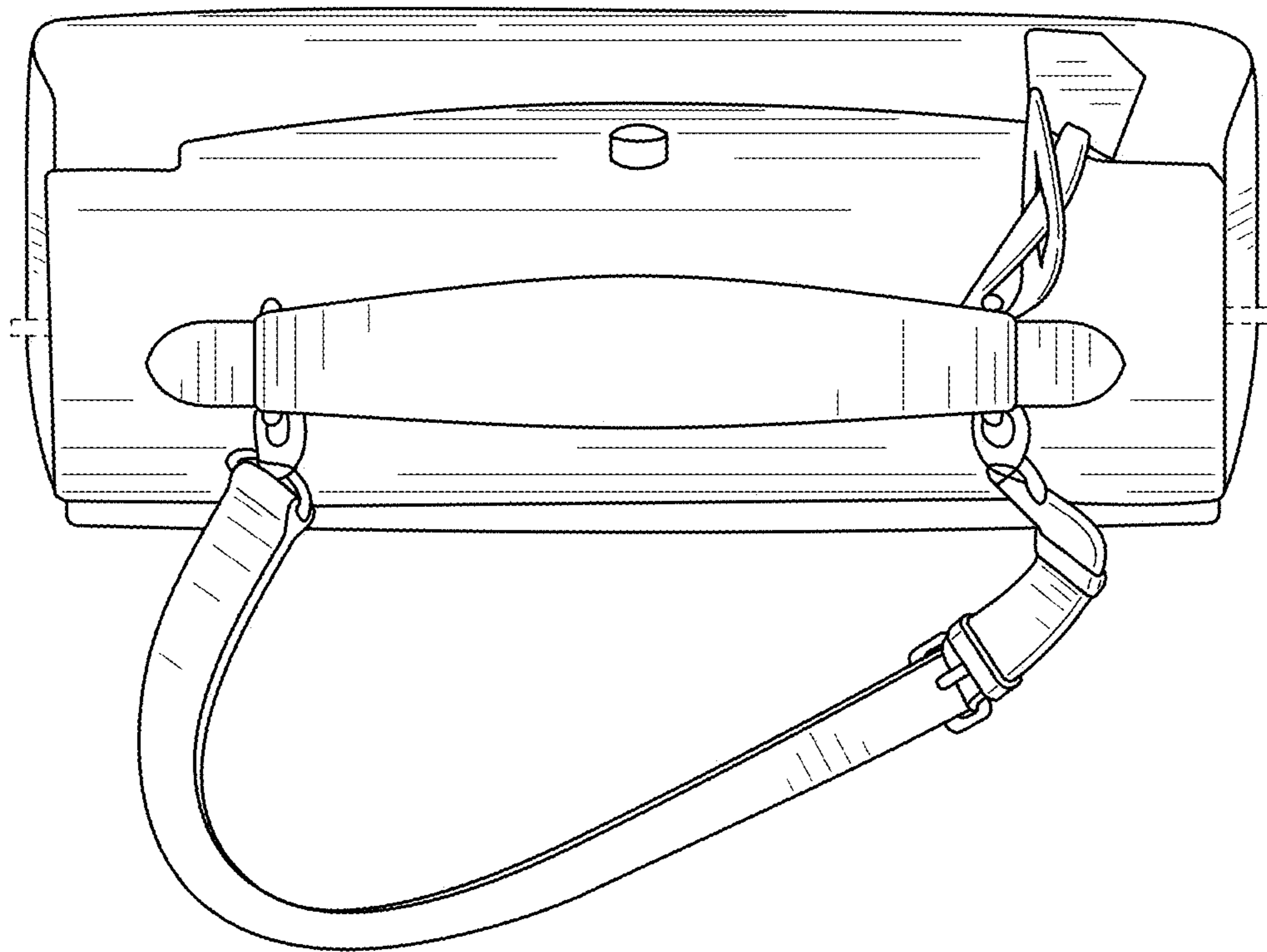

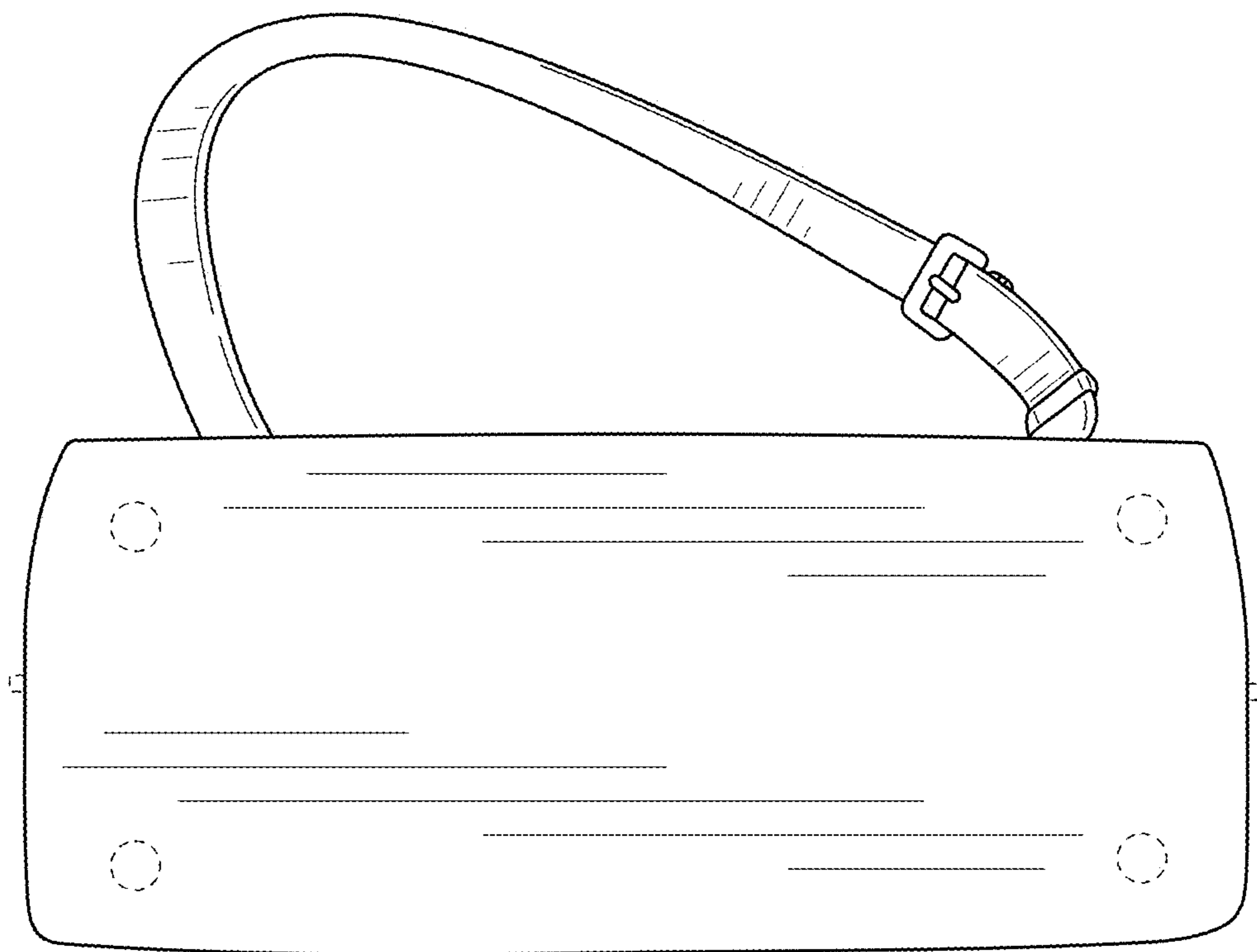
