We claim the ornamental design for a mattress layer, as shown and described.

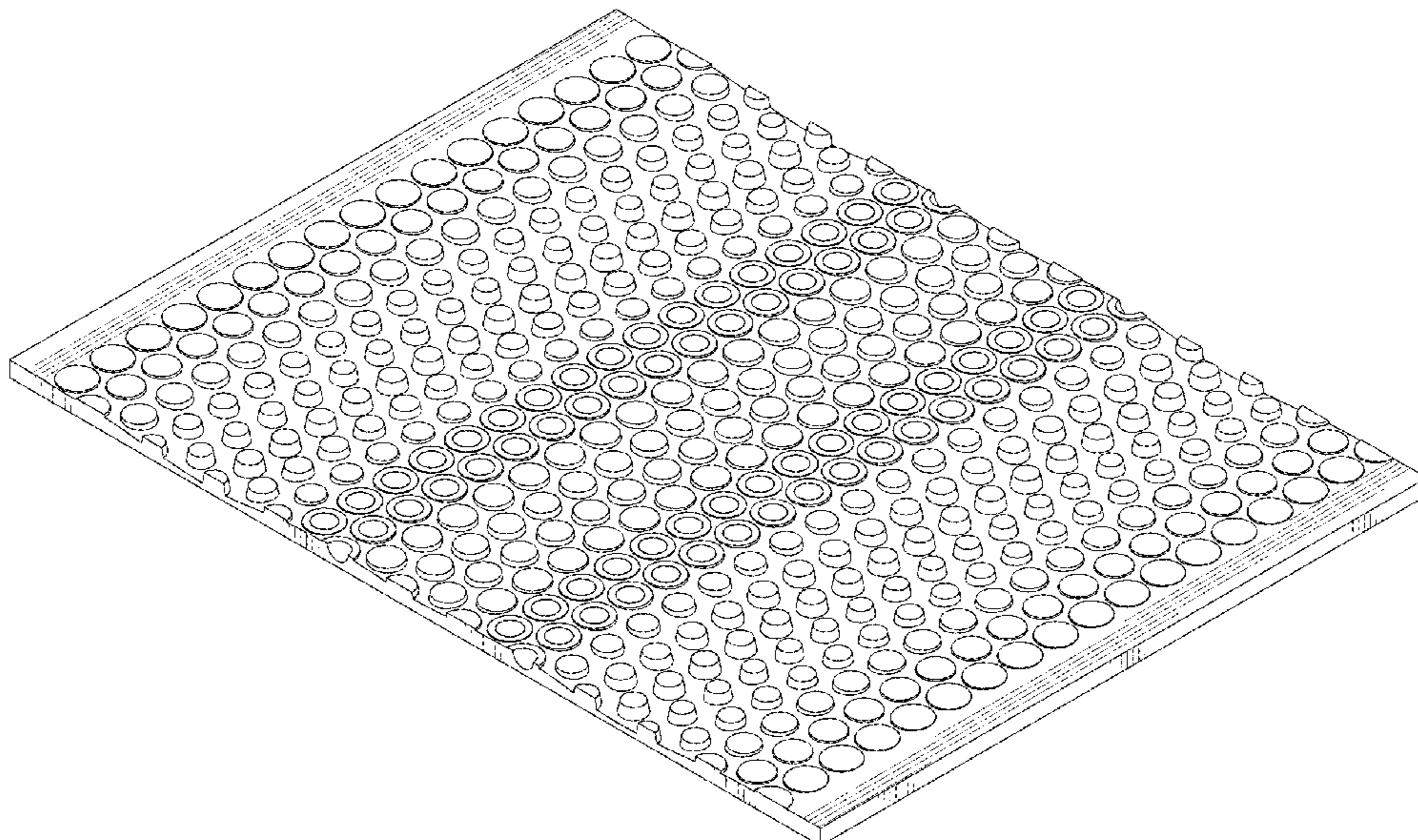
DESCRIPTION

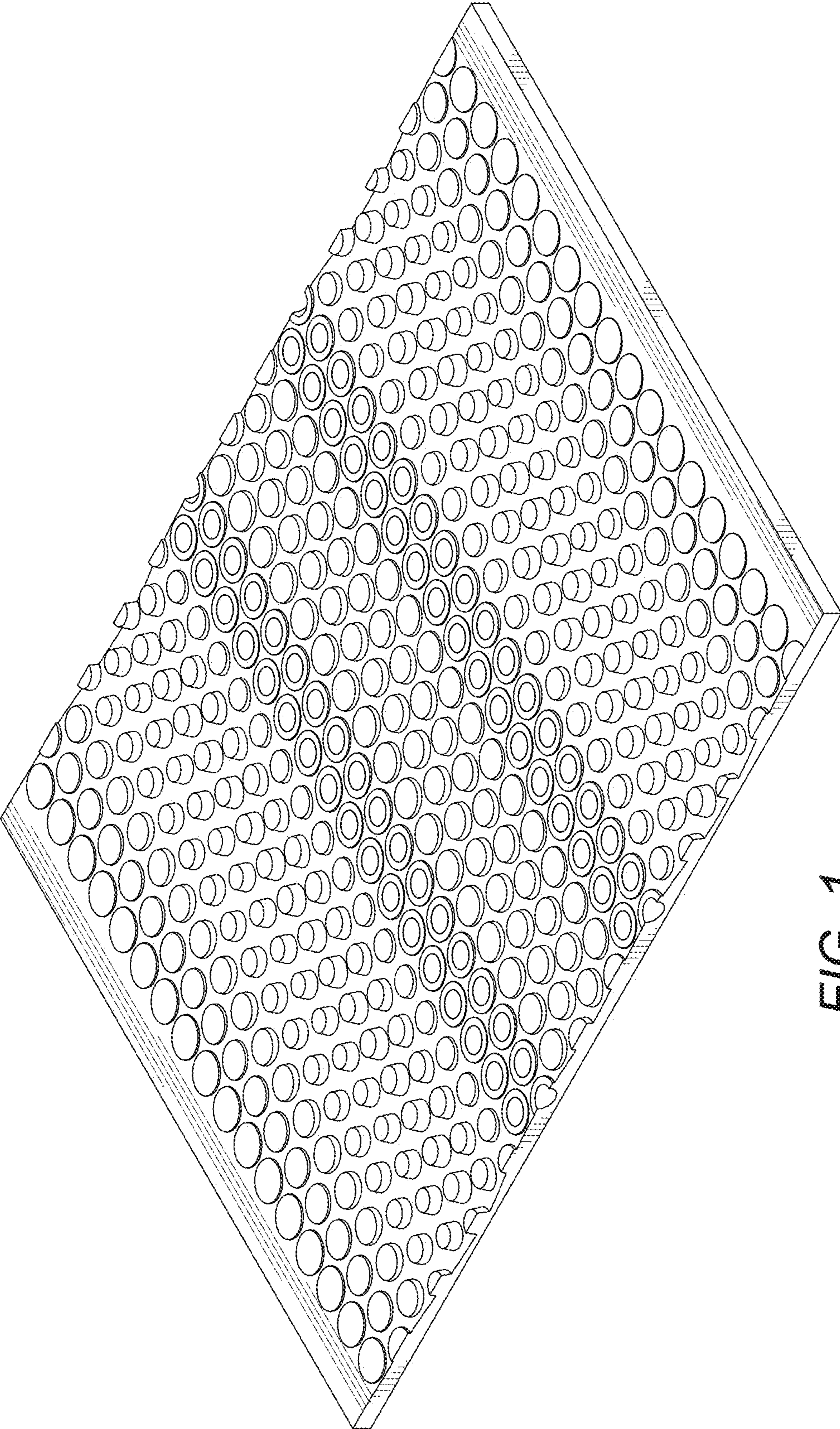

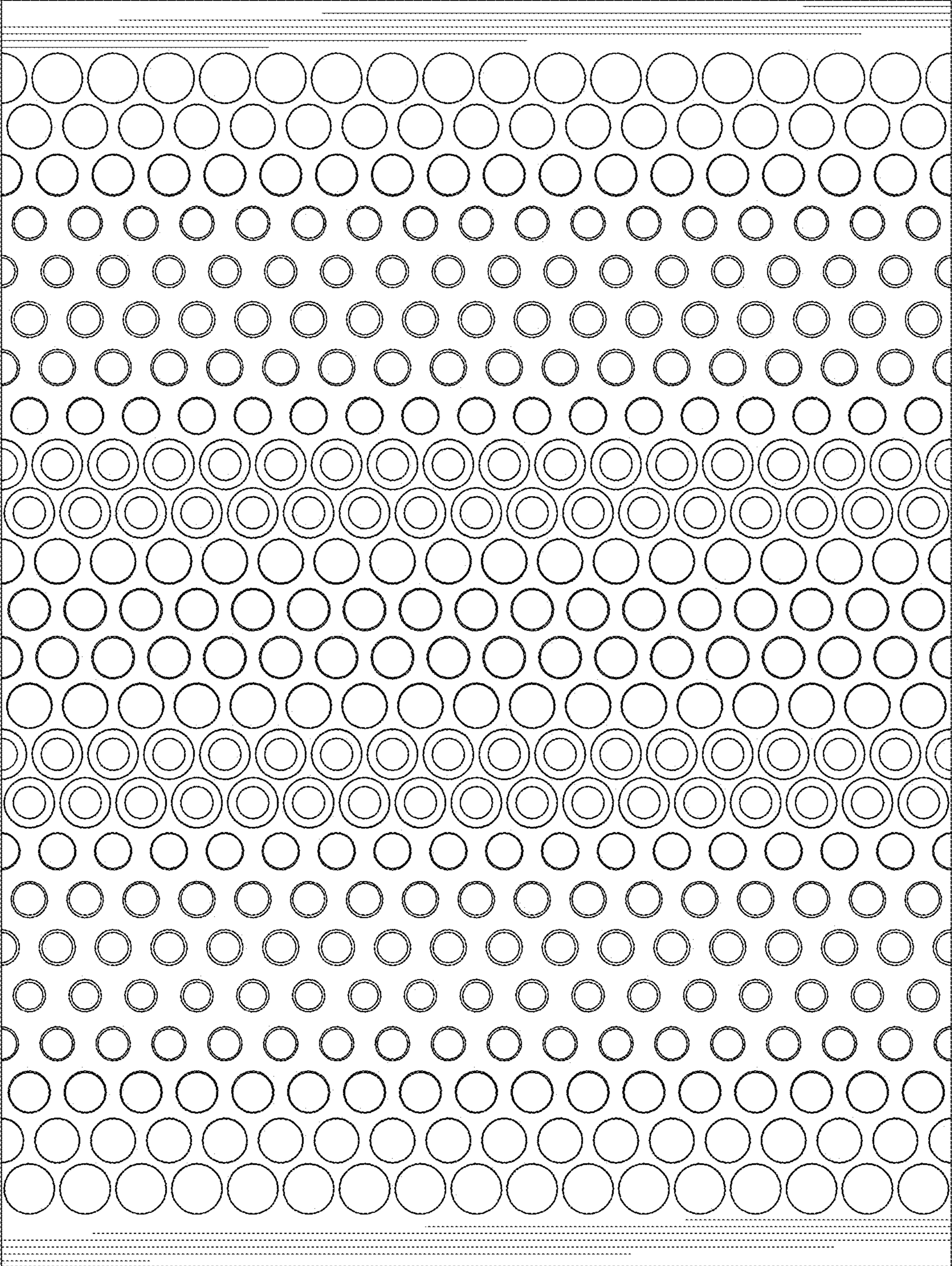

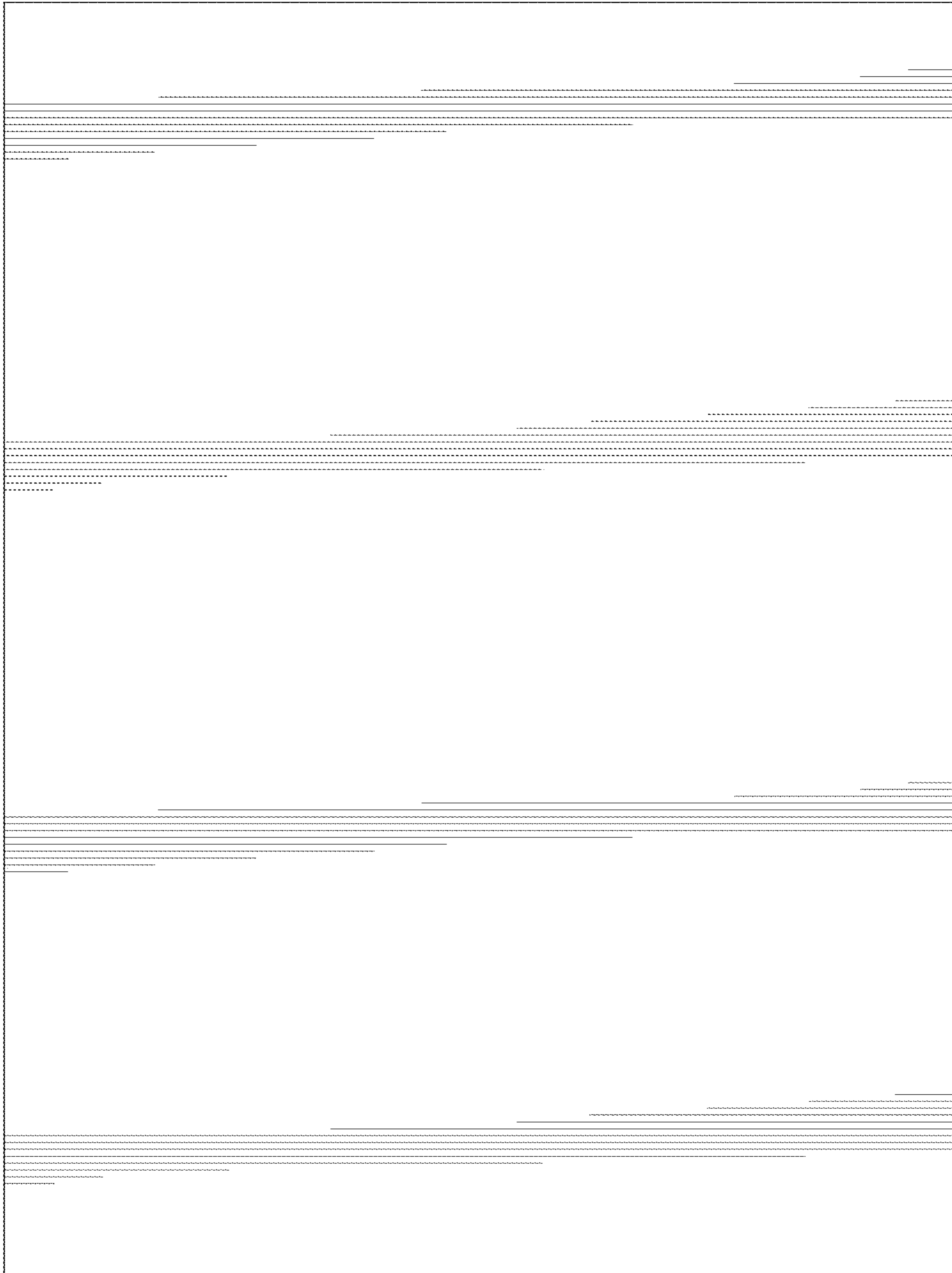

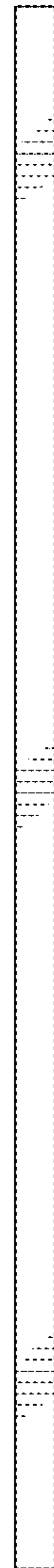
