(57) **CLAIM**

The ornamental design for a flexible band with identifying indicia, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a flexible band with identifying indicia showing one embodiment of my design.

FIG. 2 is a bottom plan view thereof.

FIG. 3 is a side elevation view thereof.

FIG. 4 is a left end view thereof; the right end view is the same as the left end view.

FIG. 5 is a top plan view thereof, shown with the letter Q.

FIG. 6 is another top plan view thereof, shown with the letter F.

FIG. 7 is another top plan view thereof, shown with the letter T.

FIG. 8 is a top plan view of a flexible band with identifying indicia showing another embodiment of my design.

FIG. 9 is a bottom plan view of the flexible band of FIG. 8.

FIG. 10 is a side elevation view of the flexible band of FIG. 8.

FIG. 11 is a left end view of the flexible band of FIG. 8; the right end view is the same as the left end view.

FIG. 12 is a top plan view thereof, shown with the letter Q.

FIG. 13 is another top plan view thereof, shown with the letter F.

FIG. 14 is another top plan view thereof, shown with the letter T.

FIG. 15 is a top plan view of a flexible band with identifying indicia showing another embodiment of my design.

FIG. 16 is a bottom plan view of the flexible band of FIG. 15.

FIG. 17 is a side elevation view of the flexible band of FIG. 15.

FIG. 18 is a left end view of the flexible band of FIG. 15; the right end view is the same as the left end view.

FIG. 19 is a top plan view thereof, shown with the letter Q.

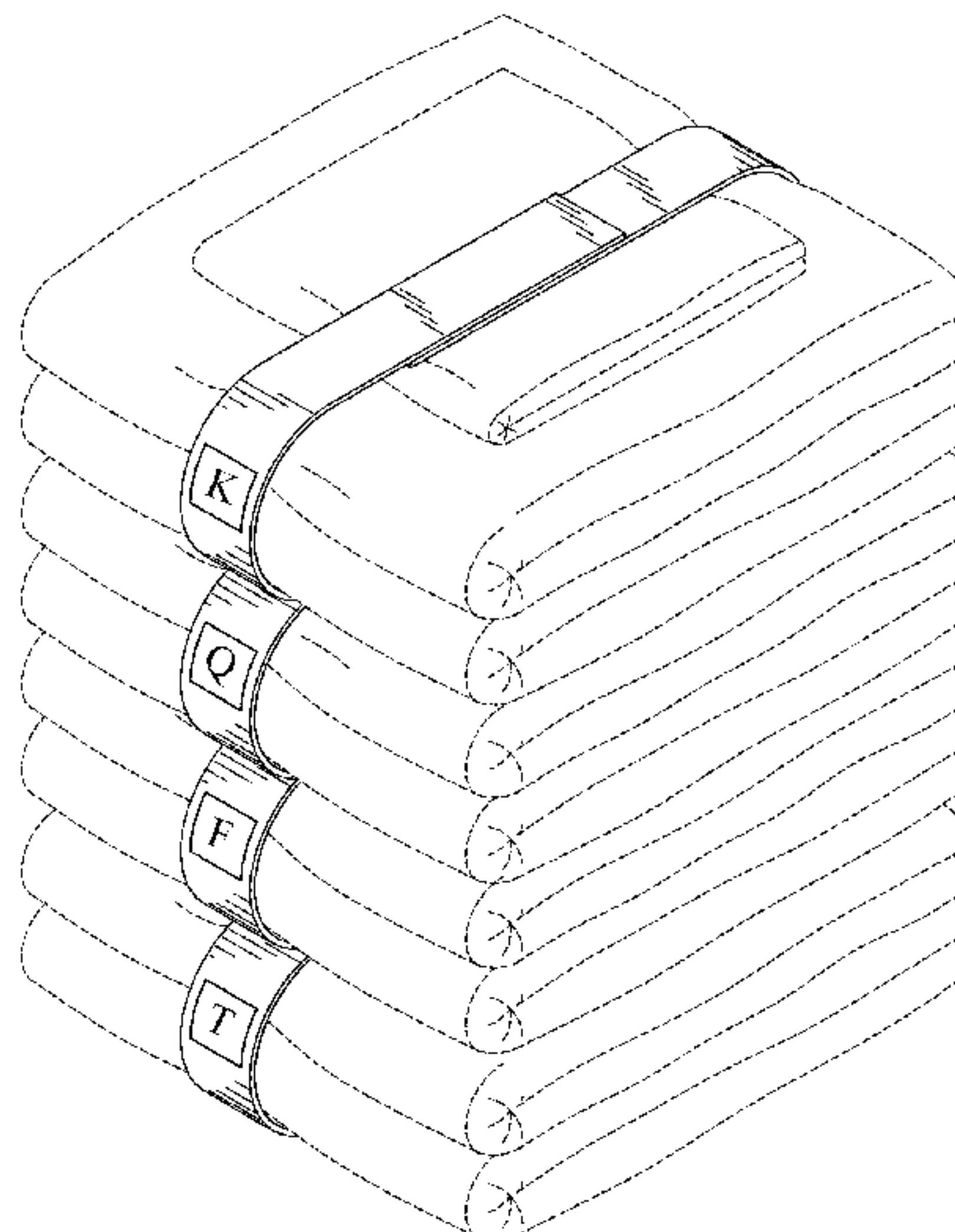
FIG. 20 is another top plan view thereof, shown with the letter F.

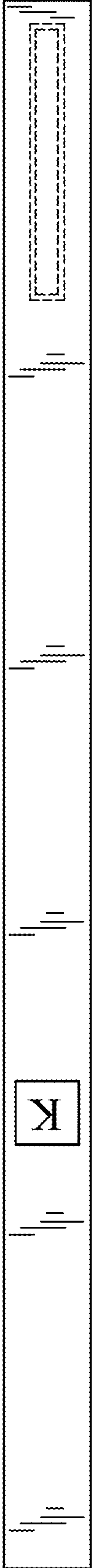

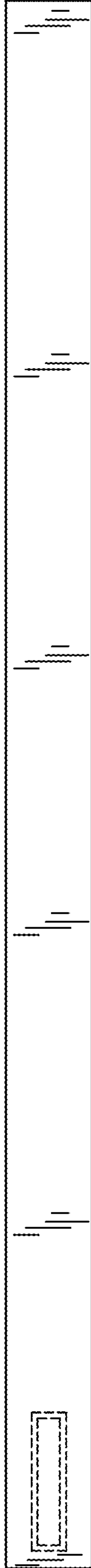

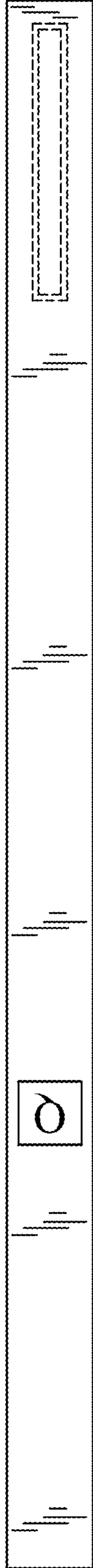

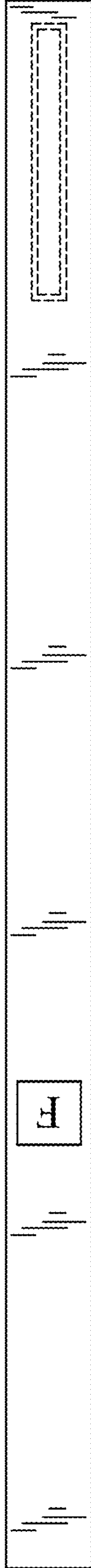

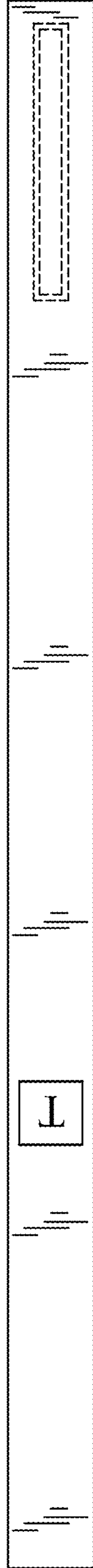

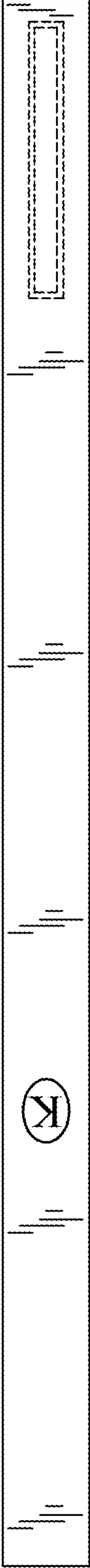

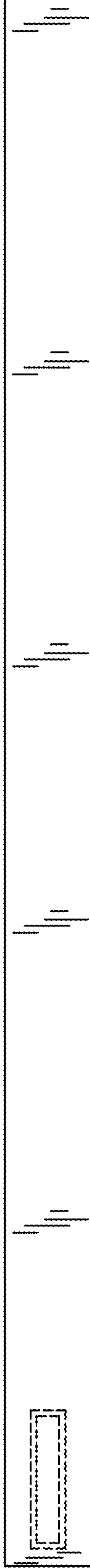

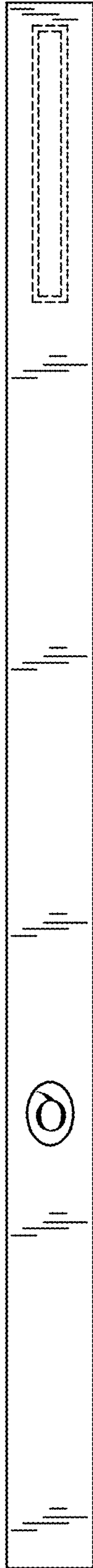

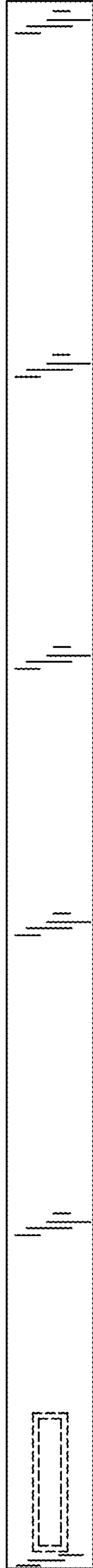

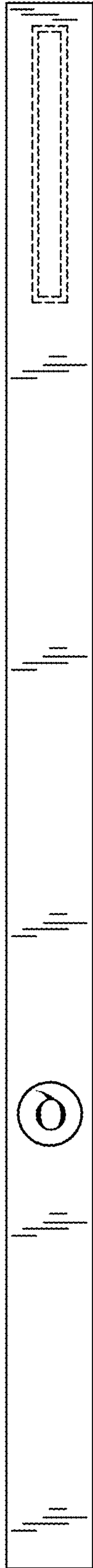

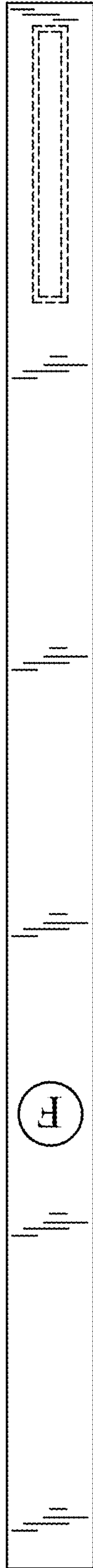

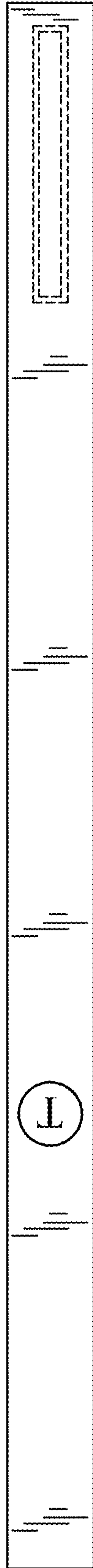

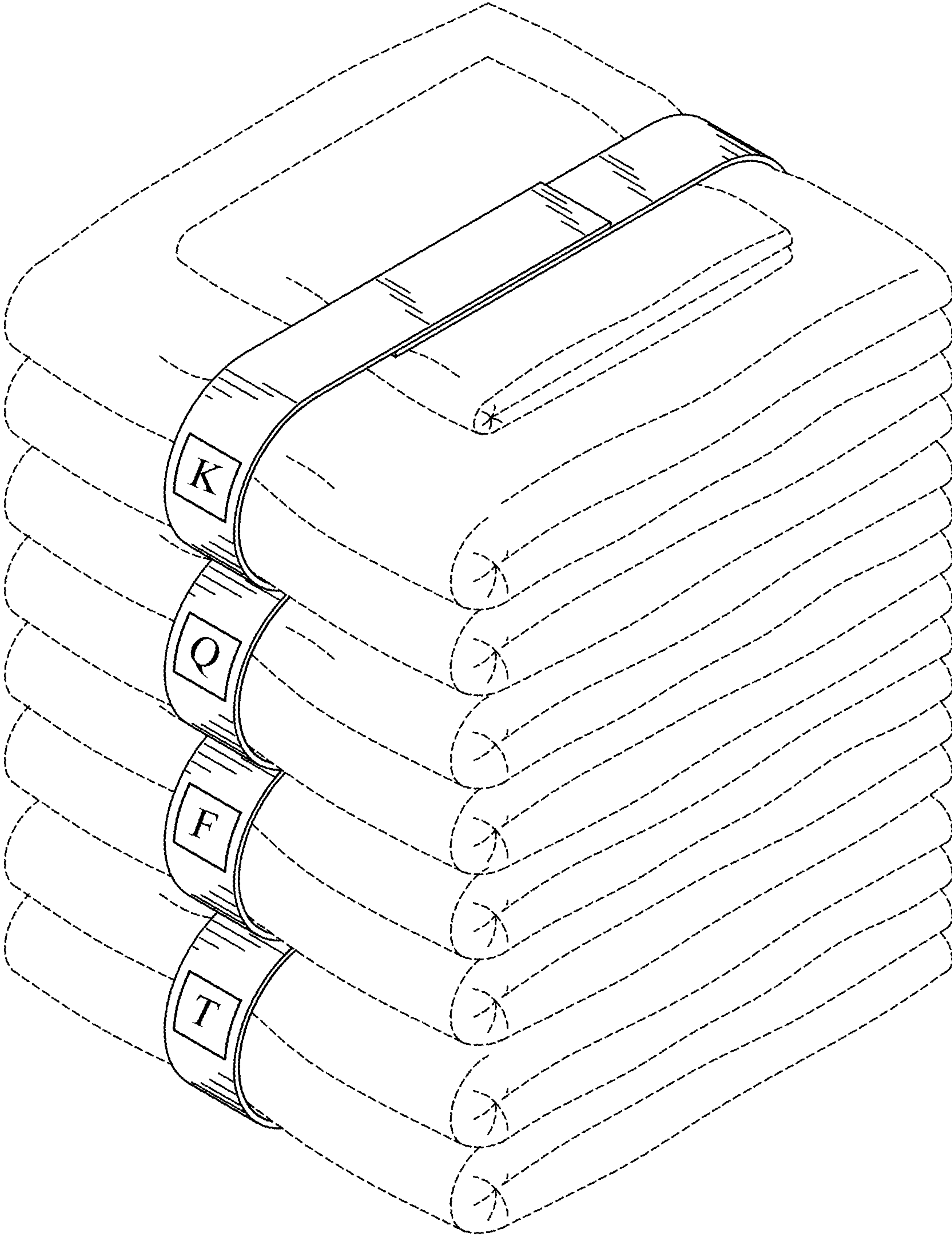
