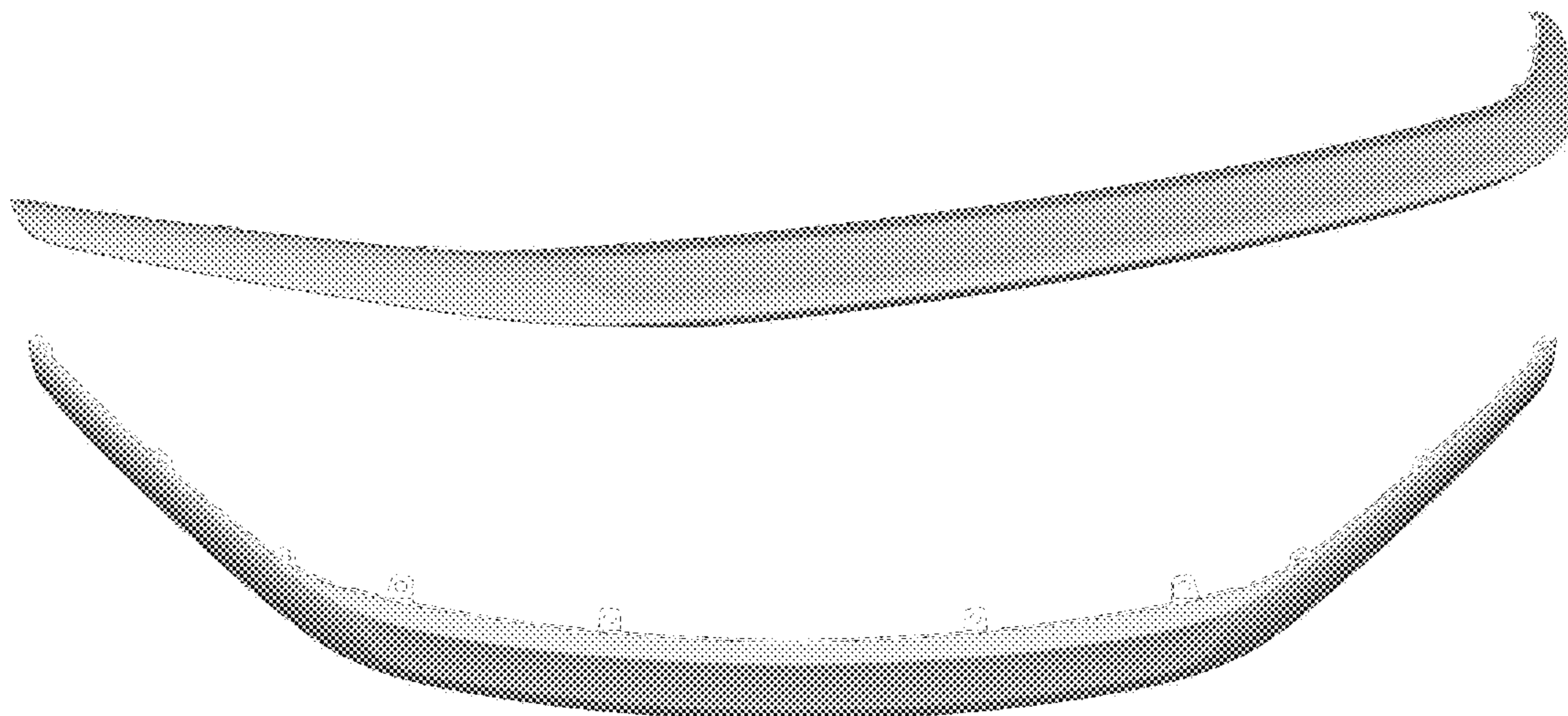
(57) **CLAIM**

The ornamental design for a vehicle grille bar, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a vehicle grille bar showing a first embodiment of my new design.  
FIG. 2 is a rear perspective view thereof.  
FIG. 3 is a front elevational view thereof.  
FIG. 4 is a rear elevational view thereof.  
FIG. 5 is a left side elevational view thereof.

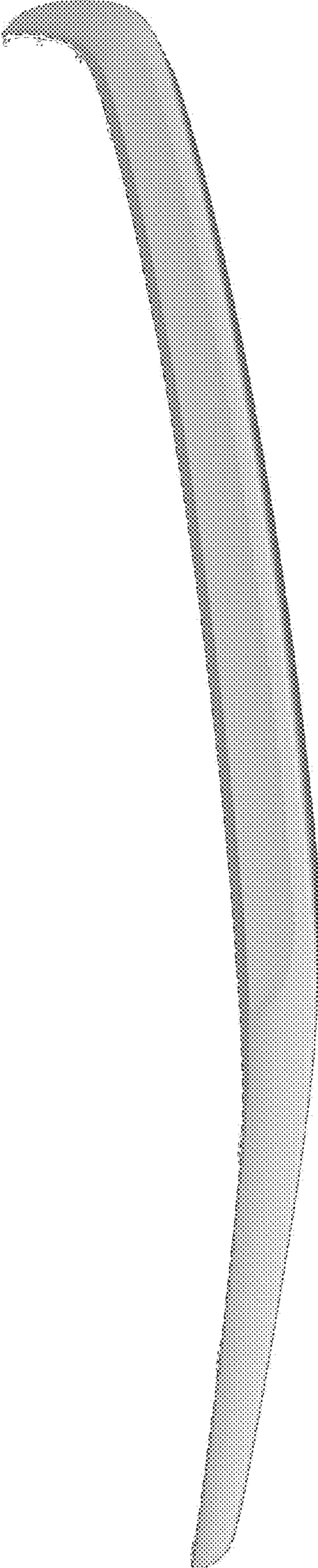

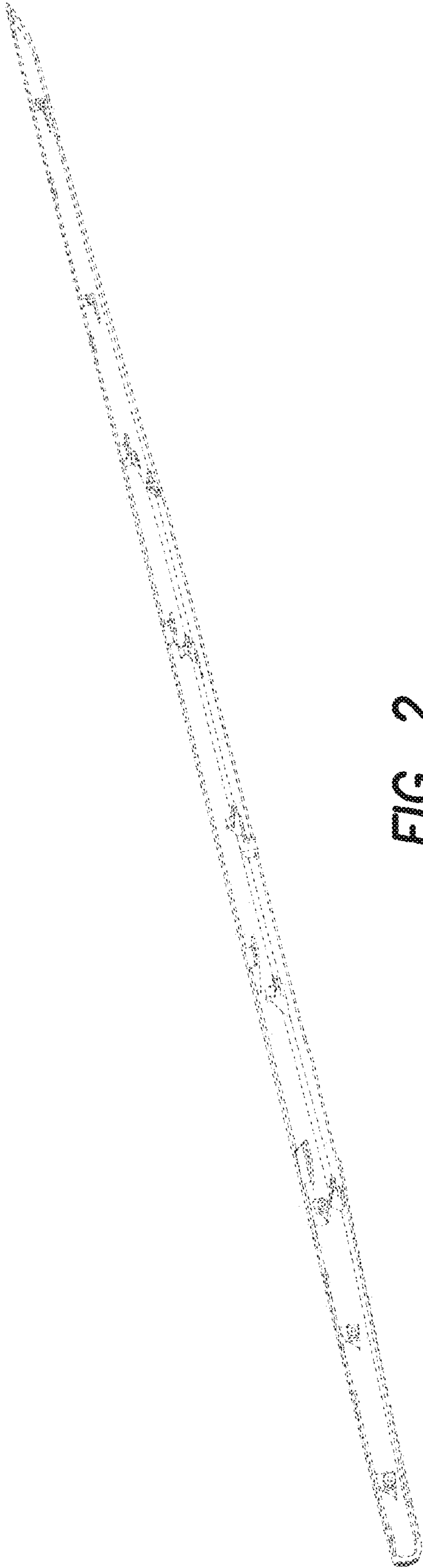

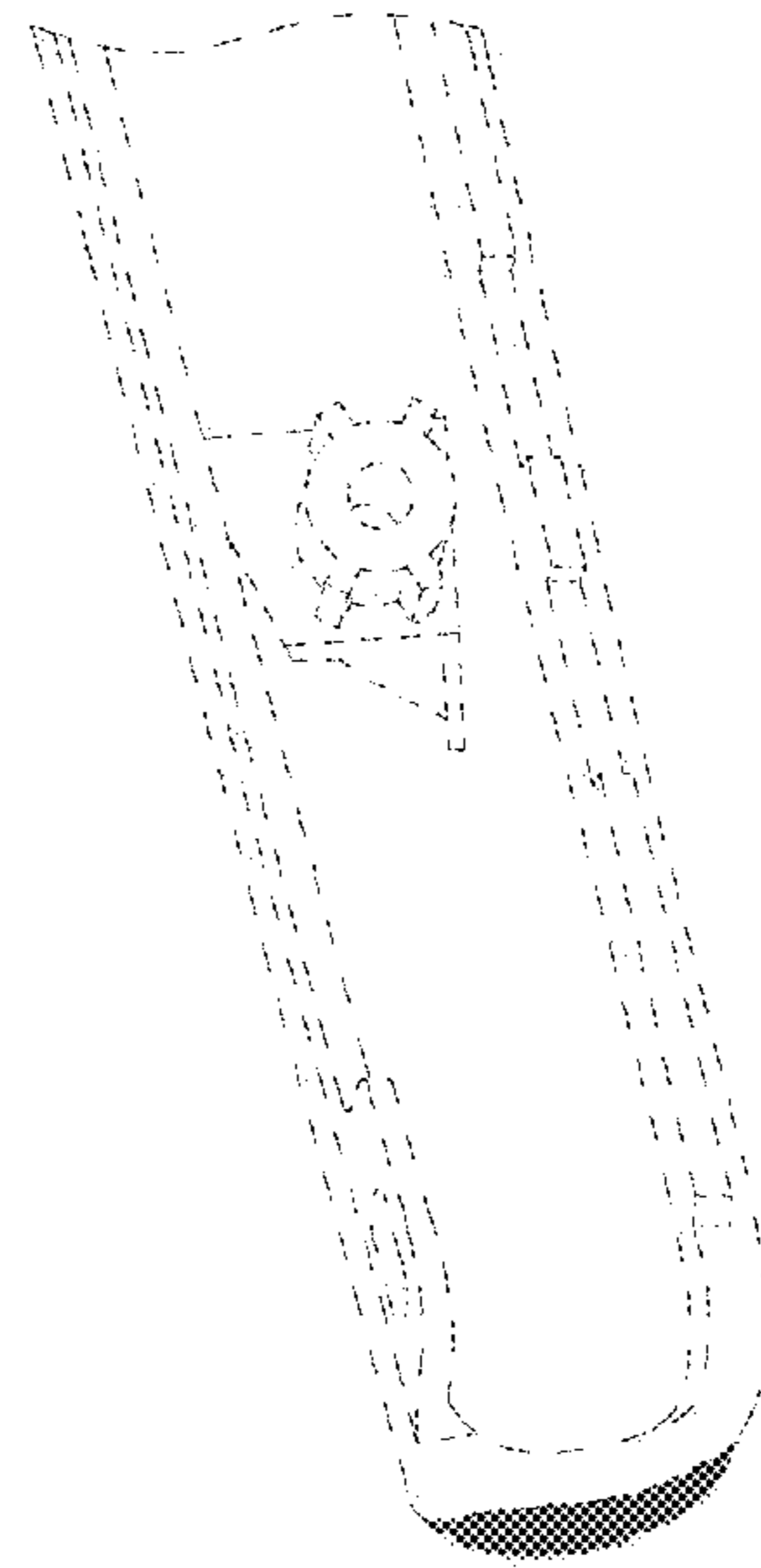

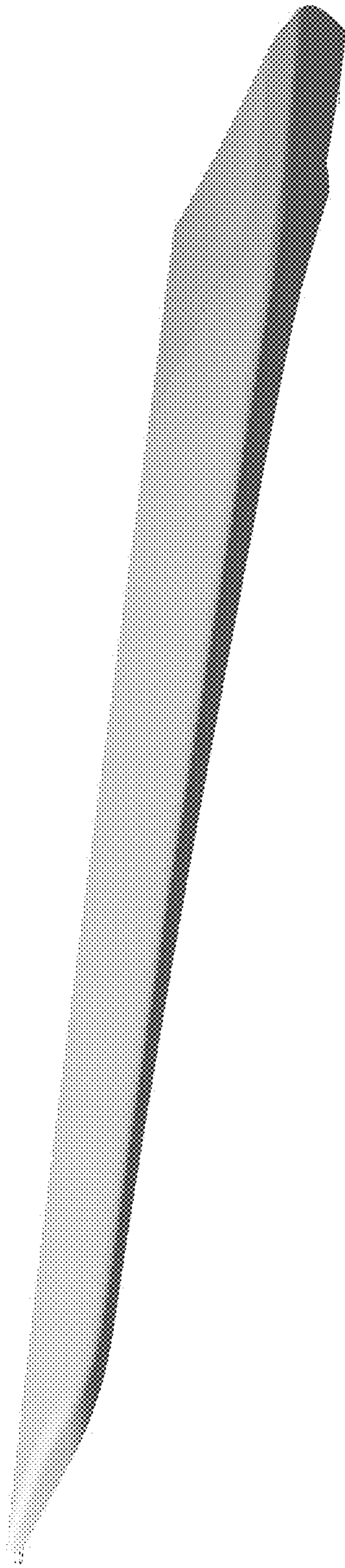

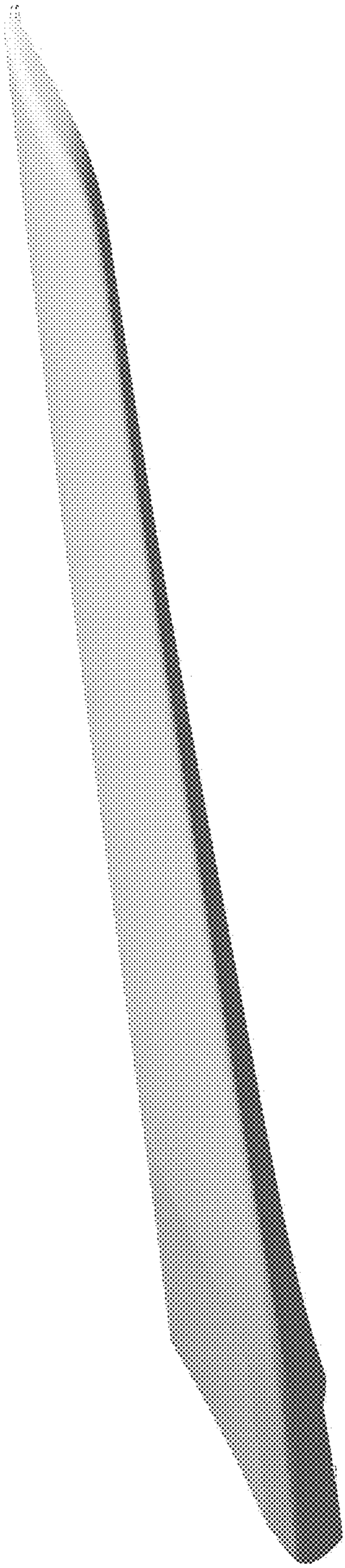

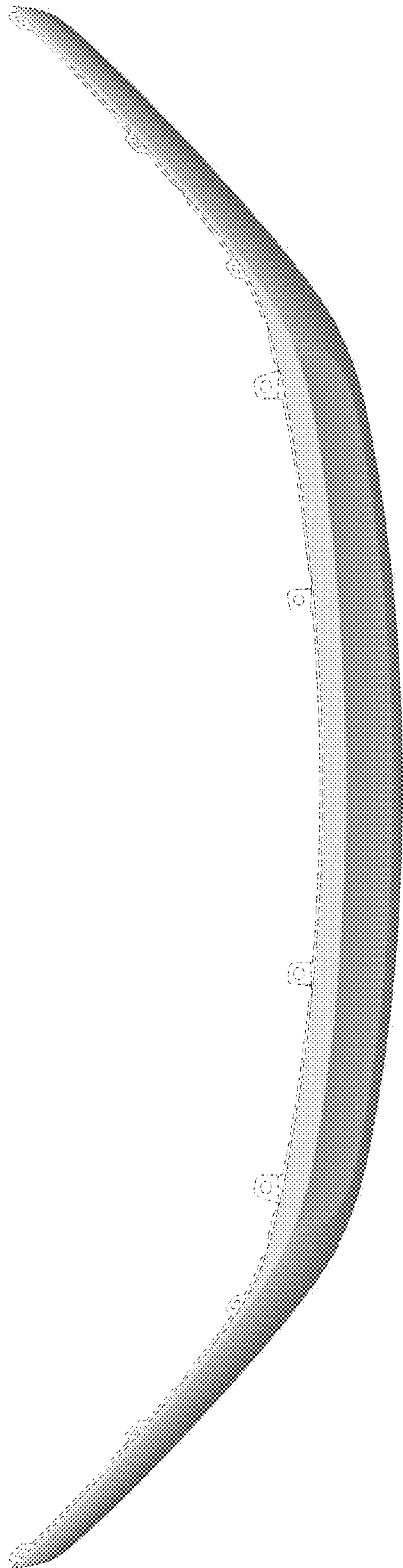

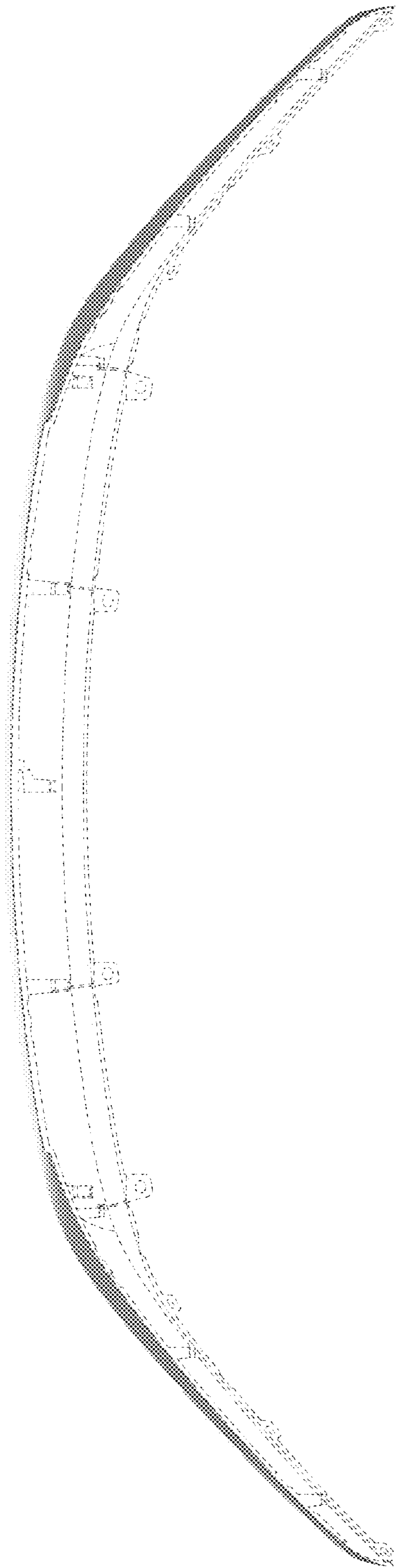
