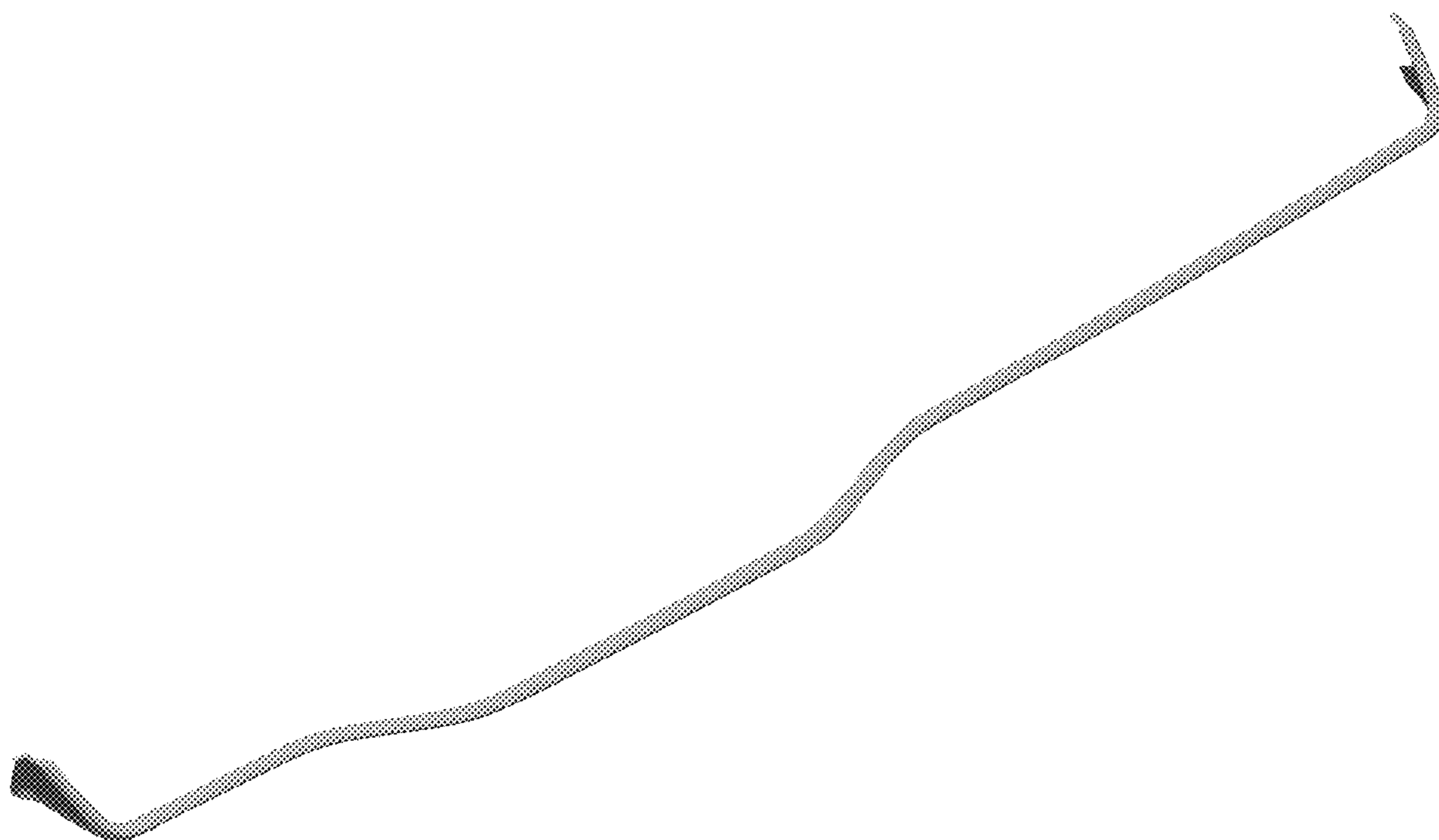
(57) **CLAIM**

The ornamental design for a vehicle vent finisher, as shown and described.

DESCRIPTION

FIG. 1 is a front left elevated perspective view of a vehicle vent finisher according to the present invention.
FIG. 2 is a front left perspective view of the vehicle vent finisher shown in FIG. 1.

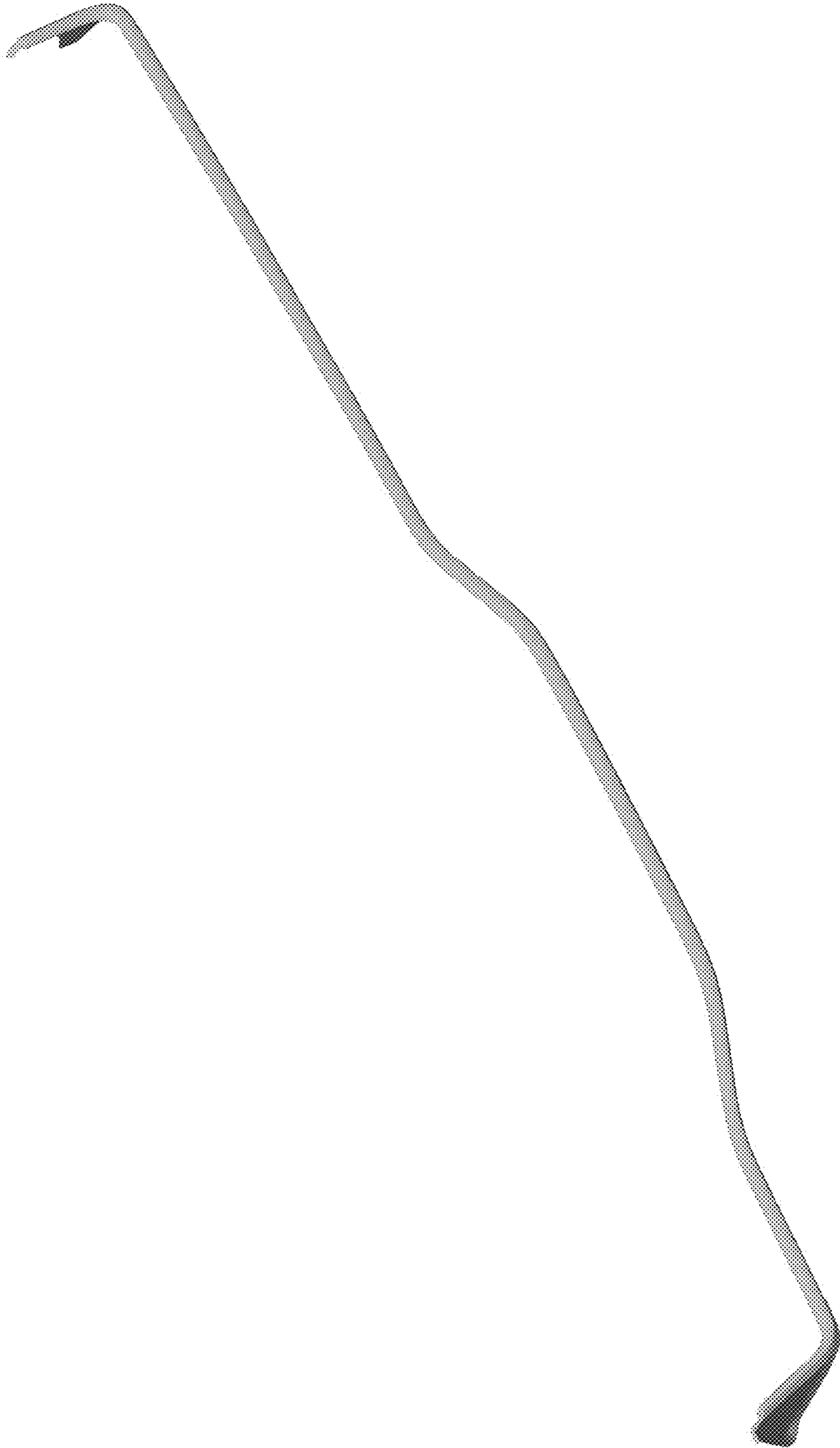

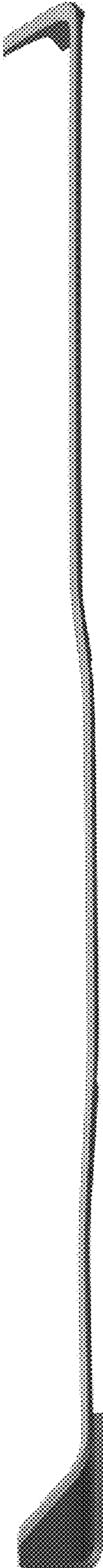

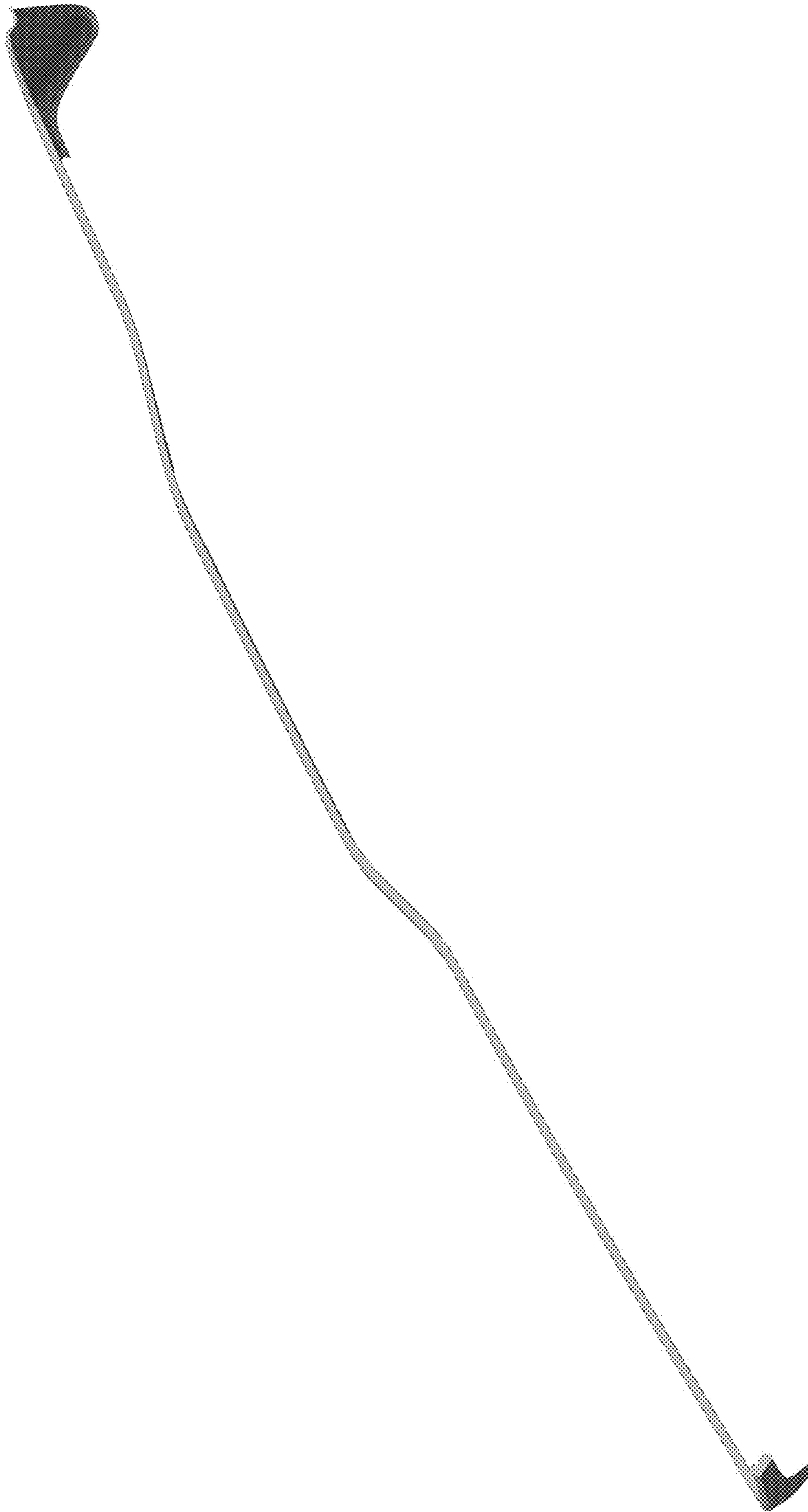

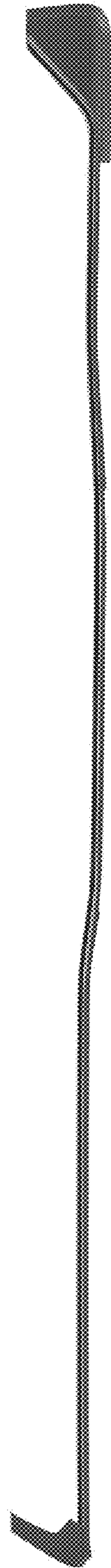

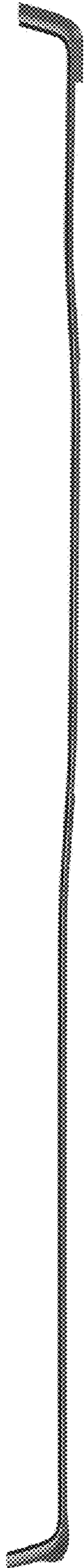

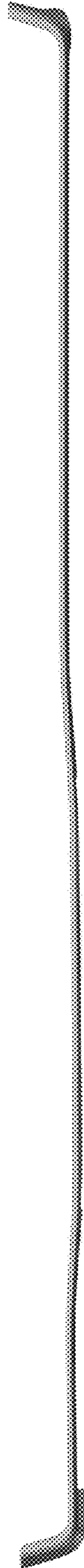

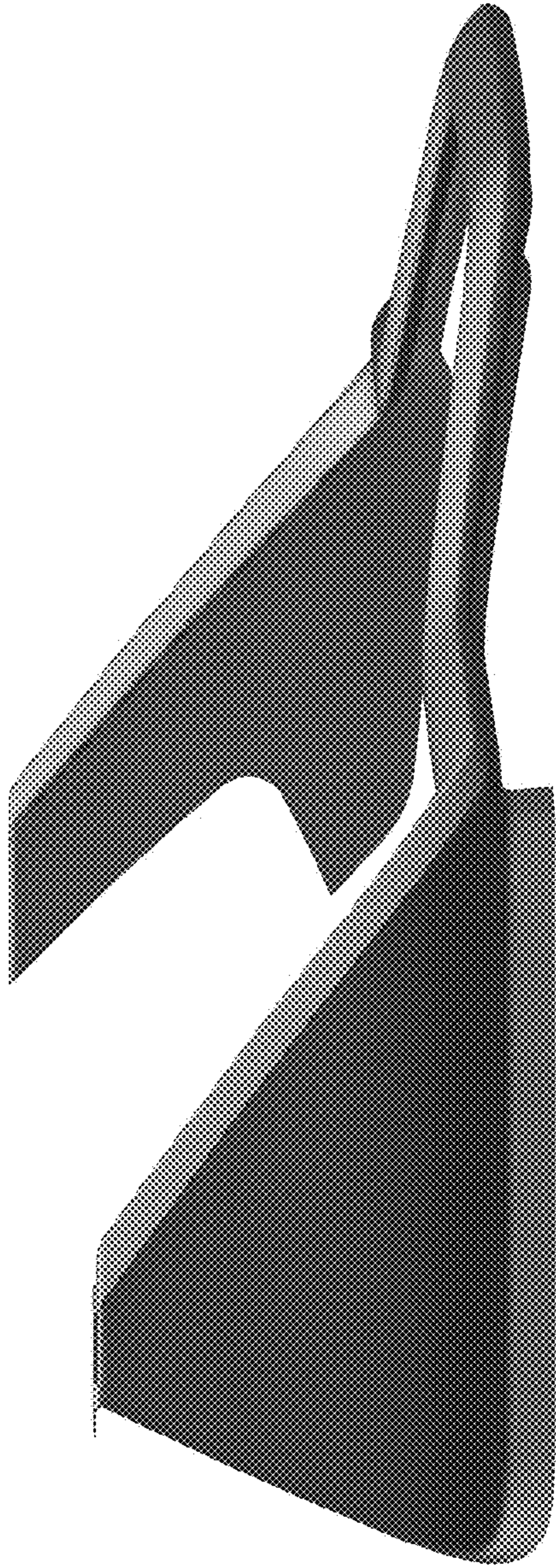

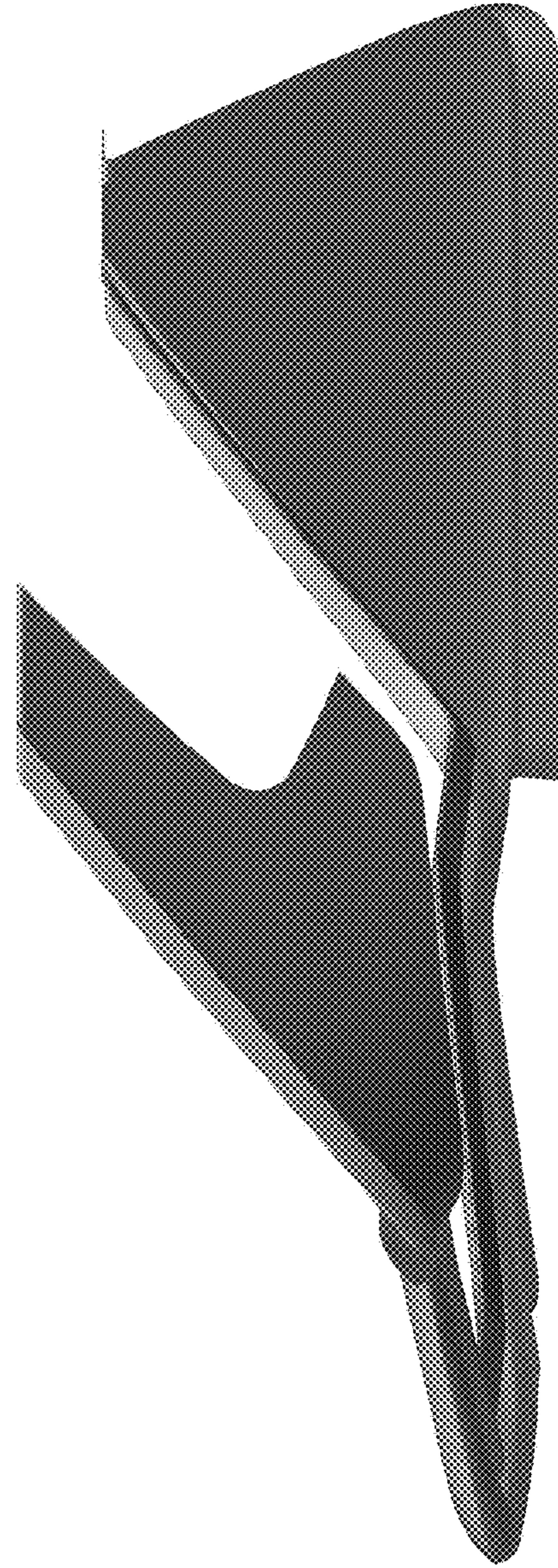

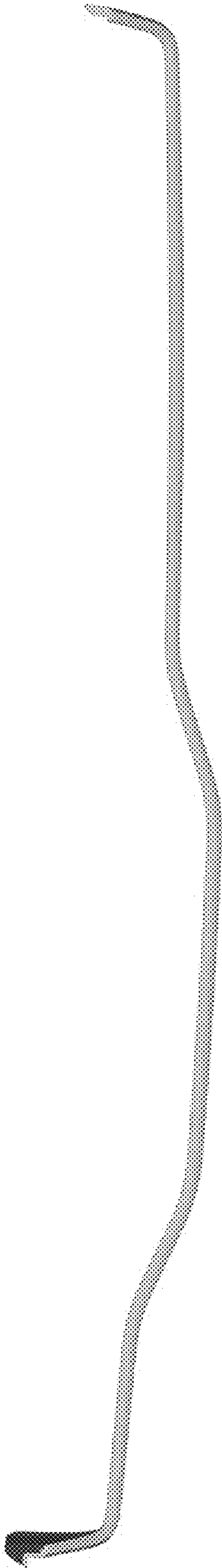

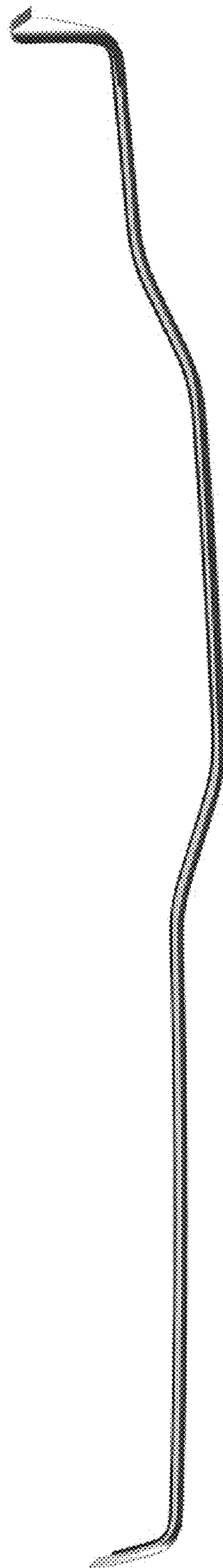
