(57) **CLAIM**

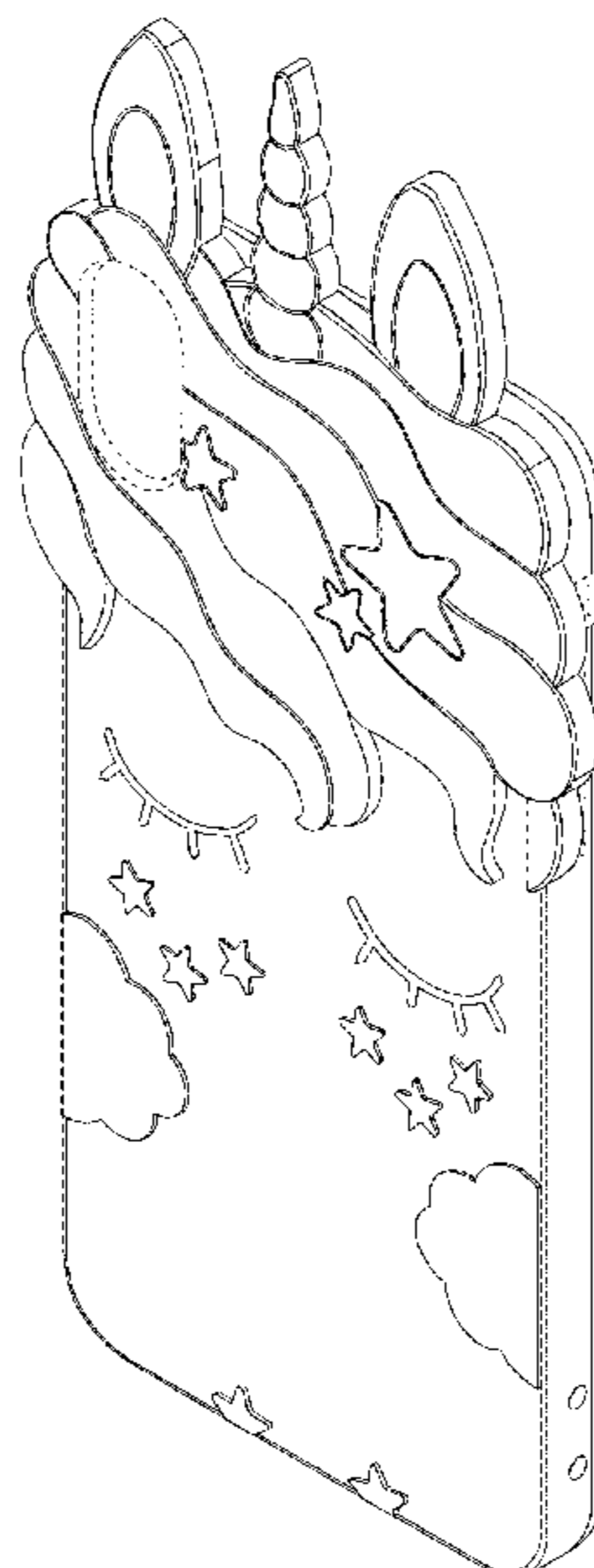
The ornamental design for a cell phone case, as shown and described.

**DESCRIPTION**

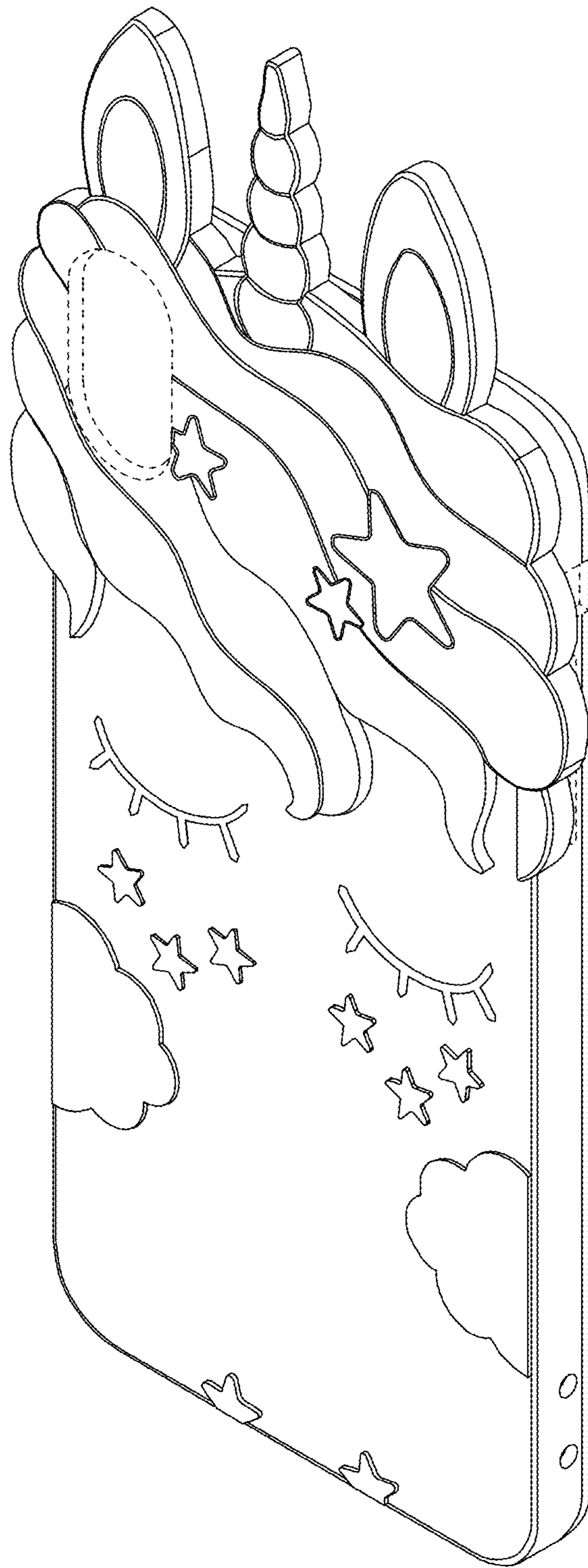

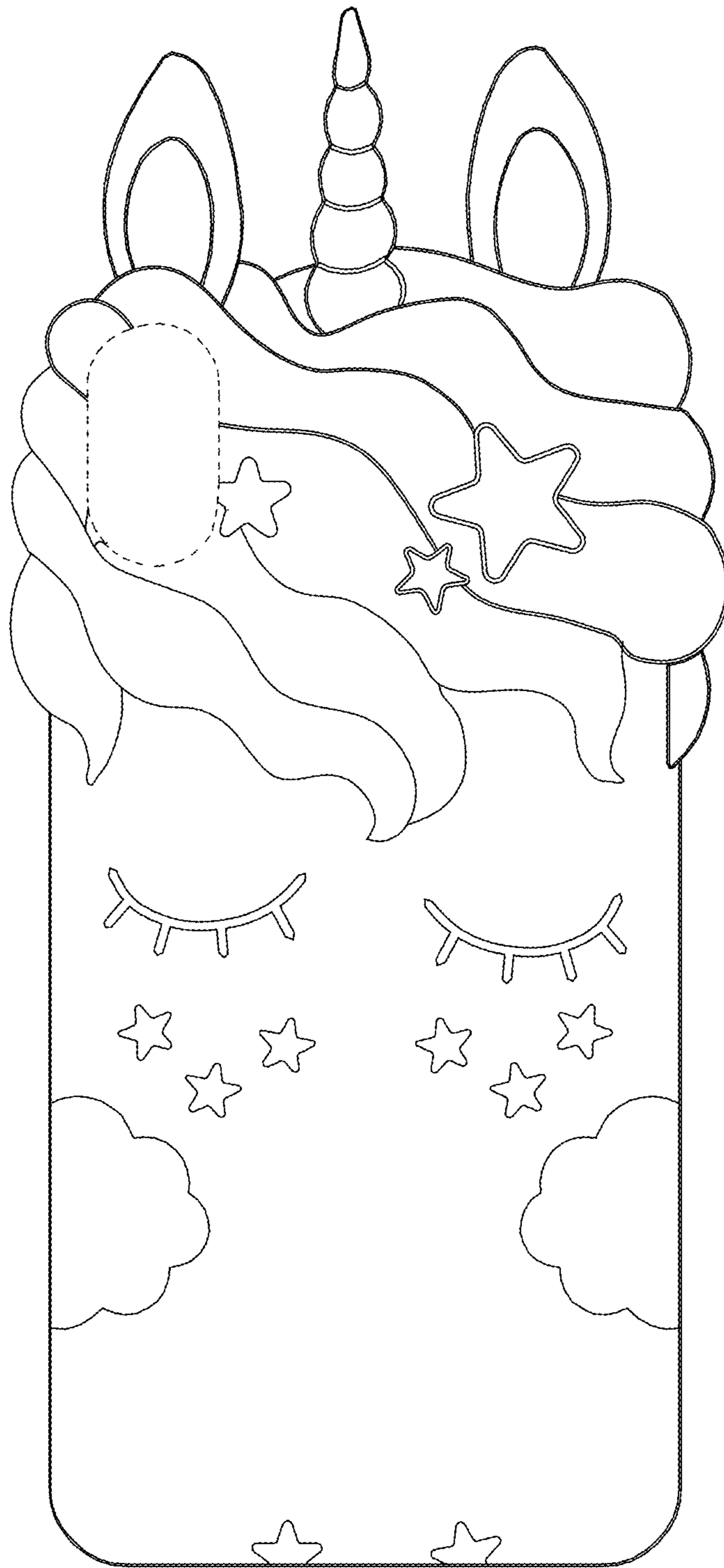

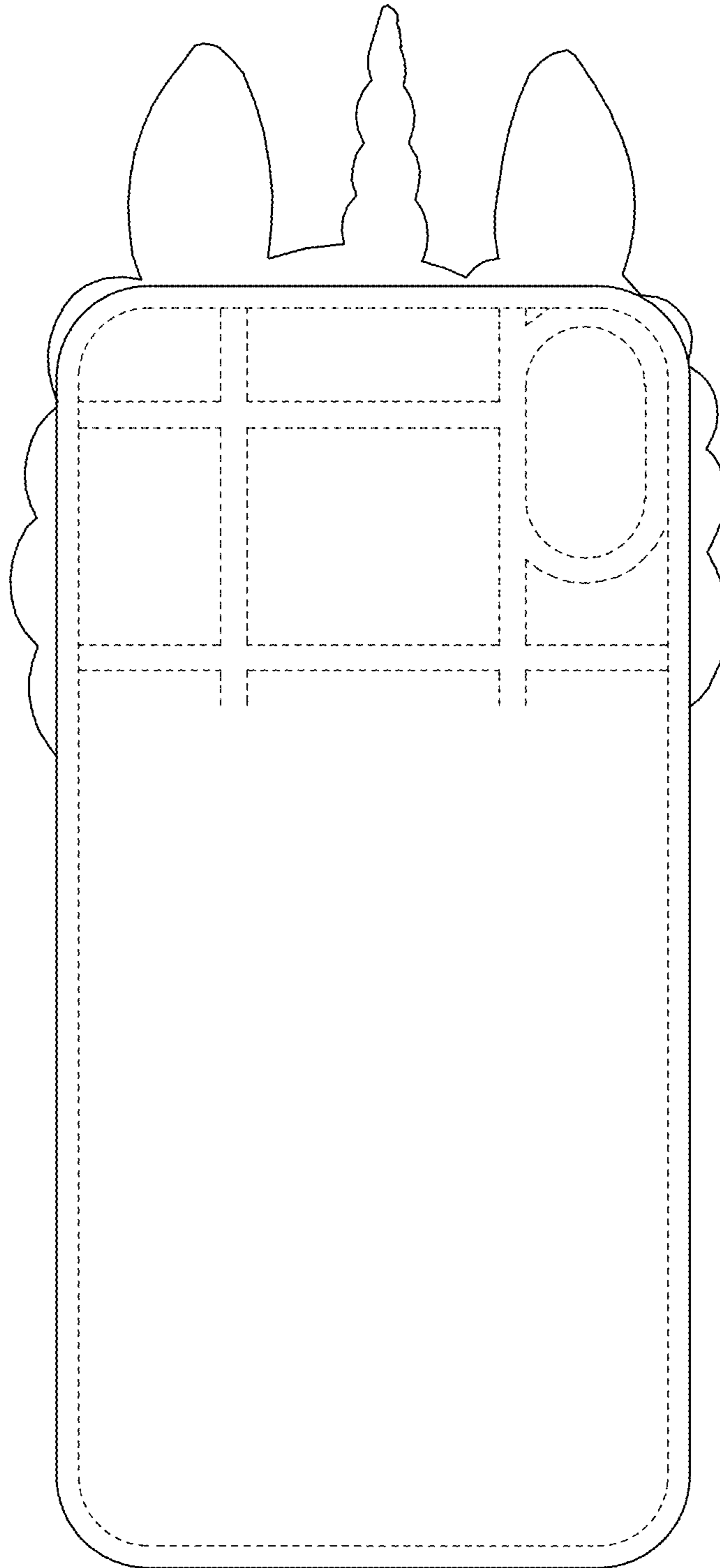

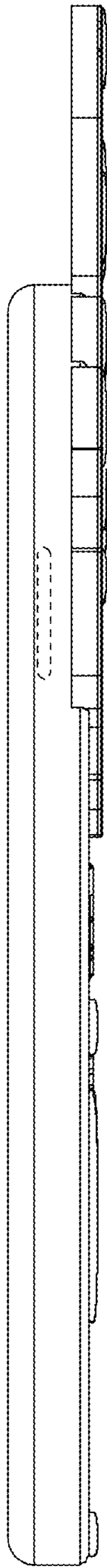

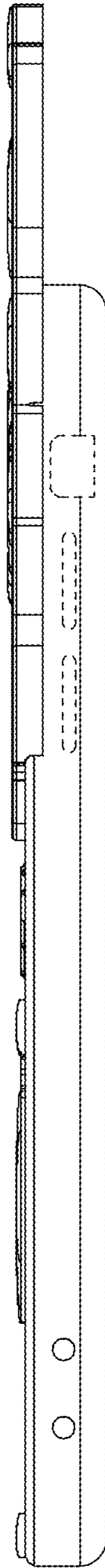

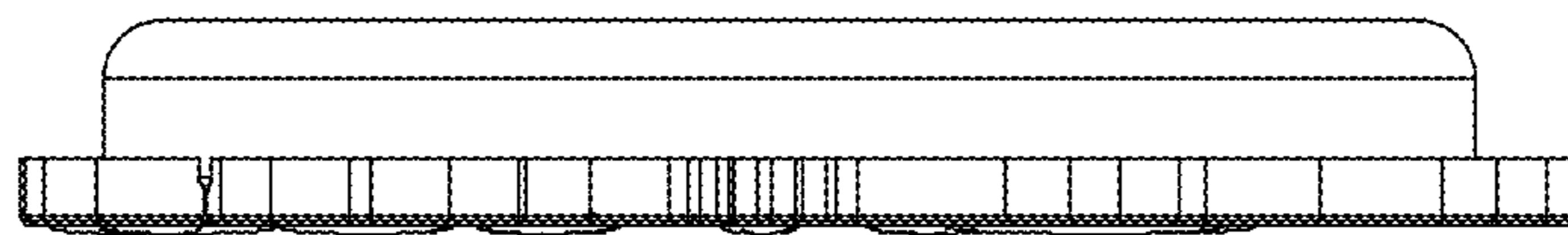

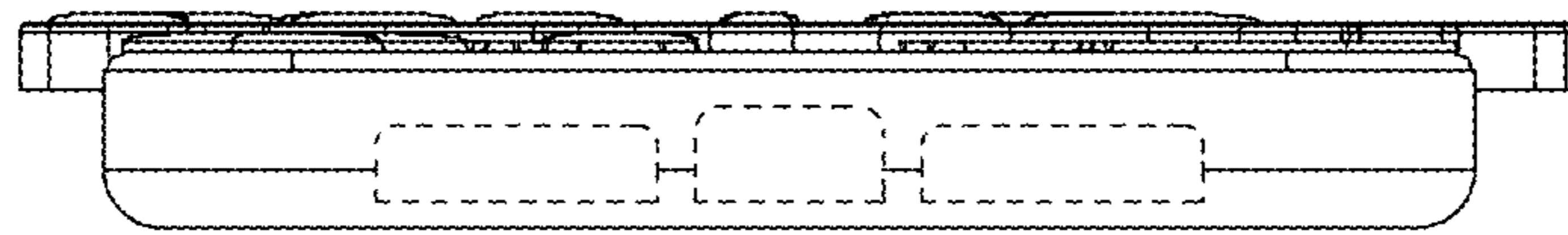
