(57) **CLAIM**

The ornamental design for a display panel with news headlines graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display panel with news headlines graphical user interface, according to a first embodiment.

FIG. 2 is a front view of a first image in a sequence of a display panel with news headlines graphical user interface, according to a second embodiment.

FIG. 3 is a front view of a second image in the sequence of a display panel with news headlines graphical user interface, according to the second embodiment.

FIG. 4 is a front view of a first image in a sequence of a display panel with news headlines graphical user interface, according to a third embodiment.

FIG. 5 is a front view of a second image in the sequence of a display panel with news headlines graphical user interface, according to the third embodiment.

FIG. 6 is a front view of a display panel with news headlines graphical user interface, according to a fourth embodiment.

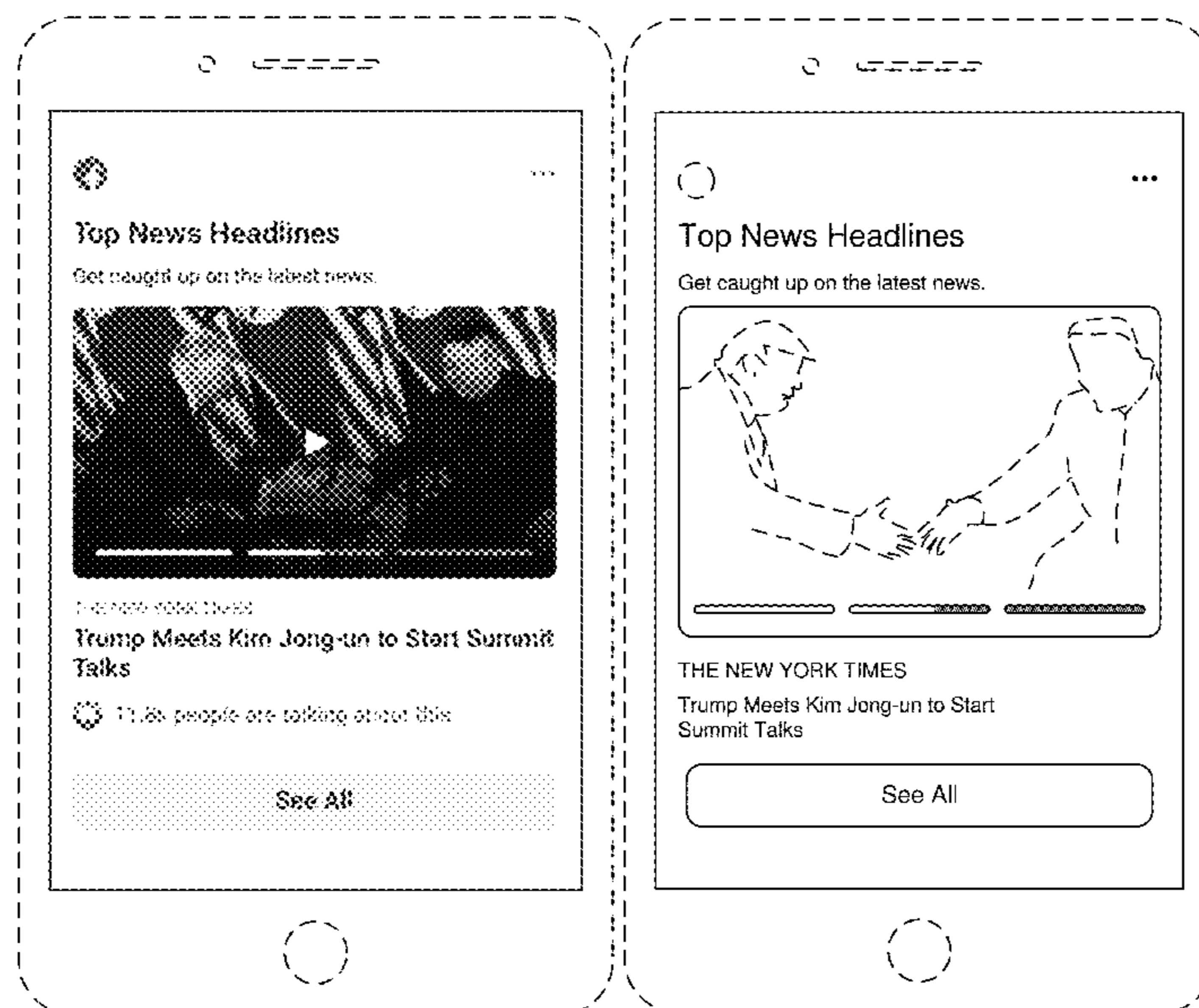
FIG. 7 is a front view of a display panel with news headlines graphical user interface, according to a fifth embodiment.

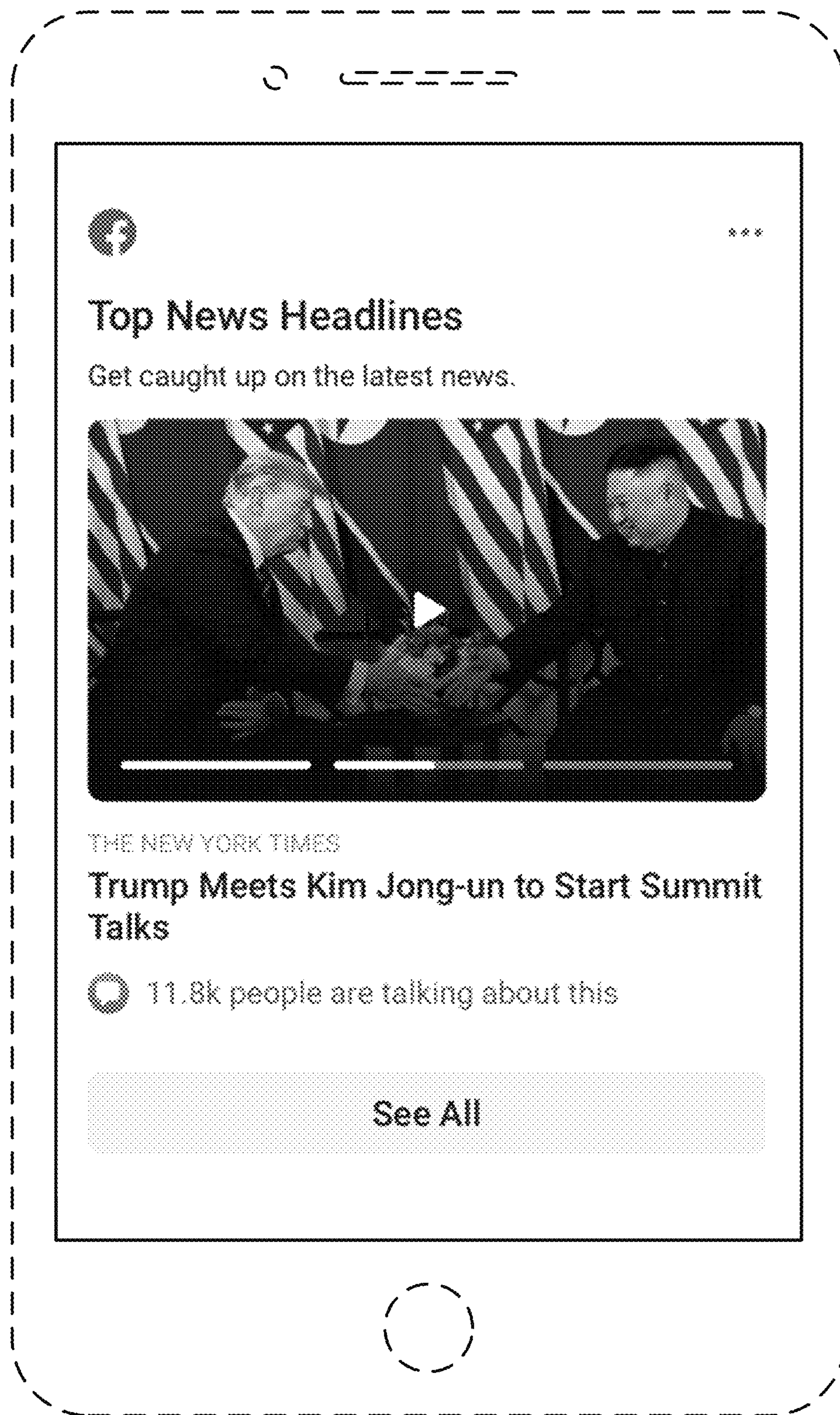

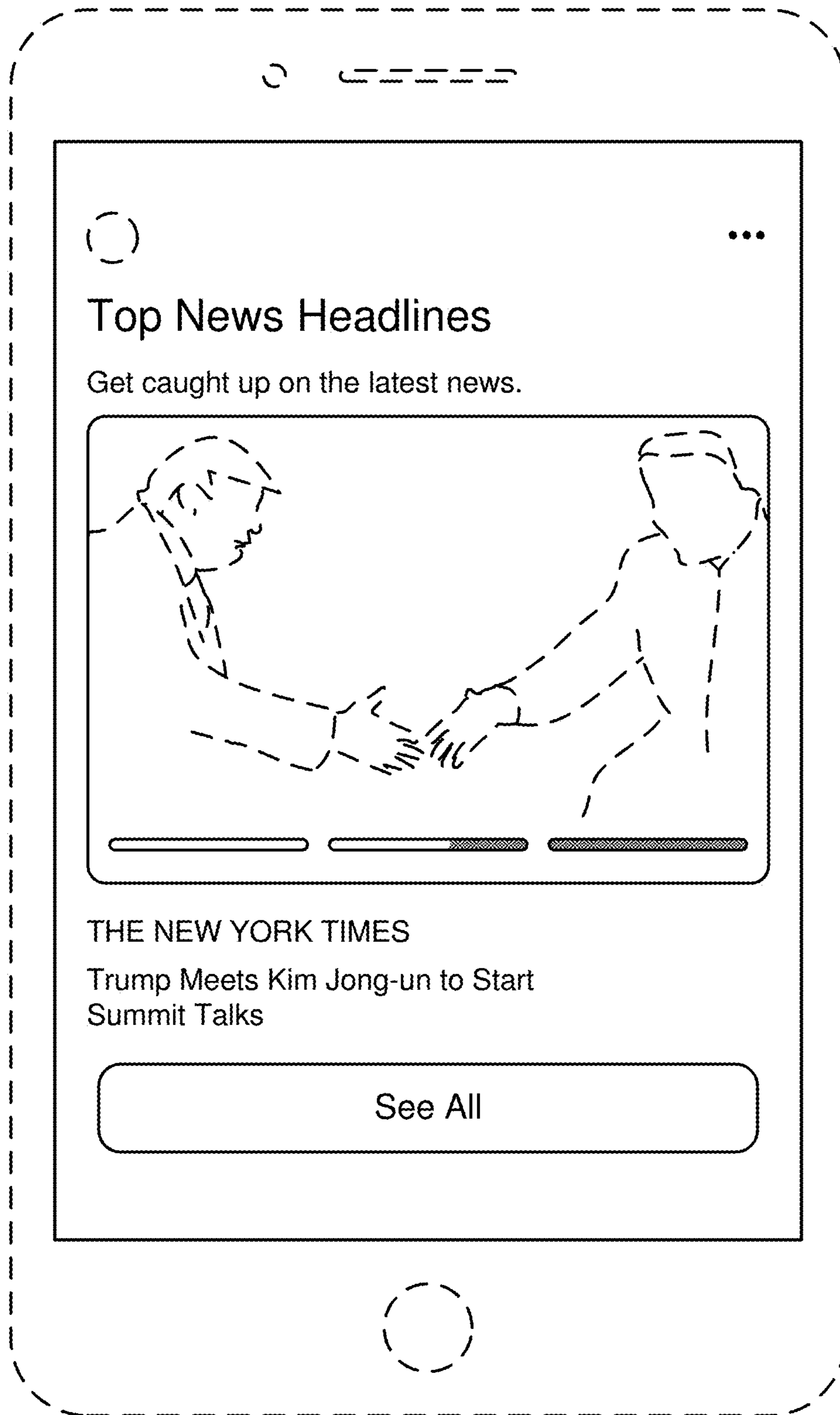

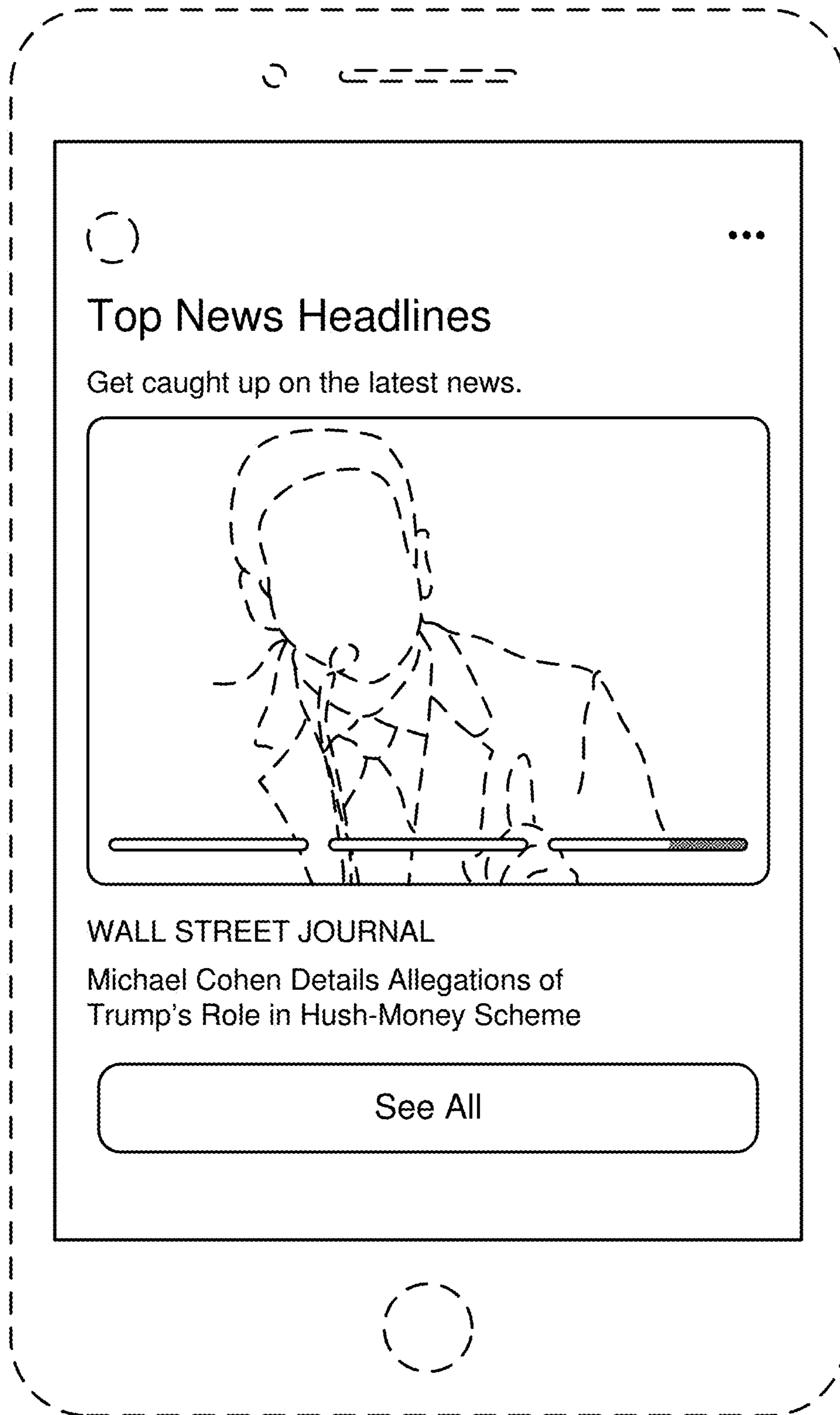

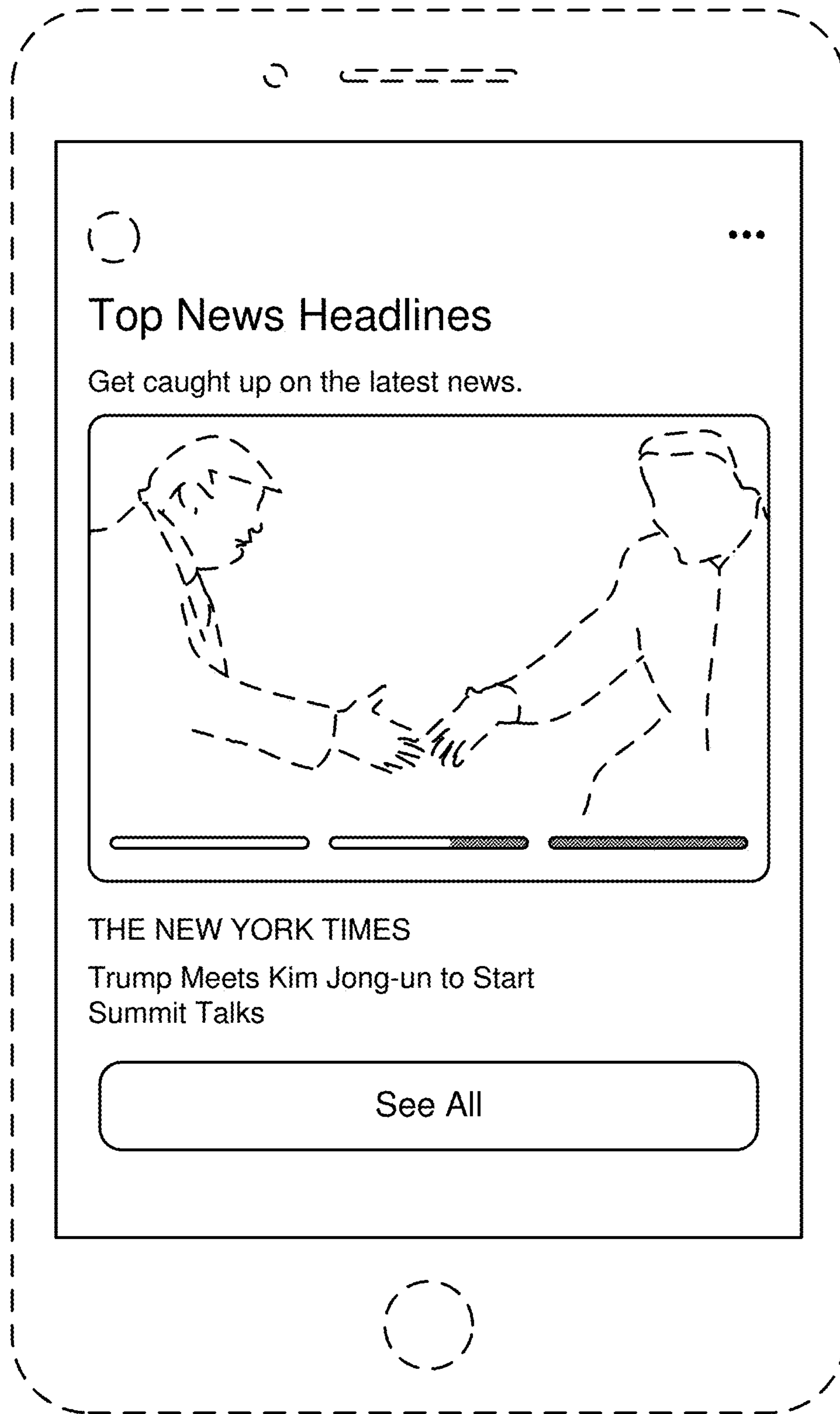

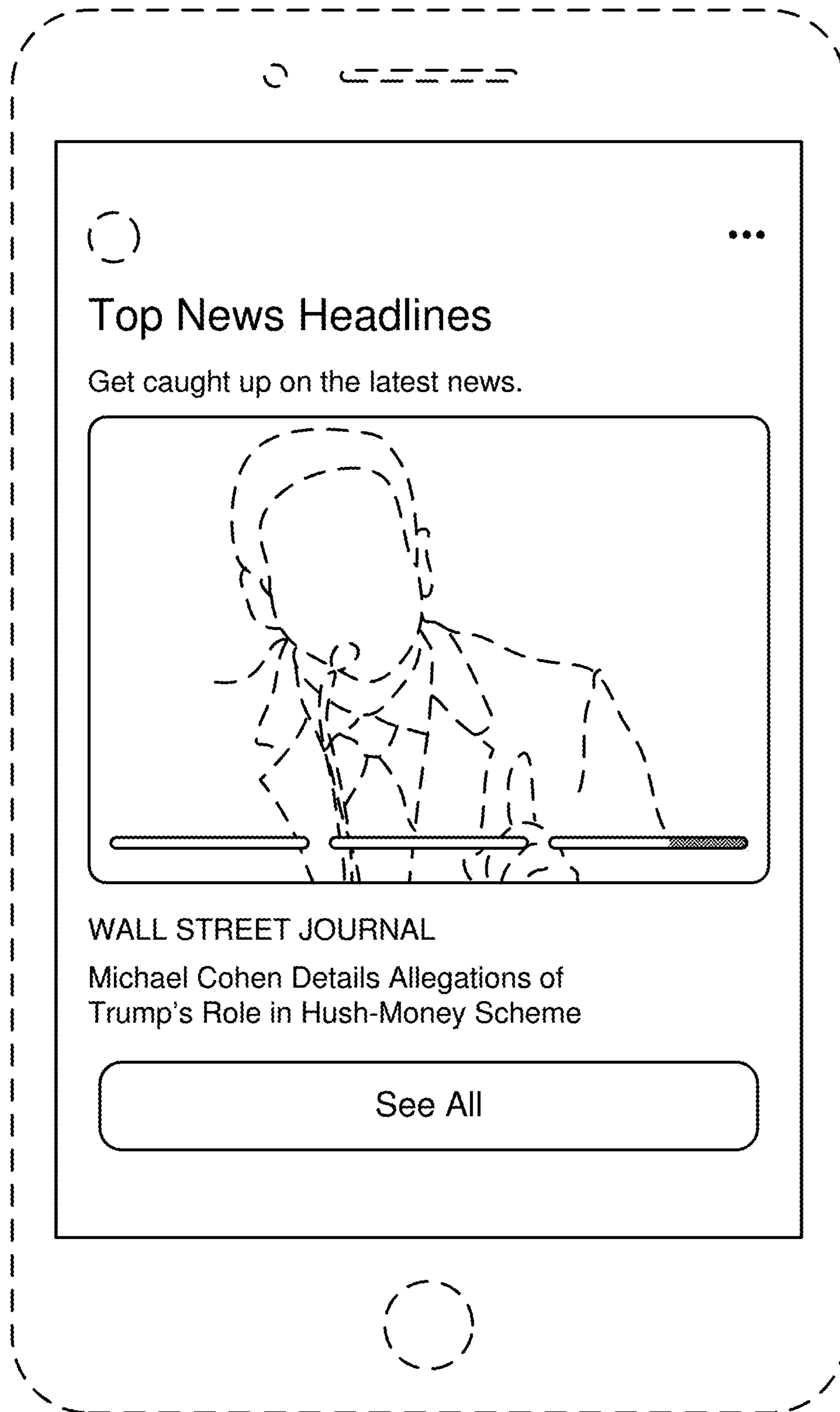

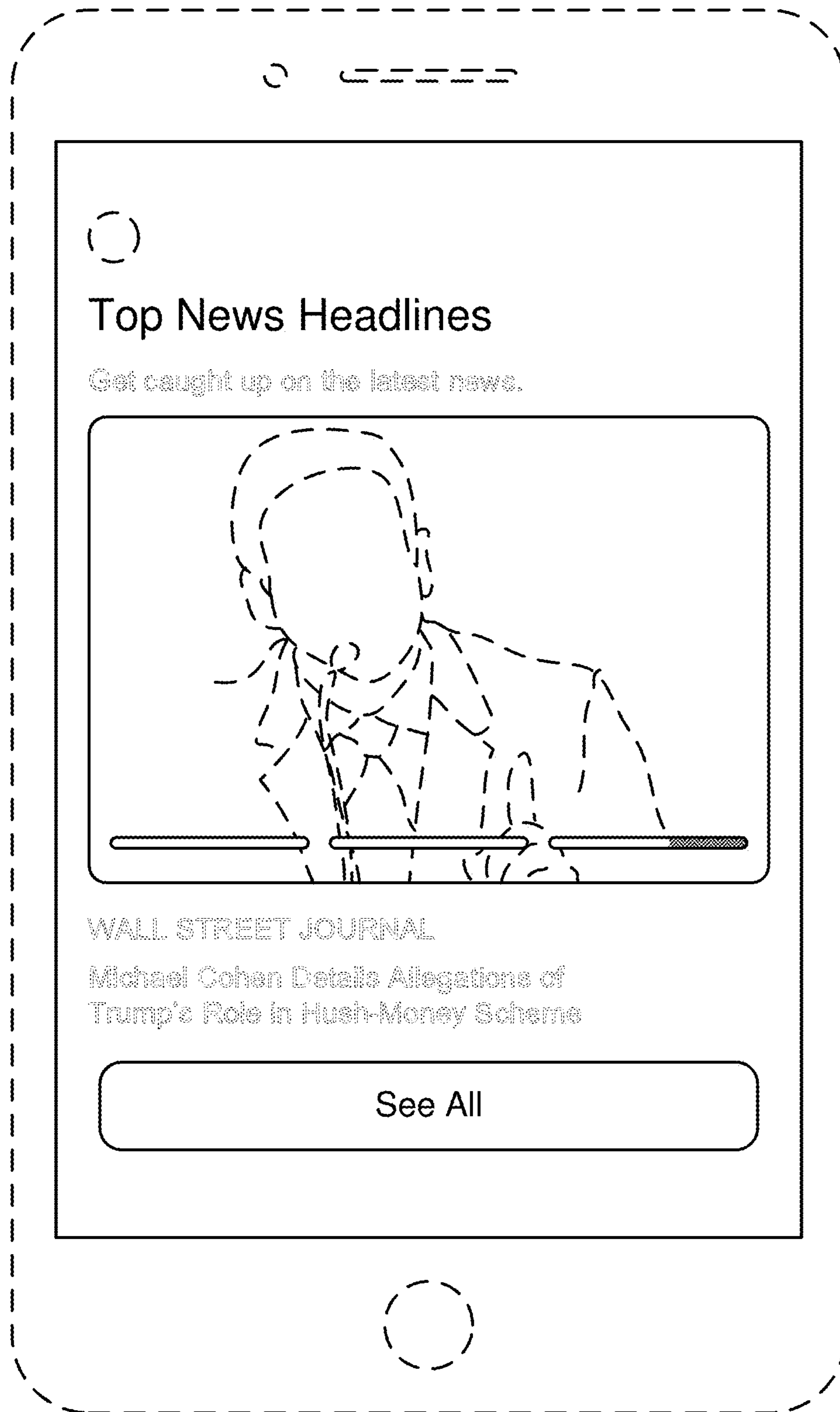
