1.3 : Bottom

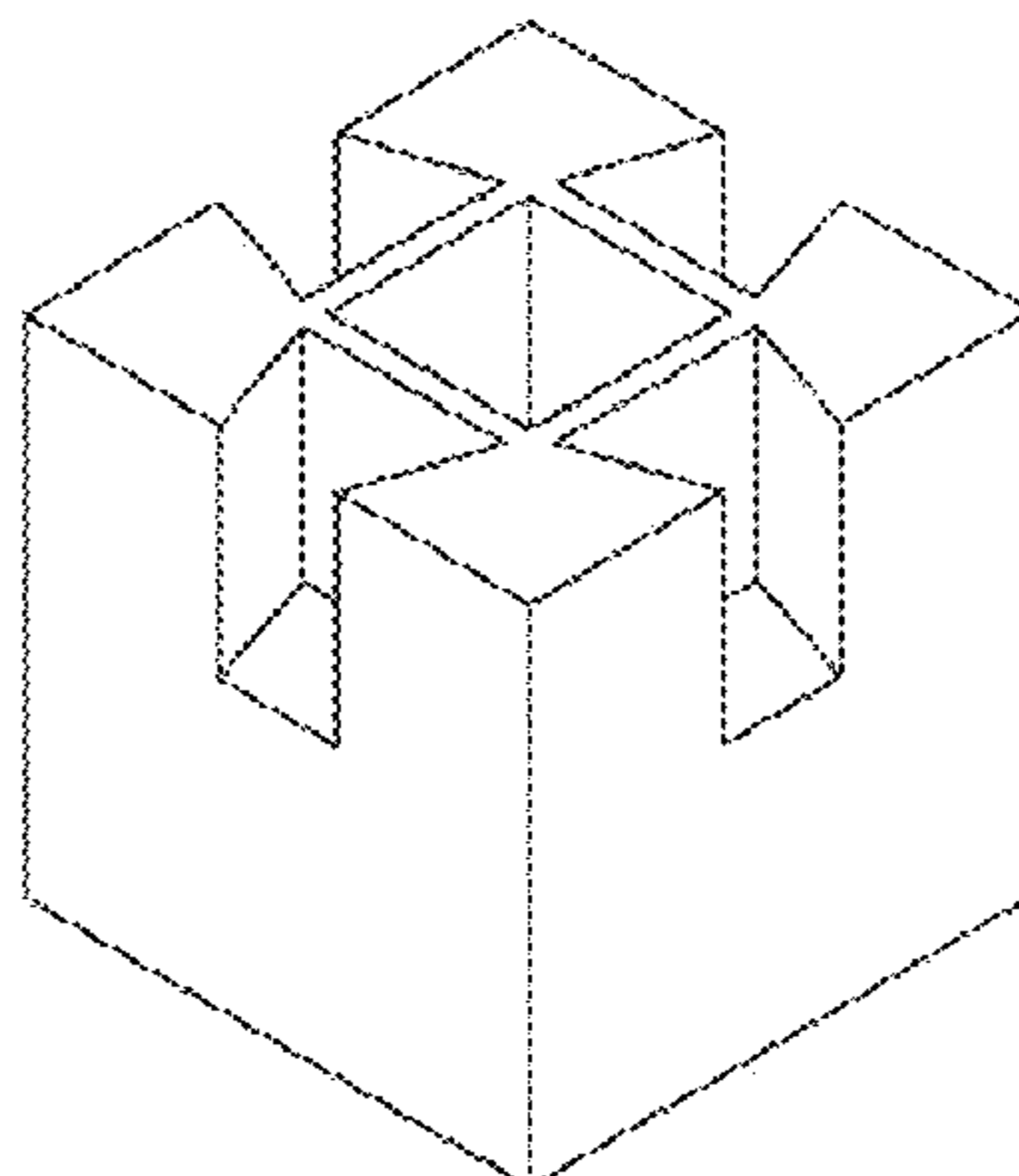
1.4 : Cross-sectional

1.5 : Perspective

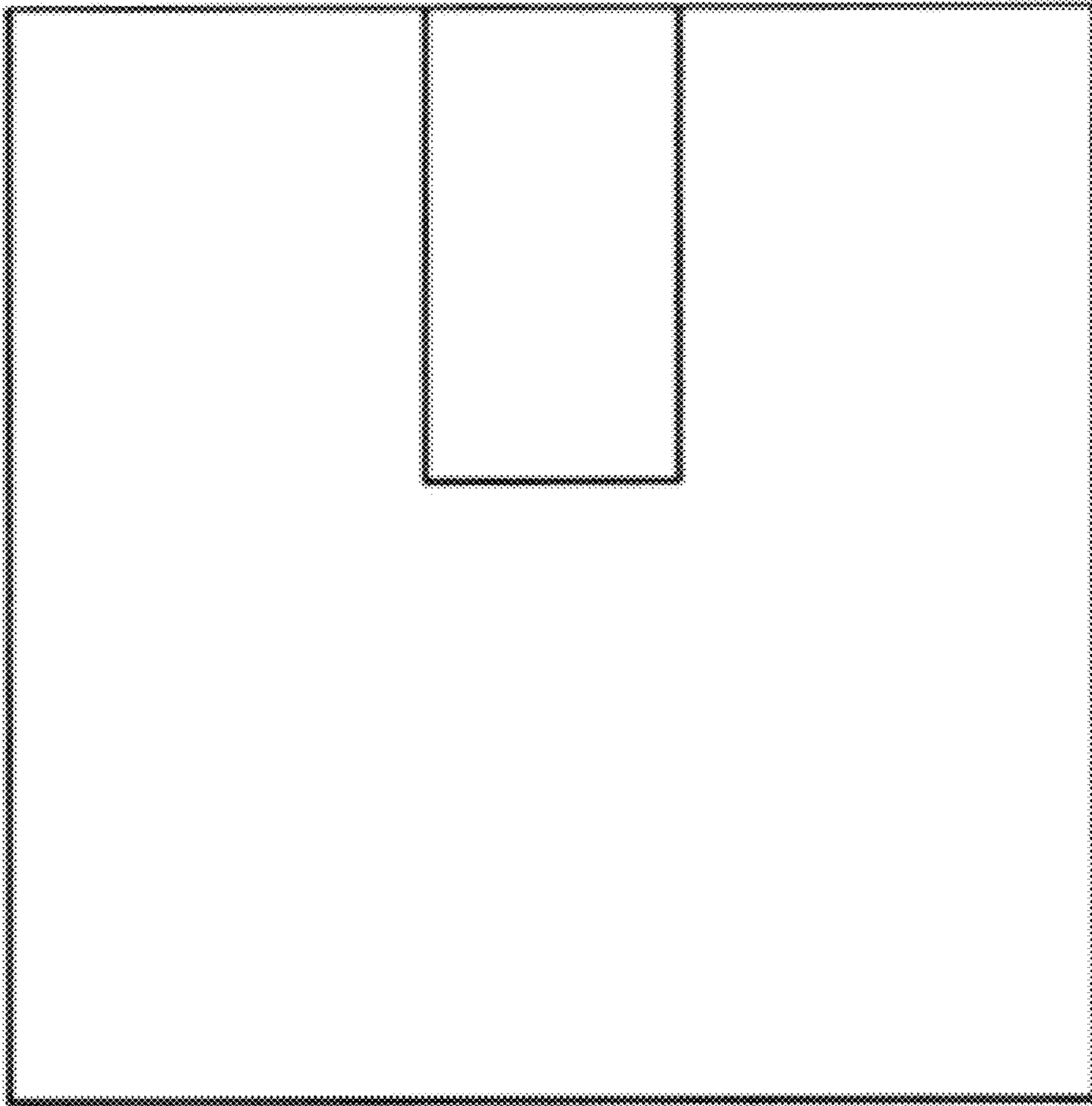
The rear view, right-side view and left-side view are omitted because they are identical to the front view.

The interior surfaces, and the solid hatching lines used to indicate these surfaces, as shown in the cross section view of FIG. 1.4 form no part of the claimed design. This view is understood to be taken along a line either horizontal or vertical through the center of the article as shown in FIG. 1.2.

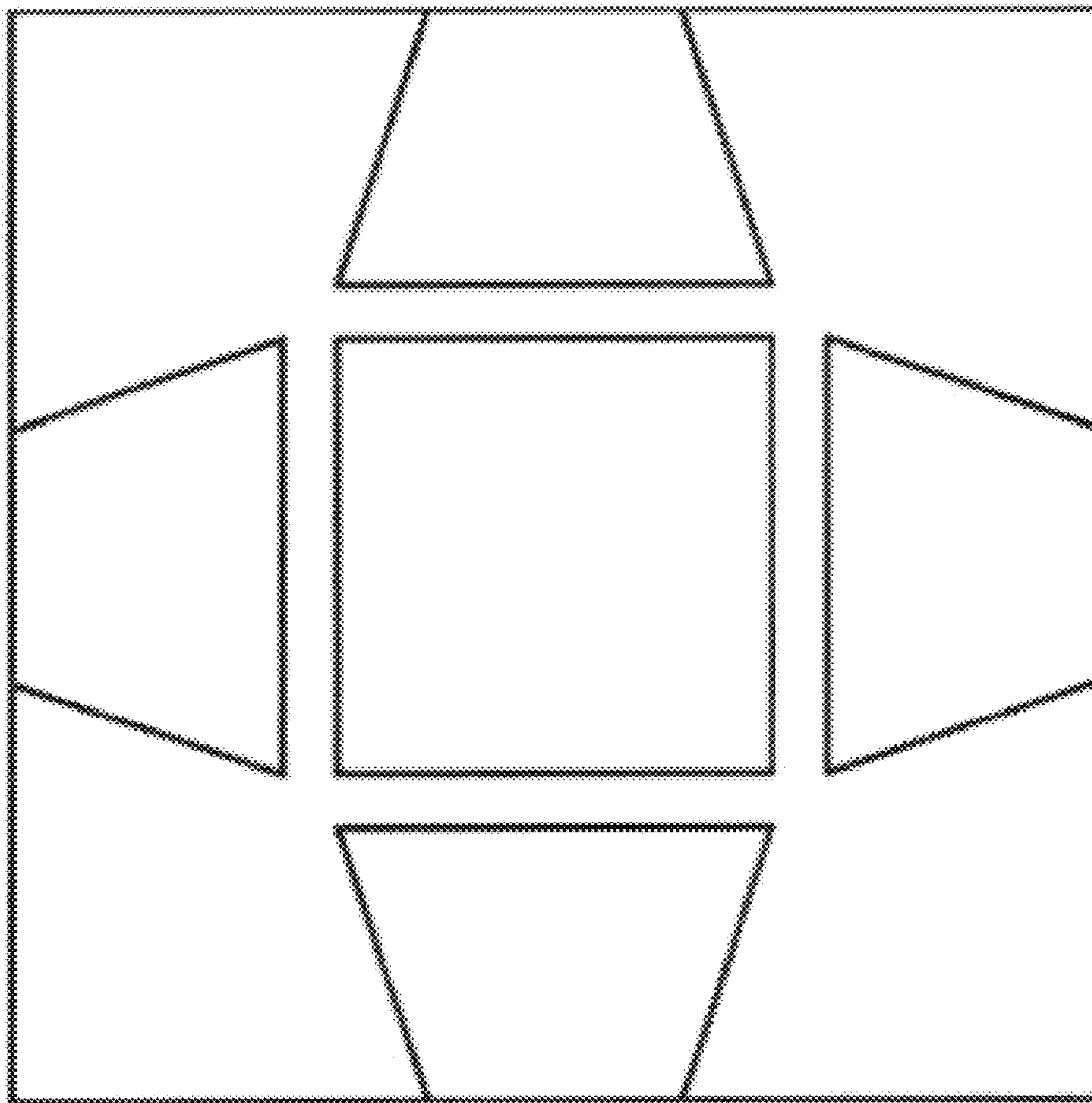

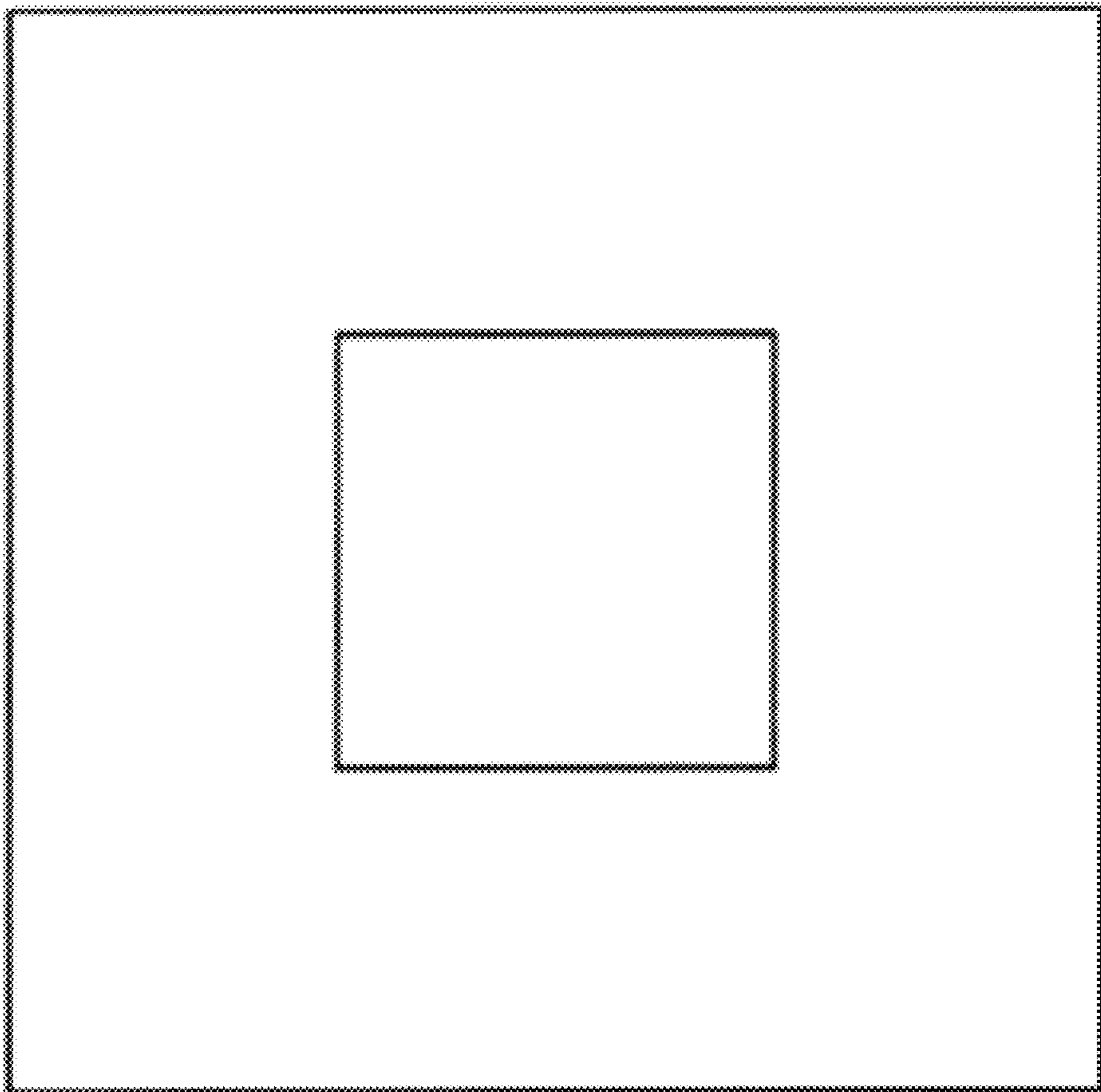

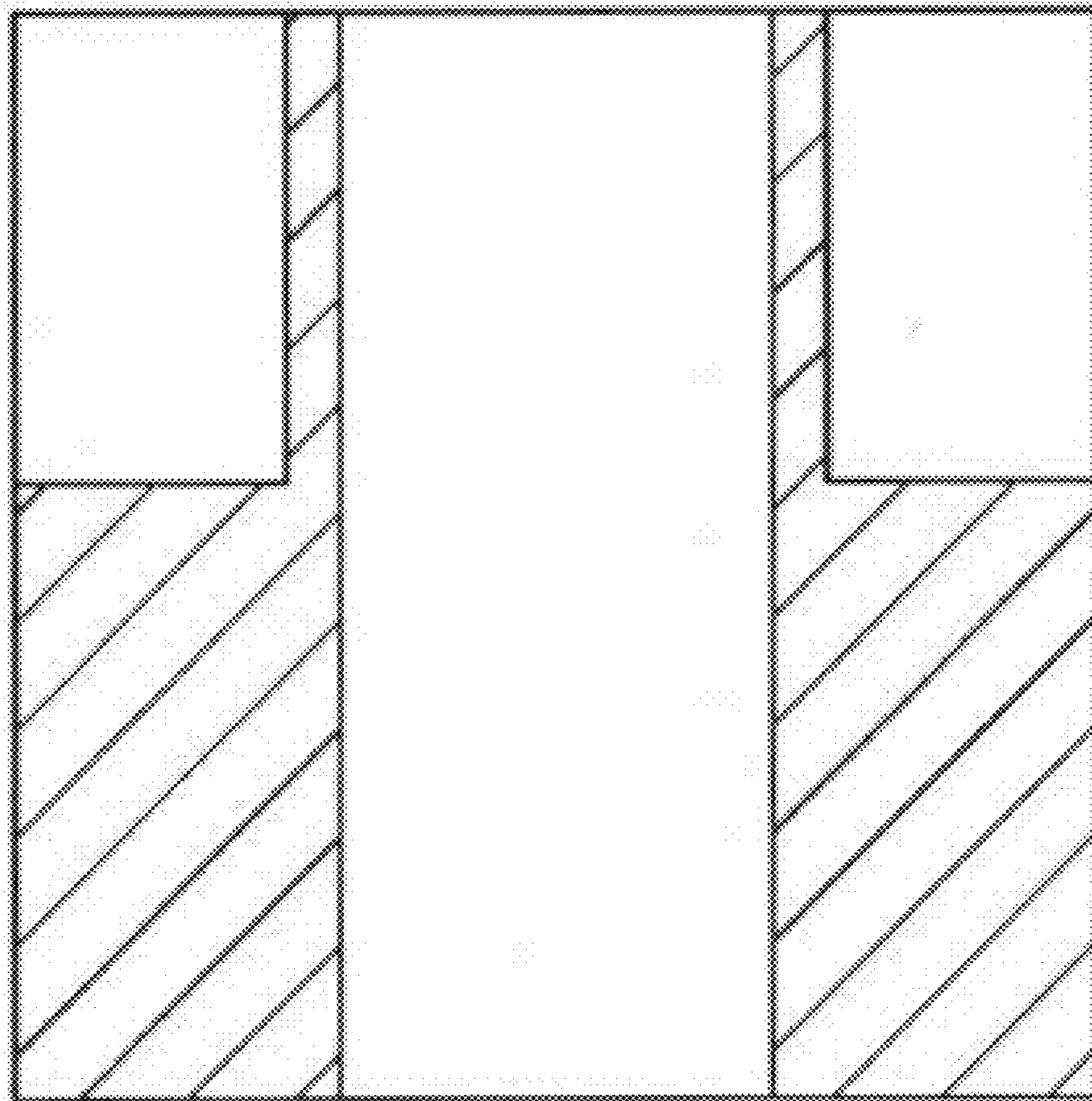
