The ornamental design for a pellet stove hopper, as shown and described.

**DESCRIPTION**

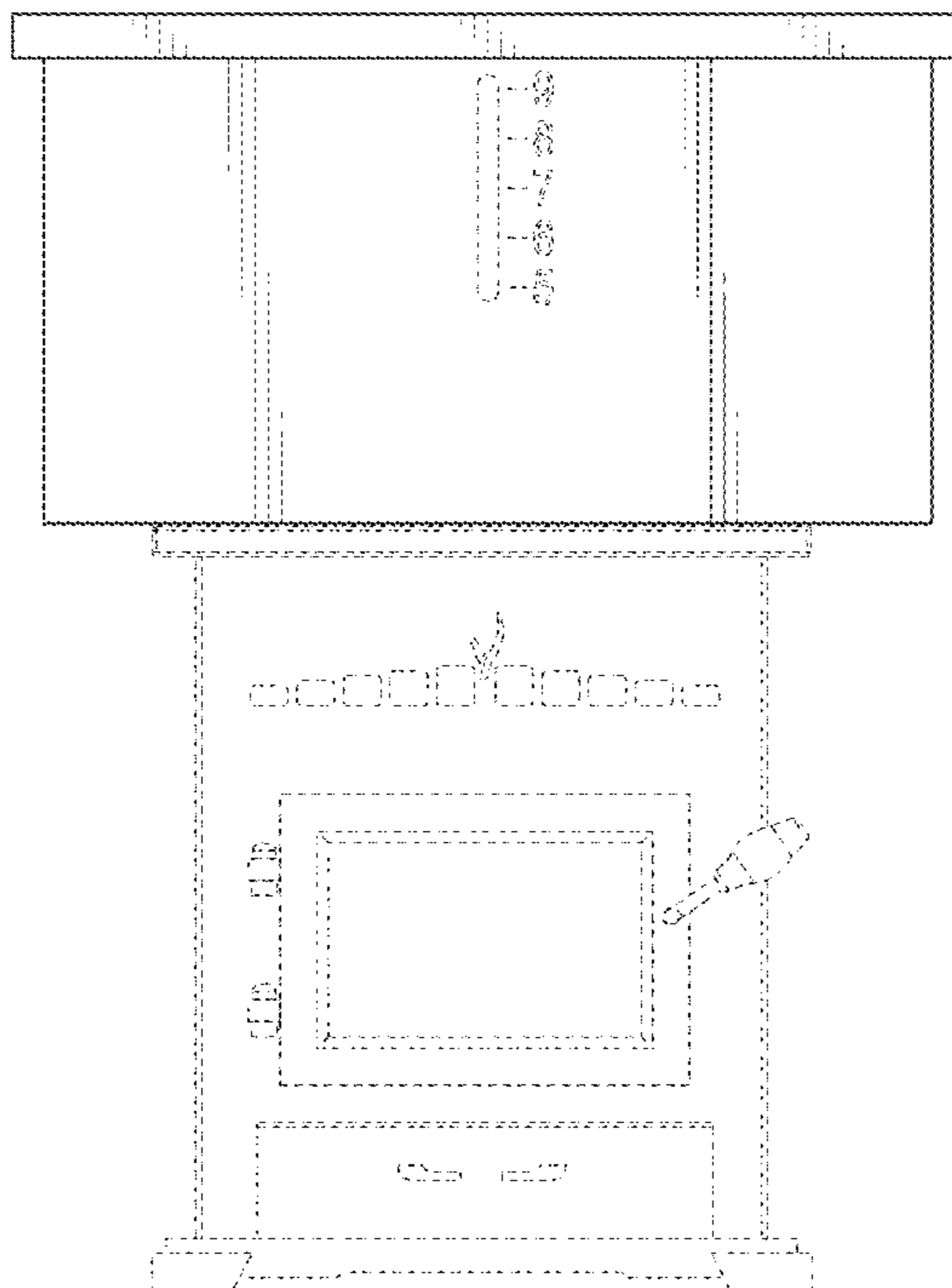
FIG. 1 is a front elevation view of the pellet stove hopper showing my new design;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a front elevation view of the hopper removed from the stove base for ease of illustration;  
FIG. 7 is a rear elevation view of the hopper thereof;  
FIG. 8 is a right side elevation view of the hopper thereof;  
FIG. 9 is a left side elevation view thereof;  
FIG. 10 is a top plan view of the hopper thereof;  
FIG. 11 is a bottom elevation view of the hopper thereof;  
FIG. 12 is a cross-sectional view of the hopper taken along lines 12-12 of FIG. 6 and lines 12'-12' of FIG. 10 thereof;  
FIG. 13 is a cross-sectional view of the hopper taken along line 13-13 of FIG. 8 and lines 13'-13' of FIG. 10 thereof; and,  
FIG. 14 is a cross-sectional view of the hopper taken along lines 14-14 of FIG. 6 and lines 14'-14' of FIG. 10 thereof.

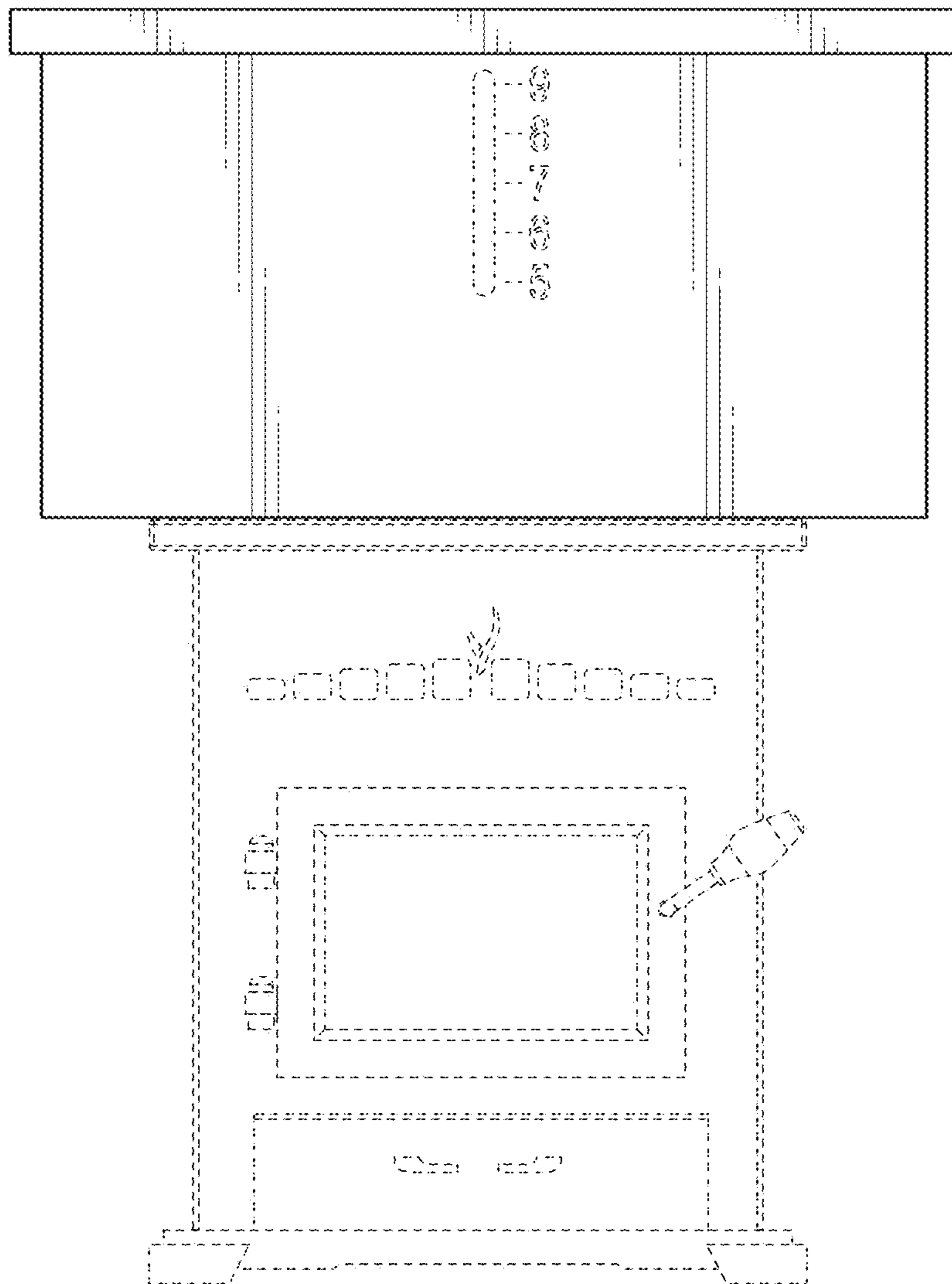

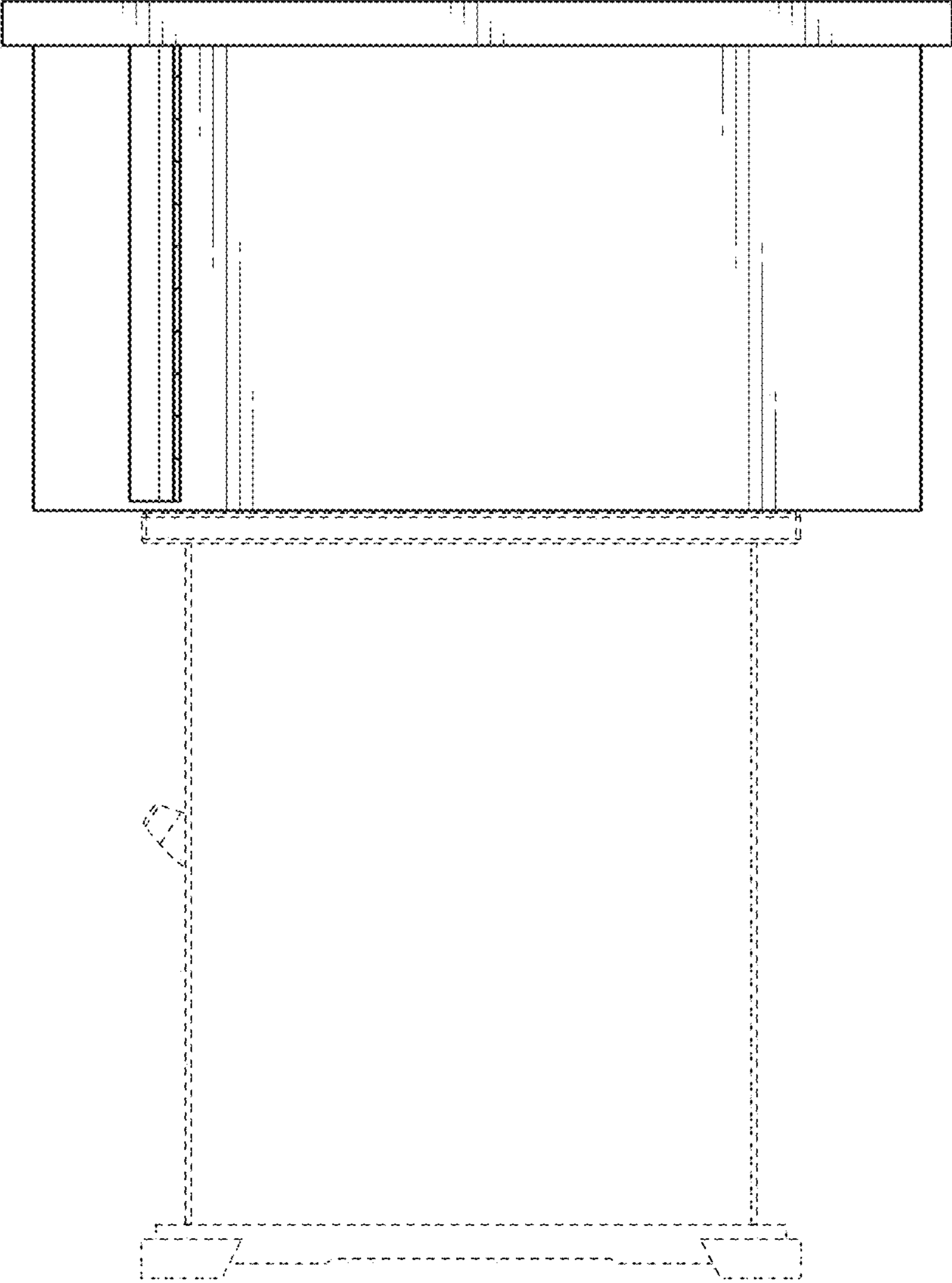

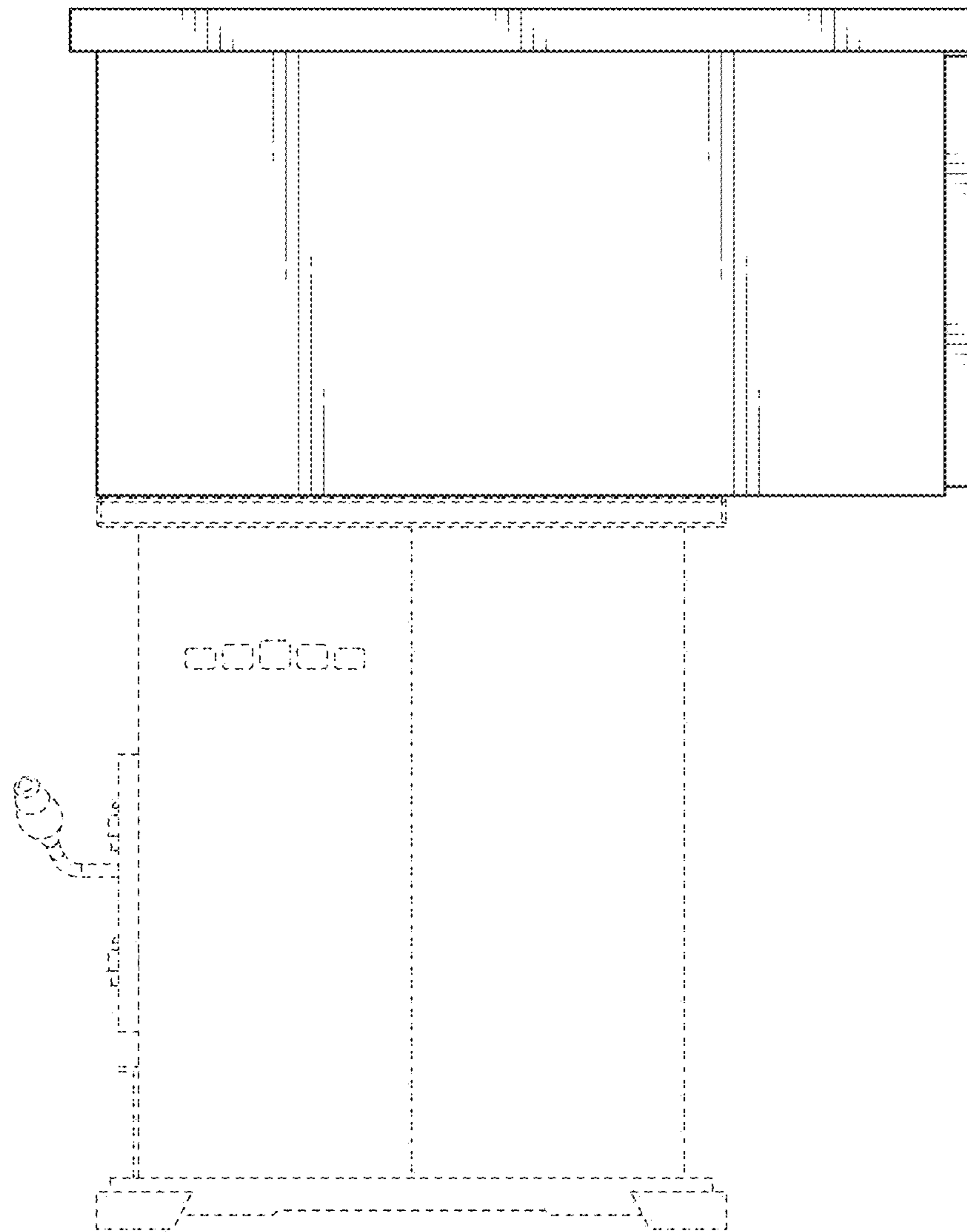

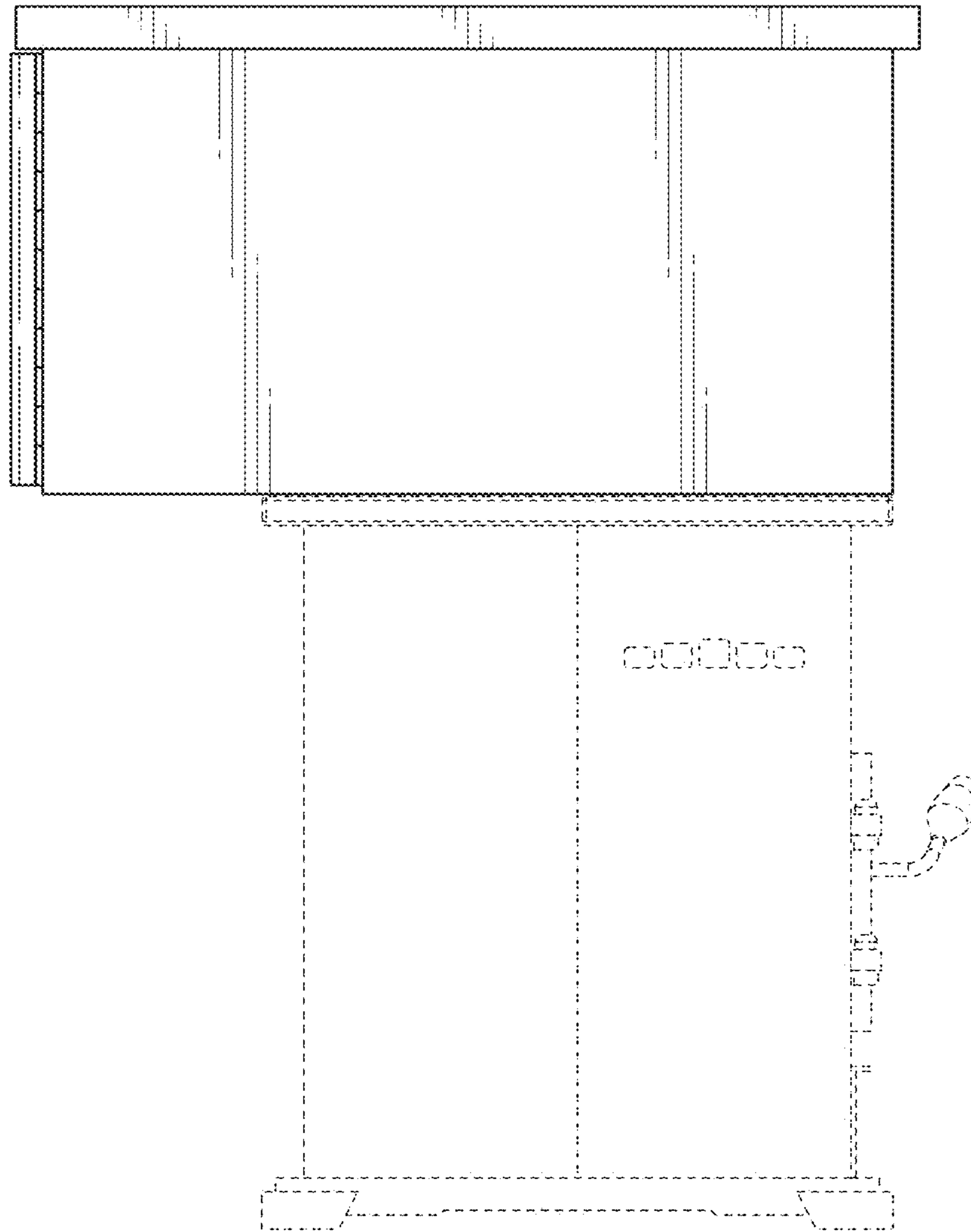

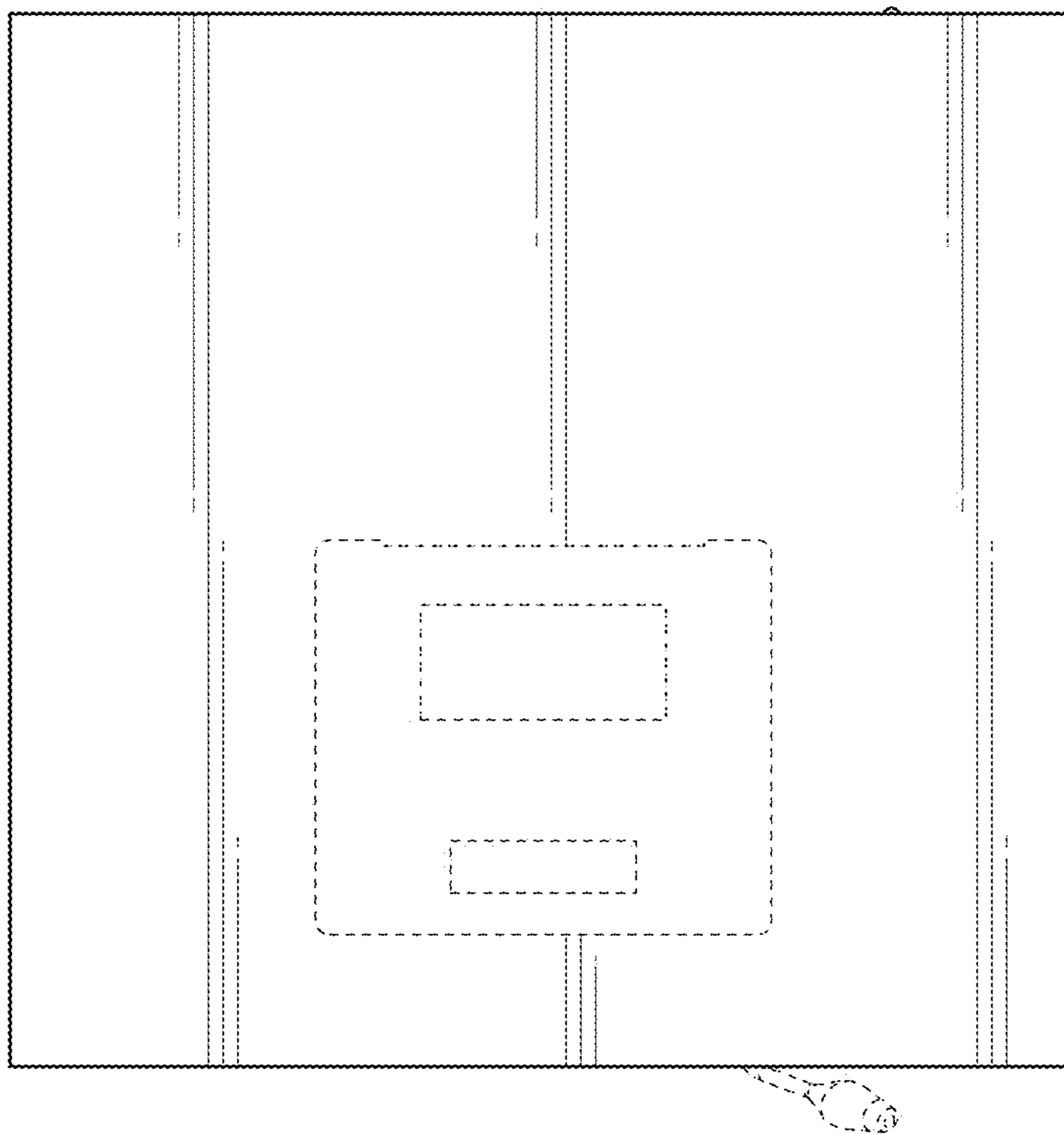

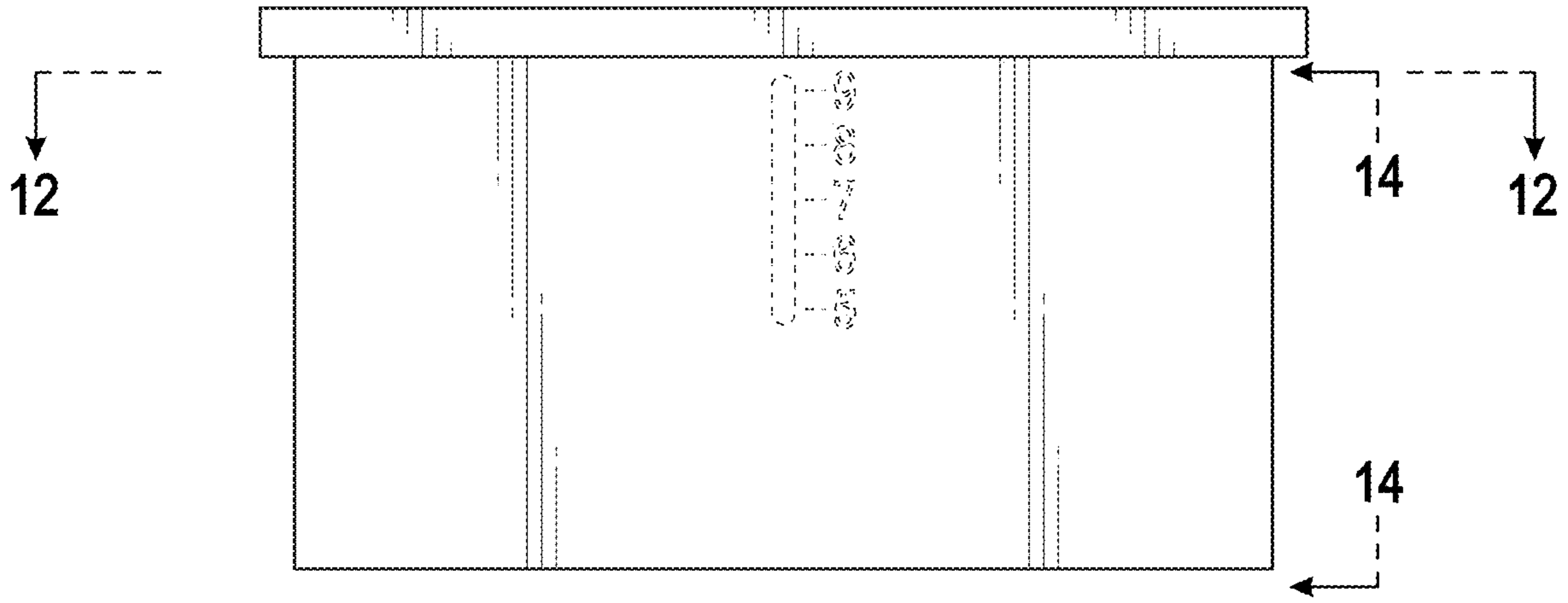

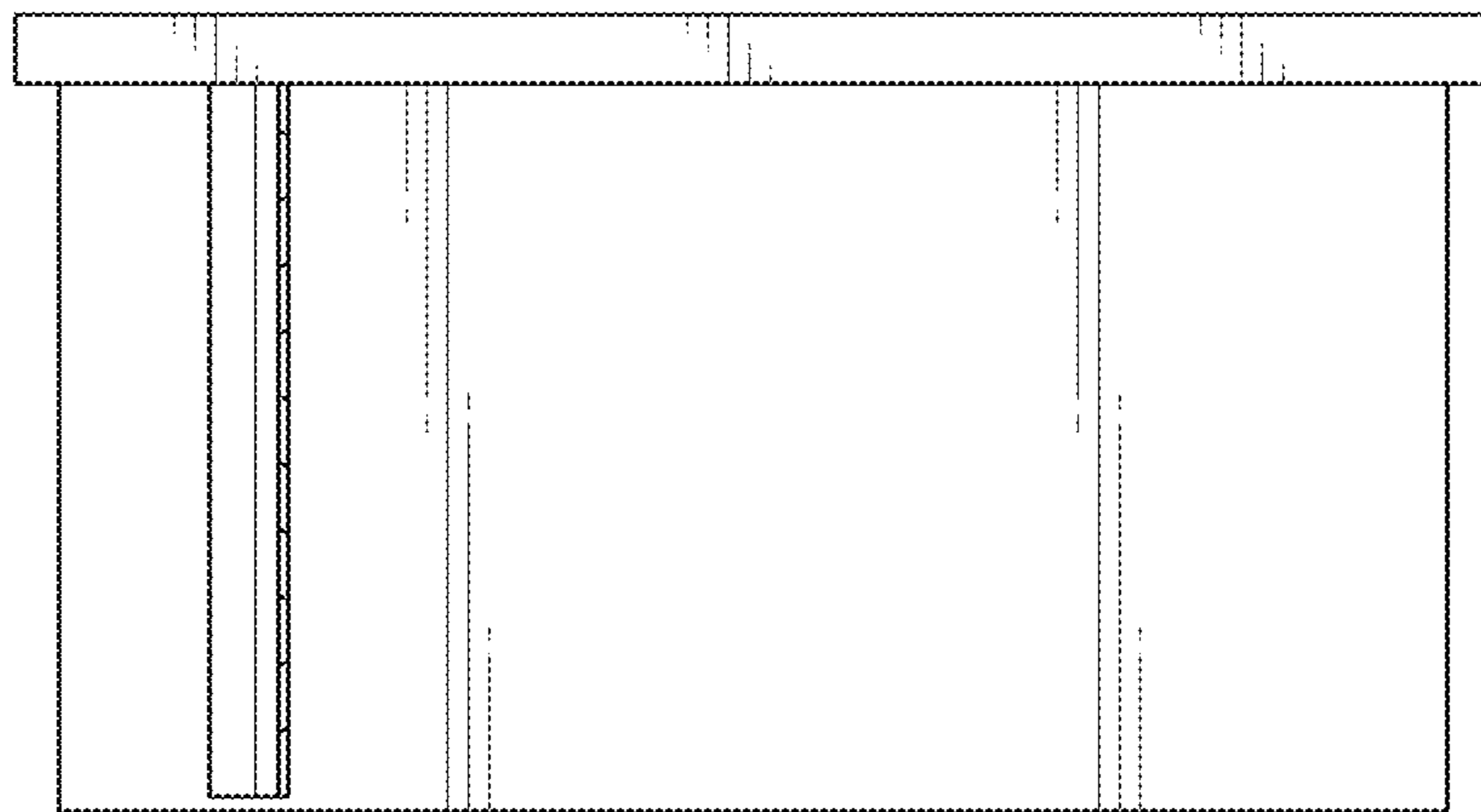

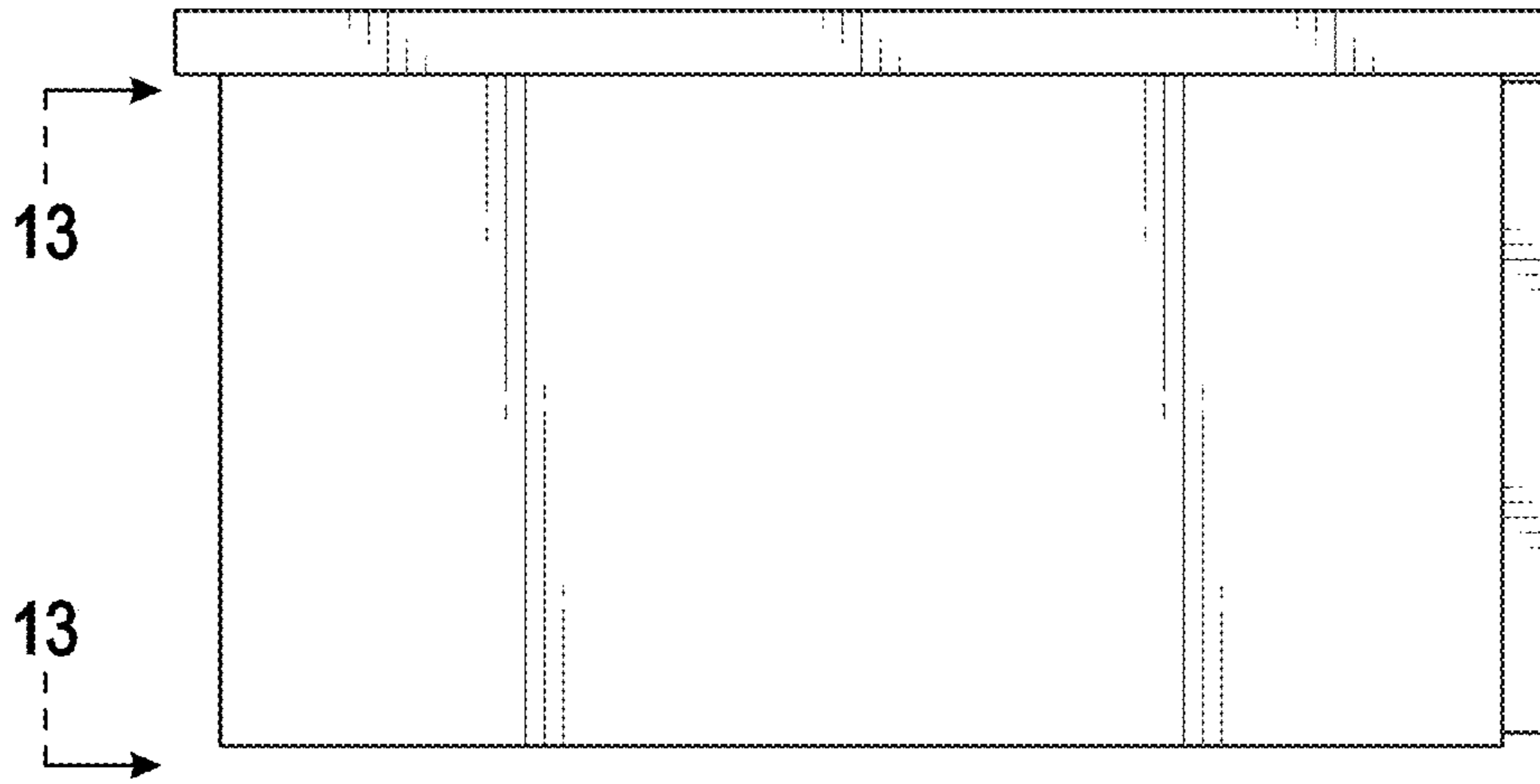

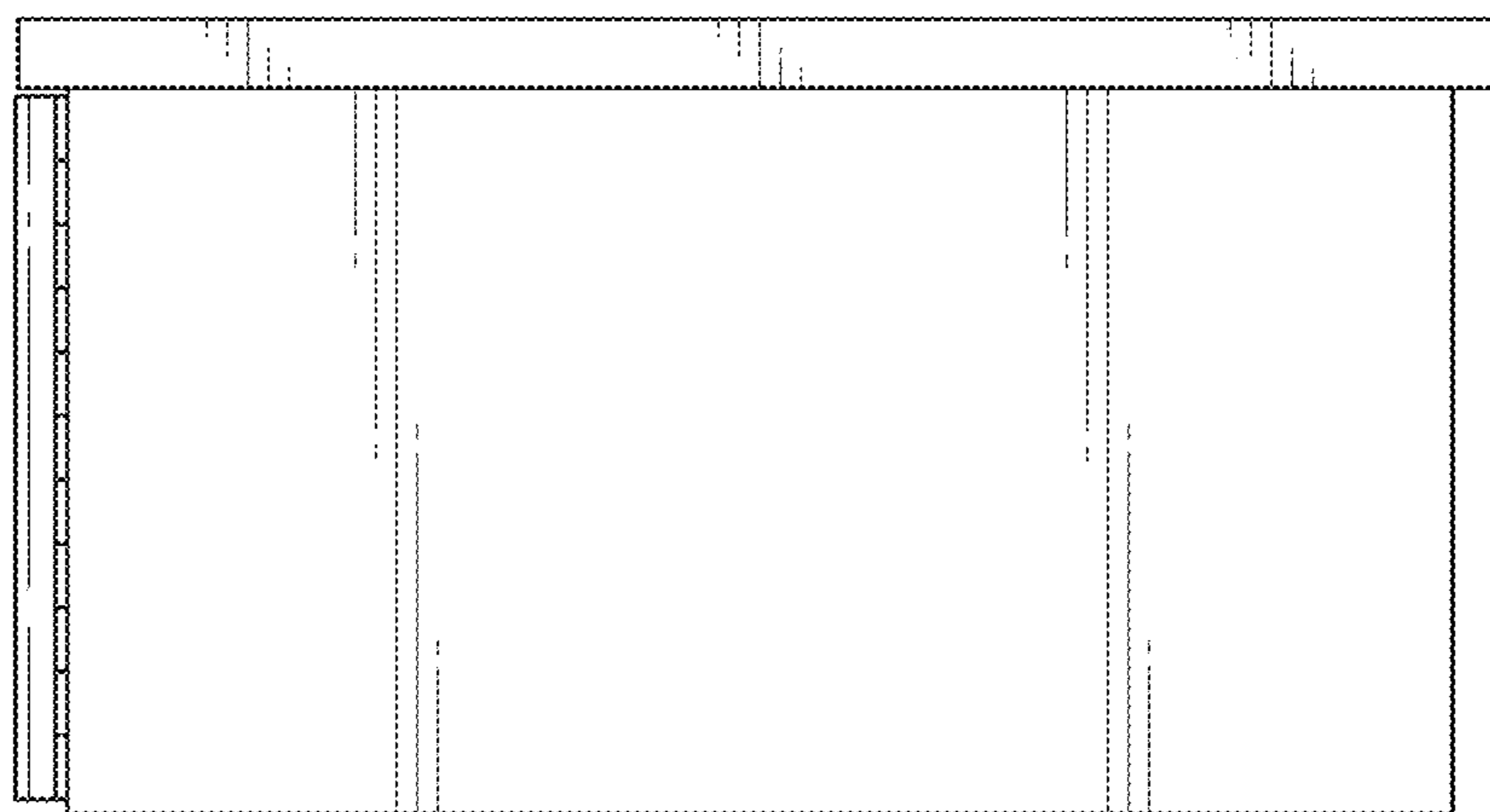

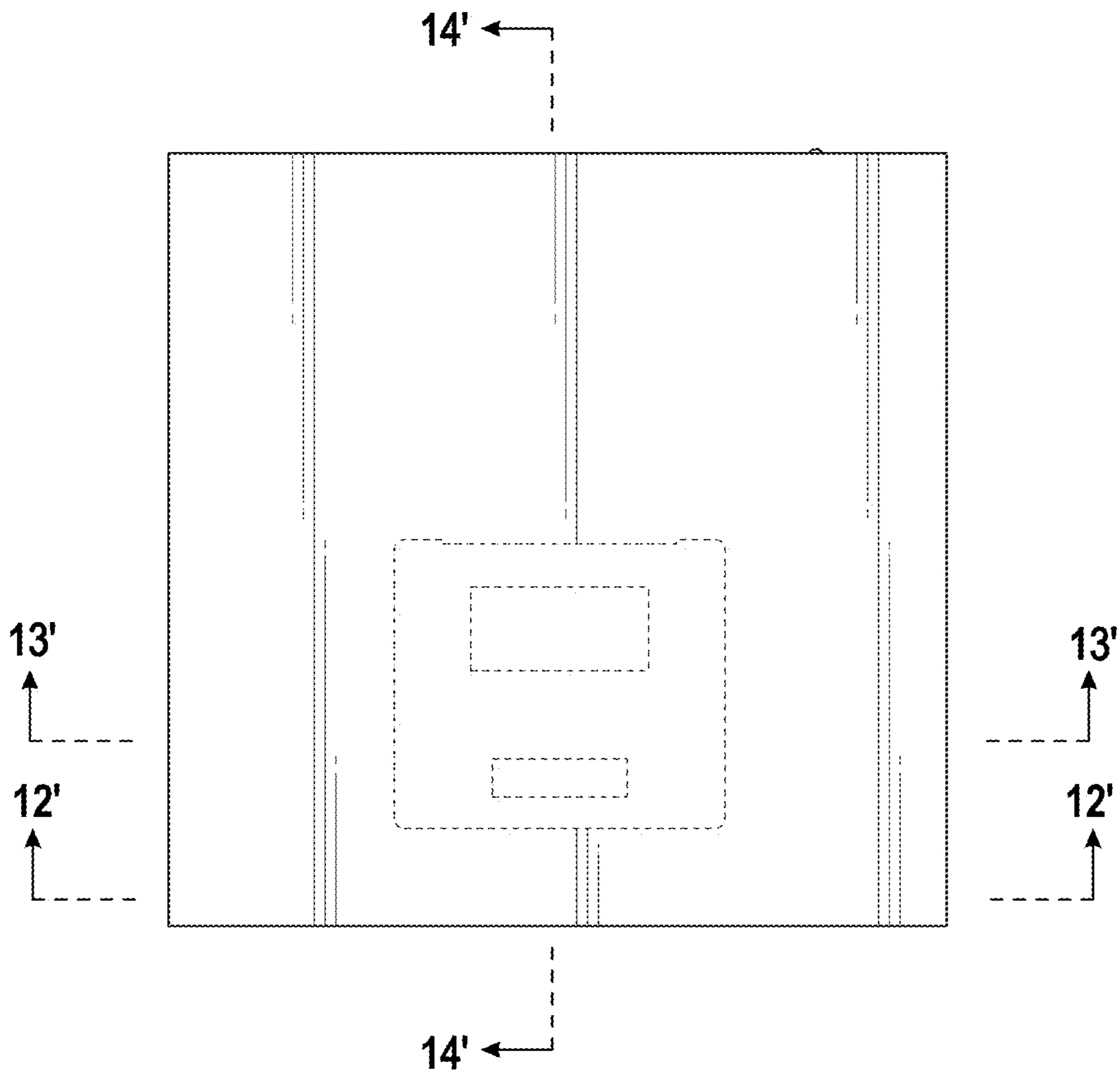

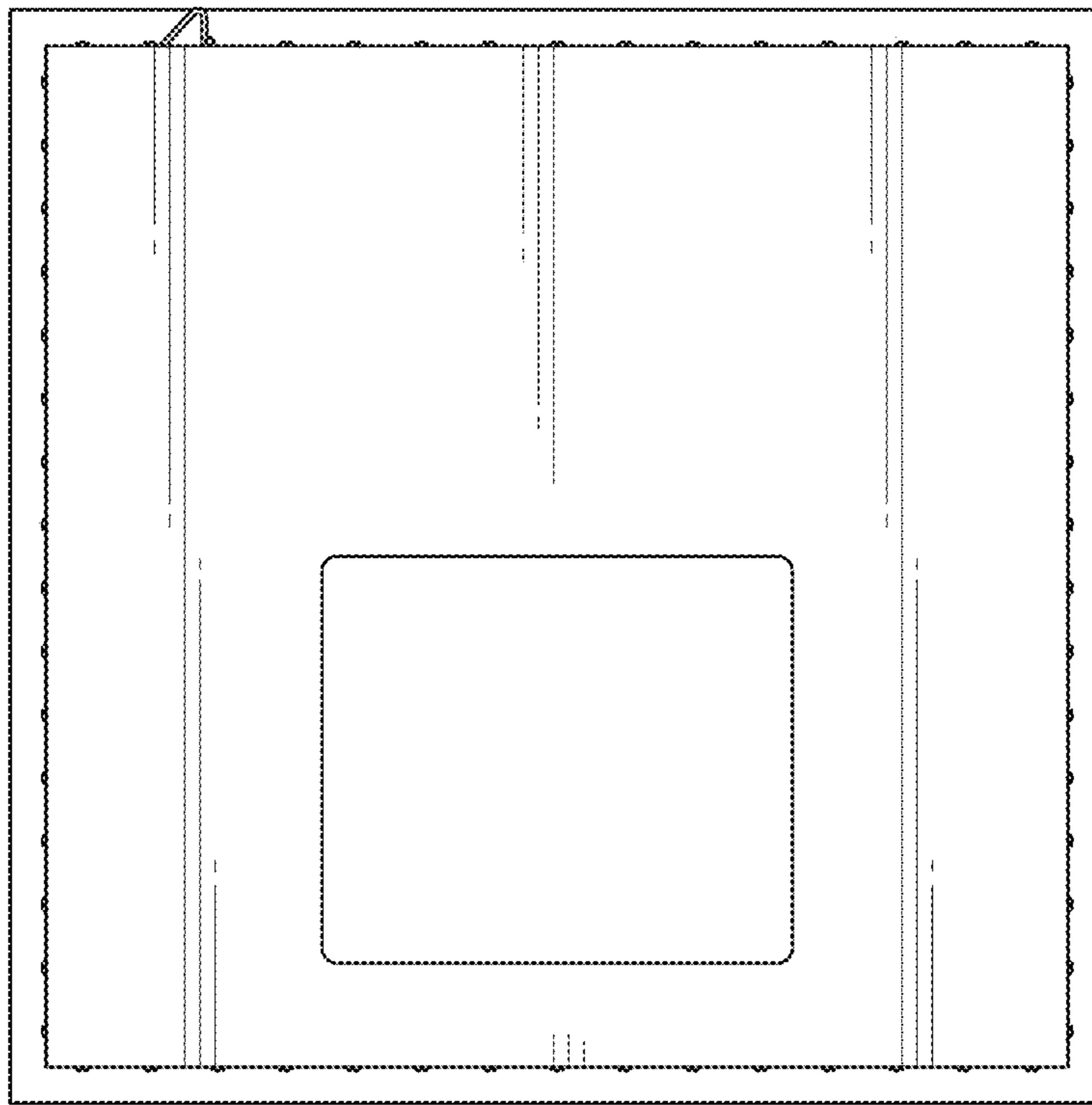

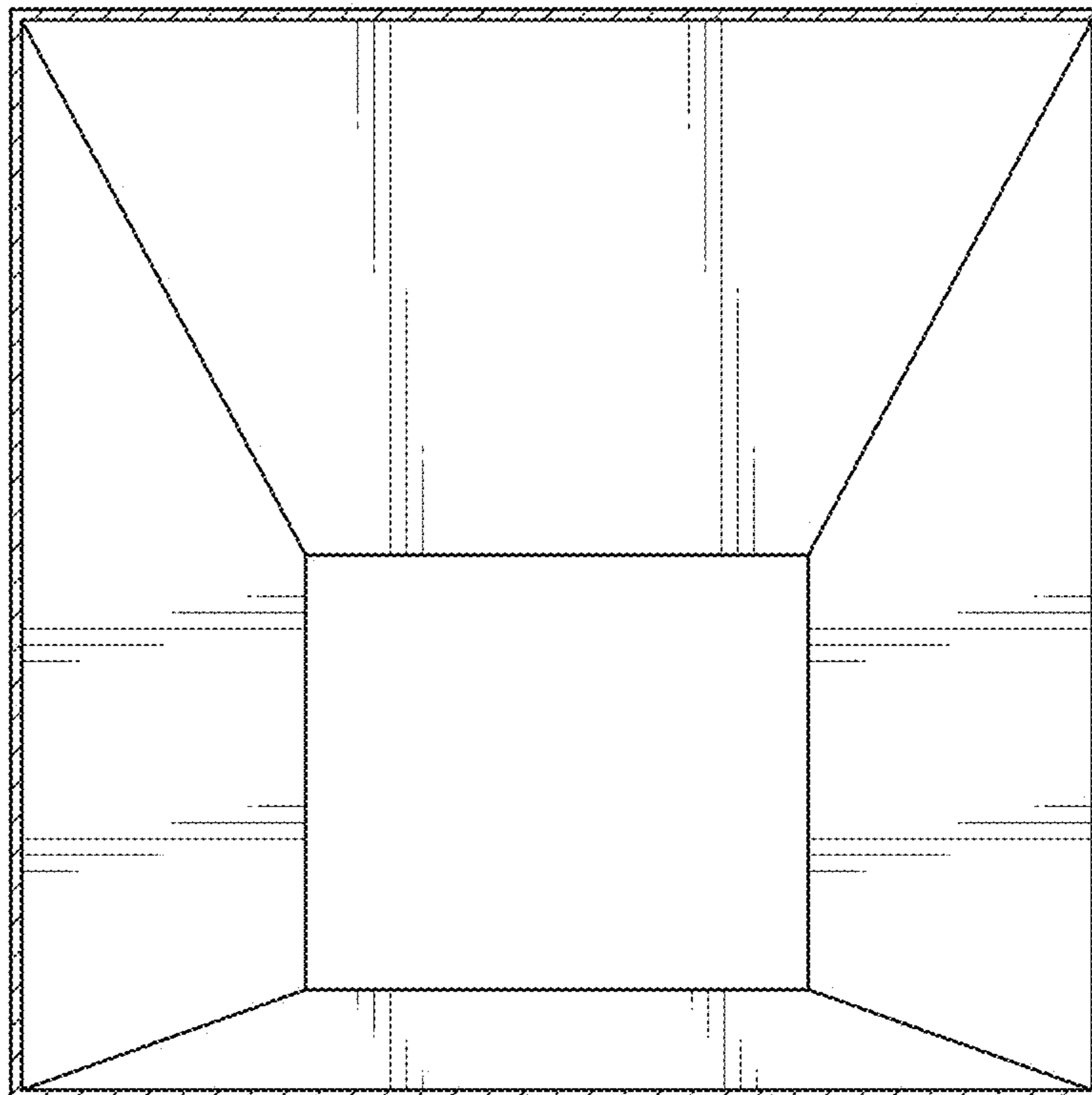

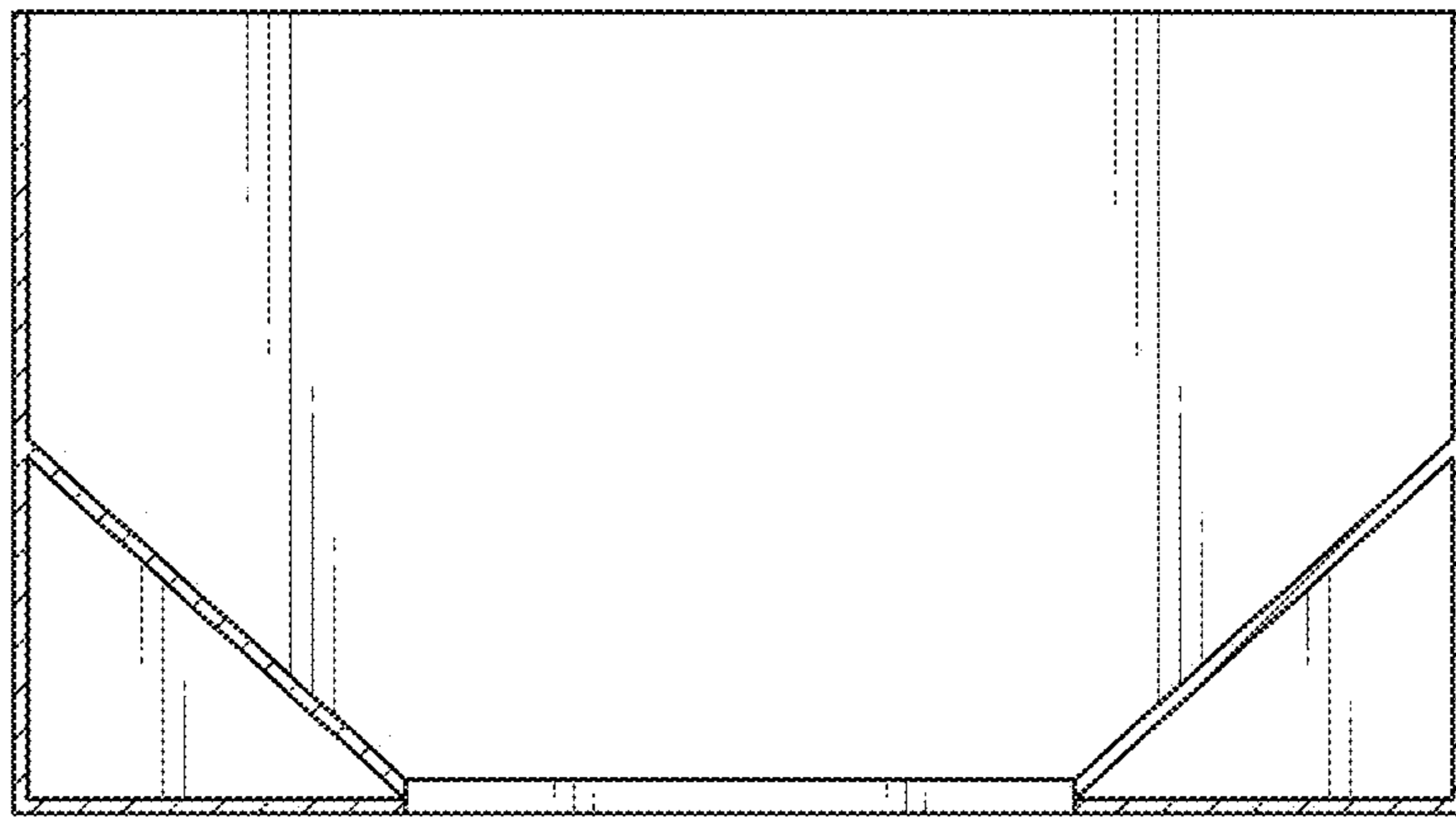

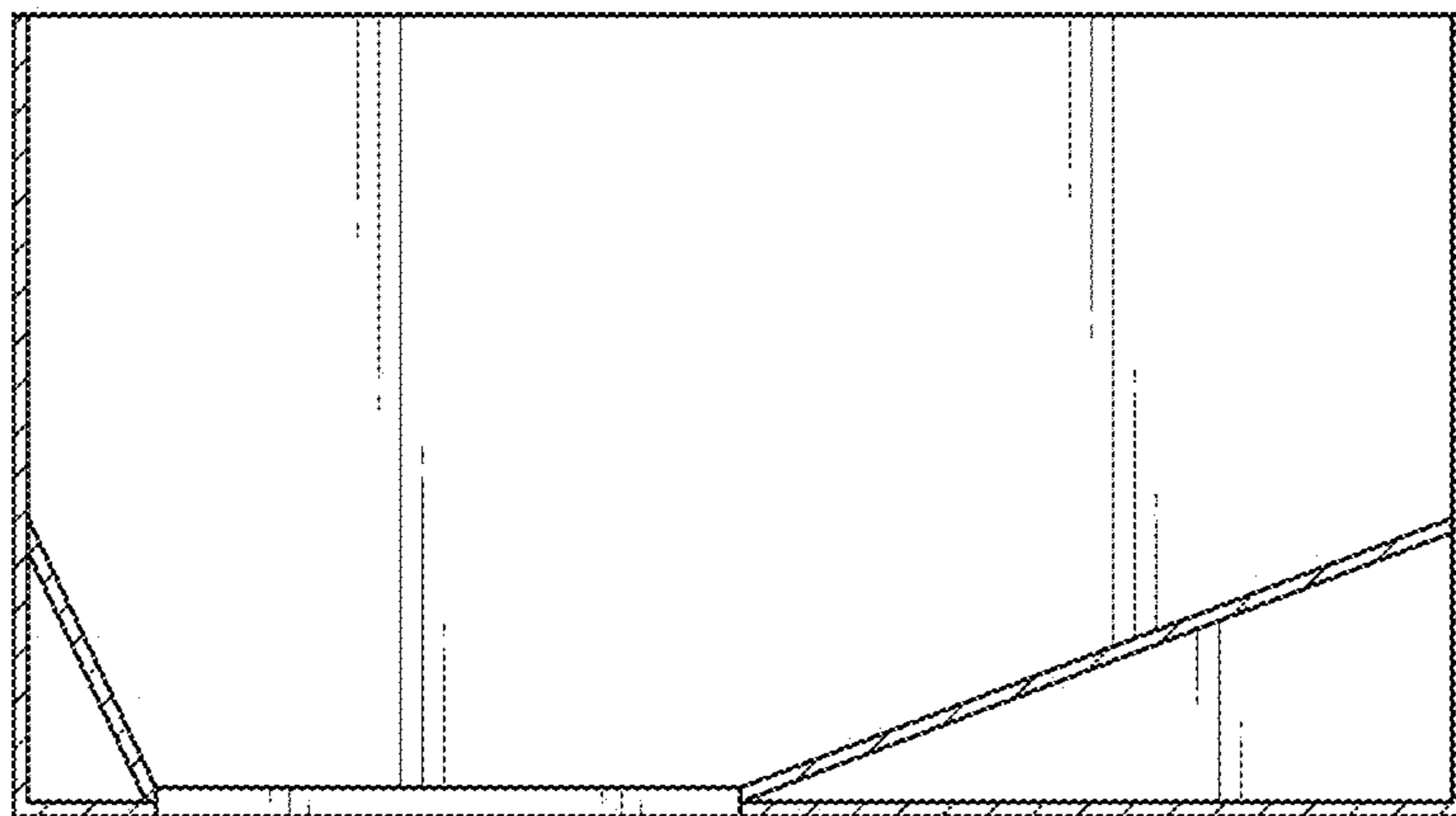
