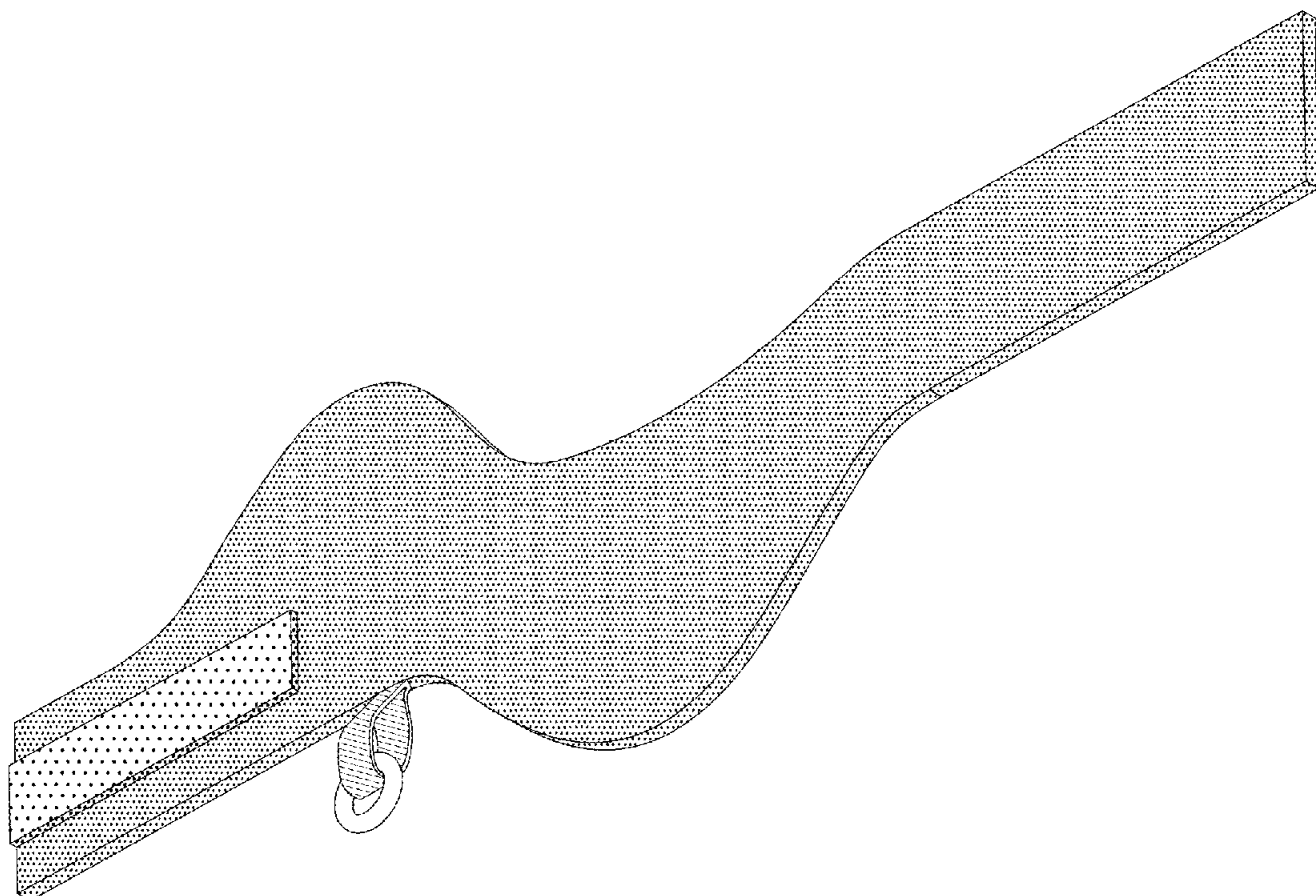
(57) **CLAIM**

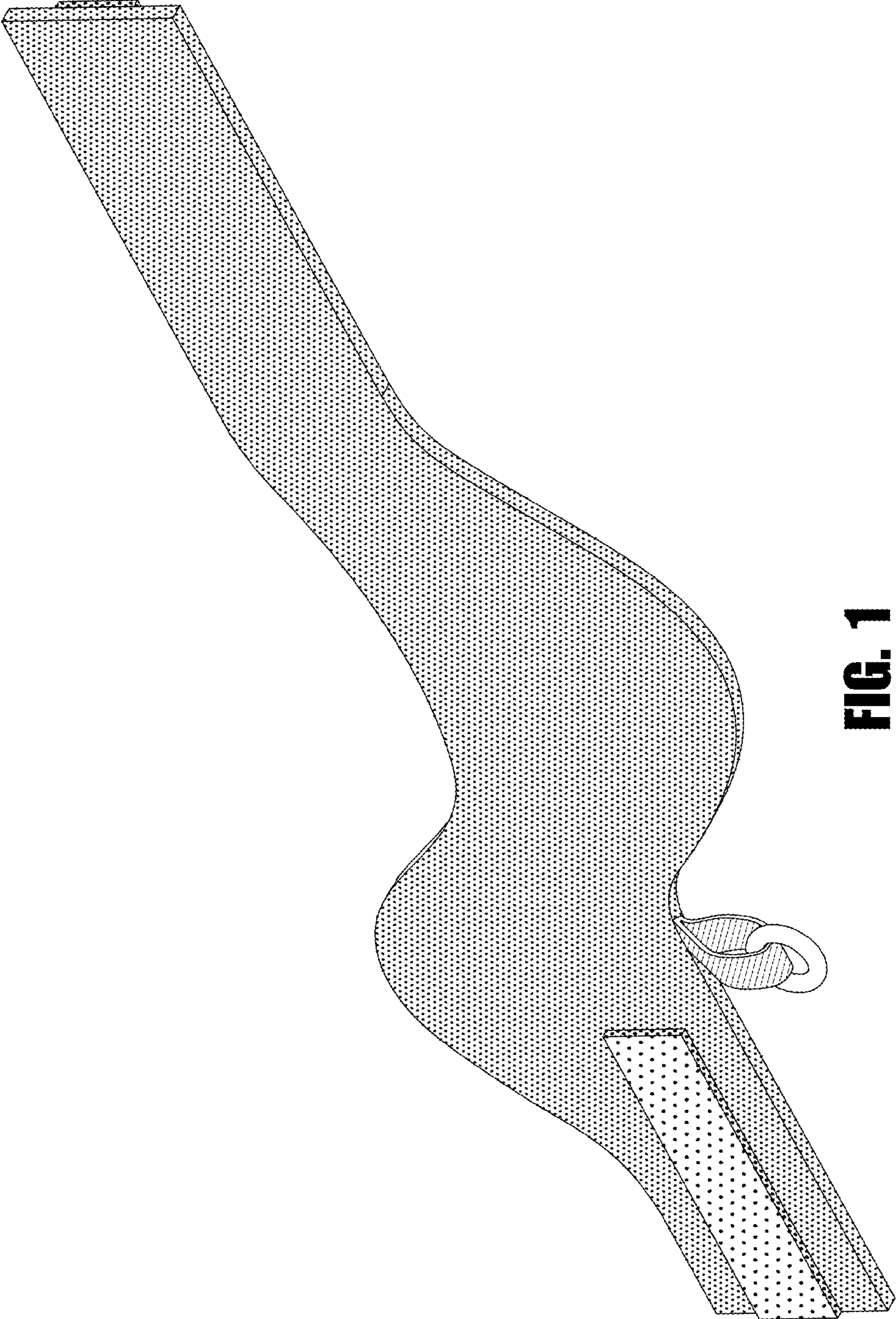
We claim the ornamental design for a neck guard for radiation scatter prevention, as shown and described.

**DESCRIPTION**

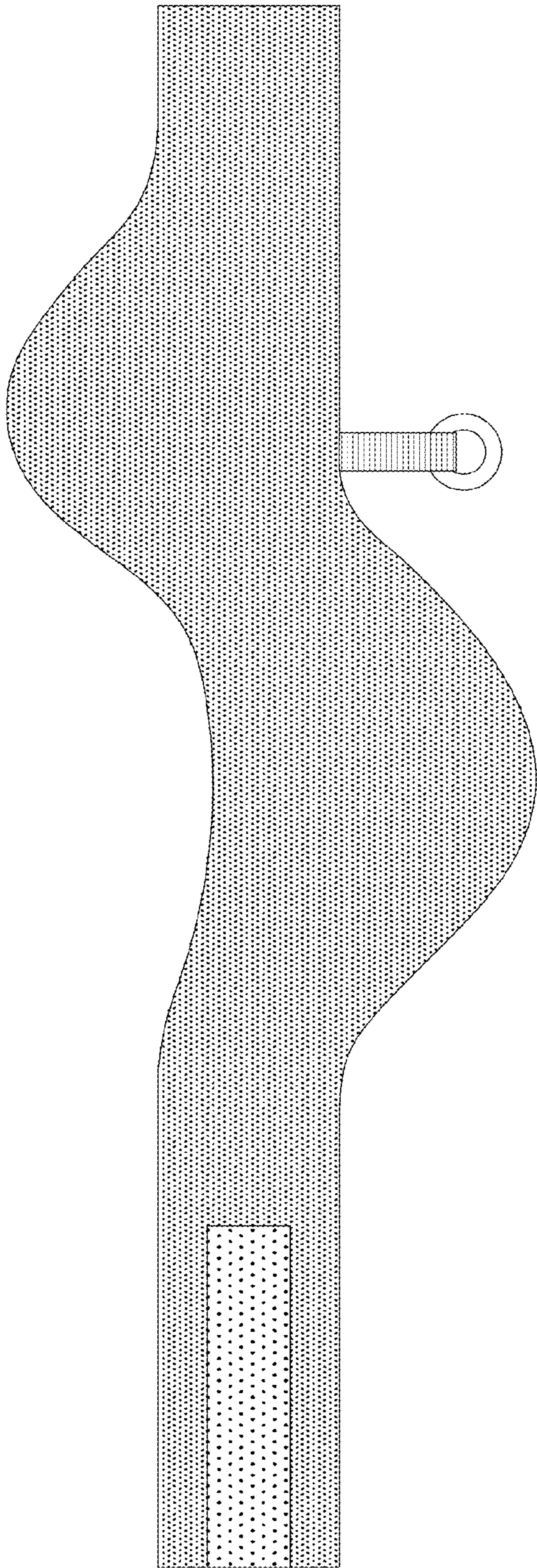

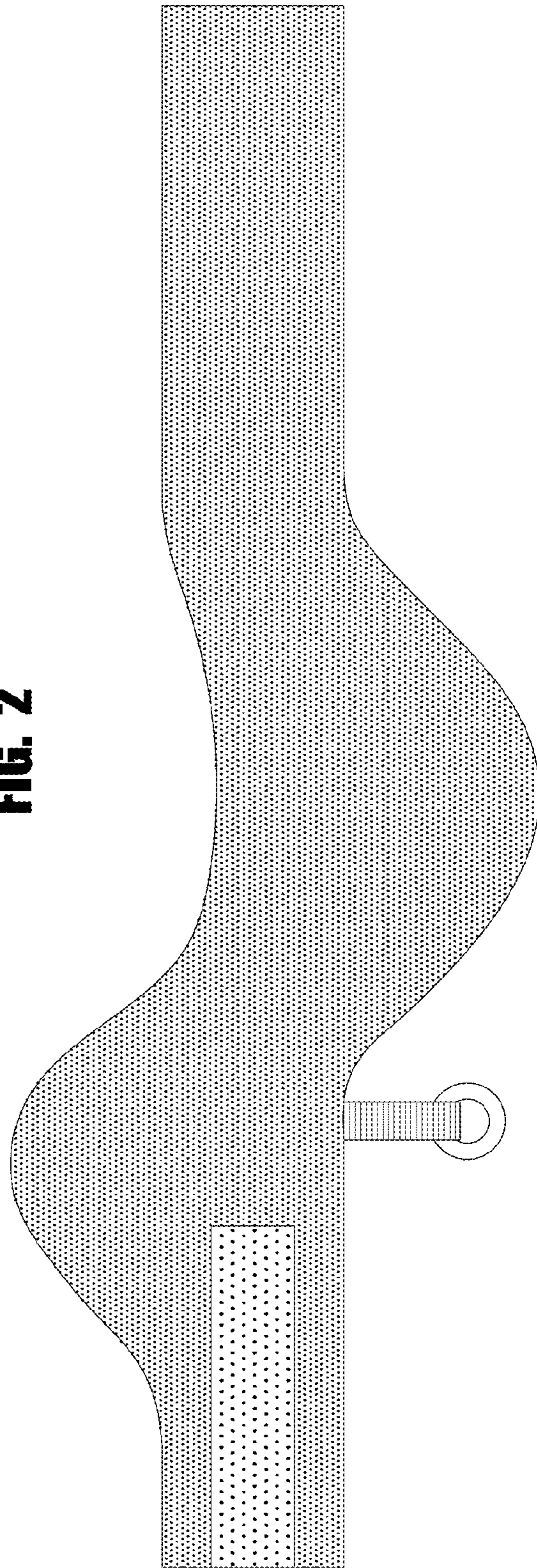

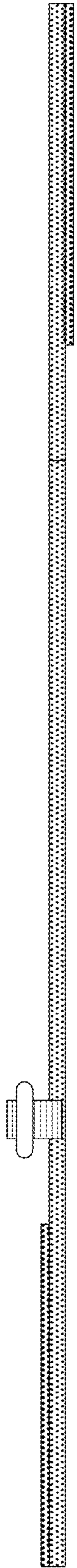




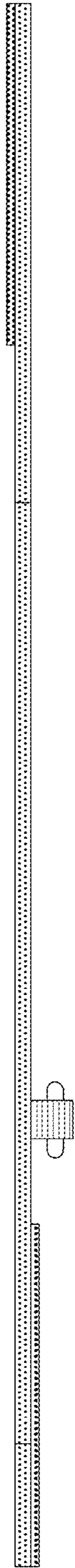
