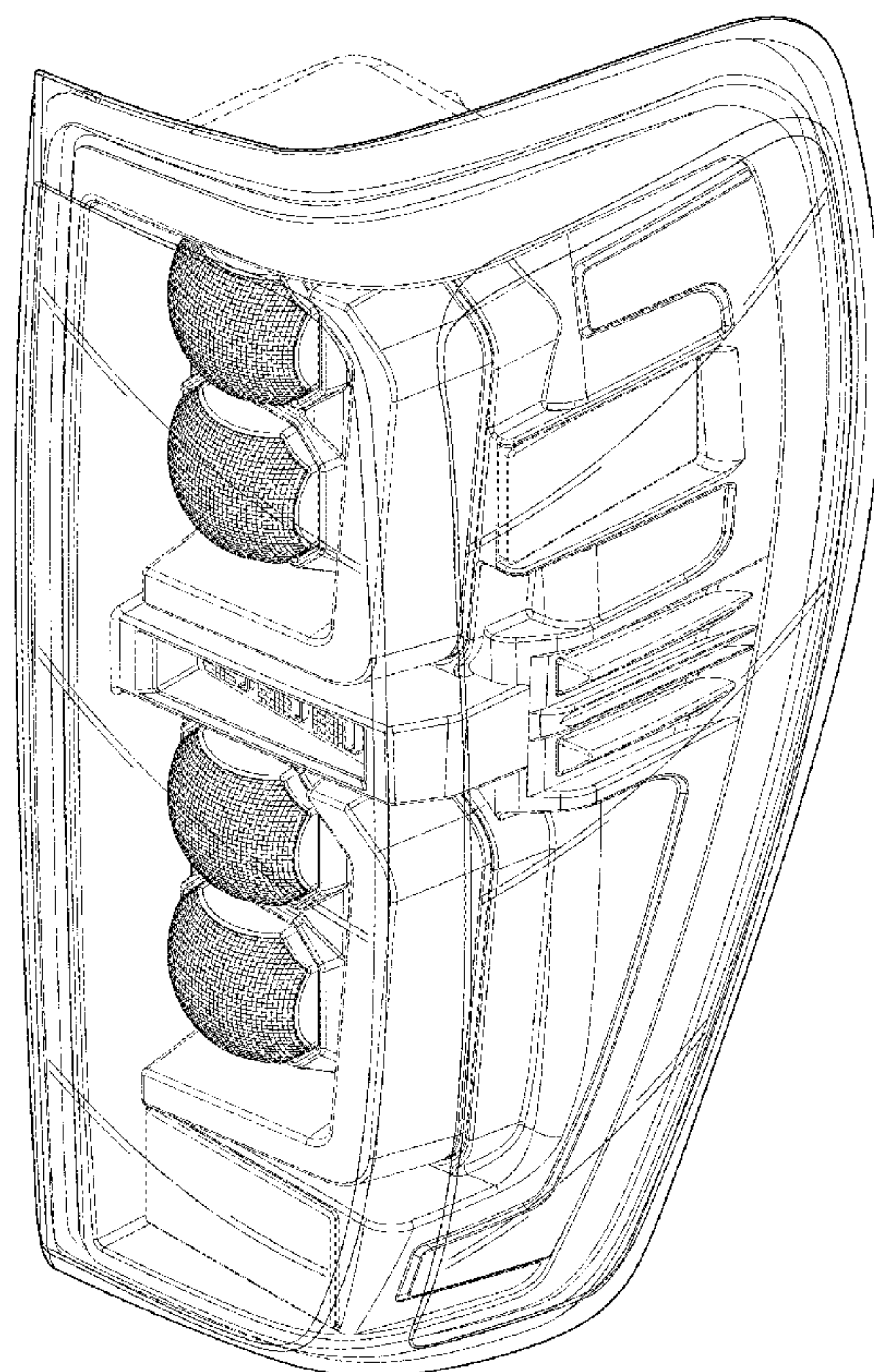
The ornamental design for a vehicle tail light, as shown and

**DESCRIPTION**

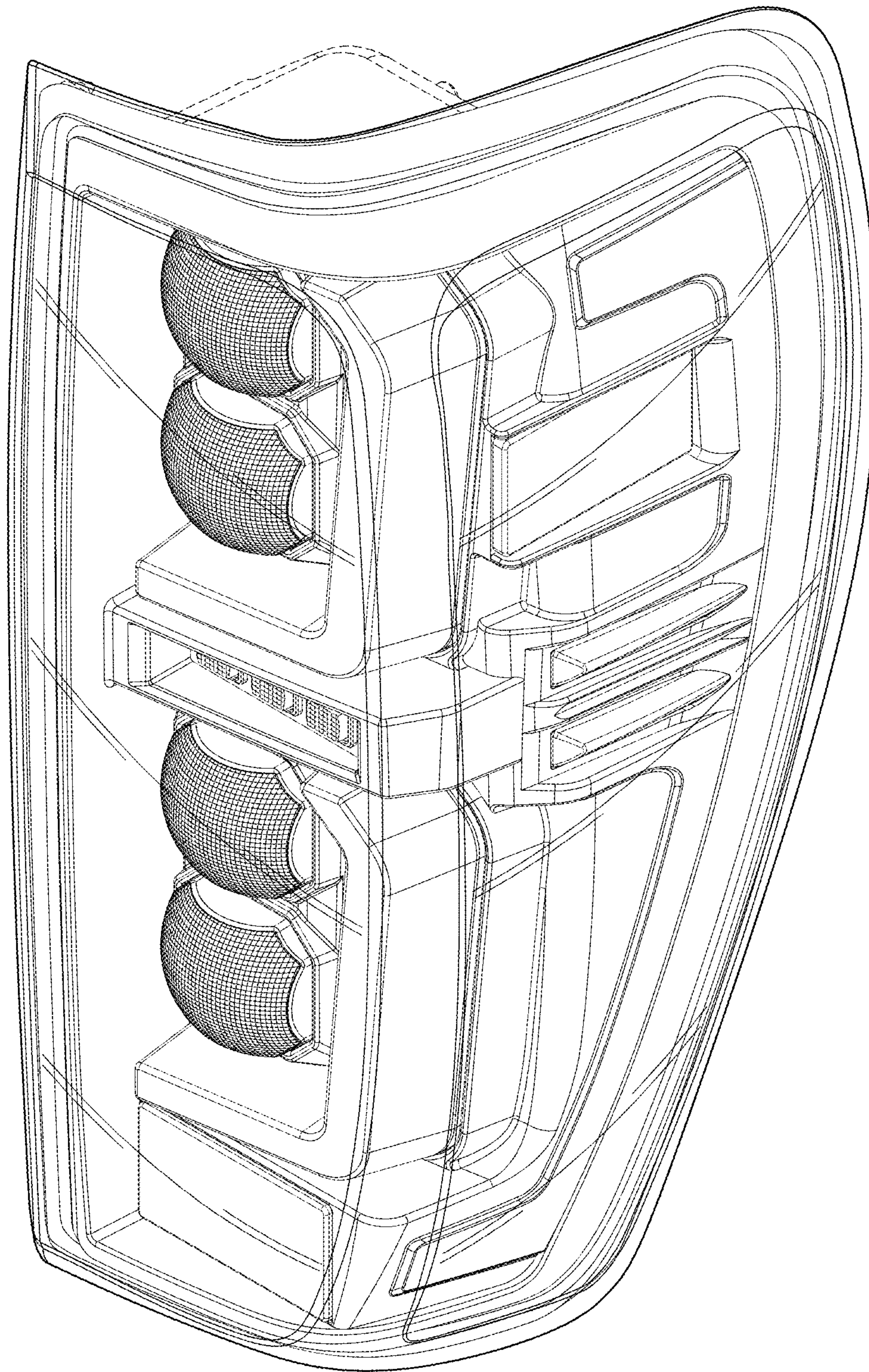

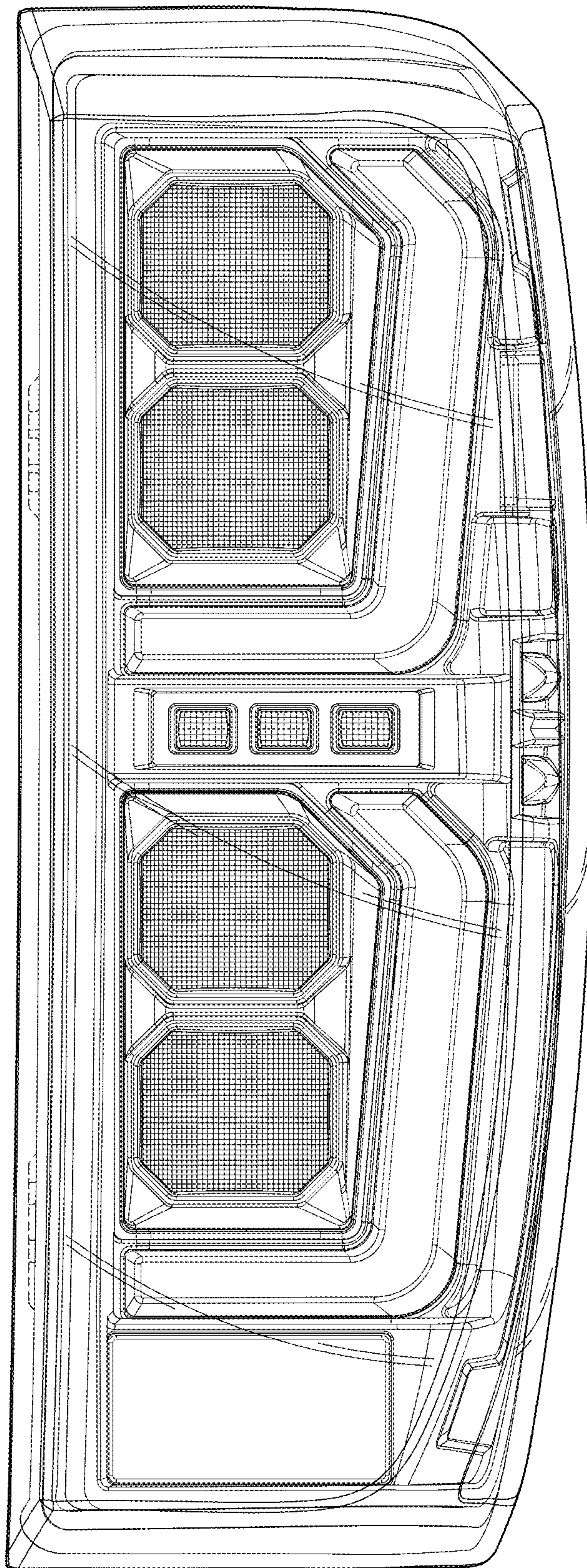

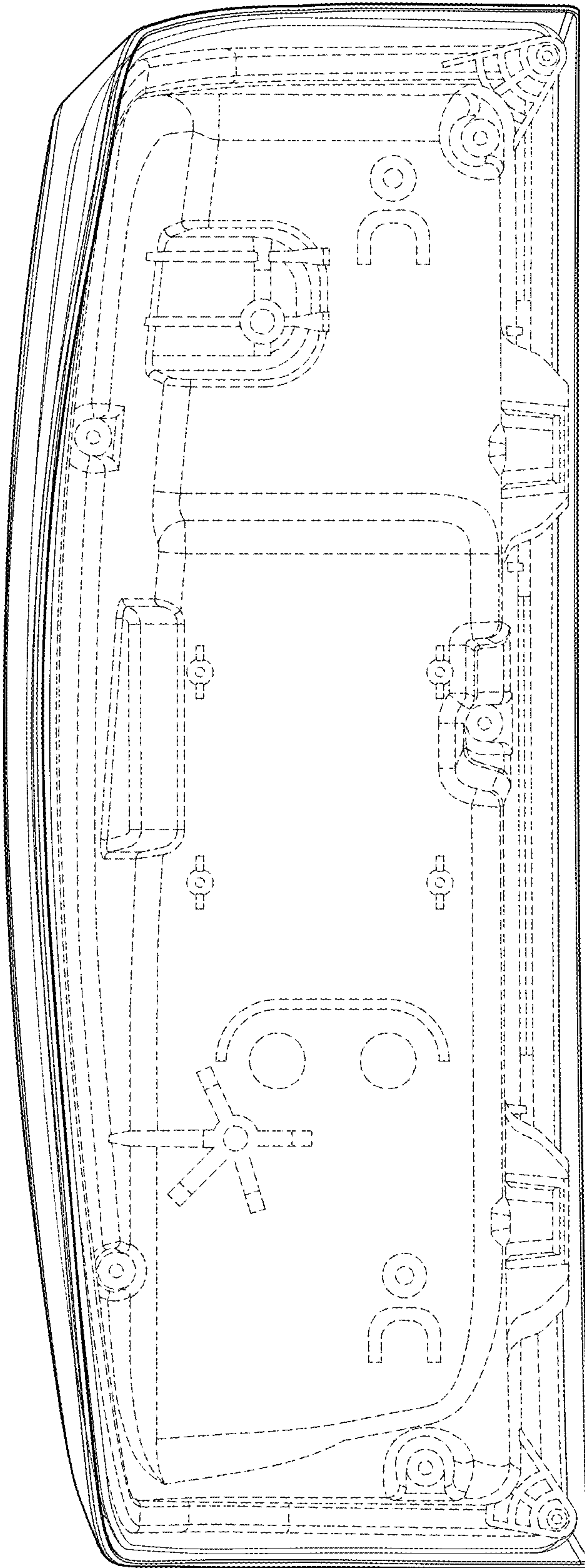

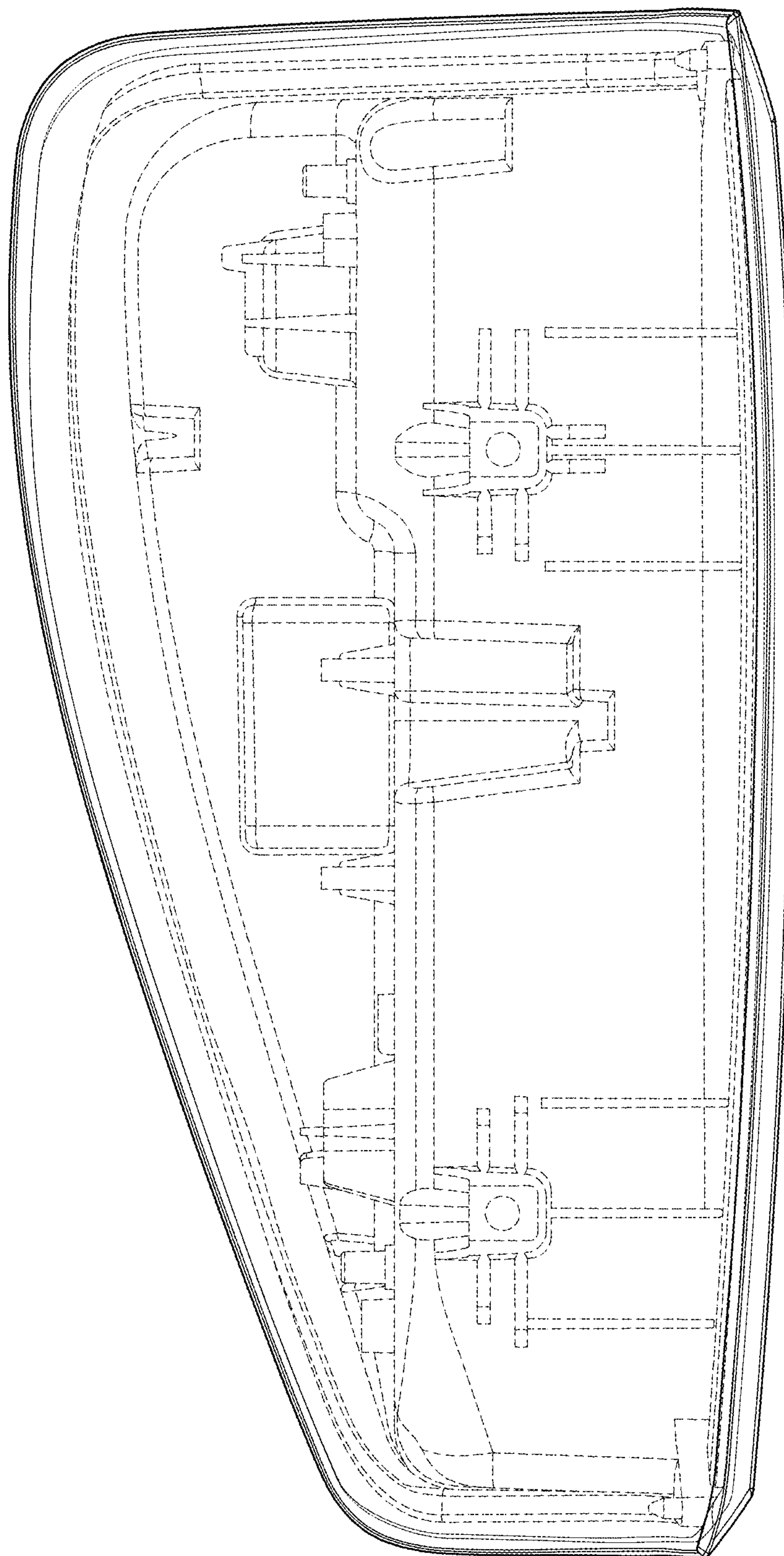

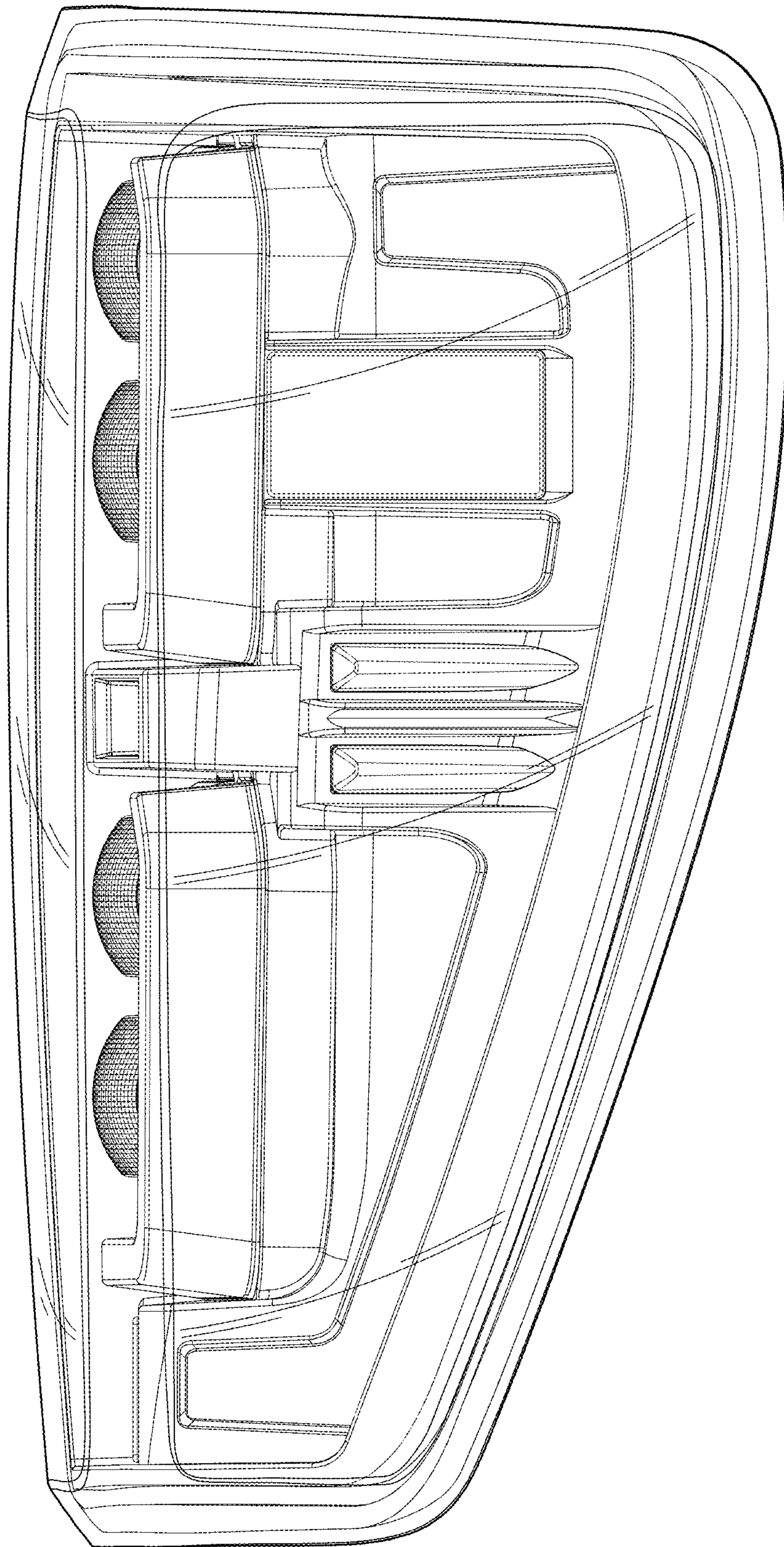

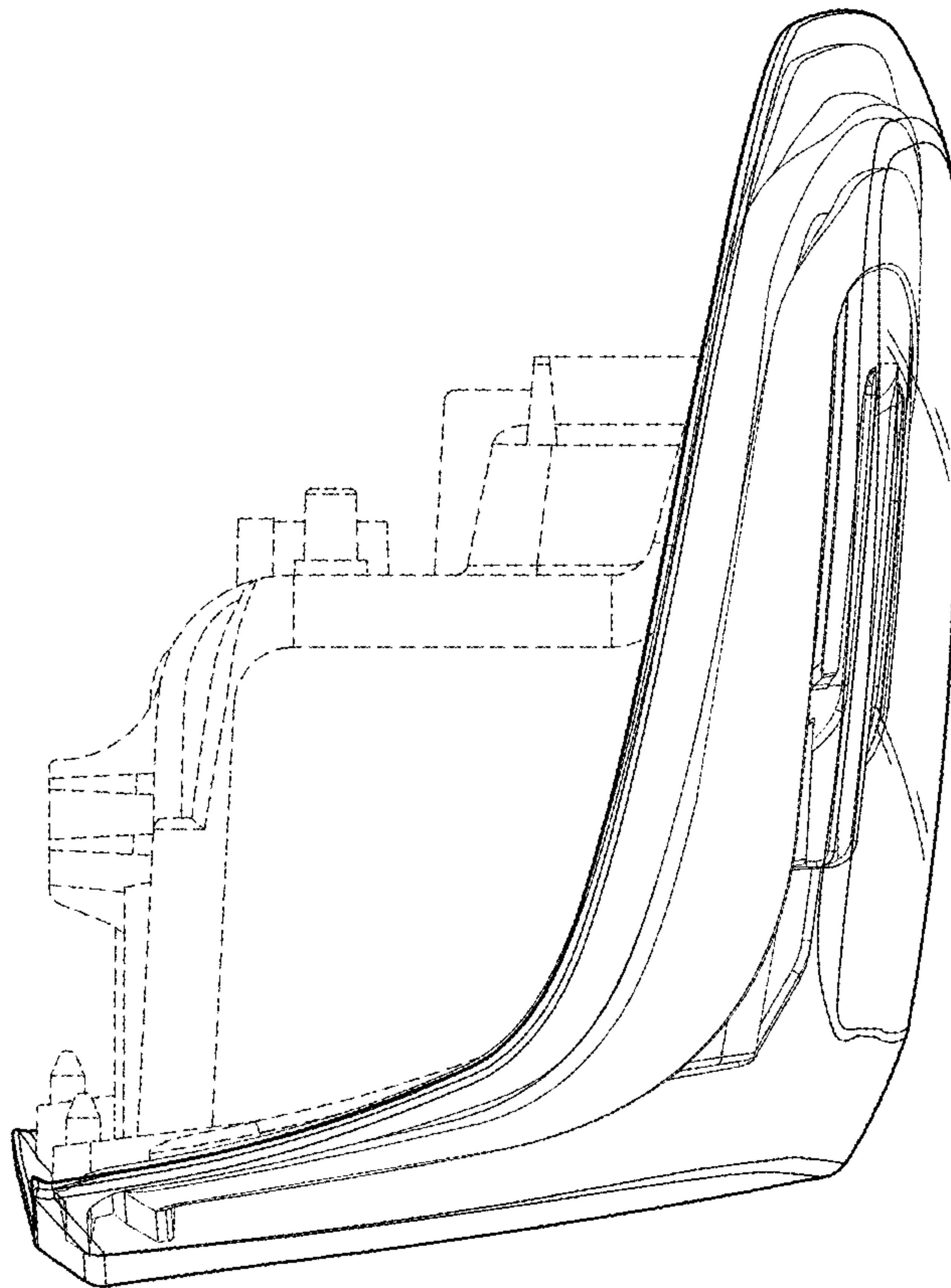

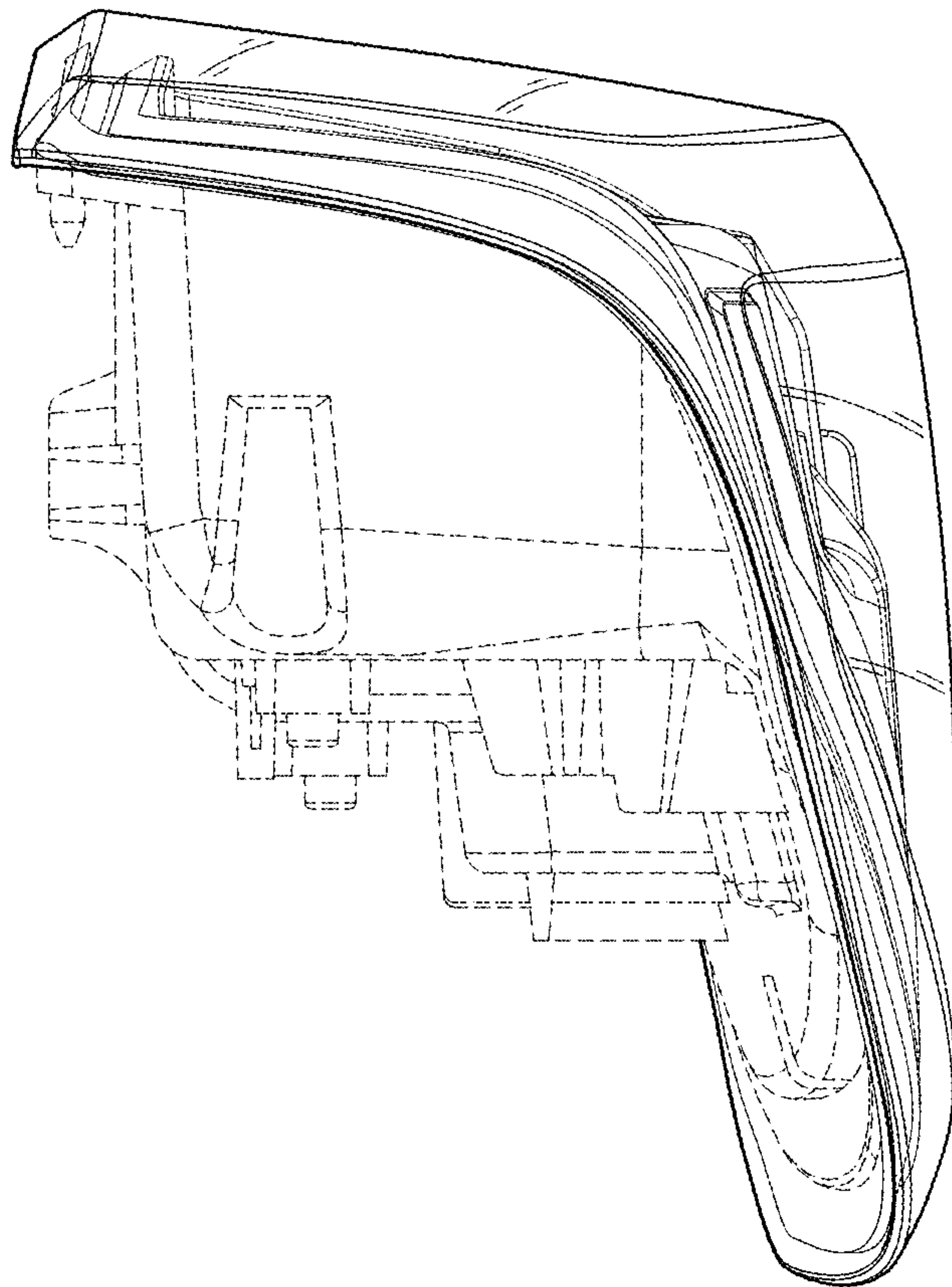
