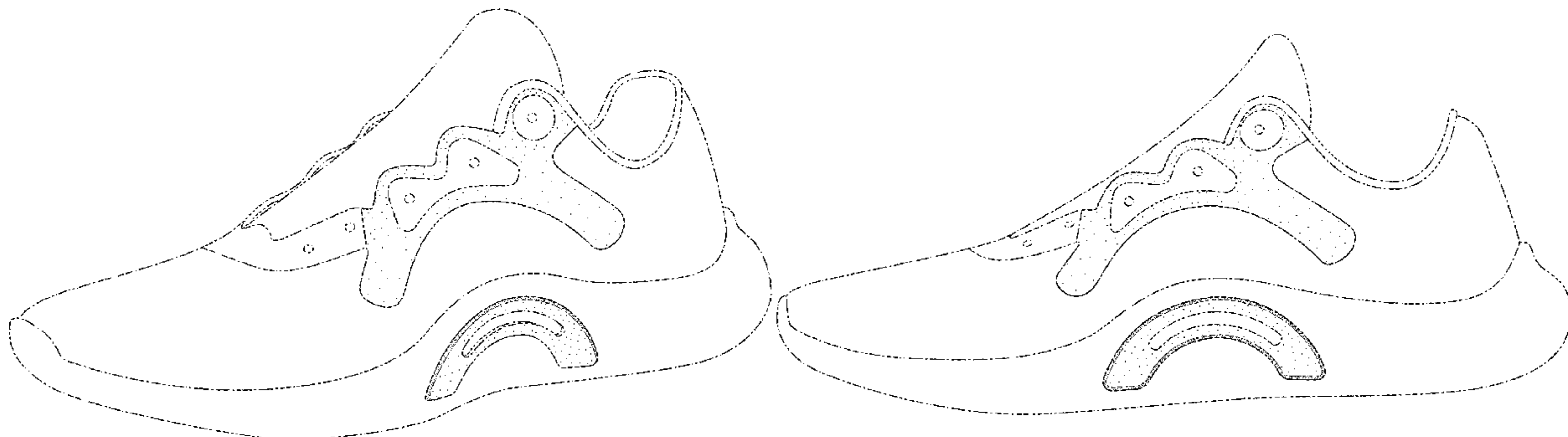
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design; FIG. 2 is a side view thereof; and, FIG. 3 is a rear perspective view thereof. The two broken line regions within the top portion of the claim, including the broken line circles therein, form no part of the claimed design. The broken line C-shaped element within the bottom portion of the claim forms no part of the claimed design. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

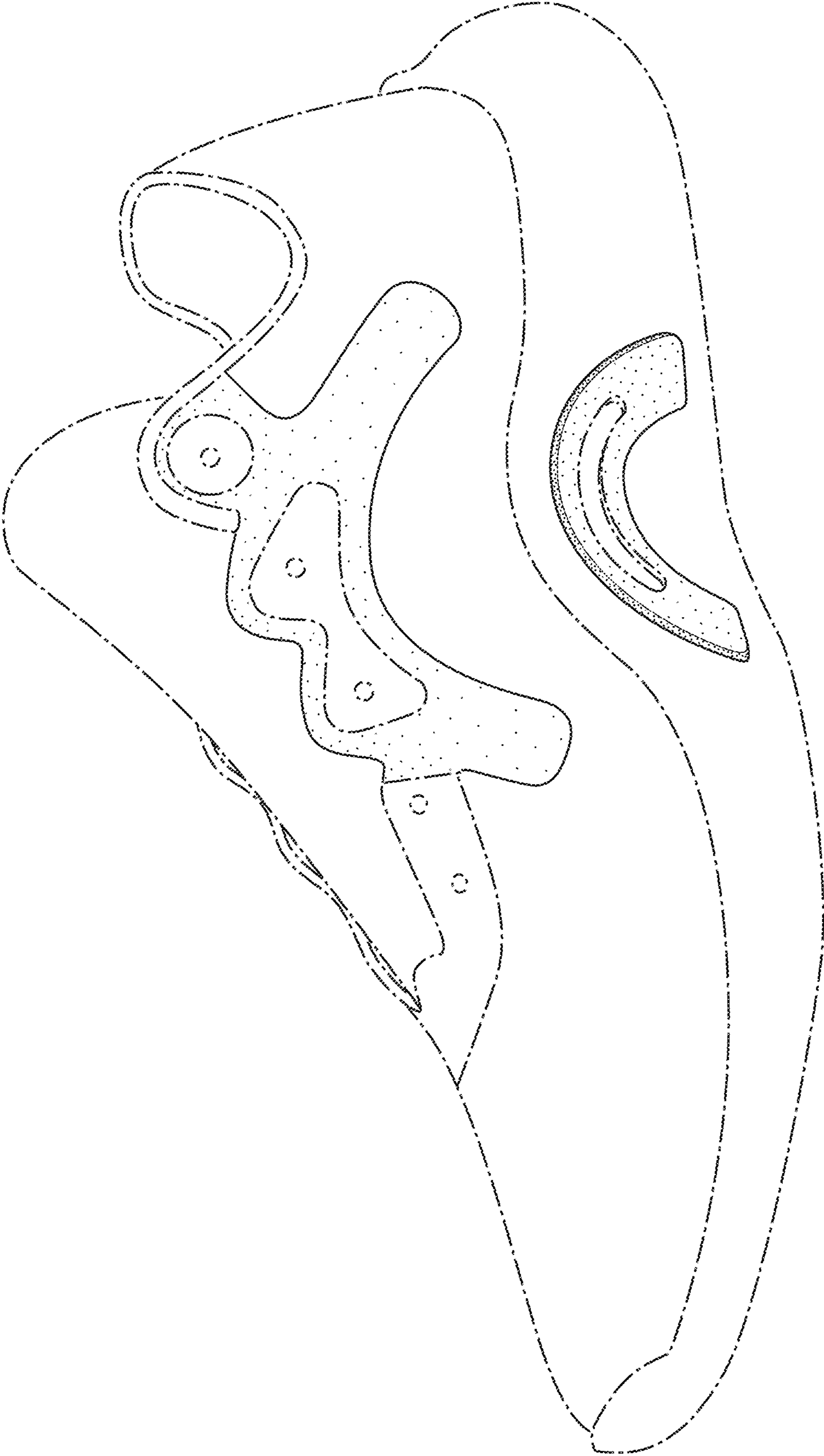

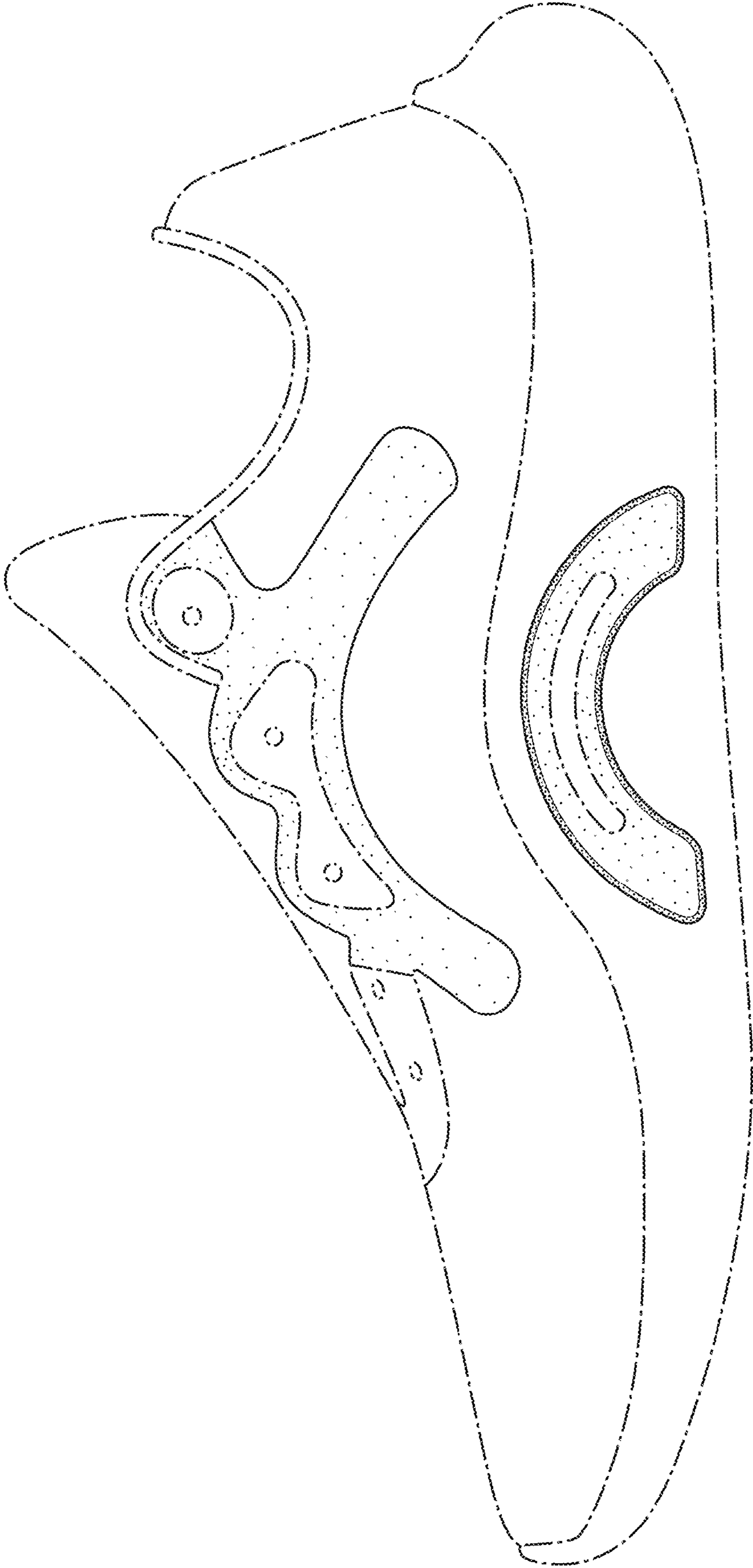

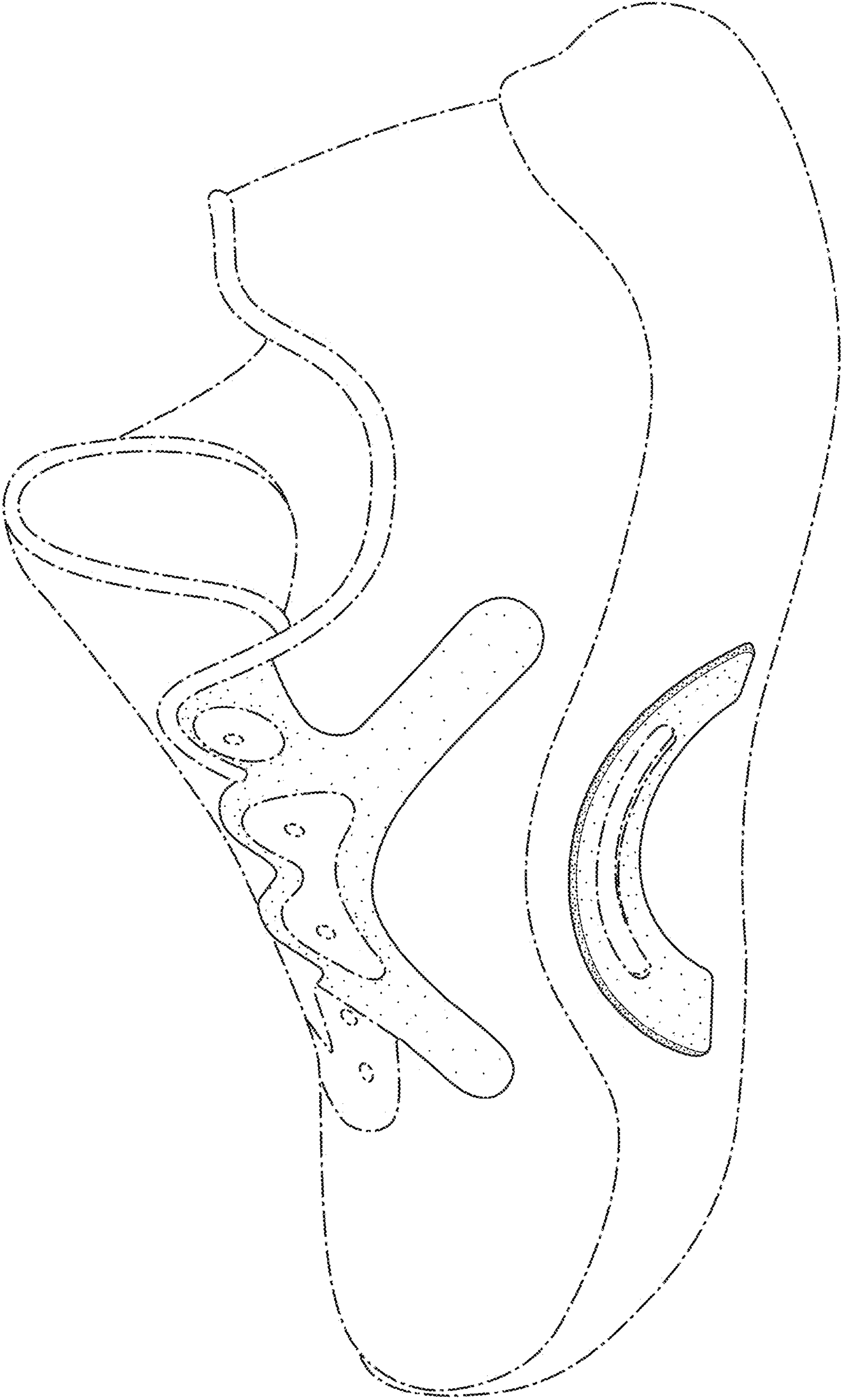
